In connection with the trial of instant case, SAAG T. J. In this connection Mr. DONEGAN suggested that this Office contact Special Agent BURT ZANDER of the Washington Field Office to determine from him the name of the State Department employee who is familiar with the original State Department documents which are connected with instant case. Mr. DONEGAN and Mr. MURPHY plan to request the presence of this individual and the documents in New York City prior to the trial of instant case.

It is recalled that SA ZANDER made the comparison between the so-called Baltimore and Pumpkin papers with the original State Department documents and Mr. DONEGAN is of the opinion that ZANDER will probably know the person in the State Department most qualified to assist them in preparing the trial brief in respect to these particular documents.

It is not known, however, whether this individual, who is most familiar with the documents in the State Department, will be used to introduce them.

In this regard it is requested that the name of this State Department employee's supervisor be determined so that DONEGAN and MURPHY will be able to subpoena the appropriate person in the State Department to introduce these documents at the time of trial.

Re: MRS. ROBERT BOWIE

On May 12, 1949 MRS. ROBERT BOWIE, 3511 S Street, N.W., Washington, D. C., was interviewed in the office of ALEX CAMPBELL in Washington, D. C. by SAAG THOMAS J. DONEGAN and AUSA THOMAS F. MURPHY.

MRS. BOWIE related that she was employed as a baby sitter in the HISS residence at 3415 Volta Place, N.W., Washington, D. C. and later at 3210 P Street, N.W., Washington, D. C., covering a period from approximately 1942 to 1947. She related that she never saw an upright or portable typewriter in the Volta Place residence of ALGER and FRISCILLA HISS but did recall seeing an upright typewriter in the 3210 P Street, N.W. address of the HISS family.

She recalled that there was a bookroom in the back of the 3210 P Street, N.W. residence that she frequented occasionally and on the occasion of these visits she observed an upright, regular size typewriter on the floor of this room. She also recalled that this typewriter had an oilcloth covering. She related that she particularly recalls this because her husband had a similar typewriter at her home and that her husband always kept this typewriter covered with an oilcloth covering.

She stated that when TONY HISS was old enough to walk about the house and play with various objects he was allowed to sit on the floor and pick away at the upright typewriter.

MRS. BOWIE related that to date the HISS lawyers and investigators have not been to visit her.

Re: MRS. ELIZA GREEN

On May 12, 1949 MRS. ELIZA GREEN, 3534 S Street, N.W., Washington, D. C., a baby sitter for the HISS family in Washington, D. C., was interviewed in the office of ALEX CAMPBELL in Washington, D. C. by SAAG THOMAS J. DONEGAN and AUSA THOMAS F. MURPHY.

MRS. GREEN stated that she acted as a baby sitter for the HISS family from the time TONY HISS was ten months old until the HISS family moved to New York City in September of 1947 and as a matter of fact, accompanied the HISS family to New York when they moved for the purpose of taking care of TONY during this trip.

She recalled that there was a small room in the rear of the 3210 P Street, N. W. house that contained a table on which was placed a typewriter and a record playing machine. She recalls specifically that one day she was attempting to get TONY outdoors but the child "was stalling around" and apparently not desirous of going outdoors. She further recalled that on this date TONY went to this room and stayed to play the phonograph machine and sometime later started playing with the typewriter. She particularly recalled that she told him not to play with the typewriter as he might break it.

In connection with her association with the HISS family subsequent to September 1947, she stated that sometime just prior to April 11, 1949 she received a letter from either ALGER or PRISCILLA HISS requesting her to come to New York so that she could take care of TONY during the latter's spring vacation. She related, however, that she was unable to go and so

Re: CLAUDIA CATLETT

MRS. CLAUDIA CATLETT, 542 North Kent Street, Winchester, Virginia, a former colored maid for the HISS family, was interviewed on May 12, 1949 in the office of ALEX CAMPBELL in Washington, D. C. by SAAG THOMAS J. DONEGAN and AUSA THOMAS F. MURPHY.

Reference is made to Page 138 of the Summary Report by SA JOSEPH M. KELLY dated March 30, 1949 wherein is set forth a signed statement of CLAUDIA CATLETT.

On the occasion of this interview, MRS. CATLETT advised that when she was working as a full time maid for the HISS family at 2905 P Street, N.W. for a period of two months, she remembered a man, dressed in what she thought were old working clothes, came to the house, said his name was CROSBY and asked to see MRS. HISS. She stated she went into another room of the house, announced Mr. CROSBY and then went downstairs to complete her work. Some short time thereafter PRISCILLA HISS ordered CLAUDIA to make some tea which she did and went to the entrance of the room where CROSBY and MRS. HISS were sitting and handed MRS. HISS the tray with the tea cups, et cetera. She related she did not see Mr. CROSBY at the time she handed the tea tray to MRS. HISS. She further stated that she had observed photographs of WHITTAKER CHAMBERS and recently had an occasion to see and talk to him in the Office of the FBI in Washington and identified this individual as the Mr. CROSBY in the working clothes who came to the HISS residence at 2905 P Street as related above.

She also stated that while she was at the 2905 P Street residence she remembered that there was a big typewriter with an old black oilcloth cover that was kept for the most part in TIMMY HOBSON'S room. She remembered that TIMMY played with it all the time and "tore it up."

She also recalled working for the HISS family when they moved to

1245 30th Street, N.W. and while there recalled that they had a nice red rug with fringe on it but it was not put on the floor. In connection with this rug she stated that when the HISS family moved to 3415 Volta Place, N.W., they did put this rug on the floor.

In connection with the rug she recalled that at one time PRISCILLA HISS told her that the rug did not belong to them.

MRS. CATLETT stated that about a month ago she received a telephone call from some man whose name she could not recall requesting that she go to the home of DONALD HISS in Washington, D. C. When she arrived there, this man, who said he was a lawyer, was accompanied by another individual whom she was also unable to identify, and these men talked to her for some time trying to find out the various periods that she worked for ALGER HISS at his various residences in Washington, D. C.

She stated that she knows DONALD HISS very well as she was at one time a maid in his home. She said that DONALD HISS was present during this latter talk and indicated that he, DONALD HISS, did not know who WHITTAKER CHAMBERS was.

During the time that MRS. CATLETT was interviewed by Agents of the Washington Field Office, she did not in any way indicate that she knew WHITTAKER CHAMBERS as Mr. CROSBY. It is suggested that probably she now associates WHITTAKER CHAMBERS with the name of CROSBY as a result of the recent conversation she had with some lawyers or investigators working for ALGER HISS.

On May 12, 1949 FLORENCE TOMPKINS, 1812 18th Street, N.W., Washington, D. C., a maid in the residence of ABRAHAM GEORGE SILVERMAN, 213E California Street, N.W., Washington, D. C. and at 2325 15th Street, N.W., Washington, D. C., was interviewed by SAAG THOMAS J. DONEGAN and AUSA THOMAS F. MURPHY.

Briefly MRS. TOMPKINS related that she recalls that, sometime in 1936 and during the winter of that year at a time which she stated was "rug time", upon arriving at the SILVERMAN home one morning she observed three large rolls in the vestibule of the SILVERMAN residence. A little later that day she, together with Mr. or Mrs. SILVERMAN, unrolled the three rolls, saw that they were three 9 X 12 rugs and later learned from conversation with either Mr. or Mrs. SILVERMAN that the SILVERMANS were to get one of these rugs and that another of the rugs was to be given to HARRY WHITE. She has no present recollection of any conversation during that particular period that would indicate that rug #3 was to be delivered to ALGER HISS or any other person.

MRS. TOMPKINS recalled that the SILVERMANS retained the rug with the red background and that the rug that was subsequently given to WHITE had an orange background. MRS. TOMPKINS related that she is positive that the WHITES received this particular rug as her sister was a maid at the WHITE residence in Bethesda, Maryland, and on Sundays, her day off, she would occasionally visit her sister at the WHITE home and on several of these occasions recalled seeing the rug with the orange background in the WHITE residence.

MRS. TOMPKINS recalled that she heard the name of HISS mentioned in the SILVERMAN household but she could not definitely recall the person

On May 12, 1949 KATHLEEN GOOSBY, a colored maid who presently resides at 509 Florida Avenue, N.W., Washington, D. C., was interviewed in the office of ALEX CAMPBELL in Washington, D. C. by SAAG THOMAS J. DONEGAN and AUSA THOMAS F. MURPHY.

MRS. GOOSBY related that she was employed as a maid at the 3210 P Street, N.W., Washington, D. C., residence of ALGER HISS for somewhat less than a year around the period of 1945. She related that on numerous occasions while she worked for the HISS family she had occasion to visit the back room on the main floor of this residence and described therein a desk that was right next to the door as you entered upon which was a large typewriter. She distinguished this from a small or portable typewriter. She observed photographs of numerous standard typewriters but was unable to pick out the Underwood typewriter. She recalls that on one occasion she saw ALGER HISS using this typewriter for a very brief period. She further recalled that this occasion was just subsequent to the time that ALGER HISS had returned from a long airplane trip (from Russia). She stated that this stood out in her mind because just previous to Mr. HISS' return, MRS. HISS was very alarmed and upset because the weather was very bad and she knew that her husband was going to take a long airplane trip.

During the time she worked at the HISS residence on P Street, N.W. she saw TIMMY HOBSON on two occasions but recalls that TONY HISS was a small child at that time and, of course, in the house continually.

It was observed that she was unable to recall the names of any persons who had visited the HISS household. She related that none of the HISS investigators or lawyers have talked to her to date.

On May 12, 1949 MRS. CORA MC COLLUM, presently residing at 3618 S Street, N.W., Washington, D. C., a baby sitter for the HISS family, was interviewed in the office of ALEX CAMPBELL in Washington, D.C. by SAAG THOMAS J. DONEGAN and AUSA THOMAS F. MURPHY.

MRS. MC COLLUM related that she was employed as a baby sitter by the HISS family while the latter resided at 3415 Volta Place, N.W. Washington, D. C. and later at 3210 P Street, N.W., Washington, D. C.

MRS. MC COLLUM was unable to recall ever having seen an upright Woodstock typewriter at the Volta Place residence but recalls that at the P Street residence there was a room in the back of the house, just off the living room, which contained numerous book shelves and with a standard upright typewriter placed on one of these book shelves. She recalls particularly that she would go into this room quite frequently to get a book to read while she was baby sitting and specifically recalls seeing this typewriter on all of the occasions she visited this room at 3210 P Street, N.W. over a period of approximately two years.

She is unable to recall ever having seen a portable typewriter in this particular room or as a matter of fact in any of the rooms in the HISS residences on Volta Place and P Street.

MRS. MC COLLUM related that none of the HISS investigators or lawyers have talked to her to date.

CHAMBERS related that PRISCILLA HISS had informed her at one time during their acquaintanceship that she first met ALGER HISS while she was a student at Bryn Mawr when she went on a trip to Europe. It was not readily apparent but either ALGER and PRISCILLA went in a group to Europe or they went in separate groups and met each other while in the same town or on a hiking or bicycle trip.

Mr. MURPHY requested that a check be made at the State Department to determine whether a passport was issued for ALGER and PRISCILLA HISS at about that period.

It is to be noted that PRISCILLA HISS graduated from Bryn Mawr College in 1924.

During a general discussion of this case, Assistant United States Attorney THOMAS F. MURPHY inquired as to whether the Bureau had obtained photostatic copies of the Masthead of the "New Masses" showing the name of WHITTAKER CHAMBERS as one of the editors. He was informed that copies of the magazine showing CHAMBERS as editor had been observed but it was not known at that time if photostatic copies had been made.

He suggested that if these photostats had not been obtained that efforts should be made to get them.

In this connection Mr. MURPHY also inquired as to whether the Bureau had obtained copies or photostats of the edition of "New Masses" which contained four stories written by WHITTAKER CHAMBERS in 1930 or 1931. The titles of these stories are contained in CHAMBERS' statement and it is suggested that efforts be made to obtain at least photostatic copies of the "New Masses" editions which contain these stories.

In this connection Mr. MURPHY also inquired as to whether the Bureau had obtained copies of the poems which CHAMBERS had submitted to SAMUEL ROTH. He suggested that if these had not been obtained that efforts be made to do so.

It is to be noted that SA JAMES R. SHINNERS obtained photostatic copies of an article written in "New Masses" by CLIFTON FADIMAN and also observed the Mastheads of various editions of this magazine. It is also noted that Agent SHINNERS interviewed ROTH.

It is suggested that the information requested by MURPHY be obtained as soon as possible.

During a discussion of this case, Mr. DONEGAN and Mr. MURPHY have indicated that PRISCILLA HISS will probably be a witness in instant case and that they desire that as much background information as possible be obtained concerning her.

During the interview of Mr. and Mrs. CHAMBERS by AUSA MURPHY and the writer on May 11, 1949, Mrs. CHAMBERS related that PRISCILLA HISS at one time told her she was employed at the Museum of Modern Art in New York City.

As set forth in another Memorandum, PRISCILLA HISS is supposed to have met ALGER HISS in Europe sometime probably prior to 1924 when PRISCILLA was attending Bryn Mawr College.

On Page 119 of the Summary Report of SA JOSEPH M. KELLY dated March 30, 1949 there is set forth some background information concerning PRISCILLA HISS. MURPHY has suggested that a check be made at her various places of employment to determine what information is available concerning her.

In this connection Mr. MURPHY has made available to this Office a first draft of a chapter of a proposed book written by VICTOR LASKY. This draft deals with the early background of both PRISCILLA and ALGER HISS and will be of some assistance in handling this request.

Reference is made to the telephonic request of Special Agent THOMAS SPENCER on May 5, 1949 requesting that the Navy file of TIMOTHY HOBSON be reviewed in an effort to determine if there have been any inquiries made concerning his record outside of FBI inquiries, since HOBSON was discharged October 17, 1945 from the Navy.

The writer reviewed the Navy file of HOBSON at the Naval Records Management Center, 605 Stewart Avenue, Garden City, New York on May 5, 1949 and found no indication in the file that any requests had been made to review same outside of the FBI since 1945.

Naval Lieutenant B.G. JONES who is in charge of the records advised that he recalls noone attempting to review the record of HOBSON outside of the FBI. He recalled that after the FBI first checked the record, several days later he received a telephone call from a man named RUTLEDGE at the Bureau of Naval Personnel in Washington, D.C. saying that several FBI agents had called in Washington requesting the file of HOBSON and wanted the file sent to Washington. This was done and the file was returned to Garden City.

H.C. EATON who signed the medical report can be located by Washington Field Office through the Bureau of Naval Personnel inasmuch as he is or had been a Naval Officer and Officer records are not stored at Garden City. General inquiries at Garden City revealed noone who recalled him.

During the investigation of this case, WHITTAKER CHAMBERS informed Agents of this office that either investigators or lawyers for ALGER HISS had been to "Time" magazine and obtained typewriting specimens and other material from CHAMBERS' personnel file at that magazine. As will be recalled, the original evidence in this case was turned over to the HISS lawyers for examination and during the course of the examination in Pittsburgh, the HISS document examiners compared a plain sheet of white paper with the original documents in this case; possibly indicating that an effort was being made to determine the age of the original documents with that of the plain sheet of paper in the possession of the HISS document examiners.

There appears some indication that the blank piece of paper used by the HISS document examiners may have been obtained from the personnel file of CHAMBERS at "Time" magazine.

It is therefore requested that inquiries be made at "Time" magazine to determine if possible what material was supplied to the HISS investigators by "Time" personnel.

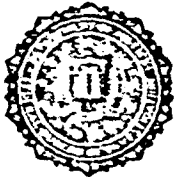

On May 11, 1949, Mr. and Mrs. JAY DAVID WHITTAKER CHAMBERS were interviewed at their farm located at Westminster, Md., by Assistant United States Attorney THOMAS MURPHY of NYC and SA THOMAS G. SPENCER of the NY Office.

During this interview, Mr. MURPHY expressed interest in a motor vehicle driver's license which Mrs. CHAMBERS recalled obtaining sometime during 1937 in Baltimore, Md.

At the request of Mr. MURPHY, inquiry was made at the Department of Motor Vehicles, Baltimore, Md., and it was learned through Miss MARILYN SARUBIN, Clerk, that on 6/16/37, ESTHER CHAMBERS, 3310 Auchentoroly Terrace, Baltimore, Md., submitted an application for instruction and examination permit to the Department of Motor Vehicles, Baltimore, Md. A description of Mrs. CHAMBERS appears on this application, as well as her birthdate, namely June 25, 1900. The application reflected that the driving instructor for Mrs. CHAMBERS was one FRANK F. BAROCK, 2516 East Preston St., Baltimore, Md., who utilized a vehicle in his instruction having 1937 Maryland license 449-285.

Mrs. CHAMBERS took her operator's examination and driving test 6/23/37, using in this test a Ford automobile bearing 1937 Maryland tags 98-387. She was issued operator's permit #697499 on this date, 6/23/37.

The records of this Department reflect that Mrs. ESTHER CHAMBERS applied for a duplicate operator's permit on an unknown date due to a change of address to Bixler's Church Road, RFD #3, Westminster, Md., and was issued a duplicate operator's card bearing the number originally issued to her, #697-499. On the reverse side of this card appears the number 266421, which is merely a file number of the Department of Motor Vehicles reflecting that a duplicate operator's permit has been issued. Mrs. CHAMBERS has in her possession at the present time this duplicate operator's certificate bearing both of the numbers reflected above, the date of issuance being October 29, 1940. According to her, this duplicate operator's permit was obtained due to the loss of her original driving permit.
