At 10:50 am on May 23, I advised Mr. Leo Laughlin of the Bureau that this case had come up before Judge Kaufman this morning and that the government and the defense had both stated they were ready. However, Judge Kaufman advised that he would hear this case and that he was not able to do so this week. Consequently, he was setting the time for trial as 11:30 am on May 31, 1949. Judge Kaufman indicated that the case would definitely go to trial at that time. I advised Mr. Laughlin that a motion was to come up before Judge Kaufman this morning on this case, which we understood pertained to a request for depositions from Ambassador PHILIP JESSUP, now in Paris, France, and from Governor ADLAI STEVENSON of Illinois, but that the judge held off hearing this motion until the Criminal Calendar had been completed. I advised Mr. Laughlin that we would inform the Bureau as to the results of this motion later on in the day.

Re New York teletype dated 1/19/49 regarding EPHRAIM SCHWARTZMAN,
Aka Fred Schwartzman, Fred Coleman.

On March 24, 1949 Mrs. A. MONEYER, 220 East 6th Street, Ontario, California advised that EPHRAIM SCHWARTZMAN had been rooming in her house for several months and she was suspicious of him, because he claimed to be a cattle buyer, but is not the type, claimed to be from Russia and spoke with a foreign accent, and told her numerous stories which appeared to be false.

On April 30, 1949 she furnished a notebook which she had obtained from his room and photographs of which are being enclosed for your information. The notebook appears to contain an essay by SCHWARTZMAN on Communism and there are indications that he might still maintain an interest in these matters.

Mrs. MONEYER advised that SCHWARTZMAN left on May 15, 1949 and furnished the forwarding address of Grand Mountain Hotel and Camp, Grenfield Park, New York.

On the afternoon of May 23, I spoke to Mr. H. B. Fletcher of the Bureau and advised him that Mr. T. J. Donegan had discussed with me the matter of the Woodstock typewriter allegedly recovered by the defense. Mr. Donegan wanted to know what our attitude was on the matter of the government approaching the defense to get samples of typewriting from this machine. He advised that he and Mr. Murphy are of the opinion that it was not desirable to approach the defense or to let the defense know that we knew they had the machine, but he and Mr. Murphy did not want to put the Laboratory document examiner in a difficult position if the Laboratory feels that it should have samples from this machine. He advised that in the event the Laboratory feels that it should have samples from the machine, he and Mr. Murphy will reconsider, although he is not sure that even under such circumstances they should approach the defense.

Mr. Fletcher was advised that I had told Mr. Donegan that the Laboratory had identified the CHAMBERS documents (Q6 through Q69) as having been typed on the same typewriter as the typed application for Federal employment form #57, signed by STAFFORD J. McQUEEN, and that it was my impression that the Laboratory was rather definite about the extent of its testimony. Mr. Fletcher advised that he would discuss this at the Bureau from the standpoint of the Laboratory and would let me know the Bureau's reaction.

Mr. Donegan was so advised.

Mr. Donegan called the writer this morning and advised that day he had received a letter from RICHARD CLEVELAND CHAMBERS' lawyer in Baltimore. This letter pointed out that EDWARD McLEAFAN HISS' attorney had been requesting for the past two weeks that CLEVELAND expedite the signing of the Baltimore depositions by CHAMBERS. Mr. Donegan advised that since these depositions contain some inaccuracies it would be highly undesirable to have CHAMBERS sign them in view of the fact that the trial in this case is scheduled to begin May 31. He suggested that this office communicate with the Baltimore Office and request that an agent from that office contact CHAMBERS and point out diplomatically to him the undesirability of having these depositions signed at this time.

The writer telephonically communicated with SA Stanley Ross in the absence of ASAC Robert Lally, and informed him of Mr. Donegan's desires. Agent Ross stated that he would have this matter handled immediately.

Re: EDWARD H. FEARON

On April 12 and 13, 1949, EDWARD FEARON made an examination of the 69 Baltimore Documents as well as three standard specimens at his office 502 Granite Building, Pittsburgh, Pennsylvania. The writer was present during this examination.

During the course of this examination, Mr. FEARON advised the writer that it was his understanding that he had been retained in this case through LLOYD STRYKER, attorney for the defense. Mr. FEARON stated he had done work for Mr. STRYKER in the past.

The Bureau has advised that the files indicate that EDWARD H. FEARON testified in New York on June 17 and 18, 1946 in the Lustig Case and that he gave an opinion diametrically opposed to that of a Bureau examiner. The files reveal that FEARON was 67 years of age in June, 1946 and that he had testified in many civil and criminal cases in behalf of the defendants and in behalf of the Government. His appearance was indicated to be rather poor and his voice squeaky and uninteresting, and he is known to have rambled on in an incoherent style. He is known to have been an instructor in book-keeping in a Pittsburgh high school until 1943 at which time he retired. In May, 1941, he received newspaper publicity for his work in the handwriting field in "Collier's" magazine. According to the Pittsburgh Office, he has been commended and denounced for his work alternately.

He is referred in the Martindale Hubbell Law Directory for the year 1949, in Volume II, Page 1453, as having his office at 502 Granite Building, 6th Avenue and Wood Street, Pittsburgh, Pennsylvania, telephone Atlantic 2732. It states in this directory that he is a charter member of the American Society of Questioned Document Examiners.

At 3:05 p.m. today I spoke with Inspector H. R. Fletcher of the Bureau with reference to the deposition to be taken by the defense from Governor ADLAI STEVENSON of Illinois, who is to be used as a character witness for the defense. I advised Mr. Fletcher that the Government attorneys have until midnight tonight to place in the mail their cross interrogatories in connection with the deposition, and they had requested us to furnish them with any information available in the Bureau files concerning Governor STEVENSON. Mr. Fletcher stated that he would endeavor to comply with this request. I also informed him that I was making the same request of our Chicago and Springfield Offices.

At 3:10 p.m. I spoke with Special Agent I. A. Ryan of the Chicago Office, furnishing him with the same information and requesting him to forward a teletype as soon as possible. I also requested that he call the Springfield Office, requesting that division to furnish the same information, upon being advised by him that Governor STEVENSON had been out of Chicago for some time and a possibility existed that the Springfield Division would have more current information on him. I requested that we be advised by teletype even if no information is available. He said this would be done.

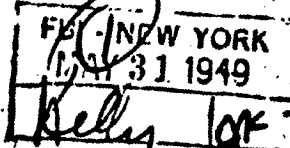

"The Great Crusade" by Gustav Regler, with a preface by Ernest Hemingway. Translated by Whittaker Chambers and Barrow. New York: Longmans Green and Company. (An autobiographical novel about the Spanish Civil War)

The New York Times Book Review dated 9-29-40, written by Fred T. Marsh contains a book review relative to "The Great Crusade," and excerpts from this book review are set out as follows:

"Here is another excellent book of the Spanish Civil War - - -. The writing, though various, is always expressive of a profound sadness, as every book makes felt the emotional realization of the meaning and significance, the profound sense of historical prescience, that animated the rank and file of the Loyalist armies. These men were betrayed - - - by forces outside Spain. Whence the deep dejection - - - of impending doom for everything that these writers often consciously betray. The book deals with the victorious six months (1936-37) during which, in battle after battle, - - - the Italian divisions were defeated. Regler, Hemingway tells us, a German intellectual and refugee, was with the Polyglot, International 12th Brigade, which, cooperating with the Holy German 11th, was in the thick of these actions. Regler himself is the 'Commissar' of the heroic 12th, calling himself Albert, a self-portrait of unusual objectivity. The most brilliant passage of the novel - - - deals with the intellectual and emotional responses among the men and their leaders, who are Communists, over the Russian treason trials - for there are very many more ardent young Communists proportionately - - - in these two International Brigades than in the Spanish Army. Albert himself, who has been in Russia and at the home of Corky, met Radek and Bukharin, passes through his greatest period of dejection. And among the men it is beginning to be asked, 'Where are the Red battalions and supplies?' 'The Great Crusade' is to be recommended especially for those who have read and thought a good deal about the Spanish War."

"'The Great Crusade' by Gustav Regler concerns itself with the golden age of the International Brigades in that battle of Spain that was the first great battle of the present war. Mr. Regler saw it, fought in it, lived through it, and has put it down on paper as it was. He has done so in the form of a novel - a novel that has great truth, a remarkable variety of human beings, and little flag waving. The men of the International Brigades came from many countries to fight for what they believed, and against Fascism. Mr. Regler is an honest novelist - in his picture of revolutionary Spain he includes the cowards, the imbeciles, and the traitors. The fear of treason is almost worse than treason itself, yet, by the nature of things, it is bound to exist in revolutionary armies. The trouble is that it is so often the wrong people who get shot. 'The Great Crusade' is a moving and crowded story of men in action. It takes place before the tide is turned and the tanks and planes crushed Loyalist Spain. Anyone who wants to know about that battle should read it - indeed anyone who wants to know why men fight Fascism should read it."

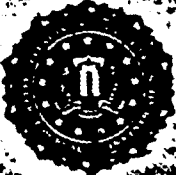

Mr. Donegan is desirous of ascertaining the background and other information concerning his ability and standing as a psychiatrist in the event that Judge Kaufman allows BINGER to remain in Court during the trial and is later offered as a witness for the defense.

On the afternoon of June 2nd, Mr. Harbo of the Bureau called to advise that Laboratory Examiner Fred Webb had developed two slides in connection with his forthcoming testimony regarding the identification of two rolls of film turned over by Chambers as film which had been taken on Inslerman's camera. Mr. Harbo advised that these slides had turned out very well and would reflect the points on which the identification was based. He advised that before Webb went ahead and made 22 additional slides he wanted to find out whether we still considered this a matter of importance. I advised him that the film had been introduced into evidence this afternoon at the trial and therefore undoubtedly it was still a matter of importance. He advised that Webb would go ahead and develop the other slides unless advised to the contrary.

On the afternoon of June 2nd I spoke to Mr. Donegan concerning this. He advised that the slides were desired.

Arrangements should be made for a projector and a six-foot screen for use of Webb in projecting these slides in the court room. In the event we do not have such a projector and screen, the Bureau is to be advised so that Webb can bring one up with him.

This would be necessary where a report has not been submitted to the New York Office by the other office for submission to the United States Attorney. While all of this has undoubtedly been brought to the attention of the United States Attorney from day to day; it would be well to include a memorandum for his attention definitely setting out just what has been reported. should particularly cover the information presented as to the finding of the Woodstock typewriter and now in possession of the defense attorneys. As has been the practice, Mr. DONEGAN and Mr. MURPHY should be currently advised of any and all information inasmuch as they will need this in preparing their examination of the witnesses to be called.

There have been a number of requests made upon us by Mr. DONEGAN and Mr. MURPHY for certain information, investigation, and the location of other material. Each of these items should be examined to determine which have not as yet been accomplished and as of Friday, May 27, 1949, any offices not replying and furnishing information desired should be advised by teletype to do so as of that date.

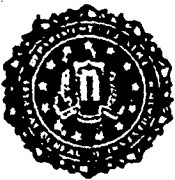
In connection with the trial of ALGER HISS each day any unusual situation arising or anything of particular importance developed, the Bureau should of course be immediately advised of this. This morning, before trial, JUSA THOMAS MURPHY and J. J. DONEGAN, together with LLOYD PAUL STRYKER and EDWARD McCLAIN, had a conference with Judge KAUFMAN in connection with the jury foreman. MURPHY strongly urged that JAMES be withdrawn from the jury and one of the alternates put in his place. Judge KAUFMAN stated that he did not believe that sufficient information had been supplied him to indicate that JAMES had been contaminated, nor was there sufficient information to warrant citing him for contempt. He did state, however, that, if the defense was willing, he would substitute one of the alternates for JAMES. STRYKER double-talked for several minutes and eventually refused to agree to this substitution. Accordingly, KAUFMAN stated that he would not remove JAMES from the jury.

On June 5, 1949, AUSA T. F. Murphy advised the writer that he had had a conversation with HORACE SCHWALL. SCHWALL advised Murphy that during the early stages of the HISS attempts to locate the Woodstock typewriter, ROSENWALD, who is assisting in the investigation, requested him to find "an old Woodstock typewriter." SCHWALL stated that he believes that some inquiry was made at the typewriter firm of ADA' KUNZE, located at the corner of Fulton Street and Broadway, but cannot recall whether this firm ever supplied the HISS people with an old Woodstock.

Mr. Murphy has suggested that inquiry be made as soon as possible at the typewriter firm of ADA' KUNZE for any information indicating that the HISS attorneys or HISS himself arranged for the purchase or rental of a Woodstock typewriter some time probably in December, 1948, or January and February of this year.

MEMORANDUM

Mr. Alger Hiss was interviewed at his request at the Federal Bureau of Investigation on March 25, 1946, at 2:30 P.M., at which time he furnished the following information:

Honorable James F. Byrnes, Secretary of State, spoke to Hiss regarding the report of two separate committees "on the Hill" which had listed persons belonging to subversive groups and both had listed Hiss. It was Hiss' recollection that the two committees might possibly have been the House Committee on Un-American Activities and a Subcommittee of the House Military Affairs Committee. He stated that Mr. Byrnes indicated that one of these committees had working for it a former Agent of the FBI.

At that time Mr. Byrnes asked Hiss about possible membership in the National Lawyers Guild and about his association with Lee Pressman. Hiss stated that he told Mr. Byrnes that he used to know Pressman very well but had had no contacts with him recently. He also mentioned to Mr. Byrnes that he had been interviewed several years ago by a representative of the FBI with regard to alleged membership in subversive organizations. Mr. Byrnes advised Hiss that he had discussed this matter with the Attorney General and with the Director of the FBI.

Hiss stated that Lee Pressman was a classmate of his at Harvard Law School and had served on the Harvard Law Review with him. After graduation, Hiss had seen little of Pressman until they both were employed by the Department of Agriculture. Jerome Frank had selected Hiss for employment in the Department of Agriculture either because of a recommendation by Pressman or by Felix Frankfurter, who was a former law professor of Hiss'. During the time that Pressman and Hiss were employed by the Department of Agriculture, they were very close, but after Pressman left to go with the CIO, Hiss saw practically nothing of him.

With regard to membership in subversive organizations, Hiss advised that he was not much of a joiner but could have been on the mailing lists of organizations of various kinds, but he was unable to say whether this was a fact. He does recall that for a period of five or six months prior to his employment with the Department of Agriculture, he was a member of the International Juridical Association which he characterized as a small group interested in labor law. Hiss denied that he was ever a member of the Washington Committee for Democratic Action and did not believe that his wife was ever a member. He was of the impression that his wife could have been a member of the League of Women Shoppers because he thought that some of her friends had been members of that organization. She also could possibly have belonged to some grocery cooperative in Georgetown. Other than those two

organizations, he was unable to say to what groups his wife, Priscilla Fensler Hobson Hiss, could have belonged, although he did recall that his mother, Mrs. Mary Hiss, who resided in Baltimore, wrote him several years ago stating she had joined some group, the name not recalled by him at this time.

With reference to specific instances which have occurred to him possibly prompting reports about him, he mentioned the following:

While in San Francisco at the United Nations Conference on International Organization, he was advised of a report received by the FBI that two individuals connected with a Spanish Refugee Aid organization, name not recalled, who had called on Hiss officially, had reported back to their organization that Hiss had advised them on certain matters. Hiss stated he checked his records and found that Freida Kirshway had sent two people, one of whom was a local lawyer, who had a resolution regarding Franco, to Hiss' office to find out certain procedural matters. Hiss stated that he advised these two individuals that he couldn't handle the matter and explained to them the procedural limitations of the secretariat of the UNCIO. Their resolution regarding Franco was later introduced by the Mexican Government representatives, to the best of his recollection.

Another instance which came to his mind was told him by his former chief of the State Department, Stanley Hornbeck, who is now the Ambassador to the Netherlands. At the time Hiss first came into Hornbeck's office, Hornbeck told him that someone, name unknown to Hiss, had stated that Hiss was "a red". Hiss stated that Hornbeck paid no attention to this report.

During the past year and a half or two years, since the Dumbarton Oaks Conference, many employees of the State Department have made speeches to various groups at the instructions of their superiors in the State Department. One of the individuals making such speeches has been Hiss. To his knowledge there have been accusations that State Department representatives have been "whitewashing the Russians". Hiss thinks there may have been some such allegations regarding him.

In July, 1945, according to Hiss, a friend connected with Reader's Digest advised him that Isaac Don Levine had written an article claiming that at the Yalta Conference, Hiss had persuaded the late President Roosevelt to agree to the admission of the Ukraine and Byelorussia to the United Nations at a meeting where Roosevelt, Hiss and Stalin were present. Hiss said that this was a fabrication because he has never met with Roosevelt and Stalin alone, and besides he does not speak the Russian language.

Miss stated that Mr. Byrnes had mentioned William F. Stone, now in the Department of State, as another individual whose name was mentioned by the two House Committees. Miss advised he had known Stone for a long time but knew of no Communist Party connections on the part of Stone. He did recall, however, that for a year or two he had been associated with Stone, then a representative of the Foreign Policy Association, in a supper club headed by a Mrs. Moorehead, also with the Foreign Policy Association, who lives on R Street in Washington, D. C., and which consisted of representatives from various government departments who met once or twice a month and heard various speakers on international affairs. He recalls that Lee Pressman represented labor in this supper club and possibly Mordecai Ezekiel represented the Department of Agriculture. He recalls that there was someone from the Department of Interior but was unable to recall the identities of other individuals with whom he met during this two-year period. The meetings, according to Miss, were often held in the old Evergreen Cafeteria in the Department of Agriculture Building.

Miss was questioned specifically whether he was at this time or had at any time in the past been a member of the Communist Party and he emphatically stated he had not. He was asked specifically whether he had had any association with the Communist Party at any time in the past and he denied any such contact or association. He was asked specifically whether he had any friends whom he knew to be members of the Communist Party and advised that he knew of no friends who were members of this Party. However, he had heard many people say that Lee Pressman was either a party member or followed the party line, but Miss did not know this to be a fact.

Mr. Miss was specifically asked whether he had any association with any person or persons who might be members of any subversive organizations which association might have caused the belief to exist that he likewise was a member of any such subversive organization, and he stated that he knew of no association on his part with any persons which would lead to this conclusion.
