MEMORANDUM:

Re: JAHAM

This afternoon ASAC Lally, Baltimore, was telephonically furnished with pertinent information concerning the testimony offered yesterday at the trial in instant case by J. KELLOGG SMITH, wherein SMITH claimed that HOBSON was at camp at Chestertown, Maryland, during July and August, 1937; that his leg, which he had broken in July, was still bothering him and he was using crutches which he abandoned towards the end of July; further, as to SMITH'S testimony that ALGER HISS arrived at Chestertown at the beginning of his vacation, July 16, and remained at Chestertown, visiting the camp daily without exception through August 16, 1937.

LALLY was requested to have WHITTAKER CHAMBERS reinterviewed concerning his recollection (1) of the condition of TROY'S leg during the Spring and Summer of 1937; (2) whether or not he recalled that he was still using crutches in the Summer of 1937; and (3) whether or not the HISSES' presence at Chestertown might refresh CHAMBERS' recollection of the manner in which the Peterboro trip was initiated. It was pointed out to Lally that CHAMBERS to date cannot clearly recall how this Peterboro trip started. He is uncertain as to whether or not it was commenced from the HISSES' home in Washington, whether they picked him up in Washington, or whether they picked him up at Baltimore. It is believed possible that the above facts testified to by SMITH might refresh CHAMBERS' recollection as to other occurrences on the trip. Lally was also asked to have CHAMBERS requestioned concerning the possible issuance of any checks by the HISSES on the Peterboro trip.

RE: JAHAM

At 11:10 A. M. on June 18, 1949 Mr. PAUL GILMORE of the "Williamsport Sun" newspaper, Williamsport, Pennsylvania, telephonically contacted the writer to advise that he is presently preparing an article concerning HENRY JULIAN WADLEIGH who was a witness at the above-captioned case in New York City.

Mr. GILMORE explained that his research disclosed that ALBRA WADLEIGH was pastor of the Christ Episcopal Church located in Williamsport, Pennsylvania, from 1865 to 1869; further, that HENRY JULIAN WADLEIGH'S father, namely, HENRY RAWLE WADLEIGH, was an Episcopal minister located in Greenfield, Massachusetts. For the purpose of Mr. GILMORE'S newspaper article, he desired to know whether ALBRA WADLEIGH is the grandfather of HENRY JULIAN WADLEIGH, the witness in instant case.

Mr. GILMORE inquired as to whether the investigation conducted by the FBI disclosed the desired information, whereupon the writer advised Mr. GILMORE that he was not personally acquainted with the history of HENRY JULIAN WADLEIGH'S ancestry. Mr. GILMORE was advised that his inquiry would be furnished to the proper authorities in this office and if the information was such that it could be furnished to Mr. GILMORE, this office would communicate with him.

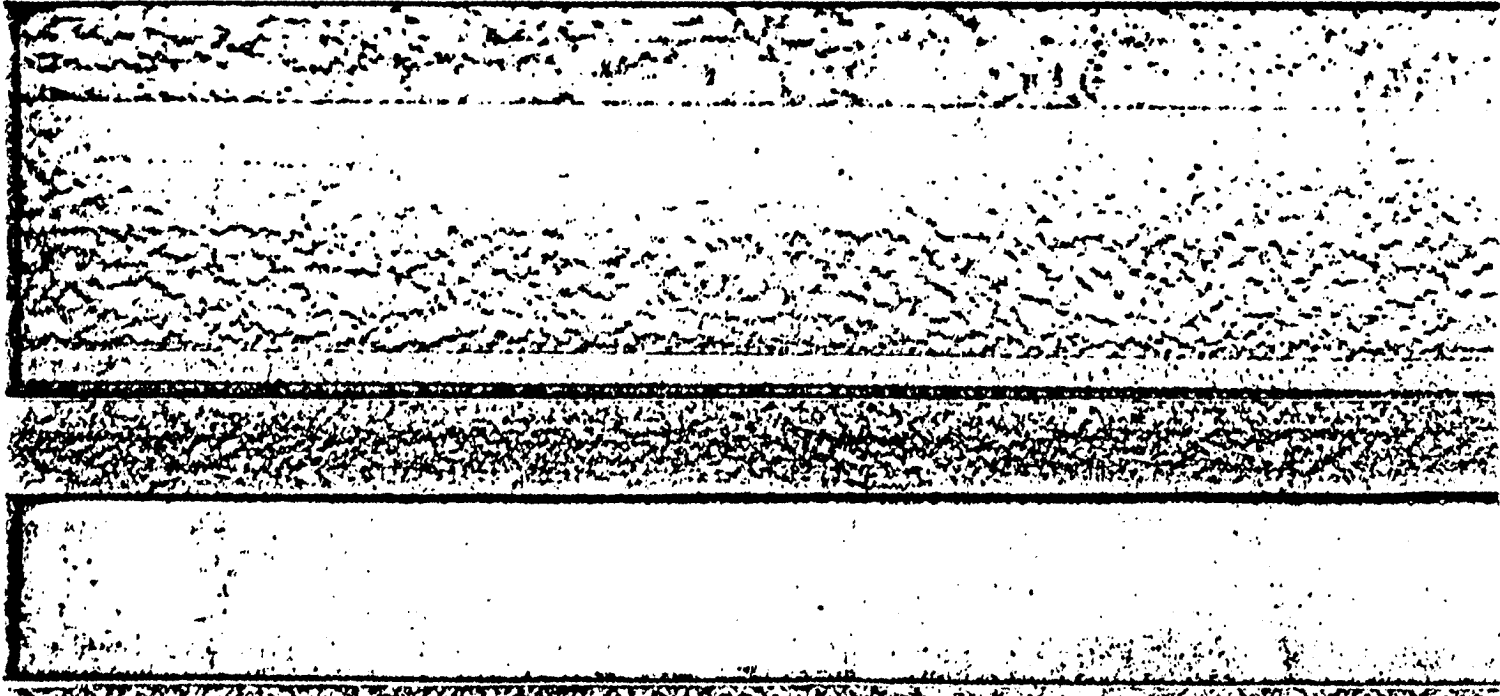

At 1:15 pm, I spoke to SA Nixon of the Washington Field office and requested that NICHOLSON be contacted and that he be requested to be in New York by noon on June 13 to testify in accordance with the summary report; further, that he would be given a subpoena upon arrival. At 3:15 pm, SA Nixon called back and stated that NICHOLSON would be available. Mr. Donegan was so advised.

It is noted that Mr. Donegan also desired to know whether Mr. WALTER SCOTT of the State Department would be cooperative as a witness. SA Zander of the Washington Field office, at my request, made inquiry concerning SCOTT. At 7:00 pm on June 10, Agent ZANDER advised that he had inquired about SCOTT and ROBERT L. BANNERMAN, formerly Chief of the Security Division of the State Department who was very cooperative with the Bureau, said that SCOTT was one thousand percent cooperative with him when he was in the State Department, and that he had no reason to believe that SCOTT would have changed. At 5:15 p.m. this date, Supervisor DELAVIGNE of the Washington Field Office called and furnished the following information:

Agents of the Washington Field Office contacted the House Committee on Un-American Activities and determined that the stenographic company which transcribed the minutes of the House Committee hearing on August 25, 1948 was WARD & PAUL, 1760 Pennsylvania Avenue, N.W., Washington, D. C. The Agents then contacted WARD & PAUL COMPANY and determined that B. H. FIRSHEIN was the steno who transcribed CHAMBERS' testimony on August 25, 1948. The Agents had the steno read his notes for a considerable portion prior to the word "dent". When the steno in reading his notes arrived at the word "dent", he was stopped and asked if that was the correct word. FIRSHEIN stated that his notes reflected a correction mark at this point where he advised the notes appeared to have the word "Balt" rather than the word "dent". He also stated that he recalled having asked somebody in the hearing room what word CHAMBERS had used in this connection and had been advised by this unidentified person to insert the word "dent" in his notes. FIRSHEIN has his notes and is willing to testify on the above information. The Washington Field Office will confirm this information by teletype today.

A German adventurer and for a short time nominal King of Corsica, born at Cologne. Educated Court of France, served first French Army and then in that of Sweden.

Neuhof's capacity for intrigue was great and realising this, Baron de Goertz, minister to Charles XII of Sweden, sent him on a mission to England and Spain to negotiate with Cardinal Alberoni. His reports to have deserted his wife returned to France became mixed up in John Law's financial affairs. He later wandered about Portugal, Holland and Italy.

At Genoa made acquaintance of prisoners (Corsican) and exiles, persuaded them if he were made King of Island he could free them from Genoese Tyranny. In March 1736 proclaimed

King Theodore I when he landed, he
was finally defeated in the war

He was arrested for debt in London

At 10:45 this morning, Judge Kaufman announced that previously the defense had been allowed to inspect the Grand Jury testimony of WHITTAKER CHAMBERS taken on October 14 and 15, 1948 before the GJ in New York City in view of the fact that certain inconsistencies were contained therein directly in conflict with testimony he subsequently gave to the Grand Jury and in the instant case. At the same time, the defense asked for permission to inspect two oral statements given by CHAMBERS to the FBI in 1942 and 1945. Kaufman told the jury that he had examined these two letters and had found certain inconsistencies therein. He mentioned that the two oral statements were dated May 14, 1942 and June 26, 1945. He stated that when CHAMBERS was interviewed by agents of the FBI on these dates he stated that he had been a member of the Communist Party from 1924 to the Spring of 1937, and that in describing his activities at no time did he make any reference to the fact that the defendant, ALGER HISS, gave him any confidential documents and stated in substance when he was interviewed on June 26, 1945 that in connection with his courier activities, when asked if he had any indication he was active or participating in a Soviet espionage ring, he replied that he did not suspect this and he thought he was only promoting the Communist movement in the United States.

Mr. Murphy requested that Judge Kaufman inform the jury that the two statements referred to, that is May 14, 1942 and June 26, 1945, were oral statements. The judge so instructed the jury. He then related that the government had stipulated that if CHAMBERS were recalled and that if the agents who took these oral statements from CHAMBERS were to testify, they would testify to the facts as he related above. Kaufman stated that he also examined the three signed statements executed by WHITTAKER CHAMBERS before agents of the Federal Bureau of Investigation on December 3, 7 and 8, 1948. He told the jury that after reading the three statements taken in December, 1948, he found no inconsistencies in these statements as related to the testimony given by CHAMBERS in the instant trial and therefore, he denied the defense motion to inspect these statements. The judge therefore returned the three signed statements, as well as the two letters in 1942 and 1945 to Mr. Murphy.

"Mother Mary" by HEINRICH MANN was scanned by the writer at the New York Public Library and a brief summary of this book is as follows:

"Mother Mary" concerns itself with the depression in Germany after World War I and the action takes place in the vicinity of Berlin, Germany, in 1925, among families of the upper class. President SEEHASE, the head of a large industry in Berlin, made bribes to build his industry and General von LAMBART had assisted him from the beginning in building this industry. President SEEHASE released the General from his position which placed his family in a poor financial condition. The General's son, VALENTINE von LAMBART, retained his position in the industry.

Baroness HARTMAN, a rich neighbor to the General, a widow who married for title and money, recognized VALENTINE as her son; that shortly after his birth she left the baby on a fountain at the General's house and she saw a man take the baby into the General's house. VALENTINE told the Baroness of his boyhood including a Communist friend who, on one occasion, agreed to go to his house and on the way boarded a train. VALENTINE felt happy over it but was afraid of himself and thought, "You shouldn't love him so much". His friend disappeared.

Princess ADELE, a young girl, lived in VALENTINE'S house and, on one occasion, VALENTINE caught the Princess running around the darkened house naked. Please be advised that on Friday, May 20, 1949, HENRY JULIAN WADLEIGH telephonically advised that on May 18, 1949 when he was in New York City being interviewed by SAAG T. J. DONEGAN and USA MURPHY, two attorneys known to him as DAVIS and SHAPIRO representing ALGER HISS, visited his home and attempted to elicit from his wife the date of WADLEIGH's departure to Turkey, which date is in 1938. WADLEIGH advised that his wife was unable to supply the attorneys with this information and did not wish to cooperate with them.

On Thursday, May 19, SHAPIRO telephonically contacted WADLEIGH and asked if he would supply this information. WADLEIGH replied that, under the advice of his attorneys, he would furnish no information whatsoever to SHAPIRO or DAVIS. SHAPIRO asked if he would make one exception and give to him, SHAPIRO, the date of his (WADLEIGH's) departure for Turkey. WADLEIGH replied to SHAPIRO that he would make no exceptions and thus closed the conversation.

WADLEIGH advised on May 20, 1949 that he believes he sailed aboard the S.S. President Harding from New York City on March 10, 1938 for Turkey. He recalls that he furnished substantially the same information to Mr. MURPHY but advised that he does not think he furnished MURPHY with the name of the vessel. WADLEIGH observed, however, that it may have been that he returned from Turkey aboard the President Harding, but he is substantially certain that his outgoing voyage was made on a ship of the President Lines. He also said that his date of departure could have been several days earlier than the 10th, but he is fairly positive that it could not have been later than March 10.

The above data is furnished for the information of the Bureau, New York Office and SAAG DONEGAN.

At the request of Mr. Donegan and Mr. Murphy, who are handling the HISS trial, I spoke to Mr. Ken Delavigne of the Washington Field office on the afternoon of June 10, 1949 to advise him that the name of JOHN PEURIFOY, Assistant Secretary of State furnished as the person in the State Department competent to testify concerning the secrecy and confidential nature of the State Department documents in 1938, does not appeal to the prosecuting attorneys inasmuch as there is a probability that PEURIFOY, upon cross-examination, will be turned into a character witness for HISS. Therefore, it is desired that another representative of the State Department be used to testify concerning these documents. WALTER K. SCOTT, Assistant under PEURIFOY, was mentioned by the Washington Field office as also qualified to testify in this respect. I requested Mr. Delavigne to have Agent Zander check to see whether SCOTT was disposed in a friendly manner towards HISS or whether it would be safe to use him as a witness from the State Department. I also inquired whether DONALD L. NICHOLSON, Chief of the Division of Security in the State Department, would be competent inasmuch as Donegan said NICHOLSON was a former Bureau agent and very well disposed towards the Bureau. Mr. Delavigne advised that NICHOLSON had originally turned these documents over to the Bureau but at that time had stated that he would not be competent to testify concerning them as they came from another division in the State Department. I advised Mr. Delavigne that our problem was simply this: we need someone from the State Dept. who can testify concerning the secrecy and confidential nature of these papers in 1938 but we do not want someone who is favorably disposed towards HISS and therefore will be turned into a character witness for HISS upon cross-examination.

I also advised Mr. Delavigne that the 1937 State Dept. register reflected that one ROBERT T. GREENFIELD was a messenger under Assistant Secretary of State SAYRE and therefore was in the same group with HISS. I inquired whether GREENFIELD had been interviewed. Mr. Delavigne advised that he had not. I advised him that GREENFIELD should be interviewed as a possible witness and at the same time the Wash. Field office should find out if GREENFIELD has been subpoenaed by the defense. This request was made in accordance with instructions from Mr. Donegan.

Mr. Delavigne advised that they would get to work on these two items immediately and would call us tonight relative to SCOTT and would interview GREENFIELD over the weekend. I advised Mr. Delavigne that Mr. Murphy wants to call the State Dept. tomorrow morning to arrange for the proper official to come up here to testify.

The writer and SA ROBERT C. BLOUNT interviewed HORACE GREGORY, Professor of Poetry at Sarah Lawrence College, Bronxville, New York. Mr. GREGORY was interviewed in connection with investigation conducted in the case entitled, "JAY DAVID WHITTAKER CHAMBERS, was; ET AL; PERJURY; ESPIONAGE - R; INTERNAL SECURITY - R", New York file 65-14920.

During the course of this interview, Mr. GREGORY advised that he had formerly been very much in favor of Communism in the early 1930's. He said that he had associated with many liberals and people who were sympathetic towards Communism during that period, and that he had written articles for the "New Masses." During this period he made the acquaintance of JOSEPH FREEMAN, who was one of the editors of "New Masses", and became good friends with FREEMAN. Mr. GREGORY said that about 1936, he had become rather disillusioned with Communism because it restricted writers in their freedom of thought and expression. He advised that although he, himself, had never become an actual member of the Communist Party, he lost all his enthusiasm and sympathy for Communism about 1936. In that year he wrote an article which he said was published in the "New Masses", entitled, "Why I Am Not a Communist."

HORACE GREGORY related that he thereafter completely separated himself from Communism and lost many of his pro-Communist friends. He said that at present he is strongly opposed to Communism.

He related, however, that he had maintained friendship with JOSEPH FREEMAN even after this article had been written in 1936. He said that he had spoken about his disillusionment about the Communist Party to FREEMAN and FREEMAN had seemed rather sympathetic in 1936, even though

FREEMAN was at that time a member of the Communist Party, and one who was well known in the Communist movement.

GREGORY said about 1937, JOSEPH FREEMAN had written a book, "An American Testament", which was definitely very liberal and pro-Communist. This book, however, had met with disfavor in the Russian press. Despite this, FREEMAN remained a member of the Communist Party and active in Communist circles.

GREGORY said that he had taken a trip to Europe in 1939, and had returned to the United States about the end of September, 1939, a few weeks after the war had started in Europe. A few months later, that is at the end of 1939 or the beginning of 1940, JOSEPH FREEMAN came to him at his apartment, and FREEMAN at that time was in a very emotional state.

FREEMAN told GREGORY that he wanted to confide in GREGORY. FREEMAN said that he had broken with the Communist Party and that he was very much afraid for his life. FREEMAN further told GREGORY either that he had been approached to engage in espionage work for the Communists, or that he had engaged in espionage work for the Communists, and that he was very fearful for his life because he had ceased this work and had now broken with the Party.

GREGORY said that he could not recall specifically what FREEMAN had said about FREEMAN'S connection with Communist espionage, but that he definitely recalls that FREEMAN had told him about some connection FREEMAN had had with Communist espionage, and that this was one of the reasons why FREEMAN had completely broken with the Communist Party.

GREGORY advised that FREEMAN had also mentioned that he, himself, was dissatisfied with the Communist system, and with the Russian treatment of FREEMAN'S book, "An American Testament." However, GREGORY said FREEMAN told him that his break with the Party was due also to either by an approach made to FREEMAN for work in espionage, or the fact that FREEMAN had worked in espionage for the Communists.

GREGORY related that FREEMAN was at that time very much upset and he said that he, GREGORY, had spent most of his time trying to quiet FREEMAN down. He said, accordingly, that he had not paid close attention to what FREEMAN had told him about Communist espionage or FREEMAN'S participation in Communist espionage. However, GREGORY says that he definitely recalls that JOSEPH FREEMAN mentioned either that FREEMAN had been approached to engage in Communist espionage or had actually engaged in some espionage, and that, according to FREEMAN, had at that time broken with the Communist Party completely.

GREGORY says that he recalls that he had heard that JOSEPH FREEMAN had made two or three trips to Russia during the 1930's.

MORACE GREGORY said that at the present time he could recall no specific details concerning this discussion had by JOSEPH FREEMAN with him in the end of 1939 or beginning of 1940. He said, however, that he would think this matter over in an attempt to recall any further details.

GREGORY advised that JOSEPH FREEMAN is still a novelist and is still around New York City, although he has not seen him for some years. He advised further that JOSEPH FREEMAN had married a daughter of KARL WEIGAND, a writer for Hearst newspapers.

He said that he believes JOSEPH FREEMAN is now completely anti-Communist and he advised that he thought that FREEMAN might furnish any information that he had concerning his own participation in Communist espionage or being approached to participate in espionage. GREGORY said that he has a very high opinion of JOSEPH FREEMAN. GREGORY did state that he would prefer that FREEMAN not be apprised of the fact that GREGORY had furnished the above information.

It is noted that in the case entitled, "JAY DAVID WHITTAKER CHAMBERS, was; ET AL; PERJURY; ESPIONAGE - R; INTERNAL SECURITY (C) - R", JOSEPH FREEMAN was interviewed at the offices of EDWARD BERNAYS, 26 East 64th Street, New York City, on March 25, 1949.

At that time, JOSEPH FREEMAN advised that he was a former member of the Communist Party, and that he had been associated as editor with the "New Masses" in the past. It is believed that this person is identical with captioned subject.

It is noted that there are many references in the New York files to JOSEPH FREEMAN, but same were not reviewed by the writer.

It is suggested that the New York files be completely reviewed on JOSEPH FREEMAN; that thereafter HORACE GREGORY be reinterviewed for any further details that he can furnish in regard to the above discussion between JOSEPH FREEMAN and HORACE GREGORY in the end of 1939 or the beginning of 1940. It is also suggested that thereafter JOSEPH FREEMAN be interviewed completely in regard to any activity on his part in Communist espionage, or on the approach made to him to engage in Communist espionage, based upon his alleged statements to HORACE GREGORY.

HORACE GREGORY has advised that he can be contacted at Sarah Lawrence College, Bronxville, New York, until June 1st, and thereafter, for the remainder of the Summer he can be contacted at his home, Rookleigh Road, Palisades, New York, telephone number Piermont 2-0816.

In regard to HORACE GREGORY, there is a closed file in the New York Office, file number 100-91667. Furthermore, there is presently leads outstanding to consider the advisability of interviewing HORACE GREGORY in the case entitled, "COMMUNIST INFILTRATION OF YADDO, SARATOGA SPRINGS, NEW YORK; INTERNAL SECURITY - R", which leads are set out in the report of SA JOHN J. O'TOOLE, Jr., at Albany, New York, dated March 31, 1949.

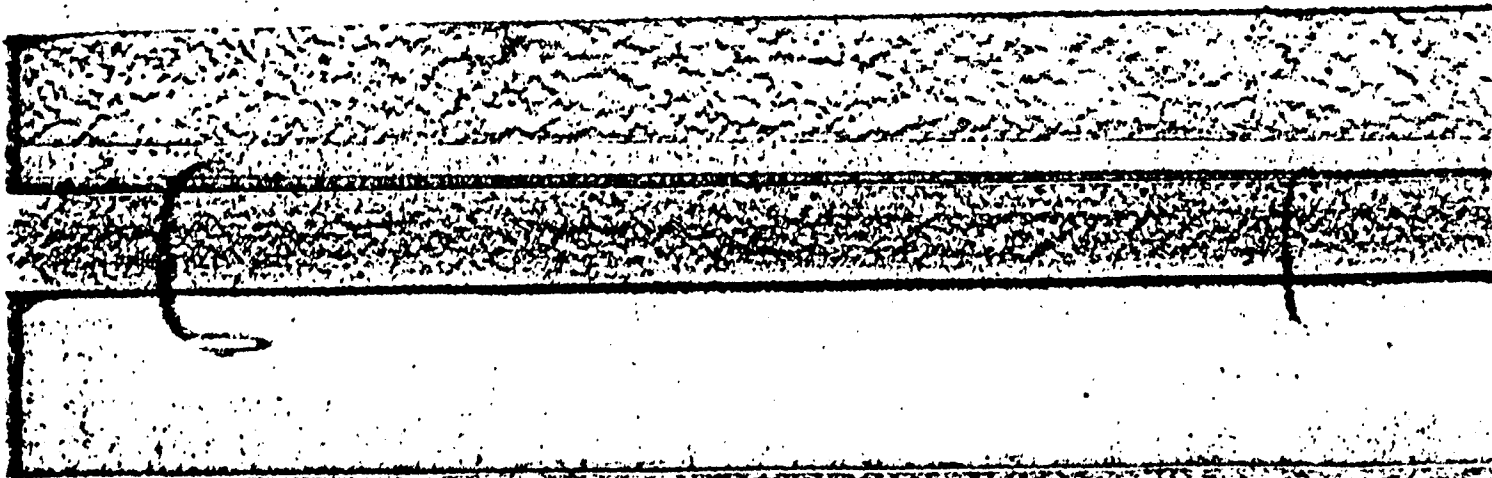

On the afternoon of June 13, 1949 I discussed with Mr. T. J. Donegan Bureau letters of 1942 and 1945 which had been given to Judge Kaufman, and he advised as follows:

Judge Kaufman, in chambers after the termination of today's session of the trial, called counsel in and said that he had reviewed the FBI statements of 1942 and 1945. Mr. Murphy called to his attention that they were not FBI statements; that they were FBI communications; that they were letters reflecting some information the agents had obtained from CHAMBERS. The judge said that he had examined them and he believed there was information in them that was contrary to the testimony of CHAMBERS and therefore the defense was entitled to that information. Mr. Murphy called to the judge's attention again the fact that these were not statements; that they were not signed but they were merely a recording of the results of the interview with CHAMBERS on these respective dates. Murphy also stated that in the event the judge intended to furnish these statements to the defense, he would want to refuse and he would desire to put an agent on the stand so that the agent would be in a position to refuse to follow the judge's instructions to turn them over, pursuant to the regulations of the Attorney General.

The judge stated that he had that in mind, but he did not think the problem of taking this position was involved and furthermore, he had already examined the statements and he had satisfied himself as to the materiality. He then stated that it was his intention that he would read certain parts of these FBI statements. Mr. Murphy again called his attention to the fact that they were not FBI statements. The judge then read from the May 14, 1942 statement, page 2, a sentence that WHITTAKER CHAMBERS advised he was a member of the Communist Party from 1924 until the Spring of 1937, at which time he ceased connection with the Party. On the last page of that letter to the Director, dated May 14, 1942, he read this excerpt: "He was advised that it might be deemed advisable to secure more detailed information on one or more parts of his above discussion but it is pointed out that this individual left the Party in 1937...". He then advised that in the letter of June 26, 1945, the Bureau letter which reflects an interview with CHAMBERS, CHAMBERS said in two instances he was in the Party from 1924 to 1937. The judge further advised that in the 1945 letter CHAMBERS had told the agents that espionage was not involved but that the matter concerned Communist activities.

Following a telephone call from HORACE SCHMAHL, a private investigator who formerly was employed by the defense, to Assistant United States Attorney Thomas Murphy, the following investigation was conducted:

Miss BESSIE A. MEADE, Manager of Adam Kunze Typewriter Company, 212 Broadway, New York, N. Y., advised that on February 11, 1949, she received a telephone call from Mr. ROSENWALD, an attorney, who advised that he was calling to make inquiries regarding the renting of an old Woodstock typewriter. Mr. ROSENWALD advised that Mr. SCHMAHL told him that this company could perhaps assist in locating an old Woodstock typewriter. Mr. ROSENWALD did not advise for what purpose he wanted this typewriter. Miss MEADE stated that she recalled that he specified a certain year or years in which this typewriter would have to be manufactured. She was unable to recall the exact years, but stated it was back in the early 1930's, to the best of her recollection. She further advised that they had no old Woodstock typewriters on hand, but that she knew that a client of theirs had an old Woodstock typewriter, and she contacted this client on behalf of Mr. ROSENWALD.

This client was the Australian Consolidated Press, 229 West 43rd Street, New York, N. Y. She stated that she then contacted the Australian Consolidated Press and made arrangements to pick up the old Woodstock typewriter that they had in their possession. On February 24, 1949, this old Woodstock was turned over to Mr. ROSENWALD at the law office of Debevoise, Plimpton and McLean. Miss MEADE stated that before turning over the typewriter to Mr. ROSENWALD, she brought it in to her office, had it cleaned up, and she believed a new ribbon was placed on it. The typewriter was rented to Mr. ROSENWALD on a monthly basis. The typewriter was returned to Adam Kunze Typewriter Company on May 24, 1949. Subsequently the typewriter company returned the typewriter to the Australian Consolidated Press.

Mr. L. J. MILLER, American editor of the Australian Consolidated Press, was contacted on June 10, 1949, by the writer, and he made available to the writer

the old Woodstock typewriter and a specimen was obtained from this typewriter by the writer. The serial number on this typewriter is N256978, and it has pica type print. When Mr. ROSENWALD originally made the request to the typewriter company to obtain an old Woodstock typewriter, he specifically requested that it should be one that contained pica type.

Both Mr. L. J. MILLER and Miss DOROTHY BLISS, receptionist at the Australian Consolidated Press, advised that prior to turning over this typewriter to the typewriter company in February, 1949, it had not been used for a period of several years. They both advised that they had no specimens in their possession of this typewriter prior to the time they turned it over to the typewriter company in February, 1949. They attempted to obtain some specimens prior to that date but were unsuccessful. The typewritten specimen that was obtained by the writer was shown to Document Examiner Ramos Feehan at this office, and he advised that the typewriting on this typewriter was not the same as the typing on the Baltimore documents. He did advise that he noted there was one peculiarity on the typing on this specimen that was peculiar to the typing on the Baltimore documents--that is, there was a similar type of defect in the small letter "g."

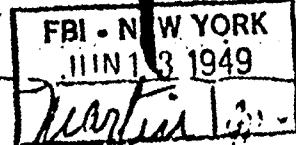
The records of John Hopkins University, Baltimore, Maryland, reflect that subject attended that school for six weeks in the summer of 1925, taking courses in English and Journalism.

As a result of factional strife and increasing dissatisfaction with subject's method of managing Communist Party affairs, he was forced to resign from the Texas Communist Party on the latter date.

July 29, 1946 to date - As David Carpenter, subject has been employed as a proofreader and feature writer for the "Daily Worker," 50 East 13th Street, New York City, an East Coast Communist publication, and serves as a member of the fifty-man National Review Commission of the Communist Party in New York City.

May 23, 1947 to date - Confidential Informant ND-460, trash coverage of Communist Party National Headquarters, New York City, reported that David Carpenter served as Club Treasurer of the Herman Boettcher Club of the Communist Party.

II. COMMUNIST ACTIVITIES

(a) Known or Suspected Communist Party Membership

Charles Krumbein, National Treasurer of the Communist Party, New York City, in a letter to Joe Wright, subject's predecessor as Secretary of the Texas State Committee of the Communist Party, dated May 4, 1943, stated, "I should mention that he (Carpenter) is a Party member of fifteen years standing, having been Organization Secretary in the Maryland District, active among metal workers, and was Section Organizer here in New York where he more than doubled the membership in about eighteen months. His name is Carpenter."

In an interview with Simon Casady, Editor of the Valley Evening Monitor, McAllen, Texas, in September, 1945 subject stated that he visited Russia in 1934.

Investigation of subject by the Bureau has disclosed that he has served as a Communist Party functionary since his appointment to the Texas State Communist Party as State Secretary from 1943 until the Communist Party was dissolved in Texas on July 30, 1944. From July, 1944 to December, 1945, when the Party became the Peoples Educational and Press Association, he served as President of that organization and traveled extensively throughout the southern states for the purpose of coordinating the activities of various "splinter groups" in the Southern States on behalf of the National Headquarters of the Communist Political Association.

Since 1946 the subject has been employed as a proofreader and writer for the "Daily Worker." The subject has written a number of book reviews for the "Daily Worker" under the name of David Carpenter.

It is noted that Carpenter apparently adopted the name of Steve Potter upon assuming the duties of Literature Director of the Communist Party in Texas, in addition to his position of President and State Secretary.

(b) Membership or Affiliation with Communist Party Front Groups

From 1939 to 1940, as David Zimmerman, subject was employed as Editor and Business Manager of "Work", official news organ of the Workers Alliance in Washington, D. C. and New York City. The Attorney General on February 5, 1943, listed the Workers Alliance as a subversive organization and a Communist front group in Executive Order 9300.

From July, 1944, to December, 1945, Carpenter was President of the Peoples Educational and Press Association of Texas (PEPA).

Since July, 1946, subject has been an employee of the "Daily Worker," East coast Communist newspaper, in New York City.

(c) Contacts with Known or Suspected Communists

Carpenter has had contact with numerous Communists in the New York area and Southern States, as is reflected in the files, due to his position of paid functionary in the Party and his long-time membership therein.

III. SOVIET ESPIONAGE ACTIVITIES

Whittaker Chambers in December, 1948, advised that one David Carpenter was a photographer for his Communist Party underground apparatus during 1936 - 1938; that Carpenter did his photography in a Southeast apartment in Washington, D. C., and lived for a time with Eleanor Nelson, a member of another apparatus, in Northwest Washington, D. C. He said that Carpenter was also known to him as David Zimmerman.

Chambers said that Carpenter had possibly been a Communist Party organizer in Baltimore, Maryland.

Chambers advised that Carpenter had introduced Henry Julian Wadleigh to him in Washington, D. C., in 1936. Wadleigh was then employed by the State Department and subsequently furnished information to Chambers from files of the State Department.

Other individuals in the apparatus introduced to Chambers by Carpenter were George Pigman and his brother Ward Pigman of the National Bureau of Standards and that Ward Pigman furnished material to Carpenter for photographing.

Chambers said that Carpenter received \$100.00 a month for work he did on behalf of the Communist Party.

Chambers and Wadleigh have identified a photograph of David Zimmerman as the individual they knew as David Carpenter and Harold Wilson.

As has been previously set forth, Carpenter admitted to Simon
ready Editor of the Valley Evening Monitor, McAllen, Texas in September,
1945, that he made a trip to Russia in 1934. This has not been verified
through investigation.

Mr. ROBERT MORRIS, attorney, 40 Exchange Place, New York City, secretary for Congressman COUDERT in New York, advised me today that he had been in touch with JAY LOVESTONE, ISAAC DON LEVINE and other Communist Party members and that in discussing the HISS trial they wondered whether not the Government could not qualify someone as an expert witness who would testify relative to CHAMBERS' break with the Communist Party and who could point out that in many instances when individuals break with the Party they make what he terms a "splinter" break and it is typical that they are reluctant to make a full disclosure of their information at the time of the initial break and continue to parcel out the information.

Mr. MORRIS did not know whether or not we would be able to introduce this type of testimony and whether it would be of assistance in connection with this case but he wanted to call it to the attention of this office for appropriate consideration.

He further advised that ISAAC DON LEVINE told him that PRISCILLA HISS was a Communist Party member and while Mr. MORRIS had no specific information regarding this information, he is getting in touch with LEVINE and advised that if any information is developed along this line of a specific nature he will appropriately advise this office. He also stated that CARL BINDER, the psychiatrist, was reported to him by LEVINE as being a close friend of HISS; further, it was his recollection that BINDER'S name had appeared in the Dies Committee report as being a member of some Communist Party front groups.

Reference is made to my call of this morning to Social Agent Bert Zander, with reference to Q5.

Mr. Zander advised at 12:20 p.m. today that it would be futile to go to the State Department in pursuit of the requested information. He pointed out that an extensive effort had been made at the State Department earlier in the case with respect to Q5. It will be noted that Q5 is not actually a State Department document as such; rather, it is information typed from an "ID report dated January 7, 1938, entitled "SINO-JAPANESE SITUATION," etc. An exhaustive search of the State Department failed to find any carbon copy of what we call Q5. It is also noted that Q5 does not contain any stenographer's initials. In view of the foregoing, Mr. Zander stated that it is not possible to ascertain the location of any stenographer's notes in connection with Q5 inasmuch as no record of Q5 as such ever was located in the State Department. He further advised that the secretaries in the State Department who had worked in HISS' office had been questioned regarding Q5 and they failed to have any knowledge regarding the document.

At approximately 1:00 p.m., I called MR. LEO LAUGHLIN, of the Bureau, to advise him that an individual named DAVID WHITEHEAD, of Clifton, New Jersey, who works at the Bendix Aviation Corporation, in Teterboro, New Jersey, called MR. DONEGAN'S Office this morning to advise as follows:

WHITEHEAD stated that he was at the St. Francis Health Resort at Denville, New Jersey on the evening of June 1st for the purpose of seeing a MISS LILLIAN JAEGER. While he was talking to MISS JAEGER and MR. and MRS. JOHN CEDDIS, who were also guests at the resort, a woman, who said she was MRS. JAMES, wife of the Foreman of the Petit Jury at the HISS trial, made the definite statement that both her husband and herself believed HISS to be innocent and that her husband would do his best to swing the jury in his direction.

MR. LAUGHLIN was advised that HUBERT EDGAR JAMES, of 1067 Madison Avenue, New York City, is the Foreman of the HISS jury. MR. LAUGHLIN was advised that Attorneys MURPHY and DONEGAN discussed this information with Judge KAUFMAN before court session this morning and that Judge KAUFMAN had requested that inquiry be made to find out if the wife of the Foreman of the jury actually was at the health resort on the evening of June 1st. MR. DONEGAN also requested that WHITEHEAD be personally interviewed to get any additional information he might have.

I advised MR. LAUGHLIN that inasmuch as the Judge had requested this inquiry we were going ahead and have the Newark Office make the inquiry immediately. MR. LAUGHLIN agreed. I then called ASAC KAACK, of the Newark Office, and furnished him with the above information concerning WHITEHEAD'S call and I advised him that WHITEHEAD can be reached at his office at the Bendix Aviation Corporation, telephone Hasbrouck Heights 8-2000, Extension 2092, and that his residence is 285 Lakeview Avenue, Clifton, New Jersey, telephone Van Horden 4-2003W (a new telephone). MR. KAACK was requested to have Agents immediately interview WHITEHEAD at his place of business and it was also

requested to have discreet inquiry made at the St. Francis Health Resort for the purpose of ascertaining whether MRS. JAMES, the wife of the Foreman, had been present, on the evening of June 1st. MR. KAACK was advised that the inquiry should be made in such a fashion that it would not get back to the ears of MRS. JAMES. It was suggested that the inquiries be restricted at this time to the interview with WHITEHEAD and the check of records, etc., at the resort regarding the presence and identity of MRS. JAMES.

I requested that the results of these inquiries be telephonically furnished to me this afternoon.

ASAC KAACK called at 3:30 p.m. and advised of the results of the interview with MR. WHITEHEAD as follows:

MR. WHITEHEAD stated that he did not hear the reported conversation wherein MRS. JAMES alleged that she and her husband were in sympathy with HISS. The conversation was repeated to him by MISS LILLIAN JAEGER and, according to WHITEHEAD, the statement was made in the presence of MISS JAEGER, MR. and MRS. GEDDIS and possibly a man named KING may have been present. WHITEHEAD stated that both MISS JAEGER and MR. and MRS. GEDDIS would be cooperative if we wanted to interview them. He also stated that MRS. JAMES is a guest at the St. Francis Health Resort.

MR. KAACK wanted to know whether MISS JAEGER should be interviewed in view of the fact that WHITEHEAD was not present when the alleged conversation took place. I suggested that MISS JAEGER be interviewed on a discreet basis and that she should be made to understand that she should not discuss the matter with other patients at the health resort. This was felt to be necessary in order that we could get a first-hand account of what the actual conversation was.

At 3:55 p.m., MR. KAACK called to advise that MRS. CATHERINE W. JAMES, 1067 Madison Avenue, New York City, has been a guest at the St. Francis Health Resort since May 23rd. The name of her nearest relative is reflected on the records as MR. H. JAMES, 1067 Madison Avenue. The relationship is not noted. Reference is made to my memorandum of June 6, 1949 concerning the motion by defense attorney Stryker that the Judge direct the Government to produce, among other things, the record of the two F.B.I. conversations with CHAMBERS in 1943 and 1945.

On the morning of June 9, 1949 Mr. H. E. FLETCHER of the Bureau called to advise that the Bureau feels that the two letters reflecting the referenced two interviews, namely, dated May 14, 1942 and June 26, 1945 should not be introduced as evidence. Mr. FLETCHER advised that we should discuss this with Mr. DONEGAN in order that he may in turn discuss it with Judge Kaufman. Mr. FLETCHER advised that the Bureau feels that there is certain extraneous information in these letters plus the fact that the letters reveal the names of some individuals under investigation and that the letters reveal confidential information and administrative information. Mr. FLETCHER pointed out the following parts of the letters in question:

Letter of May 14, 1942

Last paragraph, page 8, where the statement is made that most of CHAMBERS' information is history, hypothesis or deduction.

Letter dated June 26, 1945

Page 5, paragraph 3- The material regarding Mrs. JACOB ANNA MONES.

Page 6, paragraph 2- That portion starting with "A review of the New York files reflects" and ending with "Berlin".

Page 6, paragraph 5- Regarding NATHAN WITT, beginning with "WITT" and ending with "Division". (two sentences).

Page 18, paragraph 3- Beginning with " a review" and ending with "passport violations". (two sentences).

Also in this paragraph reference is made to the "key figure list".

Page 22, paragraph 5- Beginning with "The above information" and ending with "his case file will be considered closed."

I advised Mr. FLETCHER that I had spoken to Mr. DONEGAN on the morning of June 9, 1949 and he had stated that no further mention had been made of these two interviews with CHAMBERS by FBI agents. Consequently, I thought it best to allow the matter to lie dormant. I advised that if the question is again raised, I can then discuss the Bureau's comments as reflected above with DONEGAN. I pointed out that Judge Kaufman has not been particularly helpful to the Government in this case from his attitude towards the Government witnesses, and it was a matter of conjecture as to what his reaction would be if these letters were discussed with him. I advised Mr. FLETCHER that we will let the Bureau know immediately if this issue is raised further.

On the morning of June 8, 1949 I received a call from Mr. HARBO of the Bureau relative to our teletype of June 7, 1949 advising that Laboratory experts FEENAN and WEBB should be available for the trial in the above case at New York City on the morning of June 9, 1949. Mr. HARBO advised that FEENAN would be here in accordance with our request, however, WEBB is standing by for testimony on the COPLON case in Washington. Mr. HARBO requested that we check with prosecuting attorneys Murphy and Donegan to see whether WEBB is needed at this time.

Supervisor TUOHY caused a check to be made with Mr. Murphy and Mr. Donegan who advised that they plan to utilize WEBB possibly on the morning of June 9th, therefore, they would like to have him come up to New York this afternoon to go over the recent charts he has made. Mr. HARBO was so advised.

However, the Bureau had also checked with Mr. Whearty and Mr. Kelley handling the COPLON case, and they said they were moving to use WEBB this afternoon or tomorrow morning in the COPLON case, consequently, he could not come up to New York. I advised Mr. HARBO that we would inform Mr. Murphy and Mr. Donegan of this, and in the event they felt WEBB was still necessary here at this time, they could contact Mr. Whearty and Mr. Kelley and work it out among themselves. Mr. HARBO agreed and said that WEBB would stay down in Washington unless it was worked out to the contrary.

Supervisor TUOHY was furnished this information in order that Mr. Murphy and Mr. Donegan could be advised at once.

A confidential source advised that according to an existing rumor, Alger Hiss plans on using as a defense in connection with his trial in answer to the question as to how Chambers happened to use the Hiss typewriter

The informant also made the comment that this showed Hiss's character in that he was ready to sacrifice his stepson in order to defeat the charges of perjury which have been brought against him.

The informant also made the comment that Hiss had wonderful lawyers, that they had done a complete job of investigating all aspects of the case and that apparently they are being paid from what is known as the Alger Hiss Defense Fund to which prominent people have been making \$3,000 contributions. This source stated that Eugene Meyer, former owner of the Washington Post, had contributed \$3,000 to the Alger Hiss Defense Fund and that he also understood that Dean Acheson, Secretary of State, had made a similar contribution through a member of Acheson's law firm. This source stated that the House Un-American Activities Committee is endeavoring to prove these contributions and intended to subpoena bank officials to produce any cancelled checks to support these contributions.

You should immediately advise Mr. Donegan and Mr. Murphy of the above information.

At 11:15 am on June 6, I called Mr. H. B. Fletcher of the Bureau to advise him that defense attorney STRYKER had asked CHAMBERS, on examination this morning, when he was first interviewed by the FBI and CHAMBERS replied about 1943. He was then asked if he was again interviewed by the FBI and he replied that he had been in 1945, he believed. He was then asked if the FBI took a statement from him and replied that the agents did not; that in the first interview the agents took notes and in the second interview they wrote out the material but he was not asked to sign anything.

STRYKER then made a motion that the judge direct the government to produce the testimony of CHAMBERS before the Grand Jury in October, 1948; the record of the interview had by RAY MURPHY of the State Department with CHAMBERS; and the record of the two FBI conversations with CHAMBERS in 1943 and 1945. The judge denied the motion but directed the government to turn over to him (the judge) the Grand Jury testimony mentioned above and the statements made to FBI agents in 1943 and 1945. The judge refused to direct the government, over STRYKER's strenuous objections, to produce the MURPHY interview. STRYKER said he might have to subpoena the records from the State Department.

Mr. Fletcher was advised that the judge said that he wanted to read the Grand Jury record and the two statements to the FBI for the purpose of seeing if there were any inconsistency with the statements made by CHAMBERS later. If there were no inconsistency, he would continue to deny STRYKER's motion and if there was any inconsistency, he would rule otherwise.

I advised Mr. Fletcher that the two interviews with CHAMBERS are reflected in letter to the Bureau dated May 14, 1942 entitled "WHITTAKER CHAMBERS, was., ESPIONAGE - R", an 8 page letter, and a 22 page letter dated June 26, 1945, entitled "WHITTAKER CHAMBERS, INTERNAL SECURITY - R". I advised Mr. Fletcher that I had briefly looked over these letters and it appeared that they were the most concise means of reflecting the interviews although the letters included the results of file checks on several names mentioned by CHAMBERS. In addition, on page 18 of the letter dated June 26, 1945, mention is made of the Key Figure List in the New York office, I pointed out that if these are turned over to the judge and he finds any inconsistency and makes the government produce them in court, matters separate and apart from CHAMBERS' discussion of HISS will be made public, including items such as the Key Figure List, which are not pertinent to this trial.

ADDENDUM:

On the morning of June 7, I advised Mr. H. B. Fletcher of the Bureau that Mr. Murphy and Mr. Donegan had furnished the minutes of the Grand Jury to the judge at the close of court on June 6 and that they propose advising the judge that the interviews with CHAMBERS in 1942 and 1945 are contained in two letters, one 22 pages long and the other 8 pages long; further that these letters contain information furnished by CHAMBERS concerning many individuals other than HISS and also contain the results of our file checks against such individuals and other extraneous material. They are going to suggest to the judge that the extraneous material pertaining to file reviews and administrative matters be deleted from these letters. Mr. Fletcher advised that a memorandum was being prepared for the Director, pointing out the objectionable material in these letters from the standpoint of having the letters introduced into evidence. I advised Mr. Fletcher that as soon as the matter had been further discussed with Judge Kaufman, this morning, we would let the Bureau know of the developments.
