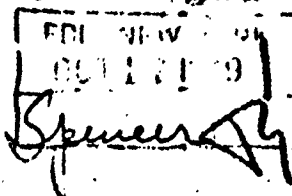

MEMORANDUM:

Re: JAHAM

This morning ASAC Bob Lally, Baltimore, telephonically referred to our teletype of the 14th, inquiring as to whether AUSA Tom Murphy is definitely coming to Baltimore on October 18. After checking with SA Tom Spencer, I advised Mr. Lally that Mr. Murphy and Spencer would leave New York at 8:50 a.m. tomorrow via American Air Lines, arriving at Baltimore at approximately 10:00 a.m. Mr. Lally said that SA Frank Johnstone would meet them at the airport. He further advised that he would advise CHAMBERS that they are coming.

Mr. Lally made further reference to our teletype of the 14th in connection with WELFORD RAYMOND DAY, who claims to have dated Mrs. EVELYN KING. Mr. Lally inquired whether DAY was positive if EVELYN was the first name, or was he guessing at it. He advised that they had located a Kings Tavern at Catonsville, Maryland, and that it is operated by two brothers, GEORGE and PAUL KING. Their brother, KENNETH, who is deceased, had a wife named EVELYN, but she in no way meets the description of the EVELYN we are trying to locate. Mr. LALLY requested that we reinterview DAY today to find out if he is sure EVELYN'S husband ran the tavern, or was it merely a claim. He requested that we bleed DAY for any other details for possible leads, asking him whether EVELYN had any sisters or family or anything else which might help locate her.

Mr. Lally advised also that old Baltimore directories list a Mrs. ELIZABETH E. KING in the 2200 block of Druid Hill Avenue. On the theory that the "E" might stand for EVELYN, they are seeking to locate this party. Mr. Lally also wanted to know whether DAY would be able to identify a photograph of EVELYN.

MEMORANDUM:

Re: JAHAN

Reference is made to the newspaper articles appearing, particularly in the New York Times and Journal-American of October 12, 1949, in connection with WILLIAM ROSEN. Both of these newspapers indicated that AUSA Murphy had informed the newspaper reporters that ROSEN had been served with a witness subpoena outside of a department store in Los Angeles and that when ROSEN appeared before Judge LIEBELL on October 11, Murphy had informed the newspapers that ROSEN was being released from custody of the FBI on the promise that he would appear and testify as a witness in the retrial of the HISS case.

Murphy was out of the city at the time these newspaper stories appeared, and upon interview on October 14, 1949, he advised that the stories were entirely untrue and that as a matter of fact he had not talked to any newspaper reporter in connection with the above-mentioned ROSEN affair; and that apparently the newspaper reporters had learned that ROSEN would appear before Judge LIEBELL in connection with his being subpoenaed as a witness in this case. Murphy did relate, however, that since the subpoena called for ROSEN'S appearance on October 10, he wanted to protect himself and therefore had ROSEN brought before Judge LIEBELL, and at that time ROSEN was instructed to be prepared to appear in Federal Court in the SDNY on November 1 next, which is the tentative date scheduled for the hearing of this case.

RE: JAHAM

On the morning of October 18, Mr. Thomas Donegan called to advise that Mr. VINCENT ASTOR who is the owner of "Newsweek", had discussed with him the propriety of the proposed appearance of CHAMBERS in a television broadcast sponsored by "Newsweek". Mr. Donegan advised that he had informed Mr. ASTOR that he considered such an appearance on the part of CHAMBERS prior to the forthcoming trial highly inadvisable. Mr. Donegan advised that Mr. ASTOR likewise felt that such an appearance by CHAMBERS was inadvisable and that Mr. ASTOR had instructed "Newsweek" that the matter should be dropped. Mr. Donegan advised that Mr. ASTOR wanted the Bureau to know that he had instructed "Newsweek" to discontinue its efforts to get CHAMBERS on this broadcast as he considered it inadvisable in view of the forthcoming trial.

Mr. Donegan further advised that he understood from Mr. ASTOR and his representatives that AUSA Murphy had been contacted by "Newsweek" concerning the proposed appearance, and that Mr. Murphy had stated he would take it under advisement but that he was against the suggested appearance. Mr. Donegan advised that Mr. Murphy had not discussed the matter with him; consequently, he was not in a position to say what Mr. Murphy's views were.

Motion to Shift 2nd Trial to Vt. Heard Today

Daily News Editorial Cited By Govt. in Opposing Move

Nov. 1 Date Set by Judge to Allow Hiss Attorney Time to Prepare Case

NEW YORK. (UP)—The second Alger Hiss perjury trial was postponed today until Nov. 1, and a Federal Judge took under advisement Hiss's application for a change of venue to Vermont.

Judge Vincent L. Leibell adjourned the opening of the trial after a new attorney recently retained by Hiss said he needed two months to prepare his case. Leibell told the attorney, Claude B. Gross, of Boston, that he could have three weeks—until Nov. 1—and then might make another adjournment effort if he felt he could not go to trial at that time.

The change of venue motion was argued before Judge Alfred C. Coxe when Leibell disqualified himself on the grounds that a member of his family was employed by Time. The Whittaker Chambers, former \$30,000-a-year, senior editor of Time magazine and admitted former courier for a pre-war Soviet spy ring, is Hiss' principal accuser.

Asst. U. S. Atty. Thomas F. Murphy, government prosecutor in the Hiss case, opened his argument by reading excerpts from a page one editorial in the Burlington, Vt., Daily News of last Friday. The editorial had termed the change of venue attempt "downright insulting" and said the defense was wrong if it meant to "imply that Vermonters would condone treason if treason was found to be proved."

ASKS RUTLAND TRIAL

Arguing for a change of venue to Rutland, Vt., where the Federal Court sits, Edward B. McLean, a Hiss attorney, said the "terrific, antagonistic publicity in this district for days and days" on the part of newspapers had created an atmosphere making it "inevitable that any juror would be prejudiced about this case and unable to sit fairly on it."

He said the situation did not obtain in Vermont. He said there were only two newspapers of general circulation in Rutland and that they had carried brief and unbiased dispatches about the first trial.

QUERIED BY JUDGE

"You mean to say they don't read any other papers than the local ones in Vermont?" Judge Coxe asked. "I've just come from Vermont and you get all the news there that you get anywhere in the United States. The radios are working there also."

McLean said New York newspaper circulation in the Vermont district was "infinitesimal." He said that a poll taken by the defense among 200 people in New York City showed that 45 percent of them admitted they had formed an opinion about the merits of the case. In a similar poll taken in Rutland, he said, 33 percent who had an opinion were readers of New York newspapers.

DECISION LATER

Judge Coxe gave McLean until Thursday morning to file an answer in the change of venue motion to affidavits and exhibits submitted by Asst. U. S. Atty. Thomas F. Murphy, government prosecutor in the Hiss case.

The judge gave no indication of when he would announce a decision on the motion.

Why Does Hiss Like Vermont?

(Guest Editorial from the New York World-Telegram.)

Alger Hiss has applied for a change of judicial scenery for his second perjury trial because he believes an impartial trial is impossible in New York. His first trial, on charges that he falsely denied that he aided an alleged prewar Communist spy ring ended here last July with a hung jury.

The former State Department official wants to be tried in Vermont. He says he picked the state because the press there treated his case with more moderation than the New York newspapers.

Mr. Hiss is decidedly naive if he thinks he can avoid newspaper coverage of his trial by holding it in Vermont.

Mr. Hiss has a perfect right to seek a change. He is entitled to the fairest possible trial. And the public also has the right to expect that this important and nationally prominent case get the fairest possible trial.

The judge of the federal district which includes Vermont most probably will be Gov. Ernest W. Gibson of that state. Gov. Gibson recently was appointed to the bench by President Truman. The appointment has not yet been confirmed by the Senate but

We think it is too much to ask of any judge that one of his first jobs on the bench be the Hiss trial. We think it is not fair to the public to place the trust of absolute, impartial justice in this complicated case in the hands of an inexperienced judge, however great his potential ability.

Governor Gibson has, in our opinion, demonstrated that he may not be aware of the prominence of Communism in this country. At an American Legion convention last July, he attacked a Legion list of "undesirable" speakers. On the list are names of fellow travelers. At the convention, the Governor defended Dr. Marshall E. Dimock, once one of his legislative aids and a sponsor of the recent pro-Soviet "peace" conference in the Waldorf-Astoria Hotel.

Perhaps this is a clue to why Mr. Hiss likes Vermont.

If Mr. Hiss is successful in moving his trial to Vermont, we suggest Governor Gibson step aside to permit the most able and experienced federal judge available to be called in to preside.

Ed. Note:—Dr. Dimock's association with the pro-Commie cultural conference mentioned above caused considerable comment in Vermont last winter.

Only two weeks before the conference took place, the Vermont Legislature overwhelmingly defeated Governor Gibson's proposal for a power authority. It was generally conceded that the utility charge of "Socialism" was a basic factor in this defeat.

Dr. Dimock, a member of the House of Representatives, led the fight for the measure. He based his case on the pretense that there was no real fight between the utility interests and the liberalists who in recent years had demanded cheaper power for Vermont.

Hardly had the power authority issue been settled in Montpelier than Dr. Dimock's name again came into the press, this time in the New York City papers. He was described by Dr. Harlow Shapley, left-wing Harvard astronomer and mainstay of the pro-Soviet conference, as a "Vermont Republican legislator" who was a member of the program committee. Actually, Dr. Dimock did not attend the conference. The reason given in the New York press was that he was prevented by a cold. Later, when pressed by this paper for an explanation, he declared that he broke off all association with the conference when he found that it was "loaded."

If the witness identified or will be called upon to identify a trial exhibit, a brief description of the exhibit should be inserted.

This compendium will be used for reference purposes during the trial and must, therefore, be compact yet complete. It is suggested that this matter be given immediate attention.

Reference is made to the memorandum of SA T. G. Spencer dated September 21, 1949 and teletype from Boston to the Bureau dated October 13, 1949.

Referenced memorandum indicates that MAXIM LIEBER may have brought a girlfriend to his cottage at Smithtown, who possibly may have seen PRISCILLA HISS and ESTHER CHAMBERS at LIEBER'S Smithtown cottage.

Referenced teletype reflects that Mrs. ELIZABETH PERKINS has advised that she recalls an individual by the name of Mrs. MOLLY WEISS who was a pianist, and Mrs. PERKINS believes that Mrs. WEISS was a girlfriend of MAXIM LIEBER.

Inasmuch as ELIZABETH PERKINS was employed by MAXIM LIEBER up until about 1936, it is possible that this Mrs. MOLLY WEISS may have accompanied MAXIM LIEBER to the Smithtown cottage of LIEBER'S in 1935.

Accordingly, it is felt that the files of the New York Office should be reviewed and investigation conducted to identify and locate Mrs. MOLLY WEISS, aforementioned, in order that she may be interviewed concerning any visits she may have made with LIEBER to LIEBER'S Smithtown cottage and as to whether she ever saw ALGER or PRISCILLA HISS in the company of Mr. and Mrs. WHITTAKER CHAMBERS at that place.

The Strange Case of Noel Field

The strange case of Noel Haviland Field is worth more than passing attention.

Noel Field, an American citizen, has been branded a Communist by Whittaker Chambers. It has been alleged in connection with several of the Communist cases that he belonged to the Russian spy apparatus in the prewar period. Whether he was a member of the Communist Party, there does not seem to be any serious doubt that both during the prewar years and during the war he had several Communist friends.

But available evidence indicates that today Noel Field, his wife, and his brother, Hermann H. Field, are all victims of the Russian secret police. Hermann Field disappeared from the airport in Warsaw on Aug. 22. Some friends had taken him to the airport, but departed before the plane did. He never has been seen or heard of since by any westerner.

It was only after Hermann Field's disappearance that anyone bothered to check up on Noel Field. It was then discovered that Noel had not been seen or heard of since June. At that time he was in Prague with his wife, presumably continuing the type of refugee relief work which had been his open and avowed activity since he resigned from the League of Nations secretariat in Geneva after the war broke out. Previously he had been a career officer in the State Department.

After his disappearance he was named in the Hungarian Government's purge trial of Laslo Rajk as an alleged "Amer-

ican intelligence agent." Rajk was successively minister of justice and minister of foreign affairs in the postwar Communist-controlled Hungarian Cabinet. Hungarian propaganda claims that it was Noel Field who persuaded Rajk to serve as an "imperialist spy."

Mrs. Noel Field disappeared about the same time as Hermann.

So here we have an American citizen who has been publicly branded at home as an alleged traitor to his country and yet who has now disappeared in eastern Europe after being called an undercover secret American agent in a Cominform country purge trial. And his brother and wife apparently are also victims.

It is quite possible that Noel Field was an acquaintance, perhaps even a personal friend, of Rajk. Rajk served in the International Brigade in Spain during the Spanish Civil War. Noel Field helped rescue many a member of that brigade from internment camps in Vichy, France. He worked for the Unitarian Service Committee at the time.

That Noel Field was actually an American undercover agent engaged on orders in trying to promote trouble for the Russian-dominated governments in eastern Europe seems unlikely. That is what the Hungarian trial purported to prove. Yet it is perfectly possible that this is the case. We have such agents. And Noel Field was used by the American Office of Strategic Services during the war. His known connections with several Communists and the charges made repeatedly against him at home would

have been excellent "cover" for just such work. And he had contacts with the type of Communists who broke away from Moscow in Yugoslavia and who are known to be restive under Moscow controls in the satellite countries.

The truth is something we probably shall never know. If Noel Field was an undercover agent of the United States deliberately accepting the stigma of Communist affiliations at home in order that he might serve his country more effectively, that is something which can never be admitted publicly. But in our frequent excitement about "subversives" and "spies" and "disloyal persons" we might remember that some among these are Americans who have deliberately sacrificed their reputations at home to serve their country "underground." Not even the FBI knows the identity of the undercover agents of the United States central intelligence agency.

More probably, Noel Field just had a strong personal fondness for left-wingers of the Tito and Rajk breed who fought in the Spanish Civil War and then in the wartime resistance and ended up by discovering that Moscow had taken over their home countries and found they didn't like it. It is to be hoped that if Noel Field was not himself a secret agent among such people we have others who are, for they—the Titos and the Rajks—are the people who more than any others have weakened the fabric of postwar Russian imperialism.

At 10:15 A.M., this date, SA Victor A. Lemaitre advised the writer of the following information:

In the course of the investigation of another matter SA Lemaitre interviewed DOUGLAS HEDIEN ALLEN, Chairman of the Board of the Otis-Astoria Corporation, 220 Eleventh Avenue (25th Street), New York City, telephone WATKINS 4-4343. Mr. ALLEN resides at 130 East 75th Street, New York City. His home telephone number is REgent 4-3747.

Mr. ALLEN advised SA Lemaitre that he knew LAWRENCE DUGGAN for many years. He was acquainted with DUGGAN from the time DUGGAN was a child. According to ALLEN, prior to what ALLEN termed the suicide of LAWRENCE DUGGAN, DUGGAN wrote a letter to SUMNER WELLES in which he set out in detail the fact that DUGGAN knew of the existence of a Communist underground in the Government service; that he knew the extent to which this underground controlled the Government and that he knew how high the underground reached among important Government officials. This letter reportedly advised SUMNER WELLES that as a result DUGGAN contemplated suicide, rather than to reveal the extent to which the underground controlled the officials of this Government. ALLEN expressed the opinion that as a result of receiving this letter SUMNER WELLES suffered the attack which resulted in his being found on his estate many hours after he disappeared from his home. At the time WELLES was found he was suffering from shock and exposure.

By way of further background on ALLEN, SA Lemaitre indicated that ALLEN was an important person with an extensive knowledge of South American affairs.

Among the other things which ALLEN told SA Lemaitre was that the FBI had been ham-strung in its investigation of the ALGER HISS case. He also specifically mentioned the AMERASIA Case in which he said the Bureau's investigation had been curtailed by high Government officials. ALLEN further stated that ADOLF BERLE of the State Department, was the principal

pal exponent of the recognition of Soviet Russia in the Government service, and had persuaded South American countries to recognize Soviet Russia at the time BERLE was Ambassador to Brazil. According to SA Lemaitre, ALLEN is a Republican, opposed in every respect to the New Deal and Fair Deal and is an opinionated man.

It is recommended that ALLEN be interviewed immediately for all information in his possession on the alleged letter written by LAWRENCE DUGGAN to SUMNER WELLES; particularly, is it important that it be determined, if possible, how ALLEN knows such a letter was written. Following the outcome of the interview consideration should be given to conducting an interview with SUMNER WELLES to obtain, if possible, the letter from DUGGAN to WELLES.

A lead card should be made out assigning lead to SA J. J. Danahy, who should be accompanied by another Agent completely familiar with the ALGER HISS Case at the time the interview with ALLEN is conducted.

The Indices of this Office have not been searched on DOUGLAS HEDDEN ALLEN.

During the interview with WHITTAKER CHAMBERS on October 18, 1949, at the latter's farm, he related that he had received some information which had escaped his mind for some time and that his best recollection was that he received this information from ROBERT STRIPLING.

CHAMBERS related that one FAY (ph) of the Justice Department, had, during the Executive Sessions of the House Committee on Un-American Affairs, been requesting and receiving transcripts of these Executive Sessions and because of the friendship between FAY and ALGER HISS, FAY was making these transcripts available to HISS. FAY allegedly made his request to Congressman NIXON. For some reason, however, shortly after these transcripts were being made available to FAY, NIXON refused to honor any subsequent requests.

CHAMBERS pointed out that this, apparently, would have been of extreme importance to ALGER HISS because HISS usually appeared before the Executive Sessions subsequent to the time CHAMBERS testified and, therefore, would be in possession of all information that CHAMBERS had related to the Committee before he, HISS, had made any comments to the Committee.

Mr. MURPHY stated that it possibly would be very helpful if the transcript of these Executive Sessions could be obtained and the information supplied by CHAMBERS to the Committee and that supplied by HISS be compared.

It is to be noted that in all probability the individual referred to by CHAMBERS as FAY, is identical with GEORGE MORRIS FAY, U. S. Attorney for the District of Columbia; it is to be noted further that according to the newspaper accounts at the time, Mr. FAY was being furnished transcripts of testimony being taken by the HCUA from CHAMBERS, HISS and others possessing information about the activities of either or both.

During the interview of WHITTAKER CHAMBERS on October 18, 1949 by Assistant United States Attorney THOMAS F. MURPHY and the reporting agent, CHAMBERS related that he had recently recalled a bit of information that he had neglected to relate to SA FRANCIS X. PLANT and the reporting agent at the time the detailed statement was being taken in January, February and March, 1949.

This incident occurred in about July, 1935, when CHAMBERS and his wife were residing in the Greenwich Village Apartment of MEYER SHAPIRO. CHAMBERS stated that because of the extreme hot weather in New York City at that time, the CHAMBERS and HISSES had talked about getting a place in the country for the rest of the summer. Both Mr. and Mrs. CHAMBERS recall quite vividly reading an advertisement probably in the Sunday Edition of the "New York Times" or the "New York Herald Tribune" which listed a summer place adequate for two families near Callicoon, New York.

This summer place was allegedly on the Upper Delaware, probably just above Callicoon and near the town of Black Eddie. CHAMBERS related that one day (he could not recall whether it was a Sunday or a weekday) ALGER PRISCILLA HISS and he drove up to this summer place, found it to be unsuitable and returned to New York City the same day. CHAMBERS described the house as "small and shacky" and his recollection was that it was situated between a dirt road and a railroad track and about one-half mile from either the Delaware River or a small lake. CHAMBERS stated that they talked to a man and woman who, apparently, owned the premises, but he cannot give any description whatsoever of these individuals.

It is suggested, therefore, that a review of the "New York Times" and the "New York Herald Tribune" for July, 1935 be made in an effort to locate this advertisement. If the advertisement is located, it is believed that further investigation be conducted to determine whether anyone presently residing in or near this summer place could possibly identify ALGER and PRISCILLA HISS or WHITTAKER CHAMBERS.

The Beech Seal for Hiss?

The possible trial of Alger Hiss, described by Assistant U. S. Attorney General Thomas F. Murphy as "a traitor, and another Benedict Arnold" is one "blessing" that the State of Vermont, and especially the City of Burlington, can do without.

Mr. Hiss, a summer resident of Peacham, and his attorney, show a typical summer resident's lack of understanding of Vermont as evidenced by their petition for a change of venue of this trial from New York to Vermont. The affidavits attached to his petition purport to prove that there was only moderate public reaction in Vermont to Hiss's first trial. Of course, you could not expect a sophisticated cosmopolite such as Alger Hiss to appreciate that just because Vermonters do not pound on a tub to express the condition of their emotions that they would contemplate an act of treason with any more apathy than any other part of the U. S.

In fact, this newspaper considers Mr. Hiss's application for a change of venue from New York to Vermont as downright insulting. It is one thing to imply that he would get fairer treatment in Vermont. But it is another thing to imply that Vermonters would condone treason if treason was found to be proved.

This newspaper has previously commented freely and frankly on the disgraceful spectacle of two U. S. Supreme Court Justices coming into court to be character witnesses for Mr. Hiss. It has furthermore praised the majority of the members of the jury of New York who refused to be over-awed by the Supreme Court Justices and other prominent citizens, who testified as to their idea of the excellence of Mr. Hiss's character.

This newspaper does not believe that Mr. Hiss can look forward to a jury of complacent Vermonters. It does not believe that Vermonters will be any easier on him than would be a New York jury, and it is an affront that Mr. Hiss indicates that he thinks this would be the case.

The words of Assistant Attorney General Murphy, as

report on Newsweek and Time magazines for June 18, are well worth recalling, in connection with the Hiss trial. First of all, Murphy answered the emotional plea of Criminal Lawyer Stryker, who defended Hiss, by pointing to the Woodstock typewriter that the Government claims Mrs. Hiss used to copy confidential documents which they also claim Mr. Hiss had taken from the State Department and which Chambers said Hiss had delivered to him, and the trial's testimony in four green-bound volumes. "There are the three solid witnesses in this case," said Mr. Murphy, adding that there were three uncontradicted facts: 1. Chambers had in his possession copies of secret State Department documents; 2. These documents were all dated in the first three months of 1938; 3. All but one of the typed documents were copied on the Hiss typewriter.

Declared Mr. Murphy, "Someone has said that roses that fester stink worse than weeds. A brilliant man like this man, who betrays his trust, stinks. Inside that smiling face is a heart black and cancerous. He is a traitor."

Said Mr. Murphy, "I dare say Judas Iscariot had a fairly good reputation. He was one of the Twelve, he sat next to God, yet we know what he did. Brutus, the friend of Caesar, I dare say he had a good reputation. He got so close to his boss he stabbed him. Benedict Arnold came from a fine family, was one of the first in the Revolutionary War, but he sold out West Point. He wasn't caught, but had he been don't you think he could have called George Washington as a reputation witness?"

It is perfectly true that no man is guilty until proved so under the American system. But it is also true that eight out of the 12, or a two-thirds majority of the jury, felt that Mr. Hiss was guilty.

In the opinion of this newspaper, from what it has been able to learn, Mr. Hiss is guilty.

We agree with Murphy when he said "Let us suppose one of your children is apprehended in the kitchen with jam on his face. We don't have to get a stomach pump to find out if he's been eating jam. We have the jam on his face."

We hope that if Vermont has the misfortune to be tainted with this trial a Vermont jury will give short and quick justice to Alger Hiss. It is a pity that our modern laws prevent the use of the beech seal, which Ethan Allen, Remember Baker and Seth Warner used with so much effectiveness on the behalfs of those who violated the integrity of the State of Vermont in the days of the American Revolution.

With the news that Russia now has the atomic bomb, the danger of having anyone in high places who might be betraying this country is no longer a matter of academic interest.

Our very lives are at stake, and under such circumstances we cannot afford traitors anywhere in this country of ours.

He stated that he was very thankful for this matter as it probably concerned a story which he had heard and which he believed was authentic.

This story is to the effect that LIEHLING is allegedly writing a story criticizing "Time" Magazine, and that LIEHLING is attempting to sell this story to "Collier's" Magazine. MEDINA stated that he could, of course, not positively sustain the advertisement in this story, but felt that the ad was placed in connection with LIEHLING'S story.

On the afternoon of November 1, 1949, HAROLD MEDINA JR. of Cravath, Swain and Moore, attorneys for "Time" Magazine, telephonically communicated with the writer. His call was in connection with the Osborne article that appeared in a recent column of WALTER WINCHELL in the "New York Daily Mirror". As will be recalled from previous memoranda, efforts were made to determine whether there was any proof to statements made by WINCHELL in his column.

On this date MEDINA related that he had just talked to Mr. OSBORNE and others in "Time" Magazine in an effort to straighten up the so called WINCHELL-OSBORNE story. He continued that in his conversation with OSBORNE, the latter related that he was in Rome in the Fall of 1944 on an assignment for "Time", and after a diligent search of the cables of "Time" he might have sent, and from his own recollection, he could recall nothing that would substantiate the statements made by WINCHELL in his column.

OSBORNE also told MEDINA that he could never recall having criticized CHAMBERS' editorial policy as fictional rather than factional, and he is positive that no such statement was credited to him in a cable or any communication.

MEDINA related that OSBORNE had a very high regard for CHAMBERS as a man and as an editor, but that OSBORNE had differed to some extent in the manner in which a story might be edited by CHAMBERS.

MEDINA also related that sometime around 1944, some criticism of CHAMBERS' editorial policy had been made by one of the sections of "Time" Magazine. MEDINA related that the source was probably a new editor whose name he could not recall.

As a result of this criticism, HENRY LUCE the publisher, became somewhat alarmed and asked OSBORNE to check into the matter. OSBORNE made a survey and wrote a one copy personal and confidential memorandum to LUCE in which OSBORNE set out the results of his investigation, gave the various pros and cons as to CHAMBERS editorial ability, etc., and apparently whitewashed the entire affair.

LUCE subsequently sent a confidential memorandum to one HILLINGS, who at that time was one of the editors, and who is now the principal editor on "Time" Magazine, requesting that HILLINGS look over OSBORNE'S memorandum, and to make any further comments he chose to in connection with this affair.

HILLINGS' comments to LUCE in this regard were also favorable in so far as LUCE was concerned. MEDINA related that the material on these memoranda is presently not in existence, and the information he received came from OSBORNE and HILLINGS themselves.

In connection with the comments made by WINCHELL in the OSBORNE cablegram story, OSBORNE related to MEDINA that he, OSBORNE, had recently talked to LEONARD LYONS of the "New York Post". At this time LYONS told OSBORNE that he, LYONS, had been informed personally by WINCHELL that the latter's story in connection with the OSBORNE cablegrams was true, and that he could back it up.

As an aside, OSBORNE volunteered that for the past several years, WINCHELL has been taking a "lot of cracks" at "Time" Magazine in the hope of fermenting some correspondence and publicity between WINCHELL and "Time", which would result in some free publicity for WINCHELL. MEDINA stated that as a matter of policy "Time" incorporated completely ignored the remarks made by WINCHELL concerning "Time", its policy, etc. He also stated that WINCHELL has purposefully leaked information to newspaper sources indicating that he, WINCHELL, obtains his foreign news information from a confidential source at "Time" Magazine.
