Reference phone conversation of SA THOMAS SPENCER, this date.

ELLIOT INGRAM, 93 Mill River Avenue, East Rockaway, N.Y. was interviewed this dated. He is presently a student at Adelphi College in Garden City, N.Y. He resides at this address with his mother, Mrs. EDWARD J. BATEMAN.

INGRAM stated that he attended the Camp Riggs O'Marlow in Chestertown, Maryland from 1933 until 1938 and was also at the camp during the summer of 1940. He stated that he remembered TIMOTHY HOBSON very well as he had known him at the camp for several summers and had been assigned the same tent with him on several occasions. However, he did not recall any leg injury on the part of Hobson. He stated that he had met Mr. and Mrs. Hiss on several occasions at the camp.

INGRAM produced correspondence between he and his mother, showing that during August 1937 he had worked on the farm of one C. BROWN across the river from this camp. He worked and lived right on the farm and only visited the camp occasionally during that time. He was unable to state if the HISSSES were at the camp daily for any extended period.

During the course of examination of CHAMBERS this morning, defense attorney CROSS elicited from CHAMBERS the fact that he had first been interviewed by the FBI in 1942 or 1943 and that subsequently, from then until August, 1948, he had been interviewed approximately ten to fourteen times by agents of the New York Office and, most of the time, at his office at Time, Inc. CROSS then asked for the production of FBI reports dated 5/14/42 and 6/26/45. He referred to the transcript of the first trial of the HISS Case in requesting this report. AUSA MURPHY objected strenuously to the introduction of these documents and brought out the fact that these were not statements signed by CHAMBERS, but were reports made by FBI Agents as a result of interviews with CHAMBERS. CROSS pressed the point and the Judge eventually decided that he would examine the two reports in question and, if he found any inconsistent statements, that he would, of course, be forced to allow the defense to see that portion which contained statements inconsistent with CHAMBERS present testimony.

It will be recalled that in the first trial, this matter was brought up almost in the same fashion and that Judge Samuel Kaufman requested that he be given the two letters in question. After Judge Kaufman examined these letters, ~~he advised the defense that certain portions of them were shown to the defense and CHAMBERS was subsequently cross-examined in connection with these inconsistent statements.~~

After this motion had been dispensed with CROSS requested that all information appearing in the FBI files wherein CHAMBERS had made statements to FBI agents be made available to him. MURPHY again strenuously objected to the production of such material, indicating that it would be a physical impossibility to even check the indices and obtain such information in a reasonable period of time.

At the close of the trial at 1:00 P. M. today, it was decided that the reports of 5/14/42 and 6/26/45 be presented to Judge Goddard for his perusal and that the matter of the additional information requested by CROSS in connection with FBI reports be handled subsequent thereto. In accordance with Judge Goddard's decision, it will be necessary to produce today, the New York office letters to the Bureau dated 5/14/42

Any decision rendered by Judge Goddard or statements made by Defense Attorney CROSS in connection with other Bureau reports will be immediately brought to the attention of ASAC A. H. Belmont.

During the argument between MURPHY and CROSS in connection with the production of these letters, CROSS stated that, if the Government did not produce the reports, he would subpoena the agents who talked to CHAMBERS and examine them on whatever information CHAMBERS divulged to them. It might be noted that during the course of cross-examination CHAMBERS recalled having talked to an Agent Greenwald and Jack Ward. In connection with Greenwald, it might be noted that in the letter of 5/14/42, there is a report of the interview had with CHAMBERS by SA JOHN R. PAUL and E. J. Greenwald, Jr.

In the opening statement of CLAUDE GROSS in this case, he indicated that the persons responsible for abstracting documents from the State Department were HENRY JULIAN WADLEIGH and (X), an individual in the Far Eastern Division of the State Department. Mr. X was not further identified. Mr. MURPHY stated that he obtained some information indicating that Mr. X might possibly be JOHN CARTER VINCENT. It is to be noted that this individual was mentioned somewhat prominently in the AVERASIA case.

It is suggested, therefore, that the AVERASIA file be reviewed and a summary of the information concerning JOHN CARTER VINCENT be prepared so that it may be used in the event VINCENT'S name comes out in this trial.

In a conference last night in connection with the trial of this case, Mr. MURPHY stated that in a telephone conversation he recently had with RAY MURPHY of the State Department, the latter told him that the manner in which the passports were obtained in the "WEINER" passport fraud case paralleled the story told by WHITTAKER CHAMBERS as to how he obtained a passport in the name of DAVID BREEN. Mr. MURPHY recalled that this case was handled by the Bureau's New York Office and suggested that possibly there might be some information in our files that might be of some assistance to him in the prosecution of this case.

It is suggested, therefore, that the WILLIAM WEINER passport file be reviewed, as well as the file 40-241. In the exhibits of the 40-241 case there appears a great deal of information concerning passport frauds in connection with Communists and Soviet agents. It is suggested that a summary of this information be prepared as soon as possible so that it can be given to Mr. MURPHY.

Reference is made to memorandum of SA T. G. SPENCER of 10/31/49 (Serial 4721) which indicated WHITTAKER CHAMBERS related on 10/18/49 that in about July, 1935, he and his wife and Mr. and Mrs. ALGER HISS had talked about getting a place in the country for the rest of the summer. He and Mrs. CHAMBERS recalled reading an advertisement, probably in the Sunday edition of the "New York Times," or the "New York Herald Tribune," which listed a summer place adequate for two families near Callicoon, New York. This summer place was allegedly on the Upper Delaware River, probably just above Callicoon, and near the town of Black Eddy. (A check of maps and postal directories indicates there is no place called Black Eddy in New York State and undoubtedly what is meant is the town of Long Eddy).

CHAMBERS related that one day, he could not recall if it was a Sunday or a week day, he, with ALGER and PRISCILIA HISS, drove to the summer place, found it to be unsuitable and returned to New York City the same day. CHAMBERS described the house as "small and shacky" and he recalled that it was situated between a dirt road and a railroad track and about one-half mile from either the Delaware River or a small lake. CHAMBERS said that they talked to a man and woman who apparently owned the premises, but he could not give any description whatsoever of these individuals.

It was suggested that a review of the "New York Times" and the "New York Herald Tribune" for July 1935 be made in an effort to locate this advertisement, and if it was located that further investigation should be conducted to determine whether anyone presently residing in or near this summer place, could possibly identify ALGER and PRISCILIA HISS or WHITTAKER CHAMBERS.

On November 7 and 9, 1949 the writer, at the New York Public Library, 137 West 25th Street, New York City, reviewed the classified advertising sections of the "New York Times" and "New York Herald Tribune" for the dates from June 16 to July 31, 1935.

The following advertisements were located, one of which might be the advertisement mentioned by CHAMBERS:

It is suggested that investigation be conducted at Long Eddy, New York and Callicoon, New York, both of which are in Sullivan County, at the places mentioned in the above set out advertisements, to determine whether anyone presently residing in or near these summer places, or the persons who placed the above advertisements, can identify photographs of ALGER HISS and PRISCILLA HISS, or WHITTAKER CHAMBERS, as those of individuals who in 1935 were seeking a summer place in Long Eddy or Callicoon, New York.

Re memo of SA T. G. SPENCER, 11/17/49, requesting investigation at Department of Health, New York City, concerning Birth Certificates of DAVID BREEN and EDNA ROGERS.

On November 18, 1949 the writer contacted MATTHEW BURNS, First Deputy Commissioner, Department of Health, New York City, 125 Worth Street, who referred the writer for the required information to CARL L. ERHARDT, Director, Bureau of Records and Statistics, Department of Health, New York City.

Mr. ERHARDT advised that the Health Department had received a subpoena from the attorneys for ALGER HISS dated November 15, 1949, requiring the bringing in Federal Court of:

1. Birth record of DAVID BREEN, born April 28, 1900, son of JOHN EDWARD BREEN;
2. Death certificate of DAVID BREEN, date of death unknown;
3. Death certificate of JOHN EDWARD BREEN who died September 26, 1908.

ERHARDT stated that the birth and death records of DAVID BREEN were located, but no record was found for the death of JOHN EDWARD BREEN.

A representative of the Department of Health appeared in Federal Court on November 17, 1949 with photostatic copies of the birth and death records of DAVID BREEN, but he was advised that he was not needed at the time, and should hold himself in readiness for a future call to appear.

ERHARDT exhibited a photostatic copy of the Birth Certificate of DAVID BREEN dated May 7, 1900, Number 7889-1900, Brooklyn. This birth report had been made by Dr. JOSEPH A. KENE (handwriting not clear), 169 Elloby Street, (Brooklyn). It reflected that DAVID BREEN was male, white, born April 28, 1900 at 17 Clermont Avenue (Brooklyn), his father, JOHN ED BREEN, 17 Clermont Avenue.

The father was born in the United States, was twenty-eight years old, and his occupation was a clerk. The mother was MAY BREEN whose name before marriage was O'NEIL, 17 Clermont Avenue, born in the United States, and twenty-three years old. The BREENS had one previous child, and on the birth of DAVID BREEN they had two living children (this included DAVID BREEN).

ERHARDT indicated that his records show that only one request had been made for a copy of the birth record of DAVID BREEN, which was made on March 16, 1935. The name of the person who made the request and received a copy of the birth certificate was not shown in the records. The only other request for this birth certificate was made by subpoena from the HISS attorneys.

ERHARDT advised that he could not make a search for the birth record of EDNA ROGERS unless more specific information was given to him such as the date of birth, names of the parents, etc.

ERHARDT exhibited a photostatic copy of Death Certificate Number 17757-1 Brooklyn, for DAVID BREEN which was dated October 18, 1903 and signed by Dr. JOSEPH A. KENE, 14 Greene Avenue. This certificate indicated that DAVID BREEN, white, male, died at 17 Clermont Avenue (Brooklyn) at the age of three years, six months. He was born in Brooklyn and died in a private home. His father, JOHN ED BREEN, was born in the United States. His mother's maiden name was MARY O'NEILL and she was born in Brooklyn. The doctor attended the deceased on October 17 and 18, 1903. DAVID BREEN died on October 18, 1903 at about 1:00 A. M. The cause was diphtheria (duration six days), and contributing cause was heart failure.

The Hiss attorneys have subpoenaed the birth record of David Breen from the New York City Health Department.

It would appear that this is in connection with the passport application of Whittaker Chambers in the name of David Breen, which the defense have subpoenaed and which they have seen.

Mr. Murphy requests that investigation be made at the Department of Health in order to locate this birth certificate and copy therefrom all pertinent information. An effort should also be made to determine what, if any requests were made, and by whom, for a copy or copies of the birth certificate of David Breen.

According to the passport application filed by Chambers, he indicated that he, as David Breen, was born in New York City April 28, 1900, and his father's name was John Edward Breen, born at Rutland, Vermont, and died September 26, 1908; that David Breen was married April 3, 1929. It is requested that the information appearing on this birth certificate be obtained.

In the passport application of David Breen it is indicated that Breen's wife's name was Edna Rogers. It is requested that a search of the Board of Health records be made to determine, if possible, the location of a birth certificate in the name of Edna Rogers, it being assumed that she was born somewhere between 1900 and 1910. Mr. Murphy requests that every effort be made to obtain the Edna Rogers birth certificate and that, if this appears to be an unsurmountable task, he be so advised.

On the afternoon of November 16, Mr. Donald Parsons of the Bureau Laboratory called relative to our teletype of November 14th, wherein we requested the Laboratory to furnish us with the dates of all laboratory reports showing examination of all typewriting specimens obtained and examined which are dated during the year 1937 and for the first four months of 1938. Mr. Parsons advised that this would entail a rather length project and he wanted to be sure that the Laboratory understood that we wanted what we asked for in the teletype.

I advised him that the defense attorneys in one of their motions had stated that the FBI during its investigation interviewed and obtained typewritten documents from between 500 and 1,000 persons, which documents had not been returned by the Bureau to the persons interviewed. Further, the defense contended that some of these documents might be identified as having been written on a Corona portable typewriter and if the defense was able to examine such documents, it would enable the defense to more exactly determine the date when HISS got rid of the Woodstock typewriter inasmuch as it was supplanted by the Corona portable typewriter. I advised Mr. Parsons that during the forthcoming trial it may be that the defense will renew its request for such documents; therefore, we desire to be in a position to know what documents the Laboratory had examined and if the documents had been returned to the persons supplying them.

Mr. Parsons advised that the Laboratory would get to work on this at once and furnish us the desired information.

Reference is made to Baltimore teletype to the Bureau, New York and Philadelphia dated November 2, 1949.

Efforts to locate the tourist house at which ALGER HISS and WHITTAKER CHAMBERS remained overnight on the Saturday night before Easter, 1934 or 1935, have been fruitless.

A detailed map of Montgomery County, Pennsylvania, is being forwarded with this letter for the assistance of the Baltimore Office in attempting to refresh WHITTAKER CHAMBERS' recollection of the tourist house on Route 202 in the vicinity of Center Square, Pennsylvania. The map has inked notations of landmarks, many of which were present during the period, 1934-35. The distances north and south of Center Square of these landmarks are approximated. The notation on the map regarding Strassburger's Estate indicates that the estate is bordered by a white stone wall approximately ten feet in height and approximately two-tenths of a mile in length. This wall parallels Route 202 on the west or left side facing north and is a little more than one mile north of Center Square. The notation regarding William Penn Inn was entered on the map in that it is a landmark that might easily refresh CHAMBERS' recollection since the Inn was located at the same site approximately four miles north of Center Square on the west or left side facing north since approximately 1925. The Gwynned Inn is indicated on the map as the Sunset Inn, by which name it was known in 1934-35.

## Informant Says State Department Files Open to Counsel

## SAY HISS AIDED BY STATE DEPARTMENT

Attorneys for the former top-ranking State Department official have been given free access to many of the files from which he is alleged to have stolen documents for a Soviet spy.

Hiss is scheduled to go to trial Nov. 17 on charges of swearing falsely to a grand jury last December when he denied peddling the confidential papers to Whittaker Chambers, confessed agent for the Kremlin.

His first trial ended in a jury disagreement last July with eight of 12 jurors voting for a guilty verdict.

### Meet Obstacles

In some sections of the State Department, it was learned, Hiss' legal staff encountered obstacles. The Passport Bureau refused to permit examination of its papers and Attorney Claude B. Cross obtained a court order which the government today asked Federal Judge William Bondy in New York to quash. Judge Bondy took the petition under advisement.

The Hiss lawyers, it was said, were even permitted to examine confidential files which have been banned to Congressional investigators by a Presidential gag order. They were seeking evidence, it was said, not only to buttress Hiss' defense, but to discredit government witnesses against him.

### Work with Counsel

Hiss, free under \$5000 bond, obtained legal permission some time ago to leave the New York court's jurisdiction and come to Washington to work with attorneys in shaping a "new line of defense."

Hiss has powerful friends in Washington, including State Secretary Acheson, under whom he once served. According to testimony of former Assistant Secretary A. A. Berle, the Acheson-Hiss group in the State Department was known as the "pro-Russian" clique.

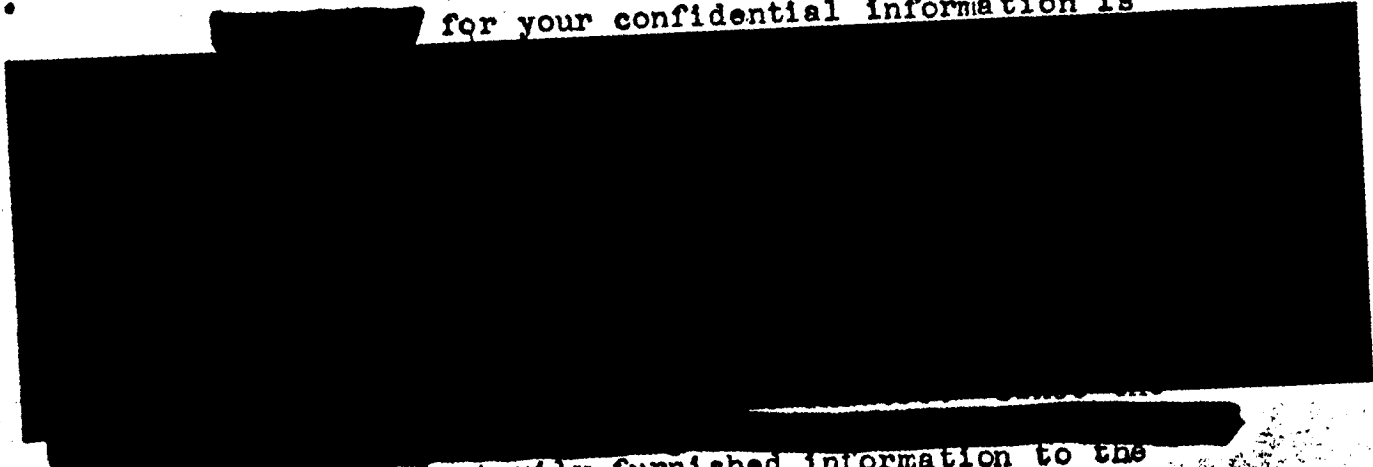

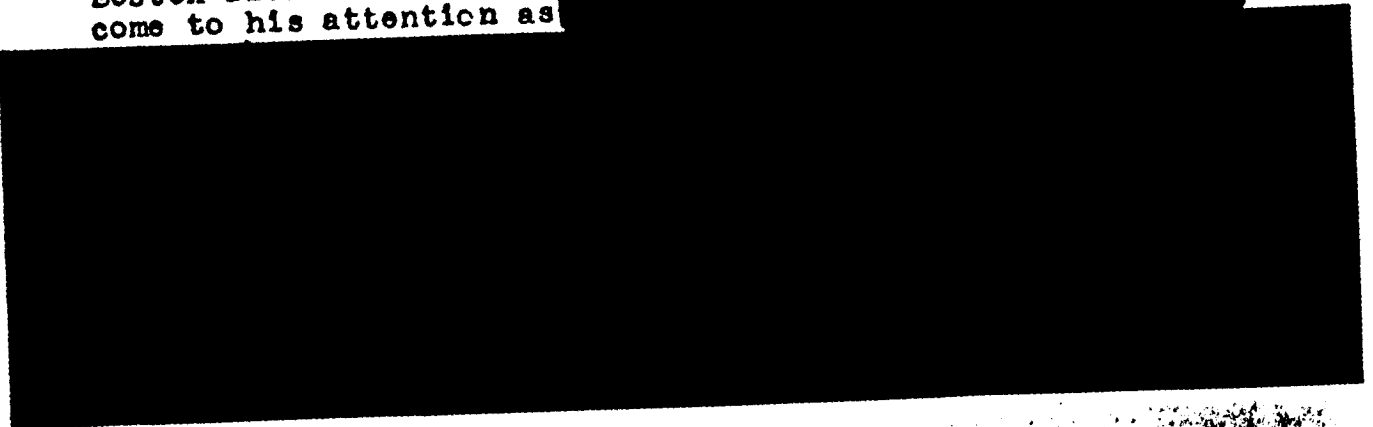

On November 3, 1949 Doctor PAUL W. MASSING was interviewed by Special Agent John W. O'wara and the writer. He advised that during the previous week the head of the Sociology Department at Rutgers University and his superior, one Mr. RILEY had contacted and advised him that an attorney by the name of VAN MERON (Phonetic) had contacted RILEY and wanted to interview Doctor MASSING since he understood that Doctor MASSING was separated from his wife, HEDE MASSING who is to be a witness in the coming trial of ALGER HISS. VAN MERON advised RILEY that he wanted to find out from Doctor MASSING some information concerning HEDE MASSING'S citizenship status, also something concerning her reliability.

Doctor MASSING told Mr. RILEY that he did not wish to talk to VAN MERON and that so far as he knew Mrs. MASSING'S citizenship status was legally sound and that anything she said was absolutely reliable.

Doctor MASSING has not heard from VAN MERON since the contact through RILEY.

VAN MERON is probably VAN WERTON who is an attorney in the law firm of McLean, who has been handling the bulk of the preparation for the defense in connection with the coming trial.

On November 7, 1949 HEDE MASSING advised the writer that she had on the morning of November 7, 1949 received a call from a girl named HELGA CONROY who formerly worked with her at the Shipyard in Hoboken, New Jersey during the war. HEDE was HELGA'S boss. They were very friendly. HELGA advised HEDE that she had been contacted through an attorney friend of hers named SALINE (Phonetic), who was speaking for an attorney, CLAYTON (Phonetic), who represented the law firm of Hutton and Hinch (Phonetic). HELGA was to be interviewed concerning her knowledge of HEDE MASSING. She called HEDE immediately after she
