At 9:50 a.m. today NELSON FRANK of the "World-Telegram" telephonically informed the writer that several days ago an acquaintance of his whom he would identify only as a sincere, high type Socialist, had asked him whether he and his newspaper would be interested in buying certain information pertaining to captioned matter; particularly information to be supplied by HEDE "ASSING" and which would, according to the representation made to FRANK, supply the actual details connecting subject ALGER HISS with the Russian agent BORIS BYKOV.

FRANK said it was only after considerable interrogation of this man that he learned the information being offered emanated from "ASSING", and that after consulting with his editor on the matter, it was decided that the World-Telegram was not interested. FRANK claimed to have been unable to secure the exact details of the information to be furnished.

At 11:30 a.m. today FRANK further informed the writer that he had just learned that the above-described information was being purchased by the New York "Daily News" for a reported sum of \$750, and that the information had been represented as consisting of definite "proof" of the link between ALGER HISS and the Russian agent BYKOV. FRANK said he had not been able to establish whether "ASSING" herself was the instigator of the transaction and explained that she allegedly had told her story to a friend, who in turn had discussed the matter with the Socialist friend of FRANKS, and that he did not know who was to receive whatever sum was realized in the event a sale could be made. FRANK also pointed out that "ASSING'S" information was said to be noted on four sheets of paper which of course would go to the purchaser.

It is suggested that inquiry be made of HEDE "ASSING" for details of this alleged transaction.

There is being transmitted herewith a photograph of FELIX AUGUST INSLERMAN which was obtained from the personnel file of INSLERMAN at the General Electric Company, Schenectady, New York. INSLERMAN is presently employed by the General Electric Company.

For the information of the New York Office and the Bureau, the personnel file reflects that he is presently being investigated for clearance for secret work on "Project Hermes", which is a highly secret U.S. Army Project presently being carried on at the Schenectady Works of the General Electric Company. (It would appear from his work address that he may already be employed on this project.)

It is desired, in accordance with the request of the Baltimore Office, that the photograph of INSLERMAN be exhibited to JAY DAVID WHITTAKER CHAMBERS, to determine if he is identical with the "FELIX" who was used as a photographer by the espionage network.

In the event he is so identified, it is requested that this office be advised immediately, and it is suggested that the Bureau be notified immediately, in order that consideration may be given to furnishing the Army with sufficient information to cause him to be rejected for clearance to work on a secret project.

The enclosed photograph must be returned promptly to the Albany Office for return to the General Electric Company.

I informed Mr. McFarlin that we had received the teletype from Baltimore stating that the photograph of FELIX was being sent to New York, but that we had not as yet seen the photograph. Mr. McFarlin informed me that Baltimore has another photograph of FELIX which is clearer and if CHAMBERS is hesitant about identifying FELIX, Baltimore will send the second photograph.

After checking with Section 1, I advised Mr. McFarlin that the photograph had just arrived and that we would exhibit it to CHAMBERS this afternoon, if he were available. Mr. McFarlin requested that Baltimore be advised immediately as to whether or not CHAMBERS identifies this photograph. I told him I would call him.

Re: LAURENCE DUGGAN

At 4 p.m. I received a call from Mr. Nichols in which he emphasized that we are to say nothing whatsoever to the press concerning the nature of the interview with DUGGAN or the reasons for his interview. He advised that there had been a big story in the Miami papers going into the details of the interview and attributing the source of their information to this office. I assured Mr. Nichols that the story was absolutely without foundation and that we have not discussed the matter with anybody.

I pointed out that the press is apparently trying to keep the story alive; that we are constantly receiving inquiries; but that we have not told them anything except that DUGGAN was interviewed. I advised Mr. Nichols that there is little mention of the FBI in New York papers, except to state that so far this office has declined to reveal what DUGGAN said or why the FBI was interested in him. I told Mr. Nichols I would be on the look out for any mention of the FBI in future editions of New York papers.

Mr. Nichols said if we get any further inquiries from the press we should merely state we have no further comment to make other than what has already been said, and if questioned further we should tell them any other comment would have to come from the Attorney General. He also requested that we send a teletype to the Bureau setting forth exactly what we told the papers in connection with the DUGGAN matter.

I advised Mr. Nichols I would review the late editions of the papers here and would call him back to give a synopsis of what they say.

At 5:10 p.m. I called Mr. Nichols and read to him a summary of an article appearing in today's edition of the New York Post by JAMES A. WECHSLER under dateline Washington D.C., December 23rd, concerning LAURENCE DUGGAN's story to the FBI allegedly obtained from a highly authoritative source. The article stated that he was asked by FBI agents what he knew of the alleged Communist underground spy apparatus within the Government. He told agents he had been approached by a person, identity not disclosed, with an offer to be admitted to the ring, but DUGGAN had rejected the invitation.

I pointed out to Mr. Nichols that the Post article states that the New York FBI has refused to answer any inquiries as to why DUGGAN had been questioned or what he said. I told Mr. Nichols I had before me a copy of a memorandum reflecting the results of a previous conversation had by Mr. Nichols with Mr. Belmont in which it was decided exactly what the press should be told, and that we had strictly adhered to the Bureau's instructions in this regard.

Mr. Nichols requested I write a letter to the Bureau setting out the information given to the press and enclosing a copy of the memo dictated by Mr. Belmont.

I had a call referred to me from Mr. Scheidt's office on the morning of December 23d from MICHAEL SINGER, a reporter for the "Daily Worker" who stated that he is doing some articles on the appearance of GEORGE HEWITT before the Grand Jury. He stated that he had been advised by Mr. Scheidt on December 22d that this office had no record of the local police department's wanting GEORGE HEWITT on a State warrant. He inquired whether or not there was any action that we ordinarily take to make people available whose whereabouts we know of for the local police. I advised him that there could be no general statement made to that effect since the local police did not advise us or have no reason to advise us of every person that they want or have a warrant for, just as we don't advise the local police of every person for whose arrest we have a warrant.

I pointed out to him that we do maintain, under Congressional enactment the National Repository of Fingerprints in Washington and that local police are invited to place wanted or stop notices against the fingerprints of the person they want. Then if this person is picked up in another jurisdiction and is fingerprinted and his fingerprints are sent in by the police department that recently arrested that individual, the Washington headquarters advises both police departments of the recent arrest.

I pointed out to him that such wanted notices in our National Fingerprint File in Washington are not known to all the various FBI offices like the New York Office.

I further advised him that in instances such as the case he is interested in, when a man appears before a Grand Jury to answer a subpoena there would be no fingerprints taken of the person and the operation of the fingerprint Bureau service would not come into play.

SINGER then inquired whether or not it was lawful to arrest on a local warrant someone who was under a Federal Warrant or Federal process, such as HEWITT. I told him that was a legal question that could be passed upon appropriately by the local District Attorney interested in the case or by the Federal District Attorney, who is familiar with the case or that he might appropriately address it even to his own attorney; that it was not a matter of investigative fact upon which we could make any statement.

He then inquired whether or not a person, such as HEWITT, appearing before a Grand Jury, was not under some sort of guidance or protection of the FBI. I told him, again that I thought the proper place for him to address such an inquiry was to the local District attorney or Federal Attorney or his own attorney for a legal opinion, if that is what he wanted. I further advised that as a matter of fact he should, from his general information, realize that subpoenae issue from various State Judicial and quasi judicial bodies and various Federal Judicial and quasi judicial bodies as well as legislative bodies both Federal and State and that the FBI in no way ever comes into the picture since the subpoena is issued by either the State or Federal Judicial or Legislative bodies and that the person it is issued to is answerable to that body.

I called Inspector L. L. Loughlin at the Bureau and advised him of the lead headline in the "Daily Worker" for this morning (dec. 23): "FBI PROTECTS STOOLPIGEON FROM APREST. Hewitt at Jury While Cops 'Seek' Him," and that the fact that this story had been written by MICHAEL SINGER and advised him of SINGER'S call to this office and of my answers to him.

Mr. Cornelius stated that this material was leaving the Albany Office this morning and he would see that it was sent to the Bureau. O'Brien of the New York Office. According to Mr. Donegan, McLEAN is desirous of having these specimens returned to him in order that they may be appropriately examined by a handwriting expert. Mr. Donegan requested that in the event these specimens were in the New York Office they should be immediately returned to Mr. McLEAN, and in the event they were still in the FBI Laboratory in Washington, some expeditious means should be used to have them returned to Mr. McLEAN as soon as possible. This afternoon, I advised Mr. H. E. Fletcher of the Bureau that HENRY HILL COLLINS, Jr., upon contact, had refused to permit being interviewed by us. He stated that he could be of no assistance to the FBI and did not want to be interviewed by the FBI.

With respect to the Bureau's instructions that we interview FREDERICK V. FIELD, I advised that we had ascertained today that FIELD is presently believed to be at New Hartford, Connecticut, near Torrington; that one source indicated he would be there until after New Years while another source indicated that he was returning to New York City tomorrow morning. I asked Mr. Fletcher if he desired New Haven to attempt to interview him today. He stated we should wait until tomorrow on the possibility that he will be in New York. I advised him we would do this and, in the event he did not return, we would have New Haven make a discreet check to ascertain if he is definitely at New Hartford.

Mr. Fletcher was further advised that T. J. Monegan, Special Assistant to the Attorney General, had informed us today that Mr. McLEAN, attorney for ALGER HISS, had requested that the typewriting specimens turned over to this office by McLEAN be returned; that Mr. Monegan felt they would have to be returned and accordingly, we were returning them to Mr. McLEAN this afternoon.

I advised Mr. Fletcher that, with respect to his inquiry earlier today relative to the WOODROW WILSON FOUNDATION we had ascertained that FRANKLIN D. ROOSEVELT was its first president and that HARRY GIDEONSE, President of Brooklyn College, is now its president. I further advised that numerous prominent names are listed among its directors, including DARRYL ZANUCK, JOSEPH DANIELS, HENRY WALLACE, etc., and that its purpose is to promulgate the world peace ideas of WOODROW WILSON. It has a list of 200,000 contributors, maintains the Woodrow Wilson Memorial Library and, since we have no previous derogatory reference on it, it would appear to be a legitimate outfit.

I further advised that we were still checking on KLEINER and would call him back later today with the results of our inquiries.

At 4:55 pm today, I advised Mr. Fletcher that we were continuing our efforts to identify KLEINER but have not come up with anything. I informed him we discreetly interviewed some people and also the superintendent at the residence of ATWATER. The superintendent stated that ATWATER always has someone living with her. The superintendent stated he was not familiar with the name of KLEINER and pointed out that the apartment house is cooperative and does not permit Jewish people in. The superintendent further stated that ATWATER has been having a Mrs. JONES living with her for the past 3 or 4 years. I advised Mr. Fletcher that in the event our inquiries are negative, we are going to make some discreet checks at the WOODROW WILSON FOUNDATION. I inquired of Mr. Fletcher whether there would be any objection to interviewing ATWATER in the event the check at the WOODROW WILSON FOUNDATION were negative. Mr. Fletcher stated he did not think there would be any objection but that we should clear with him before we contact ATWATER.

I called Mr. Fletcher of the Bureau at 5:15 PM on the evening of December 27th and advised him that we had contacted HEDE MASSING and that she knew none of HISS' associates and knows nothing about BORIS BYKOV and added that any statement connecting ALGER HISS and BYKOV is inaccurate. She had never authorized the sale or the giving away of information and that the only people who knew of her knowledge of HISS' alleged espionage activities are the FBI, Federal Grand Jury and her husband, PAUL.

I also mentioned that Mr. Donegan had advised us that NORMA ABRAMS had told him that the "Daily News" had been offered a story concerning HEDE MASSING's knowledge of HISS' connection with BYKOV and which was mentioned in our teletype of the 27th. This story was the same as NELSON FRANK furnished to us with the exception that there was a reference made to documents. I advised him this was probably the four pages of notes FRANK had mentioned to this office. Mr. Donegan stated that Norma Abrams said she did not believe that the news would purchase a story.

I also called Mr. Fletcher's attention to an article appearing in the "Brooklyn Eagle", by-lined Washington, D. C. dated December 27th, a UP dispatch, wherein they make reference to DEWEY PEARSON's broadcast of Sunday night wherein he stated that HEDE MASSING and BORIS BYKOV had attempted to locate LAWRENCE DUGGAN. I pointed out that the person was probably wrong in his reference to BYKOV since MASSING did not know him and further that the story apparently circulating around the New York press on the 27th probably grew out of the PEARSON broadcast and has no basis of fact. I asked him if he desired the article in the Eagle and also a similar article prominently mentioning HEDE MASSING in connection with LAWRENCE DUGGAN and Attorney General Tom Clark's interview on television broadcast Sunday night. Late this afternoon Special Assistant to the Attorney General T. J. DONEGAN advised this office that he had received a telephone call from RUBIN B. SHWITZ, an Attorney, Two Seven Six Fifth Avenue, New York, who is the brother of CHAMBERS' wife. According to Mr. DONEGAN, SHWITZ telephonically communicated with WILLIAM McJULTY of the Law Firm of MINTON and McJULTY who are the present attorneys of CHAMBERS, and informed McJULTY that he had in his possession two notes in connection with the recent publicity about CHAMBERS' life having been threatened by GRACE HUTCHINS. McJULTY had apparently advised SHWITZ to turn these papers over to Government Officials. At six PM this evening, agents of this office, at the request of MR. DONEGAN, appeared at his office where SHWITZ related the following story: SHWITZ has only seen WHITTAKER CHAMBERS on about ten occasions subsequent to the marriage of his, SHWITZ, sister to CHAMBERS; that one of these occasions was sometime in nineteen thirty-eight when CHAMBERS informed SHWITZ that he was breaking with the Communist Party and gave definite indication that he was in fear of his life. Sometime thereafter, an unknown woman appeared at SHWITZ' Law Office and, on finding that he was not there, left the following handwritten note: "Thursday, May nineteen, nineteen thirty-eight. Dr. Mr. SHWITZ, there is a very important (this word underlined) message for your sister. If she or her husband will call either STEVE or me, we have some important memos for them. (Signed) GRACE, Labor Research Association, eighty East one one Street, Stuyvesant nine dash one naught four two." Later that same day, upon SHWITZ' return to his office, he made a telephone call to the previously mentioned number and talked to a woman, whom he described as having a very "Intellectual and Cultured voice", who stated that if SHWITZ would inform her of the whereabouts of CHAMBERS, she would see to it that CHAMBERS' wife and two children would have no harm done to them. Although Mr. SHWITZ' recollection is not very clear on this telephone conversation, he did recall quite specifically that the woman indicated that it was "A matter of life or death."

During this telephone conversation, an appointment was made for this woman to visit SHEMITZ in the latter's office. SHEMITZ stated that upon a review of his diary for May, thirty-eight, there was found a notation "four forty PM Miss STEVEN or Miss STEVENS." He recalled that this Miss STEVENS talked to him and reiterated the conversation she had had with SHEMITZ over the telephone previously, and SHEMITZ agreed to get in touch with Mr. CHAMBERS if he could. SHEMITZ stated that, although he does not even have a hazy recollection of this woman's description, he is positive she is the same woman who talked to him over the telephone because, he stated, of the very cultured and refined voice she possessed. At the conclusion of this conversation, SHEMITZ requested this person to leave a written note that he could turn over to Mr. CHAMBERS and she then wrote the following on a torn slip of paper: "GRACE and her friend, STEVE, must get in touch with you immediately". There are other notations on this paper, which were explained by SHEMITZ - one is the notation, "Two one three naught W, Lynbrook", Long Island, and the notation, "Pikesville, Maryland eight four four F dash twelve, operator ninety one". SHEMITZ related this was the telephone number of CHAMBERS in Maryland and that he had attempted to telephonically communicate with CHAMBERS but was unsuccessful in reaching him. Sometime later, he stated, possibly within a month, SHEMITZ met CHAMBERS quite by accident near SHEMITZ' Law Office and he verbally informed CHAMBERS of the message and telephone conversations he had had with this unknown woman. SHEMITZ was quite definite in his recollection that CHAMBERS did not outwardly place any importance whatsoever on the information supplied by SHEMITZ at that time. Further efforts will be made to determine whether the GRACE and Miss STEVENS mentioned before are identical with GRACE HUTCHINS.

On December 27, 1948, the writer contacted Mr. T. J. Donegan pursuant to instructions from the Bureau that he should be contacted relative to a proposed reinterview of HORACE SCHWAHL, private investigator, who has been retained by the attorney for ALGER HISS, Mr. McLEAN.

It was pointed out to Mr. Donegan as set forth in the teletype of December 22, 1948, from the Washington Field Office, that SCHWAHL throughout his own investigation had inquired only about typewritten specimens and that he made no inquiries concerning the typewriter itself; that further more it was felt that perhaps SCHWAHL had knowledge of the present whereabouts of the typewriter or had knowledge concerning the disposal of this typewriter by PRISCILLA or ALGER HISS. Mr. Donegan stated that in order to interview SCHWAHL it would be necessary to contact the attorney, Mr. McLEAN. He stated further that he felt at this particular time not much of value would be obtained in interviewing SCHWAHL as SCHWAHL had previously stated that he would keep the Bureau advised of any pertinent developments that he might uncover. Mr. Donegan felt that there would be a duty placed upon SCHWAHL, and also upon the attorney, Mr. McLEAN, to advise the Government if any evidence came into their possession that would be pertinent to this criminal investigation.

Donegan Mr. Donegan was also asked if he felt that at this time we should interview TIMOTHY HOBSON, son of PRISCILLA HISS by her first marriage, who is presently residing with the HISS family at 22 East 8th Street. Mr. Donegan stated that he felt that the proposed interviews of SCHWAHL and HOBSON should be held in abeyance at the present time. He stated that he still felt that the most damaging evidence in the Government's possession were the statements made by ALGER HISS on December 4, 1948, to the agents in the Baltimore Office that his wife, PRISCILLA, had disposed of the typewriter to a second-hand dealer in the vicinity of their home in Washington, D. C., subsequent to 1938.

Mr. Donegan stated that in ALGER HISS' testimony before the Grand Jury he had stated that the typewriter was disposed of some time around

1936 It was Mr. Donegan's thought that ALGER HISS had completely forgotten about his statement to the agents in Baltimore, and that he did not feel that he wanted to refresh ALGER HISS' recollection as to this statement. He stated that it was his thought that an interview with HOBSON or SCHWAHL, which in all probability would have to be conducted in the presence of the attorney McLEAN, may in all probability bring out the discrepancy between HISS' statements to the Baltimore agents and to the Grand Jury.

Mr. Donegan was advised of the contents of the teletype from the Washington Field Office dated December 24, 1948. Mr. Donegan stated that since there were now three witnesses in Washington who had knowledge of a typewriter being in the HISS home around 1946 or 1947, he felt these were very strong points and furthermore he had no objection to the agents of this office conducting extensive investigation in the vicinity of the HISS home in order to secure witnesses who may possibly have observed the typewriter in the home of ALGER HISS at 22 East 8th Street, New York, N. Y. He stated he had no objection to agents interviewing the superintendent and in fact he felt that they could even go to the neighbors who live next door to the HISS apartment to make inquiries regarding their knowledge of the existence of a typewriter in the home of ALGER HISS.

Mr. Donegan stated that in the event witnesses are found who can reasonably be sure that they have observed an old-fashioned upright typewriter in the home of ALGER HISS, at this point he would consider contacting attorney McLEAN and advising him that we now have definite evidence that the typewriter was in the HISS home in Washington, D. C., in 1946 and 1947, and was also observed more recently in their home in New York City. Mr. Donegan stated that he felt at this point the interviews with TIMOTHY HOBSON, Mrs. HISS, and SCHWAHL may then be contemplated.

The following is a summary of all information in the possession of this office with regard to the disposal of the Woodstock typewriter:

At the time ALGER HISS was interviewed on December 4, 1948, by agents of the Baltimore Office, he advised that it was his recollection that the typewriter was disposed of subsequent to 1938 to a second-hand dealer or second-hand typewriter store in the vicinity of his home in Washington, D. C. At the time ALGER HISS testified before the Grand Jury in New York City he was asked if he remembered whether the original big typewriter was sold or thrown out, and he answered he hadn't any recollection of its disposition. On another occasion before the Grand Jury he was asked how he disposed of the typewriter, and he said he frankly had no idea.

When Mrs. HISS was questioned both by agents of this office and before the Grand Jury, she stated that she recalled that they had an old typewriter that was given to her by her father in the early 1930's, but that she had no recollection of when or how it was disposed of. Upon constant questioning she maintained her position that she had no knowledge of how the typewriter was disposed of or the exact time it was disposed of.

TIMOTHY HOBSON, at the time he was questioned before the Grand Jury, advised that he only slightly recalled a large old upright typewriter in his home in Washington, D. C., but that he had no knowledge of how this typewriter was disposed of. Thus it can be seen that the only information as to the disposal of this typewriter was secured from ALGER HISS when he was originally spoken to by agents of the Baltimore Office on December 4, 1948.

This office is conducting extensive investigation in the vicinity of the present residence of ALGER HISS in order to ascertain if any of his neighbors or the superintendent or other employees of his house have any knowledge of the presence of an upright typewriter in his home. This office is also attempting to secure specimens of typewritten material typed by ALGER or PRISCILLA HISS, as well as by TIMOTHY HOBSON.

As you have been previously advised, Mr. Donegan is opposed at this time to further interviews of Mrs. HISS or TIMOTHY HOBSON. He has advised that he feels the statement made by ALGER HISS to the Baltimore agents is very damaging.

At 11:10 am today, I advised ASAC Santoiana of the New Haven office that an angle has come up in this case requiring that FREDERICK VANDERBILT FIELD be interviewed. I informed Mr. Santoiana that it had been ascertained that FIELD is supposed to be at New Hartford near Torrington, telephone Windsor 730-J-2. I told Mr. Santoiana that we thought FIELD was coming to New York today and that we would handle the interview here, but that a pretext telephone call to his secretary had disclosed that he will be at New Hartford until New Years. Mr. Santoiana was informed that the bureau will probably want an agent from New York to conduct the interview but that we wondered if New Haven would ascertain if FIELD is definitely at New Hartford, exactly where he is there and how long he will be there. I pointed out to Mr. Santoiana that if FIELD was going to be in New Hartford today and tomorrow, we could make arrangements to conduct the interview him up there either today or tomorrow. I further told Mr. Santoiana that we will obtain Bureau clearance before we send an agent to New Hartford to conduct the interview.

Mr. Santoiana advised that he would check on this immediately and call me back.

At 3:00 pm today, SAC Cornelius of the Albany office advised that INSLERMAN went to New York on Sunday afternoon and that his wife left for New York yesterday afternoon. He stated that a woman who lives down the road from the INSLERMANs is staying at the INSLERMAN house in their absence. The INSLERMANs advised this woman they would get in touch with her by phone tomorrow. This woman does not know where the INSLERMANs are staying in New York or how long they will be gone. Mr. Cornelius stated that the question arises as to whether Albany should have the woman turn the camera over to the agents on the basis of the old consent to search. Mr. Cornelius further stated this would not be done without authority from the Bureau.

I inquired of Mr. Cornelius whether the INSLERMANs advised when they were coming back or if they were coming back. He said that they had not. Mr. Cornelius further informed me that INSLERMAN's supervisor at work did not know where INSLERMAN was; that he has not reported for work since he was questioned by the FBI, nor has he been home since the agents talked to him. Mr. Cornelius advised that when Mrs. INSLERMAN left yesterday for New York, he took with her a small girl who had stayed with them during the summer months and who had come back to stay with them over the Christmas holidays. This small girl, who is Italian, came to the INSLERMANs through the Herald Tribune Fresh Air Fund and she is JOAN MORRONE, of 626 Clinton Avenue, Brooklyn, Apartment 3-D. Mr. Cornelius pointed out that JOAN MORRONE may know where the INSLERMANs are.

I told Mr. Cornelius that I did not think it would be possible to try to get the camera from the woman who is now staying at the INSLERMAN house on the basis of the old consent to search. Mr. Cornelius agreed, and stated it would not be done unless the bureau checked with the USA and the USA approved or else issued a search warrant for it. I asked Mr. Cornelius if the name of the woman in the INSLERMAN house was known and he said it was not. Mr. Cornelius advised that he was going to call the Bureau and advised Mr. Fletcher of the above facts and ascertain what action the Bureau recommends. I told Mr. Cornelius that I would be in touch with the Bureau later on and would see what action should be taken. I pointed out that the Bureau might want an agent to be present when the INSLERMANs call.

the woman tomorrow in order that he could talk to INSLEMAN on the phone and get a consent to search telephonically or ascertain whether the camera is in New York with him.

Mr. Cornelius was advised that we would hold off checking on JOAN MORRONE until we learn whether the Bureau first wants to try to deal with INSLEMAN telephonically.

Mr. Cornelius stated he would get in touch with Mr. Fletcher and call me later.

At 4:15, Mr. Cornelius called back to advise that he had spoken to Mr. Fletcher who instructed that the woman staying at the INSLEMAN house should tell INSLEMAN, when he calls tomorrow, that the FBI wants to get in touch with him. Mr. Cornelius stated that INSLEMAN will be furnished with my name so that he can get in touch with the New York office. If INSLEMAN does not call his house tomorrow, then we should wait until Saturday. Mr. Cornelius further stated that if INSLEMAN does not get in touch with this woman, this matter should be discussed with Mr. Donegan to find out if he wants to have a search warrant issued. Mr. Cornelius stated that Albany will make arrangements with the woman to tell INSLEMAN that the FBI wants to get in touch with him and for him to give her the address where he can be reached.

I was further advised by Mr. Cornelius that Mr. Fletcher instructed that New York should go ahead and try to locate INSLEMAN through JOAN MORRONE, the objective being to locate him and talk to him. Mr. Cornelius stated that if nothing develops, the Albany office will arrange on Saturday to contact the woman staying at the INSLEMAN house and at that time would try to get a look at the enlarger in INSLEMAN's possession. I suggested to Mr. Cornelius that at that time the agents try to ascertain if the camera in is the house so that in the event we talk to INSLEMAN, we would know whether he was telling the truth.

Mr. Cornelius stated that INSLEMAN's supervisor in Schenectady has advised that INSLEMAN is in a better position than any man in the project to know the makeup of the guided missile, the kind of metal which goes into each part and what makes the missile function. He is also in an excellent position to evaluate all the information which comes to him.
