An official of the Washington Gas and Light Company was called as a defense witness on December 28, 1949 and testified that the records of the Washington Gas and Light Company show that the gas at the residence of GEORGE ROUHLAK at the P Street address was turned off on January 10, 1938 and the meter was taken out on May 9, 1938, it being noted that no gas was consumed from January 10, 1938 to May 9, 1938.

AUSA MURPHY requests that ROUHLAK be immediately contacted to determine if he can recall if this was a fact and to inform as to how they heated the house and cooked their meals during the time that he and the CATTLETT family lived there.

At 9:35 this morning [redacted] called to advise that she read in this morning's papers that yesterday ALGER HISS testified that he had spent the Christmas of 1936 (1937, she thought) with "Mrs. HISS" brother at Chappaqua, New York.

[redacted] Mrs. JOHN COX, who resides at 51 East 97th Street and who presently can be reached in care of H. RITHOFFLER, 104 East 23rd Street, Huntington Station, Long Island, New York, telephone Huntington 5397, formerly ran a small school at Chappaqua and was very intimate with the FANSLER family. She said that if we desired to check to verify HISS' story about spending the Christmas in Chappaqua we might desire to contact "Mrs. COX, who should be in a position to corroborate or deny HISS' allegation.

[redacted] further advised that she was formerly associated with "Mrs. FANSLER when she was married to FANSLER, [redacted] she alleged [redacted] one time she heard of "Mrs. FANSLER being a Communist. [redacted] advised that "Mrs. COX told her on one occasion that, to say the least, the whole group, meaning the FANSLER - HISS crowd, was "slightly tinged with red."

"APPOPOS ATTACK ON TESTIMONY CONCERNING BLOOMING OF FLOWERS IN WINTER IN THIS AREA. DURING YEARS INVOLVED IN HISS CASE I WAS OWNER OF COLONIAL ESTATE KNOWN AS TULIP HILL NEAR ANNAPOLIS. AND FEEL YOU WOULD LIKE TO KNOW THAT IN MONTH OF JANUARY EACH YEAR JAPANESE QUINCE, ROSES AND FORSYTHIA WOULD BLOOM THERE. GOOD LUCK.

On both direct and cross-examination today Priscilla Hiss testified that she worked as a food server and a helper in a Socialist meeting hall that was located on the west side of Broadway between 120th and 125th Streets in New York City. She also testified that she attended meetings and made some contributions but particularly assisted in the serving of foods to "numerous unfortunates".

Victor Lasky, a staff writer for the World Telegram, advised Mr. Murphy today that he had talked with Julius Gerber today, a former City Secretary for the Socialist Party, and Max and Bob Delson, attorneys in New York City. The above mentioned people informed him that they have no recollection that any such establishment was maintained by the Socialist Party (in 1931-32, as testified to by Priscilla Hiss). Mr. Murphy suggests that Gerber and the Delsons be located and interviewed in connection with the allegations made by Priscilla Hiss. Lasky had no indication of the addresses of the above mentioned people but stated that they could all be located in the Brooklyn and New York City directories.

In 1948, he secured a new passport rather than renewing the old one. Mr. Hennrich advised that in the event we need further information regarding these passports, the Washington Field office will be glad to secure it.

The New York Telephone Directory lists a HENRIKAS RABINAVICIUS living at 115 East 90th Street, telephone number SA 2-8778. His business office is 527 Fifth Avenue, MU 7-0200. The telephone directory also lists an address at Green Farms Road, Westport, Connecticut, Fairfield 9-1203.

Inquiry at 527 Fifth Avenue revealed that RABINAVICIUS was associated with the Lambert W. Hupplar Company, successors to the C. P. Dawson Company. Hupplar is associated with the New England Mutual Life Insurance Company, Room 300, 527 Fifth Avenue. A pretext call made to the office of the L. W. Hupplar Company revealed that RABINAVICIUS was in the office. This information was obtained from the switchboard operator.

The files of the Credit Bureau of Greater New York were checked by Special Employee Ralph Murdy, who advised that the only reference to RABINAVICIUS was dated 7-10-46. The Credit Bureau records reflected that RABINAVICIUS was about 40 years of age and married. His wife's name was not given. His business address was 527 Fifth Avenue, C. P. Dawson Company, agents for the New England Mutual Life Insurance Company. His residence was Post Office Box 12, Saugatuck, Connecticut. There was no litigation or trade information concerning RABINAVICIUS.

JAMES BINGER RETELCALL FROM NY TO BOSTON THIS MORNING STATING THAT DR. BINGER WROTE BOOK SOME TIME AGO ON ACCOUNT OF WHICH HE WAS BROUGHT UP ON CHARGES. DR. DEAN CLARK GENERAL DIRECTOR, MASSACHUSETTS GENERAL HOSPITAL, INTERVIEWED AND STATED HE HAD KNOWN DR. BINGER FOR FIVE YEARS. HE HAD NO KNOWLEDGE OF ANY SUCH CHARGES, WAS OF THE OPINION THAT IF CHARGES HAD BEEN BROUGHT THEY WOULD BE BROUGHT BEFORE NEW YORK BOARD OF EDUCATION, NEW YORK COUNTY MEDICAL ASSOCIATION, OR NEW YORK ACADEMY OF PHYSICIANS. DR. STANLEY COBB CHIEF OF PSYCHIATRIC SERVICE, MASS. GENERAL HOSPITAL SAID HE HAD KNOWN DR. BINGER SINCE NINETEEN HUNDRED THREE, AND HAD WORKED AT HARVARD MEDICAL SCHOOL WITH HIM. HAS DISCUSSED BOOKS DR. BINGER HAS WRITTEN AND SAID THERE HAS NEVER BEEN ANYTHING COME TO HIS ATTENTION THAT DR. BINGER HAD BEEN BROUGHT UP ON CHARGES OF ANY KIND. HE BELIEVES HE WOULD KNOW OF THEM IF SUCH CHARGES HAD BEEN MADE. SUGGESTED THERE WAS A REMOTE POSSIBILITY THAT THERE MAY HAVE BEEN SOME QUESTION ARISING OUT OF DISSEMINATION OF INFORMATION TO THE LAITY WHICH SHOULD HAVE BEEN CONFINED TO PROFESSIONAL CIRCLES BUT THAT WAS ONLY A POSSIBILITY AND HE HAD NO KNOWLEDGE OF SUCH.

MEMORANDUM

Re: JAHAM

At 12:50 p.m. this date, Supervisor Phil Breed of the Boston Office telephonically advised the writer that interviews had been conducted in Boston of Dean Clark, General Director of the Massachusetts General Hospital, and also an interview was conducted of STANLEY COBB, Chief of the Psychiatric Service of the Massachusetts General Hospital.

In the course of the interview of DEAN CLARK, he stated that he has personally known CARL BINGER for about five years. CLARK had no knowledge whatsoever of any charges which had been preferred against BINGER. It was CLARK'S opinion that if such charges had been brought against BINGER, they probably would have been brought before the New York Board of Education, the New York County Medical Association, or the New York Academy of Physicians. CLARK suggested that the above three would be sources who may have information concerning any such charges. CLARK was also of the opinion that BINGER was a member of all three of the above-named associations.

Breed further stated that STANLEY COBB, Chief of the Psychiatric Service, Massachusetts General Hospital, advised at the time of the interview that he has been personally acquainted with BINGER since 1903 and had attended Harvard Medical School with BINGER. COBB stated that he had no knowledge of any charges having been preferred against BINGER. He also stated that he had never discussed with BINGER any book which was the origin of charges brought against BINGER. It was COBB'S opinion that if such facts were so he would probably have had some knowledge of them because of his close association with BINGER. COBB remarked that there was a remote possibility that BINGER may be criticized for the dissemination of information to the laity which should have been confined to professional circles. This was not further elaborated upon.

Breed advised that this constituted the essence of the above interviews, and stated that a teletype summary of the interviews would be sent immediately to New York.
