Serial 5377 is a memo from New York to New York dated 9/29/50, consisting of one page. This document was classified "Secret" on 7/6/77, by classifying officer number 4842 in categories 2 and 3, pursuant to Executive Order 11652, Section 5 (B) with an indefinite date of declassification, as its disclosure could reveal an intelligence source and a foreign relations matter the continuing protection of which is essential to the national security. The classified data denied under (b)(1) of the FOIA is confined to page 1, paragraph 1, lines 4, 5, 6; all of paragraph 2; paragraph 3, line 1, first two words; paragraph 4, all of paragraph.

RE Baltimore letter 9/26/51 entitled "JOSEPH FELS BARNES, ESPIONAGE - R, ISA 1950".

JAY DAVID WHITTAKER CHAMBERS, self-confessed former Communist and Soviet Espionage Agent, was interviewed on his farm near Westminster, Maryland on January 5, 1952 by SA PATRICK D. PUTNAM, at which time CHAMBERS furnished the following information:

CHAMBERS advised that he could furnish no further information re BLACK, other than that already reflected in referenced Baltimore letter. CHAMBERS explained that he had met BLACK on only one brief occasion in approximately 1945 at which time he was introduced to BLACK by CALVIN FIX, former Time official, now deceased, when BLACK, FIX, and CHAMBERS happened to be leaving the Time office at the same time. CHAMBERS stated that this meeting with BLACK was merely an incident of introduction, the duration of which was not over a few seconds.

CHAMBERS advised that the only reason that he characterized BLACK as being "on the left" is because BLACK had JOE BARNES' brother working for him at time. In this regard CHAMBERS advised that he considered JOE BARNES' brother, BARNEY BARNES "on the left" only because of the fact that he was the brother of JOE BARNES. CHAMBERS explained that this was purely speculation on his part and that he had no evidence reflecting Communist Party membership or affiliation on the part of either BLACK or BARNEY BARNES.

It is to be noted in re Baltimore letter of September 26, 1951 entitled "JOSEPH FELS BARNES, ESPIONAGE - R, ISA 1950" that CHAMBERS advised that in about 1937 J. PETERS told him that JOSEPH FELS BARNES was a member of an underground unit of the Communist Party which was operating in New York City.

On January 29, 1952, RITA REYNOLDS, who was secretary for Judge Murphy during the trial preparations of both the HISS trials, telephoned and furnished the following information to the writer:

She said that at the direction of MYLES LANE, United States Attorney, SDNY, all the material pertaining to ALGER HISS, presently maintained in the office of T. J. DONEGAN, Special Assistant to the Attorney General, on the 18th floor of the United States Court House, will be moved to Room 301B, a file room maintained by the United States Attorney's office in the Court House. She said that this material would include all Bureau reports pertaining to captioned case, all exhibits which were presented in evidence at both HISS trials by the Government, and the transcripts of the testimony in both HISS trials. She said that this material would be moved within the next few days to Room 301B.

Miss REYNOLDS further advised that MYLES LANE had directed that Mr. STANLEY D. ROBINSON, Assistant USA, SDNY, will handle any arguments on the re-hearing for a new trial, based on the motion made by the attorneys for ALGER HISS, provided Judge GODDARD grants a new hearing on said motion. She said Mr. STANLEY D. ROBINSON is a regular Assistant U. S. Attorney in the Southern District of New York and can be contacted at Room 431, United States Court House, or through building extension 431 on the telephone.

Mr. LANE has directed the persons in charge of the file room at 301B to make the keys to all the HISS material which will be maintained in that room available to Bureau agents. Further, Mr. LANE has directed that Bureau agents have permission to remove any material they may need pertaining to the HISS case after Bureau agent has signed a receipt for same.

Accordingly, after a few days, all of the material pertaining to the ALGER HISS case which was used at the first and second trials of HISS will be moved from Mr. DONEGAN's office on the 18th floor and will be maintained at Room 301B in the United States Court House.

At 3:10 p.m., same day, SAC ALDEN called Supervisor WALTER E. LEVVIS at New York and advised the only information on BLACK appeared in Baltimore letter to Bureau and New York dated 9/19/49 entitled "JAY DAVID WHITTAKER CHAMBERS, was. ET AL, Perjury, Espionage-R, IS-C". ALDEN said he would hold off sending another copy until he heard whether we could find the letter in our files and requested he be called back.

At 5:05 p.m. on that same day, the writer called SAC ALDEN and advised him the letter in question had been found by us. The variation in the material in regard to BLACK was called to ALDEN'S attention. He said he had already noticed it; had discussed it with the agent who wrote both letters, and had learned that the first account of what CHAMBERS said is to be considered as the more accurate, rather than the version recited in the letter of 9/26/51.

CHAMBERS stated that HARRY CHANDLER is completely unknown to him and was never associated or connected with CHAMBERS' Communist underground apparatus or any other such apparatus to the best of his knowledge. Mr. CHAMBERS stated that he has never heard of HARRY CHANDLER and has no information regarding him.

Re: LAURENCE DUGGAN

At 1:25 P. M., 8/29/51, Inspector Leo L. Laughlin, Bureau, contacted the writer and requested that this office search its files for all information furnished to us by HEDE MASSING concerning LAURENCE DUGGAN. Mr. Laughlin indicated that, in her testimony before the McCarran Committee, HEDE MASSING had indicated LAURENCE DUGGAN was well disposed toward the Communist Party when she approached him. In her testimony on the occasion of her second appearance before the HISS Grand Jury, HEDE MASSING had indicated that LAURENCE DUGGAN was "resistant" when she approached him to work for her apparatus. Mr. Laughlin desired all information furnished by MASSING concerning DUGGAN on this apparent inconsistency. I advised Mr. Laughlin that I believed there was, in all probability, no inconsistency, but that DUGGAN had been a Leftist and was friendly toward the Communists while, at the same time, he was very much afraid to become involved in anything leading toward Espionage. I told him we would review the records and submit a teletype summary.

The above was furnished to SA Roy J. Barloga with instructions to review the files.

The Los Angeles Office advised that in an interview with on ALFRED H. EDWARDS, a member of the Board of Auditors, International Typographical Union, the latter referred to an article in "New York World Telegram and Sun." This article was one of a series by RALPH de TOLEDANO and VICTOR LASKY, authors of the book, "Seeds of Treason," and the article contained some excerpts and summaries of the book.

EDWARDS made reference to one particular paragraph which is as follows:

"A third was in Brooklyn at the home of an assistant foreman of the Daily Worker's composing room."

The above quotation referred to various headquarters used by CHAMBERS during his espionage days.

According to EDWARDS, he received a letter from a close friend, Mrs. BEVERLY B. CLARK, 1003 Belle Ave., Teaneck, New Jersey. CLARK is employed in the composing room at the "New York Times" and is a member of the IUT. CLARK informed EDWARDS that according to his information the assistant foreman of the composing room of the "Daily Worker" was HARRY CHANDLER, who is employed by the "New York Times."

When CHAMBERS was interviewed in the New York Office he spent considerable time talking about the Brooklyn headquarters. He described it as being somewhere in the Brownsville section of Brooklyn; that the apartment was rented by JOSHUA TAMER, whose brother, HARRY TAMER, was employed in the composing room of the "Daily Worker." According to CHAMBERS, HARRY and JOSHUA TAMER were brothers-in-law of SAM SHOYET, the assistant foreman of the composing room of the "Daily Worker."

It is suggested that CHAMBERS be interviewed for any information he may be able to offer regarding CHANDLER.

The following information was set out in New York report of Special Agent George J. Starr dated 3/20/40:

"Howard Rushmore, former motion picture critic of the 'Daily Worker,' was interviewed on February 29, 1940, at this office. Rushmore states that the two CP newspapers, the 'Daily Worker' and the 'Freiheit,' are composed on the seventh floor at 35 East 12th Street - 50 East 13th Street, New York City, by the F. & D. Printing Co., Inc. The Printing presses and the stereotype machinery are located in the basement, the latter equipment being owned and operated by the Cooper Stereotype Co., of 200 Varick Street, New York City, a union house. Cooper is not a CP member. The linotype work for the two papers is handled as two separate jobs on account of the language differences, but is all done by the F. & D. Printing Co., Inc. There have been labor strikes on the 'Freiheit' because of the failure to pay the linotype men. These occurred during the summer and fall of 1939, but were kept out of the press, and it is not generally known that there was any labor trouble on the paper. Rushmore states that there is a man named Barnett among the linotype workers on the 'Daily Worker' job who might talk. There is a total of between twenty and thirty linotypers and they are paid the union rate of \$60.00 weekly. There are about ten men working on what is known as 'the hand side' who assemble and set type. These men get the union scale of \$60.00. Most of the above mentioned men are anti-Communists; all of them are union men. The two foremen are believed to be either 'Red' or at least sympathetic. They get \$90.00 weekly, part of which is 'kicked back' to the CP. M. Golos is in charge of the composing room. He is a Party member. HARRY CHANDLER is his assistant. That is not his real name. He is a Party member. Arthur Stein (probably A. H. Stein) is in charge of payroll and administration. He is a Party member. He told Rushmore that they were having some difficulty in getting out the paper because of delays in paying their bills. There is a mortgage on the composing room equipment. It is believed to be held by the firm which furnishes the paper. (Note - This would probably be the Clinton Paper Corp. of 30 Main Street, Brooklyn. - GJS). This equipment, Rushmore states, occupies the entire seventh floor of the building. In the basement are the stereotypes. There are three or four men working there all the time. They probably get about \$70.00 weekly. Cooper, the owner, has a contract for this work. He has two or three other similar operations in various newspaper plants. The man in charge of the printing presses is named Kelly. He is a Jewish fellow, real name Nelson, and a Communist. He has about seven men working under him. Kelly should get about \$125.00 weekly, according to the union scale. The men get \$70.00 weekly. These men are all union men and not believed to be 'Reds.' There are about eight molders. They get about \$60.00 weekly. They are a good type of men and not known to be 'Reds'. Rushmore states that Elmer Brown, the head of the ITU, is a member of the CP. The mailers have their own union (Mailers' Union No. 6). The men on the job are not 'Reds', but the man in charge may be a sympathizer."

The Los Angeles Office addressed a letter dated November 9, 1940 to Assistant Director E. J. Connelley in connection with "DUCASE" and listed the names of subjects of espionage cases in the Los Angeles Office. Among the names listed were E. Gitaro Kojima and Ko Taro Minakuti, subjects of Los Angeles File No. 65-456, originally reported by ONI. The following information was set out re these subjects showing a connection with one HARRY CHANDLER:

"Kojima and his secretary, Minakuti, arrived in San Francisco on February 22, 1939 ostensibly for a six months' business trip. Subjects, Kojima, 53 years old but looking 45, and his secretary, Minakuti, 53 are known to have stated that they were campaigning to destroy the security of the State's Gentlemen's Agreement with aircraft factories and then purchase airplanes in this country for the Japanese. It has been ascertained that Kojima has been interested in various promotional schemes in this country prior to his last entrance; that he is known to HARRY CHANDLER, publisher of the Los Angeles Times; that he is now promoting the Pan-Pacific Trading and Navigation Company, incorporated in the State of Nevada, allegedly organized to export gasoline to Japan. It is further understood that he is endeavoring to interest capital in the "North China Development Company" organized with the approval of the Japanese Army."

The information set forth herein was obtained from Mr. ALFRED H. EDWARDS, member of the Board of Auditors, International Typographical Union, residing at the Morrison Hotel, 1246 South Hope Street, Los Angeles, California, on April 4, 1951 when he visited the Los Angeles Office and was interviewed by SAA H. EDWARD WHITE. EDWARDS is of unknown reliability, and has requested his identity be kept confidential. He has previously furnished this office information concerning members of the ITU, the records of which union he is in a position to examine.

This appears to be an espionage allegation page 12 5/1

EDWARDS exhibited a clipping, the date and source of which is not known to him but appears to be from a recent series of articles in the New York World Telegram and Sun. A photostat of this article concerning the book "Seeds of Treason" is enclosed for your information.

EDWARDS pointed out the part of this article concerning the underground of the Communist Party, which states that one of the headquarters was "at the home of an assistant foreman of the Daily Worker's composing room."

EDWARDS advised that he had received a letter from a close friend of his, Mr. BEVERLY B. CLARK, 1003 Belle Avenue, Teaneck, New Jersey, which letter was dated March 30, 1951. CLARK is employed in the composing room at the New York Times, and is a member of ITU. This clipping was enclosed with the letter. CLARK told EDWARDS that according to his information the "assistant foreman of the Daily Worker's composing room" was HARRY CHANDLER, Registration No. 113890 (which number apparently applies to his New York Times number), who is employed by the New York Times.

Another source of information, according to EDWARDS, is JOHN PAUL BUFFA, 452 East 187th Street, Bronx 58, New York. BUFFA is active in the ITU, and will give reliable information concerning members of that union.

I called Mr. A. H. Belmont of the Bureau and advised that this morning I had received a call from Mr. RAYMOND SCHINDLER, who referred to conversation he had had with Mr. Belmont.

Mr. Belmont advised that Schindler, in company with a man named WILLIAMS (who had been an agent in 1920-21) had been in to see him yesterday; that they had quite a talk; that Schindler said he had a valued client by the name of White & Case, an old reputable law firm for which he had done a lot of work; that White & Case called him in a while back and said that a valued client of theirs by the name of LOCKWOOD SR. had a son LOCKWOOD JR. who had been conducting investigation relative to the typewriter in the HISS case and White & Case wanted Schindler to talk to the defense attorney for Hiss, consult with him and conduct certain investigation if the way was clear to do so; that Schindler then talked to Chester Lane, who apparently is representing Hiss; that Lane wanted Schindler to do two things - check on the original date of Hiss' typewriter to verify investigation that Lockwood had conducted, and to see if he could get reputable experts in the typewriting field to compare documents from this reconstructed typewriter they are making with documents from the Hiss typewriter, to see if they had been able to actually reconstruct a typewriter which was identical in characteristics with the Hiss typewriter; that Schindler said he was going to do that but with the understanding with Lane that if he got anything that showed Hiss was guilty he was going to turn it over to the government authorities; that he was not doing anything underhanded and he wanted the Bureau to know what the story was. Mr. Schindler advised Mr. Belmont that a typewriter mechanic and machinist by the name of TYTELL has been working almost a year constructing this order; that they brought up about 20 old Woodstocks and went to the Allen Typewriting Company in Illinois which took over the old Woodstock Company and got a lot of old type and with these old typewriters and type they have been constructing a typewriter for the purpose of having keys reflecting the identical characteristics of the Hiss typewriter. Mr. Belmont said the Hiss typewriter was a defense exhibit and the defense is now in possession of it.

Mr. Belmont said that Mr. Schindler further advised that they have approached typewriting experts with the

them make the comparison but the more prominent experts would not touch it; that they finally got Elizabeth McCarthy, a typewriting expert in Boston; that she has been working on this and now claims they have all the keys identical with the Hiss typewriter with the exception of 8 keys; that they are now working on the 8 and plan to have them finished in the near future.

Mr. Belmont said that Mr. Schindler advised he is very friendly with highly reputable typewriting men and he has mentioned it to them - for instance, SELLERS, who is tops in the field; that they are very much interested in it because it vitally affects the field of typewriting identification; that Schindler thinks he could get them to make the comparison, not on a civil basis but as a matter of interest in typewriting identification field. Mr. Schindler said that he thought Hiss was guilty as does most everyone else but he is going to follow through and give SELLERS samples of Hiss' own typewriter and samples of the constructed machine typewriting, and see what the results would be.

Mr. Belmont said he told Schindler that he would pass this information on to the Department of Justice. Schindler was agreeable to this. Mr. Belmont said he told Schindler we would be interested in this but were not asking for information; that Schindler said he would want to give it to us.

Mr. Belmont said that a letter on this is being sent to this office. I said that in the meantime I will do nothing on this.

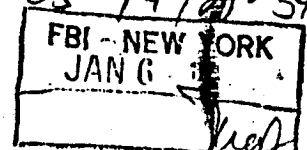

J.W.CARTWELL, officer, Bank for Savings, Northeast corner of Broadway & 86th Street, advised that instant bank has been located at this address since about 1947 and that the National City Bank, now located at the Southeast corner of Broadway & 86th Street, was formerly located at this address. CARTWELL advised that no open or closed account is maintained at his bank for ELIZABETH BENTLEY or ANTHONY MICHAELIDES.

E. BRUCE WETZEL, assistant manager, National City Bank, Southeast corner of Broadway & 86th Street, caused a thorough search to be made of the records of his bank and advised that there is no record of ELIZABETH BENTLEY or ANTHONY MICHAELIDES ever maintaining a savings account, special checking account, or regular checking account at his bank. He added that his branch usually maintains an account card index for an indefinite period, but that if instant account was ever maintained at his branch, the card index was lost or destroyed when the branch moved from the Northeast to the Southeast corner of Broadway and 86th Street. He stated that the records of his bank fail to indicate any inquiries concerning instant accounts and that the officials who normally receive such inquiries can recall no inquiry concerning instant individuals.

WETZEL advised that the Chase National Bank formerly maintained a branch at the Southeast corner of Broadway & 86th Street (where the National City Bank is now located) and that records of that branch are now consolidated with the records of 73rd & Broadway branch of the Chase National Bank.

ROBERT WETZLER, Second Vice President, Chase National Bank, 73rd & Broadway, caused a check to be made of his records and advised that there is no record of ELIZABETH BENTLEY or ANTHONY MICHAELIDES ever maintaining a savings, special checking or regular checking account at his branch, which records also cover the old 86th & Broadway Branch. He added that the account card index of special checking accounts are destroyed after being closed 2 years and that regular checking account card indexes are destroyed 10 years after the accounts close. He added that if instant account was closed prior to 1940 there would be no record in the card index of instant account. WETZLER stated that any inquiry concerning instant accounts could only be answered at his bank with the statement that "there is no record" of instant account.

WETZLER caused a check to be made of the account card indexes maintained at the main office of the Chase National Bank and advised that the account of ELIZABETH T. BENTLEY c/o U. S. Service & Shipping Co, 212 5th Ave, NYC, opened 2/21/47 at the 5th Avenue Branch of the Chase National Bank and closed 9/23/47 after transferring to the Garfield Branch of the Chase National Bank (23rd Street). WETZLER added that the card index containing the above information, which referred to a special checking account, should have been destroyed, since the special checking account has been closed over two years.

ELIZABETH BENTLEY called today and advised that she had some information to the effect that BILASKY was checking some records. She had no idea as to what records he may have been checking but had recalled something she had neglected to bring to our attention. She related that in 1935, she opened a joint account with a fellow Communist, ANTHONY MICHAELIDES who was in her unit at Columbia, and whom she had intentions of marrying. This account was opened, probably, at the National City Bank which is located on the northeast corner of 86th St., and Broadway. She stated there was no monkey business in connection with the account itself but she wanted to bring this to our attention. It is suggested that this branch be checked to determine if anyone has made any recent inquiries concerning this account.

In connection with her application as a Home Relief investigator in Civil Service, she stated that at the time she made application she was a Communist and probably didn't include all the information she should and may have fabricated some of the information on this record.

On Sunday last when she was talking to SAYPOL et al., one of the assistants questioned her about the "Hinckleys." She stated that this matter should probably be looked into further, as there was some unpleasantness in her connection with the HINCKLEYS.

Inspector A. H. Belmont called on the evening of 12/8/50 and advised NYO has been sending teletype information to the Bureau advising of the various pieces of information that we are picking up, telling of the defendant's efforts to build a typewriter and to refute some of the other pieces of government evidence; the contacting of people in Philadelphia and the contacting of SCHMALL.

Mr. Belmont stated the Bureau realizes we have been presenting this information to SAAG Thomas J. Donegan but they desire at this time that we go over the whole thing with Mr. Donegan to determine whether or not there are any legal steps that may be taken to stop these tactics. At approximately 12:00 noon today the Circuit Court of Appeals handed down their opinion in the ALGER HISS case. Judgment of the lower court was affirmed by all three Judges--HAND, CHASE, and SWAN.

The writer talked to USA Irving Saypol in connection with the legal ramifications resulting from the affirming of this decision by the CCA. Saypol stated that the defendant HISS has a period of fifteen days from today's date, during which time he may make an application to reargue his case. He also has a period of thirty days from today's date in which to file a petition for certiorari to the Supreme Court. Fifteen days from today the United States Attorney's Office may direct HISS to surrender or make a motion to revoke his bond. At this time HISS can make an application to remain on bail pending appeal, and this of course will be up to the judgment of the District Court for the Southern District of New York. Mr. Saypol related that the rules governing this particular situation are to be found in the Rules for Criminal Procedure, Rule 37 and 38.

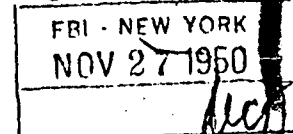

On August 22, 1950, former AUSA Tom Murphy turned over to the writer a copy of a letter dated January 29, 1950, at Killingworth, Higganum, Connecticut. This copy was unsigned but was directed to ALGER HISS, and indicated that there was enclosed a check for \$100 for HISS' defense fund. This letter also related that FISHER BUELL of Clinton, Connecticut, had made some remark relative to the fact that Judge GODDARD, who heard the second trial, had a preconceived notion of the guilt of ALGER HISS. This letter was turned over to MURPHY by the post office authorities. MURPHY requested the writer to determine, if possible, the identity of the writer of this letter, together with the identity of Mr. BUELL, and specifically stated that he had no intention of bringing this to the attention of Judge GODDARD or any of the Federal judges in this district, but was desirous, for the record, of determining the identity of the sender and of FISHER BUELL.

Through a check at the State Department and investigation at Higganum, Connecticut, it was determined that the author of this letter was Laurence Eustis Salisbury, a resident of Higganum and a former employee of the State Department. FISHER BUELL was identified as a former Wall Street broker, being a senior partner in the firm of Buell and Company, One Wall Street. This firm was dissolved some time in 1928 or 1929. This information was furnished the Bureau by New York letter of August 22, 1950. The Bureau answered this letter on September 29, 1950, and they point out on page 2 of their letter that the identity of the individuals mentioned above, as well as any other information developed, should be brought to the attention of the United States Attorney, but that "at that time the United States Attorney should be advised that none of the information concerning this matter has been furnished to the Department of Justice and that the Bureau would not do so unless the United States Attorney requested this action."

Reference is made to the report of Special Agent John W. Powell dated November 3, 1950, at New Haven, Connecticut, which sets forth background information concerning SALISBURY and FISHER BUELL. This report designated one copy for Mr. Donegan and one copy for the United States Attorney. At the time this report was received in this office the copies for Mr. Donegan and

the United States Attorney were sent to them directly by the receiving clerk. This report makes no mention of the basis for the investigation, nor does it have any reference to the letter in question.

Reference is made to the writer's report of November 17, 1950, which is to be furnished to the United States Attorney. This report contains no information relative to the above-mentioned letter except the fact that SALISBURY was the author of the letter dated January 29 directed to ALGER HISS. Mr. Donegan presently has all of the files of the HISS case that normally would be kept in the United States Attorney's office. The question of advising either Mr. Donegan or Mr. Saypol that the Bureau was not going to furnish copies of the report to the Department was discussed with Mr. Donegan on a confidential basis. He stated that it was his opinion that if this fact was brought to the attention of Mr. Saypol, the latter would immediately communicate with PEYTON FORD, and this might result in some embarrassment. He stated it was his suggestion that no mention of this be made to Mr. Saypol and that we allow the reports to go through since they appear to be very innocuous on the face and probably would not result in Saypol questioning the basis for the investigation in Connecticut. He stated that he would appreciate it if his suggestion was given to Mr. Belmont or Mr. Ladd at the Bureau as he was not quite sure of the purpose of the Bureau's suggestion relative to not giving copies to the Department. He stated that if the Bureau has some other idea in mind he would be of course willing to act in any way that the Bureau suggested regarding this matter.

Eddie Jackson of the New York Daily News called from the pressroom and advised he had a picture of ALGER HISS and his wife taken in front of the U. S. Court House building, which showed one or two other persons and he asked if we had anyone who could identify the other people.

I consulted with Mr. J. J. Maguire, Bureau, about this and we both agreed that we could not comply with this request. I told Mr. Maguire I would handle this with Mr. Jackson.

In Jackson's absence, I talked to Jimmie Parlatore, in the pressroom, who said he knew of Jackson's call and the reason for it. He also said there was no further need for the request now because Jackson had already obtained an identification from someone else in the building. Mr. Parlatore said he attended the whole trial and knew who the person was and would make an identification for any reason other than publication. As he put it, he was 99% sure. I told Mr. Parlatore that, if anyone else raised the question, we would have to take the same position he is taking.

I called Inspector A. H. Belmont, Bureau, and advised him that oral arguments had been held today before the Circuit Court of Appeals, consisting of Judge Swan, presiding; Judges Harrie B. Chase and Augustus Hand. It was argued for the appellant by Mr. BENJAMIN and for the government by CLARKE RYAN. Mr. Benjamin took approximately two hours to present his argument and Clarke Ryan took approximately one and one-quarter hours. Mr. Saypol and Mr. Donegan were seated at the counsel table beside Clarke Ryan.

I told Mr. Belmont there was nothing new on the argument; that Mr. Benjamin spent most of his time arguing the facts as he would, almost, in a summation to a jury, but, at the end of his argument, advised the court that they had been critical of the prosecutor and of the FBI and that the prosecutor had labelled his criticism of the FBI as following the Communist Party line, which was a prejudicial error.

I told Mr. Belmont that Clarke Ryan, in his opening statement, he repeated the challenge of Thomas F. Murphy before the Jury and reminded the court that Murphy had made that challenge to the Jury; that if they believed for one moment that any activity of the FBI in this case was in any way unethical or underhanded, that the Jury should bring in a verdict of acquittal. Ryan repeated that the government still took that position before the Circuit Court of Appeals and Ryan further chided the defense counsel for such remarks. I advised Mr. Belmont that both Judge Swan and Judge Chase had asked some pointed questions of Benjamin during the course of his arguments which clearly showed that they saw through some of his rather ingenious but falacious arguments. Mr. Belmont requested that a teletype be sent to the Bureau. I advise d him one would be sent and that we would also mail to the Bureau a copy of the final briefs filed by the appellant and the government.

CLARK RYAN, Special Assistant to the United States Attorney, who is working on the HISS case, advised the writer that the HISS attorneys had refused to consent to the order which was sent to their office this morning. This order, as previously related, was a request for the defense to consent to THOMAS MURPHY, the present Police Commissioner, to appear amicus curiae on the brief and also for oral argument in connection with the HISS appeal. Mr. RYAN stated that he conferred with Mr. MURPHY today and that subsequently he, RYAN, talked to JAMES T. McINERNEY of the Department, and Mr. McINERNEY had suggested that a motion be filed Monday next requesting the Court to permit MURPHY to appear amicus curiae on the brief and also for oral argument.

RYAN related that at the present time he and MURPHY plan to split the oral argument. How this will practically be accomplished is not known at the present time, although it would appear that one or the other will probably argue the facts and the other the law applicable to the Government's position.

Dear Mr. Ford:

This is in reference to the confidential memorandum which you delivered to me at our conference in your office last Friday, June 2, 1950. At that time, in discussing the course of future proceedings, it was agreed that I should bring the matter generally to the attention of the Chief Judge of the United States Court of Appeals for the Second Circuit.

On further reflecting, I concluded that, in the circumstances of this case, it was entirely appropriate to discuss the matter with Judge Clark himself and, as I told you on the telephone last night, I did so. Judge Clark emphatically denied having made the statements attributed to him to anybody at any time. He requested of me, and I told him that I so intended, that the subject be brought to the attention of Chief Judge Learned Hand. I talked to Judge Hand this morning and he was exceedingly grateful for the way in which this matter has been handled.

Judge Clark has written to me and I enclose a copy of his letter dated June 7, 1950. I have replied to the latter letter, stating that, in view of the necessity for maintaining the confidence of the informant in this case, further investigation, including inquiry of the author of the statements, should be pursued by those most competent to do so, that is, the Agents of the Federal Bureau of Investigation.

Re: ^{BELL} LEANDER LOVELL (121-1226)

SAAG Thomas J. Donegan called and furnished the following information which I transmitted to Inspector Carl Hennrich at the Bureau.

Mr. Donegan advised that he had just had a visit from a Mr. LOVELL, a former State Department man, who is now working for ECA and has just returned from abroad. Mr. Donegan stated that LOVELL was mentioned in what he referred to as THE BERLE NOTES. He is a State Department man who worked with WADLEIGH. He wanted to see the notes and SAAG Donegan said he had no authority to discuss anything like that with him and then LOVELL just eased himself out, saying he did not know a lot of the people he is alleged to have known, and excused himself. Mr. Donegan says he thinks the Bureau may want to interview LOVELL and he may then wish to call him before the Grand Jury. I asked Mr. Donegan what LOVELL's first name was and he said he did not know. I also asked him what this individual's address was, but he did not know that either.

I told Mr. Hennrich that I would get in touch with SA Thomas G. Spencer who, in all probability would be in a position to furnish more complete information relative to LOVELL.

SA Spencer advised that this LOVELL is undoubtedly LEANDER LOVELL, who was one of the people mentioned by CHAMBERS and DON LEVINE to A. A. BERLE and which conversation has come to be referred to as "THE BERLE NOTES" inasmuch as BERLE made notes of this interview and these notes have been introduced in the HISS Trial.

Having in mind that a Loyalty case or an ECA case might be involved on LOVELL, I checked with Mr. Leo Laughlin at the Bureau and he said he did not think there was a Loyalty case, but he was pretty sure there was an ECA case on him. I then checked with Mr. Chris Callan of the Bureau and Mr. Callan advised that LOVELL had been fired by ECA for Loyalty reasons and that there was presently in progress a Loyalty Hearing in Washington on LOVELL.

LABOR STRIFE WILL BE IMMEDIATE EFFECT OF HARRY BRIDGES CONVICTION.
On April 4 Harry Bridges was convicted of perjuring himself when he denied he was a Communist Party member in his 1945 naturalization hearings. Govt will now take steps to deport Bridges, but his attorneys have announced that they will appeal the verdict and have already made a motion for a new trial. Deportation proceedings will be delayed until final decision on his appeal is reached. That will probably take a year or two.

Meanwhile Bridges will be free to help Stalin, to sabotage U S economy and undermine Marshall plan aid to Europe. The warning of what is to come was given by officers of Intl Longshoremen's and Warehousemen's Union (ILWU), of which Bridges is Pres, after "guilty" verdict had been announced.

"It sounds an alarm that must be answered at once and vigorously by the members of our union and by all workers on land and sea everywhere", they said. And Vincent Hallinan, Bridges' attorney, in his defense summation on Mar 17 warned the jurors in the Bridges' trial that "this trial is being followed in every language in the world".

The inference is unmistakable. Last summer Stalin's World Federation of Trade Unions (WFTU) met in Marseilles, France. It formed a new maritime dept of the WFTU called the Intl Union (Federation or Conference) of Dockers and Seamen and elected Harry Bridges president. Bridges had been indicted for perjury by U S Govt three months earlier.

Stalin's new world-wide maritime federation took this into consideration and reminded U S Govt of the esteem in which it held Harry Bridges; it said it would take care of him, that he had nothing to fear.

"If the U S Atty General, Tom Clark, succeeds in his efforts to deport Harry Bridges, he (Bridges) will not be lost to maritime workers. There will be a place for him in the international organization of the maritime workers and in the labor movement of the respective countries."

There were several reasons why Bridges was made president of Stalin's new maritime federation. One was the fact that he had always been a faithful Communist and follower of Stalin, another that he was pres of ILWU which controls shipping on the U S West Coast and the final tactical consideration was Bridges' coming trial.

Moscow planned carefully. Preparations were already under way to disrupt shipment of arms from U S to Atlantic Union countries in Europe. Strikes would have to be called and, as Counterattack has already pointed out (see Letter #149 pp 2 & 3, Mar 31) Bridges' conviction could be used as an excuse to call a strike in U S that would coincide with Stalin's sabotage efforts in European ports. Bridges himself, at end of 1947, threatened strikes to disrupt U S Marshall Plan aid. Embittered by his conviction and pending deportation he won't hesitate to act now.

WFTU has already demonstrated its power to tie up world shipping. When Communist-led Canadian Seamen's Union, a small union of only 10,000 members, lost a jurisdictional battle to the AFL Seafarers Intl Union (anti-CP) in 1949, it called for sympathy strikes. Communist unions affiliated with the WFTU answered by tying up the port of London... and ports in Scotland, Norway, Holland, Italy, Australia and other countries.

Now the convicted perjurer and Communist, Harry Bridges, will probably call his ILWU out on strike in protest against his conviction and over the issue of the outlawing of the hiring hall. There are indications, too, that the WFTU's maritime division will take up the call in support of their leader, that another world-wide shipping tie-up may be attempted. The excuse will be Bridges, the real purpose will be to weaken all democracies opposing Stalin's aggression.

Louis Saillant, Communist Secy of the WFTU, declared at Marseilles last summer that "On all the oceans, in all the ports of the world, 750,000 seamen and dockers are henceforth fighters for peace". These are the men who are ready to answer Bridges' call.

There will be bloodshed and violence on docks of Europe if this happens. Loyal American seamen are cooperating with State Dept and Dept of Defense to get U S arms landed in France and Italy. They have formed fighting brigades and have coordinated their plans with those of the anti-Communist French and Italian maritime workers. Sailings of ships carrying arms to Europe were held up by U S to allow time for the completion of these plans.

American seamen are prepared to use force if necessary to deliver aid to our European allies... and it looks now as though force will be needed.

The tragedy is that all this could have been prevented. Bridges should have been deported years ago. He is still in U S and capable of doing so much harm only because of the go-soft-with-the-Commies attitude that prevailed in Washington for so many years.

Federal Judge Chas B Sears recommended Bridges' deportation in 1941. But a packed Supreme Court, by a vote of 5-3, overruled Judge Sears. And Frances Perkins, Sec of Labor, defended Bridges. She said he was innocent that stool pigeons had testified against him.

Bridges himself made the most telling comment on the whole affair. Referring indirectly to the majority Supreme Court decision written by the late Justice Frank Murphy in 1945 ("the Bridges case will stand forever as a monument of man's intolerance to man"), a bystander reminded Bridges that the Supreme Court had rescued him the last time. Bridges replied, "Well, there's no Murphy now".

THE ATTACK ON "SEEDS OF TREASON" HAS BEGUN. Last week Counter-attack favorably mentioned the book "Seeds of Treason", the first detailed account of the Hiss-Chambers espionage case. Biased attacks on this book were expected from the Communist press, but not from the New York Times.

The Times review was written by John Desmond, who claimed the book was a "quickie job", vaguely hinted (but didn't show) that it had "an element of irresponsibility", that it was written on a questionable basic assumption and that it was "a ride to literary notoriety on Whittaker Chambers shirrtails". Desmond's review was a clever piece of damning by subtle insinuations without presenting any facts to justify his criticisms.

The "basic assumption" questioned by Desmond is that the men mentioned by Whittaker Chambers were actually connected with the Communist un-

derground. Desmond doesn't deny that they were, but he says he is not in a position to know if it's true and, as far as he can find out, the authors of "Seeds of Treason" don't know either.

But when Lee Pressman, John Abt, Nathan Witt and other persons named as members of the espionage ring by Chambers were subpoenaed to appear before Un-American Activities Committee they refused to deny Chambers' charges and refused to deny that they were CP members. Doesn't Desmond know this? And isn't he aware of all the corroborating evidence that backs up Chambers' charges?

His "quickie" charges are completely false. Several other books on the case (which he mentions, but doesn't say are quickies) are already in the hands of publishers, as he points out. The authors started work on "Seeds of Treason" two years ago. It is definitely not a "quickie".

Editor of Sunday Times is Lester Markel, who has had Alger Hiss as a guest in his home. Last week the Sunday Times favorably reviewed Owen Lattimore's book, "Pivot of Asia", and patted Mr Lattimore on the back.

And Times chose a picture called "The Face of Treason" to illustrate the page on which "Seeds of Treason" and the book, "Treason", by Nathaniel Weyl were reviewed. The artist whom the Times so honored, and paid for the use of his painting, is David Alfaro Siqueiros.

Siqueiros is an alleged GPU agent. Leon Trotsky, while he lived, was hated by Stalin and the CP more than any other man. After many unsuccessful attempts, Stalin's secret police finally killed Trotsky in Mexico in Aug 1940. Several months earlier, on May 24, Siqueiros led a band of Mexican Communists, disguised in uniforms they had stolen from the police, in an attack on the home of Trotsky in an attempt to murder him. An American, Robt Sheldon Harte, who served as chauffeur and helper to Trotsky, recognized one of the would-be assassins. Trotsky and several of his followers barricaded themselves in Trotsky's well-fortified home and the attackers were driven off, but they took the American, Robt Harte, with them.

Harte's body, buried in lime and with a bullet in the base of the brain, was found a month later by the Mexican police. Siqueiros and others in the attacking party were arrested. Siqueiros admitted he had led the raiders, but denied he had killed Harte. Before the case could be brought to trial he skipped Mexico and went to Chile and Cuba.

State Dept refused to allow Siqueiros to enter U S when he applied for a visa to attend Cultural and Scientific "Peace" Conference sponsored by Natl Council of Arts, Sciences and Professions in NY last March.

But Times Sunday Editor, Lester Markel, seems to believe Siqueiros' art should be publicized and that Siqueiros should be helped financially.

COMMUNISTS CAPITALIZE ON CONSTRUCTIVE WHITE HOUSE WORK. President Truman has called a Mid-Century White House Conference on Children and Youth to discuss what is being done, and what needs to be done, for proper child care in U S. Conference will be held in Dec 1950, and should be supported by all American organizations honestly interested in child welfare.

Congress of American Women, leading Communist front for women in U S, has already started campaign to use this Conference to its own advantage. CAW is on Atty General's list of fronts and was an affiliate of Stalin's world-wide front, Women's Intl Democratic Federation, until a short time ago. Last year Dept of Justice ordered CAW officers to register as foreign agents. To avoid having to do this CAW disaffiliated from WIDF.

A "Bread and Butter" Conference on Child Care will be held at Hull House (one of most famous settlement houses in U S) in Chicago on April 15 and 16. Program for child care developed at this Conference will be submitted to White House Conference, according to claim of the sponsors of the Bread and Butter Conference. For propoganda purposes they have tied their conference into Pres Truman's Mid-Century Conference on Children and Youth.

"Bread and Butter Conference" will be a completely Communist undertaking. The program it submits to White House Conference will be the CP line on child welfare, subtly camouflaged in high-sounding phrases.

Helen Wortis, Secy of the "Bread and Butter" Conference, is chmn of the Commission on Child Care and Education of the Congress of American Women. In literature promoting the conference her address is given as 2 East 23 St, NYCity. the offices of the Congress of American Women.

Other leaders of Congress of American Women who are sponsoring Conference include Muriel Draper, CP member and Pres of CAW; Dr Gene Weltfish, anthropologist of Columbia University & Honorary Pres of CAW; Mrs Mary Jane Melish, wife of Rev Wm H Melish, ousted from his pulpit because of Communist activities; Mrs Ada B Jackson, a leader of NY's Communist-controlled American Labor Party; Mrs Edyth Lutzker, Pres, Child Care Center of the Parents Assn of New York; and Nora Stanton Barney, architect & delegate to second congress of Stalin's Women's Intl Democratic Federation in Budapest in 1948.

Hollywood and Broadway are represented by Gale Sondergaard and Uta Hagen, both of whom have supported many Communist fronts. Also Sadie Ornitz and Margaret Maltz, wives of Sam Ornitz and Albert Maltz, two of the "Hollywood Ten" (screenwriters). Copies of the CP membership cards of Ornitz and Maltz were produced during the Hollywood investigation.

Communist and pro-Communist labor officials who are sponsors include Jack Bigel and Frank Herbst of the United Public Workers, which was recently expelled from CIO; Rose Russell, legislative director of Communist-controlled Teachers Union, an affiliate of Public Workers; Joseph Selly, Pres of Amer Communications Assn, soo. to be expelled from CIO; Bernard Segal and Winifred Norman of the United Office and Professional Workers of America, another of the CIO-expelled unions.

Communists have heavily infiltrated child care and welfare work, as is shown by list of sponsors of this conference from all parts of U S.

And Hull House in Chicago has loaned its facilities to fronts for meetings and conferences of various kinds in the past. These Communist organizations have been encouraged and helped by the tacit approval given them by one of the outstanding settlement houses in U S.
