MEMORANDUM

Re: JAHAM

The following investigation was conducted by Special Agent William G. O'Donnell:

Files of Central Office, INS, show MAX BURSTEIN was issued quota immigration visa No. 1325 on December 30, 1946, at Munich, Germany. His application for visa, filed December 18, 1946, indicates he was born January 18, 1898, at Minsk, Russia. At that time he was a widower but has one child, ISAK BURSTEIN, born May 17, 1929, in Kauen, Lithuania, but then living at 734 East 176th Street, Bronx 57, New York. He was destined to join his son at that address. On April 24, 1947, his address is given in care of KRONHAUS, 740 Sackman Street, Brooklyn, New York, and on September 9, 1947, his address is given as 36 Grafton Street, Brooklyn, N. Y.

JOSEPH HOLTZMAN, 734 East 176th Street, Bronx, New York, advised that ISAK BURSTEIN resided at this address for approximately six months immediately after he arrived in the United States from Europe. He then moved to Lakewood, New Jersey, and he has heard nothing concerning him since. Mr. HOLTZMAN did not know the father of ISAK, MAX BURSTEIN.

The Brooklyn telephone directory reveals that Mrs. ROSE KRONHAUS resides at 740 Sackman Street, Brooklyn, New York. Investigation revealed that this is a private home in Brooklyn, New York.

Mrs. M. ZIMMERMAN, landlady, 36 Grafton Street, Brooklyn, New York, advised that she had never had any tenants at this address named BURSTEIN. She stated that many of her tenants have boarders of whom she would have no record, but that she could not remember anyone living in this building who had a name similar to BURSTEIN.

A check of the Brooklyn telephone directory revealed that a MAX BURSTEIN resided at 523 Saratoga Street and that an ISAAK BURSTEIN resided at the same address, and both had the same telephone number.

MEMORANDUM

Re: JAHAM

At 12:30 p.m. on March 3, 1952, JESSE FARRAR of the Baltimore Office telephoned and spoke to the writer concerning LOUIS J. LEISMAN, whom Farrar termed a possible witness for the defense in the forthcoming motion for a new trial on the part of ALGER HISS.

Farrar said that the Baltimore Office has interviewed a number of people, all of whom have advised that LEISMAN is a drifter who has lived in many places for short periods of time. Farrar advised that the records of the Veterans Administration do reflect that LEISMAN did reside at 1619 Eutaw Place in Baltimore, Maryland, in the period in question--that is, from June, 1935, through January, 1937. He said, however, that the contacts of the Baltimore Office at the Veterans Administration have advised that the records of the Veterans Administration there are not too accurate and Farrar says that accordingly they do not believe too much credence should be placed in said records.

Farrar advised that LOUIS J. LEISMAN has a sister named ANNA GREENBERG, residing in Baltimore, Maryland, and he said that the indices of that office reflect no derogatory information concerning ANNA GREENBERG. Farrar said that the Baltimore Office feels it would be advisable to interview ANNA GREENBERG as to her brother, LOUIS J. LEISMAN, in particular as to whether LOUIS J. LEISMAN was residing at 1619 Eutaw Place during the period in question. He said, however, that Baltimore would not interview ANNA GREENBERG until the United States Attorney, Southern District of New York, had authorized same, in view of the fact that this might be construed as intimidation of a witness, since her brother, LOUIS J. LEISMAN, might possibly be a witness for HISS.

Farrar requested that this office advise the Baltimore Office on the afternoon of March 3, 1952, as to whether the United States Attorney, Southern District of New York, would furnish permission for the Baltimore Office to interview ANNA GREENBERG re the points set out above.

The writer telephonically communicated with Supervisor OBERNDORF of Washington Field Office on 3/5/52 and referred him to the report of SA JOHN E. HOWARD, 5/18/49 in instant case and particularly to the statement signed by IRA LOCKEY, Jr., which bears the date of 5/16/49.

OBERNDORF's attention was also called to WFO teletype 5/14/49 indicating that that office knew the serial number of the HISS Woodstock (230099) at least by 5/14/49.

OBERNDORF advised he would immediately check the files and further stated that both ~~SA~~ TEMPLE and PEASINGER, Agents who witnessed this statement, are still in Washington Field and he would also question them concerning their recollection of the time the information was first obtained and also further information concerning the receipt that LOCKEY showed the Agents at the time concerning the HISS Woodstock typewriter.

At 2:05 PM, March 5, 1952, Supervisor OBERNDORF of the Washington Field Office, telephonically furnished the following information to the writer:

OBERNDORF stated that he had reviewed the files of Washington Field in captioned matter and had interviewed Agents TEMPLE and PEASINGER, who witnessed the statement taken from IRA LOCKEY, Jr., on May 16, 1949.

OBERNDORF stated that Agents TEMPLE and PEASINGER first obtained the information concerning the Serial No. 230099 of the Woodstock typewriter when they called upon IRA LOCKEY at his home on 5/14/49. LOCKEY at that time was ill and in bed. After a brief interview LOCKEY's wife requested that the Agents not press LOCKEY for additional details but return at a later date to get these details.

Consequently, on 5/16/49 the Agents returned and took a signed statement from LOCKEY which bears the date 5/16/49. This statement appears in the report of SA JOHN E. HOWARD, 5/18/49 at Washington in this case.

The above is submitted to reflect that the Washington Field did have information as to the serial number of the Woodstock typewriter on 5/14/49, which information was included in the Washington Field teletype of 5/14/49, but not included in the report of SA JOHN E. HOWARD, 5/18/49, as having been received by Washington Field on 5/14/49.
