MEMORANDUM

Re: JAHAM

At approximately 5:30 p.m. on March 12, 1952, a representative of the press dropped off a copy of a printed document entitled "SUPPLEMENTAL AFFIDAVITS SUBMITTED IN SUPPORT OF MOTION FOR A NEW TRIAL" in the above-captioned case. Mr. Whelan made this document available to the writer, who reviewed it and furnished Mr. Whelan with a general summary of its contents. Photostatic copies of it were prepared.

At 9:00 p.m. Mr. Whelan called Night Supervisor Martin at the Bureau and advised him that it appeared that these supplemental affidavits had been filed late on the afternoon of March 12 by HISS' attorneys, further advised him of the general contents, and requested that Martin telephonically advise Assistant Director Belmont of these facts. On the same evening a photostatic copy of the document was forwarded to the Bureau by mail to the special attention of Mr. Belmont.

On the morning of March 13 the writer checked with the Clerk of the Criminal Court, USDC, SDNY, and ascertained that the supplemental affidavits had been filed at about 4:00 p.m. on the afternoon of March 12. At 9:20 a.m. on March 13 Mr. Whelan telephonically advised Mr. Hennrich at the Bureau that these supplemental affidavits had been so filed.

MEMORANDUM

Re: JAHAM

On the afternoon of March 14, 1952, Supervisor Bill Branigan of the Bureau called and wanted further explanation of our teletype of March 13 concerning the reason why a lead was set out for the New York Office to attempt to locate the old Woodstock typewriter that had been rented by the HISS attorneys prior to the first trial.

Branigan was advised that the United States Attorney felt that the HISS people had rented the old Woodstock for some particular purpose and that purpose was never determined during the investigation or during both trials. The United States Attorney was of the opinion that possibly an attempt had been made prior to the first trial to substitute or change the old Woodstock to resemble in some fashion the HISS Woodstock machine, thereby indicating that forgery by typewriter had been considered as early as the Spring of 1949, and therefore this was not a new theory or newly-discovered evidence as the January 24 affidavit would make out.

Branigan was asked whether the Bureau had any objection to our handling this request of the United States Attorney, and he said the Bureau had no objection, but that they were preparing a memorandum for the Director based on New York teletype of March 13, and they wanted to be definitely sure of the reason for this part of the investigation. Branigan stated that the writer's explanation cleared this matter up and that we should of course run this lead out.

Mr. Hennrich pointed out that Laboratory men had interviewed three individuals in Chicago who were with the Woodstock Typewriter Co. and that in all probability the interview with HOKANSON would be unnecessary particularly since he would be interviewed by agents and not by technical men. Following the filing of a motion for a new trial on January 24, 1952 by the attorneys for ALGER HISS, the FBI conducted certain investigation. The purpose of this investigation was to assist the United States Attorney, Southern District of New York, in his preparation of the Government's answer to this defense motion.

One phase of the FBI's inquiry was concerned with determining the background and reputation of LOUIS J. LEISMAN, one of the affiants for the defense. During the course of this part of the investigation certain of LEISMAN's relatives in Philadelphia, Norfolk and Baltimore were interviewed.

On March 7, 1952, I received a letter from CHESTER T. LANE, in which he stated that an unnamed attorney in Baltimore had informed him that "the FBI have been harassing almost every member of his (LEISMAN's) family and that he, LEISMAN, is a Communist and requesting LEISMAN's address from them. LEISMAN is quite annoyed about this and regards it all as an effort to intimidate him."

On March 8, 1952, I informed the FBI of the allegation in CHESTER T. LANE's letter and requested that they determine whether the allegation had any merit. I have recently reviewed the facts pertaining to the interviews of LOUIS J. LEISMAN's relatives and find, (1) that the FBI has absolutely no information indicative of the fact that LEISMAN was or is a Communist and therefore statements that the Agents told LEISMAN's relatives that he was a Communist are utterly false and ridiculous; (2) the relatives of LEISMAN who were interviewed were definitely not harassed but on the contrary were most cooperative and therefore this allegation is absolutely unfounded.

With reference to the allegations made by Chester T. Lane on March 21 last, concerning the fact that because of the FBI's inquiries at the residence of Leisman's son the latter was being evicted and forced to find new living quarters, the following information is set forth:

Two personal interviews and two telephonic contacts were had with Mrs. Beatrice Burg of Aberdeen, Maryland, by an agent of the FBI. In connection with Leisman's son, Jackie, it has been determined that he was placed in the care of Mrs. Burg by either Leisman or his wife for a temporary period beginning about the latter part of February.

On February 29 Mrs. Burg was interviewed by an agent of the FBI, at which time she informed that she was "disappointed in having only received \$25 in consideration for room and board of Jack Leisman for a period of two weeks, and that this amount was insufficient to cover the cost of his care."

On March 20, 1952, Mrs. Burg was telephonically contacted, and she advised at this time that Leisman intended to visit her over the weekend of April 5 in connection with their boarding his son, Jackie. At this time on March 20 the boy, Jackie Leisman, was still living at the Burg residence in Aberdeen.

On both of the personal interviews with Beatrice Burg she was advised prior to commencing the interview that the FBI's interest in Leisman was not due to any criminal or subversive activities on his part and should not in any way reflect upon his character or that of anyone in his family.

Sergeant Sylvester Burg, Military Police, Aberdeen Proving Ground, Aberdeen, Maryland, the husband of Beatrice Burg, was also interviewed at the Post Intelligence Office in Aberdeen, Maryland, and he related that although he had a great admiration for Leisman's son, Jack, he found Louis Leisman to be a particularly offensive individual and had no desire to associate with him or to confer with him any more than was necessary. He informed the agent at this time that Jackie Leisman was living in his residence in Aberdeen and that "I had better hear from him (the father) pretty soon. We've got his kid, you know, and we haven't got any money from him since the last time he was up." Sergeant Burg stated that he was reluctant to turn the boy out but just couldn't keep him any longer unless they received money for his care. At the time of this interview the agent informed Sergeant Burg that the eviction of Jack Leisman was a matter that should be considered independently of any investigation of the boy's father.

KIRSTEIN indicated she had evidence that CHAMBERS was out of the C.P. in 1937. KIRSTEIN also said typewriter evidence introduced at the HISS trial was faked but she did not say how.

KIRSTEIN apparently was interested in the date CHAMBERS left the Party. She indicated she had sought assistance from the C.P. in this respect but had been brushed off. KIRSTEIN felt the C.P. considered her a "police agent". She was bitter about this and said, "they made me spend hours and hours in the library when they could have helped me".



On March 28, 1952, HANNAH F. SULNER, who has previously given information in instant case regarding MARTIN K. TYTELL, personally appeared in the New York Office. She advised that subsequent to the conference she had with CHESTER LANE in connection with her possibly giving information regarding forged documents, she had on March 3, 1952, sent LANE a bill for \$50.00. This bill was for "CONFERENCE IN THE CASE OF ALGER HISS FOR APPEARING IN CONFERENCE ON FEBRUARY 25, 1952, AT THE RESIDENCE OF MISS BURTON, 55 MORTON STREET, NEW YORK. PROFESSIONAL SERVICES REFUSED."

Mrs. SULNER stated that on March 25, 1952, she had received a letter from CHESTER LANE in which he acknowledged receipt of her bill and in which he called her charges nonsensical and indicated he would not pay the bill as rendered. He also added, "To suggest that this conference constituted professional services rendered is nothing short of ridiculous."

Mrs. SULNER advised that she intended to press LANE for the bill; however, the writer advised her that whatever she did in this regard was something that the FBI could in no way advise her.

CHESTER T. LANE telephonically communicated with the writer on the afternoon of April 9, 1952, and advised that a few days ago he had received a letter from the USA in which the latter wanted permission from the Landon School officials prior to making any cuttings from the HISS standard (the Landon School letter).

CHESTER LANE advised that he had been in telephonic communication with PAUL BANFIELD, the Headmaster at the Landon School, and although the latter was perfectly willing to allow a piece to be cut from this letter, he thought that he should consult with his Board of Regents since it was a document kept in the regular course of business of the university. He stated that immediately upon receipt of permission to do this he would advise this office.

CHESTER LANE also stated that he had been in touch with Dr. NORMAN and the latter now desires to cut three one-inch pieces from various parts of the envelope that originally contained the Baltimore and other documents. NORMAN also wants permission to slit this envelope down the side so that he may take a photograph of the inside of the envelope.

CHESTER LANE further related that he had been in Boston earlier this week and conferred with his experts, and they told him that they felt it would be quite necessary for them to extend their examination of the documents two or three days past the April 11 deadline. He wanted to know if the Government would concede to this. He stated that the granting of this extra time would in no way affect his filing of his final affidavit on April 21 as has been scheduled by Judge Goddard.

The writer informed CHESTER LANE that the above matters would be taken up with the United States Attorney and he would be advised of the results.

On the afternoon of April 10, 1952, the writer conferred with USA Myles Lane in connection with the most recent request made by the defense in connection with the Baltimore papers and other exhibits. MYLES LANE advised:

1. He has no objection to having the defense experts examine the papers for an extended period of two or three days beyond the April 11 deadline that was previously set. In this regard it might be noted that CHESTER LANE has indicated he will have his final affidavit filed on April 21, the day which had been tentatively set for the filing of this paper.
2. MYLES LANE advised that he has no objection to having the defense experts cut five one-inch squares from the envelope in which the Baltimore papers were originally contained.
3. MYLES LANE advised that he would strenuously object to allowing the defense experts to cut this envelope down the side and across the bottom in order that it might be placed on a flat surface for photographic purposes. He stated that if the defense experts can advise the Bureau as to the relevancy and the results that might be obtained from cutting the envelope, and the Bureau experts agree that some purpose could be served in making this experiment, then he would probably agree to having it done; otherwise he would oppose it.

MYLES LANE then advised the writer that he was involved in a murder trial presently being prosecuted in the United States Court House and requested that the writer convey his opinion in this matter to CHESTER LANE, and the writer agreed to do this.

Subsequently on the afternoon of April 10, CHESTER T. LANE was contacted telephonically by the writer, and was advised that the writer was calling at the express request of the United States Attorney in view of the latter's necessary presence in Court, and the writer outlined the remarks and opinions made by MYLES LANE. CHESTER LANE stated that he would communicate with his experts and have the experts reduce to writing the purpose and reasons for cutting this envelope and conducting the experiments which were contemplated.

At 11 a.m. on 4/11/52, CHESTER T. LANE telephonically communicated with the writer. He advised that he had been in telephonic communication with Dr. NORMAN and that Dr. NORMAN had thought it would be more expeditious to have LANE communicate with the New York Office of the FBI rather than his, Dr. NORMAN's, reducing his request to writing and giving it to the Boston Office.

LANE advised that NORMAN has visually examined the inside of the envelope which contained the Baltimore documents and other papers and has come to a definite conclusion that there are stains on the inside of the envelope; further, that these stains are of such a nature that they would have "permeated" any paper or papers that were in close proximity to these stains. He stated that in view of this Dr. NORMAN wanted to take photographs of some magnification in an effort to determine the nature of these stains.

Whether LANE meant to say it or not is not known, but he did state that they were of the opinion that the Baltimore documents never were in this envelope. It would also appear that Dr. NORMAN has examined and photographed the Baltimore documents with a view to determining whether they contain any stains and probably finding none they are in a position to argue that since no stains appear on these papers and stains definitely appear on the inside of the envelope, the Baltimore documents never were inside instant envelope.

This information is being forwarded to the Bureau Laboratory for their opinion, after which the matter will be discussed with the U. S. Attorney.

ADDENDUM: At 3:00 p.m., 4-11-52, CHESTER LANE again telephonically communicated with the writer and advised that he had just received word from Dr. NORMAN that the latter was anxious to look at the four pages of yellow paper containing information alleged by CHAMBERS to have been written by

It is to be particularly noted that if Dr. NORMAN wants one square cut from a particular document, there must be an equivalent of the amount he desires left on the document so that if necessary the FBI Laboratory can conduct a similar paper examination. In no instance should any part of the document be given to Dr. NORMAN which contains typewriting markings from the court or any other writing. In other words, if Dr. NORMAN is given a piece of paper it should have no marks on it. After Dr. NORMAN has selected the documents from which he desires these 4 inch squares and it has been cleared by the New York Office, the cutting should be done in the presence of Dr. NORMAN or a person designated by him and this cutting should take place in the Boston Office. After the pieces are cut from the document they should be placed along side of the document and photographed in such a fashion that the entire document will be reproduced together with the piece that is cut from it. Upon completion of the above examination the documents should be returned by personal courier to the New York Office.

In the event that any difficulty is encountered in connection with the examinations by any of the defense experts, the New York Office should be telephonically advised.

On April 22, 1952, the writer interviewed Judge Thomas Murphy on another matter. During the interview Judge Murphy advised that on April 21 he had been to a small dinner party given by GILBERT MONTAGUE, an extremely wealthy New York lawyer.

At the dinner party was a Mrs. PRATT, an 80-year-old woman who, according to Judge Murphy, appeared to be a very prominent and wealthy individual. Judge Murphy was seated next to Mrs. PRATT during the dinner, and the conversation drifted to the ALGER HISS case.

Mrs. PRATT stated that she had been talking to JOHN W. DAVIS (prominent New York attorney) who was a character witness for HISS during the first trial. Mrs. PRATT stated that DAVIS had told her that he had read a copy of the defense's motion for a new trial, particularly that portion of it dealing with a metallurgist who had made some studies and performed some examinations on the HISS typewriter. DAVIS stated that from his reading of this metallurgist's report (Dr. NORMAN) he was of the opinion that the Government had "gotten the wrong guy."

Mrs. PRATT also, during the dinner, told Judge Murphy that she was a close personal friend of IRVING OLDS, Chairman of the Board of U. S. Steel, and that OLDS in commenting on the HISS case had indicated that he had figured HISS to be a wrong guy for a long period of time. He stated that everyone made a big to do about HISS' having at one time been secretary to former Justice Oliver Wendell Holmes. OLDS is supposed to have said that he too was at one time secretary to Holmes, and the former secretaries of Holmes have formed the practice of getting together once a year; he stated that even in those days he had figured HISS for an impertinent pusher and definitely on the wrong side of the fence politically. OLDS is also supposed to have stated that he, OLDS, received a very substantial yearly salary and a good portion of it was paid to him because of his judgment in dealing with men and situations which involved investments of many millions of dollars. OLDS is supposed to have stated that for his, OLDS', money ALGER HISS was a 'wrong guy.'
