At 12:45 pm on January 6, SAC Cornelius of the Albany office called with further reference to the search warrant to be issued to search INSLERMAN's home at Cambridge. He wanted to know whether SA O'Toole would be needed to prepare the affidavit inasmuch as SA O'Brien would appear to have all the information necessary for the affidavit. I advised Mr. Cornelius that Mr. Whearty had informed me that he did not want to by-pass Mr. Higby, the USA at Syracuse. Consequently, the affidavit and search warrant would be made out at Syracuse rather than Albany. Mr. Cornelius advised that he would discuss with Mr. Higby whether Agent O'Toole's presence was necessary and if it was not necessary, O'Toole would remain in Albany. Mr. Cornelius advised that the U. S. Commissioner in Syracuse is out of town and will not be back until tomorrow, January 7th.

On the afternoon of January 6, I called Mr. Cornelius to advise him that Agent O'Brien was leaving on the 6:30 pm train and would arrive at Syracuse about midnight; that we were attempting to have the affidavit drawn up prior to his departure and he would bring it with him, together with a copy of the search warrant which was to be used to search the house in the Bronx, in order that USA Higby could use this as a sample in drawing up his search warrant. I advised Mr. Cornelius that, in our opinion, it would be desirable for Agent O'Toole to proceed to Syracuse in order that the Bureau would be protected in that it could not be said later that he should have been present to assist in the preparation of the affidavit. I advised that inasmuch as there has been considerable indecision in the matter of this search warrant, it appeared to me that the Bureau should be protected by having O'Toole present. Mr. Cornelius advised he would send O'Toole to Syracuse. Mr. Cornelius advised that a reservation was being made for Agent O'Brien at the Hotel Syracuse and he should call there upon his arrival. I advised him that Agent O'Brien would go to the resident agency in the morning and then proceed to the USA's office.

Mr. H. E. Fletcher of the Bureau called on January 6th relative to our teletype advising that Mr. Donegan wanted the Landon School letter, the 65 documents turned over by CHAMBERS and copies of the microfilm recovered from the pumpkin in order that the attorney for ALBER HISS, Mr. McLEAN, could examine them through the use of experts. Mr. Fletcher advised that the Landon School letter was already in the possession of Mr. Donegan as it had been brought up by SA Jones of the Washington Field office who introduced it before the Grand Jury. The other two items will be brought up by a laboratory representative at such time as Mr. Donegan desires them. The Bureau will wait to hear from us on this.

On the afternoon of January 6, Mr. Donegan called me to advise that he had not been in favor of turning this material over to Mr. McLEAN but that in the opinion of other representatives of the Department, McLEAN was entitled to it. Mr. Donegan requested McLEAN to make his request for the material by letter which McLEAN did, presenting a letter addressed to United States Attorney McGohey on January 6. As the letter was addressed to Mr. McGohey, Mr. Donegan called Mr. McGohey to discuss the matter with him and Mr. McGohey advised Mr. Donegan that in his opinion no such material should be turned over to McLEAN without the proper motion before the court. Consequently, Mr. Donegan advised he is not turning over the material to McLEAN.

This information should be included in the daily teletype to the Bureau.

At 11:20 am today, in the absence of Mr. H. b. Fletcher of the Bureau, I advised Mr. Leo Laughlin that we feel that there should be available to Mr. Donegan and the attorneys handling the perjury trial a report setting forth all the information the Bureau has on HISS. I told Mr. Laughlin that we have been contemplating that up here but it appears to us that the most satisfactory source of all that information is the Washington Field office. I pointed out that HISS had been active over a period of years in Washington and that while HISS has lived in New York during the last few years, he has not been active here. I further pointed out that we were to submit the report here, we would be quoting reports of the Washington Field office. I suggested that the Bureau consider having the Washington Field office review its files and submit a report containing all the information the Bureau has on HISS.

Mr. Laughlin was advised that we are going to review our files concerning WHITTAKER CHAMBERS and consolidate all the information in one report.

Regarding the 65 documents turned over by CHAMBERS at the time of the libel suit in Baltimore, I advised Mr. Laughlin that we are of the opinion that these also should be set out in a report. I informed Mr. Laughlin that we have the documents here but that Agent Zander of the Washington Field did a great deal of research at the State Department identifying these documents as coming from State Department records and was able to effect a 100% comparison. I told Mr. Laughlin that we never received complete information about this identification; that we feel that these documents should be set forth verbatim in a report and that the pertinent information which reflects that they did come from the files of the State Department should also be set out in the same report. I suggested to Mr. Laughlin that the Bureau consider having the Washington Field office submit this report.

In connection with the microfilm which the House Committee has, I advised Mr. Laughlin that we have photostatic copies of this as it was turned over by the House Committee to the Department. However, when our laboratory examined the film, additional prints were developed. I told Mr. Laughlin that we were notified by the Bureau that the laboratory was able to bring out some of the indistinct prints so that they were legible but that we never received these additional prints.

While on the 14th floor of the building on January 6, 1949, in connection with a consultation with T. J. Donegan, I accidentally met LOU BENDER, with whom I have been personally acquainted through official business for the past several years, and who is now representing FELIX AUGUST INSLERMAN.

Mr. BENDER was desirous of discussing the fact that he has refused to allow INSLERMAN to talk either to agents or to the Grand Jury, and that he has likewise refused to permit INSLERMAN to voluntarily turn over his three cameras to us. He mentioned that INSLERMAN is very anxious to tell his whole story but that BENDER, as his attorney, owes him the duty of not-permitting him to talk since he might incriminate himself. He stated that he has emphasized to INSLERMAN the consequences which might result to him if he should tell his story.

Mr. BENDER also appeared rather anxious to retain his cordial relations with the Bureau and was somewhat apologetic because of the stand he has taken. He mentioned that if he allowed all his clients to plead guilty he wouldn't have much of a law practice. I of course made no comment as to what advice he should give this client except to say that he as a lawyer of course knew what he was doing and from his experience knew that in many instances lawyers felt it would be for the best interests of their clients to tell their whole story to the proper authorities.

The total results of the conversation with Mr. BENDER led me to believe that he is not sure that he is taking the right course in preventing INSLERMAN from cooperating with us.

Mr. BENDER also indicated that he is fearful that his client, if he talks, could be prosecuted under Title 80, Section 18, because the

Statute of Limitations would not be a bar to prosecution of INSLERMAN for his activities. I made no comment as to this.

In the course of our conversation Mr. BENDER also remarked that the Government attorneys in this matter had pulled a "real boner." I asked him what he meant. He said that he had observed them escort WHITTAKER CHAMBERS into the Grand Jury Room while INSLERMAN was in there; that as a result of having a hostile or adverse party in the Grand Jury Room at the same time his, BENDER'S, client was present he could get thrown out any indictment the Grand Jury might return against INSLERMAN. I made no comment on this.

The substance of the foregoing was relayed to Mr. Belmont, who furnished it to Mr. Donegan.

I received a telephone call on January 10th from Mr. ARTHUR M. ROARK, Jr., Insurance Investigator, 2 Broadway, New York City, who stated that he was operating out of the New York Bureau of Investigation, 320 Broadway, New York City. He said that LAURENCE DUGGAN had two insurance policies with Home Life and Aetna and that the Aetna policy was less than two years old and was contestable if Duggan's death was a suicide. He asked if I would be able to furnish any information which would be pertinent to his investigation. I advised him that no investigation of Duggan's death was made by us. He mentioned the fact that according to press reports Duggan had been interviewed by the FBI. I told him that I could make no comment about that, and that our files are confidential, and any request for information about our interview with Duggan would have to be directed to the Attorney General of the United States.

In connection with the simultaneous searches being conducted today by the Albany and New York Offices at 9:00 a.m., Agent FRANK GALLANT together with Agent JOHN DANAHY were enroute to the home of J. W. RYNDERS, 909 Summit Avenue, Bronx, New York, to execute the warrant.

At 11:45 a.m. Agent DANAHY advised that he was located at telephone TO 25761 and that he could be contacted there. DANAHY stated that LOUIS BENDER, Attorney for FELIX A. INSLERMAN had contacted him and stated that the Leica Camera in which the Agents were interested was at Cambridge, New York in the farm house. DANAHY requested that this information be forwarded to Albany in order that the Albany Agents conducting this search would be cognizant of this fact.

At 11:50 a.m. SA R. D. LEE of the Albany Office was advised of the fact that the Leica was located at Cambridge and requested that the Agents conducting the search be informed of this fact. He also was requested to advise this office immediately when he learns of the results of their search.

At 12:10 p.m. Agent LEE advised that Agent O'TOOLE at Cambridge, New York, stated the Agents had executed their search warrant and seized the two cameras named in the search warrant. O'TOOLE could not state what make or type cameras they were.

At 12:15 p.m. Agent TUOHY was advised of the search at Albany and at 12:25 p.m. Agents DANAHY and GALLANT were advised of the fact that Albany had recovered two cameras.

At 1:15 p.m. Agent DANAHY advised that one (1) camera, a folding Kodak model had been obtained as a result of their search and that their search had been concluded.

At 2:25 p.m. ASAC BELMONT was advised of the fact that Albany had recovered the two cameras and Mr. BELMONT suggested that Mr. FLEISHER at the Bureau be contacted to determine by what method the cameras should be delivered to the Bureau.

At approximately 10:00 on the morning of January 8, 1949, the writer and SA FRANCIS J. GALLANT entered the premises at 909 Summit Avenue, Bronx, New York to search the premises occupied by J. W. RYNDERS under authority granted by a search warrant issued on January 6, 1949 to SA GALLANT by the U. S. Commissioner, Southern District of New York. Mrs. J. W. RYNDERS, mother-in-law of FELIX A. INSLERMAN, responded to the ringing of the doorbell and opened the door several inches, meanwhile holding it secure with an interview chain. The writer and SA GALLANT identified themselves and attempted to state their business, but Mrs. RYNDERS became highly agitated and excited, and shouted that she could have nothing to do with the F. B. I. until she called "the lawyer." She spent several minutes running frantically through the house, crying that she "wasn't involved in this matter" and trying to find "the lawyers" telephone number. After several minutes, she found the number and tried to call the attorney, but received no answer. She returned to the door and after several minutes, the writer and SA GALLANT were able to calm her down sufficiently to explain to her the purpose of the visit. This explanation and the presentation to her of the search warrant precipitated another semi hysterical outburst, and the writer and SA GALLANT asked Mrs. RYNDERS if any nearby relative or neighbor could be called to calm her. She stated her husband was at work and she didn't want the neighbors to know of her difficulties. She became more composed and the writer ascertained from her that "the lawyer" she was endeavoring to reach was LOU BENDER, Attorney for INSLERMAN. The writer offered to look up BENDER'S home telephone number for her, and Mrs. RYNDERS passed the Bronx telephone directory through the doorway opening. The writer furnished her with Mr. BENDER'S home phone, Kingsbridge 3-1519 and Mrs. RYNDERS attempted to call him. However, she was unable to obtain a dial tone after several minutes of waiting and again started to cry and shout that the F. B. I. had disconnected her phone. She was assured that the F. B. I. had taken no such action.

To pacify Mrs. RYNDERS, the writer offered to call Mr. BENDER from an outside phone and ask him to call Mrs. RYNDERS. She said this would be satisfactory and stated that while this was being done, she would go down to her kitchen and prepare a cup of coffee.

SA GALLANT waited at the door while the writer went to a nearby public phone and at about 10:40 A. M. the writer reached Mr. BENDER at his home. I advised Mr. BENDER of the nature of the warrant and of our intention to execute it, and requested Mr. BENDER to call Mrs. RYNDERS. Mr. BENDER stated that he doubted the legality of the warrant and the legality of its execution on a Saturday. I advised Mr. BENDER that we had been assured of its legality and the legality of its execution during daylight hours by a Special Assistant to the Attorney General, and that it had been issued by the U. S. Commissioner on January 6, 1949 after submission of an appropriate affidavit.

Mr. BENDER then advised the writer that he had just received a telephone call from FELIX INSLERMAN at Cambridge, New York, who told him that the agents had entered his premises in search of cameras, and that he had the camera on the premises. Mr. BENDER asked me to call our Albany office before searching the RYNDERS' residence. I told Mr. BENDER I could not do this and that we desired to execute our warrant with a minimum of distress to Mrs. RYNDERS. Mr. BENDER then asked me what I desired him to tell Mrs. RYNDERS. I told him that I could not suggest what he should advise his client.

Immediately after talking to Mr. BENDER, I called SA EDWARD HUGHES, Supervisor on duty, and gave him the context of my discussion with Mr. BENDER. SA HUGHES advised he would consult with Mr. BELMONT and advise Albany.

Upon the writer's return to 909 Summit Avenue, Mrs. RYNDERS was engaged in phone conversation with Mr. BENDER. Upon the conclusion of her conversation, she told the writer and SA GALLANT that Mr. BENDER had advised her not to admit the agents until they called their Albany office. The writer and SA GALLANT advised Mrs. RYNDERS that they were under no duty to call the Albany office, but if admitted, would call the New York office before commencing the search. Mrs. RYNDERS stated this would be satisfactory, and admitted the agents, who again called SA HUGHES. SA HUGHES advised that no word had been received from the Albany office concerning the finding of the cameras at Cambridge, New York, and immediately thereafter, the search of RYNDERS' premises was commenced by the writer and SA GALLANT. The search was

conducted in the presence of Mrs. RYNDERS and included the living room, dining room, hallway, bathroom and two bedrooms, and all closets on the first or ground floor, a rear porch, and a kitchen, and cellar with store-rooms, used and occupied by the RYNDERS in the basement of the house.

In the left bottom drawer of a dressing table in a bedroom on the southwest portion of the first floor, an Eastman Kodak folding camera, Century Model, case #126 was found by SA GALLANT. Mrs. RYNDERS stated that this camera was owned by her husband who had purchased it many years ago. However, in view of the nature of the warrant and the explicit naming of a folding Kodak camera, this camera was seized, without protest by Mrs. RYNDERS, and a receipt given to her for it. A statement as to the article seized was prepared and signed by Mrs. RYNDERS and will be kept as an exhibit in this case. Charts showing the area searched by each agent and the location of the camera seized have been prepared, and will likewise be retained as exhibits.

At 1:15 P. M. the search was concluded and SA HUGHES at the office was so advised. Mrs. RYNDERS, during the search and at the time of the agents departure, appeared completely composed and cooperative, and expressed no animosity toward the agents or the bureau because of the action taken. She expressed the opinion that she and her husband were unfortunate victims of circumstances since they were not involved in the case, and had no choice but to offer their home as shelter to their son-in-law when he visited New York. 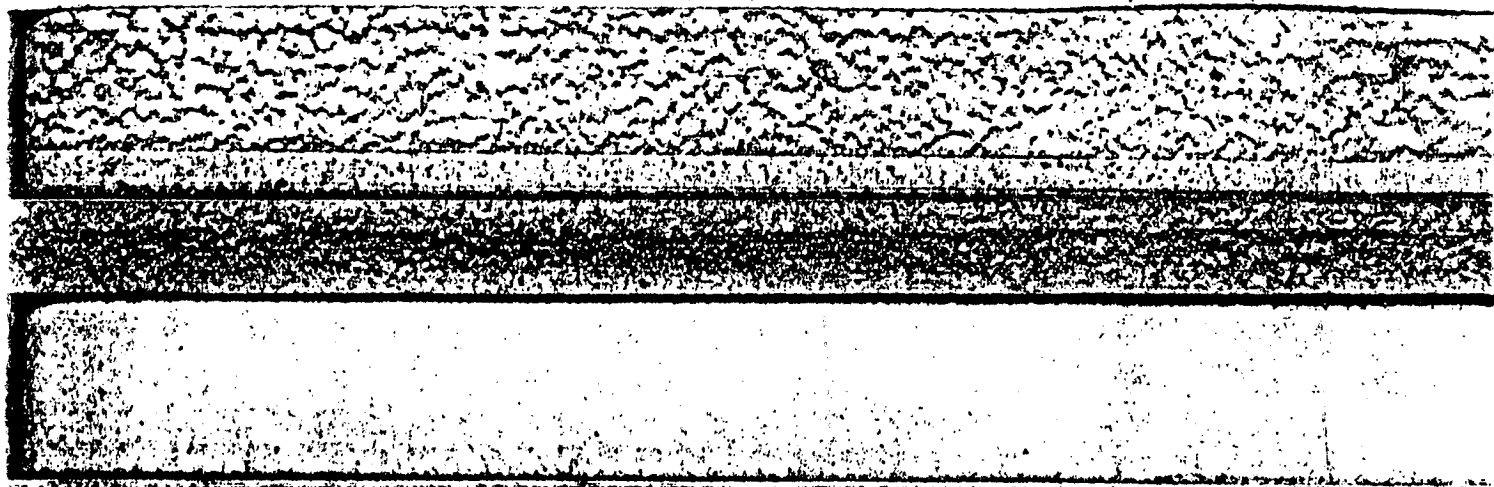

On the afternoon of January 11, 1949, Mr. T. J. Donegan called and referred to letter from the Washington Field dated January 7, 1949, wherein he, Donegan, was quoted as saying that prior to any interview with the family of ALGER HISS, authority should be obtained from him. Mr. Donegan advised that this was not a correct statement; that he had only suggested that clearance be obtained from him prior to interviewing TIMOTHY HOBSON, Mrs. HISS and ALGER HISS. I advised Mr. Donegan that we would note this correction so that there would be no misunderstanding on the part of the Bureau concerning it.

On the afternoon of January 11, 1949, while speaking to Mr. H. B. Fletcher of the Bureau, I advised him of Mr. Donegan's call per the above. He advised that the Washington Field Office had misstated the policy in this matter; that actually it was Bureau policy that members of the HISS family were not to be interviewed until clearance had been obtained from Mr. Donegan in view of the fact that Donegan had suggested that the above three not be interviewed.

On January 5, 1949, I talked with Mr. WHITTAKER CHAMBERS, who advised me that he was introduced to an individual whom he knew as FELIX by a Colonel BYKOV. He further stated that FELIX was a photographer in Baltimore, Maryland, and that he had been sent to Baltimore by Colonel BYKOV to do photographic work for his apparatus.

Mr. CHAMBERS advised that at the time he knew FELIX he was residing on Callow Avenue, Baltimore, Maryland, and that FELIX possessed a Leica camera which was used in photographing the material that he would furnish to FELIX.

Mr. CHAMBERS also advised me on this date that he had seen an individual whom he has identified as FELIX, and he has been told that this individual's name is FELIX AUGUST INSLERMAN, further, that he is positively certain that the individual whom he had seen in the United States Court House on Monday, January 3, 1949, and was told this individual's name was FELIX AUGUST INSLERMAN, is identical with the FELIX whom he knew in Baltimore, Maryland, and referred to hereinabove as being engaged in photographic work for him in Baltimore.

On January 6, 1949, a conference was held with T. J. Donegan, Assistant AG, Mr. Ray Whearty, Mr. Louis Bender, attorney for FELIX INSLERMAN, who also was present, and the writer. At this time Mr. Whearty asked FELIX INSLERMAN if the Leica camera which he had brought down to New York was at the home of his father-in-law at 909 Smith Avenue, Bronx, New York. INSLERMAN replied that it was. Mr. Bender then stated that he had told INSLERMAN to bring all the cameras in his possession down to New York and Mr. Whearty asked if the other cameras were up in Cambridge, New York, and INSLERMAN replied that they were. Mr. Bender then stated that INSLERMAN would be going up to Cambridge over the weekend and he expected to return to New York the first part of next week, and he would bring the cameras with him at that time.

On the morning of January 12, 1949, Mr. Thomas Donegan called to inquire whether the FBI Laboratory had completed its examination of the cameras secured by agents of this office and the Albany Office under search warrants last Saturday, January 8, 1949.

I spoke to Mr. Floyd Jones at the Bureau concerning this and advised him that FELIX INSLERMAN was again being brought before the Grand Jury and undoubtedly Mr. Donegan wanted to have the results of the examination of the cameras as a basis for questioning INSLERMAN. Mr. Jones checked with the Laboratory and then advised me that the comparison of the cameras with the micro film has not yet been made because the Laboratory has not been able to secure possession of the micro film from the House Committee on Un-American Activities. He advised that every effort is being made to secure this film in order that the examination may be conducted at once.

Mr. Jones then inquired whether ALGER HISS or his wife had handled the original documents turned over by CHAMBERS at Baltimore at the time the depositions were being taken relative to the libel suit of HISS against CHAMBERS. He advised that the Bureau was considering having the Laboratory make an examination of the original documents to see whether the fingerprints of ALGER HISS or his wife appeared thereon.

I told Mr. Jones that some weeks ago we had suggested to the Bureau the possibility of such an examination and inquiry at that time had reflected that numerous persons had handled these documents, including the attorneys present at the taking of the depositions, CHAMBERS.

I advised Mr. Jones that I did not know whether HISS or his wife had had access to the documents but if the Bureau contemplates an examination of the documents for fingerprints this could be checked into later in the event fingerprints of HISS or his wife were discovered. Mr. Jones advised that the Bureau is presently considering such an examination but the documents would probably be discolored by this examination. I suggested that the Department be consulted prior to such an examination because the question would come up as to whether the documents were to be used as evidence in the case and this, of course, raised the issue as to the desirability of having them discolored through examination.
