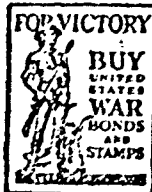

At 5:30 pm on January 13, 1949, I advised Mr. H. B. Fletcher of the Bureau that I had talked to Mr. T. J. Donegan relative to the fingerprint examination of the CHAMBERS documents. I informed Mr. Fletcher that, according to Mr. Donegan, we have to bear in mind that the court will undoubtedly honor a motion on the part of Mr. McLEAN, attorney for ALGER HISS, for an examination of this material by outside experts and that such an examination by them will cover the typing, the watermark of the paper and the age of the paper. I told Mr. Fletcher that the outside experts would try to uncover information which would reflect that the paper is new and could not have been produced in 1937 or 1938. If handwriting appears on the typewritten documents, the handwriting would be checked. Mr. Fletcher stated that no handwriting appears on the typewritten documents.

I further advised Mr. Fletcher that Mr. Donegan stated there is no objection to the fingerprint examination if it would not effect an examination by other experts and would not give them grounds to claim they could not conduct the examination because the documents had been tampered with. Relative to whether ALGER or PRISCILLA HISS have touched the papers since they were produced by CHAMBERS in Baltimore, I advised Mr. Fletcher that it is Mr. Donegan's opinion that quite possibly ALGER HISS examined the papers in Baltimore. The only way to find this out, however, is to determine what went on in Baltimore. I told Mr. Fletcher that on the morning of January 14th, we were going to ascertain from CHAMBERS whether he brought in the originals or photostats; whether the documents were handled by all of the attorneys and HISS; whether the documents were taken out of the court room so that PRISCILLA HISS might have had an opportunity to touch them, and in this way ascertain whether there is a basis for the fingerprint examination. I also advised Mr. Fletcher that if CHAMBERS' recollection needs refreshing, we will contact his attorney.

Relative to document Q-5 which was typed on a Royal typewriter, I informed Mr. Fletcher that we discussed this with CHAMBERS. CHAMBERS advised that the document must have come from one of two sources, either WHITE or HISS, and that he could not recall WHITE giving him any typewritten documents up to that time. Consequently, he is of the opinion it must have come from HISS. Mr. Fletcher was advised that in order to question CHAMBERS further on this, we wanted to do a little checking and find the original State Dept.

The Manhattan Telephone Directories reflect that MAXIE LIEBER is an office representative, 469 Fifth Avenue, New York City, telephone LU 2-3135.

It was noted in a review of the pre-trial depositions that CHAMBERS had known LIEBER slightly while he was employed as an editor of "New Masses" in 1932. In August, 1935, CHAMBERS moved to a cottage on the Delaware River near Frenchtown, New Jersey on the Pennsylvania side which cottage was rented by LIEBER who was running a literary agency in New York City. CHAMBERS indicated that he spent about two months at this cottage although many of his nights were spent at HISS'S home on P Street, Washington, D. C. He recalled that during this period, Mrs. HISS spent about ten days at this cottage and that ALGER HISS had visited them on at least one occasion which occasion was to take Mrs. HISS back to Washington, D. C. CHAMBERS stated that LIEBER was present on numerous occasions while Mrs. HISS resided in this cottage, and he believed that LIEBER met Mr. HISS at that time. This cottage was rented by LIEBER from a Mr. BEECOT (ph.) of Frenchtown, New Jersey who also had a cottage next to them on the Delaware River and he believed that Mrs. BEECOT, a sister to Mr. BEECOT, had also met Mrs. HISS. CHAMBERS recalled that this cottage was located about three miles below Frenchtown, New Jersey on the Pennsylvania side and the town was possibly called, Smithtown, Pennsylvania.

While residing at this cottage, CHAMBERS recalled that money had been given to him by the Communist Party to purchase an automobile which he did while accompanied by LIEBER, and this car was purchased on Broadway, New York City under the name of CHAMBERS. He described this car as a coffee colored (tan) Ford. CHAMBERS believed that he registered this car in New York City under the name of DAVID BRENNER, then he went to Maryland he sold this car to himself to have it under the name of CHAMBERS which was possibly in 1936.

During the summer of 1935, CHAMBERS moved to LIEBER'S farm at Ferndale, Pennsylvania. He had maintained a pseudo business relationship with LIEBER in that LIEBER was used as an employment reference, i.e. he told others he worked for LIEBER, a literary agent. At that time LIEBER was living with his wife on this farm and he knew the names that CHAMBERS had used in the underground which included LYDIA CARTER and DAVID BRENNER.

In the fall of 1936, CHAMBERS moved to New Hope, Pennsylvania on the Delaware River. He recalled that Mr. and Mrs. WISS had been looking for a summer home and they found a little stone house at New Hope and they went to a real estate dealer, Mr. WOOD, at New Hope and asked him about the house. CHAMBERS recalled that he went to look at this house with WISS or WOOD or both and it was rented by CHAMBERS under the name of DAVID BRILL. He stated the landlord was TOM MARSHALL, an apple grower, who owned a farm one and a half miles south of New Hope, Pennsylvania. He stated that LIEBER had visited them at this house and they probably lived there until early 1937.

During the early part of 1937, CHAMBERS occasionally visited New York City and while in New York City, he usually stayed with LIEBER or with his mother at Lynbrook, Long Island.

CHAMBERS also recalled that possibly in 1936 he took part in setting up an underground apparatus in Japan. He stated he was working with LIEBER on this setup and that they both worked under a man who was known to them only as "BILL" who had the responsibility of establishing the underground in Japan. CHAMBERS recalled that he was introduced to "BILL" by Dr. ROSENBLITT or J. PETERS. CHAMBERS stated that it was his duty to find a business cover in the United States whereby Communists could live in Japan under this cover. He stated that at this time he and LIEBER set up the American Features Syndicate which was set up in LIEBER'S office in New York City. He said that this office was a cover address for a man named CHARLES CHASE who was in the Communist underground in Japan.

It is suggested that the files in the New York Office, relative to MAXIE LIEBER, be examined and thereafter that LIEBER be interviewed relative to ALGER WISS and his wife to develop information on the contacts of CHAMBERS with WISS. He should be questioned about the various means used by CHAMBERS and all of the persons mentioned in the above memorandum should be discussed with LIEBER so that further possible logical leads may be covered.

Mr. CHAMBERS was interviewed this morning by SA F. X. [redacted] and the writer in connection with the so-called Q-5 document, which is one document of the 65 that is not typed on the Woodstock typewriter. Mr. CHAMBERS related that it is his recollection that he obtained this document from Mr. HISS, together with the other 64. He stated that there is a remote possibility that this document could have been obtained from HARRY WHITE but he discounts this greatly because of the fact that he never, as far as he can recall, received anything but handwritten material from HARRY WHITE.

CHAMBERS was asked whether he knew of any other typewriters that might be available to PRISCILLA HISS during the pertinent period. He related that the only people who had a typewriter which PRISCILLA would have dared use in copying any confidential material would be HENRY COLLINS, MARION EACHUS and DONALD HISS. He was asked whether either he or PRISCILLA HISS could have copied this material in his, CHAMBERS', home. He stated definitely that this was not the case and pointed out that he was living in Baltimore at this time. He made the suggestion that it was possible that on the date that this document was being typed, the Woodstock typewriter might have gotten jammed up and it was necessary for PRISCILLA to obtain another machine to complete this work. It is not believed that this suggestion has much merit in view of the fact that instant document is dated January 8, 1938 and the remaining 64 documents are dated subsequent to this time. It is pointed out that if the Woodstock typewriter had been broken, it is doubtful that, because of its age, it would have been prepared.

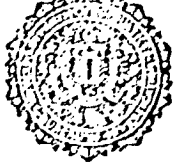

April said he came to N.Y.C. because on 1/1/47  
he had visited an uncle of RENEE Roth (wife of ANDREW ROTH  
arrested in the JAFFE case - 65-14461). April said he had left  
the name of Renee Roth's uncle at home on a slip of paper. The  
uncle's residence he believes is on 44<sup>th</sup> St. NYC. The Uncle told APRIL  
that Andrew Roth was now in India writing for magazine.  
Andrew and Renee Roth are about to be divorced.

April's <sup>former</sup> wife, LAURETTA PPRIC of 3714 Q many Road,  
Washington D.C., from whom he secured a divorce in Reno, Nevada  
on 5/18/47, formerly worked on the Senate Labor and Education  
Committee under Senator Pepper and worked with CHARLES KRAMER,  
RENEE ROTH, PHIL CURTIS, etc. Through his former wife,  
April became acquainted with these and all the people employed  
by the Committee as well as LARSEN who worked in the U.S. State  
Dept. and who was arrested at the same time as ROTH. Lauretta  
April, according to Complainant, also had been employed by the  
War Production Board, Office of War Information, the  
KILGORE Committee, and is presently with the Public Health  
Service in Washington D.C.

April recalled several instances of his contacts  
with Charles Kramer, etc. which had been brought to his  
mind as significant since he had been told that Kramer  
had been an unresponsive witness before the Un-American  
Committee.

When April originally met, slath, Roth was in the  
Navy and was trying to get a book he had written cleared by  
the Navy for publication. Roth told April he was being held up  
by the Navy "bureaucrats" and April who had been in the

Coast Guard was sympathetic with Roth. Roth was trying to  
have Senator Pepper's influence on the Navy Dept. to clear  
the book. April recalled that about 2 days before Roth was  
arrested he was asked by Roth to accompany him to Sen. Pepper  
office. April recalls they went to see CHARLES KRAMER, who  
was high in Sen. Pepper's office. When they saw KRAMER, Kramer  
seemed excited and asked Roth if he had been followed to  
Pepper's office. <sup>after Roth's arrest April recalled that Sen. Pepper had asked</sup>  
<sup>him what he thought of Roth and he replied that he did not</sup>  
<sup>know but that Roth seemed like a nice guy.</sup>

After Roth's arrest, April noticed that all Roth's  
friends seemed to be afraid to help him or get in touch with him.  
April aided him and entertained Roth's mother  
when she came to Washington. He never recalls one remark  
made by Roth's mother to the effect that "Andrew should  
not have done all they told him to do". He did not know  
the significance of such remarks, but at the moment he  
thought that Roth may have been acting under instructions.  
April wondered if these were Soviet instructions. He also stated  
that the whole Roth family were Communists but had nothing  
specific on this.

April also recalled ~~that he remembered~~ that at  
a party he attended some months before Roth was arrested  
he heard Roth ask a person "where he had left the  
stuff" and the person said it was in his coat. April  
believed the other person was Lawrence of the State Department.

April remembered that PHIL CURTIS who was  
also with the PEPPER Committee, once asked him at a party  
to which Loretta April had taken him, why he (April) didn't  
join the Communist Party. According to April he  
told CURTIS very definitely that he despised the

Communist Party and could not see why any American  
would belong to it. He said CURTIS seemed very  
pleased at this and Lauretta Apil told him on the  
way home that he should not have answered Curtis  
like that. On reflection Apil wondered if the whole  
group were Communists. At this point Apil said  
he had no animus toward his former wife and recalled  
that when the Pepper Committee was disbanded all of the  
persons except his wife had been taken care of and transferred  
to other jobs.

Apil was unable to complete the interview  
having to go to the SANE (M. HOROWITZ) PRESS Company (copy the  
JAN 20 1948  
Page 14408)  
at 1400 Broadway N.Y.C. where he was to be interviewed

Mr. T. J. DONEGAN furnished the New York office a photostatic copy of what appears to be typewritten notations in a notebook which are dated Friday, December 13, 1940, entitled, "Counter-Revolutionary" and bears no signature. According to Mr. DONEGAN, this material was turned over to him by Mr. MC LEAN, ALGER HISS' attorney. The material contained in this photostat is supposed to have been written by MALCOLM COWLEY.

Briefly, the material relates that the author (MALCOLM COWLEY) had lunch on December 13, 1940 at the New Western Hotel with WHITTAKER CHAMBERS, and as a result CHAMBERS related certain information concerning the latter's association with the Communist Party, from 1924 to 1929, and subsequently CHAMBERS' connection with the underground apparatus particularly in Washington, D. C. from approximately 1931 until 1937. Of particular importance was the fact that this article relates that "SAYRE, the high commissioner to the Philippines, is also connected with the underground movement."

On this date SA FRANCIS X. PLANT and the writer interviewed Mr. CHAMBERS concerning this material, and he related that he met MALCOLM COWLEY at the New Western Hotel for lunch sometime in 1940; that at that time MALCOLM COWLEY was a free lance writer. CHAMBERS declared that so far as he knew, COWLEY was not a member of the Communist Party, but was always more or less close to Communist Party activities. He related that in one instance he was associated with a group that was soliciting assistance in the election of FOSTER and FORD in the national elections.

He stated that COWLEY is well known in literary circles, that at one time he was on the staff of the "New Republic" as literary editor, and that he has written a rather well received book in connection with leftist activities on the left bank in Paris. CHAMBERS related that he recalls that during this luncheon, he talked to COWLEY about the Communist Party underground, and related to him some of the information that he had previously related to ADOLPH BERLE when the latter was in the State Department. He denied specifically that he had mentioned that SAYRE was in any way connected with the Communist Party movement.

CHAMBERS advised that he has not seen MALCOLM COWLEY since that time. He did recall, however, that COWLEY wrote an article or a series of articles about ERNEST HEMINGWAY as a result of interviews he had with the latter in Cuba, and that these articles were published in some rather recent issues of "Life" magazine.

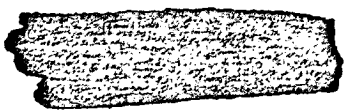

In reviewing the testimony of ALGER HISS before the HCUA, page 1174, it was noted that HISS stated that JOSEPH JOHNSTON of Birmingham, Alabama, who was in Washington, D. C., accompanied HISS to the Committee hearings and told HISS a representative of the press said that there were reports being received by the press ever since CHAMBERS testified that CHAMBERS had spent a considerable part of the last four to five years in mental institutions. JOHNSTON is a lawyer who, according to HISS, went to Harvard Law School with him.

HISS further testified that Mr. WALTON, who was formerly an employee for "THE INCORPORATED" had told a friend of his that CHAMBERS had been to a mental institution in 1946.

It is noted that in the testimony of CHAMBERS before the HCUA, page 1188, that CHAMBERS denied he had ever been treated for mental illness.

The following investigation was conducted by SA WILLIAM J. McCARTHY, JR., on January 11th through January 18, 1949:

With a view towards identifying "PETER" who was WHITTAKER CHAMBERS' superior in Soviet espionage, an analysis was made of the information furnished by CHAMBERS, a review of the New York file on BORIS BYKOV, with aliases, and a review of other files. CHAMBERS advised that he first met "PETER" through ALEXANDER STEVENS, also known as JAY PETERS, in the Fall of 1936 in New York City in front of St. Patrick's Cathedral. He met PETER many times after this up to early 1938 when CHAMBERS broke with the Soviets. The meetings took place at various theaters in New York. Some meetings took place in Washington, D. C. PETER never indicated where he lived. He rarely mentioned anything about his background. However, CHAMBERS gathered that PETER had been in Russian Secret Police work or had been a prosecutor for the Russian Government. Further, that probably from 1932 to 1934 PETER was doing secret work in Europe. He probably arrived in the United States in late 1935 or early 1936.

During the period from early Spring, 1937 until approximately March, 1938 CHAMBERS saw PETER nearly once a week in New York or Washington and turned over microfilm to him. CHAMBERS introduced PETER to HENRY HILL COLLINS, JR. in a theater in Brooklyn, probably in 1937; to A. GEORGE SILVERMAN sometime in 1937 in Washington, D. C.; also to HARRY DEXTER WHITE in 1937; also to ALGER HISS and JULIAN WADLEIGH.

CHAMBERS never knew PETER'S true identity; however, after he broke he had a long conversation with General WALTER KRIVITSKY in late April, 1938. After furnishing KRIVITSKY with all his descriptive data concerning PETER, KRIVITSKY stated that PETER was BORIS BYKOV. This was not a positive identification but was probably a pretty good one since both CHAMBERS and KRIVITSKY were only out of the service of the Soviets a short time and their information and recollection were very accurate.

CHAMBERS described PETER as follows:

Height:	5' 7"
Build:	Medium
Hair:	Reddish, thinning

Nose:	Thin, pointed nose, particularly thin at the end and his nose occasionally quivered.
Characteristics:	Clean-shaven, well proportioned, neat dresser, wore hard worsted expensive but conservative suits, always wore a hat, was quick in his movements, probably wore reading glasses, not cocky or conceited but definitely authoritative in his manner, had a ferret-like way about him.
Peculiarities:	Invariably carried his right hand inside his jacket or overcoat (Napoleon style)
Languages:	Spoke Russian, spoke German with a Yiddish accent, spoke very poor English when he first came to United States but improved during his stay.

CHAMBERS advised that PETER had a wife in the United States. He did not know the wife's name. He recalled that he saw her once. He described her as follows:

Nationality:	Russian, not Jewish
Languages:	Russian; practically no English; had one expression in English which she frequently used, "Its a gay farce".

In regard to any pattern for the meetings between CHAMBERS and PETER, CHAMBERS stated that PETER consistently changed the place of the meetings and that they met in the Bronx, Manhattan, Brooklyn and Queens. CHAMBERS recalled that on one occasion he met PETER in Brooklyn and they returned to Manhattan via the East Side subway and PETER got off at Fourteenth Street. CHAMBERS recalled that PETER had a wonderful knowledge of the New York subway system.

Concerning any arrivals or departures from the United States of PETER, CHAMBERS stated that he had no knowledge of any arrivals or departures; however, he believed that PETER arrived in late 1935 or early 1936. He had no idea how he arrived. CHAMBERS stated that he did not believe that PETER had ever been in the United States prior to his arrival in late 1935 or early 1936. He had a great fear of the American secret police. CHAMBERS believes that if PETER had been here before, he would not have had this fear.

In his book "In Stalin's Secret Service", General WALTER KRIVITSKY stated that BORIS BYKOV was the head of the Soviet Military Intelligence from 1936 on. He did not further identify BYKOV in the book; however, on June 28, 1939 General KRIVITSKY was interviewed by RUTH SHIPLEY of the Passport Division of the State Department. During the interview they discussed BORIS BYKOV.

Miss SHIPLEY prepared a memo relating to the interview and set forth the following information concerning BYKOV:

"Another person very active in the Soviet Intelligence work in this country who is now here is a man said to be Colonel Boris Bykov, or Bykoff, or Bukov, or Bukoff. He is probably in charge of the extermination of KRIVITSKY. He is said to be a small person with very odd red-brown eyes, red hair and red eyebrows. He came to this country in the Summer of 1936 from France also probably first class on the Normandie. He received a visa in Paris in the Spring of 1936 or either a German or Polish passport."

This office is presently checking the manifests of the Normandie for all arrivals during the Summer of 1936.

[REDACTED] advised SUZANNE LaFOLLETTE in 1939 that Colonel BYKOV had worked with General KRIVITSKY in Italy as an agent of Soviet Military Intelligence and was later placed in charge of this organization in the United States. [REDACTED] described BYKOV to SUZANNE LaFOLLETTE as age in 1939 - 40 years, hair dark red, build medium, eyes brown with thick brown eyebrows and lashes, skin very red especially about his neck, characteristics - always talking about himself.

[REDACTED] was reinterviewed on January 14, 1949 by SA FRANCIS X. PLANT and WILLIAM J. McCARTHY, JR. [REDACTED] advised that she first met BORIS BYKOV, probably in 1927, in Italy. She met him just once and then very briefly. She met him again in Vienna in 1930 or 1931. This time the meeting was in a restaurant and the meeting was very brief and was social.

[redacted] was of the opinion that BYKOV was an Austrian and had been connected with the Austrian Communist Party and had gone to Russia and became attached to Soviet Intelligence during the 20's. She described BYKOV as follows:

- Age: In 1927, 28 or 29
- Height: 5' 8"
- Complexion: Pale
- Hair: Reddish blond, not a real red-head, thinning on top
- Eyes: Color not known; eyes had red rings around them
- Eyeleshes: Light colored, almost white
- Lips: Possibly full lips
- Marital status: Probably single in 1927
- Characteristics: Well-dressed

[redacted] stated that General WALTER KRIVITSKY had advised her that BYKOV was connected with Soviet Military Intelligence and was in the United States. Further, [redacted] thinks that General KRIVITSKY stated that he had met BYKOV on the streets in New York City after the General had come to the United States from Canada which was in November, 1939. This would mean that BYKOV would have to have been seen by KRIVITSKY between November 1939 and 1941 when KRIVITSKY died. [redacted] did not recognize the name BORRIS HERTZ.

The Bureau in reviewing its files trying to identify BYKOV came up with some information to the effect that two individuals, JAN VALTIN and RICHARD WERBS and MAURICE WALKIN had furnished information about one BORRIS HERTZ. JAN VALTIN advised around 1940 that BORRIS HERTZ, a Comintern representative, had been in the United States for about a year or two. He described HERTZ as a Russian Jew of small stature with red hair and in his late 40's.

MAURICE WALKIN, who was prominent in Communist activities in New York was interviewed in early 1940 and advised that BORRIS HERTZ was a Comintern National Representative who arrived in the United States in 1937. He described HERTZ as a small Russian Jew. He added that HERTZ had worked all over Europe including Germany and France and had collaborated with LEO WAIKISS in Spain. WAIKISS was the Chief of the O.G.P.U. there. HERTZ was a former organizer of the Leningrad O.G.P.U.

From the above it will be noted that BORRIS HERTZ, who has never been identified, could be PETER and/or BORIS BYKOV. The individuals who furnished



tation on HERTZ will be reinterviewed. Since this office is now in possession of a great deal more information about "PETER" it may now be able to identify or eliminate BORRIS HERTZ as PETER.

The State Department and Immigration and Naturalization Service, Central Office, files were both checked for a record of BYKOV or HERTZ and he was found. This would indicate that neither HERTZ nor BYKOV was in the United States under either of these names.

The individuals mentioned by CHAMBERS as having met PETER through him are for the most part hostile and are not likely to cooperate. The only one who did meet PETER and who has cooperated is JULIAN MADLEIGH. He was interviewed concerning PETER and advised that he only met him once. He could recall very little about PETER other than that he was under the impression that PETER had one arm missing. This impression may have been due to the fact that PETER frequently carried his arm inside his jacket or overcoat. MADLEIGH was unable to add anything which would help in identifying PETER. The individuals who could probably help in identifying PETER but who would probably be uncooperative are HENRY HILL COLLINS, JR., GEORGE SILVERMAN, and ALGER HISS. HARRY DEXTER WHITE is deceased.

A number of individuals who were known or suspected as having operated as Agents of the Soviets in the United States were considered as being possibly identical with PETER. All have been eliminated. Below is set out under the name of the individual who is known or suspected of being involved in Soviet espionage the basis for eliminating the individual:

JACOB GOLOS

CHAMBERS advised that he knew JACOB GOLOS and GOLOS was not PETER.

WILLY BRANDES

BRANDES' physical description does to some extent fit PETER. CHAMBERS viewed a photograph of BRANDES and stated he did not feel BRANDES was PETER. [redacted] viewed a photograph of BRANDES and did not recognize BRANDES as BYKOV. Further, BRANDES was involved in an arrest and trial in England in 1937, hence could not have been seeing CHAMBERS once a week in the United States during 1937.

VASSILI ZUBILIN

Neither CHAMBERS nor [redacted] recognized the photograph of ZUBILIN as PETER or BYKOV. Further, ZUBILIN could not be PETER.

because ZUBILIN was in Moscow in late 1937 and early 1938 [redacted] hence could not have been in Washington and New York during this period meeting CHAMBERS.

BORIS BAZAROV, alias BORIS SHPAK, BORIS SPALAK

BAZAROV, who was [redacted] principal in New York during the period 1935 to October, 1937 and who does to some extent satisfy the description of PETER, is, according to [redacted] not identical with PETER. [redacted] bases this on the fact that BORIS BAZAROV was in Moscow during the period October, 1937 to June, 1938 hence could not have been meeting CHAMBERS once a week in New York and Washington during this period.

BORIS BASSOFF

[redacted] advised that she knew both BORIS BYKOV and BORIS BASSOFF and they were not identical. CHAMBERS has seen a photograph of BASSOFF and stated that he did not appear to be PETER.

UNKNOWN SUBJECT, "BILL"

This individual was mentioned by the informant GREGORY as a Russian agent during the early 40's in New York City. His description does not satisfy that of PETER. BILL was 5' 11" tall, extremely thin, and had black hair.

BILL GRINKE

This individual was [redacted] principal during the period 1936 and 1937. He operated in New York City. [redacted] stated that he could not be PETER since BILL was definitely a Gentile whereas PETER was Jewish. Further, BILL had a full head of hair and a low forehead whereas PETER had thin hair. Also, BILL had a flat, almost oriental nose whereas PETER had a thin pointed nose.

UNKNOWN SUBJECT, JACK

This individual was the principal of the informant GREGORY. He was recently identified as JOSEPH KATZ. His physical description does not satisfy that of PETER.

The Bureau by letter dated January 3, 1949 instructed New York to show CHAMBERS photographs [redacted]

the period 1936 to 1938 with a view towards identifying BYKOV.

The Washington Field Office advised by letter dated January 11, 1949 that the names and photographs of all male employees of the Soviet Embassy during the period 1936 to 1938 were not available. However, the Washington Field Office did locate and obtain photographs of fifteen employees who worked during this period. These photographs were forwarded to New York and were shown to CHAMBERS on January 18, 1948 and he failed to recognize any of them. The individuals whose photographs were shown CHAMBERS are as follows:

The indices of this office were checked relative to all persons named BYKOV. No information which would help in identifying PETER was found. However, photographs of four individuals by the name of BYKOV, who worked for the Soviet Union in the United States, were located and were shown to CHAMBERS on January 18, 1949. He failed to recognize any of them. They are as follows:
