However, from a review of the file entitled ISAAC FOLKOFF, it is noted that one WARWICK MILLER TOMPKINS, concerning whom this office is conducting considerable investigation, has for a number of years been a close associate of FOLKOFF. Confidential Informant SF-600 advised that during 1942, TOMPKINS obtained employment at Amtorg Trading Corporation with the assistance of FOLKOFF. In addition, TOMPKINS has been closely associated with the financial activities of the Communist Party in this area. TOMPKINS is presently engaged in the taking and showing of travel moving pictures. It is noted that WHITTAKER CHAMBERS described KEITH as being a photographer.

TOMPKINS is described as born January 25, 1900 at Troy, New York, height, 5'10", weight, 180 lbs., brown hair, large head, heavy features; he carries his head forward when walking, and is of heavy build and has a ruddy complexion.

There are enclosed two photographs of WARWICK TOMPKINS, one taken in 1945, and one in 1947. It is suggested that these photographs be exhibited to WHITTAKER CHAMBERS.

In the review of the pre-trial depositions it was noted in Volume 4A, page 812, that CHAMBERS in his testimony stated that during the 1940's while employed with Time, Inc., he mentioned the names of ALGER HISS and DONALD HISS, as well as some of the circumstances of this case, to JOHN BARKHAM, who at that time was the foreign news writer, and to SAMUEL GARDNER WELLS, the religion editor of Time, Inc. He stated WELLS is still employed by Time, Inc., but that he does not know the whereabouts of BARKHAM. He further stated that WELLS was instrumental in having him join the Episcopal Church.

"While I was Editor of 'New Masses' in 1932, Mr. Fadiman wrote an article entitled 'Why I Became a Leftist' to be published in 'New Masses'. The title of this story was changed to 'Why I Became a Communist' and was published in one of the editions of 'New Masses' under the name of Clifton Fadiman. I have since been told that I changed this title. Although I cannot definitely recall having done so, I am willing to believe that I probably did. So far as I know, Clifton Fadiman has never been a member of the Communist Party. In so far as my changing the title of his article, it is my present recollection that he did not complain or criticize me for doing this."

It is requested that an effort be made to locate the described article in the New York Public Library files. The 1932 edition of the "New Masses" should be reviewed and if the article is located, arrangements made for a photostatic copy.

CHAMBERS has furnished the following information relative to an apartment used by the Russian Espionage apparatus with which he was associated:

"About six months to a year after I became associated with the underground apparatus (presumably this would be early 1933 or thereabouts) I was taken to an apartment on Gay Street in Greenwich Village. I believe that this address was 9 Gay Street. In any event Gay Street is a very short street and the apartment was located somewhere on that street..... This was a brownstone house and the entrance, as I recall it, was below the street level, probably about two or three steps. I have some hazy recollection that a Negro family lived on the street floor of this building. The apartment which I will describe later was either on the second or third floor. I recall quite distinctly the stairs leading to it were very creaky. The door leading into the apartment entered directly into the main room which in itself was fairly small. At the rear of this room was a bathroom which probably at some previous date had been a large closet. There were no windows in this room but it did contain a toilet bowl, washstand and a bath-tub.

"In connection with the main room there was a fireplace on the wall opposite to the entrance to this room. There was another door leading into a small side room, which door was on the same wall as the entrance door but towards the front of the room. I recall that there were two or three windows in the front of the house that overlooked Gay Street.

"As to the furnishings in the room, the main room contained an iron couch that was covered with some cheap material. This couch, by

pulling out a section underneath, could be made into a double bed. There were three or four wicker chairs as well as a small table in the room. In the adjoining side room there was a table and a good sized trunk, which was always locked. Down the hall from the entrance to the apartment, which I have just described, was a door leading into a single room that adjoined the apartment above-described but which did not communicate directly with the apartment. This room and the apartment took up all of the space on this particular floor.

"When I first came to this apartment the room in (the) back of the building was unoccupied. However, sometime thereafter a Russian woman, who I never met or talked to, moved into this room and, as I later learned, lived there for a short period of time. I understand that her job was to watch the apartment while the apparatus people were not present. I do not know whether the Russian woman brought furniture with her or whether the room had been furnished prior to her arrival.

"I was told at some subsequent period by John Sherman that he had rented or leased the Gay Street apartment from a Negro named Harris. It was my understanding that Harris was a New York School teacher and sympathetic with the Communist Party but was not a Communist. Nevertheless, I understood that Harris knew that he was renting the apartment to an underground apparatus. No one lived permanently in the Gay Street apartment. It was used as a work shop for the apparatus in ways which I will describe hereinafter."

CHAMBERS thereafter stated that the Gay Street apartment was used exclusively as a photographic work shop and especially in connection with seamen courier activities during the 1933 and 1934 period. He stated that his knowledge of the apartment extended over a period of about one year. At a point near the end of 1933 or early in 1934 it was feared by the apparatus that the apartment was being watched. Some time later CHAMBERS was told by his superior that the apartment had been abandoned.

An attempt should be made to locate the above-described building and to obtain management records during the pertinent period in order to further identify "HARRIS" and others associated with it.

In connection with the Gay Street apartment, ROBERT GORDON SWITZ, a subject in the Moische Stern case, who is now an informant of this office, described several apartments used by the Stern apparatus as photographic laboratories. One such apartment was located on 16th Street in Manhattan just off 6th Avenue and was rented in the name of REGINALD GRAY SARTER. SWITZ described a German sailor known to him as "HENRY". SWITZ taught HENRY photography at that apartment. From the description furnished by SWITZ it appears that HENRY was also known to CHAMBERS in connection with the seamen courier operation. It appears that SWITZ knew HENRY in 1932 and CHAMBERS met him sometime later in 1933.

The information relative to HENRY is set forth merely for information. He is not known to have had any connection with the Gay Street apartment. It would appear that they were both used by the same apparatus, however.

CHAMBERS has furnished the following information concerning one SAM SHOYET and his daughter, AZIA SHOYET:

"It is my recollection that the 'Daily Worker' had no facilities for printing the paper. This work, so far as I know, was let out to an independent contractor located, as far as I know, in the same building as the 'Daily Worker' office (previously described by Chambers as being located in 1927 on East 9th Street just off 2nd Avenue, New York City)..... I would from time to time circulate about the Linotype Room and got to know some of the men fairly well and they liked me..... While so engaged I became acquainted with SAM SHOYET, the assistant foreman of the company that was doing the linotyping. I knew Shoyet to be a member of the Communist Party and I recall that on one or two occasions, while in conversation with him, he remarked that he had lived in Paris and Tokyo. I recall asking him how he got along in those cities and he merely remarked that he followed his trade as a printer.

"Some years later when I was talking to Dr. Philip Rosenbliett, he informed me that Sam Shoyet was a Russian agent who, sometime in the 1930's, was sent as a Soviet agent to Mukden, Manchuria; that Shoyet's daughter, Azia, a bacteriologist who studied at Hunter College, had been sent at approximately the same time to Vladivostok, probably to join her father in some Soviet espionage work. Upon learning this from Dr. Rosenbliett, I immediately surmised that Shoyet's work in Paris and Tokyo had probably been on behalf of the Soviet Government. My best recollection of a description of Shoyet is as follows:

"Relative to Azia Shoyet, it is my recollection that she was active in the YCL and that she was probably born in the United States."

CHAMPERS also advised that HARRY TAMER, he thought, was related by marriage to the SHOYETS. HARRY TAMER'S brother, JOSHUA, is known to have maintained a cover apartment for Soviet Espionage activities in connection with the Moische Stern apparatus on 55th Street in Brooklyn.

It is requested that the Hunter College files be reviewed for information relative to AZIA SHOYET from 1923 until 1935.

The indices have been checked with negative results relative to the SHOYETS.

On the morning of January 26, 1949, Mr. T. J. Donegan called to advise that AUSA Lauritano is anxious to get rid of HUMRICH who is wanted out on the west coast and who is being held at the House of Detention, pending the clarification of his story which he gave to Donegan and agents of this office last week. Mr. Donegan wanted to know if we were in a position to again interview HUMRICH and give clearance for him to go out to the west coast to face charges there. I advised him we would get in touch with either him or Mr. Lauritano concerning this. *J. Kelly*

Mr. Donegan then advised that in CHAMBERS' testimony, he has stated that servants were going in and out of the HISS home in Washington at the time CHAMBERS was associated with HISS there. Donegan says that CHAMBERS knew these servants and he wanted to know whether we had been successful in locating and interviewing them. I advised him that the Washington Field has been working on this for some time and as soon as we get results we will let him know. He then mentioned the cottage on the Delaware River near Frenchtown where CHAMBERS says PRISCILLA HISS visited about a week in 1935 or 1936, and where MAX LIEBER became enamoured of her. He wanted to know whether we had checked this and whether we had interviewed LIEBER. I advised him that I knew that a lead had ~~either~~ gone out on the Delaware River and that we were contemplating interviewing LIEBER; that we would let him know as soon as these items had been covered.

In view of the interest of Mr. Donegan in the above matters, it is suggested that the offices concerned be instructed to expedite their inquiries.

At the request of Assistant to the Attorney General THOMAS DONEGAN, the writer together with Special Agent Lawrence W. Spillane interviewed HORACE ALTON INGRAM at this Office today.

Mr. INGRAM had previously appeared before the Grand Jury and he was questioned immediately following his presence in the Grand Jury Room.

At the outset of this interview it was pointed out to Mr. INGRAM that the interviewing Agents were well aware of the story that he had previously told to Agents of the F.B.I. in Atlanta, Georgia and he was also told that the Agents were aware that he had just testified before the Grand Jury. He was asked if there was anything that he wished to add to the testimony that he had previously given or if there was anything that he wished to clarify. He stated that there was nothing further that he wished to add and he reiterated the fact that the information he had previously given was the truth. He was then shown the full length picture of ALGER HISS that was taken at the F.B.I. Office immediately following the arraignment of ALGER HISS on December 16, 1948 and he was asked if this was the same individual whom he had met in Washington in 1937 and who had approached him to do errands for him. After looking at the picture for a few minutes, he stated that this definitely was not the same individual. He was then shown the full face and side face picture of ALGER HISS that was taken on December 16, 1948 immediately following the arraignment of ALGER HISS and INGRAM again stated that this individual did not appear to be the same as the individual he had previously mentioned.

INGRAM further stated that the individual whom he thinks may be ALGER HISS spoke with a foreign accent. He was questioned as to whether he meant foreign in that it was the accent of an individual from a country

other than the United States and he advised that that was the fact. He was then asked if he believed the tall individual who approached him in 1937 in Washington, D. C. was of Jewish extraction. To this he replied that the tall individual who approached him in 1937 in Washington, D. C. was in all probability Jewish or Italian because this individual was dark skinned and had very black hair.

It should be noted that such description does not fit that of ALGER HISS.

INGRAM insisted that the picture that he had observed in the newspapers showing ALGER and DONALD HISS entering the Court House at the time the publicity first appeared in the newspapers appeared to him to be the same individual as the one who approached him in Washington.

INGRAM again was questioned as to his reputation for being a drinker and he readily admitted that he had the reputation for being a bit of a drinker. He was asked if at any time he had ever been in any institution or hospital. He stated that on one occasion in the late 1930's his father had had him committed to a farm in Georgia for drunkenness. He stated that his father did this in order to try to cure him of his habit of habitual drunkenness. He advised that the only other time he was in a hospital was in 1945 when he was in a veteran's hospital because of a heart condition and a bad stomach.

At the conclusion of the interview, Mr. INGRAM was escorted by the Agents to the 14th floor where he was turned over to the guard who stated that he would inform Mr. DONEGAN that we had completed the interview with INGRAM.

PERJURY
ESPIONAGE - R

At 5:50 pm on January 26, Mr. H. B. Fletcher of the Bureau referred to the pumpkin film documents developed from film turned up by CHAMBERS in the pumpkin on his Maryland farm. Mr. Fletcher advised that some of these documents pertain to Navy activities. The Navy asserts that these particular documents pertaining to Navy material came from the Bureau of Standards and not from the Navy itself. Mr. Fletcher requested that we ask CHAMBERS if these documents came from the Bureau of Standards through PIGMAN who was CHAMBERS' contact at the Bureau of Standards, or whether CHAMBERS obtained them through some contact in the Navy Department. The Navy is concerned to be sure that there is no leak in the Navy Department through which CHAMBERS was able to obtain these documents.
