Enclosed is check in the amount of \$6.00 to cover cost of these two books, and it is requested these books be forwarded to the Miami Division,




On 10/18/58 [redacted] Morris, Minnesota, telephoned this office while she was in Minneapolis to attend the football game to advise of a meeting which had been held at Morris, Minnesota, on 10/15/58.

According to [redacted] this meeting had been organized by a group fearful of the spread of Communism and the central theme of the meeting about which the proceedings revolved was a review of the Director's book "Masters of Deceit." It was strictly a non-partisan meeting in which a number of local groups including some of the churches participated. About 300 persons attended the meeting. There were representatives of both the Republican and Democratic-Farmer Labor parties - the two major political parties in the state of Minnesota - present.

[redacted] thought the Director might be interested in knowing that the review of his book was extremely well received and the material set forth in it appeared to have a great impression on the persons attending the meeting. She said it awakened in many persons a new realization of the dangers of the CP. COMMUNIST PARTY

[redacted] asked what she and those affiliated with her could do in the matter of the Communist menace. She was informed that this Bureau would be pleased to receive from her any information coming to her attention relating to Communist and other types of subversive activity.




Dear Mr. Hoover:

I have just read your book "Masters of Deceit" and would like to congratulate you on presenting a fine outline of the threat which faces this country today and how we can cope with Communism and ultimately nullify its threat.

Having been a history major in college and particularly interested in the historical analysis of Communism I have found that there is a missing link in a continued line of information about the day to day twists and bends of the present Russian Government and its objectives. Granted, newspapers, magazines, and radio editorials fill in this missing link to some extent. However, at their most expansive, the analysis is still too surface in its treatment.

Allow me to make an example of what I mean: The Communist Government and the Government of the United States appear to be in agreement on the exchange of students, artists, and tourists. The American Government and the American people believe that through a sincere desire to understand the two peoples might find a way to peace. However, the Communist Government, I'm sure understands that this very desire can be turned to their advantage, not for peace, but to placate the fears of Americans. Therefore, this exchange can serve as a screen. I believe, Adolph Hitler used this "Tourists" idea as a method of placating the fears of the world in the early and middle 1930's. It is difficult to argue with an Iowa farmer or a university professor who has just returned from a Communist guided tour of Russia who claims that Russia is a peaceful nation.

Therefore, I have high hopes that you can supply me with the names and addresses of government or private news agencies which have as a part of their major concern a newsletter solely concerned with the analysis of Communist efforts throughout the world. It is, of course, absolutely essential that factual information form the basis of the analysis, for only with facts at hand can arguments presented by individuals which may knowingly or unknowingly assist the Communist line be refuted.

In addition, is there a speakers bureau or a group of independent individuals who are in a position to speak at public gatherings authoritatively on not just Communist History, but their present day maneuvers. Whittaker Chambers has been suggested to me by one individual here in town who might be available for this work. This speaker program is most essential. I say this as a result of one recent experience where I heard a highly regarded individual give an address which in my mind was not a true presentation of the facts. Since this individual is entitled to his opinions and entitled to speak them publicly I would like to offer the same group a more qualified speaker who might serve as a rebuttal or give the group a deeper and more personal understanding of the threat each and every citizen of this country as well as the rest of the free world is facing in Communism today.

Hoover Announces Program of FBI Assistance

WASHINGTON (AP) — FBI men will confer with local enforcement agencies throughout the nation on handling investigations of bombings and bomb threats.

FBI Director J. Edgar Hoover, announcing this Thursday,

said he believes "these outrages can be materially curbed by an aroused public opinion, a coordinated effort on the part of the federal, state and local law enforcement agencies and by stern treatment of the perpetrators."

The 53 FBI field offices in the United States and the territories were ordered to set up the local conferences during November and December.

Hoover said field officers will explain in detail the cooperative services of the federal gov-

ernment available to local authorities in bombing incidents. Available aid, he said, includes help from FBI laboratories and the fingerprint identification division, as well as application of special techniques developed

Strange Headache Malady Hits California

BERKELEY, Calif. (AP) — "Contagious headaches" have struck thousands of Californians—mostly teenagers and young adults—in the past few months, the State Department of Public Health announced.

Researchers theorize that a virus may cause the mysterious malady, but Dr. Malcolm Merrill, health director, said they have been unable to isolate such a virus.

Dr. Merrill said the disease is mild, has caused no deaths nor made necessary any hospitalization. He described the symptoms as 12 to 14 hours of vague discomfort followed by

fever, pains and dizziness and climaxed by an intense headache lasting two or three days.

"The only thing that will bring relief is aspirin," Dr. Merrill said.

Sometime ago I met [redacted] the San Francisco office, and I mentioned to him that the F. B. I. Story was being used for reading at table for Jesuits at the University. He seemed impressed by this fact and informed you about it. Subsequently, I received a letter from you also. Because of your interest in this, I thought that the following facts might be brought to your attention in the common concern we have about Communism.

As you know here at the University of San Francisco we have a required course for the students on the philosophy, dynamics and tactics of Communism: This course was introduced by [redacted] several years ago because he realized the importance of our society in being fully aware of this ever present evil.

In the absence of [redacted] who is on an official trip in Europe, I wish to thank you for your letter of October 16th calling attention to J. Edgar Hoover's bestseller, Masters of Deceit. We appreciate your offer to make quantity purchases of the book available to our personnel at dealer discount.

As you surmised, we have had an opportunity to read and assess the book for use overseas. The book is very useful for our purposes, and we have given it strong promotional support. Examples of such support along with indications of interest from our overseas posts follow:

In response to a world-wide canvass made last March 31st, our overseas posts ordered approximately 205 copies of the book, primarily for use in the libraries of our information centers. Another canvass made last May resulted in orders for approximately 219 copies of the book for presentation to selected foreign officials and institutions.

At present our overseas posts are being canvassed for expressions of interest in low price English and foreign language editions of the book. If, as expected, the demand is sufficient, we would encourage production of such editions.

Several of the posts, including Hong Kong, Mexico City, Tokyo, and Beirut, have translations of the book under consideration, the contemplated Arabic translation being a low priced edition.
