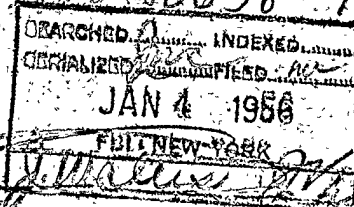
On December 16, 1955, [redacted] who was in a position to provide reliable data, made available to the NYO photographic reproductions of various notes and records possessed by CHARLES DIRBA, CP auditor, 540 East 84th Street, New York, New York. Included in this material were six schedules recapping membership data obtained during the current New York County CP registration. The membership statistics in these schedules are broken down to show the sex, age group, length of time in organization, CP club activity, whether or not regular reader of Daily Worker and Sunday Worker, occupation, national origin, trade union affiliation or professional status, and affiliation with mass organizations other than trade unions of members belonging to the various regions comprising the New York County CP. It is noted the aforementioned schedules reflect that up to December 8, 1955, 2, 299 members were registered in New York County.

Reference is made to Bureau letter to New York and other Offices, 12/9/55, wherein each office was requested to advise the Bureau by letter as to the extent of its success in identifying all Communist Party members, and securing complete and accurate membership figures.

This is to advise that there has been no meetings of the El Paso Branch of the Communist Party during the last quarter of 1955. Active members of this group consist of [redacted] and [redacted] head of the group. It is noted that [redacted] sells cosmetics from door to door, and during the month prior to, as well as including the Christmas Holidays, it was necessary for her to devote extensive time to her sales, since during this period of time she makes the greatest percentage of her income for the entire year.

[redacted] who is [redacted] of the El Paso group, has advised that [redacted] of 1955 as yet, however, [redacted] has indicated to this informant that they [redacted] sometime after the Christmas Holidays.

It is noted that this office has recently developed [redacted] and this informant has become acquainted with [redacted] and in the event of membership registration, he will, in all probability, be requested to register with this group.

[redacted] and [redacted] have advised that there has, as yet, not been any registration of Communist Party members of the El Paso, Texas Branch, which is the only known existing branch in this area, nor has [redacted] mentioned to them anything concerning registration.

With respect to these individuals, it is noted that they are still considered as members since this office has received no information indicating that they have been dropped from the Party. It is expected that this figure will possibly be reconciled if and when the El Paso Branch of the Communist Party makes their registration.

The Bureau and New York will be advised when the registration data concerning the El Paso members of the Communist Party is effected.

On December 9, 1955, the informant stated that he had been talking with [redacted] Northeastern Subdistrict District #2, Communist Party, USA. [redacted] stated that he had seen [redacted] over the weekend of December 3, and that [redacted] had been asking for the informant. [redacted] said that [redacted] was the instructor named [redacted] who had taught the informant at the Communist Party School held at Redding, New York. Informant has previously identified [redacted] by photograph as this instructor and all of this material is in the New York file on [redacted]

[redacted] said that [redacted] is the CP [redacted] for Harlem.

[redacted] discussed the New York State Communist Party caucuses that have been periodically held in New York City and stated that DOXEY WILKERSON will no longer run these caucuses on the National Association for the Advancement of Colored People, but is going to be relieved by [redacted] DOXEY will go back to his regular job at "the school". [redacted] stated that there would be a caucus in New York City at 11:00 AM on December 17 at 124 W. 124th Street.

On December 16, 1955, this informant reported that [redacted] CP functionary in Albany, had told the informant that this meeting had been changed to a meeting of the Party Commission on the Negro Question, and that she and the informant would attend. She stated that she had been in New York on December 10 and had seen DOXEY WILKERSON and that he had told her that the New York State caucus on the NAACP had been held on December 8, in New York City and that no one from upstate New York had been in attendance.

On December 18, 1955, the informant reported on this meeting held in New York City on December 17, 1955. He stated that he and [redacted] had approached the 124 W. 124th Street address, and that [redacted] was looking for an announcement of a Labor Commission Meeting. This meeting was announced on the bulletin board in the lobby as scheduled for Room 1; Room 1 turned out to be a chapter room for the Independent Order of Odd Fellows. The meeting was held in this room and attended by the following: [redacted] DOXEY WILKERSON; [redacted] ABNER BERRY, [redacted]

UNSUB BEA

A white woman in her early thirties from the Jefferson School; 5'2" tall, 115-120 pounds, slender build, sandy hair worn in a long bob, shoulder length

UNSUB ABE

A white man of Jewish origin. Six feet tall, 190-200 pounds, heavy set, fair complexion, brown hair with receding hair line. He is from New York City, is in the Jewish Movement, although he has not been in the movement long. He was asked by UNSUB SAM to do an article for the February issue of "Party Voice" on Negro-Jewish unity. He stated that he had not been in the Jewish movement long, but would write the article with some assistance.

UNKNOWN SUBJECT SAM

From the "Party Voice" gave assignments to ABE for the February issue of "Party Voice" and also assignments to [ ] and WILKERSON to do the lead article on the Mississippi situation. He assigned [ ] an article on the CIO-AFofL merger which she will write with some extra assistance. He directed that all articles be submitted during the week in January.

He is white, male, Jewish. He is in his fiftys, 5'8", 145-150 pounds, slender build, thin face, fair complexion. He has sandy hair which is sparse and receding and wears thick-lense glasses.

UNKNOWN SUBJECT OSCAR

OSCAR presided, is from Manhattan, and apparently a Party functionary because he made a talk on Party Registration. He is a Negro, male, 6'1" tall, 175 pounds, slender build, dark complexion, approximately fifty, has close cropped black hair, and speaks with a slight West Indian accent.

UNKNOWN SUBJECT LEE

Mr. LEE, a Negro male, is in his early thirty's, 5'9" tall, 175-180 pounds, stout build. He has a dark complexion, a noticeably large nose and wears horn-rimmed glasses. He apparrently is from Brooklyn. The informant has played softball with him at Camp Unity and describes him as having been on the staff of Camp Unity during the summer of 1955.

[ ] discussed this subject with [ ] and states that she is confident that Unknown Subject LEE is the husband of [ ] [ ] was unable to put any name to this individual.

Albany letter of August 29, 1955, captioned, "Wingdale Lodge" contains information from [ ] that one [ ] was a Negro who helped in the office of Camp Unity and would order jobs around the camp. [ ] described [ ] as an employee of the camp during the summer of 1955.

[ ] was described as Negro, female, forty-nine to fifty years old, from New York City, married, with a two year old daughter named LINDA; 5'8" tall, one hundred twenty pounds, and extremely slender. LEE's husband was at the camp for at least a weekend.

The meeting was opened by Unknown Subject OSCAR who presided as chairman. He immediately introduced [ ] who presented the main report for the evening which involved the NAACP. [ ] spent most of his time talking on a Civil Rights Mobilization scheduled for Washington, D.C. in February of 1956. [ ] explained that this mobilization was not CP initiated, but was CP supported. He stated that the CP wanted unified backing for this mobilization from many organizations, specifically naming the Elks and the NAACP. [ ] explained that the Mississippi issues were so hot that the NAACP was afraid the situation would get out of hand and the NAACP was trying to quiet the commotion down.

The CP wants to build up the pressure against the NAACP through other organizations, so that the NAACP will have to move in this matter. The CP wants to weld a united front on the Mississippi issues. Also, it wants to get the Labor Movement behind this and [ ] mentioned Local 600 of the United Automobile Workers of Detroit as one segment of labor which had endorsed this mobilization. The CP wants this mobilization to develop into a mass merge on Washington. The CP wants this mobilization which will be in Washington on the first day Congress convenes to develop a delegation which will visit Congress for the purpose of supporting Congressman DIGGS and his proposal. DIGGS has publicly announced that he will introduce a resolution before Congress to prohibit the seating of the United States Congressman from Mississippi on the basis that they do not represent a majority of their constituents. [ ] stated that Local 600 has a petition against seating these Congressmen, which petition is receiving nationwide circulation.

[ ] stated that one [ ] of the African Methodist-Episcopal Church is touring the country to raise food and funds for the Negroes in Mississippi who are suffering from the economic boycott against their businesses brought

about by the various White Councils that have sprung up in Mississippi. The CP, as a matter of policy, will back these efforts by the AME charge.

[redacted] will appear at the 143rd Armory in New York City on January 2, 1956 and the Party will support this appearance.

[redacted] stated that the CP is sponsoring a radio program over WAID on Civil Rights issues. He also stated that "The policy of the left" is to openly intervene in all issues. The policy is not to work in the background, but to let the people know that it is the CP that is intervening so that the people can know the CP program.

[redacted] presented a report on the AFof L-CIO merger. She stated that she had attended the merger convention and had distributed literature from the National Negro Labor Council. [redacted] stated she represented the NNEC at the convention and was pleased that there was no Red-baiting. The NNEC advocated a stronger known discriminatory in the constitution of the new AFofL-CIO and claims credit for success in this regard. [redacted] commented that her report was a labor report and should be taken up jointly by the Commission on Negro Affairs and by the New York State Communist Party Labor Commission.

OSCAR presented a talk on CP registration in New York City. He noted dissatisfaction with the progress of registration, commented that the registration of Negroes in the CP was still, and had been in the past, falling off. He stated that the Party had two hundred registered for 1956, whereas it had registered over five hundred for the years since 1952. He stated this Negro registration in the CP in New York City at one time was one thousand members. He stated that he, [redacted] [redacted] and eighteen other individuals would meet in New York City in the near future to identify past and present Party members and get them all registered for 1956.

He again expressed disappointment over registration figures for New York City, and stated that this meeting would go through the list of former Party members again so that they could be contacted and reregistered for 1956. He specifically commented that [redacted] and [redacted] would be among the eighteen individuals who would attend this meeting.

An announcement was made that a Christmas Party would be held in New York City in the Jefferson School on December 29, celebrating the end of parole for certain national leaders of the CP.

January 21 was set for the next meeting of the particular group in New York City. No location was mentioned.

At the conclusion of the meeting the informant and [redacted] went to [redacted] residence at [redacted]. The Albany, Schenectady and Utica Branches of the NAACP were discussed and [redacted] was requested to visit upstate New York and sit down with the Party members and lay out a plan of operations for them in the NAACP. January 27, at 8:00 PM was agreed upon as the night for this upstate meeting which will be held in Albany or Schenectady. [redacted] stated that he wanted all Negro Party members to meet on this occasion. He estimated there should be ten or twelve in attendance. [redacted] stated that they would be lucky if they got five members there.

Referenced letter requested information concerning Communist Party membership figures as well as identification of various Communist Party clubs and Communist Party functionaries.

Membership

During January, February and March, 1955, AL CS 2945-S\* furnished registrations for the Western Subdistrict of District No. 2, CP, USA. These re-registrations reflected 43 Communist Party members in Syracuse, New York area; 16 Communist Party members in the Ithaca-Spencer, New York area; and 13 Communist Party members in the Triple Cities area, which includes Binghamton, Endicott and Johnson City, New York. AL CS 2945-S\* obtained these registrations from [redacted] Syracuse, New York, who was then operating in the Communist Party underground using the alias [redacted]. [redacted] has left the Syracuse area and according to [redacted] [redacted] has taken over most of the duties formerly performed by [redacted]. This informant also advised that [redacted] is the Organizational Secretary for the Western Subdistrict, District No. 2, CP, USA. This source also advised that [redacted] has in his possession re-registrations for 1956. However, due to conditions beyond the control of the source, the source has been unable to obtain the complete re-registrations for 1956. To date, this source has furnished this office with 8 1956 Communist Party re-registrations.

AL CS 2918-S\* has advised that [redacted] is [redacted] of the Onondaga County Communist Party, and that [redacted] is Organizational Secretary for the Western Subdistrict, District No. 2, CP, USA. This source has also advised that [redacted] and [redacted] handle the Communist Party activity for the Triple Cities area and Ithaca and Cortland, New York, as well as the Syracuse, New York area.

On April 11, 1955, AL CS 2918-S\* furnished information which reflected that the following are the Communist Party club groups in the Syracuse, New York area:

Northeastern Subdistrict

[redacted] and [redacted] have advised that [redacted] is the Chairman of the Northeastern Subdistrict, District No. 2, CP, USA. [redacted] has advised that [redacted] is the Organizational Secretary for the Northeastern Subdistrict, District No. 2, CP, USA. On December 14, 1955, [redacted] furnished information that in Schenectady, New York, there were three groups, namely the Schenectady Community Group, Schenectady Shop and a group designated as Group II. This same source furnished information which reflected that the Group II is made up of Communist Party colonizers in the Schenectady, New York area. The identities of Group II have been identified by the Communist Party re-registrations and the identities of the Schenectady Shop and Schenectady Community Groups are likewise being identified through the Communist Party re-registrations.

This same informant advised that there are also Group IIs in Albany and Troy. There are 4 in this category in Albany and 8 in Schenectady. In addition, this informant advised there were 2 Communist Party members in Cambridge, New York.

On December 24, 1955, AL OS 2962-S\* furnished information regarding the Communist Party organizational setup in the Albany, New York area. Information furnished by this source reflected the following groups in the Albany area:

Railroad, Industrial, Community I, Community II and an additional group "At Large."

As set forth above, [redacted] furnished re-registrations for Group II for Albany, which included the Communist Party colonizers.

This office has live confidential informants in the Industrial Group, the identities of the members of the Railroad Group have previously been ascertained by this office, and there is a live informant of this office in one of the Community groups. This office at the present time is identifying the other members of the Community Group in Albany as well as the "At Large" group.

Although Bureau sources indicated the Party expected registration of members to be completed by end of December, 1955, [redacted] and [redacted] both of whom are participating in the registration in the Houston area, have advised that because insufficient contacts had been made for registration in this area by December 31, 1955, Party leaders have extended this period to January 31, 1956. According to these informants this delay has been because of several changes in Party leadership in this area during recent months, thus causing some confusion in delegation of authority.

For these reasons informants are unable to provide conclusive registration figures at this time. However, both informants furnished approximately 13 names of persons to be registered who had already registered or who will be approached in the very near future for purposes of registration. Each of these informants furnished approximately five or six additional names of persons whom they felt would likely be approached for registration before conclusion of the drive. Of the 13 names furnished by each, approximately 4 persons were known to be registered as of January 11, 1956, by [redacted] and as of January 12, 1956, by [redacted]

In the event any substantial variation in these registration figures should occur by January 31, 1956, the Bureau and New York will be so advised. These figures, of course, do not include ordinary sympathizers or persons who aid the Party but endeavor to remain anonymous.

Although these informants are not handling all of the registrations in this area, they are in a position to have knowledge of practically all persons who are registered.

estimate that registration for four of the counties in NYC will be in the low 90%. Negro registration is up to, and, in some instances, above average, although Negro membership is the lowest in years. Industrial registration is above average, with small losses in spots.

Two city-wide mobilizations are planned for the weekends of January 21-22 and January 28-29, 1956, during which CP will attempt to register 500-700 additional comrades. At the same time an effort will be made to strengthen the party organization and bring back individuals who have lost contact with the Party.

An analysis of average dues payments for the first nine months of 1955, reflected only 50% dues payments.

A discussion of Jefferson School of Social Science activities indicated a Fall registration in 1955 of 1,173 students. Proposals to increase student registration include support by the Party leadership and publicity in the "Daily Worker", and at all public meetings. The program of the school will be concentrated on youth, Negro, and trade union matters.

NY 1622-S\* advised that the next NY State Board meeting would be held at the Jefferson School on Wednesday (1/11/56).

A summary of the proceedings will be submitted to the Bureau by letter.

Other commissions have existed in the past, but there is no reason to believe that they exist and/or function at the present time.

Informant quoted [redacted] as stating, 12/22/55, that there were 319 reregistered in the City of Philadelphia and 430 would be registered and/or recruited in Philadelphia by the close of registration, 1/31/56. [redacted] added there would be 572 reregistered and/or recruited in CP, EPD, by 1/31/56.

The following is a discussion of each Region and/or Section of the CP, EPD:

1st Congressional District (CD) Region,  
aka., South Philadelphia Region

This Region contains only one section which has no separate name. The Section Chairman and Secretary-Treasurer are definitely known. Section Literature Director and Press Director are believed known because of the functions performed by them, but not specifically confirmed. The Region is in the process of reorganization. The CP anticipated registering only 39 persons in this Region for 1956.

There is only one known functioning club with 7 members, all identities and titles known. 20 other persons will probably be reregistered for 1956, but registration not specifically proven on these individuals as yet.

Additional information is being sought and planned for through two live informants in the Region, extension of the Interview Program, additional neighborhood sources and logical fisurs; there is no immediate prospect of developing a logical anonymous informant; it is expected that more information will be received from live informants and the misur covering activities of District Officials, including the Regional Organizer.

2nd CD Region,  
aka., West Philadelphia Region

This Region is composed of 3 sections having 78 members registered and 8 to be registered, as well as a number of prospective recruits. The Philadelphia Office has exact information regarding all Regional and Section Officers; names of all members and most of the prospects; there is even information regarding the identities of persons dropped and the reasons therefor. The exact club breakdown is known in one section, including all club officers and members of these clubs; partial information regarding the clubs and club officers is available in the other 2 sections. Further details are being sought for complete coverage of the Section through the [redacted] informants who are CP members of this Region, [redacted]

logical fisurs; additional neighborhood sources; recontact of an anonymous source as logical; and through two PSI's in the Region who are among the CP prospects for recruitment.

#### 4th CD Region

This Region includes the CP membership residing in the 3rd CD and the 4th CD of Philadelphia. It comprises 3 sections with 93 members on the rolls in 1955. The 1956 registration is incomplete, but the CP expects that the registration and recruiting will bring approximately the 1955 total.

Philadelphia has exact information regarding the Region and Section Officials; complete information regarding club breakdown, officers and members in one section; nearly complete information regarding the other 2 sections. There are 70 current members identified and 11 additional persons believed to be members; some prospects for recruitment are known. Complaint was recently made that the Regional Organizational Secretary keeps no record, but has all his information in his head.

Further details are being sought through [redacted] informants who are members of this CP Region, including [redacted] and [redacted] through additional neighborhood sources; through fisurs; through logical recontacts with anonymous sources; and through PSI's believed to be among the prospects for recruitment.

#### 5th CD Region

This Region was formerly combined with the 6th CD Region and was recently reorganized into a separate Region. It comprises one section, the club breakdown being unknown and total membership unknown. Two Region and Section Officials believed known; 24 additional persons are probable members.

This Region received no leadership or attention for several years and the CP organization deteriorated, members are fearful and have refused to attend meetings. There is no information that the CP has been materially successful in its

attempt to reactivate this Region. The Regional Organizer was recently dropped from the Philadelphia City Committee.

Philadelphia has concentrated on this Region heavily, especially in recent months. The volume of interviews of security subjects is probably responsible for the apparent failure of the CP to reactivate this Region.

Many fisurs have been conducted and many neighborhood sources exist. These will be continued; interviews will be continued as logical; anonymous sources will be developed as logical and possible; a trash cover is presently in existence on the Regional Organizer (the Bureau has twice refused requests for tesur on the Regional Organizer); 3 informants, 1 PSI, and 1 Panel Source live in the Region covered by the 5th CD and are attempting to elicit CP recruitment in this area.

#### 6th CD Region

This Region was recently reorganized after being formerly combined with the 5th CD Region. CP officials have stated there was virtually no organization in this area. The Region is composed of 3 sections that are presently in the process of consolidation into 2 sections.

Region Officials are known. The identities of the new sections are known, but section officials are unknown as yet. The club breakdown and club officers are unknown. The number of members in this Region is unknown, but the CP has complained that only 11 "comrades" in this Region read the "Daily Worker" which is indicative of small, inactive membership.

There are 2 informants who live in this area and are CP members, but have not been assigned to clubs, which may indicate fragmentary CP organization within the Region. There is only one functioning club known in the recent past, but this has been disbanded and most of the members reassigned to a CP study group. These persons are identified. There are 10 CP members identified, plus an additional 27 who should logically be attached to this Region.

Future coverage is planned through 1 informant who is a CP member in the Region, plus 2 informants who are CP members logically assignable to this Region; through fisurs; trash covers; neighborhood sources; and extension of the Interview Program.

### Industrial Region

This Region was created to cover the automobile, needle trades, transportation, building trades, fur and leather, and electrical industries. There are not sections and/or clubs for each of these industries, since some industrial clubs are known to be presently attached to "community" sections.

The exact structure of this Region is not known. One functioning section has been identified with 4 clubs, the officers and members being identified in 2 of these clubs, and the balance of the members believed known; one section exists on paper only, but has no operation or members assigned. The total registered in the Region as of 12/21/55 was quoted as 60 members with "several more" to be registered. Some of the members live in the Philadelphia suburbs, but are assigned to the Industrial Region. Philadelphia has identified a total of 63 persons who are not specifically assigned to community clubs who should logically be assigned to the Industrial Region. This figure includes those known to be so assigned.

Further details are being sought through one informant who is a member of the Industrial Region and one informant now in a community region who will probably be Organizer of the "paper" Section if it is activated; through logical fisurs; through neighborhood sources; through 3 informants now in CP "community" clubs who expect to be transferred to the Industrial Region; through one informant who is a logical prospect for recruitment into the Region; and through anonymous sources now in the process of development.

### Professional Region

This Region is composed of one section and was recently reorganized with most members being transferred into community clubs and sections leaving only a "few chemists and scientists." The total remaining membership is not known; however, there

recently was suggested a "Worker" bundle subscription goal of only 15, indicating a small membership.

The Regional Organizer is known, but the identities of the remaining officers and members not yet specifically established, nor exact clubs established. The activities of members of this Region are probably concentrated in the American Association of Scientific Workers with no specific CP meetings identified as such being held in the past few months. 11 persons believed still in the Professional Region in addition to the Organizer have been identified.

Future plans include 1 informant who is a CP member recently transferred from the Professional Section and seeking return to a professional club; 2 informants not CP members in the AASW; through logical fisurs; through neighborhood sources; and through recontact of established anonymous source and new anonymous sources when and where logical. Region activity is expected to be very limited in the coming period because the Organizer is known to be fearful of FBI investigative activity.

#### Youth Section

There is no Youth Section of the CP as such; however, the CP in recent months has been concentrating on reviving youth activities. CP members active as "youth" are known to be assigned to community clubs and sections. The CP general plan is to train and utilize CP youth in the Trade Union Movement and in industrial concentration and to use the Labor Youth League for public-type activities. The LYL has a sustainer program and some of the youth contributed their normal CP sustainers to the LYL.

Philadelphia has concentrated heavily on the investigation of youth through interviews, informant development, fisurs, and anonymous sources. The personnel in charge of youth work for the CP are known. Many rank and file members active in CP youth and/or LYL have been identified.

Future plans include information being obtained through 2 informants who are LYL members; through fisurs; through logical

recontact with anonymous sources; through confidential sources who are approached by LVL for help; and open investigative activities, especially of the LVL and CP members identified through informants and other sources covering their respective clubs or regions.

#### Delaware County Section

The CP claims to have a section in Delaware County with a section committee of 4 members. The total membership of the section is unknown. Exact information on clubs or members is unknown. 3 of the 4 members of the section committee are believed identified and comprise part of the 15 members believed identified in this section. Extensive fisurs and neighborhood sources on members of the section committee have been partially productive. Future plans include fisurs and neighborhood coverage to be extended to other CP members in the area; through continuation of the Interview Program; and through a promising anonymous source presently in the process of development.

#### Williamsport Section

The CP makes no claim to having reactivated this Section. No CP meetings are known to have been held in the area since 6/54. 10 CP members have been identified in this Section in the past and probably still passively retain membership, although no 1955 or 1956 registration is known to have taken place in the Section.

It is expected any revival of activity and/or registration will be detected through one informant who is a CP member in Williamsport, one PSI who is logical for rerecruitment; through neighborhood sources previously developed on past members; through fisurs; through coverage of District-level CP plans and reports at Philadelphia, plus coverage of District plans and reports through [redacted] who has recently been briefed.

#### Bucks County Section

This Section is composed of 2 clubs. [redacted] who lives in Trenton, N. J., claims to be [redacted]

[redacted] of Bucks County, Pa., and 3 counties in New Jersey. If he gives accurate information, his interest in Pennsylvania apparently is centered in the U. S. Steel Plant, Fairless Hills, Pa., (Lower Bucks County). He has given varying and apparently incompatible figures regarding "membership" in U. S. Steel concentration, once claiming 22 and another time claiming 35. Extensive efforts to identify the alleged steel concentration "membership" located only 5 CP members employed at U. S. Steel. These 5 are not known to be assigned to a CP club in Bucks County.

It is believed Philadelphia knows all the officers and members of 1 club totaling 11 members which meets regularly with 13 other people who are sympathizers and may be considered as members or prospects for recruitment. This club holds semi-social gatherings including these sympathizers, in lieu of regular CP club meetings.

The second club is alleged by [redacted] to exist, but no specific information is known regarding its structure, membership, or activity. 5 CP members recently moved into Bucks County from other areas and their present CP club assignment is not yet known.

Future plans include 1 informant who is a CP member in 1 club; 2 persons who are prospects for recruitment into the second club, including 1 informant who is a specific prospect of [redacted] through continued fisurs; through continued delving into employment records at U. S. Steel Corporation; through trash covers; through plans for anonymous sources; and through increase of neighborhood sources.

#### Lehigh Valley Section

There has been no activity in this area since [redacted] [redacted] and ranking member of the Section testified in 5/54 at the Philadelphia Smith Act Trial. [redacted] has testified many times thereafter at Congressional hearings and has publicized the names of nearly all members of this Section resulting in loss of jobs to some and public stigma to others. Some members moved from the area entirely to escape

notoriety. Testimony of [ ] was followed by Congressional subpoenas to many persons named by him.

The CP planned to reactivate this Section in late 1955 and some tentative steps were taken, but as of 12/55, the Section Organizer, pro-tem, told an informant that he had been unable to organize activity of even a single CP group and had received permission from the CP to move his family back to Philadelphia. Dues have not been collected and there has been no indication that the 1956 registration has begun.

[ ] recently advised that he was told by the District Organizer that he (the District Organizer) had visited the Lehigh Valley area, but made no claim regarding any kind of reactivation. One such visit was made to meet with PH informant.

As of the time [ ] all members of this Section were known and 4 informants were members of this Section. In the light of subsequent inactivity and fear, only a handful are known to consider themselves as still being CP members. More detailed, current membership information must await renewed CP activity and registration.

Future information is expected to be derived from the 2 informants who are members of this Section, supported by fisurs and other logical investigation, when indications of reactivation are received from local informants, Philadelphia sources receiving plans and reports of District Functionaries, and [ ]

#### Anthracite Section

This section has had no local leadership for many years and not even visits from District Officials in the past few years. District Officials recently admitted they had no idea of membership and no contacts in this area. They avowed their intention to reactivate it and claimed to have started reactivation in 4 cities in the Anthracite Section. Philadelphia has no substantiation for this and no information that any person is currently registered in the CP.

Philadelphia has conducted an extensive Interview Program throughout the area for the past few years with a high degree of success and cooperation. This program has probably been instrumental in cutting off CP activity. In the past few months, in contemplation of the revival of the CP, cooperative persons who were formerly CP members have been recontacted and alerted to possible CP activity and re-registration. Fisurs on former local leaders have been conducted and other sources alerted to any new "Daily Worker" activity or readers. Neighborhood contacts have been alerted. Contacts have been made with Pennsylvania State Police and local police departments for any signs of renewed activity. All these efforts have been completely negative to date.

Future plans include continuation of the contacts already made to receive any signs of actual revival of activity in the area.

#### Southeastern Pennsylvania Section

The Section Organizer is known, but the Section is not known to have any other functioning officers. This Section covers a rather wide area which has been broken down as follows:

##### York, Pa.

1 club with 5 members on which exact information on all the officers and members is known.

##### Reading, Pa.

3 clubs composed of 14 members; officers unknown; members probably all known.

##### Harrisburg, Pa.

1 club containing 8 members as of 1954. Present setup unknown. Each of the 8 1954 members is believed to be known.

##### Lancaster, Pa.

1 club with 3 members, 1 of whom is known and the 2 additional are believed known.

In 1954, the CP records showed 7 members from whom no dues were being collected. These 7 members are not known to have been formally affiliated with clubs and are not known to have been controlled by the CP in recent years; of these, 3 are believed known, with 4 unknown.

There has been constant activity only by the York Club. Reading is known to have been totally inactive, but is now making tentative efforts to revive activity. The extent of activity of the Harrisburg and Lancaster Clubs is not known.

Extensive interviews, especially in the past 2 years, in Harrisburg and Lancaster is believed to have probably discouraged activity. In 1954, [redacted]

[redacted] and testified at the Philadelphia Smith Act Trial. He later appeared before a Congressional Committee and named many members in his part of Southeastern Pennsylvania. This stopped the meetings of the Reading Clubs at least.

Future plans include 2 informants who are in the CP; logical fisurs; further expansion of neighborhood sources; and additional interviews as logical.

Wilmington, Dela., Section

This Section, while attached to the CP, EPD, is investigated by the Baltimore Office. As set out at the beginning of this letter, this Section has a total of 14 members as reported 1/10/56 by [redacted] and [redacted]

Otherwise, according to [ ] they might not reach that point by Christmas and then would lose about 15 days because of the Christmas holidays. [ ] replied that that was what they planned to do and they hoped to reach 80% by 11/7/55. 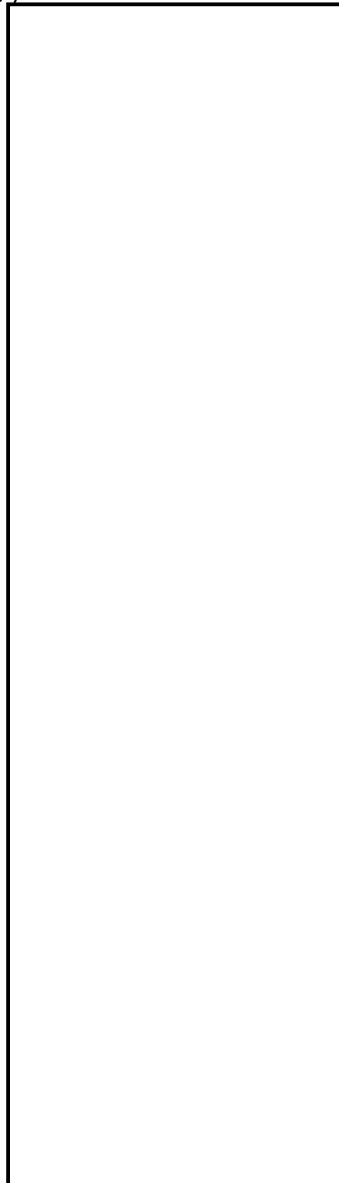

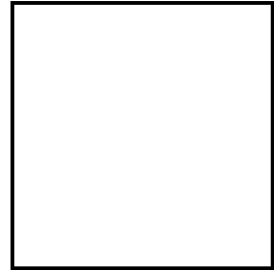

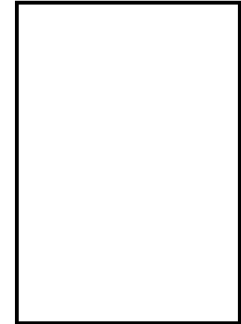

Recontacting Former Communist  
Party Members

The Communist Party leadership in every Party district has been told to make up a list of the membership of the Communist Party for the past seven or eight years. They are to make inquiries of every unit and every contact, in order to re-locate members who were lost because a lack of frequent contact or who just dropped away from the Communist Party.

CG 5824-S learned that the Party has already prepared a list of close to 3,500 names of people in New York City whom they plan to contact and, if possible, bring back to the Communist Party. Similar lists are being prepared in Chicago, Cleveland, Detroit and other large cities throughout the United States.

In addition, an effort will be made to go back into the smaller cities in several states in order to re-establish contacts in those communities which were neglected during the period when a large portion of the Communist Party leadership was operating in the underground.

Dues and Registration

CG 5824-S stated that PHIL BART told him that the registration is progressing better than was originally anticipated. He stated that while they do not have exact registration figures for the country as a whole, that the dues payments to the present time have gone up to 150,000, and they are expected to reach a figure in the 160,000's by the middle of January.

BART stated that since dues payments around registration time represent 80% of the membership, this is an advance in comparison to last year and certainly is an advance of the goal originally set for the registration.

CG 5824-S pointed out that dues payments in the Communist Party are divided on the basis of twelve monthly payments to obtain an average, and that by using BART's percentage, an estimated total membership figure can be obtained.

CG 5824-S also learned that the Communist Party plans to reduce the number of persons who are members-at-large. Every individual will be expected to be assigned to a club except those who are in very strategic positions. These persons, for security reasons, may remain members-at-large but must be in contact with someone from the Party. The reasons for assigning as many members as possible to clubs are: first, to retain discipline; and second, to be able to collect dues and other funds which the Party needs from day to day.

NY 1474-S\* advised that on 11/8/55, [redacted] at New York State CP Headquarters, took up organizational questions as a follow up to a conference which had been held previously. He said he had gone to a Brooklyn staff meeting and [redacted] (believed to be [redacted]) had had him there to make a report. He said that when the discussion opened [redacted] (believed to be [redacted]) had spoken and offered some rambling comments. She had stated that there were a lot of people unattached, very fine and wonderful people and she had been going around picking these people up and putting them into the Party, putting them into the mass movement. She had said that there was no system of organization that we know of which does that. She had also made the point that it was true that "we" need more than functioning clubs.

[redacted] said that some of the comrades raised the question of what happens to the rest of the Party, what do we do, and how do we function. He mentioned in particular a woman named [redacted] (phonetic) who asked these questions in connection with the working class community.

[redacted] also stated that [redacted] (believed to be [redacted]) had spoken (at this Brooklyn staff meeting) and after him [redacted] (believed to be [redacted]) had spoken and mainly had treated industrial problems and had made some good contributions which had nothing to do with the specific question "here." According to [redacted], [redacted] (believed to be [redacted]) had spoken and been very critical. [redacted] added that she had been that way for some time and it was not because of any peculiar problem which had arisen with regard to her being on or off the board. He mentioned that some elements of our ward were being caught off guard by the passage of the Communist control law. Some had gotten panicky and requested that the campaign be called off with the result that "we floundered and aren't we once again floundering?" He added that [redacted] report provided no answers.

[redacted] then stated that he had spoken. He said that they have been brought down to 22 sections and that is what they will remain - 22 sections. He raised a question

dealing with what they could do to accelerate them. He wondered whether there was anyone here or there capable of giving district leadership to 22 sections. At this point, according to the informant, [redacted] had stated that they did not. [redacted] continuing, asked how they could bring the County into close proximity to the State if they were going to operate on the basis of 22 sections. He said that there seemed to be an area of difference there and to go beyond Brooklyn, for a moment, he thought they would find something like that in Queens.

[redacted] then asked if [redacted] had spoken and [redacted] replied that he had not. [redacted] told [redacted] that [redacted] was of the impression that for some time Brooklyn would have to operate with no less than 22 sections. [redacted] then spoke of the differences in Queens and Brooklyn and added that they should get a committee together consisting of himself and [redacted] to meet with the Brooklyn staff or part of the staff and work out specifics and get away from the general. In addition to himself and [redacted] [redacted] proposed three people from the Brooklyn staff claiming that they did not need the whole staff. He mentioned that [redacted] (believed to be [redacted]), [redacted] and [redacted] Also to handle this follow up on the organizational discussion (apparently in Queens) he mentioned [redacted] (believed to be [redacted]) and [redacted] together with himself and [redacted]

[redacted] then stated that activity was developing on the Jewish Israel question and the TILL question. He added that they were beginning now to open up the press and then there was this open discussion on the organization. He said, in addition, that GEORGE (believed to be GEORGE CHARNEY) had suggested that they hold somekind of a functionary meeting on Israel. [redacted] stated that he did not know how he was going to fit it in. He said that the previous night they had had a Section Organizers meeting and on the next Monday (presumably 11/14/55) they were to have a city wide Section Organizers' meeting on TILL. On the following Monday (presumably 11/21/55) and for three consecutive Mondays, Brooklyn was to have a Section Organizers' meeting. He said that on that following Monday (presumably 11/21/55) they were to have a meeting of the Section Organizers' on the registration. He said that they had a [redacted] (believed to be [redacted]) mass meeting coming up in Brooklyn on 12/1/55. He said that Manhattan had a [redacted] mass meeting scheduled for the 18th and the Bronx had one for the 11th. He said he would have to call a meeting of the Section Organizers.

Identification of all CP members in the area covered by the NYO has not been effected. The most recent information available, obtained on 11/3,4/55 through NY 1637-S\*, reflected that a statement for the first eight months of 1955 covering a district-by-district breakdown of registration figures, dues, assessments and recruits was in the possession of PHILIP BART and his wife, [redacted]

PHILIP BART was identified by NY 694-S on 6/3/55 as National Organizational Secretary of the CP USA. [redacted] was, from 1951 to 1955, a National CP functionary in the underground. It may be noted too that at a CP conference in August, 1955, PHIL BART discussed registration and dues matters, indicating that he was attempting to compile such data to determine the standing of the CP in such matters.

The above-mentioned statement discloses, with reference to the entire New York district, that an actual registration of 10,381 was achieved in 1954 but no figure, only a question mark, appears for 1955, with the percentage of registration for 1955 also noted with a question mark. Forty recruits for 1955 were indicated.

Other contact with NY 1637-S\*, having access to material in the possession of the BARTS, has not supplied further membership data.

Contacts with NY 1317-S\*, having access to the records of the CP USA and New York State CP at 268 Seventh Avenue, NYC, has not furnished further information as to current membership of the CP.

[redacted] a source having access to material in the possession of CHARLES DIRBA, who apparently does auditing work for the CP, has revealed a compilation of membership registration data for New York County, disclosing a registration as of 12/8/55 of 2,299 members. However, no names were available, this being in line with CP practice of assembling data on members without recording names.

It is believed that the program outlined in NY letter of 11/9/55, noted above, affords the most logical course for securing membership figures and identification of CP members in the area of the NYO, as well as revealing the organizational structure of the CP. This program currently is being intensively followed. Further investigation concerning the identities of the 2,299 registered members mentioned above will be conducted to ascertain their identities as much as possible. Investigation will also continue to obtain additional data, such as was received from [redacted] in an attempt to develop the registration records of the CP in the NY Office area.

COMMUNIST PARTY MEMBERSHIP IN DISTRICT TWO

Current membership of the Communist Party in District 2, covering all of New York State, is estimated at 11,000.

The estimate of the number of Communist Party members within that area of District 2 covered by the New York Division is 10,626.

T-12, on September 28, 1955, made available a copy of a Communist Party registration tabulation sheet prepared for use in a New York City county.

This sheet indicates that membership data to be secured as to each member was to cover the following items:

Age  
Section  
Length of time in the Party  
Occupation  
Employment in light industry, the building trades, machinist, heavy industry or other  
Trade Union  
National Origin  
Miscellaneous organizations of which a member

Information was also sought as to whether or not the member registered was a regular reader of the "Daily Worker" and "The Worker".

The sheet was also to be noted with the information as to whether or not the club in which the member registered as a member was meeting regularly.

T-1 has reported on October 6, 1955 that on that date [redacted] stated that the Party had not had a registration for two years and that a meeting of the Board

of the New York State Communist Party was meeting the following week in order to alert a greater section of the leadership to the registration campaign and to spread the campaign out in the Party. [redacted] declared that there was to be a fight for every single Party member that could be gotten.

T-18, on October 13, 1955, advised that a draft of a memorandum entitled "For a Full-Scale Registration, Sept. 1 to Dec. 31, 1955" had been prepared for consideration by CHARLES DIRBA.

T-11, on December 22, 1955, indicated that CHARLES DIRBA was an accountant for the Communist Party and was being compensated for his services in such capacity.

This memorandum on registration set out goals of 40% by September 30th, 80% by November 8th, Election Day, and 100% by December 31, 1955. Special club meetings for discussion of the registration campaign were to be held between September 12th and 30th and every member was to receive a copy of a letter prepared by the New York State Committee of the Communist Party, for use as a discussion guide along with a National Committee statement on the subject of registration, that statement having been published in "The Worker" of August 7, 1955.

Success in registration was seen in the light of the situation prevailing after the Geneva Conference and members were to be urged not only to increase the Party's numerical strength but to strengthen every member's political and organizational ties with the Party and also improve the functioning of clubs.

Everything possible was to be done to register all members, special attention being paid to those on the verge of dropping out and those whose organizational ties with the Party had been very weak. Such members were to be strengthened by discussion and involved in such activities as work in mass organizations in order to prevent discouragement and indifference and also secure the attendance of such members at club meetings.

Every member was to be placed in industry as far as possible or in a mass organization.

The Party member conducting registration activities was told to reach and regain all possible former members who had been lost because of the past atmosphere of "witch hunts and intimidation" as well as those whose loss was due to organizational failure. It was noted that the Party had been too rigid and mechanical in dropping all who had received treatment by psychoanalysts rather than deciding each case on its merits.

Those whose transfers had not been effected in a long time were to be picked up for the collection of dues and registration and a new transfer prepared.

It was also stated that the registration forms provided were to be filled out from the bottom up in order that the data on those registered might be cut off and turned in, with the remaining top part to be used for further registration, continuing the use of such form from the bottom.

Communist Party membership in District 2, all of New York State, is currently estimated at eleven thousand members.

That area of the district covered by the New York Office is estimated to have 10,626 members. Membership in the rest of District 2, the areas covered by the Albany and Buffalo Offices has been estimated by those offices to total 374.

The Albany Office, by letter dated December 30, 1955, has advised of a estimated 168 Communist Party members in the area of District 2 covered by that office.

The Buffalo Office, by letter dated December 29, 1955, has advised of its estimated 206 members of the Communist Party in the area covered by that office.

The foregoing estimate of eleven thousand members of the Communist Party in District 2 is based in part on information made available by T-10 on November 3 and 4, 1955. The informant on those dates made available a statement of registration, dues and assessments covering the period January 1st to August 31, 1955. This statement was in the possession of PHIL BART.

On April 5, 1955, T-2 advised that BART was then in charge of the organizational and financial operations of the Communist Party, USA, and on June 3, 1955, this informant advised that BART continued to be National Organizational Secretary of the Communist Party, USA.

A copy of the statement made available by T-10 reflects a district breakdown of registration figures apparently for 1954 and 1955 as well as dues payments received, Party recruits, and returns on the 1954 and 1955 assessments.

In this statement, the New York district is indicated to have had as of 1954, 10,381 members but the uncertainty of this figure is indicated in the statement by a question mark. No figure is indicated for 1955, only a question mark is noted. A question mark is also indicated in the column headed "R%", evidently denoting registration accomplishment. In the column in the statement indicating recruits, the figure 40 appears.

The estimate of eleven thousand is also based on the information set out in referenced report in support of the estimate made for inclusion in that report.

T-1 has reported that on September 22, 1955, [ ] made the statement that the Party had not had a registration for two years and that the matter was a problem. [ ] observed that there had always been a dispute about the members registered even when the Party maintained "meticulous record". [ ] further said that there had always been discrepancies in the figures, and said that the state and the counties should have figures while sections and clubs must have names.

[ ] also said that he could not remember any registration that had been completed in six weeks or two months and said that the difficult part of registration was the final 20% made up of people who had moved and whom the Party was unable to find. [ ] remarked that the number mounted up into the hundreds.

[ ] suggested that the Party follow the method used in organizing its fund drive, that is, setting a quota of names for the different comrades to register.

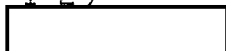

NY 1474-S\* advised that on 11/1/55, BERNIE FRIEDLAND was in discussion with [redacted] (believed to be [redacted]) at NY State CP Headquarters. [redacted] stated that he had had a staff meeting at 11:30 a.m. that day and BERNIE asked him if he knew anything concerning the railroad meeting that night. According to the informant, [redacted] made no reply to this question. [redacted] asked BERNIE how well he knew [redacted] (phonetic) and his wife because the wife was sick, having had a stomach operation and was in the Long Island Jewish Hospital. BERNIE said that he would call or send her a card.

He said the problem was that the unions were objecting to the Daily's reporting of labor matters because the unions felt that it looked too much as if they were only giving information to the Daily. BERNIE stated that it had been agreed that a corps of industry correspondents would be established with the result that the Daily would not be considered the mouthpiece of the rank and file but

Communist Party, USA planning removal of offices in January, 1956 from 268 7th Avenue to 575 6th Avenue, NYC, in building of Jefferson School of Social Science. CP reported on 12/8/55, to be preparing re-establishment of its leadership, with addition of some leaders, now in secondary capacity, to National Committee. EUGENE DENNIS and CLAUDE LIGHTFOOT reported on 12/15/55 to be leaders in reorganization. Holding of CP National Convention, on or about 2/12/56, contemplated, but postponement until after decision by Supreme Court on registration of CP under McCarran Act, among other factors, being considered. National Organization Department, on 9/29/55, asserted registration of "lost souls" is national concentration point to put end to constant shrinkage of CP membership. Financial statement of CP, USA 1/1/55, to 9/30/55, reflects receipts of \$158,756.18 and disbursements of \$143,313.15. Informant reported on 8/13 and 9/16 and 27/55 that "The Worker" was being distributed to those "afraid" by being stamped "sample copy" and sending it by cover letter signed "A Friend." T-17, on November 18, 1955, made available a copy of a letter dated September 29, 1955 prepared by the National Organization Department of the Communist Party concerning the matter of transfers. This letter stated that all transfers of members would have to contain at least all of the following information:

1. Name and address of transferee.
2. Code for use of the local area to be used for effecting recognition upon contact with the transferee.
3. A political characterization of the transferee.
4. His standing with reference to his dues.

The communication further stated with respect to dues and registration that the Organization Department desired breakdowns of dues receipts for the years 1954 and 1955. This was desired in order to enable that department to work out national dues totals and averages. The department also desired the breakdowns of registration information for 1953 and 1954 and <sup>an</sup> analysis of these breakdowns as soon as possible in addition to information obtained in the course of the current registration.

The letter of the department asserted that registration of "lost souls" was to be a national concentration point in order to put an end to the constant shrinkage of the Party membership.

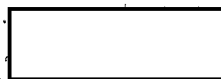

NY 1474-S\* advised that on 11/28/55, GEORGE KIRSCHNER and [redacted] at NY State CP Headquarters, discussed Negro registration in Brooklyn. GEORGE stated that the registration had been made by regions and not by sections and he had a breakdown of the Negro membership up until three or four weeks previously. He said that the total registration to date was 79 and [redacted] supplied the fact that that was Negro registration on a county wide basis of which approximately two thirds were veterans. [redacted] stated that the point in issue was whether or not [redacted] would know how much of his membership was Negro. [redacted] decided that he would not know how many more Negroes he had beyond the 41 he had on the total list.

GEORGE stated that he thought that [redacted] had in excess of 19 more than were registered in 1953. [redacted] then asked GEORGE who was working with the Bedford registration and GEORGE replied that it was [redacted] (believed to be [redacted]).

[redacted] then told KIRSCHNER that "we" had met with three counties already and were meeting with Brooklyn on the next day (presumably 11/29/55) at [redacted] (PH) (it is believed that the name might possibly be [redacted] and might refer to [redacted]).

During the course of the discussion, according to the informant, a blackboard was apparently used but the following information was developed: that the Negro membership which had been registered was far below the membership which had previously been registered in both the Bronx and Harlem, although this was not on a county wide basis but referred to Harlem and Prospect. [redacted] stated that they were going to end up with a dangerously low membership in the sense that it would be far lower than what they had. [redacted] also stated that Corona had reached 93% of its registration and had very little more to go.

[redacted] also told KIRSCHNER that they would go over reorganization and re-registration on Tuesday (presumably 12/6/55).

Later that same afternoon, according to the informant, [redacted] discussed the literature set up and stated that they had had one [redacted] (PH) come into the district to handle literature and this was an unusual circumstance. He said that the reason they were not making any big demand in regard to him was because they hoped they could get someone else of the caliber of [redacted] who would be politically able to go some place with their literature, and not just to handle it technically as far as distribution was concerned. As regards the distribution end of the literature question, [redacted] remarked that Brooklyn had a different kind of a bookshop, and the Bronx had what he considered an ideal kind of set up which cost them nothing and in which the Party organization knew there was a place to go on one, two, or three nights a week where bundles of literature could be picked up.

Letter to SAC, New York

The informant advised that Communist Party (CP) leadership in every Party district have been told to make up a list of the membership of the CP for the past seven or eight years. They are to make inquiries of every unit and every contact in order to relocate members who were lost because of a lack of frequent contact or who just dropped away from the CP.

CG 5824-S\* learned that the Party has already prepared a list of close to 3,500 names of people in New York City whom ~~it~~ plans to contact and, if possible, bring back to the CP. Similar lists are apparently being prepared in Chicago, Cleveland, Detroit and other large cities throughout the United States.

In addition, an effort will be made to go back into the smaller cities in several states in order to re-establish contacts in those communities which were neglected during the period when a large portion of the CP leadership was operating in the underground.

All offices should be especially alert to the possibility of gaining access to such a list as mentioned above, and thereafter employ full utilization of its contents to effectively increase all aspects of our coverage of the CP, USA.

The informant also learned that the CP plans to reduce the number of persons who are members-at-large. Every individual will be expected to be assigned to a club except those in very strategic positions. These persons, for security reasons, may remain members-at-large but must be in contact with someone from the Party. The reasons for assigning as many members as possible to clubs are: first, to retain discipline; and second, to be able to collect dues and other funds which the Party needs from day to day.

Letter to SAC, New York

By Bureau letter to SAC, New York, and all offices dated October 10, 1955, captioned "Communist Party, USA, Organization; Internal Security - C," and again by Bureau letter to SAC, New York, copies all offices, dated December 9, 1955, captioned "Communist Party, USA, Membership; Internal Security - C," it was pointed out that the Bureau desires each office following identification of the various clubs and their functionaries to further intensify its investigations until every member of each club is identified. In keeping with the information set forth herein from CG 5824-S\* relating to the enrollment of practically all Party members in clubs, it is believed essential to again point out that it is fundamental that each office should gear its investigations to insure complete identification of each Party member assigned to a club. It is also fundamental that in absence of other means, investigations leading to this complete identification can be activated through discreet coverage of leading functionaries in your district noting their contact with lesser Party luminaries, subsequently covering these lesser figures, and so forth down the line until each active Party member is known to your office. The Bureau will closely follow your efforts and results in this regard.

In addition to the above, [redacted] advised on January 19, 1956, that [redacted] Organizational [redacted] of the Queens County CP, had reported that the current CP registration will end on February 8, 1956. Only those who are traveling or those who otherwise cannot be reached will be allowed to register after February 8, 1956. Those who are refusing to register at this time and still persist after the February 8, 1956, deadline will be dropped from the Party.

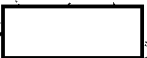

BU 185-S\* reported that on 1/31/56, a conversation took place in Buffalo, New York, between IRVING GOFF, the Organizer of the Upstate County Organization of the New York State CP, and JOHN FRANCIS NOTO, the Buffalo Smith Act Subject who is presently out on bail awaiting trial. BU 185-S\* stated that during a portion of the conversation IRVING GOFF said "when you fight on your own homeland, (it is) better than in a colonial war such as in Indo-China..... the French Communists did everything such as desert, shoot their officers etc." GOFF continued by saying "if I was in Korea I would say the hell with fighting, I want to go home and live. This is a political war and I don't want to fight for politicians."

BU 185-S\* reported that NOTO remarked that he read the biography of Prime Minister NEHRU of India. NOTO referring to NEHRU, said "he is a Marxist." GOFF said that he knew that NEHRU was a Socialist, but NOTO said "No, he is a Marxist."

Later during the conversation GOFF remarked that he wished "the Party could develop today like it did in 1928 and 1930 from nothing to a big force overnight..... the 25,000 would become a million today, etc. and they would be there when you needed them."

BART told CG 5824-S that he had been told by MANNY BLUM that the current number of registered Communist Party members in Indiana exclusive of Lake County is 60. BART also stated that he learned from BLUM that there is a good possibility of registering another 20 or so members and that eventually the number of registered members in Indiana exclusive of Lake County may reach a maximum of 90.

BART also told CG 5824-S that the Party is dissatisfied with the work of MANNY BLUM in Indiana, and stated that possibilities exist for the growth of the Communist Party in Indiana South of Indianapolis in such cities as Richmond, Anderson and Muncie.

Wisconsin District Secretariat advised that they have registered 160 members and expect to register an additional twenty members. The figure of 160 members equals the registration figure for 1954. In 1954 there was only one Negro Communist Party member registered in Wisconsin; however, at the present time there are twelve Negro Communist Party members in Wisconsin.

CG 5824-S learned that the Wisconsin Communist Party District has two divisions in Milwaukee. One of these divisions is a community division and has 57 registered members. The other division is an industrial division and there are 23 registered members in this division. There are also ten members-at-large in Milwaukee, for a total membership in Milwaukee of ninety.

CG 5824-S also learned that the remaining seventy registered members in Wisconsin are outside of the city of Milwaukee, and the following partial figures were given:

There are fourteen registered members in Madison, with the expectation that one more individual will be registered in Madison. There are seven registered members in Racine, with the registration in Racine completed. There are four registered members in Kenosha, with a possibility that one or two more members may be registered.

CG 5824-S advised that BART told the three members of the Wisconsin District Secretariat that efforts should be made to stop the recent national trend of decline in Communist Party membership. Efforts should be made to build the Party at least to a limited extent; however, no pressure will be put on the District by the National Office in this regard and there will be no extensive national drive for new members.

During this meeting, a discussion arose over the current tour being made by JOE NORTH, correspondent for the "Daily Worker", who is speaking on WILLIAM Z. FOSTER. The members of the Milwaukee District Secretariat stated that they would prefer organizing a meeting in Milwaukee, as a sort of celebration of FOSTER's birthday, which would be limited to Communist Party members, thus would be a closed meeting rather than the semi-public type of meeting at which NORTH usually speaks. Members of the Milwaukee Secretariat want to have a leading member of the Party cadre speak at this meeting and take up inner-Party problems, and they feel that NORTH is not capable of speaking at this type of meeting. They stated that they were willing to sacrifice a semi-public meeting, if necessary, in order to hold this Party meeting.

CG 5824-S stated that BART agreed that the Wisconsin District could organize a Party meeting and would not have to have JOE NORTH in Milwaukee for a speech.
