My dear Mrs. Arnold:

Your very kind letter of the 18th of Dec. received today. I have assembled the data you sent me, which I have never had all new to me, and am returning a copy, in typewritten form, for I may not have gotten all the various names spelled correctly as they are new to me.

I note you had only 5 children listed under John McNeal of the American Revolution (1745-1825) and seemed to be under the impression that I descended from John McNeal a son of Abraham McNeal who went "west" and whose descendants are unknown to you and me.

Its quite the contrary, I descend from John McNeal, Jr. a son of John McNeal the 1st. and a brother to Abraham, Isaac, Jacob, Miriam, Nancy and Martha, one of the brothers and sons which you do not seem to have listed.

It may be possible that "our" John McNeal is not a son of "your John" but may be from an entirely different group of McNeals of that part of Virginia; but it has always been our understanding that "our" John (of the War of 1812) was the a descendent of John and Martha Davis McNeal.

Pending the clearing up of that point, I am sending you a list of the McNeal descendants of "our" John of 1776-1814. We are now checking this data with the D.A.R. library files in Washington, D.C. as well as with the son and daughters of the War of 1812. It has been our understanding that "our" John was buried in the McNeal graveyard at Hillsboro, W. Va. after his death in 1814 and before his fathers death (1825).

You will note on page 3 of the data on "our" descendants, I have put a check after the name of Mrs. Phelps of Oklahoma City, Okla. It has been my understanding that she has checked this matter with the D.A.R. some 20 years ago and found that we descend from John and Martha Davis McNeal. I have wrote her a letter on this matter 4 or 5 years ago, but never got an answer to it. If you can determine whether she belongs to the D.A.R. thru the McNeals it may solve this point about John McNeal (1776-1814).

Always feel free to write me on any of these matters at any time, for I assure you it is indeed a pleasure to come in contact with a person so anxious to help as you have been, and to say that I appreciate the favors you have shown me, is expressing it very mildly.

I shall write to Mr. Calvin Price, the editor of the Pocahontas Times at Marlinton, W. Va. to see if he can locate a volume of The History of Pocahontas Co. by Rev. Wm. Price, which I can borrow and thereby familiarize myself with the McNeals of that part of the country in a more fitting manner.

Dear Mr. McNeill:

I thank you so much for yours of the 12th in reply to my "blindfold" inquiry of Sept. 18. You not only answered each direct inquiry, but added interesting points and incidents, so well related that I am moved to ask for a "second helping".

First of all, however, I beg to present my respects to your good father, John P. McNeill, Jr., now in his 75th year. He is my uncle by 14 years. I truly hope he enjoys a good health.

In all probability you know your ancestral line back to 1725—a good, long line of 8 or 9 generations, perhaps. While I do not need them in fine detail, such as dates of births, marriages and deaths, it would help us to know the approximate birth-ages. It would also help us to know the heads (maiden names) of the wives of the first two or three line-holders.

Here in brief is what I can get up: My great great grandfather Thomas McNeill was, according to family tradition, born in Ireland about 1747. The year of his coming to this land (or Pa.) is not known, but we know that he married a widow, of the name, Mrs. Mary Hughes, daughter of William Hughes, in the predecessor of Hampshire, in 1768. The Hugheses are also said to have come from Wales. I have lately reached the conclusion that Thomas McNeill was a miner at the time of migration, and that suggests that his parents likely migrated at the same time. However, I know of no McNeill tradition that mentions Thomas' parents. Thomas and Mary had six children, the first, Jonathan, born in 1769, and the second, Mary (my great grandmother), born in 1771. Price, in his Hist. of Pocahontas Co., states that Thomas McNeill came into Pocahontas from Green Springs in 1768-70. Price definitely re-stated the prevailing McNeill tradition on that point. Joshua S. Buckley, of Marlinton, a gt. gt. gt. grandson of Thom., challenges the old tradition, and believes that Thomas did not move to the Greenbrier valley until soon after the revolution. He also doubts that Thomas McNeill was born in Wales. A John McNeill (McNeill) settled on Little Levels (Poca. Co.) in 1765, and his descendants say he was born in 1745. He, also, was from the Gapon country, and married one Martha Davis of that region. Some say Thomas and John were brothers, some say they were cousins, and others say they were not related.

Buckley knows about your South Branch McNeill, and he is of the opinion, I believe, that our Greenbrier Thomas came from South Branch. Mr. Ida V. McNeill Gilman, Ontario, Calif., McNeill family historian, says that Thomas McNeill was a Rev. war soldier under George Rogers Clark, and the latter told us that Clark raised a company of two thousand in your country. That led further support to Buckley's theory that our Thomas joined Clark from early on. The idea has also been advanced that some ancestor, founder of Little Levels settlement, was also related to the South Branch McNeill. None or less has been said in writings about Col. John McNeill, and about John McNeill, neither of which titles fit John of Little Levels, although he was one of Captain John Clark's men at

BY - LAWS

WEST VIRGINIA

GOOD GOVERNMENT ASSOCIATION

(An association registered under the laws of the
State of West Virginia)

Name

The name of this Association shall be "West
Virginia Good Government Association".

Purpose

The purpose of this Association is to secure the
bona fide support by citizens of the following pledge, and
to pursue all lawful and proper means to accomplish the ob-
jects therein stated:

"BELIEVING that eternal vigilance is the price of
liberty; that democracy can survive only in the event
that the whole people take an active interest in their
political affairs; that in the course of time people
get no better government than they deserve; that poli-
tical service may be as patriotic and as necessary as
military service; that government by small minorities
is contrary to the principles upon which our government
is founded; that there should be elected to public of-
fice only people of character and ability who are de-
voted to the preservation of democracy; that these ends
may be accomplished only by an aroused public interest
and the participation in politics by all of the people --

"WE PLEDGE OURSELVES to keep informed about govern-
mental affairs, to vote at all elections, to vote in the
manner dictated by our conscience, and to urge others to
do likewise."

Membership
