15 Plaintiffs' Application for Leave to File Documents Under Seal came before  
16 this Court for consideration. After full consideration of the matter, this Court finds  
17 as follows:

18 Exhibit 21 (Bates Nos. CITY 7087-7096) to the Declaration of Kurt Franklin  
19 in Support of Plaintiffs' Opposition to the City of Palos Verdes Estates and Chief  
20 Kepley's Motion for Summary Judgment ("Franklin Declaration") is not a  
21 confidential document in that it does not contain sensitive material. The Court  
22 therefore rejects the City's designation of "Confidential" and orders this document  
23 be filed publicly.

24 Exhibit 15 to the Franklin Declaration (Defendant Alan Johnston's Cell Phone  
25 Record Detail) contains the private information of Defendant Johnston and third  
26 parties and therefore is a confidential document containing sensitive material. The  
27 Court therefore orders that this document be filed under seal.

28 IT IS THEREFORE ORDERED that Plaintiffs' Application to File

1 Documents Under Seal is GRANTED IN PART AND DENIED IN PART.

2 Plaintiffs are ordered to file Exhibit 21 publicly and Exhibit 15 under seal.
