Result of examination:

It was determined that the specimen K2 typewriter which was used to prepare specimen K1 was also used to prepare questioned typewritten impressions on specimens Q1 through Q8, Q12 and Q13 in this case and the typewritten impressions on specimens Q1 through Q4 in the case whose title includes "COMMITTEE OF VIGILANCE" and various Congressman. The "COMMITTEE OF VIGILANCE" case has Bureau File #9-67866.

An examination of the original copy of the photocopy specimen Qc11 would probably indicate that the typewritten impressions on this specimen were prepared using the specimen K2 typewriter.

The specimen K2 typewriter was not used in the preparation of specimens Qc9 and Qc10.

Specimens Q8, Q12 and Q13 appear to be ordinary United States Postal Service postcards. No indented writing or other marks of value which could indicate the immediate source of these specimens were noted.

No significant indented writing, watermarks or other marks of value which could indicate the immediate source of specimens Qc9 and Qcl0 were noted.

The result of the requested psycholinguistic examination of specimens Ql2 and Ql3 will be the subject of a separate report.

The disposition of specimens Q8, Qc9, Qcl0, Ql2 and Ql3 and the result of the requested latent fingerprint examinations of these specimens will be reported separately.

Specimens Qcl1 and K1 are returned herewith.

Photographs of specimens Q8 through Ql3 and K1 are retained.

The specimen K2 typewriter will be returned at a later date.

It could not be definitely determined if the typewriter used to prepare specimen K1 was or was not used to prepare questioned typewriting on the previously submitted specimens Q1 through Q7 and on specimens Q8, Qc11 and Q12 because possible identifying defects cannot be discerned.

However, the typewritten impressions on the aforementioned questioned specimens and on specimen K1 all have horizontal spacing of 251.5 (100 characters occupy 251.5 millimeters of horizontal space). This horizontal spacing and the accompanying coding of the questioned and known typewriting is extremely unusual and is included neither in Federal Bureau of Investigation Typewriter Standards nor in Interpol Typewriter Standards. Additionally, the aforementioned questioned and known typewritten impressions are all of the same style.

A more definite determination would require the submission of the specimen K1 typewriter to the Laboratory for examination.

The specimen K1 typewriter was not used in the preparation of specimens Qc9 and Qcl0.

The information in the first three paragraphs above applies regarding typewritten impressions on specimens Q1 through Q4 in the Bureau case whose title includes, "THE COMMITTEE OF VIGILANCE" and various Congressman. This case has Bureau File #9-67866.
