[redacted] resided in Chicago for ten years and during that time became good friends with ROSTENKOWSKI. Over the years they have remained friends and socialized together. On numerous occasions they have played golf together. [redacted] related that he has never contributed to ROSTENKOWSKI's campaign efforts.

Since 1978 [redacted] has received a variety of gifts from ROSTENKOWSKI. He has received calenders, golf shirts, gourmet popcorn and a black chair in the past. [redacted] stated that he received the black chair from ROSTENKOWSKI in December of 1990. He believed it to be a Christmas gift. Subject: PERSONNEL MATTER

On 1/4/94, the Photographic Laboratory of FBI Headquarters completed an extremely large photo production project relating to the "PLATE BLOCK" investigation (58C-WF-180673) (C-9). This project, which proved to be the second largest photo production project in the history of the Photo Lab, yielded a total of 25,500 photographs which were printed from negatives which were subpoenaed in the aforementioned matter.

It was necessary that Lab make two copies of each of the photos which were printed from the subpoenaed negatives. Due to the manner in which the Lab performed this task, the two sets of prints were not provided in separate sets. The duplicate photos were provided consecutively, grouped and labeled according to the particular batch of negatives which was printed.

As the United States Attorneys Office for the District of Columbia needed these photos for the purpose of providing them to the Federal Grand Jury hearing this case, there became an urgent need to separate these photos and create two complete, accurately labeled sets of photographs, one to be provided to the Grand Jury and the other to be retained in FBI evidence.

A request was made to FS [redacted] on 1/4/95 for assistance in this matter. FS [redacted] expeditiously organized a support team to deal with this task which began working on this project the next morning. 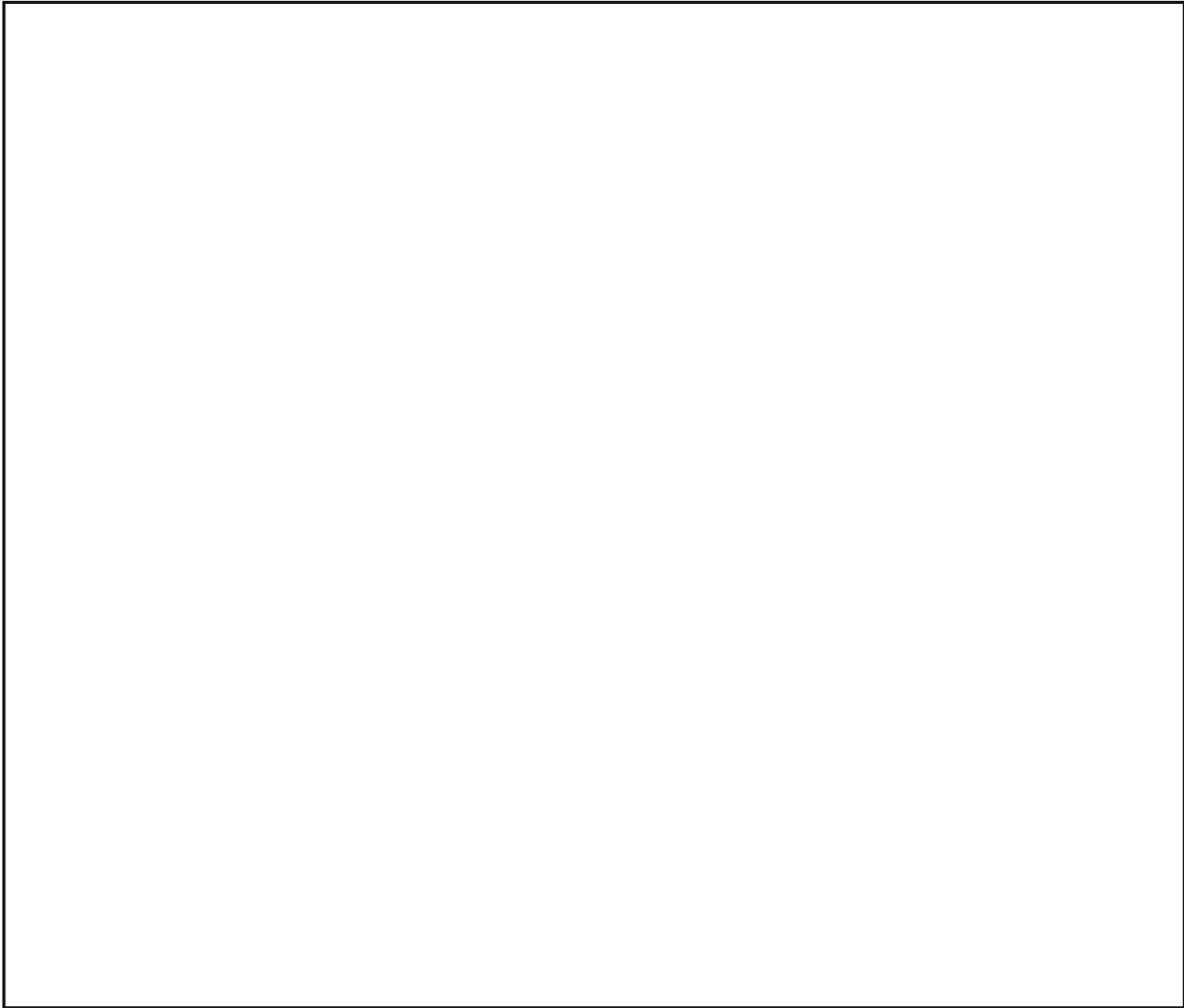

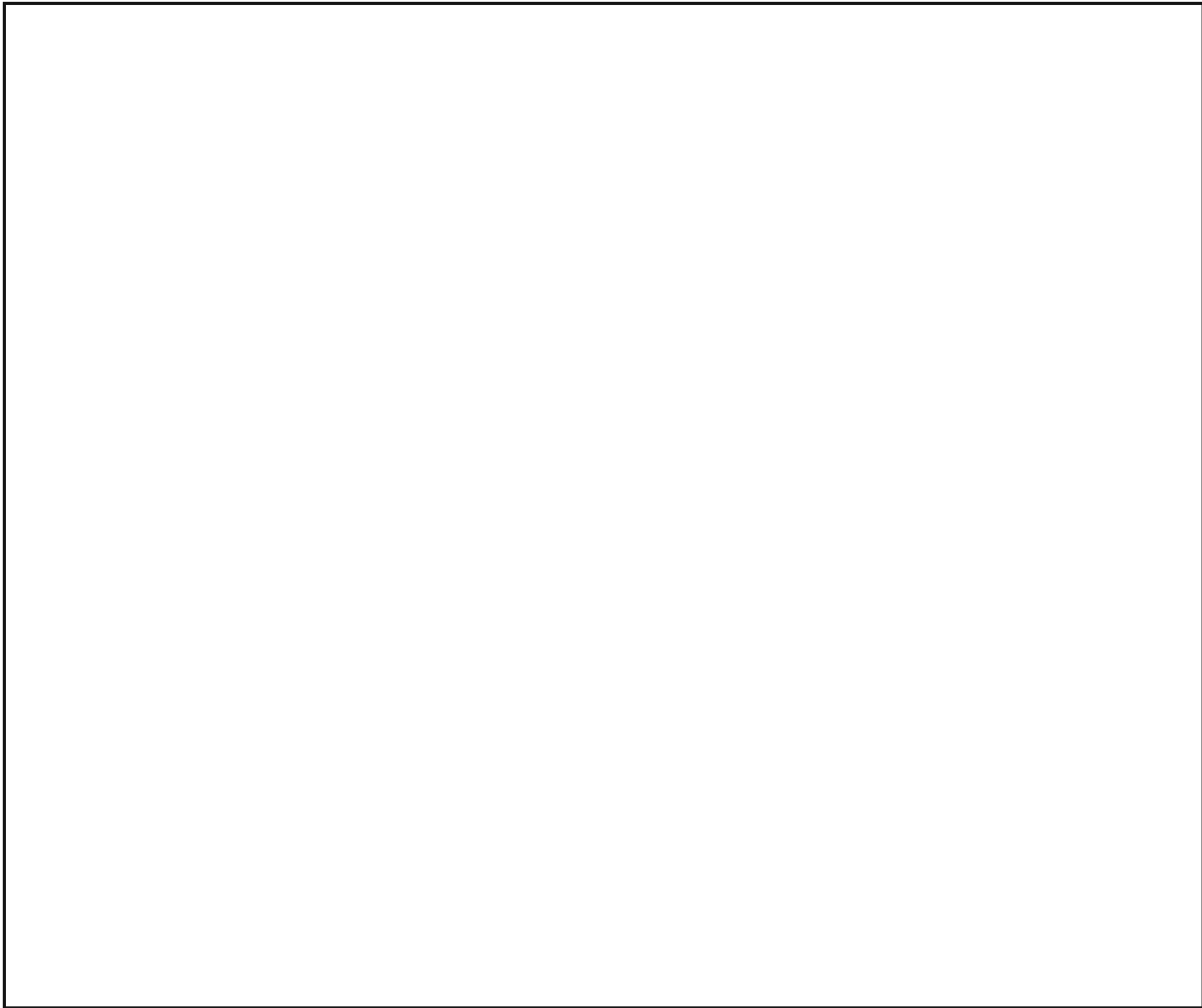

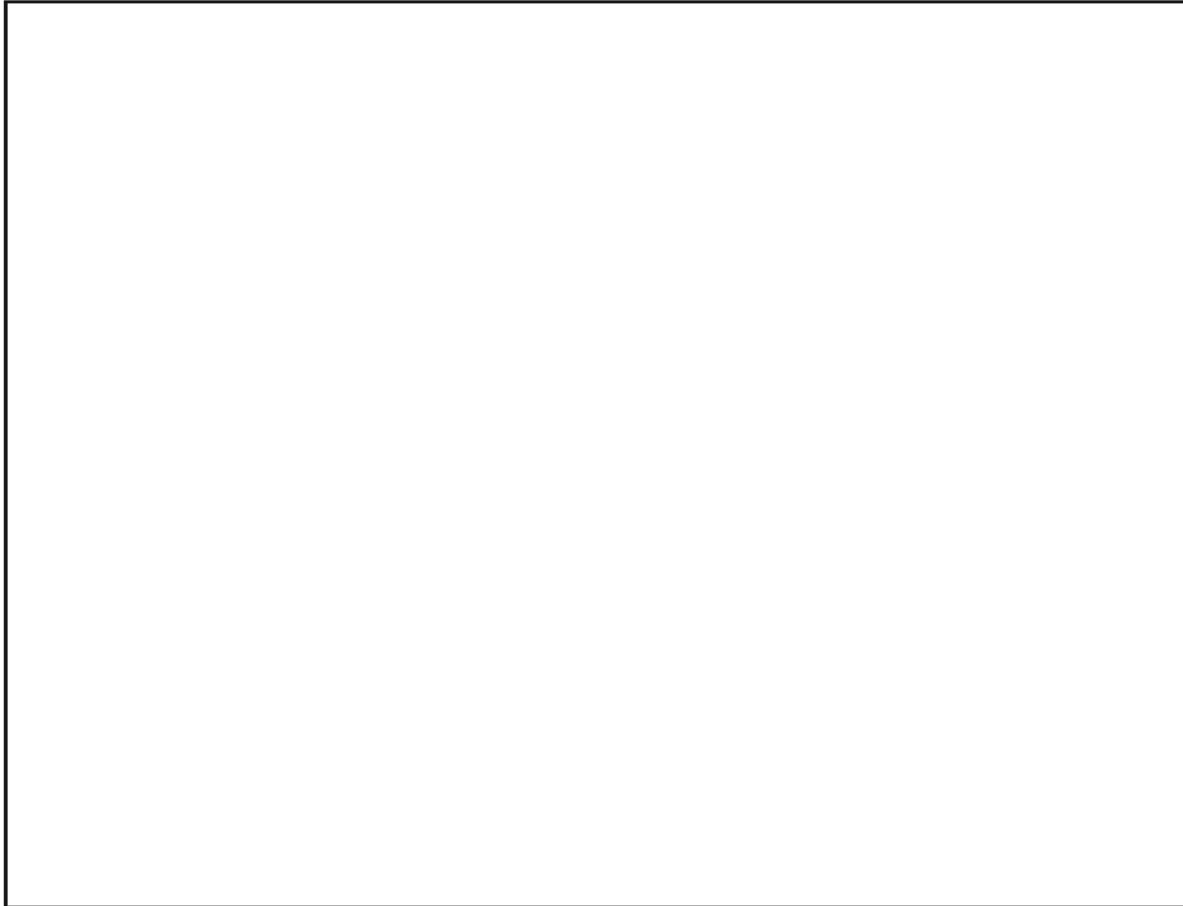

Enclosed with this communication is one Federal Grand Jury subpoena.

For the information of the Philadelphia Division, Plate Block is the code name of the investigation which includes, among others, Rep. DAN ROSTENKOWSKI of Illinois.

Investigation into this matter currently includes purchases made by ROSTENKOWSKI at the U.S. House of Representatives Office Supply Store (OSS) in Washington, D.C. These purchases under investigation are items obtained from the OSS, allegedly for official use, which actually were personal items that were kept by ROSTENKOWSKI or given by him as gifts to other individuals. These items were paid for by U.S. Treasury funds and include decorative, inscribed House of Representatives chairs, crystal sculptures of miniature U.S. Capitols, fine dining china, expensive luggage and glassware. ROSTENKOWSKI purchased in excess of \$50,000 in goods from the OSS for himself or as gifts.

The United States Attorney for the District of Columbia (USA) has requested that an attempt be made to locate

as many of these gift items as possible and that the recipients of the gifts be interviewed as to the circumstances of their receipt of these gifts. The USA has also requested that these interviews be conducted as soon as possible.

Investigation into this matter has developed numerous names of persons who are close friends and associates of ROSTENKOWSKI. Interviews conducted, to date, have had a high level of success in locating these gift items. The person associated with this particular lead, [REDACTED]

Capitols, fine dining china, expensive luggage, glassware and other items. ROSTENKOWSKI purchased in excess of \$50,000 in goods from the OSS for himself or as gifts.

The United States Attorney for the District of Columbia (USA) has requested that an attempt be made to locate as many of these gift items as possible and that the recipients of the gifts be interviewed as to the circumstances of their receipt of these gifts. The USA has also requested that these interviews be conducted as soon as possible.

Investigation into this matter has developed numerous names of persons who are close friends and associates of ROSTENKOWSKI. Interviews conducted, to date, have had a high level of success in locating these gift items. The names associated with this particular lead are persons who have hosted or sponsored ROSTENKOWSKI fundraisers, receptions or other political events that benefitted ROSTENKOWSKI. It is anticipated that, although no specific information exists that these persons received any of the aforementioned gifts from ROSTENKOWSKI, these interviews will also locate additional gift items purchased through the OSS.

It is requested that these people be located and thoroughly interviewed regarding their receiving the aforementioned items or any other items from ROSTENKOWSKI. The addresses provided to receiving offices are the most recent available employment addresses of these persons. These individuals should be interviewed regarding their relationship with ROSTENKOWSKI and should the person have received one or more of the aforementioned items, all details of why they received the gift as well as how and when the gift was received should be obtained. All correspondence regarding these gifts, if available, should also be obtained. All substantial items, other than calendars or other inconsequential items, should be photographed.

Additionally, the enclosed subpoenas which call for the production of certain items should be served on the individuals. Generally, all items except the congressional chairs should be obtained from the individual, receipts provided, entered into evidence and returned to OO. It is anticipated that these items obtained will eventually be returned. If items are discovered which are not the aforementioned items, OO should be notified as to the nature of the gifts and instructions will be provided as to whether these items should be receipted and taken into evidence.

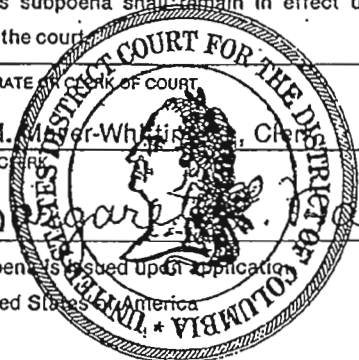

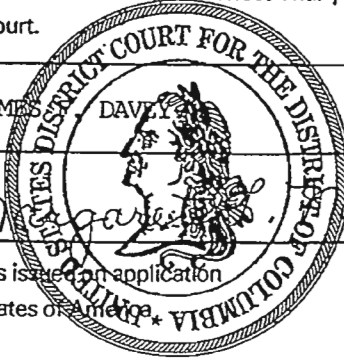
