Interview with Betty Jean Hawkins--continued from page one....

Two other white male teenagers stood out in Miss Hawkins mind and were described as follows:  
White Male teen approximate age 19, tall, blond hair, thin build, first name Billy believed to have lived off Shepherd around Pinemont. Possibly graduated from Ragan or Waldrip High School.

White Male teen first name Leroy N.O.D.

Miss Hawkins last saw Corll alive on July 29 1973. At that time she accompanied Corll to his fathers bay house up at Sam Rayburn Lake. Present at the bay home on that date were Corll, Miss Hawkins, and Corll's Father and step-mother.

Miss Hawkins had previously visited the bay home on Rayburn in June 1973 when she and Corll and Miss Hawkins children spent a few days at the lake. On neither occasion did Miss Hawkins note anything out of the ordinary in regards to the house or the area surrounding it.

Miss Hawkins last spoke to Corll by telephone on August 5, 1973 when Corll called her residence in reference to moving Miss Hawkins to her brothers trailer off of Kurkendahl Road. They talked briefly and agreed to move her possessions on August 9th.

Miss Hawkins further stated that she has only been in the residence at 2020 Lamar on three occasions and that at no time did she note anything unusual or suspicious. On two of the occasions Corll's parents were present and on the other occasion Brooks, Henley and possibly some other unknown W M teenagers were present.

According to Miss Hawkins Corll has lived numerous places since she has known him. In fact he has moved so many times that it would be impossible to recall all of the different locations. To the best of her knowledge she could recall him living at the following places:

1. 22nd Street just west of Shepherd.
2. Unknown street in the Heights.
3. Westcott Apartments around Westcott and Washington. (lived with David Brooks)
4. Off Westheimer, unknown apt. or street.
5. Off Hiram Clark Road.
6. Princess Apts. 1555 West Rd. Apt #63. (lived with David Brooks)
