REPORT ON THE RENEWAL OF THE CASINO HOTEL ALCOHOLIC

BEVERAGE LICENSE FOR TRUMP MARINA ASSOCIATES, L.P. D/B/A

TRUMP MARINA HOTEL CASINO (PRN 3390202)

On June 23, 1999, the Casino Control Commission (Commission) renewed Trump Castle Associates, L.P. d/b/a Trump Marina Hotel Casino's (Trump Marina) Casino Hotel Alcoholic Beverage (CHAB) license through March 31, 2003. The casino licensee's name was changed to Trump Marina Associates, L.P. in April 2003.

The above referenced petition, filed on December 5, 2002 and amended April 4, 2003, asks the Commission to renew Trump Marina's casino license and CHAB license through June 30, 2007. The Commission, on March 12, 2003, approved an extension of Trump Marina's casino and CHAB licenses to the earlier of the Commission's final disposition of the license proceedings or June 30, 2003 to allow Trump Marina's license renewal hearing to be consolidated with the license renewal hearings of Trump

Taj Mahal Associates d/b/a Trump Taj Mahal Casino Resort (Taj Mahal) and Trump Plaza Associates d/b/a Trump Plaza Hotel and Casino (Trump Plaza).

Although this petition makes no reference to the Trump licensees' CHAB Cooperative Purchasing Permit, PRN 3390203, filed in connection with the renewal of Taj Mahal's CHAB license, asks the Commission to renew the Trump properties' CHAB Cooperative Purchasing Permit through June 30, 2007, and a revised Cooperative Purchase Agreement for Alcoholic Beverages was submitted on April 1, 2003 that removes Trump Casino Services, LLC as a party to the cooperative purchasing agreement.

Additionally, by letter dated June 4, 2003, the Division of Gaming Enforcement (Division) indicated that it has no objection to the renewal of Trump Marina's CHAB license and the renewal of the Trump licensees' CHAB Cooperative Purchasing Permit through which Trump Marina purchases alcoholic beverages with Taj Mahal and Trump Plaza. A copy of the Division's letter is attached.

Staff recommends that the Commission renew the Trump Marina's CHAB license to continue the casino licensee's authorization to sell, dispense, serve, consume, and/or store alcoholic beverages in, on or about the locations identified on the attached listing (Exhibit A). If approved, the renewal term for the CHAB license will run concurrently with the renewal term of the Trump Marina's casino license. Staff also recommends that the Commission approve the April 1, 2003 Cooperative Purchase Agreement for Alcoholic Beverages and issue a CHAB Cooperative Purchasing Permit that runs concurrently with the Trump licensees' CHAB licenses. A copy of the Cooperative Purchase Agreement for Alcoholic Beverages is attached as Exhibit B.

## COOPERATIVE PURCHASE AGREEMENT FOR ALCOHOLIC BEVERAGES

Trump Marina Associates, L.P., whose address is Huron Avenue and Brigantine Boulevard, Atlantic City, New Jersey (hereinafter "TMA"); Trump Taj Mahal Associates, whose address is 1000 Boardwalk, Atlantic City, New Jersey (hereinafter "TTMA"); and Trump Plaza Associates, whose address is Mississippi Avenue and Boardwalk, Atlantic City New Jersey (hereinafter "TPA"), herein on this \_\_\_\_\_ day of April, 2003, enter into the following agreement for the purpose of purchasing and transporting alcoholic beverages.

WHEREAS, TMA, TTMA AND TPA are the holders of Casino Hotel Alcoholic Beverage (CHAB) licenses, said licenses having been issued to TMA, TTMA and TPA by the New Jersey Casino Control Commission;

WHEREAS, said Casino Hotel Alcoholic Beverage licenses permit the retail sale and consumption of alcoholic beverages on the respective premises operated by TMA, TTMA and TPA;

WHEREAS, TMA, TTMA AND TPA is desirous of entering into an agreement to enable them to purchase alcoholic beverages as a cooperative;

WHEREAS, it is the intention of TMA, TTMA and TPA to purchase said alcoholic beverages as a cooperative (the "Co-op") and to arrange for the delivery of said alcoholic beverages to their respective loading docks located at TMA, TTMA and TPA or, in the alternative, to store said beverages in a licensed warehouse and to transport said beverages under the storage and transportation licenses presently issued to TMA, TTMA and TPA, said licenses having been granted by the New Jersey Division of Alcoholic Beverage Control;

WHEREAS, it is the intention of TMA, TTMA and TPA to administer said Cooperative Purchase Agreement in accordance with the provisions of N.J.S.A. 5:12-1, et seq; N.J.S.A. 33:1-1, et seq.; N.J.A.C. 13:2-26.1, et seq.; and N.J.A.C. 19:50-1.1, et seq.

TMA, TTMA and TPA hereby agree as follows:

- 1. TTMA shall purchase all alcoholic beverages intended for consumption upon the licensed premises respectively owned by TMA, TTMA and TPA. However, nothing in this Agreement shall prevent either TMA, TTMA or TPA from purchasing alcoholic beverages individually through an appropriate food and beverage buyer pursuant to approved internal controls.
- 2. When it is determined by any of the licensees that a purchase is to be made from a licensed New Jersey wholesaler, TTMA shall order and arrange for the delivery of said alcoholic beverages on behalf of the licensee(s).

- 3. Payment for all alcoholic beverages ordered in the manner set forth in paragraph 2 shall be in accordance with the internal control procedures as submitted to and approved by the Casino Control Commission. Payments to wholesalers shall be made by TTMA based on the invoices provided.
- 4. Any alcoholic beverages purchased pursuant to this agreement may be stored at the licensed liquor warehouse owned by TPA and located at Canale Drive, Egg Harbor Township, New Jersey, or at the respective hotel casino premises of the parties. If stored at the Canale Drive Warehouse, alcoholic beverage inventories for each member of the Co-op will remain segregated at all times.
- 5. All transportation of alcoholic beverages purchased pursuant to this agreement shall be transported in vehicles licensed to and operated by TMA, TTMA or TPA pursuant to the appropriate permits issued by the New Jersey Division of Alcoholic Beverage Control and in accordance with the applicable regulations of that agency (N.J.A.C. 13:2-20.2, et seq.).
- 6. All alcoholic beverages purchased pursuant to this agreement shall be physically segregated or delivered individually to each licensee's loading dock. Said separation or individual delivery shall be such that the alcoholic beverages shall be separately invoiced and designed either for TMA, TTMA or TPA and shall remain completely segregated upon and until delivery to each licensed facility. Under no circumstances shall there be co-mingling of inventory of the licensees.
- 7. It is understood and agreed between and among TMA, TTMA and TPA that any purchase or transfer in violation of the alcoholic beverage statutes and regulations committed by any member of the Co-op shall be a violation by all members of the Co-op.
- 8. This Agreement shall remain in effect indefinitely as long as TMA, TTMA and/or TPA remain CHAB licensees and as long as approved by the Casino Control Commission or until terminated by mutual agreement or until thirty (30) days after any party gives written notice to the others that it will withdraw from this Agreement. No termination or withdrawal shall be effective until written notice thereof shall be given to the New Jersey Casino Control Commission.

9. No amendment to this Agreement shall be in force or effect until such amendment is first approved by the New Jersey Casino Control Commission.



#### Dear Chair Kassekert:

The Division of Gaming Enforcement is in receipt of the above captioned petition ("Petition") filed on December 5, 2002 with the Casino Control Commission ("Commission") on behalf of Trump Marina Associates, L.P. ("Trump Marina"), a casino licensee, for the renewal of its Casino Hotel Alcoholic Beverage (CHAB) license. The Petition also requested the renewal of its casino license. Please accept this letter as the Division's response to Trump Marina's request to renew its CHAB license only.

Since the last renewal of Trump Marina's CHAB license on June 23, 1999, the Division has conducted periodic audits of the licensee to determine compliance with the applicable statutes and regulations pertaining to holders of a CHAB license, specifically the provisions of *N.J.S.A.* 33-1 et seq., *N.J.A.C.* 19:50-1 et seq. and *N.J.A.C.* 13:2-1 et seq. Based upon the reviews of the Division during that period, the Division found the licensee to be in general compliance with infrequent, relatively minor incidents of non-compliance. The licensee was advised of those incidents with the licensee correcting the deficiencies.

In consideration of the prior regulatory history of Trump Marina in regard to its compliance with the requirements attendant to its CHAB license, the Division has no objection to the renewal of Trump Marina's CHAB license.

In addition, the Division has no objection to the renewal of the Trump licensees' Cooperative Purchasing Permit, through which Trump Marina purchases alcoholic beverages with Trump Taj Mahal Associates and Trump Plaza Associates.

#### **APPLICANT**

1. TCA, a New Jersey limited partnership, is the owner and operator of Trump Marina Hotel Casino and is the holder of a casino license and CHAB License initially issued by the Commission on June 14, 1985 and most recently renewed in June, 1999 for the period through May 31, 2003. The current partners of TCA and their respective ownership interests are: Trump Hotels & Casino Resorts Holdings, L.P., ("Trump Holdings"), a Delaware limited partnership, which holds a 99% general partnership interest and Trump's Castle Hotel & Casino, Inc. ("TCHC"), a New Jersey Corporation which holds a 1% interest. TCHC is a wholly-owned subsidiary of Trump

Holdings, through which Trump Holdings indirectly holds the remaining 1% interest in TCA. TCHC is the issuer of the presently outstanding \$5 million aggregate principal amount 10 1/4% Series B Senior Secured Notes Working Capital Notes.

2. TCA is also the holder of a Casino Hotel Alcoholic Beverage ("CHAB") license initially issued and thereafter renewed by the Commission contemporaneously with the initial issuance and each renewal of its casino license (See Commission Resolution No. 99-13-24-B.

### RELATED ENTITIES

- 3. Trump's Castle Funding, Inc. ("TCFI"), a New Jersey corporation, is wholly-owned by TCA. TCFI is a qualified financial source and entity qualifier of TCA. The sole business activity of TCFI is to raise funds through the issuance of its securities, as nominee for TCA, and to lend the proceeds to TCA in exchange for promissory notes. TCFI is the issuer of the presently outstanding \$242.1 million of aggregate principal amount 11 3/4% Mortgage Notes ("Mortgage Notes"), and \$62 million of aggregate principal amount 10 1/4% of Series B Senior Notes ("Senior Notes") and \$92.5 million of aggregate principal amount 13 7/8% subordinated increasing rate Pay-in-Kind Notes ("PIK Notes").
- 4. THCRI is a publicly-traded Delaware corporation, a qualified holding company of TCA, and is the sole general partner of Trump Holdings, directly and through THCR/LP Corporation holding an approximate 63% interest therein.
- 5. THCR/LP Corporation, a New Jersey corporation is a qualified holding company of TCA, and is a limited partner of Trump Holdings, holding an approximate

3% interest therein. THCR/LP is wholly-owned by THCR Holding Corp., a qualified holding company of TCA, and which is a wholly-owned subsidiary of THCRI.

- 6. Trump Casinos, Inc. ("TCI") is wholly-owned by DJT, is a qualified holding company of TCA, and is a limited partner of Trump Holdings, holding an approximate 4% interest therein.
- 7. TCI-II is wholly-owned by DJT, is a qualified holding company of TCA, and is a limited partner of Trump Holdings, holding an approximate 6% interest therein.
- 8. DJT is a natural-person qualifier of TCA, and is a limited partner of Trump Holdings, directly and through TCI and TCI-II holding an approximate 37% interest therein.

### LICENSE RENEWAL

- 9. A completed application for renewal of the TCA casino license is being timely filed with the Commission including submission of the appropriate Business Entity Disclosure Form for the casino licensee.
- 10. TCA will provide the Commission and Division of Gaming Enforcement with such further information as required.
- Pursuant to <u>N.J.S.A.</u> 5:12-88, TCA seeks renewal of its casino license and CHAB License for the four year period through June 30, 2003, a date co-terminus with the license term of Trump Plaza Associates.
- 12. Pursuant to <u>N.J.S.A.</u> 5:12-103 and <u>N.J.A.C.</u> 19:50-1.3(d), TCA also seeks renewal of its CHAB license for a term coterminous with that of its casino license.

WHEREFORE, Petitioner TCA respectfully requests that the Commission:

- a. renew its casino license for the period through June 30, 2007; and
- b. renew its CHAB license for the period through June 30, 2007.


