I, *Fred Trump*, a NATURALIZED AND LOYAL CITIZEN OF THE UNITED STATES, hereby apply to the Department of State, at Washington, for a passport for myself, accompanied by *my wife and baby* as follows: *Elizabeth Trump*, born at *Hallstadt, Germany*, on the *10* day of *October*, 18*85*; and *baby Elizabeth Two months old*.

I solemnly swear that I was born at *Hallstadt, Germany* on or about the *14* day of *March*, 18*69*; that I emigrated to the United States, sailing on board the *S.S. Eiden*, from *Bremen* on or about the *15* day of *October*, 18*85*; that I resided *18* years, uninterruptedly, in the United States, from *1885* to *1904*, at *Seattle, Wash. D.C.* that I was naturalized as a citizen of the United States before the *Superior* Court of *British Columbia*, at *Seattle*, on the *27* day of *October*, 18*92*, as shown by the accompanying Certificate of Naturalization; that I am the IDENTICAL PERSON described in said Certificate; that I am domiciled in the United States, my permanent residence being at *New York*, in the State of *New York*, where I follow the occupation of *Hotelkeeper*; that I am about to go abroad temporarily; and that I intend to return to the United States *within a year*, with the purpose of residing and performing the duties of citizenship therein.

Further, I do solemnly swear that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; and that I take this obligation freely, without any mental reservation or purpose of evasion: SO HELP ME GOD.
