1. Reference is made to my memorandum report dated August 14, 1968, case file number as above, subject: Interview of Louis DOUHERET conducted on August 8, 1968, at the Federal Penitentiary, Atlanta, Georgia, in which I reported the offer of cooperation made by DOUHERET and his conditions for such a cooperation.

2. On August 9, 1968, Customs Agent Albert W. Seeley and I briefed Acting District Supervisor Bernard A. Theisen Jr., Acting Enforcement Assistant George R. Halpin, Assistant U.S. Attorney Andrew Lawler, Customs Agent Edward T. Coyne, Group Leader, Joseph Dino, Narcotic Agents Thomas J. Dugan and Norris Durham on the results of the interviews conducted at the Federal Penitentiary, Atlanta, Georgia, on August 6,7,8, 1968, particularly, the interview of DOUHERET.

3. It was subsequently decided that DOUHERET's full cooperation is desirable in that this cooperation will lead to the development of a far reaching conspiracy involving Joseph ORSINI, Fernand ORSINI, Arnold ROMANO, Dominick ROMANO, Frank CAMPANA and others.

4. On August 15, 1968, Assistant U.S. Attorney Andrew Lawler and I conferred with Assistant U.S. Attorney William Tendy, in charge of the narcotics section at the Office of the District Attorney, SDNY. Mr. Tendy concurred with the decision made to utilize DOUHERET's testimony in the development of a conspiracy. Mr. Tendy, therefore, decided to make arrangements for DOUHERET's transfer to a different penitentiary, in order to insure his security. Mr. Tendy further decided, that, without making any promises as to the ultimate result, he would eventually initiate steps to have DOUHERET's sentence reconsidered by the proper authority. Mr. Tendy authorized me to inform DOUHERET of the decision reached.

5. On August 19, 1968, Customs Agent Seeley and I, while at the Federal Penitentiary, Atlanta, Georgia, on another matter, interviewed DOUHERET who reiterated his offer to cooperate and requested a

conference with Assistant U.S. Attorney Tendy as evidenced by the brief message he wrote to Mr. Tendy (see attached photocopy and translation). I then advised DOUHERET that his offer to cooperate had been found acceptable and that he could expect a transfer to another penitentiary sometime towards the end of September, 1968.

6. In view of this development, steps are now being taken to transfer DOUHERET to the Southern District of New York under adequate security precautions in order to fully exploit his offer of cooperation.
