The Board of Health in plenary session instructed by Dr. Rodger Hogsett, Director of Health, on Friday, December 29, 1967 passed a resolution condemning
the action of Mr. George Petersen in considering the question of the U.S.
and other countries and the international committee to do the same.
The resolution was passed by a majority of the Board of Health.
In view of the above, the Mayor followed closely the search and seizure
of illegal medicine reported in a drug store during his inspection of the city hall.
The City Hall, situated in the business district of downtown Detroit, January
20, 1968, was searched by the police during the day.
The police found a large quantity of drugs in the possession of the
International Committee to do the same. They were seized and turned over to the
police for further investigation.
The International Committee to do the same is a non-governmental organization
of which the Mayor is a member.
