General Manager's Update

I hope this newsletter finds you well. We had a very informative look back at the origins of the Neighborhood Council system on Saturday with the Board of Neighborhood Commissioners' founders panel of Greg Nelson, Jerry Gaines and Raphael Sonenshein. If you weren't able to make it, we recorded the event. You can watch it and track the <u>Plan review process here</u>. I'm looking forward to working with the Commission and Neighborhood Councils for the next 4 months to create a better Plan for all of us.

I'm happy to report that the City Clerk and the Department have come up with a proposal to join efforts to administer the 2014 Neighborhood Council elections. The election process and procedures will be similar to how we ran the elections in 2012, and the City Clerk will use their talents for the back office function of candidate filing, ballot printing, vote-by-mail processing, polling supplies management and post election survey compilation.

This great partnership will allow the Department to work with the Independent Election Administrators to focus on citywide and local election outreach and election day execution. We'll be laying out the details in our post election report to Education and Neighborhood Committee this month as well as requesting a change in the election ordinance to give


