Give your name, how many years you have lived in Westchester, Playa del Rey or your area, make your statement, and "try not to repeat previous speakers"

Suggested one minute comments (pick one):

1. Moving runway 260 feet north permanently moves noise contour closer to homes, business, schools and churches and newly impacts over 13,000 residents in Westchester / Playa del Rey, Inglewood and South Los Angeles.

2. Moving the runway to the north violates the LAX Plan and LAX Specific Plan which states that aircraft noise and operations should be moved as far away from surrounding neighborhoods as possible.

3. There is strong support for the Environmentally Superior Alternative, Alternative 2 and Alternative 9. Alts 2 and 9 are supported by Council

Members Bill Rosendahl and Eric Garcetti, Maxine Waters and groups such as ARSAC, Neighborhood Council of Westchester/Playa del Rey, Westchester Vitalization Corporation and many more.

4. The existing north airfield was determined to be extremely safe in the North Airfield Safety Study and that moving the north runway could not be justified for safety purposes alone.

5. Alternatives 2 and 9 probably will not result in lawsuits which could further delay LAX modernization for another 3 years.
