Good afternoon Nate,

I wanted to update you on the Westchester Lutheran School condition compliance effort with regard to Case No. ZA-2004-3419-CU-PAD-PA2. As you aware **three6ixty** is working with the school to implement the conditions of this case that became effective on April 29<sup>th</sup>, 2013. School officials meet in late April and are moving forward to comply with the 31 conditions of approval. A Covenant & Agreement was recorded on May 24<sup>th</sup>, 2013 as required by Condition No. 31 accepting the conditions.

The school will also be working during the next year to be ready for the filing of a Plan Approval to review compliance as required by Condition No. 30. In this regard, outdoor activities along the southwest property line have been relocated east of the existing buildings. The court area will also be removed by July 1<sup>st</sup>, 2013, as required by Condition No. 7 e.

Board members and parents met this week and a Committee was formed to oversee the effort. We think it would be helpful to meet with some of the adjacent property owners that have been involved with this case in the

next few weeks to introduce ourselves, update them on this progress, hear from them, and again provide contact information so that we can establish good communication for the next school year.

Perhaps we can arrange a meeting the week of June 24-28? We can make calls/invites if needed.

On behalf of the school we very much appreciate your ongoing attention to this matter and look forward to making next school year great.
