Good Morning.

Please note that Today the item relative to the position allocation for the Special Assessment Section (BIDs program) is scheduled in the Personnel Committee. The Special Assessments Section used to have 15 positions. Currently, we have 11 positions in SAS this includes two Accounting Clerk II positions. A study recommended that only 10 positions go to Economic and Workforce Development. The 10 positions will exclude one of our current the Acctg Clk II positions required to prepare all of the accounting documents in our Financial Management System and deal with the County for the collections and appropriations of the amounts to each BID's proper account. A budget motion requested a Senior Management Analyst II position as the Director of BIDs (this position was intended for me to oversee the BID program at EWDD. However, I am currently in the Chief Management Analyst position and have requested to have the Director position listed as a Chief so that I am not taking a demotion.

The report submitted requests the Sr. MA II to go up to a Chief MA; the Sr MA I to go up to a Sr MA II (Rosemary), add an additional Management Analyst (BID Analyst), an additional Senior Clerk Typist (Billing) and an additional Accounting Clerk II (BID accounting) position for a total of 14 position. We are requesting the additional 3 positions (salary difference) to be covered by the BID trust fund.
