## Airport Permit Services

- Charter/Limos/tour buses
- Private Parking Courtesy shuttles (e.g. Wally Park and Parking Spot)
- Hotel/Motel Courtesy shuttles (e.g. DSS, Best Western)
- Schedule Service (Mickey's, Shuttle One, Ventura County Airporter)
- Airfield NELAs
- CSPP
- Airfield Motor Vehicle Permits (non-construction)

She said that they are aware of the problem and trying to work with LAWA PD to help with the problem.

LAWA staff is reluctant to meet with us because they don't have a solution that can be enforced.
