In the new year, the Hollywood Entertainment District BID will be conducting a competitive bidding process for the financial services agreement.

We are in the process of developing an RFP, which will be released toward the end of January, but in the meantime, we hope to gather some candidates (firms and individual practitioners) who may be in a position to respond to this RFP.

The entire scope of work will be bid out, including the following general task areas:

- Accounts Payabl
