MEMORANDUM FOR THE DIRECTOR:

b7c Mr. Ladd and I have checked on [redacted] file.

With reference to the Mrs. Roosevelt incident, we of course never investigated this. It was investigated by CIC prior to 1943. We do have a photostat of the G-2 file.

in the Bureau files.

✓ There were no recordings between Mrs. Roosevelt [redacted] Obviously, they did have a microphone because there were recordings of conversations [redacted] Mrs. Trudie W. Pratt which also reflected what transpired in the hotel room.

This information was given to George Burton by Colonel Kibler and Colonel Jack Bissell. It is recorded in a blue memorandum dated December 31, 1943.

|| The blue memorandum and a photostat of the G-2 file are maintained by Miss Gandy but have never been in the Files Section.

It is not believed that anyone in the Bureau has knowledge of this except Burton, Mr. Ladd, E. A. Tamm, me, and the stenographer whose initials are FIL and whose identity we are now trying to establish.

b7c It is therefore believed thoroughly safe for Mr. Tracy to tell Senator Watkins the FBI never investigated the Roosevelt- [redacted] There is nothing from official sources on this in the FBI files.

Both Mr. Ladd and I do recall there have been newspaper articles linking [redacted] Mrs. Roosevelt.

In 1949, Frank Waldrop of the Times Herald told me they were on the trail of certain recordings that allegedly would show an illicit relationship [redacted] Mrs. Roosevelt. At that time I made a thorough check of all our files and there was nothing in the main files. The pink memorandum has never been circulated in the Bureau and is not known to anyone outside of Miss Lutz in my office, Mr. Tolson, Miss Gandy, and you. Mr. Ladd was informed of my check this morning although he vaguely recalls when I was checking on this a year ago.

Marion Canty, who is Drew Pearson's secretary, left the Bureau in October, 1944. However, she would have no knowledge of this as she had been in the Washington Field Office from 1937 to 1944 when she resigned.

The photostat of the G-2 file and the blue memorandum dated December 31, 1943, are attached.

Mr. Tracy will be advised along the lines of our discussion this morning. He will also tell Watkins that Anderson's wife works in Ident but does not have access to the main files. I think, as a tactic, Tracy should get across to Watkins and Watkins should carry the point to Anderson that he had checked at the FBI and FBI files do not contain any such information. It is obvious that Anderson probably has learned of the file from G-2 sources and from the rumors which have been circulated in Washington.

THE DIRECTOR:

The thought occurs that if the President does not know of the furor that was caused in G-2 some years ago as the result of G-2's investigation of [REDACTED] his connections with Mrs. Roosevelt, you might want to consider mentioning this incident to him. *Qu*

[REDACTED] a close friend of Jimmy Wechsler and the last word I had was [REDACTED] working for the New York Post which has been exceedingly critical of the President as well as of us. Wechsler, of course, is a kingpin in the Americans for Democratic Action along with Mrs. Roosevelt [REDACTED]

The attached memorandum [REDACTED] connections with Mrs. Roosevelt along with the G-2 investigation, the subsequent confrontation with Mrs. Roosevelt and the order issued by FDR that everyone knowing of this action should be sent to the South Pacific until they were killed. The information was furnished to George Burton when he was assigned to Liaison by a Colonel Kibler and Colonel Bissell. *Qu*

This, of course, could have a relationship to the subsequent orders given the Army to destroy the files on subversives. *Qu*

We have photostats of the G-2 investigative reports on their coverage [REDACTED] there is no question [REDACTED] tie-in with Mrs. Roosevelt. G-2 files contain Mrs. Roosevelt's letters [REDACTED] invariably start with [REDACTED] and end with "All my love, ER." *Qu*

Indicative of the type of data in this file is a report dated March 7, 1943, reflecting that Mrs. Roosevelt checked into the Urbana-Lincoln Hotel, 11:45 a.m., March 5, 1943, accompanied by Malvina Thompson. She expressed the wish that no publicity be given to her arrival. At the time of her registration, she stated she expected a young friend from Chanute Field to visit her and reserved Room 330 for him. She occupied Room 332. The rooms were joined by a connecting door. At 9 o'clock on March 5, [REDACTED] at the Urbana Lincoln Hotel stating he understood Mrs. Roosevelt had a room reserved for him. He was directed to Room 330. *Qu*

Mrs. Roosevelt ordered dinner for the three sent to Room 332 at 8:30 p.m. Upon the arrival [REDACTED] Malvina Thompson had her luggage moved into the room occupied by Mrs. Roosevelt. Neither Mrs. Roosevelt nor [REDACTED]

We, the undersigned, petition the 86th Congress to eliminate the House Committee on Un-American Activities as a Standing Committee.

We believe that the U. S. Supreme Court has, in the United States vs. Watkins, made it clear that the Committee has habitually misused its mandate in unconstitutional ways for political purposes; that it has become an agency for repression; that it has usurped the functions of the executive and judicial branches of our government.

We are confident that only a return to constitutional procedures can protect us against subversion without at the same time subverting the very liberties we seek to protect.

For two decades the Congress has allowed the Committees to function. For two decades the Committee has condemned individual Americans, has wrecked the lives of some, and has denied them the due process of law that English and American courts have toilomely evolved over many centuries. Now the nation is reaping the bitter harvest:

1. The Committee has perverted, and thereby imperiled, the proper and necessary powers of the Congress to conduct investigations.
2. The Committee has helped discourage free study and inquiry in working for peace while the world is threatened with destruction.

NEW YORK, Aug. 3.—Edward W. Davenport, personal and political friend of Wendell Willkie last night denounced Gov. Thomas E. Dewey, Republican, as a presidential nominee as "a big shot" and criticized him for not repudiating Representative Fish.

Repudiation of New York earlier in Mr. Willkie's campaign for renomination.

Mr. Davenport spoke at the opening rally of the new Liberal party, which was formed when non-winning members split from the American Labor party and others, claiming the Labor party was Communist-dominated. The Liberal party has endorsed the Democratic national ticket.

"I want a President of the United States who has the courage to fight against nationalism and isolationism," Mr. Davenport said.

Repudiation came late.

"The Republican candidate had for weeks resisted all efforts to extract from him a repudiation of Fish on the Congressman's record. Only when a newspaper quoted Mr. Fish in an anti-Semitic statement did the candidate repudiate Fish and then on that ground alone."

"Did he repudiate Mr. Fish because the Congressman obstructed all attempts to prepare the United States for war? No indeed!"

Mr. Davenport declared it was no accident that Mr. Fish "followed the anti-Semitic line."

"He has founseed that line because he has been one of the leading isolationists of this country and one of the loudest nationalists in the world. And yet he is not in all these years the present Republican candidate re-

presented Mr. Fish on that same ground."

After criticizing the Democratic party for "shirking of political responsibility on the racial equality issue," Mr. Davenport said:

"But what I live in a glass house, I am a Republican."

Political Devolution.

"And I do not know of any more pertinent example of political devolution than the platform the Republican party has offered the voters of this country."

Another speaker at the rally was Louis W. Brown, former Office of Public Administration director, who said full employment should be the main objective of labor and liberals in postwar America.

Mr. Franklin D. Roosevelt, who also spoke, said:

"You know I am a great believer in organized labor. Organized labor is the great hope of liberals in the future. But organized labor must educate its own members. It is not free of racial and religious prejudice."

"If democracy is going to succeed we must have a spiritual basis on which to build. We should really believe in the brotherhood of man, not that one group should have all the good things in life and that the rest of the world have what's left over."

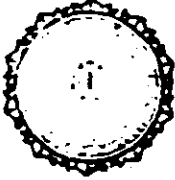

He also advised that the Commission was to have conducted an investigation regarding [REDACTED] however such an investigation was never made. It was [REDACTED] belief that the Commission had decided not to investigate in view of the Hatch Act investigation being conducted by the Bureau and that probably the Commission would send Mrs. Roosevelt a copy of the report furnished to them by the Bureau.

In a news release dated February 2, 1946, the GREEK AMERICAN COUNCIL called upon sympathetic organizations, trade unions and societies to urge the President of the United States to instruct our delegation at UNO to disassociate the United States sharply from the position of Foreign Secretary ERNEST BEVIN concerning Greece and to support the Soviet demand for the immediate withdrawal of British troops from Greece. This request was sent in the form of a letter to the President by EVASIKELIANOS, President of the Council and MICHAEL WANDELENAKIS, Secretary of the Council. The news release indicated that the Council also sent a radio-gram to ELEANOR ROOSEVELT in London requesting her to fight in the Security

Council toward a defeat of the British attempt to destroy the Greek spirit. A copy of the letter to the President is enclosed for the Bureau's information.

In a press release by the GAC issued January 22, 1946 it was stated that the COUNCIL, which represents a cross section of Greek Americans in the United States, hailed ANDREI GROMIKO's letter

on Greece to the United Nations Security Council as a "contribution to the maintenance of world peace and security". The release continued that the president and secretary of the COUNCIL cabled GROMYKO, warmly thanking him for his timely letter and the action of his great country.

It was stated that other cables were sent to the United Nations Security Council, Secretary of State JAMES F. BYRNES, and to ELEANOR ROOSEVELT endorsing GROMYKO's letter on Greece.

By reference from the Director's Office, I took a telephone call at 4:45 P. M. today from [redacted] of the State Department, who explained that he was working with Mrs. F. D. Roosevelt on United Nations matters. [redacted] stated that he had received a letter from Mrs. Roosevelt today, inclosing a communication relative to a secret organization undermining the welfare of our country. [redacted] commented that in his opinion and from his interpretation of Mrs. Roosevelt's remarks, the writer of the communication in question is probably a "crackpot." He said that Mrs. Roosevelt indicated the person may have been suffering from the strain of war, with the result that it had affected the writer's mind. However, she asked [redacted] to give the letter to someone to check, adding that if such an organization existed and was carrying on as alleged, the FBI certainly should know about it. In response to my inquiry, he stated there was no name given but that the letter was rambling and somewhat incoherent in nature. [redacted] wanted to know if the Bureau would look into the matter.

I told [redacted] that if he would refer the letter to us, we would see that it received appropriate attention.

This Bureau has conducted no investigation of _____ and our indices contain no references to her. It would appear likely that whatever investigation may have been conducted of her was handled by some branch of the War Department. This Bureau's files contain no indication of such an investigation nor of a request from any agency for information concerning _____

Mrs. Roosevelt's note suggests she may have a mistaken opinion as to this Bureau's responsibility and interest in a matter of this nature. In answering Mrs. Roosevelt, I hope you will clarify her on this point, explaining that in those instances where this Bureau does conduct investigation at the request of some other Governmental agency or furnishes information to it, under no circumstances does the Bureau make any recommendation or express an opinion concerning an individual's qualifications for any position or assignment.

A great portion of this book is based upon information gathered by the author from chatter she heard during the war years in cocktail lounges, drawing rooms, teas, luncheons, supper parties, and personal contact with some of the Members of Congress and Washington Big Wigs. She mentions in a number of places that "gossip" had it that so and so occurred. A great deal of her book, however, is an indictment of the Communist Party and showing how the "termites" worked their way into the New Deal through President Roosevelt, Eleanor Roosevelt and others close to the White House doing a great deal of damage.

April 3, 1947

In chapter XVII the author discusses Eleanor Roosevelt showing the reaction of Washington as well as other parts of the country to her various idiosyncrasies.

She mentions on page 288 Eleanor Roosevelt's close association with Joseph Lash who had been under fire for his leftist activities when he was executive secretary of the American Student Union which rigidly followed the Communist party line. She mentions that Mrs. Roosevelt invited Joseph Lash to the dinner party when the Chief Justice Harlan Fiske Stone was the ranking guest and that she singled out Lash for a seat at the table of honor. She states that Mrs. Roosevelt used her position in attempting to obtain a commission in the Intelligence Branch of either the Army or the Navy for Lash but that he was turned down by both services on the basis of his civilian activities and was subsequently drafted.

The author tells on page 290 of a visit by Mrs. Roosevelt to a new army post near Miami, Florida, where she was taken to Private Lash's barracks and that he then "to the envy of his comrades, entered General Wooten's open car and accompanied the official party on a tour of the post....Shortly after her visit Lash was ordered to Bolling Field, near Washington, before being transferred to Noumea in the South Pacific.

Other favorites of Mrs. Roosevelt's such as Melvin Douglas, his stage wife Helen Cahagan and the dancer Myriss Chaney who was given a \$4,500 a year job in the office of Civilian Defense through the efforts of Mrs. Roosevelt, are discussed in this chapter by the author.

The author indicates that Mrs. Roosevelt's "proteges invariably shaded from pink to deep red" were the subject of endless discussion in Washington and throughout the country. (page 283)

The Democratic Party in the State of Georgia was this week officially confirmed as Fascist by a Federal Court ruling. It is no longer possible for Democratic Party voters, white or black, in the State of Georgia, to secure by the ballot any representation not under the domination of the Ku Klux Klan, chartered or unchartered. The three-man court upheld the county-unit system which can throw out, by private commitment the choice of the majority of party members in any primary election. In the last primary the Negro-baiting, labor-hating Eugene Talmdge, Phi Beta Kappa's only red-suspender snapper, was declared the winner in an election in which the admitted and duly counted majority voted for his somewhat more acceptable opponent. We were never among those who sang such paeans of political praise over the fact that in that primary 'Negroes voted for the first time in Georgia', feeling that what happened both to them and their votes was more importantly the issue. Nor did we join in the chorus of acclaim that accompanied the junket of Georgia's Dan Duke to acquire for Northern consumption a few photographs of himself holding up a Klan hood (no Klansman in it!) and information which he could have got by picking up the telephone and calling the Non-Sectarian Anti-Nazi League, the Friends of Democracy, Union for Democratic Action, or even more easily by idly turning the pages of John Roy Carlson's UNDER COVER. We have very good reason to believe that Mr. Duke himself has been sprinkled with the 'sacred fluid' and that he is far more familiar with 'who's who' in Walton County than he is willing to admit. Talmdge has publicly declared that a fascist system of 'selected franchise' under the control of secret societies organized for murder, rapine and theft of the tax-payers' funds, as was proven in prosecutions which resulted in convictions of Klan leaders on all these counts, will, under his administration, be the future system of election in Georgia's Democratic party primaries. The controlling majority in Georgia's backward counties is attained by terrorist tactics, the licensing through the Klan and/or similar groups of private controls over the religious, political and social life of the residents of the State. It secures in the hands of the fascist machine perpetuity of tenure in office unless the impossible policy of seizure is undertaken. There is not the slightest political hope that a majority will vote in any Republican or other party primary not committed to the unit-vote system. With his right of franchise thus destroyed, the Georgia citizen, already inured by tradition, custom and iron discipline to the fascist program willingly will suffer the disability and this degradation of his citizenship. Nazis did not and do not 'suffer' under the yoke of their servitude. They like it. Georgians do not 'suffer' under their fascist form of government. As was publicly screamed from Atlanta over a national radio hook-up on July 23, 'We like it!'

In making its decision the all-Southern court pointed out the failure of the Electoral College to follow the popular will in the election of three Presidents, John Quincy Adams, 1824; Rutherford B. Hayes, 1876; and Benjamin Harrison, 1888; but it did not point out that there has been a movement to abolish the Electoral College on those same grounds. If such a welcome abolition movement grows, there is not a Southern state which will lend its support to any such increase of democratic preachment or practice. The danger to the nation as a whole from this decision of the Georgia case is not yet as apparent as it will become when the Southern bloc in Congress, feudal to the core in its political philosophy, ruthless in its abuse of the slightest public power, bitter and hate-filled in its viewpoint, and cruel and unjust in its every political decision, goes to work on the legislative proposals emanating from the 'alien' remainder of the United States

Subject: AMERICAN SOCIETY FOR CULTURAL RELATIONS WITH ITALY.

Summary of Information:

"He stated that POLLOCK told him "This is big political stuff. We must be careful of every move we make. We must avoid discussion of any kind, except on cultural relations, because of the FBI".

He advised that letters were sent to persons asking them whether they are interested in better cultural relations with the Italian people, and if so, to return a card which was enclosed with the letters. He said those who returned the cards were noted as sponsors. He informed us that Mr. CRANE showed him a pile of letters. One letter was from former Mayor LaGUARDIA who replied he did not think he could join right now. Another letter was from Mrs. Eleanor ROOSEVELT, who said she was too busy. When asked whether he heard the names of Edward PERKINS, Manager, American Export Line, and Charles ROSES, UNRRA Director in Italy, mentioned in any of the conferences, he replied he did not. He stated that the name of the Treasurer of subject organization Anthony CAPRANO, was mentioned, and that there was a great deal of discussion about the former Prime Minister, Ferrucci PARRI. He informed us that Frederick WOLTMAN, of the World Telegram, spoke to the Secretary to the Italian Ambassador, and was informed that the Italian Ambassador had to be at the dinner, otherwise the Italian Government would put some pressure on him. He advised that Frank SINATRA'S Manager informed WOLTMAN that the signature of SINATRA was never obtained.

Mr. De GROOT emphasized the fact that he got up three or four press releases on cultural basis and that the release gotten out by the organization on March 10, 1947, before he entered the picture was gotten up by POLLOCK.

He advised that Mr. CRANCE, who was a son of the former Ambassador to China, is at present a member of the Committee for Anglo-Soviet Friendship. He believed CRANE recently left for Italy to see his daughter.

Confirming our telephone conversation of today, I inclose herewith one copy of each of the reports heretofore received from Chanute Field.

Subject was visited during the weekend of March 12-13-14 by [REDACTED] (See Incl. No. 4).

During the weekend Subject was heard to remark to [REDACTED] that he wished that his commission would "come through" quickly. Other evidence indicates that Mrs. Roosevelt is trying to secure a commission in Military Intelligence for Subject.

General R. E. O'Neil, Commanding Officer, Chanute Field, is anxious to remove Subject from his Field and would cooperate in any way to get Subject another assignment.

Subject is a student in the Weather Forecasters' School from which he is scheduled to graduate July 2. This School is now located in Grand Rapids, Michigan, but Subject is on detached service at Chanute Field. He is subject to transfer at any time to Grand Rapids.

So far only Intelligence personnel at Chanute Field, this office, and yourself are advised of this case. I feel that the Asst. Chief of Staff, G-2, Second District, AAFTC, St. Louis, Missouri, should be advised and I will instruct the Intelligence Officer, Chanute Field so to advise such officer unless you advise me to the contrary on or before Monday, March 22. The Asst. Chief of Staff, G-2, Second District, is Lt. Colonel Fred W. Siebert, formerly Intelligence Officer at Scott Field, Illinois, who it is believed would cooperate to the fullest extent with this office in any handling of the case.

As related to you during our phone conversation, it was the first plan to arrest Subject in Champaign during the weekend of March 13-14 on a morals charge because sexual intercourse was entered into between Subject and [redacted]. However, the final decision was against this. It is expected that [redacted] will return for another visit with Subject the weekend of April 3, at which time it is believed another opportunity will be presented to arrest Subject on a morals charge. If the meeting of April 3 between Subject and [redacted] occurs in Chicago as is believed likely, such arrest could be made by the Chicago Police at the behest of this office with no complications, whatever, and in such a manner that there would be no publicity and that this office would at all times be in control of the situation. Arrest on such a morals charge would provide something concrete upon which to base disciplinary action or a transfer of Subject by authorities in Washington. Also, it might be thought advisable to give the arrest sufficient publicity that E. R. would not care to intervene in the matter.

Joe dearest,

Your letter of the 7th came this morning and your two wires are here and I feel so excited about the thought of hearing your voice. What will I do when I actually see you! I will call Wednesday as I am arriving about 7. I will promise to call when I reach Columbia for 7 P.M. your time. (Illegible) whether St. Louis is an hour earlier than here. Though it probably 8 but you are on that time. She was very pleased with your note.

I am so glad you may get to Grand Rapids early in March and if you can go before the 5th I'll go on instead of Champaign. Wm. Allister was here for lunch yesterday and was delighted when I told her you might be there and told her to tell you and (Illegible) whether no. I feel just as you do about the State Department and the North African policy but I think there will be some changes. Last night Marshall Field and Louis Weiss were here for dinner and we argued (of course I started and prolonged) till 9:40. F talked convincingly but convinced no one and Wm. Louis Thompson made an interesting and penetrating remark this morning "I think, said she, that Franklin does things often from inspiration then finds the reason to justify them." I wanted to add that he sometimes changed them and I think last night's talk had an effect. I like the Yank editorial and prayed it does represent the attitude of the soldier. F. said one most interesting thing, namely that he looked for less trouble between United States and Russia and China than between any (Illegible) Great Britain. He had said that before you remember but I was surprised to have him say it to others. Louis Weiss felt as (Illegible) as I did over the DeGaulle story. Harry Hopkins sent for me yesterday and said he felt I should set up some United Nations (Illegible) on post war planning. He suggests in all capitols the representatives meet monthly and take up questions of feeding, education, etc. I feel what we need is more confidence in Russia and China that as a people we want to

understand them and their problems and work with them. I asked Harry if he thought my going there now during the war would help here and there. He said if I thought so I should make Franklin let me go but to wait until Madam Chiang came. She will be here next Wednesday and she is now in the big house at H.P. I think she is going to surprise F a good deal but she will charm him. She won't lean like Martha of Norway though. She can't be fooled either. Somehow it seems to me that she compels honesty.

Trud says your work is very hard and having no place and no real time must be a great strain. I am glad you drink your milk and hope some day you get enough sleep but you have a great deal to catch up on. You must fight against the melancholy, Joe dear. I am enclosing a letter that came with a valentine from Trud and I feel you can believe (Illegible) her and be happy when she comes to you. I feel that in spirit and thought you are close at all times. I pray St. Valentine too that he may bring us all together but that is because I need you very much.

Ambassador Daniels was in just now and he wanted me to go to the Editors' dinner tomorrow night with him so I am going and tonight as I don't speak at the W.H. correspondents' dinner I am going up to Eleanor Morgenthau's to dine and listen. I hope he says something.

Mrs. Frankfurter brought (Illegible) a Dr. Majaen (English) who believes that Palestine can and should be the home of all Jewish people who wish to go there. He was very convincing but I have heard many arguments on the other side.

I must close so bless you dear a world of love.

She is very quick and when they asked her what China needed most and she hesitated FDR said "Ammunition and war supplies and we will get them there as fast as the Lord will let us" and the next question was "Will you comment on how satisfactory the deliveries have been?" She came back with "I will leave that to the President and only added "The Lord helps those who help themselves." Upon that the press conference ended.

She went to bed till 4 PM. She arose and was given the Chi Omega award at a 15 minute ceremony but it was moving and she made a charming speech. Recalling that yesterday I quoted to her from a letter a young man in the army had written me saying that personal ambitions could never seem to him so important they must emerge in a movement for the betterment of mankind she said that was what gave her courage. The men and the women who would join in a movement so all over the world we might move forward together. You see, what you said made a deep impression on her and struck an answering spark. Great people think alike I have heard.

She has been talking to FDR since 9:20 so I must go and excuse her and lead her to bed. I'll come back then and finish. Later 11:30 I have talked both and finally gotten them to bed and FDR has been given some white silk for shirts and I

have the most beautiful carved ivory and I am ashamed to receive such gifts when we can give nothing to speak of in return. I have a real liking for her though so accepting these gifts from her is not hard.

I am going to N.Y. Tuesday to be at the ship and have his officers to tea if they don't sail before so I hope I can get Trude to lunch with me and tell me all she can about you. I am really hungry to see you and I miss you so much. I would give so much to look up and see you walking in and know you were under my roof. I am as busy as I can be and interested and still you are always in my mind and I wish I could share the things that I like which I feel you too would like with you and Trude. I'm happy to think that tonight you are together and I hope there is no cloud over these days.

Bless you darling, good night and a world of love to you.

This investigator interviewed a reliable informant, [redacted] Chanute Field, Illinois on February 16, 1943, relevant to Subject.

Informant disclosed that on February 15, 1943 at 6:57 P.M. in the 7th Technical School Squadron orderly room at Chanute Field, Illinois, Subject received a person to person telephone call that originated in Columbia, Missouri, from Mrs. FRANKLIN DELANO ROOSEVELT.

The conversation lasted for three minutes, ending at 8:40 P.M.

During the conversation Subject referred to Mrs. ROOSEVELT as "ELEANOR" and she, in return to Subject, as "Sergeant". She inquired as to his health and to what progress he was making in his work, especially referring to his school work at Chanute Field.

Mrs. ROOSEVELT referred to a girl whose name she did not mention and remarked that "the girl had shingles."

She inquired of Subject if he liked the President's speech and Subject replied that it was very good.

Subject was advised by Mrs. ROOSEVELT that she would [redacted] by plane from Columbia, Missouri but she did not reveal [redacted] conversation.

Re: Interview with reliable informant

This officer interviewed a reliable informant on March 5, 6, and 7, 1943 in Urbana, Illinois in connection with an investigation of Subject who is suspected of Communist affiliations.

Informant stated that Mrs. Franklin D. Roosevelt had checked into the Urbana-Lincoln Hotel, Urbana, Illinois at 11:45 A.M., March 5, 1943. She was accompanied by her secretary, Miss Malvina Thompson, and expressed the wish that no publicity be given to her arrival. At the time of registering for her room, Mrs. Roosevelt stated that she expected "a young friend from Chanute Field" to visit her and reserved room 330 for him. Mrs. Roosevelt occupied room 332. Informant stated that the rooms had twin beds and were joined by a connecting door.

About nine o'clock on March 5, 1943, informant stated, a soldier came to the desk of the Urbana-Lincoln Hotel and announced that he was standing in line and understood that MRS. ROOSEVELT had a room reserved for him. He was directed to room 330.

Informant stated that MRS. ROOSEVELT had ordered dinner for three sent to room 332 about 8:30 P.M. He also said that upon the arrival of MISS THOMPSON, her luggage moved into the room occupied by MRS. ROOSEVELT.

Neither MRS. ROOSEVELT nor [redacted] left their hotel rooms during the entire stay on March 6, 1943 except to have lunch in the Hotel dining room. Other meals were served in their rooms, according to informant.

MRS. ROOSEVELT checked out of the Hotel at 7:35 A.M., March 7, 1943 and [redacted] left the hotel a few minutes before that time, according to informant. The hotel bill for all parties occupying rooms 330 and 332 was paid by MRS. ROOSEVELT.

NOTE: It is noted that March 6, 1943 was the regular off-duty day for [redacted] Teach. Reference is made to the letter from MRS. ROOSEVELT (Exhibit I) in which she stated that she would be in Champaign on March 5, 1943.
