Dear Marisa:

I am the consultant assisting the South Park II BID (a new BID in CD14 that will be separate but co-managed by the existing South Park BID - part of which lies in CD9.)

Issue: South Park II is unexpectedly in the position to possibly make the regular tax rolls. We may not. We will know by end of the day Thursday (tomorrow.) It hinges on our property owners signing their petitions. We have reason to expect we may receive enough by tomorrow.

Solution: If we complete our petition drive tomorrow, we would need to secure CM Price's waiver from ED Committee to send this to Council next week. We will also need CP Wesson's assistance to schedule it promptly (next Tuesday.) The item is the Ordinance of Intention, an action which authorizes the Clerk to issue the ballots to property owners. There is a mandatory 45-day ballot period (state law) before the item can return to Council for approval. New BIDs must be approved prior to the Council's July recess to make the regular tax roll. Renewing districts can be approved after recess due to a different Assessor deadline. I can elaborate on any specifics you need, but I have endeavored to keep this email brief.

Assistance: I will do anything within my power - promptly - to support our request. The Clerk is tweaking our MDP/ER one last time, but I will forward it as soon as it is final (hopefully today.) If we are successful, I am happy to write a draft briefing paper for you for Council, or provide anything else that would assist.

Opposition to our item: None known.

Support: Very strong; more than 35% of our owners have participated in the process from the beginning. I will have property owners at Council to speak in support if desired. Consent is also fine if preferred by Council. Jessica in CD14 has been our primary contact, however, as she is out until the 11th, I have alerted Martin and Sara that we could be in council next week, and I am cc-ing them on this request.
