#### Hello Tara,

- Once the balloting has commenced by mailing to the owner of record as required by state law, a property owner can contact our office and ask for a replacement ballot to be sent to a different address or even inform us of parcel ownershipchanges. We will send the property owner a 'REPLACEMENT LOST BALLOT AFFIDAVIT' which they can fill out, sign and return to our office and if everything is in order a replacement, duplicate or updated ballot will be sent out. These transactions are documented in the same way return mail is handled allowing us to have a complete record of what was done and why and where items were mailed.
