Unman tells Stone: I haven't any news for you at all so far, but I wonder if you could perhaps call me later this week? Stone answers: OK, I call you Saturday. Unman says: I'd rather you made it Friday morning in case I go out on Saturday. Stone says: OK. Unman says: thank you very much for ringing. (S) (u)
9:27	AM	OG	G.V.Schneider B9280-6 John Stone to unman at LE5-9100 (tape). Stone asks for Mr Carney (ph), who isn't in, but is expected shortly. (S) (u)
9:30	AM	OG	G.V.Schneider B9280-8 John Stone to unman at Con Edison. Stone wants the electricity from old address cut off in Beechhurst and the account transferred to the new address at 500 E. 83rd st. The electric current is on at the apt. at 83rd st. Unman will comply with Stone's request. (S) (u)
9:35		OG	G.V.Schneider B9280-12 John Stone to Jim Angleton. Jim relates that I'm told there's nothing new, and our Italian friend gets in; he's actually coming with the Pope and will be down here for lunch on OCT. 6th. If you can call me tomorrow morning, then you and I can make plans on how we get together. OK? Stone agrees. Stone asks: can you check what information you have on one man, <u>Yuvim Friedman</u> (sp). Maybe, you know him? Jim answers: no, and asks if Friedman is an American? Stone answers that he's an Israeli; he's the man who caught Eichmann. Jim says: I don't think this Friedman did any kidnapping at all. If he's the one I think about, he's the one who tried to get the credit for it. Stone comments that it's interesting to get the story that Jim has and maybe some other agency.
