AT 11:55 AM, THIS DATE, ONE PATRICK FONZI, WHO IDENTIFIED HIMSELF AS STAFF INVESTIGATOR WITH SENATOR RICHARD F. SCHWEIKER, TELEPHONICALLY CONTACTED SA JOHN J. COTTER AT NYO. HE ADVISED HE HAD BEEN IN CONTACT WITH MARITA YURASITS (NEE MARITA ILLONA LORENZ) IN REGARD TO HER CONNECTION WITH FIDEL CASTRO AND CUBAN REVOLUTIONARY GROUPS IN THE MIAMI AREA IN 1959 AND EARLY 1960S. FONZI ALSO STATED HIS CONTACT WITH MRS. YURASITS WAS ALSO RELATED TO THE "KENNEDY CONNECTION WITH ACTIVITIES AT THAT TIME."

FONZI ADVISED THAT MRS. YURASITS HAD INDICATED TO HIM THAT SHE WAS AN INFORMANT OF THE NYO, AND AS SUCH, WAS IN CURRENT CONTACT WITH SA COTTER. FONZI WAS IMMEDIATELY ADVISED THAT MRS. YURASITS IS NOT NOW, NOR HAS SHE BEEN AN INFORMANT OF THE NYO.

UPON BEING ADVISED OF THIS, FONZI STATED HIS PRIMARY INTEREST IN CALLING THE NYO WAS BASED ON A STATEMENT MRS. YURASITS MADE, TO THE EFFECT THAT SHE HAD HAD CERTAIN GROUP PHOTOGRAPHS OF HERSELF AND OTHER INDIVIDUALS, WITH WHOM SHE HAD BEEN INVOLVED IN THE 1959-EARLY 1960S PERIOD, WHICH PHOTOS SHE CLAIMS TO HAVE GIVEN TO SA ALBERT F. CHESTONE* (CURRENTLY IN NEWARK OFFICE). FONZI INDICATED THAT, IF POSSIBLE, HE WOULD LIKE TO OBTAIN THESE PHOTOS, OR COPIES THEREOF, INASMUCH AS THEY MIGHT BE OF ASSISTANCE IN THE INVESTIGATION BEING CONDUCTED BY SENATOR SCHWARTZ'S COMMITTEE.

FONZI WAS ADVISED THAT SA COTTER HAD NO KNOWLEDGE OF THE EXISTENCE IN THE NYO OF THE PHOTOGRAPHS IN QUESTION AT THIS TIME. FONZI ADVISED HE WOULD CALL SA COTTER, NYO, D AT 11:55 AM, FEBRUARY 25, 1976, IN THE EVENT THESE PHOTOS WERE LOCATED. FONZI'S TELEPHONE NUMBER 301-861-7651.
