He is presently attending Yale University, Department of Public Health under a Research Fellowship. Dr. SHEPS stated on his application for admission to Yale that he was in the Royal Canadian Army Medical Corps with the rank of Captain from April, 1943, to March, 1946. He listed his last employment as Assistant Deputy Minister, Department of Public Health, Province of Saskatchewan, Canada, 1946. SHEPS is scheduled to speak at the New Haven Youth Conference March 16, 1947 on "Health and Recreation".

SOLOMON LISCHINSKY

Reference letter from the Washington Field Office to New Haven dated January 28, 1947, requested the New Haven Field Office to identify and furnish background information on an individual identified as SHEPS, 15 Dwight Street, New Haven, Connecticut, who was a correspondent of Subject SOLOMON LISCHINSKY in this case.

PAUL MARTIN, Assistant Postmaster, New Haven, Connecticut, advised that Dr. CECIL SHEPS resides at 15 Dwight Street with his wife and infant child. He revealed that he had received quite a bit of mail, most of which was originally addressed to Canada and forwarded to Dwight Street.

Using a pretext, the Writer contacted Mrs. HENRY LEADER at the information desk of the YWCA, 48 Howe Street, New Haven. Mrs. LEADER advised that Dr. SHEPS was scheduled to speak at the New Haven Youth Conference to be held at the Y.W.C.A. Sunday, March 16, 1947. She made available the program for this conference which revealed that Dr. CECIL SHEPS, Rockefeller Fellow, Yale Health Department, was to be a panel speaker on "Health and Recreation". Mrs. LEADER advised that as far as she knew SHEPS is from Canada and is connected with the Canadian Ministry of Health.

Mother - ~~POLLA BAWERMAN~~, born Odessa, Russia. His religious affiliation was given as Hebrew. He listed two brothers - ~~JOEL SHEPS~~, M. D., University of Manitoba, 1939, ~~SIDNEY G. SHEPS~~, LLB, University of Manitoba, 1941, and one sister - ~~LUCILLE ELISON~~, M. D., University of Manitoba, 1945.

Dr. CECIL GEORGE SHEPS prepared at St. John's High School, Winnipeg, Canada. He received an M. D. Degree, University of Manitoba, 1936. He married, time and place not given, Miss ~~REDELL CHERNIOCK~~, daughter of J. A. and ~~PATTY CHERNIOCK~~. Miss ~~REDELL CHERNIOCK~~ received an M. D. Degree, University of Manitoba, 1936. Dr. SHEPS lists his service record previously as Assistant Director, Health Service, Department of Public Welfare, Province of Manitoba, 1939 - 1940; School Health Physician, City of Winnipeg, Canada, 1942, 1943; Director of Division of V.D. Control, Department of Public Health, Province of Saskatchewan, Canada, 1944 - 1945; Assistant Deputy Minister, Department of Public Health, Province of Saskatchewan, Canada, 1946.

He states on his application blank for admission to the School of Medicine at Yale University that from April of 1943 to March of 1946, he was in the Royal Canadian Army Medical Corps with the rank of Captain. He is presently, as stated above, in the Department of Public Health, Yale University School of Medicine.

Reference is made to my previous memoranda in the above captioned matter which were concerned with Mary Jane KeeneY's endeavors to join her husband in Japan.

Lieutenant Colonel Innis Randolph of MID advised Special Agent F. P. Griffee of the Liaison Section that a message had been received from the Far Eastern Command on April 4, 1947, stating that the facts of the KeeneY case were being presented to the Loyalty Investigative Committee, General Headquarters, Far Eastern Command, for proper disposition with respect to the evidence available. The Far Eastern Command will advise the War Department as to what action is taken.

**ACTION:** It is recommended this memorandum be routed to the Internal Security Section. This matter will be followed with Colonel Randolph and the Bureau will be promptly advised of any further developments.

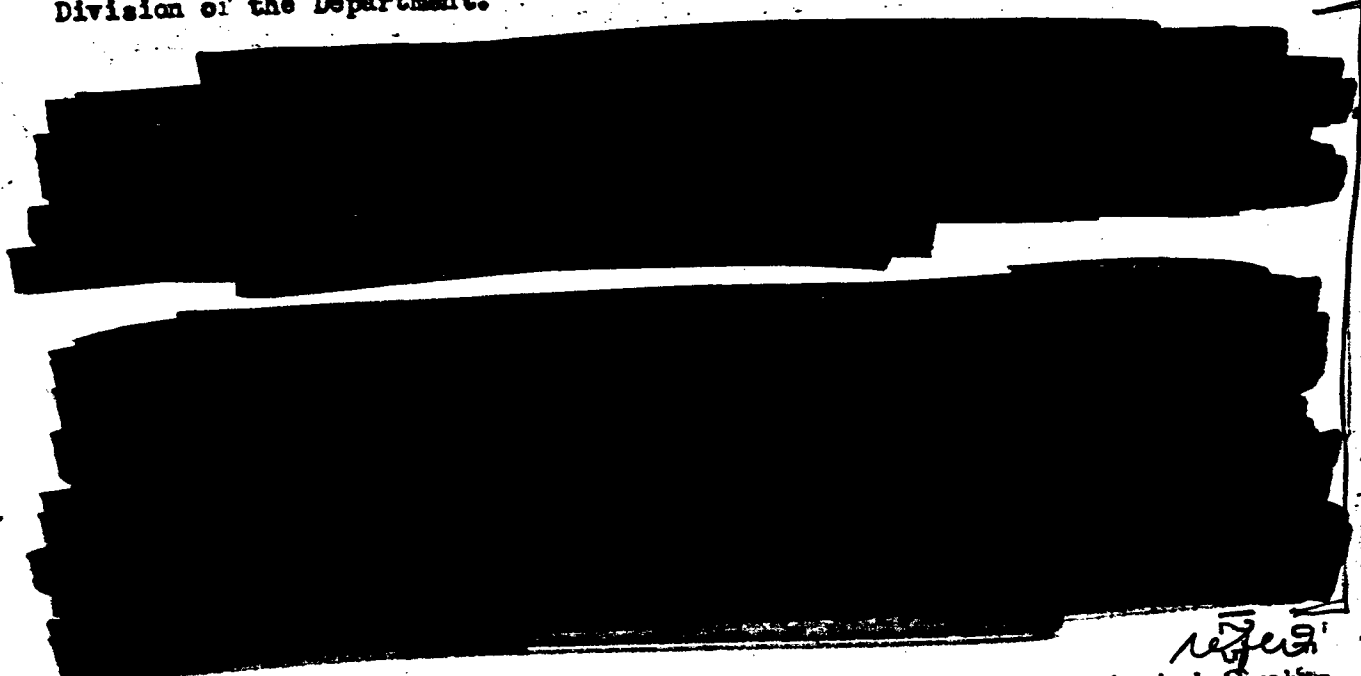

Investigation has revealed that a WILLIAM BURTON LARSON was present in Rio de Janeiro during the first two weeks of April 1946. This LARSON maintains a permanent residence in Santiago, Chile, and is employed as a free lance newsreel photographer. Investigation has not reflected any Communist activities on the part of WILLIAM BURTON LARSON. However, it is known that during the early part of the war he was interrogated in Santiago, Chile for taking pictures of confidential naval installations in that city.

During the subject's visits to Rio de Janeiro, it was ascertained that he maintained constant contact with one MARTIN ROSENBERG who is an employee of the Office of Information and Cultural Activities of the American Embassy in Rio de Janeiro. Investigation has not reflected any subversive or Communist activities on the part of ROSENBERG. However, it has been ascertained that ROSENBERG was in touch with the following persons in the United States:

LLOYD LEHRER, Executive Editor of "World Report", 24th and N Streets N.W., Washington, D. C. ROSENBERG received a business letter

thanking him for his letter to ~~CHARLIE MARINE~~ and stating that he, ~~LEHRBES~~, had received a letter from ~~LEO SHUBERT~~. It was evident that ~~ROSENBL~~ had applied for a job with "World Report" as a Latin-American correspondent and was refused.

On October 4th, 1946 ROSENBERG received a letter from ~~JOHN AKIN~~, Associate Director of the Council for Inter-American Cooperation, Inc., 57 William Street, New York City, thanking him for his letter of September 24th and the material he submitted from the local members covering the visit of Brazilian engineers to New York. The letter also states that ~~ARNOLD TSCHERDY~~ was extremely gratified and liked the remarks on the micro-film story based on the council's report.

ROSENBERG received a balance statement from the Hamilton National Bank of Washington, D. C. indicating a balance of \$1,023.01 as of September 23rd, 1946. Attached to the balance sheet was a cancelled check indicating a payment of \$453.67 to ALAN FISHER on September 3rd, 1946.

It was also ascertained during ~~REDMONT~~'s visits to Rio de Janeiro that he was in contact with ~~ALAN FISHER~~ who is employed as a photographer and writer at the Office of Information and Cultural Activities. Subsequent investigation has revealed that ~~FISHER~~'s United States residence is 2668 East 27th Street, Brooklyn, New York.

It has also been developed that FISHER was attached to the Brazilian Expeditionary Force in Italy as a known liaison agent in charge of photographing various episodes of the Brazilian Army activities overseas. While in Italy FISHER became very friendly with one ~~CARLOS SCLAR~~, a Brazilian painter, who was assigned as the official artist to the Brazilian Expeditionary Force in Italy.

~~SCLAR~~ following the war became a prominent member of the Communist Party in Brazil and is an executive of the Associao Dos Excombatentes (Brazilian War Veterans Society) which is dominated by Communists. ~~SCLAR~~ is also an executive in a Communist dominated pictorial magazine entitled "Revista Do Povo" (Peoples Review). It was noted by this source that FISHER contributed photographs to this magazine and among the photographs in an article attributed to him were several photographs of the Brazilian Communist leader, ~~LUIS CARLOS PRESTES~~.

Coverage of the Subject in São Paulo was not effected due to the lack of informants in that area, a situation which has developed with the transfer of personnel to the domestic field. (u)

Regarding REDMONT's interview with Ambassador PAWLEY on September 6, 1946, the Ambassador was approached discreetly by Special Agent SAM J. PAPICH at which time Mr. PAWLEY stated he could not exactly recall what took place on the occasion of the interview with REDMONT. He stated that the interview was very short and that he had attached little significance to it.

For the information of the Bureau and interested offices, this office has been using the utmost discretion in investigating REDMONT's contacts in the Office of Cultural Affairs. Agent PAPICH, who has had personal contact with many of the employees of the Cultural Office, advised that none of these individuals could be trusted as a confidential source of information on the instant matter.

It is being suggested that the American Federated Press may have been used as a blind by the "Daily Worker" in order to cover the true source of the declarations allegedly made by Ambassador MESSERSMITH.

Although the activities of WILLIAM A. WIELAND have not been highly pertinent to the instant case, it has been deemed advisable to request the Bureau for background information on this individual. This is being done by a separate letter.

u & [ On September 5, 1946, Source J [ furnished ] the information that much publicity was given to an alleged statement made off the record by the American Ambassador to Argentina, GEORGE MESSERSMITH, wherein he was quoted as having stated that war with Russia is inevitable. This statement was made at an American Legion gathering in Buenos Aires at which BERNARD REDMONT was the only correspondent present.

The news story was attributed by the Moscow press to the New York "Daily Worker", which in turn quoted its source as the American Federated Press correspondent in Rio de Janeiro. The Communist newspaper "Tribuna Popular" of Rio de Janeiro on September 7, 1946, contained an article entitled "The 'Daily Worker' Comments on the Warlike Declarations of Messersmith". This article quotes an Associated Press dispatch, dateline September 6, New York City, as follows:

"The Communist newspaper 'Daily Worker' reprinted an article of 'Pravda' commenting on the speech of the American Ambassador in Buenos Aires under the caption 'Messersmith Scandal---Department of State Over Appeal of War'. The 'Daily Worker' states that Messersmith's denial of the speech attributed to him of the American Federated Press, an organization which serves American workers' newspapers, has been accepted 'with a grain of salt' by Washington journalists. The reason his denial is not accredited is that an American who attended the gathering at which the speech was made wrote a letter to those newspapermen concerning the statements made."

Since the foregoing data was assembled information has been received to the effect that while in Rio de Janeiro REDMONT was in contact with LUIZ CARLOS PRESTES, Secretary-General of the Communist Party of Brazil. This was brought out in an article which appeared in the Communist publication "Tribuna Popular" on October 6, 1946. This article is based on an Associated Press dispatch from Washington, D. C., which stated that the magazine "World Report" had published an interview of PRESTES by REDMONT. In this interview PRESTES was quoted as stating that he did not believe that a third war was inevitable; that the United States was playing with fire by refusing to take action against the Fascist governments of Spain and Portugal; that the policy of the Communists with regard to the United States was not pro or con; that, however, the United States was a capitalist country and "it contained politically powerful reactionary groups which influenced the government in its aggressive tendencies". PRESTES was also quoted as having stated that the Communist Parties of Latin America did not maintain connections within or without the hemisphere.

In connection with current investigations concerning known and suspected Soviet espionage agents in the United States, it has been learned that Joseph M. Gillman, an employee of the War Assets Administration who resides at 4396 Earlston Drive, N.W., Washington, D. C., is suspected of being engaged in Soviet espionage activities. Joseph M. Gillman is a known and frequent contact of David R. Wahl, Nathan Gregory Silvermaster, Robert Talbot Miller, III, and Victor Perlo, all of whom are suspected Soviet espionage agents.



I deem it advisable, therefore, that you authorize a technical surveillance on the residence of Joseph M. Gillman at 4396 Earlston Drive, N.W., Washington, D. C., in order to determine the extent of his possible Soviet espionage activities, and further to determine the identities of his contacts.

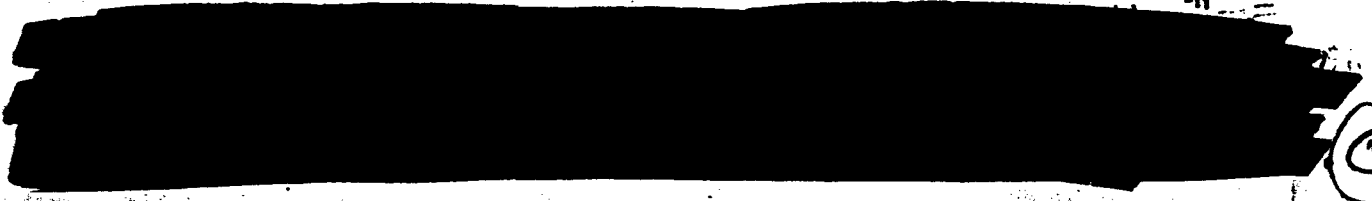

Inasmuch as it is known that the subjects in this case travel extensively, the Bureau should be advised immediately of any contemplated change in their whereabouts and, especially, where they will be on April 16, 1947, in order that appropriate arrangements can be made to have them interviewed.

In connection with these interviews, it is fully realized that in the absence of a war it may be difficult to arrange for simultaneous interviews, but every effort should be made to interview these subjects as simultaneously as possible under these circumstances.

Signed statements should be obtained, if possible, from the subjects in the event that any substantiating or corroborating admissions are made. The originals of these statements should immediately be forwarded to the Bureau.

The subjects should be interviewed vigorously in an effort to obtain from them information concerning their activities in this espionage parallel, including their knowledge of any other individuals participating in similar activities. Their motives for their activities should be determined and the extent of their knowledge, if any, as to the disposition of the material which was furnished by them and others. Every effort should be made to protect the identity of informant Gregory and the use of any technical and microphone surveillances. If it is necessary to conduct interviews in the subjects' homes or offices, consideration should be given to the obtaining of a waiver of search from the subject in order to obtain any possible existing evidence.

In view of the importance of these interviews, I want to strongly emphasize that they should be handled only by Agents of your Offices who are thoroughly familiar with all the aspects of this investigation. The Agents should thoroughly familiarize themselves with the material contained in the interrogation summary memoranda which have been prepared by your Offices for use in conducting the interviews.

Upon the conclusion of these interviews, the Bureau should immediately be advised of the results by teletype.

*ad* Mary Wolfe Price, you may recall, was a subject in a miscellaneous group in Washington and New York City who furnished information to Gregory that was collected from other members of this group. Mary Price also acted as a courier between the group in Washington and Gregory in New York City. Joseph B. Gregg, another member of this group, has acted as courier between this group and an unknown Russian contact after Gregory's activities ceased in the latter part of 1944. It is believed that Gregg is in a position to furnish considerable information concerning other subjects of this group, including William Walter Remington, who is presently employed by the Government.

Robert Talbott Miller, III, another subject in the miscellaneous group, is known to many subjects in this case and, according to Gregory, was introduced to Gregory by Jacob M. Golos. He, therefore, is in a position to furnish information concerning Golos' activities as well as the activities of those subjects now employed in the Government.

It is reiterated that these additional interviews may produce additional information further corroborating Gregory's statements concerning those subjects now employed by the Government. ul

Reference is made to the report of Special Agent LUDWIG W. R. OBERNDORF dated January 8, 1947, at Washington, D. C., in the case entitled ALEXANDER LEO MEYENDORFF, with aliases, INTERNAL SECURITY - R, and to Washington Field Office letter to the Bureau dated March 27, 1947, in the same matter.

Referenced report reflects that MEYENDORFF was born April 18, 1910, at Leningrad, Russia, and entered this country September 16, 1928, at Boston, Massachusetts, from FRANCE. He was arrested in New York City in 1935 for distributing leaflets put out by the "Friends of the Soviet Union". He has admitted membership in the Communist Party from May, 1938, until the summer of 1940 under the alias of JOHN LACALLE.

He was arrested June 21, 1941, by the Immigration and Naturalization Service, New York City, as an alien being a member of or affiliated with an organization seeking to overthrow the Government. He had previously fought deportation to Russia. Although deportation was recommended, the subject was finally released on his own recognizance on December 10, 1941.

From July 12, 1943, until March 19, 1944, he was employed by "Russky Golos" in New York City. Since March 22, 1944, he has been employed as an economist by the Soviet Government Purchasing Commission and Amtorg Trading Corporation.

Reference report develops further that from October 10 to 15, 1946, MEYENDORFF was a patient at Casualty Hospital, Washington, D. C. He was suffering from a stomach ailment and his physician was Dr. STEPHEN VERGES.

With reference to [REDACTED] (S) (C) it is desired to point out that A. B. GARMAN has been identified as AI in this case and that FEDOR A. GARMAN was a suspect in this case as GARMAN's possible successor.

A comparison of the description of MEYENDORFF with that of the unknown subject JACK reveals certain similarities, notably that both are blond, both have been in this country for some time and both suffer from stomach ailments.

During a surveillance of MEYENDORFF on March 1, 1947, it was noted that he is a careless dresser and that his appearance is Semetic.

JACK is reported as being familiar with New York City and Washington, D. C.; MEYENDORFF has studied and been employed in both cities over extended periods of time. JACK mentioned to informant GREGORY that his real name was a good Lithuanian family name and that he was not of pure Jewish blood; MEYENDORFF's name is not typically Russian and might be Lithuanian.

In view of the above, this office is giving consideration to the possibility that MEYENDORFF may be identical with the unknown subject JACK in the GREGORY case.

The New York Field Division, which is in possession of copies of the referenced report, is requested to review MEYENDORFF's file with the Immigration and Naturalization Service at Ellis Island, New York, and to obtain a photograph of MEYENDORFF for the purpose of exhibiting it to informant GREGORY. The report of Special Agent W. J. HIGGINS dated September 5, 1941, at New York City in the case entitled ALEXANDER LEO MEYENDORFF, was, REGISTRATION ACT, INTERNAL SECURITY - R, notes that MEYENDORFF's photograph is available in the Ellis Island file.
