I thought you would be interested in the following information which was made available to this Bureau through a source known to be completely reliable.

Allan Rosenberg, a local attorney, who you may recall is a subject in the Gregory case about which a summary of information has been made available to you, returned to Washington on July 8, 1946, after attending a convention of the National Lawyers' Guild in Cleveland, Ohio. The National Lawyers' Guild is reliably reported to be subject to considerable Communist influence having numerous known Communist Party members among its ranks.

Rosenberg advised his wife that he had served on the Resolutions Committee and that the Guild had adopted a resolution vigorously condemning you and asking for your removal unless you change your policy. Rosenberg further stated that Assistant Attorney General Wendell Berge promptly joined the Guild and that Senator Claude Pepper also joined.

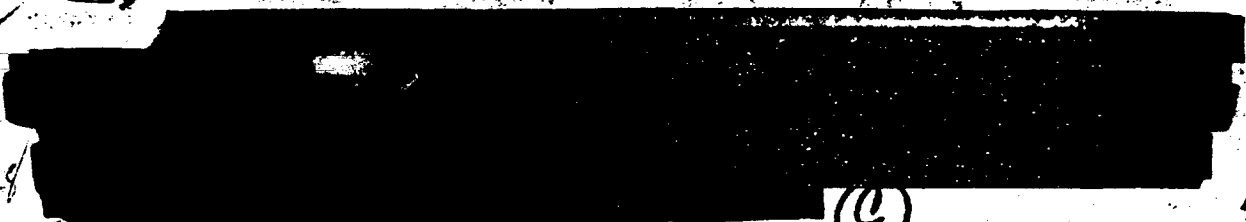

GREGORY ESPIONAGE, R, REFER FIVE IS
 IN INTERVIEW WITH CI GREGORY TODAY SHE STATED THAT IN HER LAST MEETING
 WITH HELEN TENNEY OF NYC THAT SHE LEARNED THAT TENNEY HAD BEEN DISMISSE
 FROM THE WAR DEPARTMENT AND RECEIVED HER NOTICE OF DISMISSAL ON JUNE
 NINETEEN, NINETEEN FORTY SIX, EFFECTIVE JULY NINETEEN, NINETEEN FORTY
 SIX. TENNEY WAS INFORMED BY HER SUPERVISOR THAT THE REASON FOR HER
 DISMISSAL WAS BECAUSE OF A REORGANIZATION IN TENNEY-S DEPARTMENT.
 APPARENTLY NO STIGMA WAS ATTACHED TO HER DISMISSAL. TENNEY INDICATED
 THAT SHE WAS A POSSIBILITY OF OBTAINING A POSITION WITH THE PUBLIC
 HEALTH SERVICE IN NYC DOING SOME PUBLICITY WORK BUT THAT THIS JOB IS
 STRICTLY ON A TENTATIVE BASIS. TENNEY INDICATED SHE WAS RETURNING TO
 WASH ON JULY SEVEN OR EIGHT, NINETEEN FORTY SIX AND WOULD REMAIN IN WAS
 AT HER JOB UNTIL THE DATE OF HER RELEASE ON JULY NINETEEN. GREGORY

HE DID NOT INDICATE THE LENGTH OF TIME OVER WHICH HE EXPECTED TO RECEIVE THIS AMOUNT OF MONEY. WILLIAM BROWDER VOLUNTEERED THAT SOMEONE FROM THE MUTUAL NETWORK HAD RECENTLY APPROACHED EARL BROWDER AND SOLICITED HIS APPEARANCE OVER THIS NETWORK AT TEN THIRTY PM ON JULY FIFTEEN, NINETEEN FORTY FIVE IN WASHINGTON DC. GREGORY HAS NO KNOWLEDGE OF THE SUBJECT MATTER OF EARL BROWDER'S BROADCAST ON THIS DATE. WILLIAM BROWDER ALSO ADVISED THAT EARL WAS APPROACHED BY THE MAGAZINE NEW REPUBLIC AND WAS REQUESTED TO WRITE A SERIES OF SIX ARTICLES FOR THIS MAGAZINE WHICH EARL CONTRACTED TO DO. IN CONNECTION WITH AN ARTICLE IN THE NEW YORK DAILY NEWS OF JULY FOUR, NINETEEN FORTY SIX BY JOHN O-DONNELL CONCERNING THE MANNER IN WHICH EARL BROWDER OBTAINED HIS PASSPORT, WILLIAM STATED THAT EARL AND HIMSELF WERE QUITE UPSET ABOUT THIS PUBLICITY AND THAT, HE, BILL, HAD TALKED TO SOME NEWSPAPER MAN, A FRIEND OF HIS, WHO INDICATED THAT THE ITEM WAS LIBELOUS. WILLIAM BROWDER STATED THAT HE HAD ANTICIPATED TAKING THIS MATTER UP WITH A LAWYER WITH THE POSSIBILITY OF SUING JOHN O-DONNELL. HE INDICATED, HOWEVER, THAT EARL HAD NEVER SUED ANYONE BEFORE AND COULD NOT STATE AT THIS TIME WHETHER A SUIT WOULD ACTUALLY BE INSTITUTED. IN CONNECTION WITH EARL'S SCHEDULED BROADCAST ON JULY FIFTEEN, NINETEEN FORTY SIX, WILLIAM BROWDER STATED THAT ON THE NEXT DAY HE IS GOING TO HAVE A PRESS CONFERENCE BUT STIPULATED THAT JOHN O-DONNELL IS NOT INVITED.

Synopsis of Facts:

"Compania Industrial y Distribuidora, S. A.," Humboldt 42, Mexico, D. F., organized January 28, 1942. Owned and controlled by EGON SCHOENWALD, SR., and EGON SCHOENWALD, JR., who occupy posts of President and General Manager respectively. SCHOENWALD, SR., Belgian national by birth, naturalized Mexican citizen. SCHOENWALD, JR., Mexican citizen by birth. Firm has good commercial reputation and operates with capital of some 365,000 pesos Mexican currency. No apparent subversive connections attributed to SCHOENWALDS. Firm appears to have only business connections with ZAYDMAN.

It will be recalled that during the visit made to Mexico, D. F., by suspect ADAM ZAYDMAN he was in close contact with the firm Compania Industrial y Distribuidora, S. A., Calle Humboldt 42, Mexico, D. F., and it was determined that this firm had been named as his local representative for the distribution of perfumes. *u u*

u [According to Source C,] Compania Industrial y Distribuidora, S. A. was organized in Mexico, D. F., on January 28, 1942, for a duration of five years. The object of the firm was the purchase and sale, exportation and importation, of chemical, mineral and combustible products, as well as perfumes and cosmetics. Its declared capital was fixed in the sum of 100,000 pesos Mexican currency (approximately \$20,000 United States currency) represented by 100 shares of stock valued at a nominal value of 1,000 pesos each. The stock was originally owned as follows:

40 shares - ROBERT BIUM
40 shares - EGON SCHOENWALD, JR.
18 shares - JOSE ORTIZ DE LA PENA
1 share - RAMON MONZON
1 share - IULIS BEAUREGART

Shortly after the organization of the firm the shares previously owned by BIUM were purchased by EGON SCHOENWALD, SR., and this individual, together with his son, control the business in its entirety.

EGON SCHOENWALD, SR., is a Belgian national by birth who was naturalized as a Mexican citizen in 1914. He is 63 years of age, married, and has resided in Mexico since 1905. SCHOENWALD, SR., is described as having previously been employed by various banking firms and later was interested in real estate promotion concerning which there are reports indicating that a number of the investors lost considerable sums of money. SCHOENWALD returned to Europe following this failure in 1930 and did not return to Mexico until 1938.

EGON SCHOENWALD, JR., son of the previously described individual, is a Mexican citizen by birth, some 30 years of age and married. He is reported to have completed his college education in Europe and returned to Mexico with his father, entering the firm of Compania Industrial y Distribuidora, S. A.

At the present time EGON SCHOENWALD, SR., is President of the firm and EGON SCHOENWALD, JR., is General Manager and Treasurer.

u (A) [According to Source C] this firm is presently dedicated primarily to the manufacture of perfume and chemical products. It has an excellent business reputation and reportedly presently controls a capital of approximately 365,000 pesos Mexican currency (approximately \$73,000 United States currency).

Mr. JAMES SCHULTZ, superintendent at 430 East 86th Street, New York, New York, advised that THEODORE BAUMGOLD had maintained an apartment at that address since 1942, but that he had been in the armed services most of the time, and that very little of him had been seen at that address. SCHULTZ advised that about one year ago Mrs. LYDIA BAUMGOLD sublet the apartment maintained by herself and BAUMGOLD at that address. SCHULTZ stated he had not seen LYDIA BAUMGOLD since that time.

Miss HELEN CLAYMAN of the TRIO MANAGEMENT CORPORATION, 2054 Broadway, New York, New York, who is the agent in charge of the building at 430 East 86th Street, New York-City, advised that LYDIA BAUMGOLD had told her about four or five months ago that she contemplated obtaining a divorce from THEODORE BAUMGOLD because he had fallen in love with some woman in France or some other foreign country. Two weeks ago, Miss CLAYMAN received a letter from LYDIA BAUMGOLD in which LYDIA advised that she was at that time at Reno, Nevada in the process of obtaining a divorce from THEODORE BAUMGOLD. Miss CLAYMAN stated that she knew both Mr. and Mrs. THEODORE BAUMGOLD, and that other than the marital difficulties, she knew nothing concerning their private lives.

QUARTZ PRODUCTS COMPANY has offices at 305 East 45th Street, New York City, and is engaged in making quartz crystals. This QUARTZ PRODUCTS COMPANY is controlled by JOSEPH BAUMGOLD, CHARLES BAUMGOLD, THEODORE BAUMGOLD, and ROBERT BLAUNER. All of these individuals are related to one another. JOSEPH BAUMGOLD and CHARLES BAUMGOLD are cousins of THEODORE BAUMGOLD, and ROBERT BLAUNER is a brother-in-law of JOSEPH BAUMGOLD.

JOSEPH BAUMGOLD is also treasurer of BAUMGOLD BROTHERS, INC. According to credit information on file, he is native born, of Russian descent. According to credit information, this QUARTZ PRODUCTS COMPANY is worth in excess of \$800,000.

BAUMGOLD BROTHERS, INC. was founded in 1923 by three brothers: LOUIS, JACOB, and SAMUEL BAUMGOLD. 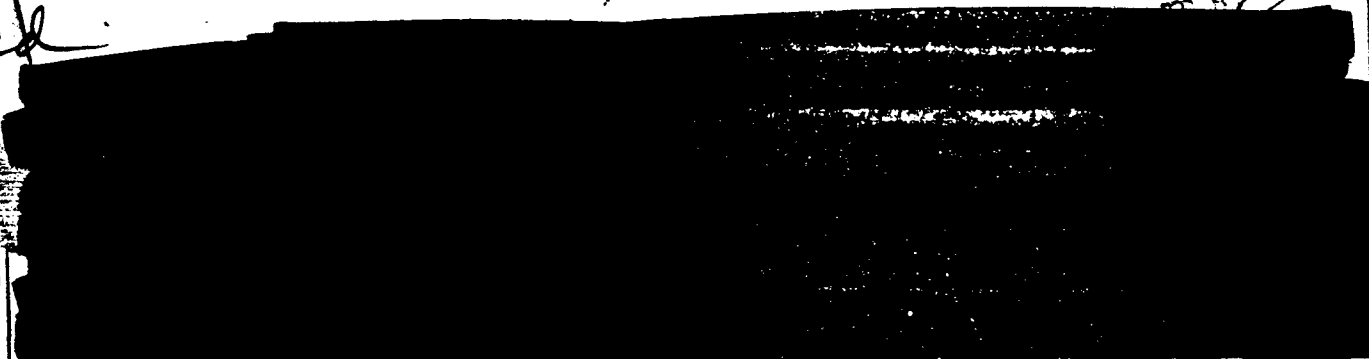

Mr. Fred Lyon, State Department, inquired of Mr. Roach today whether it would be possible for the Bureau to supply him with information from available sources, primarily from highly confidential sources relative to the present activities of Robert T. Miller, III.

As you will recall Miller was recently transferred from his job at the State Department to the old German Embassy where he is supposed to be reviewing matters which the State Department feel are unimportant and from which Miller could not obtain any information to pass on to his principal. According to Mr. Lyon Miller actually spends very little time at the Embassy, that is, he checks in in the morning and checks out at night but his activities during the day are not known.

It is for this reason that Mr. Lyon would like to be informed of the actions of Miller, that is, whether he is in contact during the day with individuals associated with Russian espionage matters. Mr. Lyon has not requested a surveillance on Miller but merely a review of the Bureau's many sources to see if it would be possible to learn his daytime activities.

In view of this request it is suggested that this memorandum be referred to the Internal Security Section so that an appropriate check may be made of the various technical logs to see if it is possible to identify Miller's activities which are now unknown to the State Department. Liaison Section should be informed of any information developed so that it may be personally passed on to Mr. Lyon.

I thought you would be interested in the attached article by John O'Donnell which appeared in the "Washington Times Herald" on July 4, 1946, and concerned Earl Browder's receipt of a passport in order to travel to the Soviet Union. The article states that a deal was made between Browder and the State Department and the Bureau whereby Browder agreed to turn over all of his records concerning Communists, especially those employed in high Governmental positions, to the Bureau in order that he could obtain his American passport. This statement is entirely untrue in so far as the Bureau is concerned.

Confidential Informant Gregory has advised the New York Office that on the afternoon of July 8, 1946, she met William Browder, Earl Browder's brother, and he mentioned the article prepared by John O'Donnell which also appeared in the "New York Daily News" dated July 4, 1946. Concerning this article, William Browder stated that Earl and himself were quite upset about the publicity and that he, William Browder, had talked to some newspaper man whom he described as a friend of his who indicated that the article was libelous. William Browder stated that he had anticipated taking this matter up with a lawyer with the possibility of suing John O'Donnell; however, he indicated that Earl Browder had never sued anyone before and therefore he could not state at this time whether a suit would actually be instituted.

CAPITOL STUFF

By JOHN O'DONNELL

IT MIGHT be recorded on this day of the celebration of the independence of our republic that the Department of Justice under President Harry Truman is actually going to work on the chore of ousting Reds and their Pinko Fellow Travelers from their posts of power in the upper brackets of Washington.

For the record: Three of the big shots in our State Department's Latin-American bureau have been told to clean out their desks, pick up their hats, and quit. The reason: Moscow affiliations and sympathy.

The job has been done by FBI's chief, J. Edgar Hoover. Five FBI agents followed the Red trail into the top secret zone of our foreign relations. The evidence has been placed on the White House desk. The boys are out.

Within 10 days, 14 desks in the Labor Department, now occupied by Moscow's Fellow Travelers, will be vacant. The same reason: Hoover's men have picked up the trail (well covered during New Deal days of F. D. R.) and blown the whistle into the sympathetic ears of Truman.

Orders from Attorney General Tom Clark, of Texas: "Infiltration of the Commies into official positions in the Government of our republic must stop." It happens to be against the law.

AND in the "now it can be told department." Against the screaming opposition of Sidney Hillman's P.A.C., the Department of Justice did a Red probe into the radical backing of California's Attorney General Bob Kenney, the pride and hope of the P.A.C. in the recent primaries.

Republican Nominee Governor Earl Warren startled the wisecracks of national politics by grabbing off the Democratic nomination as well as his formal Republican indorsement.

Interesting fact: The investigation and exposures of Bob Kenney's Red backers (which he tried to brush off), as turned up by FBI agents operating under Democratic Attorney General Clark, cost Democratic Kenney 400,000 votes.

The California Hillman mob demanded the political scalp of the Attorney General. Said Clark, who's from Texas, rather grimly: "I'm a Democrat, but if you boys want to sleep with the dogs expect to wake up with the fleas."

TYPICAL of the sharply different picture in Washington—this White House adventure of a few days ago. The President with the benediction of National Chairman Hannegan, had sent to the Senate for confirmation the nomination of a powerful backed Roosevelt supporter for a post as U. S. attorney on the Pacific Coast.

As routine, Hoover's FBI made its required investigation. There was a call for speed and the papers were O.K.'d and shipped to Truman.

Then, a few days later, Hoover's men reported to Attorney General Clark a Pinko tie-up of the candidate 10 years ago.

Clark went directly to the White House, picked up the FBI indorsement of a few days earlier, and ripped the paper to bits before the surprised eyes of Truman's White House Confidential Secretary, Matthew W. Connolly.

THE pay-off on all the present effectiveness of the Department of Justice in blocking the Moscow infiltration comes from a luck move—in which the Edgar Hoover boys hit paydirt. And they can thank, of all persons, our own native-born (Wichita, Kans.) Earl Russell Browder, one-time head of the Communist party now supposedly (but perhaps not) on the outs with Pal Joey in Moscow.

At all events, Comrade Browder came up to the State Department a few weeks ago and asked please, as a native-born American who had been sprung from the Federal house-gow by a Roosevelt pardon, would the State Department be so kind as to give him a passport to Russia so that he could take tea in the Kremlin with Pal Joey.

The State Department sat back, took a long breath, thought over, called the White House. Into the picture came the nation's No. 1 man on the Red peril—J. Edgar Hoover. Then came the very smart play.

Brother Browder was solemnly told that there might be difficulties in getting that passport. He was a good guy and probably reformed and didn't believe in the Moscow doctrine that safety for Red Russia depended directly on the overthrow of the capitalistic United States Government by force, but still—well they weren't quite sure. At all events the Browder passport was held up and Brother Browder began to squirm.

Then he proposed the deal. Give me the passport for Moscow and in return I'll give you my complete and secret files of all the distinguished Communists now ambushed on the U. S. pay roll, including those in the armed forces.

Brother Browder got the passport—after the Department of Justice got the Browder lists. Hence the effective Red purge yesterday; hence the Sidney Hillman headaches. Hence the swift deflation of the political potency of the P.A.C.

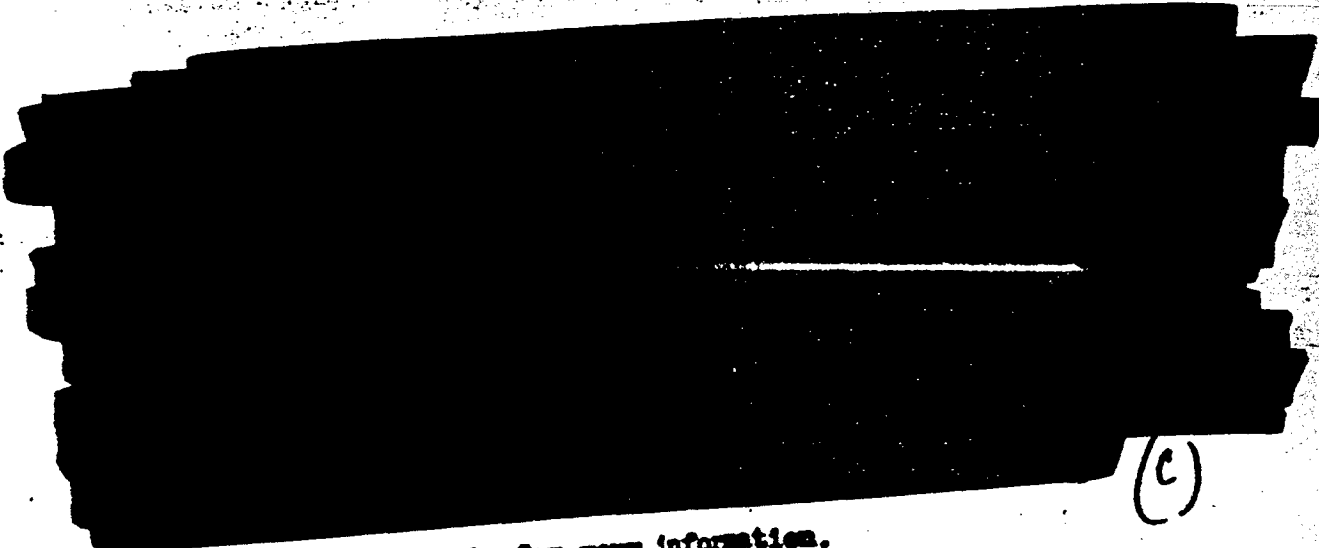



Summary

The following are the pertinent activities of Robert Talbott Miller, III, an employee of the State Department since the preparation of the summary entitled "Underground Soviet Espionage Organization (NKVD) in Agencies of the United States Government," dated February 21, 1946.

The following activities of Miller were obtained from a source regarded as highly confidential and entirely reliable and in some instances will deal with the activities of Jennie Miller, wife of Robert Talbott Miller, III.

On March 5, 1946, Miller was in contact with Mr. Charles F. Kindleberger and asked him for some advice stating that someone had called him, Miller's, chief and said they wanted him to be detailed to a job in the German Embassy in Washington to formulate a plan for what the German officers abroad should be allowed to do when they began to be represented abroad. He asked Kindleberger if this made sense to him and Kindleberger replied that he knows what it is about; that it is a dirty job and has some legal aspects; and that it is an administrative job and not a policy formulating job. He stated that they make recommendations to political directors and added that he would not do it and further he thought that Miller ought to go into the job with his eyes open. Kindleberger said that this job was out of his bailiwick and that the political boys are handling it.

On the same date Miller contacted a man whom he referred to as "Doc" (believed to be Dr. Robert T. Morse, 1106 N Street, Northwest, Miller's personal physician whom he has contacted under somewhat peculiar circumstances in the past). Miller asked him if he, Miller, could come over to see him and the doctor was apparently not too enthusiastic about it but he said he thought it would be o.k. The doctor said, "There is somebody here who probably it would be best not to -----." The doctor then asked Miller if he had found out anything and Miller replied negatively to which the doctor stated that he did. Miller then said that his leg hurt him so the doctor advised him to come on over. Miller stated that he would see him in about one half hour.

On March 11, 1946, Ann Feltus, wife of Andy Feltus, a former employee of the Treasury Department and a known contact of Nathan Gregory Silvermaster and Harry Dexter White, both subjects in the Silvermaster case, contacted Jennie Miller and advised her that she and her husband had arrived by plane on the previous night from California. She said that her husband had to rush by plane to Georgia that morning (to attend the Savannah Monetary Conference) and that she was going to New York soon whether or not Andy came back right away.

On March 12, 1946, through a physical surveillance maintained on Joseph B. Gregg, former member of the State Department and a principal subject in the Gregory case, it was determined that Gregg entered the office building at 810 18th Street, Northwest, and shortly thereafter emerged with Robert Miller and they proceeded to a parking lot between 17th and 18th Streets, Northwest, where they entered Miller's automobile.

On March 16, 1946, it was determined that Florence Levy, sister-in-law of Robert Miller, is employed at the State Department and believed to be under the supervision of Miller. During the course of the investigation of Miller it has been determined that Florence Levy has Communist sympathies.

On March 22, 1946, Jennie Miller was in contact with Maurice Halperin, another subject in the Gregory case, formerly employed by OSS. Subsequently Jennie Miller was in contact with Rose Gregg, the wife of Joseph B. Gregg mentioned hereinbefore. During the contact with Rose Gregg, Rose advised Jennie Miller that Joseph Gregg had left Washington Wednesday night and that he would let her know when he was going to return. She added that he has to have two more teeth worked on. Rose indicated that the dentist had finished the major part of the work the last time Joe was there. Apparently Mrs. Gregg was referring to her husband's visit to the office of Dr. Abraham B. Weinstein, a dentist in New York City prominently mentioned in the Gregory case and a highly suspected clearinghouse for Communist espionage activities. Gregg has visited the office of Weinstein under peculiar and questionable circumstances. It is interesting to note that Mrs. Miller apparently has knowledge of the fact that Gregg visited this dentist in New York City. *du*

On March 26, 1946, Mrs. Halperin contacted Jennie Miller and invited her over for the evening. Jennie Miller consented, but subsequently advised Mrs. Halperin that it was too late to come over and they agreed to meet for dinner at the Miller residence a week from the following Friday. *du*

On April 2, 1946, Helen Silvermaster, wife of Nathan Gregory Silvermaster, a prominent subject in the Gregory case, attempted to contact Mrs. Miller but learned that she was out for the evening. *du*

On April 5, 1946, Wilder Spaulding, chief of one of the divisions in the State Department, contacted Mr. Miller and advised him of a plan to split the office and to have two deputies in which Spaulding was to be one deputy and one Francis (last name unknown) was to be the other. Spaulding said that he would have the treaty work in the Division of Publications. He told Miller that there eventually would be a new Director over it all, but as yet no one has been named. Spaulding advised Miller that he was going to check things over and one of the first things he was going to do was to get Miller back again to head the Division of Planning and Education. *du*

Through a physical surveillance maintained at the residence of Robert T. Miller, III, at 3223 Northampton Street, Northwest, on the night of April 5, 1946, the following people were observed to enter the Miller residence between 7:30 p.m. and 8:30 p.m.: Mr. and Mrs. Nathan Gregory Silvermaster and a man believed to be William Ludwig Ullmann, who, it will be recalled, resided with the Silvermasters and is a subject in the Gregory case; Maurice Halperin and his wife, Edith; Mr. and Mrs. John Diackes; and Charles Plato, both of whom are highly suspected Communist functionaries. In addition to the above an unknown man and woman arrived in a Buick sedan bearing 1946 Pennsylvania license tag No. 166-N and entered the Miller residence. It was subsequently determined that this license was assigned to Bernard Leroy of 6112 Spruce Street, Philadelphia, Pennsylvania. An unknown man and woman also arrived in an automobile bearing 1946 D. C. license No. 106-919 which was identified as being registered to Myra C. Callis, 3206 E. Street, Northeast, who is the wife of a colored doctor. Another unknown woman arrived in an automobile bearing 1946 D. C. license No. 105-572 which was identified as being the automobile of Mrs. Polya J. Habicht, 3220 Chestnut Street, Northwest, who is a suspected Soviet agent. Parked nearby was an automobile bearing license plates which were issued to Florence Levy, Miller's sister-in-law and it appeared that she also attended this gathering.

On April 10, 1946, Robert Miller was in contact with Joseph B. Gregg and Joseph Gregg inquired as to how Miller was getting along in his new "residence" referring to Miller's transfer to the German Embassy detail of the State Department. Miller stated that he was performing his duties which did not amount to very much. Gregg said that he could not sell Miller's story in that case and added that he would not give anyone information now without getting paid for it.

On April 13, 1946, Victor Perle, another subject in the Gregory case, was in contact with the Miller residence and advised that he would like a Mrs. Brinkerhoff to have her husband contact him concerning a tennis engagement.

On April 17, 1946, Miller was in contact with Mrs. Kathleen Fahy, an employee of the American Red Cross and wife of John Fahy, an employee of the Interior Department. Both Mr. and Mrs. Fahy are suspected to be Communist Party members. Miller inquired concerning the health of John Fahy who was confined to Callinger Hospital with pneumonia.

On April 20, 1946, William Ludwig Ullmann, mentioned hereinbefore, attempted to contact Robert Miller and was advised that he would not be at his residence until later that afternoon. Ullmann left word to have Miller contact him when he came home.

On April 21, 1946, Joseph B. Gregg was in contact with Miller and it was learned that the Greggs were supposed to be at the Miller residence at eight o'clock that evening. In referring to "the situation" Miller said that "everything is about average."

On April 26, 1946, an unidentified man was in contact with Robert Miller and they made a date for Miller to see him at eight o'clock the following morning, April 27.

A physical surveillance conducted on Miller on the morning of April 27, 1946, reflected that Miller left his residence at 7:50 a.m. and drove to 3106 N Street, Northwest, and entered a residence at that address. It will be recalled that this is the residence of Dr. Robert T. Morse, previously mentioned in this memorandum. Miller remained in Dr. Morse's office from 8:10 a.m. until 9:10 a.m. on that date.

On April 28, 1946, Mrs. Miller was in contact with Alexandra Pavlovna Lewis, also known as Shura Lewis, wife of James K. Lewis who is an employee of the State Department and was formerly employed in Moscow as a code clerk in the United States Embassy. Mrs. Lewis was a Russian National at the time she married James Lewis in Russia and she is a highly suspected NKVD agent. Mrs. Miller invited Mrs. Lewis to a gathering which was to be held on the evening of April 28, but Mrs. Lewis declined the invitation inasmuch as she had guests for the evening.

Through a physical surveillance on April 29, 1946, it was learned that Miller and his wife visited the residence of John P. Marsalka, a suspected Communist, at 3317 R. Street, Northwest. It was noted that an automobile bearing license plates registered to James K. Lewis of the State Department was parked nearby.

On May 19, 1946, Mrs. Polya Habicht, mentioned above, was in contact with Miller and she invited him to a discussion which was to take place at her home. She asked Miller to take the part of the American view in the discussion and added that she would take the Russian view. She told Miller that she had received up-to-date literature and newspapers direct from Pravda and Izvestia from Moscow. Mention was made of E. Wilder Spaulding under whom Miller is working at the State Department and Mrs. Habicht said that in her opinion Spaulding was not up to date and therefore she did not think that Miller had much room for progress or advancement under him.

On May 26, 1946, Dr. Robert T. Morse was in contact with Robert Miller and made an appointment for Miller on the following Monday.

On June 19, 1946, Robert Miller was in contact with Mrs. Silvermaster and William Ludwig Ullmann and she invited them to dinner that evening. During this contact Helen Silvermaster advised Miller that Ullmann was working and that he was trying to make an impression on his new boss, meaning Secretary of the Treasury, John Snyder. Miller told Mrs. Silvermaster that his place (meaning his job at the State Department) is going to rack and ruin and that he wants to talk to Mr. Silvermaster when he returns to Washington in order to obtain some advice from him. He said he also wanted some advice from Mrs. Silvermaster and Ullmann.



For your confidential information, the Bureau is in receipt of information that there is alleged to be operating in Washington an enormous espionage ring, with the ultimate objective of obtaining all information concerning atomic energy, for specific uses as an instrument of war and commercial aspects thereof in peacetime for the purpose of making such information available to the Soviet Union. Among these individuals involved in this espionage ring are James R. Newman, the Office of War Mobilization and Reconversion, and Advisor to the Senate Committee on Atomic Energy; Dean Acheson, Undersecretary of State; Herbert S. Marks, Undersecretary of State; John J. McCloy, former Assistant Secretary of War; Howard C. Peterson, Assistant Secretary of War; Henry A. Wallatary of War; of Commerce; Paul H. Appleby and George Schwartzwalder of the Bureau of Budget; Dr. Edward U. Condon, Director of the Bureau of Standards and Advisor to the Senate Committee on Atomic Energy; Alger Hiss of the State Department, assigned to UNO; and Abe Feller of the Bureau of the Budget.

In connection with their activities, it is alleged that technical and exact information which James R. Newman desires to pass on to his Russian principals is made available to Nathan Gregory Silvermaster, a principal subject in the Gregory Case, residing at 3515 - 30th Street, N.W., Washington, D. C. and employed as an economist at the War Assets Administration, Washington, D. C., and that with regard to matters of a highly technical nature, Dr. Edward U. Condon, of the Bureau of Standards, contacts Silvermaster directly.

Advice has been received that James R. Newman is presently vacationing in Connecticut until September 1, 1946 and is residing at No. 4 New Haven Avenue, Milford, Connecticut.

Newman and Marks have been reported to be the so-called ringleaders of this espionage network and have been under close and discreet investigation in Washington, D. C.

In order to further determine the contacts of James R. Newman, you are authorized to place a sixty-day full cover on the residence of Newman in Milford, Connecticut, providing full security is assured, in order to determine the identity of his contacts.

Reports should be submitted by your Office under the caption "Nathan Gregory Silvermaster, with aliases; Et Al; Espionage - R."

In view of the highly delicate nature of the allegations made against the above individuals, it is strongly stressed that the utmost discretion should be exercised by your Office in connection with this investigation.

York City, on the night of June 23 for employment by the American Jewish Conference, New York City, as secretary for United Nations Affairs. A spot surveillance was requested to determine the subject's activities.

AT BOSTON and LYNN, MASSACHUSETTS

The following information was secured as a result of a surveillance conducted by Special Agent William J. McCarthy and the writer.

Subject HALPERIN, his wife and children arrived at 62 Rogers Avenue, Lynn, Massachusetts, at 1:45 PM, June 21, 1946. This is the residence of Mrs. HALPERIN's parents, Mr. and Mrs. HYMAN S. FRISCH. The subject remained here until about 3:45 PM when he went riding with his family. He returned at approximately 5:30 PM and stayed until 9:30 PM when he proceeded to the home of his parents at 1156 Commonwealth Avenue, Brighton, Massachusetts, where he spent the night.

On June 22 HALPERIN left 1156 Commonwealth Avenue at 12:30 PM, driving with his parents to 89 Broad Street, Boston (a public service building). At this address they entered the office of M. H. SAVAL, Room 415, an insurance broker. After a short visit they left this address in the company of an unidentified individual and proceeded to Montey's Restaurant, 54 North Street, Boston. The individual who accompanied them can be described as follows: age 40, height - 5'9", weight - 185 pounds, black hair, dark complexion, heavy build, race - white. This individual was subsequently identified as BERNARD KAITZ, an employee in the office of M. H. SAVAL. Further reference is made to this individual later in this report.

At 2:35 PM the subject, KAITZ and the subject's parents returned to 89 Broad Street, remaining here until 4:15 PM when they again departed from the building and proceeded to 1156 Commonwealth Avenue, Brighton. En route to Brighton they stopped at the Exeter Theater, Exeter Street, Boston, and inquired at the box office concerning tickets. The subject spent the night of June 22 at his parents' home in Brighton, Massachusetts.

On Sunday morning, June 23, the subject left Brighton at 8:45 AM and proceeded to 62 Rogers Avenue, Lynn, where he arrived at 9:15 AM and picked up his wife and two children and departed at 9:35 AM by automobile for Fall River, Massachusetts.

AT FALL RIVER, MASSACHUSETTS and PROVIDENCE, RHODE ISLAND

A surveillance was conducted on the subject HALPERIN in Fall River, Massachusetts,

by Special Agent H. E. WILBUR and in Providence, Rhode Island, by Special Agent H. E. WILBUR together with Special Agent E. C. HYMAN.

On arriving in Fall River HALPERIN proceeded to Temple Bethel where he attended a one o'clock wedding of his brother-in-law MILTON FRISCH to NATALIE COURSE. After the wedding reception the subject proceeded with his family to the house located at 101 and 103 Carrington Avenue, Providence, Rhode Island. It was subsequently ascertained that LOUIS L. ROTTENBERG is listed in the Providence City Directory as the occupant of the apartment #101. The same directory lists 103 as vacant. The only reference to LOUIS L. ROTTENBERG in the files of the Boston Field Division is an article appearing in the Evening Bulletin, Providence, Rhode Island, dated June 18, 1934 which lists LOUIS L. ROTTENBERG as secretary of the Rhode Island State Socialist Party.

The subject HALPERIN subsequently departed from this address and proceeded to New York City. His wife and family departed at 8:15 PM and proceeded to Lynn, Massachusetts, where they arrived at 10:15 PM.

The New York Field Office was telephonically advised at approximately 11:45 PM on the night of June 23 that the subject was en route to New York City.

AT BOSTON, MASSACHUSETTS

Confidential Informant T1 advised that on the evening of June 21 after the subject had left the FRISCH home, 62 Rogers Avenue, Lynn, the informant's wife overheard some of the conversation of the FRISCH family concerning HALPERIN. Mrs. EDITH HALPERIN said that the subject is an idealist and no one will ever change him. Mention was made of his new Government job and the family indicated they were not enthusiastic about it even though it paid \$9,000 annually.

The subject's brother-in-law, SAULLY FRISCH, was heard to say that the subject is definitely anti-American.

Mr. HYMAN FRISCH stated that the subject got his appointment with the American Jewish Conference through the assistance of LIPSKY (apparently LOUIS LIPSKY) and it is time that the Jewish people in this country woke up.

Confidential Informant T2 identified the individual on whom the subject called at 89 Broad Street, Boston, Massachusetts, as BERNARD KAITZ, an employee in the office of the M. H. SAVAL Company, insurance broker. This informant who

is considered entirely reliable stated he has known KAITZ seven or eight years and considers him entirely reliable and he knows nothing derogatory concerning him. He further advised that KAITZ served in the United States Army up until about January, 1946 and saw action in Italy. At present he is residing in Everett, Massachusetts.

From the Boston City Directory it was ascertained in 1942 BERNARD A. KAITZ resided at 86 Ruthven Avenue, Roxbury, Massachusetts. According to the records of the Merchants Credit Bureau, Inc., 52 Chauncy Street, Boston, Massachusetts, KAITZ's wife is named ROSE and they resided at 558 Chestnut Street, Springfield, Massachusetts, and as of November 27, 1944 he was about twenty-nine years of age and was serving in the United States Army in Northern Italy. Inquiry concerning KAITZ was made at the office of Confidential Informant T3 with negative results. Inquiry was also made at Selective Service boards in Roxbury, Massachusetts, with negative results.

H. G. TULIPMAN

By letter dated May 23, 1946 the Washington Field Office requested the Boston Office to ascertain the identity of and furnish available background information concerning H. G. TULIPMAN, 68 Eastern Park Road East, Gloucester, Massachusetts, who was a correspondent of subject MORRIS HALPERIN.

The following investigation was made by Special Agent SAMUEL J. LEVIS.

The Gloucester City Directory, the Gloucester Telephone Directory and a check of the Assessor's records at Gloucester, Massachusetts, failed to reflect the name H. G. TULIPMAN or any person by the name of TULIPMAN in the city of Gloucester during the past five years. It is also to be noted that there is no Eastern Park Road East, Gloucester, Massachusetts. All the names of persons living on the following streets in Gloucester were checked with negative results: Eastern Point Boulevard, Eastern Point Road, Eastern Avenue and East Main Street. There is no Park Road or Park Street in Gloucester, Massachusetts. A check of the records of the North Shore Credit Bureau, Gloucester, also failed to reflect the name of TULIPMAN.

Sergeant EUGENE ALVES of the Gloucester Police Department advised that he believed there was an Eastern Park Road in Gloucester, New Jersey.

Sergeant Alves, Sergeant John Coyle and Marshal Wilfred Ellis of the Gloucester Police Department advised that they had never heard of anyone in Gloucester by the name of TULIPMAN.

You may possibly recall that Allan R. Rosenberg is one of the subjects in the Gregory case and who, since the inception of the Bureau's investigation, has discontinued his Government employment and is presently engaged in the private practice of law in Washington.

Information has been received through a confidential source covering the residence of Rosenberg to the effect that on July 8, 1946, Rosenberg returned to Washington after attending a convention of the National Lawyers' Guild in Cleveland, Ohio. The National Lawyers' Guild is reliably reported to be subject to considerable Communist influence having numerous known Communist Party members among its ranks.

Rosenberg advised his wife that he had served on the Resolutions Committee and that the Guild had adopted a resolution vigorously condemning Attorney General Tom Clark and asking for his removal unless he changes his policy. Rosenberg further stated that Assistant Attorney General Wendell Berge promptly joined the Guild and that Senator Claude Pepper also joined.

At 7:30 AM, July 10, 1946, Mr. John H. Fisher, a taxicab driver who resides at 1350 Queens Street, N.E., Washington, D. C., telephoned TRINIDAD 7481, advised that at about 2:00 AM on the morning of July 10, 1946, he picked up an unidentified man whom he dropped near the 900 block of N Street S. W. During the course of the ride to the destination, Mr. Fisher entered into a conversation with the unidentified man regarding prices of the OPA. Mr. Fisher related that his wife had purchased a cantaloupe for thirty cents and he told her not to buy any more at that price and other miscellaneous conversation. When the farer left the taxicab at the above mentioned address, the taxicab driver remarked "Do I sound like a Communist?" and the unidentified individual replied "No, but you ought to be". Later Mr. Fisher found a brief case on the seat of the car which he believed was dropped by the individual. This brief case contained considerable miscellaneous papers and a notebook all relating to world control of atomic information and it contained several business cards inscribed as follows: Daniel Melcher, Director of the National Committee on Atomic Information, 1749 L Street, N.W., Washington, D. C. National 5230. The brief case also contained names of numerous individuals and contacts. Mr. Fisher inquired as to whether or not the FBI would be interested in the contents of the brief case, and Mr. Fisher was advised that the FBI would be interested in the contents and that an Agent would contact him early this morning. The Washington telephone directory reflects a listing for Daniel Melcher, 476 N Street, S. W., telephone Executive 7236.

Mr. R. G. Fletcher was contacted and furnished the above information and he suggested that Mr. Robert Newby of the Washington Field Office be contacted so that an Agent of the Washington Field Office could proceed to the residence of Mr. John H. Fisher and obtain the information contained in the brief case.

Pursuant to his instructions, Mr. Newby was contacted and he advised he would send an Agent to the residence of Mr. Fisher as soon as possible.

Special Agent Newby of the Washington Field Office called with regard to the brief case of Daniel Melcher which was found in a taxicab by John H. Fisher, the chauffeur, and which the latter reported to the Bureau at 7:30 AM, July 10, 1946. Mr Newby advised that the brief case had been secured, all of the contents photostated and the brief case returned to Fisher so that he might return it as though in the normal course of business to Melcher. It will be noted that Melcher is a subject in the Silvermaster case, and Mr. Newby stated that the main item of interest in the brief case appears to be a set of answers Melcher has prepared and proposes to use in reply to charges brought against him by the National Committee on Atomic Information. The data of recovery from the brief case is being assembled at the present time and will be sent to the Bureau promptly.

ESPIONAGE - R (Refer 5 IB)

Reference is made to the ABE Summary dated June 24, 1946, wherein it is noted that at 9:12 a.m. an unidentified man contacted Olivia Abelson and told her that he is on a concentrated protein diet for stomach ulcers. He told her that there was a meeting of the dues collectors on the following Wednesday evening at headquarters to explain a new system of collecting dues. The man said that Weinstein will speak to them and that a card will be given to each member who will fill it in showing the date on which his dues are paid, and that the cards will be maintained at National Headquarters.

The Washington Field Office should make an effort to identify the unidentified individual who contacted Mrs. Abelson, it being noted that this individual complained of stomach ulcers. It will be recalled that the unknown subject "Jack" is alleged to have suffered from stomach ulcers and it is possible that the unknown individual may be identical with "Jack."

You may further recall that the various Russian contacts of Informant Gregory received from her dues which she had collected from subjects in Washington, and it is possible that the unknown individual may be instrumental in collecting dues for the Communist Party or the Soviet Government.

The New York Office should endeavor to determine through its various sources if Dr. Abraham B. Weinstein was in New York City on June 24, 1946, in order to eliminate the possibility of his being identical with the Weinstein mentioned above.

MARTIN ROBERT ROGERS
MAURICE HALPERIN

You will recall that Maurice Halperin is a subject in the Gregory Case and is presently employed by the American Jewish Conference in New York City. Martin Robert Rogers, an employee of the Office of Research and Intelligence of the State Department, is a close associate of Halperin and has been in contact with him frequently while Halperin was employed by the State Department and since his departure from the State Department.

On June 29, 1946, according to a source regarded as completely reliable, Halperin returned to his residence in Washington from New York City and had a conference with Bob Rogers and Rogers told Halperin that he wanted to tell him of some of the things going on at the State Department. He stated that MacRooney (phonetic) had granted his leave. Rogers added that he came across an amusing discovery — that if an employee had accumulated Compensatory Leave and had not been able to use it through the fault of the agency within ninety days, the agency had to compensate the employee for it in cash. He said he told MacRooney that if he preferred to pay him in cash, it was all right with him, but MacRooney said they would let it go as leave.

Rogers said that he had appealed his Efficiency Rating and MacRooney had agreed to arrange a hearing for him the week end of July 15, when "they're going to be here." Halperin asked Rogers if it would be necessary for him, Halperin, to be here at that time, but Rogers said he thought it would be enough for Halperin to submit an affidavit. Halperin asked Rogers if that wouldn't be a good time to present the photostatic copy of a certain letter. Rogers stated, "Certainly, I've already had it photostated." To this, Halperin laughed and exclaimed, "Boy, is that going to bowl something over?" Rogers indicated that Halperin could build his career on a letter like that.

Memorandum for State Department

Rogers inquired of Halperin if the latter had received his Efficiency Rating, and Halperin stated that he had received it that morning. He stated that the Rating was "Very Good." Halperin laughed and was amused at his Rating. Halperin said he wanted to talk the matter over with Rogers before he decided whether or not to contest his Rating.

Halperin said that he had received a communication from the State Department which was an interesting one and that he would tell Rogers about it when he saw him. Rogers stated, "Incidentally, the Department of Personnel answered the inquiry about you and gave a very fine answer." He said they listed the jobs that Halperin had held and the salaries received, and that the Department of Personnel had included the information that Halperin had resigned on May 31, 1946. Halperin was very interested in this and asked if it would be possible for him to obtain a copy of this letter and Rogers said that he would give him a copy. Halperin stated, "They played it quite correctly then," which Rogers confirmed. Halperin said that this was good news and Rogers remarked that hereafter Halperin can just give the State Department as a reference and that he will have nothing to worry about. Halperin agreed and thought the matter was hilariously funny.

You may also be interested to know that Halperin, in his connection with the American-Jewish Conference, carries the title of Secretary for United Nations Affairs. Halperin has described his duties as presenting the point of view of American-Jewish organizations to the United Nations. He said that the organization has a status of an observer and that they have applied for a status as consultants. He stated the organization is generally recognized as representing the American Jew. His offices are located at Fifth Avenue and 43rd Street, New York City.

Halperin recently stated that he hasn't started work with United Nations; that is, he hasn't officially registered with U.N.O., but intends to present his credentials in the near future. Halperin stated the individual he will contact is former Ambassador John Winant.

The foregoing is for your information and any action you deem advisable.

Information concerning activities and contacts of Dr. ABRAHAM WOLFSON, with aliases, also reported. Information indicates WOLFSON was married 3-31-46 to SARAH FRANCES TAYMOR of Chicago, Ill. WOLFSON'S bride has a sister, EVELYN MILLER, whose husband, SAM MILLER, is believed to be employed by the War Assets Corp. SAM MILLER is said to have recently returned from South America.

Dr. ABRAHAM J. SHAPIRO, NYC, who is alleged by an anonymous complainant to be a Communist, and whose wife was alleged to be a "Soviet representative". WOLFSON also is a close friend of one SAM SEGAL, a CP member, who is employed at the Brooklyn Navy Yard, Brooklyn, N.Y. A survey of other contacts of WOLFSON indicates many are CP members and associated with Communist front organizations.

DETAILS: All information reported in this report was conducted by several different agents assigned to the Newark Office and these Agents will be named in connection with each of the investigations reported herein.

I. RE: JOSEPH GREGG

A. Visit with brother, January 31, 1946 to February 2, 1946

Referenced telephone call from New York to Newark dated January 31, 1946 was a call from Special Agent EDWARD DOOLEY of the New York Office to Special Agent ELBERT T. TURNER of Newark, advising that information had been received from the Washington Field Office to the effect that subject JOSEPH GREGG was leaving Washington, D. C. at 5:00 p.m. on that day aboard a Pennsylvania Railroad train which was scheduled to arrive in Newark, New Jersey at 8:30 p.m. that day. Agent DOOLEY also advised that GREGG was scheduled to be met by his brother who lives in Maplewood, New Jersey, and whose identity at that time was unknown.

On January 31, 1946 a surveillance was maintained at the Pennsylvania Railroad Station, Newark, New Jersey by Special Agents FRANK M. RAISBECK, WILLIAM H. ROCKETT, JOHN ALDEN MUNN, and the writer. As a result of this surveillance, it was determined that subject GREGG arrived in Newark, New Jersey at 8:45 p.m. January 31, 1946 and was met by his brother, HARRY A. GREENSTEIN, and both proceeded directly to the latter's home, 89 Midland Boulevard, Maplewood, New Jersey.

On Friday morning, February 1, 1946, these same Agents maintained a surveillance on subject GREGG at 89 Midland Boulevard, Maplewood, New Jersey. It was determined thereby that subject GREGG left his brother's house with his brother at 8:40 a.m. and shortly thereafter the surveillance was lost. At 11:30 p.m. on that day subject GREGG was observed by these Agents, who had maintained a surveillance on GREGG'S brother, HARRY A. GREENSTEIN, to enter 201 Scheerer Avenue, Newark, New Jersey. At approximately 12:00 p.m. subject GREGG and his brother returned to 89 Midland Boulevard, Maplewood, New Jersey. The surveillance indicated that a poker game was in progress at 201 Scheerer Avenue, Newark, New Jersey.

On Saturday, February 2, 1946, these same Agents maintained a surveillance on subject GREGG and it was determined that he and his brother spent the morning shopping in downtown Newark. On their way back to GREENSTEIN'S home these ^{persons} visited at the Daughters of Israel Home for the Aged, High Street, Newark, New Jersey, where it is believed they visited their father. In the afternoon the surveillance revealed that subject GREGG and

his brother and family visited at the home of MEYER M. RUBIN, 302 Chestnut Street, Nutley, New Jersey. While in Nutley subject GREGG also went to the home of Dr. HARRY M. CHERASHORE, 363 Center Street, Nutley, New Jersey. At 7:00 p.m. subject GREGG, his brother and family left the RUBIN home and subject GREGG was driven to a streetcar stop from where he proceeded to the Pennsylvania Station in Newark. He took the 7:45 p.m. Pennsylvania Railroad train "The Arlington" to Washington where the surveillance was turned over to Agents of the Washington Field Division.

Investigation determined that one DAVID MINTZ and one HERSCHKOWITZ reside at 201 Scheerer Avenue, Newark, New Jersey. This information was obtained from the mail carrier who covers that address.

The Newark indices were checked with negative results concerning the following named persons all mentioned above: DAVID MINTZ, HERSCHKOWITZ, MEYER M. RUBIN, HARRY M. CHERASHORE, and HARRY A. GREENSTEIN.

The records at Local Board #37, 45 Branford Place, Newark, New Jersey were checked by the writer and Special Agent JOHN ALDEN MUNN and found to contain the following information concerning HARRY ALTON GREENSTEIN.

These records reflect that this person was born on March 28, 1897 in Russia. He is employed by HARRY A. SIMON & BROTHERS, 16 W. 19th Street, New York City. His wife's name is KAY M. GREENSTEIN. He formerly resided at 913 So. 20th Street and 10 Lehigh Avenue, both Newark, New Jersey. He is 5'5½" tall, weighs 132 pounds, white, brown eyes, black hair and dark complexion. His Social Security Number is [REDACTED]. He described his work as selling men's wear to retail stores. He added that he is a supervising salesman. He was married on February 27, 1937 in North Castle, New York. He listed the following relatives:

B. Visit with brother, February 14, 1946 to February 16, 1946

Referenced telephone call from New York to Newark on February 14, 1946 was a call from Supervisor KHURTZ to Special Agent ROBERT J. GRIFFITH of the Newark Office advising that information had been received by New York that subject JOSEPH GREGG had left Washington, D. C. at 6:00 p.m. aboard a Pennsylvania Railroad train. Information was also furnished that GREGG planned to stop with his brother, HARRY, at 89 Midland Boulevard, Maplewood, New Jersey and would proceed to New York City the following day to visit one Dr. WEINSTEIN.

A physical surveillance was maintained by Special Agents WILLIAM H. ROCKETT, JOHN ALDEN MUNN and HOWARD E. TRENT, JR. at the Pennsylvania Station, Newark, New Jersey on the evening of February 14, 1946 and it was determined thereby that subject GREGG did not arrive on the train which left Washington at 6:00 p.m. on that day. However, at 10:20 p.m. that evening subject GREGG was observed by these Agents making a call from a telephone booth in the Pennsylvania Station, Newark, New Jersey. The surveillance was maintained on subject GREGG and it was determined that he went to the home of his brother at 89 Midland Boulevard, Maplewood, New Jersey.

On February 15, 1946 a physical surveillance was maintained on subject GREGG by Special Agents FRANK M. RAISEBECK, WILLIAM H. ROCKETT, HOWARD E. TRENT, JR. and JOHN ALDEN MUNN. As a result thereof, it was determined that at 9:10 a.m. subject JOSEPH GREGG and his brother, HARRY A. GREENSTEIN left the GREENSTEIN residence and proceeded by car to the Pennsylvania Station in Newark, New Jersey at which place they parked the car and caught a Pennsylvania train to downtown New York. It was determined by the surveillance that GREGG proceeded to the dental office of Dr. WEINSTEIN at 20 E. 53rd Street, New York City and the surveillance was turned over to Special Agents FRANK NOLAN and JOHN DOYLE of the New York Office.

On this same day, February 15, 1946, the surveillance was again instituted on subject JOSEPH GREGG at the home of his brother, HARRY GREENSTEIN by Special Agents CALVIN B. HOWARD and JOHN ALDEN MUNN. Information was subsequently received by Special Agent JOHN ALDEN MUNN from Mr. JOSEPH ROBINSON, 88 Midland Boulevard, Maplewood, New Jersey, who is a former Special Agent of this Bureau, that at approximately 9:30 on the evening of February 15, 1946, he observed six men arrive in two cars at the GREENSTEIN residence. He later observed these men sitting around a table in the GREENSTEIN home and he did not believe they were playing cards. No information was available as to the license numbers of the autos or the identity of these individuals.

On February 16, 1946 a surveillance was instituted at 8:00 a.m. by Special Agents CALVIN B. HOWARD, WILLIAM H. ROCKETT and JOHN ALDEN MUNN on the GREENSTEIN residence, 89 Midland Boulevard, Maplewood, New Jersey. At 9:50 a.m. JOSEPH GREGG, his brother, HARRY A. GREENSTEIN and family were observed to leave the GREENSTEIN residence and proceed by auto to Newark, New Jersey. They proceeded to the Medical Towers Building, 41 Lincoln Park, Newark, New Jersey where Mrs. GREENSTEIN and one of the children left the auto and entered the building. While she was in the building subject GREGG and his brother drove to GOLDFINGER'S FURNITURE STORE, 176 Ferry Street, Newark, New Jersey where HARRY GREENSTEIN entered the store. He remained in the store about five minutes and then returned to the car and both men proceeded to the Pennsylvania Station, Newark, New Jersey. These Agents then observed subject JOSEPH GREGG enter car No. 3925 on the 10:45 a.m. train for Washington, D. C. The Washington Field Office was advised by telephone of the departure of subject JOSEPH GREGG.

C. Visit with brother, March 20, 1946 to March 21, 1946

Referenced telephone call from New York to Newark on March 20, 1946 was a call by Special Agent ZANBER of the Washington Field Office to Special Agent JOHN P. BRADY of the Newark Office advising that subject JOSEPH GREGG had left Washington, D. C. at 6:00 p.m. on the Pennsylvania Railroad train "The Mount Vernon", which train was scheduled to arrive at Newark at 9:44 p.m. Information was also furnished that GREGG was planning to stay with his brother HARRY GREENSTEIN, 89 Midland Boulevard, Maplewood, New Jersey.

A physical surveillance was instituted by Special Agent EVERETT J. ADOLF and the writer at the Pennsylvania Station, Newark, New Jersey and subject GREGG was observed by these Agents to alight from the aforementioned train and proceed by bus directly to the home of his brother in Maplewood, New Jersey. No further activity was noted on the part of the subject GREGG that evening.

No activity was observed on the part of subject GREGG during the evening. Referenced telephone call from New York to Newark on February 15, 1946 was a call from Supervisor ED DOOLEY of New York to Supervisor ELBERT T. TURNER of Newark wherein the New York Office advised that information had been received that subject WHITE was planning to spend a week with Dr. ABRAHAM WOLFSON. On Friday, February 15, 1946 the following investigation was conducted by the writer in an attempt to determine the residence address of Dr. ABRAHAM WOLFSON. Contact was made telephonically with Assistant Postmaster O'ERDEN of the Montclair Post Office, Montclair, New Jersey and he advised, after making inquiry among the carriers that he had no record of WOLFSON residing with MAX ALBACH at 14 LaSalle Road, Montclair, New Jersey (it is noted that referenced report indicates that Dr. ABRAHAM WOLFSON had resided with these people when they lived in Newark, New Jersey).

Special Agent BURTON H. MICHAEL telephonically contacted Confidential Informant T-1, whose reliability has previously been determined, who stated that after contacting the New Jersey Dental Society, the only information he could obtain was that WOLFSON was residing in New York City with a Dr. SHAPIRO whose address was not known. The writer, accompanied by Special Agent CHARLES LAWRENCE SMITH, made a survey of the area surrounding 31 Lincoln Park, Newark, New Jersey to determine whether WOLFSON'S car was parked in that vicinity, with negative results.

Special Agent FRANK M. RAISEBECK contacted Mrs. IMOGENE SMITH of the New Jersey Welfare Council, whose reliability had previously been determined, and she advised that Dr. WOLFSON was presently residing at 55 Spruce Street, Newark, New Jersey.

These agents also rang the doorbell at WOLFSON'S apartment, No. 310, and determined therefrom that no one responded in the apartment by ringing the buzzer to open the door.

After making brief stops at HEARN'S DEPARTMENT STORE and VIM'S SPORT STORE, at which places subject WHITE made purchases, these three persons drove directly to 151 Central Park West, New York City where they arrived at 5:45 p.m. All three persons entered the apartment at this address and at 9:45 p.m. the surveillance was turned over to Special Agents GEORGE SULLIVAN and GERALD CASWELL of the New York Office.

On Sunday, February 17, 1946, the surveillance of subject WHITE was conducted by Special Agents WILLIAM H. ROCKETT, CHARLES LAWRENCE SMITH and the writer and these Agents observed that at 10:00 a.m. subject WHITE walked from 55 Spruce Street to the office of Dr. WOLFSON. At 1:00 p.m. subject WHITE left the office building and walked toward downtown Newark. After having lunch he went to Loew's State Theater and attended the movie until 5:00 p.m. Special Agent WILLIAM H. ROCKETT occupied a seat directly behind subject WHITE and was able to observe him during the entire period. At 5:00 p.m. WHITE left the movie and proceeded by bus to Dr. WOLFSON'S office and shortly thereafter came out of the office and proceeded by foot to 55 Spruce Street, Newark, New Jersey, the home of WOLFSON. A check of the current city directory for Newark, New Jersey reflects that a Mr. WARREN S. BARTH is the manager of this company. Also listed at this same address and using the same entrance is the CHURGIN DENTAL LABORATORIES, INC. The president of this company, according to the current city directory, is LEOPOLD CHURGIN. The treasurer of the company is HARRY E. HESS.

The Newark Field Division indices were checked for information concerning the S. S. WHITE DENTAL MANUFACTURING COMPANY and it was determined that a plant survey had been made at that company by the Army. This survey was not available in the Newark Field Division files inasmuch as it had been forwarded by letter to the New York Field Division. No other information appeared in the files concerning this company.

A check was made with negative results against the names of the following individuals and company:

According to this same informant, WHITE maintains a checking account with the First National Bank of Boston, Jamaica Plain Branch, which usually has a balance in three figures.

The records of the Department of Corporations and Taxation, State House, Boston, Mass., disclosed that the Barnstead, Still & Sterilizer Corporation was organized in 1916 for the following purpose:

"To carry on the business as principals or agents of manufacturing, buying, selling, and dealing in water stills, sterilizers, and hospital and manufacturers' supplies and any other business which may seem calculated directly or indirectly to enhance the value of or render profitable any of the company's property or rights or to be conducive of any of the company's objects."

The balance sheet reflected a surplus of \$124,252.36, and total assets and liabilities of \$195,901.18.

Inquiry at the Office of the Town Clerk disclosed that ABRAHAM WHITE and his wife MILLICENT M. WHITE are listed as registered voters as of January 1, 1945. At that time WHITE'S age was given as 40 and his wife's as 35. Inquiry at the Office of the Town Assessor reflected that the home in which the WHITES reside, at 41 Tennyson Road, is assessed in the name of MILLICENT M. WHITE in the amount of \$9,850.

ERNEST FISHER, Chief of the Wellesley Police Department, and Officer FLEMING of that Department have advised that ABRAHAM WHITE is not known to them and their records contain no derogatory information concerning him.

JOHN SULLIVAN, mail carrier on the route covering Tennyson Road, advised that he has been delivering mail at the home of ABRAHAM WHITE for a number of years but that he has no information on WHITE or his activities. He stated that WHITE resides with his wife and their three children and the mail received at this address is very light. Mr. SULLIVAN has never noted anything in the line of out-of-State or foreign correspondence coming to the WHITE address.

AT NEWTON, MASS.

Inquiry at Local Board 113, City Hall, Newton Center, disclosed that ABRAHAM WHITE registered under the Selective Training and Service Act

on October 16, 1940, and was assigned Order #1225. In his questionnaire he stated that he was General Manager and Vice President of the Barnstead, Still & Sterilizer Company and that his duties consisted of supervising, engineer, production, sales, distribution, purchases, accounting, etc.; and that for his work he received approximately \$135 weekly. He further stated that there were employed under him approximately 30 workers and that the company was engaged in the manufacture of equipment for the Army, Navy, defense plants, and hospitals.

An application for deferment was filed by the employer of ABRAHAM WHITE, stating that he was engaged in essential war work. This statement was signed by ALONZO J. SHADMAN, President, and described the work of the company as follows:

"It manufactures water distilling equipment to provide freshly distilled water for scientific research production of pure chemicals and pharmaceuticals in the preparation of intravenous solutions, blood plasma, penicillin, etc. Direct military uses include conversion of sea water and other contaminated water to drinking water by landing parties, etc., to provide pure distilled water necessary for storage batteries in submarines, tanks, planes, etc; Army and Navy hospitals, in connection with radar, radio and aerial photography."

As a result of the foregoing application, ABRAHAM WHITE was classified 2B by Local Board 113.
