

The close similarity in name and corresponding likeness of addresses led to the following investigation of RUDOLPH REICH.

It was ascertained that the Rio de Janeiro Red Book listed the firm, CHEMIFLORA LTDA. at Rua Dom Gerardo 46, telephone 43-6590.

(W)(X) [Source F furnished] the following information on the firm CHEMIFLORA LTDA. in a report dated November 8, 1945.

"CHEMIFLORA LTDA. is engaged in importing medicinal herbs and heavy chemicals for industries. The firm, organized in 1944, exports gums, waxes and herbs. It imports from the United States, England and continental Europe. Banking references are Bank of London of S.A., Banco do Distrito Federal, Banco de Providencia do Rio Sul and the Banco Andrade Arnaud. In 1944 the owner, RUDOLPH REICH, registered the firm with a capital of Cruzeiros 500,000 (U.S. \$25,000). At that time he had seven employees and his sales amounted to approximately Cruzeiros 3,000,000 (U.S. \$150,000) per year. The firm's trade references were listed as:

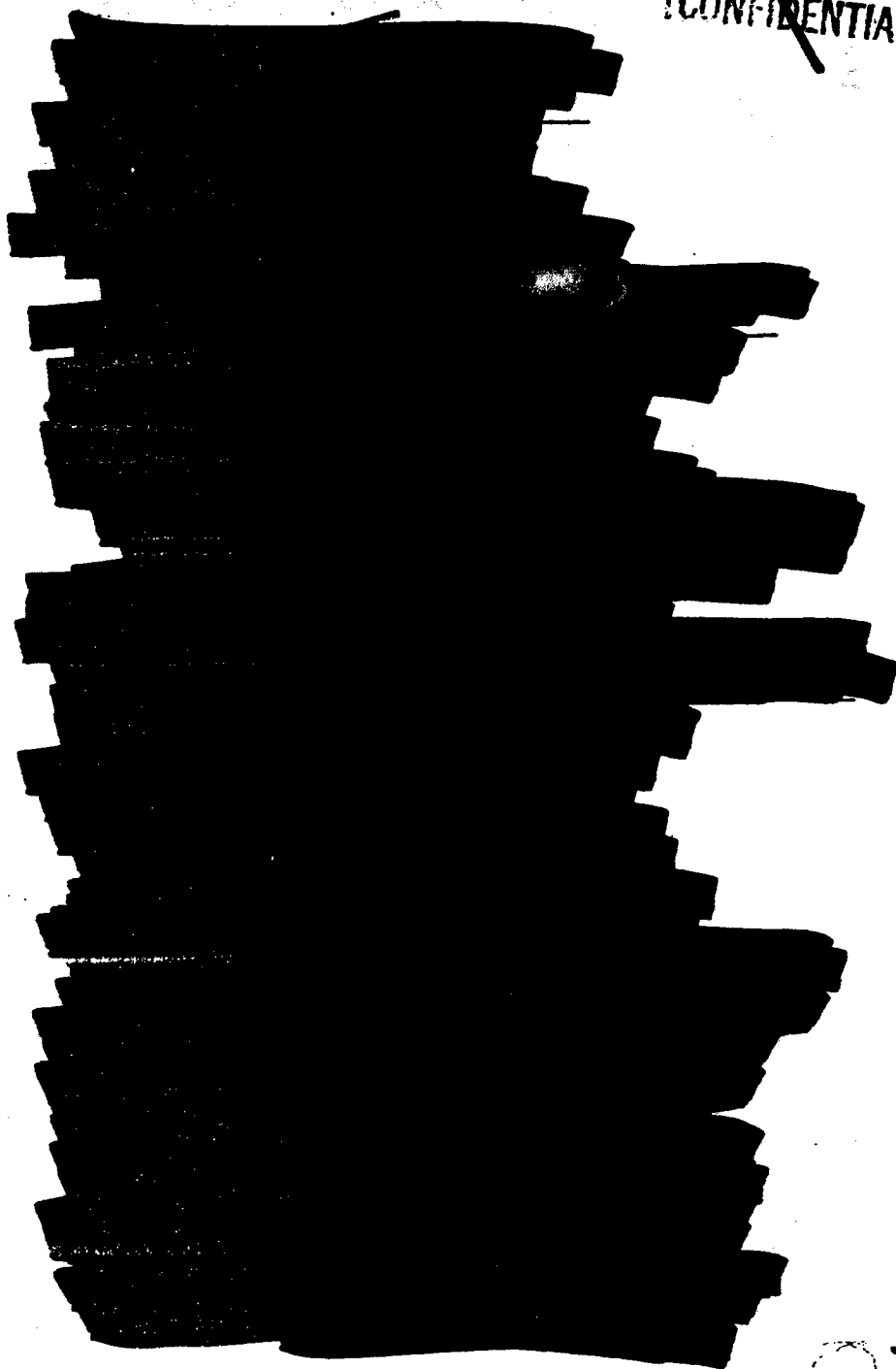

III. BERNARD S. REDMONT

(u) (X) [On April 6, 1946 highly reliable Source L advised] that BERNARD REDMONT, known Soviet agent, was scheduled to depart from Miami on April 6, 1946 via Pan American Airways and that he was en route to Buenos Aires via Rio de Janeiro. According to this source, REDMONT was proceeding to Buenos Aires to accept employment with WORLD REPORT, a publication of the United Nations Organization (UNO). It was stated that he was a former employee of the State Department. His description was set forth as follows:

[According to reliable Source O,] EGAN was a newspaper man in the United States prior to coming to Brazil about four years ago. This source advised that he has not noted any evidence of pro-Communist or pro-Russian leanings on the part of EGAN. [Source P]

(u) (X) [Source P advised] that FISHER is the brother in-law of EVELYN KILM. In a communication dated April 15, 1946 information was furnished by [Source (u) (u)] reflecting that KILM was an American residing at Rua Aparicio Borges 51, Apartment 1001, Rio de Janeiro.

(u) (X) [Highly reliable Source R advised] that the ownership statement of the newspaper "P.M." in October, 1941 listed EVELYN KILM of "Secretarial Service" as distinctly being a P.M. stockholder.

[Source P] who had occasion to take part in a lengthy conversation with EVELYN KILM advised that FISHER apparently had developed a well known reputation as a photographer in Europe during the war. As a result of this conversation it was reflected that at the present time he specializes in handling photographic assignments for the Office of Information and Cultural Affairs.

(c) [Information furnished by Source O] has disclosed that FERGUSON is the director of advertising and publicity in Rio de Janeiro for Pan American Airways. His headquarters are located at Avenida Rio Branco 85. His wife, RUTH FERGUSON, is the editor of an English-language weekly called the "Brazil-American" which has been published in Rio de Janeiro. [According to Source O,] FERGUSON gives the impression of being a typical democratic minded American. He has not expressed or demonstrated a pro-Communist attitude in conversations with this source. FERGUSON enjoys a good reputation in advertising circles in Rio de Janeiro although he appears to be inexperienced in this field. Although not confirmed, [Source O] declared that FERGUSON lately has been conducting a radio broadcast from Rio de Janeiro for the Columbia Broadcasting Studios. [Source O] is under the impression that FERGUSON has invested some capital in the "Brazil-American" inasmuch as he apparently spends considerable time with matters connected with the publication of this periodical. An examination of the Rio de Janeiro Red Book disclosed that the address, Rua Raul Pompeia 228, Apartment 402, bearing telephone No. 27-5893, is listed under the name of WARREN A. PINE, Jr. [Source M] recalls that the latter was employed by Pan American Airways in Rio de Janeiro in 1944. (c)(u)

8. United Press, Avenida Rio Branco 110/112, telephone No. 42-8000. The representative of this news agency in Brazil is JAMES ALAN COOGAN who resides at Avenida Rainha Elizabeth 277, Apartment 62, Telephone No. 27-6088. COOGAN is well known in Rio de Janeiro journalist circles. Information furnished by Sources S, G and D failed to reflect that [REDACTED] (c) b1

9. Associated Press, Rua Teofilo Ottoni 113, telephone No. 23-4273. The Rio de Janeiro representative of this agency is CHANDLER DIEHL. [Information furnished by Source T on August 15, 1945] reflected that DIEHL was well posted on economic, political and military matters in Brazil. According to this source there was no indication that DIEHL had exhibited or professed leftist or Communist leanings. (c)(u)

10. ROBERTO BOAVISTA. The Rio de Janeiro telephone directory lists a ROBERTO TEIXEIRA BOAVISTA at Rua São Clemente 137, Telephone 26-7173. According to Source D the latter is a [REDACTED]

[REDACTED] He is the son of ALBERTO TEIXEIRA BOAVISTA, the founder of the aforementioned bank and well known as an outstanding Brazilian banking personality. (c) b1

11. ANTONIO CAMILLO DE OLIVEIRA. Information furnished by Source U reflected the following. ANTONIO CAMILLO DE OLIVEIRA was born on May 28, 1892 in Itabira, State of Minas Gerais. He graduated from the law school in Belo Horizonte in 1914 and subsequently entered the Brazilian diplomatic service. He served in La Paz, London, Paris and Costa Rica. From December, 1939 to June, 1941 he was Chief of the Political Division of the Ministry of Foreign Affairs. In July 1944 he was a delegate to the Ministers' Conference held in Havana. He was one of the Brazilian delegates at the San Francisco Conference of 1945. (X)(u)


12. TIME MAGAZINE
JANE BRAGA
DONALD NEWTON

JANE GRAY BRAGA, a correspondent for TIME Magazine resides at Rua Prudente Moraes 125, Telephone 27-7576. She is a celebrated personality in Rio de Janeiro journalist circles and is well known for her aggressive, forward and outspoken manners. She has contacts in all circles, and according to Source O she counts known Communists as contacts. She appears to maintain these connections as general sources of information, and there is no specific evidence reflecting that she has been a Communist sympathizer. DONALD NEWTON, according to the same source, is technically BRAGA's superior in Rio de Janeiro. However, it is generally accepted in journalist circles that BRAGA is the dominating figure in the operations of TIME Magazine in Brazil. Source V who has been in contact with NEWTON on various occasions described him as an individual of negative personality. He stated he has not observed or noted any evidence of Communist leanings on the part of NEWTON. (X)(u)

13. HERBERT MOSES. The Rio de Janeiro telephone directory lists the above captioned individual's office as being located at Rua Rosario 112, Telephone 23-3917, and his home as being located at Rua Almirante Tamandare 15, Telephone 25-7070. [Information made available by Source W has disclosed that MOSES is a well known Brazilian lawyer, journalist and businessman who was born on July 27, 1884. He is the president of the Brazilian Press Association, a director of the Commercial Association of Rio de Janeiro, a member of the Association of Brazilian Artists, a member of the Institute of the Order of Brazilian Lawyers and is a director of the leading Rio de Janeiro newspaper "O GLOBO".] (A)(u)

Source S has stated that MOSES is a shrewd, clever individual capable of dealing with any journalists regardless of their political views. It has been noted by Source M that on several occasions MOSES has been seen conversing with JOCELYN SANTOS, a militant Communist and an officer in the Communist labor front organization, Movimento Unificador dos Trabalhadores (MUT). The same source has seen him in the company of PEDRO MOTTA LIM., former director of the Communist propaganda organ "TRIBUNA POPULAR". (A)(u)

14. BILL LARSEN. Attention has been given to the possibility that this individual may be identical to WILLIAM BURTON LARSEN who has been employed by RKO Pictures as a photographer.

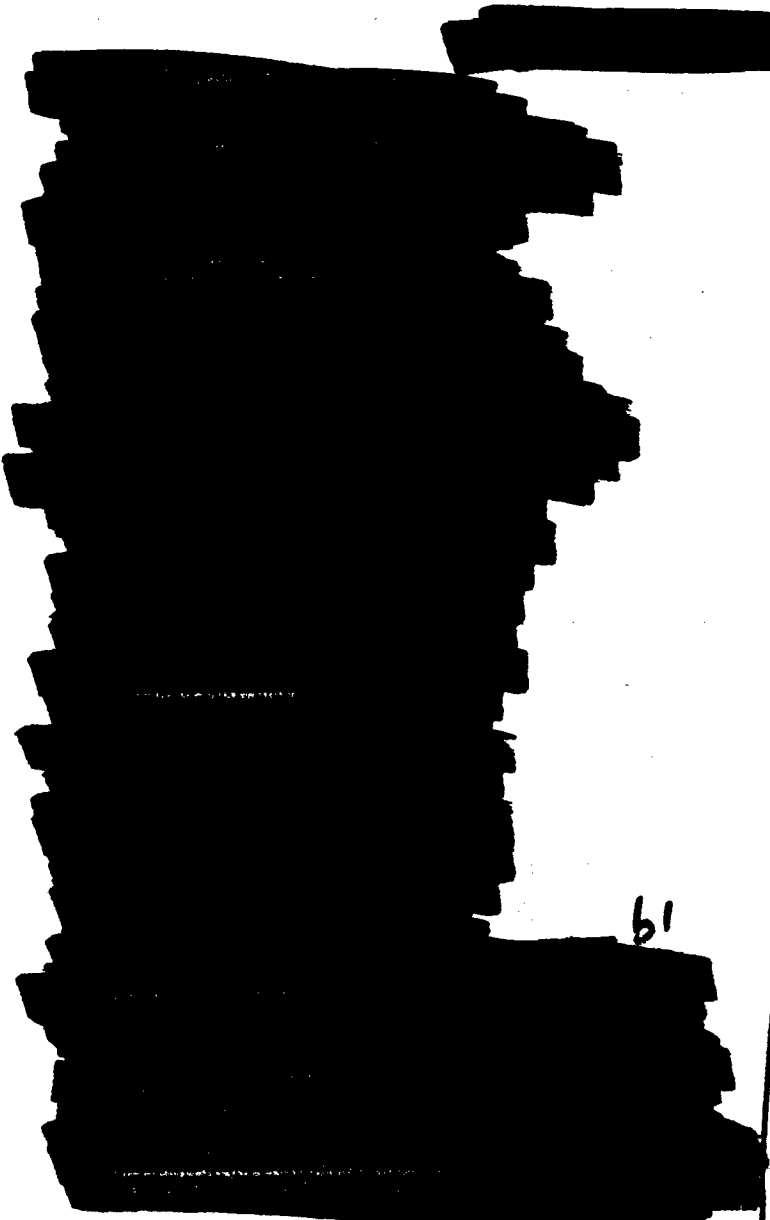

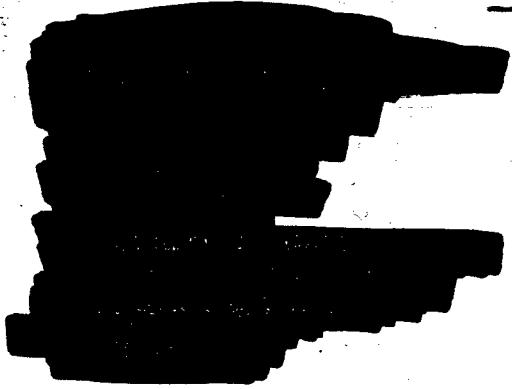
