Further reference is made to my memorandum to you in the above captioned case dated June 21, 1946, concerning the activities and contacts of the subjects Mary Jane and Philip Olin Keeney and specifically to your notation on this memorandum, "What has happened to these two individuals?" Pursuant to your request and for your information in connection with the above case, there is set out below a brief summary of the present status of the Keeneys in connection with this investigation.

You will recall that in December, 1943, Philip Olin Keeney departed for Japan on a nine months' assignment as a civilian employee of the GHQ, SCAP. You will also recall that from November of 1945 until the spring of 1946, Mary Jane Keeney served as a civilian employee in Europe of the Allied Reparations Commission. At the present time, Philip Olin Keeney and Mary Jane Keeney are residing in Washington, D. C., Philip having returned from Japan recently for a temporary visit and Mary Jane having severed her connection with the Reparations Commission after her return to Washington in the spring of 1946. Philip Keeney at the present time plans to return to Japan shortly after January 1, 1947, to continue his assignment there for an additional two years. It is known through the investigation that after he returns to Japan, he intends to lay the groundwork for Mary Jane Keeney, who is presently unemployed, to proceed to Japan to join him as the wife of a civilian employee of the Army.

At the present time, the Keeneys are among the most active subjects in the case, this activity being particularly widespread on the part of Mary Jane Keeney.

You will recall from previous memoranda that upon her return to the United States in the spring of 1946, Mary Jane Keeney brought a political testament of a deceased French political leader into the country with her and clandestinely delivered this testament to Joseph Milton Bernstein, a strongly suspected Soviet espionage agent who is presently under active investigation. You will also recall from previous memoranda that Bernstein in turn delivered this political testament to Alexander Trachtenberg, important Communist functionary, head of International Publishers, Party publishing house, and a suspected Soviet agent. The investigation of Bernstein and Keeney has reflected also that apparently during her service abroad in 1945 and 1946, Keeney, on a number of other occasions, transmitted material to Bernstein in New York.

Memorandum for the Director

At the present time and in recent months, the Keeneys have been in close and frequent contact with a number of subjects and close contacts of subjects in the above-captioned case. They are particularly close to Nathan Gregory and ~~SILVERMASTER~~ Helen Witte Silvermaster, principal subjects in the above investigation and have also been in frequent contact with William Ludwig Ullmann, who, you will recall, lives with the Silvermasters and is a subject of paramount importance in the above case. In addition, Mary Jane Keeney and, to a somewhat lesser extent due to his absence for a greater period of time from the United States, Philip Olin Keeney have maintained close and constant contact with a number of other individuals who are closely associated with subjects in this case or who are themselves subjects in this case. Among these of particular importance are the subject Maurice Halperin, the subject David Wahl, and the subject Ursula Wassermann as well as the subject Jules Korchein, who is Wassermann's paramour. In addition, the Keeneys have maintained frequent contact with a number of important Communist Party members and functionaries, including Morris U. Schappas, New York teacher, who has been an important Communist figure, Doxie Wilkerson, negro Communist functionary, and a number of Party members in the District of Columbia.

Of particular importance is the very close association between the Keeneys and Joseph Milton Bernstein. Recently, through a highly confidential informant, information contained in the personal correspondence and diaries of Mary Jane Keeney was reported, which information raises the definite possibility that both of the Keeneys have, for a number of years, been deeply involved in highly clandestine activity which may well constitute an operation of Soviet intelligence. It is noted that these diaries reflect that for several years Bernstein made regular trips to Washington to see the Keeneys, many of which trips were made at two week intervals. From this information, the definite possibility, if not probability, exists that Bernstein during these trips was acting as a courier between the Keeneys and possibly other persons in Washington and his principals, believed to be the Soviet Intelligence Service in New York.

In addition to the information set out above, you will recall that there are clear indications that Joseph Milton Bernstein is identical with the Joe Bursley (phonetic) who was described by Philip Jacob Jaffe of "Amerasia" in a conversation with Phil Roth, another subject in the Jaffe case, as a Soviet agent who had been instructed to take over Jaffe's contacts in the State Department. In this connection, it is noted that at the time Joe Bursley (phonetic) was supposed to meet with Jaffe, according to this conversation, the person who actually met with Jaffe was Joseph Milton Bernstein.

In addition, Bernstein has been closely associated with a number of important Communists of New York as well as several suspected Soviet agents. Of particular significance has been a close association with Gerhart Eisler, who, as you will recall, has been identified as the Comintern agent "Edwards" and who has written policy-setting articles for the past several years in the Party press under the pen name Hans Berger.

At the present time, the Keeneys are the subject of most intensive investigation in an effort to fully develop the significance of their activities and contacts. Every effort is being made in this connection to fully identify a number of individuals referred to in Mary Jane Keeneys diaries and correspondence by partial names, possibly cover named, and indicated by the text of this material to have been possibly engaged in clandestine activities.

ACTION:

The above is submitted for your information and pursuant to your request. Further developments of importance in connection with the above-captioned case will, of course, continue to be called to your attention.

In connection with the above-captioned case, you will, of course, recall that the up-to-date summary dated October 21, 1946, has been made available to the Attorney General for his review, consideration, and recommendations as to further action. You will also, of course, recall that on December 2, 1946, the Attorney General transmitted to you a memorandum in the above case requesting further information, requesting recommendations as to prosecution, and making certain suggestions. One of these suggestions contained in paragraph two of this memorandum was that the Bureau distribute summaries in the above case to all departments and agencies employing persons involved in this case. In connection with this suggestion of the Attorney General, you will recall that on my memorandum to you dated December 3, 1946, in the above case, you noted, "We now have A.G.'s instructions, so we will be required to comply as he directs."

At the above time, Mr. James L. McInerney of the Criminal Division of the Department of Justice telephonically advised that the Attorney General had requested him to review the up-to-date summary in the Gregory Case for the purpose of making appropriate recommendations as to prosecution or other necessary or desirable action and that he had almost completed his review of the summary. Mr. McInerney stated that he was of the definite opinion, after reviewing this summary, that a full and complete distribution thereof should not be made at this time to all employing agencies and departments in view of the fact that such a distribution would undoubtedly result in revealing information to unauthorized persons and might "blow" this case from a security standpoint.

In this connection, McInerney stated that he had discussed this problem also with Assistant Attorney General T. L. Caudle of the Criminal Division, who concurred with McInerney's opinion that a general, wholesale distribution should not be made at this time and consequently discussed this problem with the Attorney General on the late afternoon of December 9, 1946. The Attorney General, after discussing this matter with Mr. Caudle, stated that if the Criminal Division felt that no such general distribution should be made to all employing agencies at this time, he concurred in this recommendation, and he requested that the Criminal Division advise the Bureau of his decision and request that the Bureau at least for the present disregard the recommendation contained in paragraph two of his memorandum dated December 2, 1946.

Mr. McInerney stated that he was advising the Bureau telephonically pursuant to the Attorney General's instructions to Mr. Caudle. He was requested to have a confirmatory memorandum transmitted to the Bureau as soon as possible, and he stated that such a confirmatory memorandum would be prepared and transmitted to the Bureau.

ACTION:

The above is submitted for your information in connection with developments in the above-captioned case. In view of the above information, no general distribution will be made of the October 21, 1946, summary in this case at the present time to all of the employing agencies; however, it is strongly believed that copies of this summary should be made available at this time to Mr. Fred Lyon of the State Department for his personal and confidential information; to Major General Stephen J. Chamberlin of G-2; to Admiral William D. Leahy, Chief of Staff to the President; and to Mr. George Allen for the attention of the President. You will recall that the previous summary in this case dated February 21, 1946, was distributed in this fashion but that copies of the summary dated October 21, 1946, have so far been distributed only to the Attorney General, to Mr. Gus Vanech of the Department at the Attorney General's request, and the Secretary of State pursuant to his request. You will recall however, that the original summary was not sent to Mr. Allen but to General Vaughan and apparently was never called by him to the attention of the President.

If you approve, appropriate personal and confidential letters will be prepared transmitting copies of the summary dated October 21, 1946, to Mr. George Allen for the attention of the President, Admiral Leahy, Mr. Fred Lyon, and General Chamberlin. It should be noted that there is nothing in the Attorney General's suggestions which bars this limited distribution at this time.

Further developments of importance in this matter will, of course, continue to be called to your attention.

GREGORY, ESPIONAGE R. [ON DECEMBER SIX FITZGERALD CONTACTED MAGDOFF WHO ADVISED HE HAD LUNCH WITH NORT LONG, NHA, WHO WAS LOW. MAGDOFF ALSO INDICATED HE TALKED WITH VEET BASSIE WHO WOULD SPEAK TO AL AND SEE WHAT COULD BE DONE. MAGDOFF MENTIONED AL HAD LUNCH AT COSMOS CLUB WITH ENGEL AND MAGDOFF SURMISED THAT THEY WOULD REQUIRE A MAN WHO IS A NEW ENGLANDER. FROM ABOVE IT APPEARS MAGDOFF IS ENDEAVORING TO ASSIST FITZGERALD IN SECURING A DIFFERENT POSITION WITHIN COMMERCE DEPARTMENT. INFORMANT ALSO ADVISED FITZGERALD HAS INDICATED HE WOULD VISIT NEW YORK DECEMBER TEN TO SEE MOTHER.] ON DECEMBER SIX MARY JANE KEENEY CONTACTED BEN ALPER WHO INDICATED WIFE ETHEL WAS SICK AND THEY WOULD NOT BE ABLE TO MEET WAHLS AND UNWAYS. MARY JANE EXPRESSED EAGERNESS TO HAVE ALPERS MEET WAHLS. MARY JANE INDICATED SHE WOULD NOT ACCEPT THE RADIO ASSIGNMENT AS THEY HAD BACKED DOWN ON AGREEMENT. SHE STATED SHE VOLUNTEERED FOR FIFTEEN MINUTE PROGRAM THREE TIMES A WEEK. PRESUMABLY THIS REFERENCE IS TO HER ASSOCIATION WITH METROPOLITAN BROADCASTING COMPANY. MARTY (dog) and I have been together today because I have a feeling that when I take him to BOSLEY'S tomorrow (Sunday) I am leaving him there until you return. Beginning tomorrow, Sunday, my schedule will be crowded. I am seeing DAN LEVIN tomorrow, eat dinner at TODDS (LARRY TODD) and eat supper at MIRIAM'S (RAIGLE). On Monday I have a little shopping to do and hope to have a final confab with DAVE MAHL who has been in NYC a good deal the past 2 weeks. On Monday eve I dine chez HELEN S. SILVERMASTER. On Xmas I go to dinner with LOIS GARLISLE and then to JACYS (MARSAKA). This means that Marty will stay in his school but I think he is fairly contented there and he will be well cared for. Wednesday and Thursday will be filled with last minute things. I do not get my orders until Thursday and this means probably several hours at the Pentagon where things go slowly. When all details are ironed out, I may try to get another cable off to you in Berlin according to McLEW'S directions. I will certainly cable you from Tokyo and, of course, send my APO # to you before I leave Washington.

I have been in a very strange frame of mind during this whole business. I have never been greatly excited about the trip, because it always seemed to be yours by right of knowledge and understanding. However, our friends including THOMAS have made it clear that there is a job to do and it falls to my lot to do it. On this basis there is nothing for me to do but do it and I am game to deliver according to my best judgment. We have some good people along even is no one is strictly kosher, not even M.S. I shall caution care and mind my P's and Q's.

Tonight I have had a rare time going over your letters, because I want to take several with me on my travels during the next 3 days. I hope you continue in Berlin to write down all of the things you wish to remember as you have done. I am sorry that I began when I did to address your letters to Berlin. I am afraid the latest you got in Paris, particularly those from New York and the last two or three from Washington, left you with a most unsettled feeling. I am sorry about this. My delay in departure has had a debilitating effect on me, because I thought there was a vague possibility something might prevent SD (State Department) from coming through. This thought would probably have never entered my mind if I had not been fully aware of the situation and all implications. A little knowledge may be a dangerous thing, but too much understanding plus delay may be upsetting to one's equilibrium. The fact that my p.p. (passport) came through fills me with pleasure regardless of the final outcome.

1. He is taking car and will run it enough to keep in trim. RAY did not want it after he saw Baltimore traffic, but RAY is spending Thursday night with me and driving me to airport at 7 AM on Friday.

2. DAVE'S cousin, SOPHIE, may take our apartment for month of January as she will be discharged Feb. 2, 1946. If this does not work out, DAVE will see what can be done to keep someone here until your return. Col. AUTRY decided it was too far from his work.

3. DAVE and EDITH are giving me a note for \$750 which DAVE'S Father and brother will use in the plumbing business which is now prospering. Interest @ 4 1/2 %. This money will be used for supplies and other materials. DAVE and EDITH have 4,000 bonds and as DAVE says he is more liquid now than at any other time.

The total situation looks less SWEALED than at any recent date. I have packed trunk and got material at hand to pack in bags. It looks as if there would be room to spare, but not much weight except in trunk for state-side liquor.

I only hope you will find conditions in Berlin such that you can feel you are accomplishing a little something. I have been told to relax on my trip and accept it as a vacation except for the fact that I am to see all that is to be seen and talk with as many TOMS, DICKS and HARRYS as I find, and make as many notes as seem necessary.

I have a swell time chez SILVERMASTER (NATHAN GREGORY SILVERMASTER) as you have had chez COT. The S's sent oodles of love and promised to write you. They were more than thrilled with your letters and GREG was greatly excited about the ANDRES (THERESA ANDRES, a Spanish librarian who was active in the resistance movement of France. MARY JANE KEENEY looked her up in Paris.). All said you should not feel that you were accomplishing little, for they thought your contribution was already large. It is really a wonderful family and as devoted to us as we are to it. I took HELEN (SILVERMASTER) a bottle of Calif. champagne which was drunk to you, my Beloved. I was given Hindus: The Cossacks and Simonov: Days and nights which I will take with me.

I am dining chez TRISTLE (BENNETT) tonight and may convey some message to MARTIN (BENNETT) for her. I am pretty much disgusted with him leaving you far out on a limb, but we can expect little from many of our fellowmen.

I had lunch today with BERNIE (KOREMAN).

1. LUCIAN (HILMER) seems to be kind of head man now and both DAVE (DAVID WAHL) and BERNIE will work on him to push your reclass. which became stymied due to the FEA-State mixup on consolidation or call it by any other name.

2. BERNIE has a place for you in State if you want it on your return. BERNIE holds you high and AL very low. B knows nothing about AL'S future.

3. DSS was reduced to a dozen and when the heads began to fall I knew there was no place for me. MORRISSE, Mrs. CRAWFORD and Miss FORRETT were saved as well as LAURA. The documents will be kept intact for the present. So long as BOWEN (SMITH) had tentatively saved myself, there was nothing for me to do about DSS except hold as much together as possible which I did.

There will be 500 or more to draw on even if I loan DAVE (DAVID WAHL) \$750. What does French devaluation mean? More inflation and higher black markets?

DAVE tells me that many are returning from Europe faster than expected due to frustrations and other discomforts. Anyone that goes and tries to find fault with the way things are run like PLANT finds them and get nowhere in curing them. PLANT is returning.

This leads me to think you may be back sooner than I anticipated, though in Berlin you may find yourself in a spot where you can do some good. I hope before your return you won't feel as if so far as work is concerned that your trip has been a complete fizzle. There is always the chance after you reach Berlin that you may hear from THOMAS.

Everyone without exception that has heard your reports to me thinks your trip has not been in vain. The things you have accomplished on your own have been very important. Your finding of the AIDRES (THERESA) was a wonderful piece of good fortune.

Beloved,

TC (TED COHEN) ate dinner with me last night and reported that SHIGA had brought a delegation of seamen in to his office. These seamen said they were always hungry and were greatly underpaid. T (TED) said SHIGA was frequently bringing in such delegations, but Socialist Labor Party never came in. SHIGA et al are trying hard to organize the hardest manual workers in Japan and according to T are making hay. It isn't expected that they will elect many to the diet this election. Nearly 2,000,000 voters have registered in the Tokyo metropolitan area. I have not seen any record of female registrants. There is a move on foot now to purge the women, for several played an important part in the war effort and belonged to a section of the IRAA.

We have had hot cereal twice in three weeks. When it is served we get no fruit which consists usually of either an apple or very small tangerine which sell on the streets of Tokyo for about a yen per each.

It's obvious that this is going to be a hungry year for Japan. I am sure it will not equal India's famine, but many people are liable to starve to death. Seemingly some wheat will be imported, but nothing has been said about rice importations.

The Japanese are completely on the defensive. Office interviews tend to be unenlightening unless the interviewees can be immediately put at their ease. They say that the best information comes as a result of dining out with the Japanese. I hope in another week or two to be invited out.

I have not seen more than half a dozen dogs on the streets and a few of these belong to GI's. Maybe the Japanese people do not go in for dogs. It would be very difficult to feed them.

Today's papers announce MORIN'S appointment. It begins to look as if the "left" would now have an opportunity to push through certain necessary reforms as well as re-write the Constitution. Japanese constitutional reform is going on. This will affect the House of Peers if it is not liquidated. It is to be hoped that attention in France will now be turned toward the 200 families, 200 too many.

Dear Love,

Your letters were treble good when I took the time to go over them slowly. I am glad you are sending the COES some things and every minute you can spend with the ANDRES (TERESA) will be so much gain. Even if you missed the Peri (?) service you will go to others and it seems as if you are covering much ground and meeting many people who are very important to us. The fact that you are not following the ball for USA is no fault of your own. The other experiences are of real meaning and significance.

We are now 6 divisions and I am working with MARGARET STONE, Lt. Commander MALCOLM who has been ill, and Major TILTON on local and prefectural elections, etc. Now, TILTON is an old New Englander, taught at Storrs which is Conn. Men's Ag. college, and according to MARGARET about the most conservative member of the Govt. Section. He dabbles in Japanese art and has other extreme characteristics. He attended Casa where he met CY and told him the New York reds wrote the guides. I am not worried about not getting along with him because that can be accomplished if it is worth the effort. If it was to give me an opportunity to see the country from the grass roots to the urban centers I would go for it. On the other hand, this may be the time to change and put my efforts behind the library survey. The more I have thought about the subject the more it seems as if someone will make a study of libraries if the U. S. remains in Japan. Whether I want to stay here a couple of years or more if that is necessary is a question to be solved soon. I do not think you want to come here for many months on account of the unsatisfactory living conditions. It may be better 6 months hence. If I could get this library project well begun on the next half year and then return on furlough so that you and I could talk it over that might be a tentative solution and I would be accomplishing something definite. I presume word from Col. THOMAS will be reaching us both in due course. I am certain that we will be reached when something turns up for us to do. I have the feeling, at any rate, that we are both on call now which is more than I have felt for months past. If no call comes, so what, because our whereabouts is on the map and we are ready. We have done everything in our power and that is all we can do.

Beloved,

We are in the midst of what may be an historical event of great significance. This is the time I need you or our Colonel. Our section is mixed up in it to the whites of the eye.

Later on I am to have a choice of assignments. It seems that the farming situation is to be examined from top to bottom and if it develops according to my plans it will be as exciting as libraries and probably more important due to the fact that so much of Japanese economy is part of the soil and will continue to be for many years. I am making no decision for several days. I still think someone will study the library setup, but it may come several months from now unless someone pushes it from the States and this seems unlikely at this moment. I intend to keep in touch with CI & E.

The gals are complaining about their quarters. They say it is so noisy they cannot sleep and the YWCA is over-crowded and things in general are messy. They have taken their complaints as high as possible and hope for action before long. Living conditions will certainly not improve as civilians move in as officers move out. It is fortunate in more ways than one that the winter has been mild so far.

It begins to look as if food in Tokyo would really be scarce by April 1. What the 2 million people will do then is no simple question. It would seem as if the vote would lean leftward as living conditions grow poorer. Japanese docility must reach an end-point somewhere. JCP membership is now 25,000, but its effect and teachings reach far greater numbers.

I have always wondered how DAVE (WAHL) got word to you of my Tokyo arrival. I have had no word from him or from LOIS, but I am hoping someone is getting some benefit from our message as well as ourselves. There has been a certain out of this world quality about your and my departures. What it adds up to will appear later on.

Beloved,

I have lost track of time and space, but it seems according to my calculations that I left USA 15 weeks ago. Much has happened in that time that relates to things we and our kind consider worth while. I have been pretty low in the mind on several occasions. During these spells I have interpreted, for the worse, statements in your letters and have answered same in a most unelegant manner. I apologize here and now for such actions and hope you will accept them. Our signals tended to be rather crossed up and our plays ran backwards, sidewise and in any old direction except toward the goal which is eventual joining up somewhere on this earth. I do not think that your return to 215 B St. NE added to my sense of separation from many things we both hold dear and have supported for years past. I knew your return would present a different set of problems based, in some measure, on your European experience. If I had any cause for serious regrets, it was my inability to meet with and converse with those French & German souls who had resisted so much for so long. I don't think that anywhere in my correspondence there is any hint to the effect that your forces and my forces might break due to contingencies we fail to control. Probably, I might not have come to Japan, had it not been for my serious confabs with Col. THOMAS. Now that I am here it seemed as if I were repeating the long dry spell that twice occurred while we were part of JOE B's (BERNSTEIN'S) plans. I should have followed GREG'S advice and relaxed. This is not so simple when you set in an earthquake area and suddenly find yourself absorbed in another problem, libraries, but not on top of it as may be the case now. In the Army you follow channels and to go out of bounds is a crime that can slow down everything worthy of accomplishment.

In looking back 15 weeks I can see several things I might have done, but I sat on the horns of a dilemma knowing that by sitting I would not be gored to any extent, but I allowed several of your letters to pucker me and I answered in a painful manner. I should have laughed off your contentions and have said that the two K's present a solid front against possible catastrophe. I don't think we would be as efficient as we are were we alone, n'est ce pas. Together we understand far more about the tick of the world than we do alone. You seldom fly off in as many directions as I do at the same moment, but there is an element of stability in my constitutional endeavor that has played a role in your own life since 1929. I want to see you now grappling with something that

I need said arms and I will, in turn, respond with all that is pent up within me.

Hay is slowly made in Japan, but I think we are moving ahead in library matters.

Summary

Pursuant to the telephonic request of Mr. Vanech, I am transmitting herewith a memorandum summarizing the participation of Harry Samuel Magdoff in the Gregory investigation which involves the underground espionage organization operating in various agencies of the Government. It is my understanding that you desire to furnish this information to the Secretary of Commerce since Magdoff is employed in that department.

I earnestly urge that you give very careful consideration to the overall facts in the Gregory Case before reaching a decision whether to make the information concerning Magdoff available to the Secretary of Commerce or to making the information developed by this Bureau in this case available to any other Government official. I believe that the decision in this regard should be held in abeyance until a final decision has been reached as to whether criminal prosecution will be undertaken against any of the subjects in this case. I urge this procedure because it has been the Bureau's unfortunate experience that, once the facts in a case of this kind are made available to the officials of other Government departments, these facts are widely discussed and become common knowledge on such an overall scale that the subjects themselves generally know the entire results of the Bureau's investigation. As a matter of fact, in this current case the Bureau furnished a copy of its earlier summary report, prepared last Spring, to the then Secretary of the Treasury, Mr. Fred Vinson, and I am now advised that this copy of the report has been "lost" and no trace of it can be found. Another copy of the report was furnished to the White House and a month or so later was unaccountably found in a desk drawer at the War Assets Administration. I do not intend these illustrations to be critical of the persons handling these copies of the report but cite them only as indicative of the fact that reports placed in the hands of persons who would normally be most careful with them have gone astray.

If the facts in this case are made available to the heads of Government departments as I have indicated, these facts will be widely discussed throughout the Government and probably the press with the result that it will be thereafter impossible for the Bureau

Memorandum for the Attorney General

to continue its investigation of the case because of the general and widespread knowledge of the facts, principles and ramifications of the case. I believe, consequently, that no distribution whatsoever should be made of the facts unless and until a definite and final decision has been reached as to possible criminal prosecution. If and when the facts are distributed to other Government departments, the Bureau will, of necessity, have to immediately discontinue the investigation because of the impossibility of continuing it when the facts and subjects are widely known.

Background

Harry Samuel Magdoff was born August 21, 1913, at New York City. He received a B.S. Degree from New York University in 1935 and also attended the University of Pennsylvania and the City College of New York in New York City. From 1936 to 1940 Magdoff was employed as a statistician by the Works Progress Administration (in July, 1939, changed to Work Projects Administration). Subsequently he was employed by the Advisory Commission to the Council of National Defense and on July 3, 1944, became an employee of the United States Department of Commerce where he served as an economic analyst. On December 26, 1945, Magdoff was appointed to the Fact-Finding Commission set up in connection with the General Motors strike. During March, 1946, Magdoff was transferred to the Office of the Secretary of Commerce.

Confidential sources have reported that during Magdoff's attendance at CCNY he was reported together with his brother, Samuel Magdoff, to be a Communist and to have associated with individuals known to be members of the Communist Party. During that same period it was reported that Magdoff was very active in the Social Problems Club of CCNY, a reported Communist front organization. While attending the University of Pennsylvania, Magdoff resided at 49 East Gliveden Street, Philadelphia, Pennsylvania, and according to confidential sources at that time was a subscriber to the Daily Worker, East Coast Communist Party newspaper, which was delivered to Magdoff under his own name at that address.

Implication in Soviet Espionage

The following information indicating the implication of Harry Samuel Magdeff in Soviet espionage operations has been furnished by an important and admitted Soviet espionage agent who was active in Soviet espionage work from approximately 1938 to 1945 and who severed his connections with the Soviet Intelligence Service in 1945. For obvious reasons of security, the identity of this admitted former Soviet agent is not being revealed and he is being referred to under the cover name, "Gregory." In connection with the information furnished by Gregory, it should be noted that for more than a year the most intensive investigation has been conducted on the basis of this information and has failed to indicate that the information furnished by Gregory is false in any material part whatever.

In 1938, Gregory, then a confirmed Communist, was furnishing information to a person known to him only as F. Brown, who has been identified as Ferruccio Marini, an important Italian Communist in New York City who has been frequently reported to have served as an agent of the Communist International. During the fall of 1938 Marini introduced Gregory to an individual originally known to Gregory only as "Tim" or "Timmy" who was subsequently known to Gregory as Jacob M. Coles (real name, Jakob Basin or Basin), and who was known to have been for many years a most important Soviet espionage agent. Gregory from 1938 until Coles died on November 27, 1943, served as a Soviet espionage agent under Coles' direction. (u)

From at least 1941 until his death in November, 1943, Jacob M. Coles directed the operations of a widespread Soviet espionage ring procuring highly secret and important information through a large number of individuals occupying positions of great importance and the highest trust in various agencies of the United States Government. Gregory was the courier and intermediary between Coles in New York City and these individuals in Washington, D. C. furnishing information, from the summer of 1941 until the end of 1944.

After the death of Coles, Gregory's efforts were directed for a short period by Earl Browder, then head of the Communist Party, USA and subsequently by a number of Soviet agents known only to Gregory by cover names and with whom Gregory was in frequent contact until late 1945. Many of these Soviet agents have not been fully identified, but it is known that the last Soviet superior with whom Gregory was in contact and who was known to Gregory only as "Al", was actually Anatoli Borisovich Gromov, former First Secretary (u)

of the Soviet Embassy in Washington, D. C., who departed from the United States at the Port of New York on December 7, 1945. During the period Gregory served as courier in this espionage operation, he made frequent regular trips to Washington, D. C. to collect information from the numerous individuals operating in Government agencies as a part of this organization. Much of the information consisted of undeveloped and developed film containing copies of highly secret and important documents, temporarily abstracted from the files of various Government agencies by the individuals involved. The film and other information were regularly delivered by Gregory to Golos and later to other Soviet superiors. *to u*

Approximately two months prior to the death of Jacob M. Golos on November 27, 1949, Golos advised Gregory that he had very recently made contact with another group of individuals in Washington, D. C. engaged in furnishing espionage information to Soviet intelligence. Golos indicated to Gregory that he regarded the acquisition of and the contact with this new parallel as extremely valuable. He did not at that time, however, identify the members of this newly acquired group to Gregory, nor did he advise Gregory of the type of information to be expected from the agents making up this group. Golos did indicate to Gregory that he had been placed in contact with this new group by Earl Browder, then head of the Communist Party, USA and that he had made the initial contact with the group in an apartment in Greenwich Village, New York City, pursuant to arrangements made by Browder.

Shortly after the death of Golos, early in 1944, Browder advised Gregory that Golos had been contacting a new group and stated he was anxious for Gregory to meet this group and take over the operation thereof. Browder told Gregory he would arrange such a meeting and approximately two months later he informed Gregory that such arrangements had been made. Pursuant to Browder's instructions, Gregory proceeded to the apartment of John J. Abt, identified by him as Counsel for the Amalgamated Clothing Workers of America, on Central Park, West, near 90th Street, New York City. Gregory was admitted by Abt to his apartment and Abt introduced Gregory at this time to four individuals all then employed in Government agencies in Washington and all presently subjects of active investigation in connection with the underground Soviet espionage organization in agencies of the United States Government. The individuals first introduced to Gregory by Abt were:

- Victor Perle
- Charles Kramer
- Edward Fitzgerald
- Harry Samuel Magdoff.

At this meeting in Abt's apartment a general discussion was held concerning the information these four individuals would be able to furnish Gregory for transmittal to Gregory's Soviet superiors. Gregory has stated that it was obvious that these individuals, including Abt, had been associated together for some time and had been engaged in some sort of espionage for Earl Browder.

A second meeting and possibly a third meeting were held in the apartment of John Abt between Gregory and various members of this group, which is generally referred to as the Parle group. At these meetings discussions were had also of the payment of Communist Party dues by these individuals.

At the time of the first meeting Gregory ascertained that Magdoff, who at that time had just returned from a period of approximately six months' hospitalization, expected to return to his job with the War Production Board and was uncertain as to what specific type of information he would be able to furnish.

Gregory later contacted Magdoff on a number of occasions when Magdoff did furnish Gregory with information, which Gregory described as meager information obtained by Magdoff from the War Production Board and which information Gregory in turn passed on to his superiors.

Gregory has advised also that Magdoff at the time of his contacts with him was a member of the Communist Party.

~~TOP SECRET~~Activity and Contacts Reflected by Investigation

Harry Samuel Magdoff has been intensively investigated since November, 1945, in connection with the investigation of an underground Soviet espionage organization (NKVD) in agencies of the United States Government. This investigation has involved also a number of other individuals closely associated with Magdoff and named by the informant Gregory, referred to in greater detail above, as having been implicated in this underground organization.

The investigation of Magdoff has established that he has been in close and frequent contact with Victor Perlo, Edward Joseph Fitzgerald, Charles Kramer, Solomon Aaron Lischinsky, and George W. Perazich, all of whom were named by Gregory as having been involved in this underground Soviet activity and as being members of the underground parallel, commonly referred to as the Perlo group.

As noted above, in 1944 when Gregory was first placed in contact with this group, the individuals present in addition to John J. Abt included Magdoff, Victor Perlo, Charles Kramer, and Edward Fitzgerald, all of whom are known through this investigation to be closely associated. In addition, Magdoff was known to be well acquainted with Abraham George Silverman, commonly known as George Silverman who, according to Gregory, was extremely active in this underground Soviet espionage organization under the direction of Nathan Gregory Silvermaster, until recently a highly placed employee of the War Assets Corporation.

The investigation of Magdoff has also reflected that he has been in close contact with Irving Kaplan. Gregory has advised that Nathan Gregory Silvermaster stated that Irving Kaplan was connected with the War Production Board and was giving information to George Silverman, referred to above, who in turn gave the information to Silvermaster who turned it over to Gregory. Gregory has advised also that Kaplan was a dues paying Communist Party member.

It is known also that Magdoff is acquainted with Harry Dexter White, former Assistant Secretary of the Treasury, who according to Gregory was implicated in this underground organization. Frequent contacts of both Harry Magdoff and his wife have been Arthur Stein and his wife Annie. Arthur Stein is known to be closely associated with the underground Communist Party organization in agencies of the United States Government in Washington, D. C.

Particular attention is directed to the information set out above indicating the close contacts between Magdoff, Kramer, and Perlo and the fact that Gregory was first introduced to Magdoff, Perlo, and several other individuals through John J. Abt. In this connection an important former Communist

who was active in Communist affairs and intelligence operations from 1924 until 1937 and who from 1933 until 1937 acted as liaison and courier between the known Soviet espionage agent Alexander Stevens and the Communist Party underground in the United States Government in Washington, D. C., has advised that during the '30's John J. Abt, Charles Kramer, and an individual known as Nathan Perlow who appears identical with Victor Perlo were members of this underground Communist organization. This former Communist and intelligence courier should not be confused with Gregory, but it is interesting to note that he occupied during the period from 1933 to 1937, a position closely paralleling the position occupied by Gregory during the period from 1941 to the end of 1944. The following information concerning the activities and contacts of Magdoff has also been reflected through the investigation of him.

It should be noted that Mrs. Beadie Magdoff, the wife of Harry Samuel Magdoff, has during the past year been in close and frequent contact with a large number of the individuals mentioned above as close contacts of Harry Magdoff, as well as with their wives. The following additional information concerning the activities and contacts of Harry Samuel Magdoff has been developed through the investigation of him.

On December 1, 1945, Mr. and Mrs. Harry Magdoff attended a showing of the picture "The House on 92nd Street". At a time during the showing of the picture when secret writing was being brought out on the screen, Mrs. Magdoff is known to have inquired of her husband, "Do you do things like that?" The exact definitive significance of this remark cannot, of course, be completely evaluated. Mrs. Beadie Magdoff has been extremely active in the affairs of the League of Women Voters in connection with which she has been in frequent contact with Mrs. Bernard Redmont, the wife of Bernard Redmont who, according to Gregory, furnished information to her in connection with these underground intelligence operations.

In addition, during the course of the investigation of Magdoff, Magdoff and his wife have been observed in contact with a number of other individuals who have themselves been implicated in Communist activity, and also with a number of other individuals who have been in close and frequent contact with other subjects involved in this same investigation of underground espionage activity and identified by Gregory as having furnished information in this connection.

MEMORANDUM FOR THE DIRECTOR

I do not believe we should make any distribution of the new summary report in the Gregory Case at this time. You will recall that at the request of the State Department a copy has been sent to them and copies have been referred to the Attorney General for review and advice as to what further action the Bureau should take. Pending a decision from the Attorney General, I do not believe we should send copies of the report to the White House or other Federal agencies first, because of the possibility of some leak of the information set forth in the report, and secondly, because the logical position of the government departments would be to ask the Bureau what action the Department of Justice is going to take and at this time we do not know. I believe, consequently, we should hold the transmission of the additional copies of this report to other government departments until the Attorney General advises us of the Departmental's program in connection with this case.

Mr. Roach personally delivered to Mr. George Allen this morning a copy of the Bureau's summary memora entitled "Underground Soviet Espionage Organization (NKVD) in Agencies of the U. S. Government". Mr. Roach explained very briefly to Mr. Allen the contents of the memorandum, and was informed by Mr. Allen that in view of the length of the memorandum, he intended to summarize it and pass it on to the President. Mr. Allen inquired whether a copy of this memorandum had been supplied to Secretary Byrnes and was told that Byrnes had received a copy.

Mr. Allen stated that he was not quite sure in his mind that President Truman was completely familiar with the ramifications of this matter and that he felt it his duty to call it to the President's attention. Mr. Allen stated that he was going to see the President this evening but that in view of the length of the Bureau's memorandum he would probably not have an opportunity to discuss it with the President in its entirety but intended to make mention of the fact that it was available and that the pertinent portions of it would be supplied to the President as soon as possible.

**HISS ELECTED TO HEAD
CARNEGIE PEACE FUND**

Alger Hiss of Washington, director of the Office of Special Political Affairs of the Department of State, was elected president of the Carnegie Endowment for International Peace yesterday at a meeting of the organization's board of trustees here. He succeeds Dr. Nicholas Murray Butler, who resigned in December, 1945, and became president emeritus.

The trustees also chose John Foster Dulles, alternate delegate from the United States to the United Nations, as chairman of the board.

An announcement explained that the trustees amended the by-laws last May to provide for a chairman of the board and a full-time president, who will be the executive officer. Mr. Hiss, it was said, will assume his new duties "as soon after Jan. 1 as may be possible and following his resignation from Government service."

Mr. Hiss was born in Baltimore, Md., on Nov. 11, 1904. He obtained his B.A. degree from Johns Hopkins University in 1926 and his LL.B. degree from Harvard Law School in 1929. He accompanied President Roosevelt to the Crimea Conference in 1945.

Mr. Dulles has represented this country at many international conferences. He was Governor Dewey's adviser on international affairs in the Presidential campaign of 1944.

Further reference is made to your letter to the Bureau and the Washington Field Office dated July 10, 1946, in response to a letter from the Washington Field dated April 16, 1946, requesting a list of all photographs which had been exhibited to the informant Gregory. A further review of the list of names of persons whose photographs have been exhibited to Gregory in the above-captioned case as set out in your letter dated July 10, 1946, indicates that there are a number of known or strongly suspected Soviet agents whose photographs have not been exhibited to the informant but whom the informant might possibly be expected to have had some contact with either directly or through one of her various Soviet superiors.

It is believed of particular importance to exhaust all possibilities of securing identifications from photographs and pertinent observations on the part of the informant Gregory before her recollection becomes impaired by a further substantial lapse of time. In view of this, you are instructed to immediately prepare and make available to the Bureau and the Washington Field Office a complete up-to-date list of all individuals whose photographs have to date been exhibited to the informant Gregory. In this connection, it is desired also that you review the photographs which have already been exhibited to Gregory for the purpose of determining whether in certain instances it might be advisable to exhibit to her other different photographs of the same persons where such photographs are available or can be procured in order to ascertain the possibility of her identifications of these persons.

You are also instructed to make a careful check to determine what additional photographs should be exhibited to the informant for her identification at this time. In this regard it should be recalled that while Gregory cannot, of course, be expected to identify from her recollection many of the individuals who have been the subjects of Internal Security - R and Espionage - R investigations, she herself was deeply involved in Soviet espionage operations for many years, and it is possible that many of the individuals now of interest from a Soviet espionage standpoint may either be known to her or may have been seen by her at one time or another. In instances of individuals that Gregory might be able to identify or furnish information concerning where photographs are not available, you should specifically advise the Bureau and a check will be made of the Bureau files to see if any photographs are available here. In the event no photographs are available at all, every effort should, of course, be made to procure photographs of these subjects at the earliest possible moment for exhibition to the informant.

The above-captioned case involves an extensive underground Soviet espionage organization operating for a number of years through individuals employed in various agencies of the United States Government. A 298 page summary memorandum dated October 21, 1946, entitled "Underground Soviet Espionage Organization (UKVO) in Agencies of the United States Government" has been made available to the Attorney General for his consideration. My memorandum dated December 6, 1946, in connection with this case, the Attorney General requested that you be furnished a copy of this memorandum for your information and assistance.

Pursuant to the Attorney General's request and for your personal and confidential information and assistance, there is attached a copy of this summary memorandum dated October 21, 1946, which delineates the activities of this Soviet espionage group, which included a large number of important Government employees. Pursuant to the specific request of the Attorney General also, I desire to impress upon you that the information contained in this memorandum is of the most completely confidential character. This espionage investigation is still in progress, and any dissemination of this information to any unauthorized person might seriously prejudice the further investigative efforts of this Bureau in this connection. Consequently, it is requested that you maintain this memorandum for your personal and confidential use only and that no information contained therein be transmitted to any outside person or agency, at least without discussing any such dissemination with this Bureau. For your further information in this connection and pursuant to the suggestion of the Attorney General, appropriate information concerning this case is presently being made available to the Government departments employing individuals who have figured prominently therein.

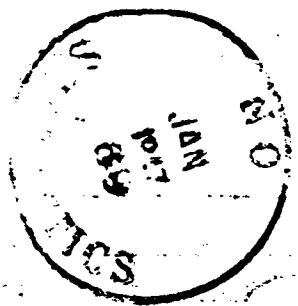

PERSONAL AND CONFIDENTIAL.

Dr. KARL ASHBURNE presently employed by University of Florida as Professor of Real Estate and Elementary Economics. He is regarded by University officials as reliable and loyal. ASHBURNE interviewed and states he first met SILVERMASTER in July, 1945 and was acquainted with him while he, ASHBURNE, was associated with War Assets Administration. ASHBURNE had only casual business contacts with SILVERMASTER and has no information regarding SILVERMASTER's background and present activities. ASHBURNE said that SILVERMASTER impressed him as being a person having a deep concern for the welfare of the American people.

age 41 and presently employed by the University as Professor of Real Estate and Elementary Economics.

The file reflected that Dr. ASHBURNE had received an A.B. degree from Texas Christian University in 1926 thereafter receiving a Master's degree from the same University. He received a PH.D. degree from Duke in 1934.

Prior to his employment with the University of Florida Dr. ASHBURNE had been High School Principal at Howe, Texas and from 1933 to 1937 Assistant Professor at T.C.U. and S.M.U. From 1937 to 1939 Dr. ASHBURNE was head of the Economics and Business Department of the Southwestern Louisiana Institute. From 1942 to 1945 Dr. ASHBURNE was employed by the United States Civil Service Commission as Regional Chief, Examining and Placement Division, Dallas, Texas. In 1945 Dr. ASHBURNE was Chairman of Boards and Awards and Chief Regional Economist with the War Assets Administration at Fort Worth, Texas.

Dean CHANDLER was unable to furnish any information regarding Dr. ASHBURNE as he said he had not become acquainted with him.

The records of the University also revealed that Dr. ASHBURNE had listed the following individuals as references:

Dean CALVIN D. HOOVER, Duke University
MONROE S. CARROLL, Chairman, Business School, Waco, Texas
EARL J. HAMILTON, Professor of Economics, Northwestern University
L. J. BUCHON, Dean, College of Commerce, Tulane University, New Orleans.

Dean WALTER MATHERLY advised that he was well acquainted with Dr. ASHBURNE and that the Dr. was appointed during the second term of the 1946 summer session at the University. Dean MATHERLY said that in his contacts with Dr. ASHBURNE he had been lead to believe that Dr. ASHBURNE was conservative and was not in any way radically inclined.

According to Dean MATHERLY Dr. ASHBURNE came to the University of Florida highly recommended and from all information available, was a high type of man.

Dr. KARL ASHBURNE was located at his home in Waldo, Florida at which time he advised he was 41 years of age and had been born in Whitesboro, Texas.

Dr. ASHBURNE said that he had first met SILVERMASTER in July, 1945 at Dallas, Texas and that he had never known SILVERMASTER before. Dr. ASHBURNE said that in July, 1945 he was being considered for appointment with the Research Division of the War Assets Administration which was then under the United States Department of Commerce and that he had been informed that NATHAN G. SILVERMASTER was the National Director of Research for the War Assets Administration in Washington.

Prior to Dr. ASHBURNE's association with the War Assets Administration, he said he was employed by the Civil Service Commission as the Chief of the Placement

Division at the original office in Dallas, Texas.

Dr. ASHBURNE said that inasmuch as he was being considered for the position of Director of Research for the Regional Office of the War Assets Administration in Dallas, that it was only natural that he should have contact with SILVERMASTER who was National Director of the War Assets Administration in Washington.

Dr. ASHBURNE said that he was introduced by SILVERMASTER by HAMILTON MORTON, who was with the War Assets Administration in Fort Worth and who had originally suggested that Dr. ASHBURNE talk to SILVERMASTER regarding his, ASHBURNE's employment by the War Assets Administration.

Dr. ASHBURNE said that his contacts with SILVERMASTER were limited to two in July, 1945 and that the only matters discussed with him were those pertaining to his, Dr. ASHBURNE's employment with the War Assets Administration. In August, 1945 Dr. ASHBURNE was appointed as Chief Regional Economist with the War Assets Administration, Fort Worth, Texas.

Dr. ASHBURNE saw SILVERMASTER no more until November, 1945 when Dr. ASHBURNE was requested to come to Washington, D.C. by SILVERMASTER, in order to look over the War Assets Administration set up in Washington.

Dr. ASHBURNE said that in compliance with SILVERMASTER's request he proceeded to Washington where he had numerous conferences with SILVERMASTER during the one week period that he was in Washington and that his conversations with SILVERMASTER were limited entirely to business discussions regarding the War Assets Administration.

Dr. ASHBURNE said that after leaving Washington he had only official correspondence with SILVERMASTER and did not see SILVERMASTER thereafter until June, 1946 when SILVERMASTER came to Fort Worth and Dr. ASHBURNE had dinner with him. Dr. W. J. HAMMOND of the History Department of Texas Christian University was a member of the dinner party on that occasion.

Dr. ASHBURNE said that the discussions which he had with SILVERMASTER at that time were again limited to business matters pertaining to the War Assets Administration.

Dr. ASHBURNE said that he had gathered the impression from SILVERMASTER's conversations that he, SILVERMASTER, had been associated with the United States government in various capacities since the inception of the New Deal and that he gathered that SILVERMASTER had also been Labor Economist for one of the Maritime Unions; also that he had previously been associated with the Farm Security Administration in Washington, D.C.

Dr. ASHBURNE said that SILVERMASTER had, during his limited contacts with him, impressed him as having a deep concern for the people of the United

States and that he was interested in the welfare, home life and in seeing that decent wages were obtained by the common working man. Dr. ASHBURNE said that there was never any indication as far as he was concerned, that SILVERMASTER was radically inclined or was engaged in any activities inimical to the best interests of this country.

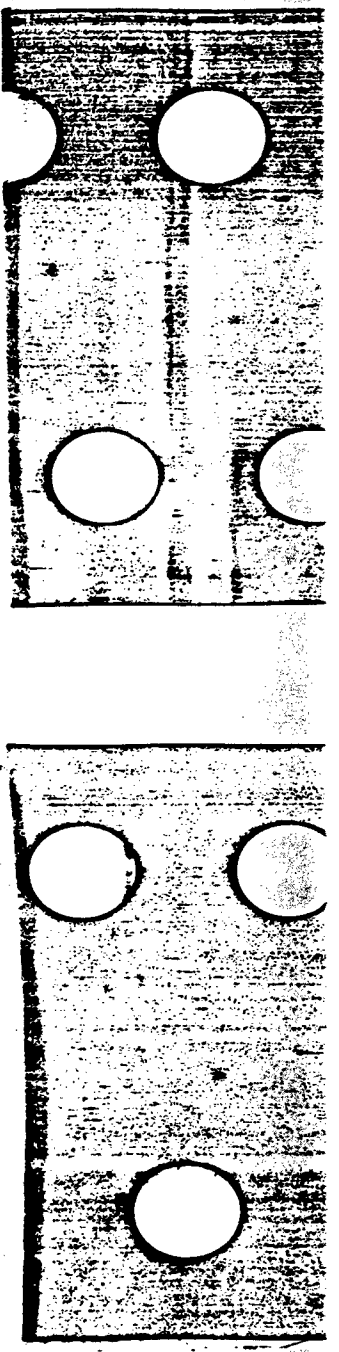

At the above time Mr. J. M. McInerney, of the Criminal Division, of the Department, who as you will recall has been designated by the Attorney General to review the above-captioned case for possible prosecution advised that he plans to be in New York City on Thursday and Friday, December 26 and 27 and possibly until Monday, December 30, 1946. Mr. McInerney stated that inasmuch as he is attempting to determine the prosecutive possibilities of the above-captioned case he would appreciate the opportunity, at sometime when convenient during the time he is in New York City, of discussing the possibilities of Gregory as a witness (appearance, vulnerability to attack, composure and so forth) with agents of the New York Office who have handled the informant Gregory. H. Belmont while he is in New York City to make arrangements to discuss the informant with the agents available who have handled Gregory.

The 1942 Directory of Medical Specialists reflects that LUMAN ELMER DANIELS, born 1895, at Woodstock, Illinois, received his M.S. Degree in Neurology at the University of Minnesota in 1932 and that he interned at the Cook County Hospital, Chicago, Illinois, in 1920 and 1921.

Confidential Informant #1, 

The records of the Colorado State Board of Nurses Examiners, 635 Majestic Building, contained an application for a permit to practice professional nursing as a war emergency nurse filed May 7, 1943, by ADELAIDE LOUISE KING DANIELS. This record reflects that Mrs. DANIELS was born at Chicago, Illinois, January 30, 1895, and she graduated from the elementary schools at Reading, Pennsylvania, 1909 and from the Reading High School in 1913. She graduated from the St. Luke's School of Nursing, Bethlehem, Pennsylvania, October 18, 1917, and was registered as a nurse by examination in Pennsylvania the same year. She spent one year in the Army Nurse Corps and four years in private nursing duty. The application stated that Mrs. DANIELS was returning to nursing to do voluntary work as Secretary of the Red Cross Nurses' Recruitment Committee. A letter from the State Board of Examiners for Registration of Nurses, Harrisburg

advised that Mrs. DANIELS was registered under No. 11426 on February 11, 1918, and that she has been considered inactive by the State of Pennsylvania since October 31, 1927.

Mr. HAROLD A. BAKER, Executive Manager, American Red Cross, 800 Logan Street, advised that Mrs. ADELAIDE DANIELS was Secretary of the Nurses' Recruitment Committee during 1943, 1944 and 1945. Her duties were to interview nurse applicants, take care of reports and generally handle the work of a Secretary for the Committee. Mr. BAKER stated that Mrs. DANIELS had been entirely loyal to the United States Government and that he had never heard her say anything which would indicate that she was in favor of any other form of Government. Mr. BAKER stated that Mrs. DANIELS was a very high type woman. He stated that she is approximately 5 feet 4 inches or 5 inches in height and that she has light brown hair.

Mr. W. H. WENDELIN, VAN SCHAACK and Company advised he has charge of the rental of the apartments at 21 East Tenth Avenue and that Dr. and Mrs. LUMAN E. DANIELS have resided at this address since May 10, 1943. He stated that they are satisfactory tenants and that he has no derogatory information concerning them. He suggested that Mrs. W. W. DIXON, 844 Humboldt Street, who was formerly caretaker at 1321 East Tenth Avenue, might be able to furnish information concerning Mrs. DANIELS.

Mrs. W. W. DIXON, Ritter Apartments, 844 Humboldt Street, advised she was caretaker at 1321 East Tenth Avenue for sixteen months during 1944 and 1945. Mrs. DIXON stated she is personally acquainted with Mrs. DANIELS and she considers her to be an excellent woman in every way. She stated that no meetings of any consequence were conducted in the DANIELS' apartment to her knowledge and that most of their friends were other doctors in the city of Denver. She stated that Mrs. DANIELS was very active in Red Cross work and that there was no question whatsoever in her mind as to her loyalty. She stated that Dr. DANIELS has been her doctor for a number of years and that he is considered entirely reliable. According to Mrs. DIXON, the DANIELS have a son, ROBERT DANIELS, attending school in Chicago, Illinois.

Confidential informants have advised that there is no indication that HAZARD is a member or active in the Communist Party of Colorado.

It will be noted that subject SILVERMASTER visited in Denver, Colorado, from 1:35 p.m., June 27, 1946, until 10:00 p.m., June 28, 1946, during which time a surveillance was maintained on him. SILVERMASTER made no contact with CHESTER HAZARD.

Mr. E. E. SCANNELL, Bureau of Labor, United States Department of Agriculture, advised that CHESTER E. HAZARD is a Health Service Specialist with the Farm Security Administration. He stated that this department will sponsor a health facility in rural areas where no hospitalization is available until such time as permanent facilities can be established. In his understanding that HAZARD travels the Rocky Mountain Region in this type of work. SCANNELL stated that he personally knows several former employees of the Farm Security Administration and that they have always spoken very highly of HAZARD, making no mention of anything which would indicate that he is not entirely loyal to the United States Government.

SCANNELL advised that he has had occasion to attend business meetings which were addressed by HAZARD, and that he considered everything HAZARD said to be entirely in order.

Mr. LIVERS, A. D. Wilson Company, advised that CHESTER E. HAZARD has resided in Apartment 11, 1575 Fillmore Street, at least since March 1, 1942, and that he has been an entirely satisfactory tenant.

LEO HAYS, caretaker at 1575 Fillmore for the past two years, stated that HAZARD has never said anything to him which would indicate that he is unloyal to the United States form of Government. He stated that HAZARD is a Government employee who travels approximately fifty percent of the time and that HAZARD has mentioned at various times that he was making trips into Wyoming, Montana, New Mexico and Texas. HAYS stated that, to his knowledge, the HAZARDS have conducted no meetings in their apartment. HAYS stated that although he personally does not like HAZARD because he considers him to be rather "hot-headed", he believes him to be entirely loyal to the United States Government.

By letter dated September 3, 1946, the Washington Field Division requested that the Denver Office attempt to identify AGNES-GROSSETT (phonetic) who was a guest at the Albany Hotel, Boulder, Colorado, on or about February 16, 1946.

It was also requested that the Denver Office identify a Mrs. SEEHORN who died while a guest at the Albany Hotel at Boulder, Colorado, about the same time.

The following investigation was conducted by Special Agent WILLIAM E. ROBINSON:

AT BOULDER, COLO.

Mr. R. J. BUSH, Manager, Albany Hotel, searched the records with negative results as to any individual being registered there on February 16, 1946, or adjoining dates by the name GROSSETT or under similarly spelled and sounding names.

Mr. BUSH stated that Mrs. SEEHORN resided at the hotel for a number of years with her husband, CLAUDE SEEHORN, who is an engineer with the Union Pacific. He stated that Mrs. SEEHORN died in a community hospital in Denver in February, 1946, and her funeral was handled by Olinger's Mortuary in Denver.

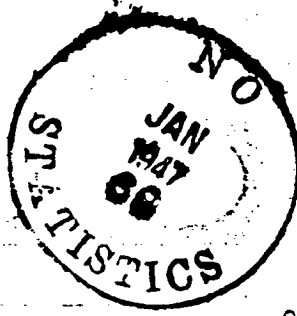

In a recent conversation with Mr. Gus Vanech, he inquired whether the Bureau believed it would be desirable for him to explain the ramifications of the Gregory Case in detail to the members of the President's Commission on Loyalty of Government Employees. After discussing this matter with the Director, I advised Mr. Vanech that the Bureau would be opposed to any discussion of the Gregory Case before the Commission at this time pointing out the probabilities that such discussion would result in leaks of information as to the nature and extent of the Bureau's coverage. I furnished to Mr. Vanech substantially the facts contained in the Director's memorandum of December 26th to the Attorney General outlining reasons why the Bureau did not feel the facts in this case should be disclosed at this time. 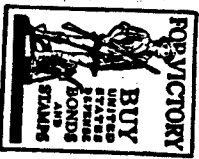
