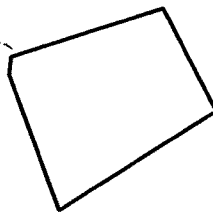
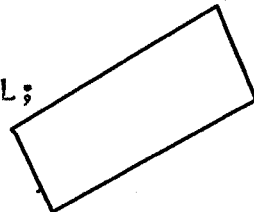

IT IS NOTED THAT AN ADDITIONAL PARTY MEMORANDUM WAS LOCATED IN THE STOCK. THIS COMMUNICATION, DATED JUNE 24, 1983, FROM THE "MILITARY LIAISON" OFFICER, FNU [REDACTED] WAS ADDRESSED TO MILITARY LIAISON IN NEW BRUNSWICK, NJ. ACCESS TO VARIED PARTS OF THE WOOD COULD BY VIA VIA NUMEROUS DIRT, GRAVEL AND PANED ROAD, FOOT PATHS AND FIRE BREAKS. THE AREA IS BASICALLY UNDEVELOPED.

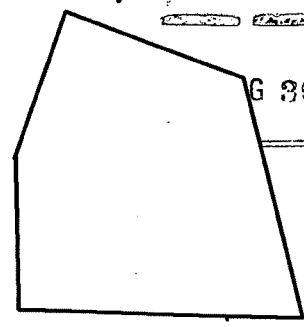

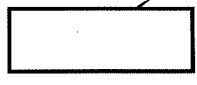

CAPTIONED MATTER WAS PLACED IN CLOSED STATUS ON NOVEMBER 8, 1982, BY PHILADELPHIA, AS INVESTIGATION CONDUCTED BY PHILADELPHIA, NEW YORK AND NEWARK FAILED TO IDENTIFY VIOLENT INTENT OR VIOLENT ASSOCIATIONS ON THE PART OF THE EASTERN SERVICE WORKERS ASSOCIATION (ESWA). IT IS NOTED THAT SINCE THE MATTER WAS PLACED IN RUC STATUS BY NEWARK ON JUNE 4, 1982, NEWARK HAS CONTINUED TO RECEIVE UNSOLICITED REPORTS FROM VARIOUS INDIVIDUALS, INDICATING A BELIEF THE GROUP CONSTITUTED A THREAT TO THE DOMESTIC SECURITY OF THE U.S. AS THE INFORMATION RECEIVED WAS SIMILAR TO PRIOR INFORMATION, NO INVESTIGATION WAS CONDUCTED.

ON AUGUST 1, 1983, NEWARK RECEIVED A TELEPHONE CALL FROM AN INDIVIDUAL IDENTIFYING HERSELF AS [REDACTED] (PROTECT b6 IDENTITY), WHO STATED SHE HAD [REDACTED] b7C GROUP [REDACTED] CALLER STATED SHE HAS BROKEN b7D WITH THE GROUP AND WISHED TO TURN OVER INFORMATION OF "VITAL IMPORTANCE" TO THE FBI.

[REDACTED] (PROTECT) STATED THAT THE TRUE NAME OF THE ORGANIZATION IS THE PROVISIONAL PARTY OF COMMUNISTS, USA AND IS REFERRED TO BY MEMBERS AS THE PROVISIONAL PARTY AND AS THE CPUSA PROVISIONAL. IT HAS NO CONNECTION TO THE COMMUNIST PARTY, USA (CPUSA). SHE * STATED THAT THE PROVISIONAL PARTY IS CONSIDERED "SECRET" AND OPERATES PUBLICLY UNDER THE COVER OF THE NATIONAL LABOR FEDERATION (NLF), ESWA, AND APPROXIMATELY FORTY OTHER PUBLIC GROUPS. THE PARTY IS DIVIDED INTO SEVERAL "FRACTIONS", WHICH ARE OPEN TO ALL PARTY MEMBERS (OR "CADRES") AND ONE "CLOSED FRACTION", WHICH IS A "MILITARY" FRACTION.

THE MILITARY FRACTION, BEING CLOSED, REQUIRES A MINIMUM OF ONE YEAR FULL-TIME PARTY MEMBERSHIP, COMPLETE WITH "POLITICAL EDUCATION, TRAINING AND EVALUATION". THIS MILITARY FRACTION IS ARMED AND PARTICIPATES IN REGULAR "DRILLS". AS THE SOURCE WAS NOT

SOURCE STATED A GUESS AT "OVER ONE HUNDRED" FIREARMS ARE IN "THE CAVE".

VAGE FIVE, NK 100-57407, ~~SECRET~~

A FORMAL SENTRY AND ALERT SYSTEM EXISTS AT THAT LOCATION, WITH SCHEDULED "SENTRY DUTY" AT A SECOND FLOOR WINDOW. THIS SENTRY HAS A VIEW OF THE ENTIRE STREET AND REPORTEDLY IF A STRANGE VEHICLE IS OBSERVED MORE THAN TWO TIMES, AN ALERT WILL BE CALLED. THIS IS REFERRED TO AS GOING INTO "RECEIVORSHIP".

DURING THESE ALERTS, ONLY MILITARY FRACTION CADRE ARE ALLOWED TO LEAVE THE ROOM IN WHICH THEY ARE LOCATED AND ARMED CADRE CAN APPEAR IN EVERY ROOM, REPORTEDLY WITHIN SECONDS.

SOURCE STATED THE MEMBERS ARE WELL TRAINED AND CAPABLE OF VIOLENCE IF THEIR OFFICE IS "THREATENED".

SOURCE STATED THE GROUP CLAIMS A PARTY MEMBERSHIP OF 15,000 AND CLAIMS TO BE ABLE TO FIELD "MILITARY CADRE" IN NUMBERS "SIZE OF THE LEBANESE ARMY".

SOURCE HAS BEEN TOLD THAT CLOSE TIES EXIST TO CUBA AND NICARAGUA. SHE HAS ALSO BEEN TOLD BY "CADRE" THAT THE PARTY HAS "SENT SOLDIERS TO NICARAGUA" AND BELIEVES SOME MEMBERS TO BE IN NICARAGUA AT THIS TIME.

SOURCE DESCRIBED THE PARTY AS A "REVOLUTIONARY COMMUNIST PARTY", TOTALLY DEDICATED TO REVOLUTION IN THE UNITED STATES.

VAGE SIX, NK 100-57407, SP

THE US GOVERNMENT AND ALL OF ITS AGENCIES ARE CONSIDERED MORTAL ENEMIES. PLANS ARE REPORTEDLY WELL UNDERWAY FOR THIS ARMED "TAKE OVER" OF THE US GOVERNMENT. THE "TAKE OVER" IS REPORTEDLY SCHEDULED FOR FEBRUARY 19, 1984.

PLANS EXIST FOR THE FOLLOWING ACTIVITIES TO OCCUR ON FEBRUARY 19, 1984: 1. UNSPECIFIED MILITARY ACTION, ON A COAST TO COAST LEVEL; 2. A GENERAL STRIKE BY TEMPORARY WORKERS; 3. STRIKES BY UNIONS UNDER THE PARTIES CONTROL; 4. A PRESS CONFERENCE; 5. COMPLETE TAKEOVER OF THE GOVERNMENT WITHIN 39 HOURS.

SOURCE STATED THE PARTY IS INVOLVED IN REAL ESTATE AND IN HORSE BREEDING. THE PARTY ESTABLISHED FOXFIRE BREEDING AND DEVELOPMENT CORP, IN NEW YORK, FOR THIS PURPOSE. IN ADDITION, THE PARTY HAS ESTABLISHED SEVERAL LAW OFFICES IN NEW YORK TO REPRESENT ITS INTEREST AND TO PROVIDE FUNDING. THE PARTY IS DIVIDED INTO SEVERAL "FRACTIONS" WHICH ARE OPENED TO ALL PARTY MEMBERS {CADRES}, AND ONE CLOSED FRACTION WHICH IS KNOWN AS THE MILITARY FRACTION.

THE MILITARY FRACTION REQUIRES A MINIMUM OF ONE-YEAR FULL-TIME PARTY MEMBERSHIP COMPLETE WITH "POLITICAL EDUCATION, TRAINING, AND EVALUATION." THIS MILITARY FRACTION IS ARMED AND PARTICIPATES IN REGULAR MILITARY DRILLS. ALTHOUGH THE SOURCE WAS NOT A MEMBER OF THE MILITARY FRACTION, THE SOURCE GAINED KNOWLEDGE REGARDING THE MILITARY FRACTION WHILE WORKING AT THE NATIONAL HEADQUARTERS OF THE CAPTIONED ORGANIZATION LOCATED IN NEW YORK CITY, NEW YORK.

This document reports the "elements of Phase II implementation." It reports "troop status" acceptances were received from [redacted]. [redacted] It discusses P.T. sessions not being held consistently, on a weekly basis. 2. A four page document dated September 22, 1981, addressed to all Political Commissors, regarding "Security." It states that Political Commissors (PCs) are responsible for security within their "arena" of Politbureau assignment. It states the document is to be filed in "Closed PC Files." It continues to warn of "clandestine sabotage" within the organization, as the "opposition" is aware of "offensive motion" and "have specific knowledge of Omega 7 operations." It refers to "doing some very heavy things" in several areas, not all of which are "visible."

3. A lengthy military training manual.

IDEOLOGY

1. A thirteen page essay entitled "Third Category Participation is Counterrevolution in Disguise." subtitled "Criticize the Third Herd." This essay refers to the Provisional CPUSA as the third largest, numerically, of its kind in the US, but with higher qualifications for full membership. It refers to the party as the "only clandestine organization" and as "the full-time professional revolutionaries. The report says the founders "fought and bled in foreign communists movements which have become the basis for the realization of revolutionary goals in the US." It defines and characterizes the varied types of revolutionaries and ends with a "reaffirmation of revolution."

2. "Statement of Principles." This large document includes an introductory portion, setting forth the philosophical justification for the organization's existence followed by a lengthy constitutional document.

3. A second copy of the "Statement of Principles," without the attached constitution.

4. A sixty-seven page document entitled "Class on the Analysis," marked "New Brunswick Copy" and "Via Courier Only." This appears to be a primer on Marxist views of history and describes the groups self image.

5. One page memorandum dated June 29, 1979, to all Eastern Political Commissors and all members. This document was a cover sheet for "Comments from a Comrade on the Analysis." It is believed to refer to item three above. The document sets forth security measures for the analysis. Areas explored via polygraph included assets observations of firearms at 1107 Carroll Street, Brooklyn, New York, the national office; the groups intent to instigate a violent "coup" on 2/19/83; the relationship between the front organizations and the revolutionary party and the origin of the voluminous documents provided by asset.

It is believed that asset's creditability is further enhanced by the large volume of specific information provided, as a great deal has been corroborated with similar information already contained in Newark files.

Additional verification of assets information has been obtained through "testing" of the asset during interviews, in an attempt to determine if asset could be "making up" or "fantasizing" parts of the story. Asset was asked about fictitious names and fictitious incidents and intrigues. Asset never "took the bait: in these traps. This seems to indicate asset is truthfully reporting what the group believes about themselves and their capabilities.

The following partial list of names of current and former members and associates of captioned organization has been compiled from a variety of sources, and is provided for the use of receiving offices. The list was compiled from [redacted] documents provided by asset and from information obtained from previous investigation. Several of these names were previously available only in phonetic form. Asset was able to provide correct spelling of these.

In addition to the successful completion of polygraph examination by [redacted] a detailed review of Newark files provided the following corroboration of assets information.

A Sacramento letter to the Bureau, dated 7/15/80, Sacramento (100-8023) captioned "PROVISIONAL WING OF THE COMMUNIST PARTY OF THE US; ET AL," relates information received from a [redacted] (protect identity) on 3/31/80. [redacted] alleged that he had joined this organization [redacted] and had only limited knowledge of the group, but alluded to a "militant armed cadre" within the organization. This general, limited information fits well within the detailed information provided by [redacted] down to names of organizations and leadership. Characterization were the same. New York asset described meetins at various churches in New York City and in a penthouse at 145 West 55th Street. Newark asset stated National Labor College (NLC) and other meetings, which are considered "secret" are held at various chruches and also provided the address of 145 West 55th Street, or 155 West 45th as a penthouse office used for the Additional Arenas (AD-AR) facility.

Both assets described documents being delivered in "pouches" by couriers.

The New York source stated that recruiting on college campuses was accelerated in 1979, to provide "solid members for the military four year plan." The Newark asset stated that 1979 marked a shift from a "defensive" posture to that of "accute offensive." All of the activities were placed on time programs and given deadlines.

[redacted] stated that military aspects were never discussed openly within the inner group. [redacted] independently claimed all business of the military fraction is considered "secret" and not discussed outside of the military, even with trusted interior cadre members.

A Philadelphia teletype to the Bureau, New York and Newark, discussed two former fringe members who confirmed the party's basic structure and gave conflicting reports of possible violence.

New York airtel to the Bureau, dated 2/3/82, confirmed several organizations described by [redacted]. It reported a letter received from a woman who attended NLC meetings in 1981. The letter spoke in vague terms of a revolution, uniformed guards at the meetings and the Marxist doctrines presented. The letter mentioned the guards with red stars on their berets and mentioned [redacted]

This appears to corroborate [redacted] reported observation of a weapon cache at NOC.

Newark Division and other public agencies have received numerous anonymous letters regarding captioned group. The writer of these letters was identified in Newark's previous investigation as [redacted] (protect identity). In an interview at Atlantic City, New Jersey, [redacted] stated he held fringe membership [redacted] During this time, he was not involved in the Military Fraction, but learned of it from other members. He reported having [redacted] weapon caches, safe houses, an armed cadre military training and a planned armed attempt to overthrow the US government.

All of the heresy information he provided is quite similar to that provided by [redacted] [redacted] and the Sacramento source. In addition to the above, on 4/26/82 and 4/28/82, the Piscataway Resident Agency received anonymous telephone calls from an unidentified male who stated his "girl friend" was a member of ESWA. He provided information which described an NLC meeting, which was remarkably similar to that set forth by other sources. He was told by a member, that "something big" is planned "within 24 months" and reported hearing a member comment "we're going to take over."

This anonymous caller declined to provide his name because he "fears" for his physical safety. The Atlantic City source reported being afraid he would be killed if the group learned he had gone to the authorities. [redacted] also reported being afraid of the group and a fear of violence caused asset to break with the group and report information known to source.

Newark verified the fact that members of the Military Fraction tried to locate asset for several weeks after departure.

In addition, documents provided by asset corroborate, as set forth in a previous communication [redacted] much of the above information, including the existence of the Military Fraction and a secret Revolutionary Communist Party.

Following the many hours of debriefing of asset, review of voluminous documents provided by asset combined with the similarity of information received from several individuals over a period of several years, it is the belief of Newark that instant group must be taken "for real," at least as far as what they think about themselves. It seems to be that members of the Provisional Party believe they will initiate some form of violent activity. Whether this will take place on 2/19/84, as alleged by asset is not known, nor is the nature of this action known.

On September 2, 1983, [redacted] provided the following information regarding the Provisional Party of Communists (PPC), United States of America (USA), also known as the Communist Party, Provisional (CP, P) and the Provisional Party (PP).

The Provisional Communist Party (PCP) was founded in approximately 1971 by a group of individuals, including [redacted] and an unknown fourth person. The PP was founded to be a revolutionary communist party whose goal is that of seizing control of the government of the US through military force. Asset was told repeatedly, over a period of more than one year, that the US government would be seized, through a coupe on February 19, 1984. The incident, referred to as the "Proscenium Tactic" is scheduled to begin at midnight on February 18, 1984. The members believe that within thirty-nine and one-half (39½) hours the US government will be under their control, probably through a capitulation. The Proscenium Tactic will include the following:

1. A general strike on both east and west coasts of unions under the control of the PP.
2. Jamming telephone lines of temporary employment agencies.
3. A national press conference.
4. Hiring halls to be opened through the Temporary Workers Organizing Committee.
5. Aggressive military action on a nationwide basis by the Military Fraction (MF). The nature of this action is not known by asset, as he was not included in the MF.

Following the founding of the PCP, a lengthy constitution was written, which has been combined with a lengthy "Statement of Principles," which defined the organizations structure and intent.

The constitution and Statement of Principals identifies the group as the PPC, USA, and as the Provisional Wing of the Party of Lenin. It refers to the "... closed, narrow and secret party of Lenin as the vehicle of revolution..." The party is defined as: "... a closed or narrow party..." whose "... actual name of the organization will appear on no documents, no propaganda." "The title 'Provisional Party' will act as a designate for inner Party documents." It later refers to the "... closed and secret party of Leninist Revolution."

In addition, the documents call for the establishment of "open" and "closed fractions." Asset stated the closed fraction is the "military fraction. The open fractions are the various "entities" established to service the "secret" party and to provide public fronts for financing, recruiting, training, and establishing a power base.

Asset stated that the party underwent a major change in 1979. Prior to 1979, the party was "all talk" with members "sitting around smoking dope in back rooms," with little being accomplished. In 1979, the party shifted from "defense" to an "accute offensive" phase. The new phase banned drugs and sex in order to become more efficient and instituted a "military" type discipline. Each member began to operate on the basis of a ~~daily "Battle Plan," in which each cadre members day is accounted~~ for, in writing, on a 24 hour basis. Each hour is accounted for in quarter hour segments.

The progress from part-time volunteer to full membership in the "interior" party is highly formalized and regulated through formal lectures, reading assignments, lectures and evaluation, under the sponsorship of two interior members.

The first stage is a "Tabular Volunteer." The Tabular is a person who volunteers, through one of the public organizations operated by full members, to donate money, run errands, make telephone calls, etc. Within three months to one year, this volunteer, after evaluation, may be upgraded to "Viable Volunteer." At this level, the volunteer can be counted on to volunteer whatever is requested. He begins attending the National Labor College and usually becomes aware, to varying degrees, of the Marxist or revolutionary aspect of the organization. He is placed under the jurisdiction of the cadre system.

The next stage, the "Tabular Cadre," may be full or part-time. He learns of the "Statement of Principles" and is assigned sponsors and given regular reading assignments. He gradually learns that the organizers are "professional revolutionaries."

The fourth step is that of "Viable Cadre." As a viable cadre, the member is fully committed to the revolution.

The final stage, "Full Member" or "Interior Cadre" comes after one year as viable cadre.

Only Interior Cadres are eligible for membership in the "Military Fraction."

Asset provided the following information concerning the groups, or "arenas" which are part of the PP:

Asset advised that the PCP is divided into 14 fractions, set forth as follows: Military, Legal, Business, Press, National Labor Federation, Association of Financial Aid to Students (AFAS), Parliamentary, Youth, Minorities, International and the National Foundation for Alternative Resources. Asset added that the AFAS, Youth and Minorities are considered in the "Politbureau Principal of Intertactical Suspense," which means they are not active.

In addition to the above, any activity not directly included in the above, such as medical, is handled under Additional Arenas (AD-AR).

Of the above, the Military Fraction is by far the largest, with many members of other fractions also holding military assignments. The military is considered a "closed" or "secret" fraction and is basically supported by all of the others. Asset stated that an "armed coupe" to overthrow the US government is the only purpose for the party's existence. Other fractions are used for recruitment, fund-raising and for legitimacy.

The National Office Central (NOC) is located at 1107 Carroll Street, Crown Heights, Brooklyn, New York. All operations, except on the west coast, are run from this location. This is considered secret by the PCP.

A Western Regional Office (WRO) is located in the San Francisco area. The name and location are not known at this time. This is considered secret by the PP.

Eastern Service Workers Association (ESWA) offices are located in the following cities: Philadelphia, Pennsylvania; Boston, Massachusetts; Rochester, New York; Trenton, Atlantic City, and New Brunswick, New Jersey.

The Eastern Farm Workers Association (EFWA) is located at Riverhead and Belleport, Long Island.

The Junior Eastern Community Service Center (JECSC) is located at the Riverhead, Long Island, facility. This facility was renamed for a Central Committee member killed in an automobile accident.

The Western Farm Workers Association (WFWA) is currently organizing a facility in the area of Phoenix, Arizona.

The California Homemakers Association (CHA) has a facility in several California cities.

The Northwest Seasonal Workers Association (NSWA) is located at Bedford, Oregon.

Western Mass Labor Action (WMLA) is located at Pittsfield, Massachusetts.

The Texas Farm Workers Association (TFWA) is active at McAllen, Texas (512-787-5984) and in Hidalgo, Texas.

The Western Service Workers Association (WSWA) has centers throughout California and the east coast area.

"public entity" and its connection with the PP is considered secret. NATLFED uses an address of 100 West 20th Street, New York, New York. This location is an answering service and mail drop. It uses telephone number (212) 924-8402 and mail box 830 at that location.

Metro 1 is located on East 14th Street and is used as a "safe house." This is an apartment used by "cadre" for sleeping and houses an office. Metro 1 is a procurement system, through which food, clothing, etc., is obtained for the NOC.

Design Studio, also known as Metro 2, is a commercial design studio. It is operated by [redacted] Design Studio prints, leaflets, and brochures. [redacted] assisted by [redacted] The studio is reportedly listed under [redacted] last name in the white pages.

AD-AR reportedly has additional apparatus in Nevada, Colorado, and New Mexico whose identities are not known to asset.

Asset added that all of the above "entities" are staffed by "interior cadre," many of whom are members of the "military fraction."

Asset added that the PCP includes numerous attorneys and medical doctors who are interior cadre. The following are known by asset to be cadre:

WHILE WORKING IN THE NATIONAL OFFICE, THE SOURCE OBSERVED FIREARMS ON SEVERAL OCCASIONS. THE SOURCE LEARNED THAT ONE ROOM IN THE HEADQUARTERS IS REFERRED TO AS "THE CAVE" AND IS KEPT GUARDED ON A 24-HOUR BASIS. ON ONE OCCASION, THE SOURCE OBSERVED THE DOOR OPENED AND BRIEFLY SAW A LARGE SUPPLY OF FIREARMS. THE ROOM CONTAINED THREE RACKS OF SHOULDER WEAPONS AND A NUMBER OF OLIVE DRAB DUFFLE BAGS WHICH APPEARED TO BE FILLED WITH FIREARMS. ON SEVERAL OCCASIONS, THE SOURCE OBSERVED FIREARMS BEING CARRIED INTO THE BUILDING, AND HAS IDENTIFIED THESE FIREARMS AS APPEARING TO BE .30 CALIBER CARBINES, AK 47'S, AND VARIOUS WEAPONS WITH SCOPES.

DURING THE SOURCE'S TENURE WITH THE CAPTIONED ORGANIZATION, THE SOURCE LEARNED THAT THE PROVISIONAL PARTY OF COMMUNISTS, USA IS A REVOLUTIONARY COMMUNIST PARTY, TOTALLY DEDICATED TO REVOLUTION IN THE UNITED STATES. THE U.S. GOVERNMENT AND ALL OF ITS AGENCIES ARE CONSIDERED MORTAL ENEMIES. PLANS ARE WELL UNDERWAY FOR AN ARMED "TAKEOVER" OF THE U.S. GOVERNMENT. THE TAKEOVER IS REPORTEDLY SCHEDULED FOR FEBRUARY 19, 1984. ON THIS DATE, THE CAPTIONED ORGANIZATION WILL ENGAGE IN UNSPECIFIED "MILITARY ACTIONS" ON A COAST TO COAST LEVEL.

NOTE CONTINUED:

SOURCE INFORMATION, CORROBORATED THROUGH POLYGRAPH EXAMINATIONS, HAS INDICATED THE GROUP HAS WEAPONS, HAS ENGAGED IN WEAPONS TRAINING, AND IS PLANNING SOME SORT OF "MILITARY ACTION" ON FEBRUARY 19, 1984. BASED ON THIS INFORMATION, A FULL DS/T INVESTIGATION WAS INITIATED ON THIS GROUP.

THE CAPTIONED ORGANIZATION HAD BEEN THE SUBJECT OF A DS/T INVESTIGATION IN 1982; HOWEVER, THE INVESTIGATION FAILED TO SUBSTANTIATE PREVIOUS ALLEGATIONS AGAINST THE ORGANIZATION.

NEWARK SOURCE ALSO INDICATED THAT [REDACTED] MEMBER OF THE MILITARY FRACTION OF THE PPC AND WOULD BE IN A POSITION TO KNOW DETAILS REGARDING ANY PLANNED ACTIONS ON BEHALF OF THE GROUP. THE SOURCE FURTHER STATED THAT MEMBERS OF THE MILITARY FRACTION OF THE PPC ARE CONCERNED THAT [REDACTED] HAS LEFT THE GROUP BECAUSE OF HIS KNOWLEDGE OF PPC ACTIVITIES.

On 10/20/83, [redacted] (Protect), [redacted] [redacted] was contacted for information about the ESWA who rents aforementioned building. Through [redacted] secretary, access was given to the lease agreement and correspondence with the ESWA. The building was originally leased by [redacted] and the rent was paid by her. It is believed that [redacted] left Philadelphia and is residing in New York. The Philadelphia ESWA is being run by [redacted]

On 11/9/83, [redacted] [redacted] was contacted for any information regarding the ESWA. He refused to be interviewed and requested that his attorney, [redacted] be contacted. On the same date, [redacted] was contacted regarding the Bureau's interest in interviewing [redacted]. A date was set for recontact after [redacted] had an opportunity to speak with [redacted]. On 11/16/83, [redacted] contacted Special Agent (SA) [redacted] and stated that [redacted] did not wish to be interviewed by the Federal Bureau of Investigation (FBI).

On 11/16/83, [redacted] (Protect), advised that he entered the ESWA Chapter, 1518 South Street, Philadelphia, and conducted an inspection of the entire building. He stated that the workers were cooperative and he did not observe any military equipment or anything suspicious. It is his opinion that the individuals working for the ESWA are concerned with helping the poor. He has not heard anything negative about the ESWA from the community. It should be noted that [redacted] in the area and has frequent contact in the community.

Detective [redacted] Intelligence Division, Philadelphia Police Department (PPPD), has been contacted for any information relating to the ESWA. He was familiar with the group, but there was no information relating to any criminal or subversive activity.

Informant coverage to date has been unable to uncover any violent revolutionary action with the Philadelphia group. The only connection with violence is when several members from Philadelphia attended a meeting in New York, where violent revolutionary

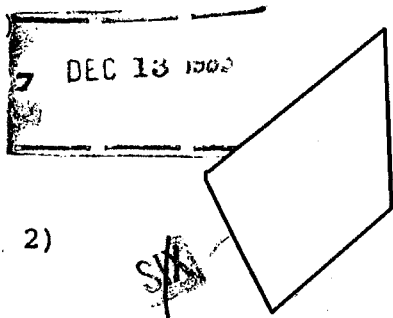
