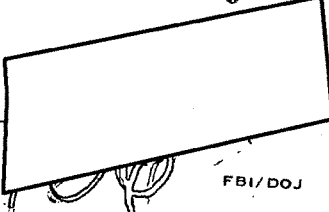

THE NOVEMBER, 1983, EDITION OF A MAGAZINE ENTITLED "CHRISTIAN CENTURY," AN ARTICLE WAS FOUND DISCUSSING CAPTIONED ORGANIZATION. SOURCE SAID THE ARTICLE WAS ACCURATE AND MENTIONED THE MILITARY FRACTION (MF) AND FIREARMS. SOURCE HAS NOT READ THE ARTICLE AND HAS NO FURTHER DETAILS.

INSTRUCTIONS WERE GIVEN TO AVOID THE USE OF ROUTINE "ENTITY" TELEPHONE MESSAGE CENTERS, AS IN COMING WEEKS, THESE COMMUNICATION LINES MAY BE "NEEDED FOR LIFE AND DEATH SITUATIONS."

DISCUSSIONS WERE HELD AS TO WHAT THE CADRE WILL NEED TO KNOW IN "BOLSHEVISING" OTHER PEOPLE AND WHEN "HAKING POWER" AS BOLSHEVIKS.

IN A FURTHER CONVERSATION DURING THE MEETING, SOURCE HEARD THE TERM LARGO USED. THIS WAS EXPLAINED, BY A CADRE MEMBER, AS BEING A GROUP FORMERLY HAD IN CALIFORNIA.

The EASTERN SERVICE WORKERS ASSOCIATION (ESWA) is, as its name implies, a service organization dedicated to assisting poor people in achieving their daily needs to include transportation, telephone service, health and welfare benefits. The ESWA, Trenton Chapter, is part of a national organization which is headquartered through a mailing address she cannot recall in New York City.

[redacted] has never heard of a "military fraction" of the ESWA, nor has she ever heard of any members receiving military training. There are absolutely no weapons stored at the Trenton Chapter of the ESWA on North Clinton Avenue and, in fact, she pointed to a sign which disallows firearms from being brought into the premises.

The dates February 18 and 19, 1984 have no special significance for [redacted] or the ESWA. She does not contemplate taking part in any military actions or any actions of violence on those dates. Further, having never heard of the military fraction (MF) of the ESWA, she has not heard any information relative to the MF taking part in any acts of violence. [redacted] is totally ignorant of any action on the part of the MF, the ESWA or the PROVISIONAL PARTY OF COMMUNISTS (PPC) to foment a revolution to topple the government of the United States commencing on February 18 or 19, 1984. [redacted] has not heard of any pamphlets within the ESWA with names similar to "LANDING SHORE PARTIES," squad combat formations, bayonet fighting, or the use of deadly force. She did state, however, that various terms associated with military jargon are utilized in the organization to delineate organizational strata. For instance, she stated that the published daily routine is referred to as a "battle plan."

When asked if she were knowledgeable of [redacted] [redacted] answered that he was the foremost organizer in the ESWA who continues to be affiliated with the organization. However, the names [redacted]

[REDACTED] are unknown to her other than the fact that she knows of a [REDACTED] who was affiliated with the TEXAS FARM WORKERS.

[REDACTED] claimed to have been affiliated with the ESWA for three years but disclaimed being either a member or a cadre of the PPC. When specifically asked if she were a communist, she replied, "No!"

The interviewing agent thereafter asked [REDACTED] to see a copy of the constitution of the ESWA. In response, [REDACTED] provided a notebook containing various bylaws and provisions of the ESWA. A perusal of these documents did not reflect a specific "statement of principles" or reference to VLADIMIR LENIN. She was also asked if the interviewing agent could review a copy of the current "battle plan" for the week. It was explained that the weekly "battle plan" had not yet been prepared and there was not yet formulated a battle plan for February 18 or 19, 1984. [REDACTED] was of the opinion that she would be spending the weekend comprising the 18th and 19th of February in telephone solicitations to organize and garner new members. [REDACTED] disclaimed ever having been to the National Office Center (NOC) at 1107 Carrol Street, Brooklyn, New York. Further, she is unaware what the term "watch window" would mean. [REDACTED] reiterated her statement that she is unaware of any stockpiling of weaponry, either at the Trenton Chapter or elsewhere within the ESWA. [REDACTED] has previously been affiliated with the New Brunswick, New Jersey, Chapter of the ESWA and, like in Trenton, she observed no stockpiling of weapons.

As she has had no physical contact with the NOC, she is totally unfamiliar with any records or literature that might be maintained at that locale.

[REDACTED] is aware of the activities of CESAR CHAVES and his efforts to organize farm workers throughout the southwestern portion of the United States. She is unaware of any affiliation CHAVES might have with the ESWA.

[REDACTED] is totally unfamiliar with the term "Omega 7" and cannot offer any information as to its meaning.

In summary, [REDACTED] stated that she was totally unaware of any military or revolutionary activity contemplated by the ESWA on February 18 or 19, 1984, or for that matter, anytime thereafter. She repeatedly denied being a part of the military fraction of the ESWA and stated further that she was not a member of the PPC.

On February 16, 1984, [redacted] provided the following information in an interview at his place of employment, JANNSEN PHARMECEUTICA.

[redacted] stated he first became aware of the PROVISIONAL PARTY OF COMMUNISTS (PPC) through [redacted]. [redacted] stated he, [redacted] and several other individuals had shared a residence several years before.

During 1981, [redacted] made [redacted] aware of her membership in the EASTERN SERVICE WORKERS ASSOCIATION (ESWA) and the NATIONAL LABOR FEDERATION (NATLFED). In the fall of 1981, [redacted] attended a meeting in Brooklyn, at which approximately 100 people were present. The meeting was referred to as the NATIONAL LABOR COLLEGE (NLC).

Sometime following this meeting, he was invited to visit the NATIONAL OFFICE CENTER (NOC). He did this on a weekend in January, 1982, and remained overnight. During this period, he was made aware of the Marxist orientation and of the existence of a "Secret" organization. [redacted] stated he recalled being introduced to members on two floors of the building and stated approximately twenty members slept in the upstairs apartment overnight. He denied having seen firearms.

During this period of time, he was asked to join the organization. He declined, though he agreed with the goals of the organization, as they demanded more commitment than he was willing to give. [redacted] stated that while he was aware that the organization constituted communist party, he was not aware of the revolutionary aspect.

Since the above, he has visited the New Brunswick, New Jersey, ESWA Office approximately one time every month. During 1983, he was asked by [redacted] to allow her to use his residence address to receive mail. He agreed and has received mail, often daily, since that time.

Source was further told that a Federal court judge had ordered that the "raid was not proper" and that "further FBI action would be illegal".

Source stated the observation that most of the members of the public entities, such as ESWA, are not aware of the PPC and do not believe allegations in the press, following the search. Other cadre and public members, who are aware of the PPC and the "revolution" intended to occur

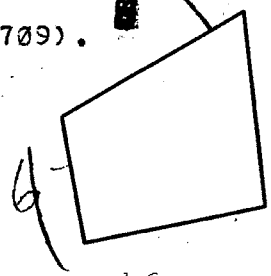

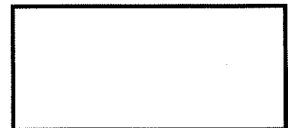

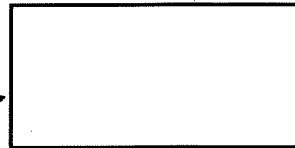

In view of the information that the PPC Military Fraction (MF) plans to commit an unknown specified action in the armed rebellion and overthrow of the U.S. Government on 2/19/84, New York is initiating overt interviews at PPC locations in New York and serving Federal grand jury subpoenas [redacted]

[redacted] Overt interviews of PPC members will also be conducted by FBI Agents in Boston, Newark, Philadelphia, Portland, Sacramento, San Antonio, and San Francisco.

The above interviews are being conducted to prevent any impending acts of violence by the PPC and to attempt to extract information concerning the PPC, the MF and its known members.

This plan of action is being disseminated to U.S. Secret Service.

On February 27, 1984, [] provided the following information:

Source stated that the interior cadre members of the PROVISIONAL PARTY OF COMMUNISTS continue to be alarmed and angry regarding overt investigation by the FEDERAL BUREAU OF INVESTIGATION (FBI). Numerous claims and "wild" statements are being issued by the NATIONAL OFFICE CENTER (NOC), in Brooklyn, which according to asset's belief, are intended to bolster the faith of the cadre.

The overt FBI investigation was described as the "largest raid in the history of the country". It was stated that the FBI "got nothing but bad press" and that the "Formation" is at the point of "getting everything back".

Source stated that the "FOSTER FIRM" held a press conference in Lyons, New York, but that it was held in error.

Source was further told, in an interior cadre meeting, that the FBI will be getting many telephone calls from individuals claiming to be cadre, but it was added, "they will not really be us". Source does not know if this indicates a disinformation scheme or if it was said merely to comfort the cadre.

In the meeting, asset was told by a Military Fraction leader that the FBI raids only caused a change of dates of the revolution and that by Monday (February 27, 1984) "all is go". It was added that there "will be a lot of smoke by Monday". The group was then warned to stay away from U.S. Route 1 through February 29, 1984.

Source is of the opinion the above may have been said as a test of source, as he is considered suspect and is intended to cause a reaction by authorities to identify the source.

No details regarding any of the above were furnished to source.
