Enclosed for the information of receiving offices are copies of an anonymous letter sent to the New York State Department of Labor, Albany, New York, and signed "Ex-ESWA", (Eastern Service Workers Association). The letter writer states that the "Provisional Communist Party" has set up front groups known as the "National Labor Foundation" and the "Eastern Service Workers Association" to raise money for the purpose of buying weapons, hiding "terrorist soldiers," and fomenting revolution. The writer also states that recruitment of members of the military and of scientists working on nuclear materials are an objective of the Provisional Communist Party.

The envelope containing the letter bears the postmark South Jersey, New Jersey and the numbers 080 as well as the date, February 22, 1984, and the letters PM.

Both the letter and the envelope it came in were forwarded to the Albany Office by [redacted] Unemployment Insurance Reviewing Examiner, New York State Department of Labor, Albany, New York.

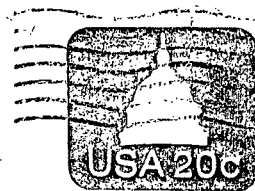

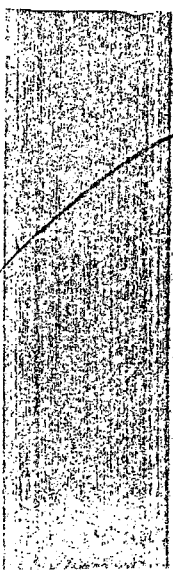

Source contacted a friend, via telephone, who has been associated with the EASTERN SERVICE WORKERS ASSOCIATION (ESWA), for several years. This individual is an ESWA member and is fairly well trusted, but is not a member of the interior group. Source knows this individual well enough to talk with her about source's abrupt departure from the organization.

Source was told that very little has been said about source's departure. Source was told that it was very much similar to the departure of [redacted] in that there was a great deal of excitement, with little said to the exterior members.

He also states that PWCP members he encountered "had people in California who supposedly robbed banks in 1968 to 1972".

Dear Governor Cuomo,

I read of the police/FBI raid on last Friday on suspected Communist terrorist HQ.

Some friends and I joined a group that was controlled by something called the "Provisional Wing of the Communist Party", after responding to pleas for money from a so-called Workers Association.

If they are the same group, they are indeed dangerous. I was told of weapons being collected by an "Armed Faction", with hidden training camps, (I never learned locations).

This Provo Party wants to go back to classic Communist techniques: organizing the workers, setting up local cells, etc,---and using force and terror to de-stabilize local populations. Their plans include bank robberies, infiltration of armed forces units, and "elimination" of key figures in city and state governments, and police. One man said they expected unions to die, and then the Party will "wipe away" the Taft Hartley law, and control the workers!

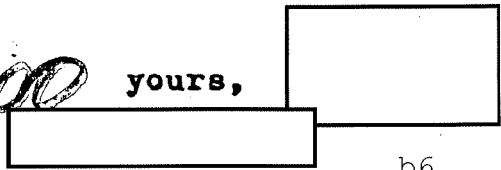

All investigation by the NYO and other field offices has not revealed any overt acts by captioned group to overthrow the United States (U.S.) Government. Due to this fact and that further investigation into captioned group remains contingent upon a definitive legal opinion of the EDNY and the outcome of the limited use of the FGJ, the NYO is requesting an extension of 180 days for the investigative period for a full field investigation.

Investigation since May 1, 1984 has included a more detailed review of evidence seized on February 17, 1984 pursuant to search warrants issued by the Eastern District of New York (EDNY) and the Southern District of New York (SDNY). This detailed review has confirmed the New York Office's (NYO's) original position as to the structure and operation of the Provisional Party of Communists (PPC).

The National Labor Federation (NATLFED) is the public umbrella organization that serves as a cover for the clandestine activities of the PPC. Under this umbrella exist forty-one front groups throughout the United States. These front groups are known within the PPC as "entities." Establishment of these entities and membership in them are centered mainly in New York, California, Massachusetts and Texas. These entities exist as avenues to recruit new members into the PPC, but when people join an entity in the very beginning, they are not advised of the true purpose of the organization until a later time when PPC members decide that the new member is to be indoctrinated. Individuals are attracted to the entities through the guise of doing voluntary community services. Individuals recruited are themselves usually of low income, and due to their socio-economic background and financial situation are ideal candidates to be recruited into the PPC. While the entities do provide some services to the community, this is done as a thin coverup while the main work to obtain money, food, clothing, support and new members is done for the operation of the PPC.

Review of documents seized (approximately forty boxes) also revealed that within the PPC exists a cell known as the "Military Faction" (MF). The MF appears to be an elite section of the PPC in which members who were accepted participated in military drills, were given a higher position of authority and possibly given training in the use of firearms. One of the documents seized was an inventory of weapons (approximately forty to forty-five) with their description and location of storage along with available ammunition.

Investigation has been coordinated with and information supplied to the following agencies:

1. The United States Attorney's Office, EDNY
2. Bureau of Alcohol, Tobacco and Firearms (BATF)
3. United States Secret Service (USSS)
4. Internal Revenue Service (IRS)
5. New York City Police Department (NYCPD)
6. United States Army, Military Intelligence

In May, 1984, [redacted] served with Federal Grand Jury (FGJ) subpoenas, EDNY. [redacted]

[redacted] The NYO expects a major portion of the investigation and its direction to be contingent upon the results of the FGJ, the information derived therefrom, and the willingness of the EDNY to subpoena [redacted]

The NYO is maintaining investigation of captioned group and is also waiting for a final definitive legal opinion on the prosecutable merits of this case from the EDNY.

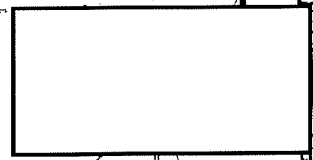
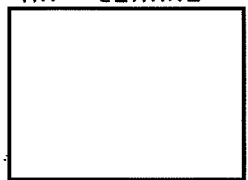

THE PROVISIONAL PARTY OF COMMUNISTS, USA IS REFERRED TO BY MEMBERS AS THE PROVISIONAL PARTY AND THE CPUSA PROVISIONAL; IT HAS NO CONNECTION WITH THE COMMUNIST PARTY, USA {CPUSA}.

THE PARTY IS DIVIDED INTO SEVERAL "FRACTIONS" WHICH ARE OPENED TO ALL PARTY MEMBERS {CADRES}, AND ONE CLOSED FRACTION WHICH IS KNOWN AS THE MILITARY FRACTION.

THE MILITARY FRACTION REQUIRES A MINIMUM OF ONE-YEAR, FULL-TIME PARTY MEMBERSHIP COMPLETE WITH "POLITICAL EDUCATION, TRAINING AND EVALUATION." THIS MILITARY FRACTION IS ARMED AND PARTICIPATES IN REGULAR MILITARY DRILLS. ALTHOUGH THE SOURCE WAS NOT A MEMBER OF THE MILITARY FRACTION, THE SOURCE GAINED KNOWLEDGE REGARDING THE MILITARY FRACTION WHILE WORKING AT THE NATIONAL HEADQUARTERS OF THE CAPTIONED ORGANIZATION LOCATED IN NY CITY, NY.

WHILE WORKING IN THE NATIONAL OFFICE, THE SOURCE OBSERVED FIREARMS ON SEVERAL OCCASIONS. THE SOURCE LEARNED THAT ONE ROOM IN THE HEADQUARTERS IS REFERRED TO AS "THE CAVE" AND IS KEPT GUARDED ON A 24-HOUR BASIS. ON ONE OCCASION, THE SOURCE OBSERVED THE DOOR OPENED AND BRIEFLY SAW A LARGE SUPPLY OF FIREARMS. THE ROOM CONTAINED THREE RACKS OF SHOULDER WEAPONS AND A NUMBER OF OLIVE DRAB DUFFLE BAGS WHICH APPEARED TO BE FILLED WITH FIREARMS. ON SEVERAL OCCASIONS, THE SOURCE OBSERVED FIREARMS BEING CARRIED INTO THE BUILDING, AND HAS IDENTIFIED THESE FIREARMS AS APPEARING TO BE .30 CALIBER CARBINES, AK 47'S AND VARIOUS WEAPONS WITH SCOPES.

DURING THE SOURCE'S TENURE WITH THE CAPTIONED ORGANIZATION, THE SOURCE LEARNED THAT THE PROVISIONAL PARTY OF COMMUNISTS, USA IS A REVOLUTIONARY COMMUNIST PARTY, TOTALLY DEDICATED TO REVOLUTION IN THE UNITED STATES. THE U.S. GOVERNMENT AND ALL OF ITS AGENCIES ARE CONSIDERED MORTAL ENEMIES. PLANS WERE WELL UNDERWAY FOR AN ARMED "TAKEOVER" OF THE U.S. GOVERNMENT. THE TAKEOVER WAS SCHEDULED FOR FEBRUARY 19, 1984. ON THIS DATE, THE CAPTIONED ORGANIZATION WAS TO ENGAGE IN UNSPECIFIED "MILITARY ACTIONS" ON A COAST TO COAST LEVEL.

NOTE CONTINUED:

IN JANUARY, 1984, SOURCE LEARNED THAT PART OF THIS "MILITARY ACTION" WOULD CONSIST OF ENGAGING IN "SNIPING" ATTACKS AGAINST TRACTOR TRAILER TRUCKS OPERATING ON AN INTERSTATE HIGHWAY IN NEW JERSEY.

THE BULK OF THE SOURCE'S INFORMATION WAS CORROBORATED THROUGH SEVERAL OTHER INDEPENDENT SOURCES. AS A RESULT, AND IN ORDER TO INTERDICT THE IMPENDING PLANNED VIOLENCE, SEARCH WARRANTS WERE OBTAINED AND EXECUTED AT SIX LOCATIONS IN THE NY CITY METROPOLITAN AREA OPERATED BY THE PPC ON FEBRUARY 17, 1984.

SEIZED DURING THE SEARCHES WERE A LOADED .30 CALIBER M-1 CARBINE, A .32 CALIBER REVOLVER, NUMEROUS ROUNDS OF AMMUNITION, HOLSTERS, PRACTICE RIFLE GRENADES (WHICH WERE DETERMINED TO BE DUMMIES), AND MILITARY PARAPHERNALIA SUCH AS UNIFORMS, BAYONETS AND TARGETS. IN ADDITION, A QUANTITY OF SMOKELESS POWDER, BRASS KNUCKLES AND SEVERAL PLASTIC TOY CARBINES WERE SEIZED. NUMEROUS DOCUMENTS, WHICH CORROBORATED THE FACT THAT THE PPC WAS PLANNING A MILITARY TAKEOVER OF THE U.S. GOVERNMENT AND INDICIA THAT THE PPC HAD PROCURED WEAPONS TO EFFECT THIS TAKEOVER, WERE ALSO OBTAINED DURING THESE SEARCHES. IN ADDITION, [REDACTED] WERE SERVED WITH GRAND JURY SUBPOENAS DURING THE EXECUTION OF THESE SEARCH WARRANTS. b3

IN TOTAL, OVER 40 BOXES OF DOCUMENTS AND RECORDS WERE SEIZED DURING THESE SEARCHES. THE TRAINING DIVISION, BEHAVIORAL SCIENCE UNIT, CONDUCTED AN ANALYSIS OF THESE SEIZED DOCUMENTS AND DETERMINED THE FOLLOWING:

THE PPC IS LEFTIST IN ITS ORIENTATION, AND EXTREMIST IN THEIR VIEWS CONCERNING THE GOVERNMENT OF THE UNITED STATES. THE GROUP IS HIGHLY ORGANIZED AND VERY MILITARISTIC. IT ALSO APPEARS TO BE OPERATING WITH TACTICS SIMILAR TO MANY CULTS, IN TERMS OF THE WAY IN WHICH THIS GROUP RECRUITS ITS MEMBERS. THEY CAN BE DANGEROUS IF THEY HAVE, OR THINK THEY HAVE THE UPPER HAND IN A CONFRONTATION.

THE NY OFFICE HAS ADVISED THAT THE EASTERN DISTRICT OF NY IS REVIEWING THE VOLUMINOUS AMOUNT OF DOCUMENTS SEIZED DURING THESE SEARCHES. [REDACTED] b3

[REDACTED] BEFORE A GRAND JURY. PPC MEMBERS, WHO HAVE BEEN PREVIOUSLY ISSUED SUBPOENAS, HAVE ENTERED MOTIONS TO QUASH BEFORE THE COURT, AS WELL AS INITIATING CIVIL LITIGATION.

BASED UPON THE ABOVE INFORMATION AND THE PROPOSED GRAND JURY INVESTIGATION, IT IS RECOMMENDED THAT A FULL DS/T INVESTIGATION BE EXTENDED ON THIS GROUP.

IN JANUARY 1984, SOURCE LEARNED THAT PART OF THIS "MILITARY ACTION" WOULD CONSIST OF ENGAGING IN "SNIPING" ATTACKS AGAINST TRACTOR TRAILER TRUCKS OPERATING ON AN INTERSTATE HIGHWAY IN NEW JERSEY.

THE BULK OF THE SOURCE'S INFORMATION WAS CORROBORATED THROUGH SEVERAL OTHER INDEPENDENT SOURCES. AS A RESULT, AND IN ORDER TO INTERDICT THE IMPENDING PLANNED VIOLENCE, SEARCH WARRANTS WERE OBTAINED AND EXECUTED AT SIX LOCATIONS IN THE NEW YORK CITY METROPOLITAN AREA OPERATED BY THE PPC ON FEBRUARY 17, 1984.

SEIZED DURING THE SEARCHES WERE A LOADED .30 CALIBER M-1 CARBINE, A .32 CALIBER REVOLVER, NUMEROUS ROUNDS OF AMMUNITION, HOLSTERS, PRACTICE RIFLE GRENADES (WHICH WERE DETERMINED TO BE DUMMIES), AND MILITARY PARAPHERNALIA SUCH AS UNIFORMS, BAYONETS AND TARGETS. IN ADDITION, A QUANTITY OF SMOKELESS POWDER, BRASS KNUCKLES AND SEVERAL PLASTIC TOY CARBINES WERE SEIZED. NUMEROUS DOCUMENTS, WHICH CORROBORATED THE FACT THAT THE PPC WAS PLANNING A MILITARY TAKEOVER OF THE U.S. GOVERNMENT, AND THAT THE PPC HAD PROCURED WEAPONS TO EFFECT THIS TAKEOVER, WERE ALSO OBTAINED DURING THESE SEARCHES. IN ADDITION, [REDACTED] b3  
[REDACTED] WERE SERVED WITH GRAND JURY SUBPOENAS DURING THE EXECUTION OF THESE SEARCH WARRANTS.

IN TOTAL, OVER 40 BOXES OF DOCUMENTS AND RECORDS WERE SEIZED DURING THESE SEARCHES. THE TRAINING DIVISION, BEHAVIORAL SCIENCE UNIT, CONDUCTED AN ANALYSIS OF THESE SEIZED DOCUMENTS AND DETERMINED THE FOLLOWING:

THE PPC IS LEFTIST IN ITS ORIENTATION, AND EXTREMIST IN THEIR VIEWS CONCERNING THE GOVERNMENT OF THE UNITED STATES. THE GROUP IS HIGHLY ORGANIZED AND VERY MILITARISTIC. IT ALSO APPEARS TO BE OPERATING WITH TACTICS SIMILAR TO MANY CULTS, IN TERMS OF THE WAY IN WHICH THIS GROUP RECRUITS ITS MEMBERS. THEY CAN BE DANGEROUS IF THEY HAVE, OR THINK THEY HAVE THE UPPER HAND IN A CONFRONTATION.

THE NEW YORK OFFICE HAD PREVIOUSLY ADVISED THAT THE EASTERN DISTRICT OF NEW YORK WAS REVIEWING THE VOLUMINOUS AMOUNT OF DOCUMENTS SEIZED DURING THESE SEARCHES, [REDACTED] b3  
[REDACTED] BEFORE A GRAND JURY. PPC MEMBERS, WHO HAD BEEN PREVIOUSLY ISSUED SUBPOENAS, HAD ENTERED MOTIONS TO QUASH SOME OF WHICH HAVE BEEN RESOLVED BY THE COURT, AND HAD ALSO INITIATED SOME CIVIL LITIGATION.

NOTE CONTINUED:

SINCE THE LAST 180-DAY AUTHORIZATION, THE EASTERN DISTRICT OF NEW YORK HAS NOT PROVIDED A PROSECUTIVE OPINION, NOR HAVE THEY INDICATED WHETHER OR NOT THEY INTEND TO PROCEED WITH THE GRAND JURY INVESTIGATION, DESPITE NUMEROUS CONTACTS BY THE NEW YORK OFFICE BOTH WRITTEN AND TELEPHONICALLY. BY TELETYPE DATED JANUARY 17, 1985, THE NEW YORK OFFICE REQUESTED FBIHQ TO ADVISE DOJ, CHIEF OF THE OFFICE OF INTELLIGENCE, POLICY AND REVIEW OF THIS MATTER, IN AN EFFORT TO SECURE A DEFINITIVE PROSECUTIVE OPINION.

INASMUCH AS THERE IS PENDING COURT ACTION IN THIS CASE, I.E., APPLICATIONS BEING MADE BY SUBJECTS TO UNSEAL SEARCH WARRANT AFFIDAVITS AND OUTSTANDING GRAND JURY SUBPOENAS, IT IS RECOMMENDED THAT A FULL DS/T INVESTIGATION BE EXTENDED ON THIS GROUP.

ALSO, DUE TO THE LACK OF RESPONSE FROM THE EASTERN DISTRICT OF NEW YORK, THE NEW YORK OFFICE HAS REQUESTED THAT FBIHQ CONTACT DOJ, OFFICE OF INTELLIGENCE, POLICY AND REVIEW, IN AN EFFORT TO OBTAIN A PROSECUTIVE OPINION FROM THE EASTERN DISTRICT OF NEW YORK. UPON APPROVAL FROM THE ASSISTANT DIRECTOR, CRIMINAL INVESTIGATIVE DIVISION, THIS REQUEST WILL BE FULFILLED.

Enclosed herewith are five (5) LHMs.

As set forth in previous communications, the New York Office (JTF-2) has documented in detail the results of six (6) Federal search warrants executed on 2/17/84, in Brooklyn, New York, regarding captioned group.

To date, the affidavit for above-described search warrants remains sealed in both the Eastern District of New York (EDNY) and the Southern District of New York (SDNY).

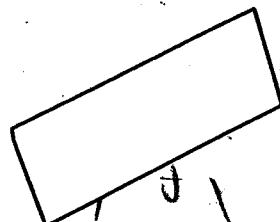

Applications to have the affidavit unsealed are presently before a United States District Judge in Brooklyn, New York.

Overall responsibility for captioned group is being handled by the EDNY, Brooklyn, New York, under Assistant United States Attorney (AUSA) JOHN GALLAGHER.

In addition, JTF-2 has disseminated the contents of the above-described searches to the INTERNAL REVENUE SERVICE; BUREAU OF ALCOHOL, TOBACCO, AND FIREARMS; DEPARTMENT OF DEFENSE, MILITARY INTELLIGENCE; and UNITED STATES SECRET SERVICE. Each voluminous report, dated 12/12/83 (prior to search), and 5/1/84 (reporting results of search), documented the group as detailed as possible based on all investigative avenues.

[redacted] is no longer associated with captioned group. Asset is [redacted] and has no access to additional information to group.

Furthermore, the New York Office has received no information concerning the group, nor has it had any source coverage since 2/84.

The New York Office has investigated this group, based on allegations provided by the above source, under A/G guidelines concerning Domestic Security (Criminal).

The New York Office conducted this investigation and collected such information:

- 1) the members of the enterprise and other persons likely to be knowingly acting in furtherance of its criminal objectives, provided that the information concerns such persons' activities on behalf or in furtherance of the enterprise,
- 2) the finances of the enterprise,
- 3) the geographical dimensions of the enterprise, and
- 4) past and future activities and goals of the enterprise.

This investigation has continued for several years, the group (size) and composition has been fully identified. There has never been an overt criminal act committed, nor has the New York Office ever identified a specific overt criminal act. Although there is a military fraction (MF) structure, this appears to be more structural than operational.

On 11/16/84, the New York Office requested a definitive written criminal opinion from the EDNY, Brooklyn, New York. To date, this has not been received.

REQUEST-OF-THE-BUREAU

The New York Office is requesting a ninety (90) day extension of full investigation awaiting the EDNY's opinion.

The true name of the organization is the "PROVISIONAL PARTY OF COMMUNISTS," and is referred to by members as the PROVISIONAL PARTY (it has no connection to the COMMUNIST PARTY, USA (CPUSA)). The PROVISIONAL PARTY is considered "secret" and operates publicly under the cover of the NATIONAL LABOR FEDERATION (NATLFED). The NATLFED acts as an umbrella organization for approximately 40 public groups across the country. The group was founded in approximately 1971, by a group of individuals, including [redacted]

[redacted] and an unknown fourth person. The Party was founded to be a revolutionary communist party, whose goal is that of seizing control of the United States Government. This takeover was to occur February 18-19, 1984, and is referred to by members as the "Proscenium Tactic." The Party is divided into several cells, which they call "Fractions," with one of these fractions being called the "Military Fraction (MF)". The MF requires a minimum of one year full-time membership, complete with political education, training, and evaluation. Several sources have reported that the MF participates in military drills. It was also reported by some sources that weapons are stored at 1107 Carroll Street, Brooklyn, New York.

The alleged planned action of the group was as follows:

- 1) A general strike on both east and west coasts of unions under the control of the NATLFED.
- 2) Jamming telephone lines of temporary employment agencies.

- 3) A national press conference.
- 4) Hiring halls to be opened through the TEMPORARY WORKERS' ORGANIZATION COMMITTEE (TWOC), which is controlled by the NATLFED.
- 5) Aggressive military action on a nationwide basis by the MF. The nature of this action is not known.

#### MEMBERSHIP AND SURFACE ORGANIZATION


Briefly, individuals are recruited to donate time, money, and work as a volunteer for a particular charitable organization controlled by the group (for example, persons would be asked to donate time and become volunteers for the EASTERN SERVICE WORKERS' ASSOCIATION (ESWA), which is supposedly a charitable, non-profit organization, whose goal is to help migrant or low class farm workers out on Long Island and other parts of the New York Metropolitan area). This first stage is called "Tabular Volunteer." The Tabular Volunteer donates money, runs errands, makes telephone calls, etc., for one of the public organizations operated by full members of the group. Within three months to one year, this volunteer, after evaluation, may be upgraded to "Viable Volunteer." At this level, the person can be counted on to volunteer whatever is requested. Also, at this stage, the person is asked to attend the NATLFED. The NATLFED is not so much a place, but rather a term used for meetings held in Brooklyn, at Carroll Street, or another location (usually an auditorium donated for use by a school or church). At these meetings, the Viable Volunteer usually becomes aware, to varying degrees, of the Marxist or revolutionary aspect of the organization. The next stage is called "Tabular Cadre." At this stage, the volunteer learns of the "Statement of Principles," is assigned sponsors and given regular reading assignments. The

person gradually learns that the organizers are "professional revolutionaries." The fourth step is that of "Viable Cadre." At this step, the member is fully committed to the revolution. After one year membership as a Viable Cadre, the individual reaches the final stage, which is a "Full Member" or "Interior Cadre."




During 1970, the subject was one of the operators of the "LITTLE RED BOOKSTORE," 3191 Mission Street, San Francisco, California, and was reportedly [REDACTED] of the LIBERATION ARMY REVOLUTIONARY GROUP ORGANIZATION (LARGO). LARGO, in March, 1970, publicly declared a state of revolution to begin on March 15, 1970, in northern California, by mailing letters to various northern California county officials. A former San Francisco source had reported in November, 1970, that [REDACTED] participated in firearms training in Chico, California, [REDACTED]

May 17, 1973, Suffolk County Police Department (SCPD), New York, advised that about January, 1973, SCPD received information from a source that there were unregistered guns located at 1735 Montauk Highway, Bellport, New York, which is a residence maintained by the EASTERN FARM WORKERS' ASSOCIATION. SCPD executed a search warrant at this location and confiscated two handguns and ammunition. Through subsequent investigation, it was determined one gun was registered to the subject.

The searches resulted in the seizing of two weapons (one at Carroll Street and one at Gold Street). However, massive records were obtained in connection with the above-described areas. It is not intended to be a complete, detailed itemization of material obtained, but a listing for the United States Attorney's (USA) Office that may assist you in the initial stages of this investigation. Unless otherwise noted, the following material was seized from 1107 Carroll Street, Apartments 1A and 2A, Brooklyn, New York:

- 10) Envelope of "Operation Foxchaser", depicting police or FBI information.
- 11) MF folder on training excercises.
- 12) Handgun purchases or request for purchases from San Antonio, Texas, regarding .357 Ruger, two Barefas, extra clips, Detonics, .357 Magnums, MS Safaris, Haynes.

- 13) File on bodyguard capabilities.
- 14) East coast liaison of nine offices regarding MF personnel.
- 15) "Proscenium" material notebook, breaking down attorneys/judges, cadre, farm labor, home improvements, labor, medical, police/detectives, political parties, press/media, racing, runkle, veterans.
- 16) Ordinance for Thompson submachine guns, .45 automatic.
- 17) State laws regarding ordinances for purchases of guns.
- 18) Federal laws regarding ordinances for purchases of guns.
- 19) Extensive newspaper articles in connection with 1981 Brinks armored car robbery in Nyack, New York, with some critiques.
- 20) Four New York State Court Officer Badges (not determined if stolen or counterfeit).
- 21) Two New York "Special Police" badges.
- 22) MF files for gun breakdown of M16 rifles, assault rifles, ammunition, Smith and Wesson, and 12 gauge shotguns.
- 23) Procurement of real estate for purchase of military related drills (breakdown of every county in New York State).

- 24) Three mobile TRC Realistic Citizen Band (CB) radios.
- 25) One main CB terminal.
- 26) Numerous military uniforms.
- 27) MF files regarding security protocol.
- 28) MF file regarding "The Farm" in Nassau County, with handwritten directions.
- 29) MF Security "Safehouses" listing numerous addresses in the Metropolitan area and other cities.
- 30) MF training: Assault training.
- 31) MF personnel files, totaling approximately 75 to 100.
- 32) MF file on combat theory in World War I. Pacific theatre.
- 33) Maps of San Bernadino County, California, noting several military bases.
- 34) Document entitled "Proscenium Tactics."
- 35) Folder on ways to construct explosive devices.

Finally, prior to the above-described search warrants being executed, the Behavioral Science Unit, FBI Headquarters, did an analysis of the captioned group, based on information available, and its findings are as follows:

This group is leftist in its orientation, and extremist in thier views concernig the Government of the United States. The group is highly organized and very militieristic. It also appears to be operating with tactics similar to many cults, in terms of the way in which this group recruits its members. That is, it will take in individuals who are "inadequate" and who are considered to be outcasts, and it will show them acceptance, warmth, and love to the degree which they have not received in other areas of their life.

The characteristics of the leader of this group fits those of the leadership of these "left wing" extremist groups. In fact, their planning, interigence, and ideology are all extremely characteristic, with the exception of the fact that this group has apparently actually acquired an ability and degree of organization to execute the far flung plans of its leadership. This is unusual in groups not supported by foreign governments (if that is the case).

It is characteristic in groups like this that the leader is generally the ideologue. He or she is intelligent, capable of intricate planning, and minute detail; however, they generally remain very vague concerning the actual execution of those plans. They will have the absolute appearance of authority, but may actually "share" authority at times with whomever is helping execute their plans. The leader will often appear quite meek when confronted by established authorities, but will extract their "revenge" later. They can be dangerous if they have, or think they have, the upper hand in confrontation.

The leader of this particular group, [redacted] has all the characteristics of the above-mentioned leader. In addition to that, he appears to have the same need for code names, fancy acronyms, and special double meaning-type of verbage, which is often used by these groups. For example, the name [redacted] uses as an alias, and its

similarity to [redacted] This proclivity for names and elaborate structures is further shown in the setup of the PPC and its secret military "fractions." It is very likely that the secret military "fractions" have all sorts of rituals and rights of passage for each level of rank. Further, the extensive keeping of records, notes, and journals, double checking on everyone, and so forth, is also characteristic of the type of leadership, of degree of apparent sophistication, and of control which this group has exhibited over its membership. Neither is it unusual to maintain such a low profile for the military "fraction."

On November 16, 1984, the New York Office, FEDERAL BUREAU OF INVESTIGATION (FBI), requested a definitive, written, criminal legal opinion concerning captioned group. To date, this opinion has not been received.

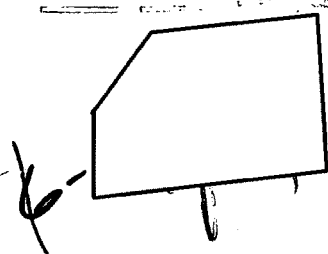

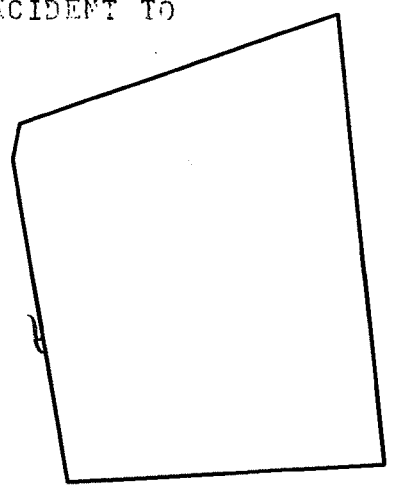

On February 17, 1984, members of the Joint Terrorist Task Force executed Federal search warrants in both Brooklyn, New York, and Manhattan, New York, in connection with a criminal investigation involving a group based at 1107 Carroll Street, using the umbrella title (SECRET) of the Provisional Party of Communists. This investigation which was pursued under the Attorney General Guidelines for Domestic Terrorism, as mandated by Congress, was vigorously and thoroughly investigated. Your agency also expended both resources and time to this endeavor. These searches resulted in the seizure of over forty (40) boxes of evidence which presently is being stored at the New York Office.

The Joint Terrorist Task Force disseminated two (2) voluminous reports to your agency, as well as other Federal agencies, namely Internal Revenue Service (IRS); Bureau of Alcohol, Tobacco and Firearms; Department of Defense; Military Intelligence and U.S. Secret Service. Each report, one dated December 12, 1983 (prior to search) and May 1, 1984 (reporting results of search) documented the group as detailed as possible based on all investigative avenues.

To date, there has not been a definitive criminal prosecutive opinion rendered in writing to our agency. Inasmuch as the Attorney General Guidelines for Domestic Terrorism



The CPUSA no doubt is more active in some places than others, which may lead one to believe they have relented in their quest to aid the Soviet Union and its "fellow travelers." The Cleveland experience indicates that the CPUSA pursues its goals with a vengeance, not only in promoting front groups such as the NCASF, but the Soviet Party Line every chance it gets. For example, the Cleveland CPUSA district set up a "Dump REAGAN Committee" in 1984 to thwart the REAGAN campaign. 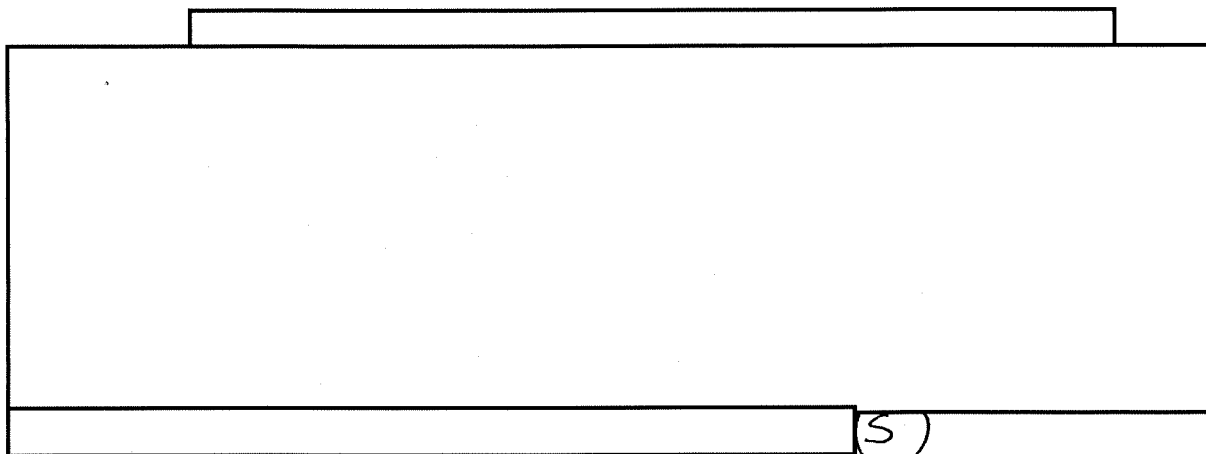

Approximately 500 delegates, et. al. appeared for the founding convention and approximately 50 youthful delegates from throughout the United States were picked because of their potential to the CPUSA. One can rest assured that these delegates are screened, cultivated, and may well represent the future leadership in the CPUSA and perhaps sensitive U.S. industry and/or U.S. Government.

It is always amazing to rediscover that most CPUSA members in the U.S. recognize the Communist Party of the Soviet Union (CPSU) as the ultimate authority and rarely criticize anything the party does.

Perhaps it is the political climate of the times that has relegated CP matters to the current low level of awareness. Local police intelligence departments no longer offer their help in CP matters because of lawsuits, FOIA releases, etc. It is also difficult to place members in the CP. It appears that former sources that for many years worked CP matters are now retired and were never replaced with new assets. The new assets take time to work their way into the CP in order to gain acceptance and recognition. It is no doubt axiomatic that CPUSA members in high positions should be recruited, but it is becoming increasingly difficult to maintain asset coverage and interest since the CPUSA appears to have achieved a certain legitimacy in the public arena. It is almost as if they are "out of sight-out of mind" and are not considered as a threat but rather as a curiosity.

An indication of this low level of awareness at which the CPUSA operates is that "one can count on one hand" the number of concerned citizens that call the Cleveland FBI concerning CP activity.

Cleveland opines that additional resources are needed to adequately cover the CPUSA, specifically, wire taps are needed on CP leaders. In addition, a one week in-service should be considered by FBIHQ for those agents handling CPUSA matters!

Investigation is continuing at Cleveland, Ohio.

## Charity or Scam? CALIFORNIA HOMEMAKERS ASSOCIATION: CHARITY OR SCAM?

**C**alifornia Homemakers Association (CHA), a group with an innocuous-sounding name, is anything but innocuous.

CHA combines a populist program for helping the poor and an authoritarian regimen for carrying it out. The group, which has two Sacramento offices, arouses strong public opinions from those who have dealings with it. Comments range from "They are feeding the poor" to they "are preparing to do violence."

CHA promotes appealing ideas with its literature. Welfare recipients and low-income workers, without the aid of government or corporate grants, are organized so they can better themselves.

Dedicated, aggressive volunteers, working out of storefront offices here, solicit donations of food, clothing and money for the poor and arrange medical, dental and legal help.

But there is a troubling side to that idealistic image.

CHA, with its penchant for secrecy, has cult-like traits and a murky, often bizarre history. At times, the group seems to be its own worst enemy. Many people who volunteer their services or donate goods are repelled by CHA's harassing telephone calls and ever-increasing demands.

Formed here in 1973 by former CSU, Sacramento professor David Shapiro, CHA has over the years used the CSUS campus as a prime recruitment area. At least one professor is a member while students have earned college credits working for it.

In 1974, CHA made headlines in the Sacramento daily papers when it won the right to represent domestic workers who provide home care to welfare recipients. Besides this incident, CHA and its affiliated organizations--the Coalition of Concerned Lawyers, the Coalition of Concerned Medical Professionals and Western

Services Workers Association have kept a low public profile. Nevertheless, sources describe the organizations as "very active" here.

**Some saw CHA help the poor "with their immediate needs such as medical problems and clothing."**

The groups have about ten full-time organizers with numerous part-time volunteer CHA members occasionally hand out leaflets and try to recruit members in front of grocery stores and the Welfare Department, 1725 28th St.

Shelie Rhym, wearing a red CHA nametag, stands in front of the Welfare Department at R and 28th Street. She holds a clipboard stuffed with CHA literature and a sign-up list for new members.

Rhym, in her late 30s with two grown children, is one of CHA's full-time organizers in Sacramento.

Rhym works from 9 a.m. to midnight seven days a week. She's been a CHA member for six months.

"I'm a backbone of the organization," she says. "I'm a cadre. It's up to me to see that everything is carried out. At the same time, she insist

A couple of weeks later, the woman and a male organizer didn't show up at the office and couldn't be contacted. Members said they were afraid for the couple's safety.

"I knew otherwise. I knew they just took off," Richmond recalls. "So I slowly got out of the organization."

Looking back on the experience, Richmond maintains that CHA was "very authoritarian. Very Marxist-Leninist. From the top on down. Very rigid. That's how they operated. I just didn't like it." Of the storefront offices, Richmond says, "There's a real strong, humorless, serious work atmosphere. There was never any room for play, going out and having good time. It was so serious there."

Richmond's story is similar to other former members interviewed. Many of the former members did not want to be noted by name because they say they are afraid of receiving harassing phone calls.

A 30-year-old woman who worked 20 hours a week for CHA for a couple months in 1980, says, "It wasn't enough, course. Nothing you do for them is ever enough."

She adds, "I didn't like the fact that they used people. I think that most of the people in the organization didn't care about poor people. They were just using that issue. I think they cared on an abstract level. It was a case of loving humanity without hating your neighbor. (But), it could be totally wrong."

A 25-year-old woman who worked for CHA for more than a year in 1983 recalls she joined CHA at first. "They were talking about feeding the poor. It was wonderful. There were tremendous problems," she donated clothing and a little money to CHA. "I felt really good about that." She also saw CHA help the poor with immediate needs such as medical problems and housing.

Once, she went to a National or College gathering in San Francisco. "That was an

exceptionally disturbing experience. (There were) uniform guards posted who never took their eyes off of me. I felt very uncomfortable."

When she went to the restroom, she was followed by a female member. "They wouldn't let me use the restroom alone."

During the labor college, the 100 or 200 people were divided up into groups. "In one class, we were encouraged to read about guerilla warfare. It really started to make me wonder.

"The way they did things really turned me off."

She says she got the distinct impression CHA was "preparing to do violence."

She asked a CHA leader about this and was told, "It was not the policy of CHA to do violence, but you have to be prepared to defend what you've built."

She said she didn't want to have anything to do with violence. Eventually, she quit, and like many former members, received numerous harassing phone calls. The calls stopped when she adamantly told them she wouldn't volunteer her services anymore.

"I don't know what they are capable of. I don't want to have anything to do with them at all anymore. I don't even want to bump into them at the grocery store."

Even so, she says it was difficult to quit the organization because some good is achieved. "I did a lot of soul searching before I cut my ties with them. I know the work they intend to do is good. I think they could be extremely effective if (it wasn't for the militancy of NATLFED)."

A 49-year-old Sacramento woman, who did not want to

be identified, says she was recruited in front of the Welfare Department several months ago. "I went to a couple of meetings," she recalls.

CHA members then called her and wanted to use her telephone, car and gas, she says. "I couldn't afford it. I'm on a very limited income.

"They still kept calling and pestering me. Every day or every other day," she says. Then it dwindled down--I lost my temper and they didn't call back.

"They use whatever they can get out of people. They kind of put the pressure on you," she says.

An all-volunteer organization, CHA depends on donations not only from individuals, but also businesses.

Ed Grady of Grady's Copy Shop likes to help out local charity organizations. He was approached by CHA members in 1980, and for several years gave them free printing.

Members would use his photocopy machine for free and supply the paper for their printing needs, Grady says.

Grady was impressed the group was an all-volunteer, grass-roots effort. But what the group stood for was "sketchy in my mind," Grady notes. "It was always a question mark."

After three years, "I decided I had given enough," Grady says. It (took) some time to sink in. They would call once a week and say, 'Can we bring it in?' It seems like they have little organization. The people would be very demanding and I don't have time for that."

CSUS Professor John Erlich, who has had students earn college credit working for CHA, hears mixed reactions from students.

"I think it is important that (CHA members), in a period when there are very few grass-roots organizations, are advancing the needs of poor people," Erlich explains.

However, Erlich says some students told him CHA made a

lot of demands on their time. "It's hard to say no when you see how enormous the problems are," he says.

Professor Decious became involved in the group because "I think there are definite problems in equal distribution of resources."

## **"They tend to work organizers to death."**

CHA members try to get more commitment out of people. "They really push people for what they call full-time organizers," said Decious. "They tend to work organizers to death."

But Decious didn't want to volunteer full-time. "This is nonsense. It's not for me. As a chemistry professor, I have other things I like to do."

\*\*\*

The man behind CHA and NATLFED is Gino Perente, who, at least according to one account, lived in Marysville for several years.

Whitnack describes Perente possessing "a unique combination of very strong and weak character traits." Perente has a "clever ability to con people. He cannot cope with being an ordinary Joe. He needs to approach people through human pawns," says Whitnack, who has researched Perente's past.

Decious, who has met Perente, describes him as "a good organizer. A hard-driving

guy. A good salesman."

"Gino and I get along very well," Decious says.

According to Whitnack, Perente's real name is Gerald Doeden and he lived part of his life in the rural community of Marysville. A Shakespearean actor, disc jockey and advertising salesman, Doeden was something of a town character, Whitnack says.

After overcoming some drug abuse problems, Doeden opened the Little Red Bookstore in San Francisco, Whitnack says. Doeden changed his name to Gino Savo and organized the Liberation Army Revolutionary Group Organization (LARGO), Whitnack says. The group's purpose was to have an armed revolution.

LARGO collapsed. In 1972, Doeden, who now called himself Gino Perente, was one of those who organized the Eastern Farmworkers Association, an off-shoot of Cesar Chavez's United Farm Workers Organizing Committee, Whitnack says.

Perente went on to organize NATLFED, the umbrella or-

ganization for CHA, the Coalition of Concerned Lawyers and the Coalition of Concerned Medical Professionals.

Decious says "it would demystify the whole thing" if people would visit NATLFED offices in New York and the other offices around the country.

However one views CHA, its local leaders would not consent to an interview with the Suttertown News. A formal request on the newspaper's letterhead was submitted outlining the areas to be discussed. No reply was received. In addition, several telephone calls and visits requesting an interview went unheeded.

Priscilla Abbott, the CHA leader in its 3714 Marysville Boulevard office, told two reporters during a visit last week that she didn't have time to be interviewed. "I really have to get going. I'm meeting with an attorney."

She added, "If I want to do a story with the Suttertown News, I'll contact you guys. I prefer for you all to leave. There's the door."

Although this article contains both positive and negative comments on CHA, the official responses to specific charges, such as the group's cult-like tendencies, were not available. One question that has to be asked: Why would a group that helps the poor, that needs volunteers, that needs donations, avoid the spotlight of a press inquiry?

The disparity of views on CHA and its affiliated groups reflect their dual nature. Undeniably, CHA helps people who may not otherwise receive aid.

Former members have told the Suttertown News that although CHA's intentions are laudable, its overzealous tactics are not. Many think CHA could be more effective if its approach was toned down.

Additionally, critics charge that CHA and its national organization, the National Labor Federation (NATLFED), are front groups for the Communist Party USA Provisional. The "hidden agenda" for the group is to recruit members for the Provisional Party, which ultimately wants an armed overthrow of the government, critics contend.

NATLFED and CHA are coming under increasing scrutiny. On Feb. 17, 1984 the FBI and the New York Police Department raided three NATLFED offices in New York and seized the group's files on leftist activists. The raid supposedly coincided with one of the dates the Provisional Party had set for an armed revolution, a timetable that has changed many times over the years, critics say.

Perhaps the biggest critic of CHA and NATLFED is Jeff Whitmack, a former Sacramento resident who lives in Oakland. The 31-year-old Whitmack joined CHA in Oakland in 1981, worked full-time for the group for two months, but became disenchanted and quit. He says CHA has too many cult-like traits and lies too much.

CHA is potentially dangerous, Whitmack claims. CHA and NATLFED inspire devotion from volunteers with a "false

"You're not a slave to the organization." She fills out a schedule each day and in that way limits her hours, she says.

"Nobody gets paid anything," she says. "They provide housing. You get food. You get clothing. When you need personal items, we get on the phone and call merchants."

At her assignment in front of the Welfare Department, Rhym helps people who are having problems with their welfare checks and recruits members. In the evenings, she hands out leaflets in door-to-door canvassing.

She, too, has heard rumors about CHA. "A lot of people are not educated about the organization. We've been called communists. We've been called capitalists. We've been called everything but good CHA organizers. We use what we've got to get what we need."

In addition to Rhym, two other CHA members, Elwood McCarken and Dean Asilay, work at the Welfare Department. McCarken, a CHA member for many years, says, "We're gonna win. We're trying to make changes in the country. A lot of changes."

\*\*\*

Tom Moore, 71-year-old

veteran union organizer, donated food and money to California Homemakers Association for several years in the mid-1970s. He thought the group was a good grassroots organization helping the poor.

But he became suspicious. "Just one of those things your gut tells you." And when Moore, the first president of the California Gray Panthers, found out that CHA was discouraging people from registering to vote, he had enough.

"I came to the conclusion that they were as phony as a \$2 bill," Moore said.

That's one view of the group. Here's another.

Sacramento Attorney Thomas Freeburger contacted the Coalition of Concerned Legal Professionals, a group affiliated with CHA, while in law school. "I needed a summer job," he explains.

Freeburger handled many cases for the group. Much of it, Freeburger says, fell under the heading of "poverty law... some sort of problem relating to the fact that they had a low income."

Occasionally, Freeburger still gets a case from the group. "I think it is a very worthwhile organization. The people are the most dedicated

On June 3, 1985, the New York Office (NYO) of the Federal Bureau of Investigation (FBI) reviewed the following letter of declination (prosecutive) from the Eastern District of New York (EDNY), dated May 21, 1985:

Re: Provisional Party of Communists

I write to inform you that we have decided to close our file on the above-captioned matter without prosecution at the present time. This action results from the fact that the Bureau's investigation, while uncovering certain documents which suggested criminal violations -- specifically, the illegal purchase and storage of weapons -- turned up hard evidence of only one weapons violation. This violation, involving the illegal purchase of a single pistol in North Carolina, is presently being prosecuted in the Middle District of North Carolina. In the absence of additional evidence and since the Bureau has indicated that the further commitment of investigative resources is unwarranted at this time, we are closing our file on this matter. Should additional evidence be discovered, we expect that you will inform us so that we might reconsider our decision in light of the new evidence.

The Bureau is presently in possession of documents seized in the course of its investigation. Since we are closing our file on the matter and inasmuch as the Bureau has indicated that it no longer wishes to retain the documents, arrangements should now be made for the prompt return of these seized documents.

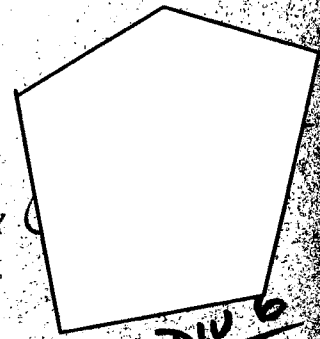

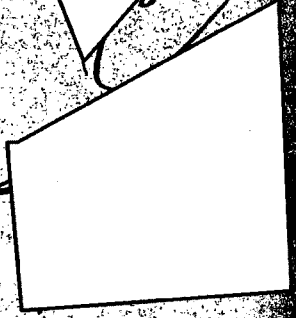
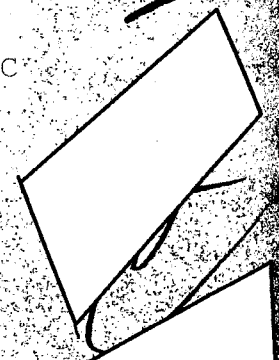

About three years ago, asset received an invitation to have Thanksgiving dinner with the group and asset attended with [redacted] was unimpressed with the group because of its leftist political beliefs and no longer would have anything to do with the organization. Asset understands that the members are usually unemployed and they do not live at the Command Post, but rather live in groups at other locations within San Francisco. The members are all on some type of work schedule and their whereabouts seems to be monitored at all times. In the evening around 7:00 p.m. there are classes held at the Command Post on Marxist/Leninism Theory.

Asset stated that all members seem to work at obtaining donations for the group and they communicate with the Command Post by radio. Asset learned from one of the members that the FBI broke into their national headquarters in New York sometime last year.
