

3 A Resolution of Commendation to  
4 Fred Fuestel as Consultant to its  
5 City Utilities.

6 The City Utilities of the City of Fort Wayne reluctantly  
7 accepts the retirement of Fred Feustel as Consultant to its  
8 City Utilities.

9 Fred Feustel possesses a comprehensive understanding  
10 of the workings of the City Light, Water and Sewage Departments.

11 He attended and pursued his graduate studies at  
12 Massachusetts Institute of Technology being awarded a Master  
13 of Science degree in Electrical Engineering. He also enlarged  
14 his education in the field of Accounting, Cost Accounting and  
15 Auditing at Indiana Extension.

16 He began his services for City Utilities in January of  
17 1935 as a Power Plant Clerk and rose to the rank of the  
18 General Superintendent of the City Utilities and as  
19 Consultant to the City Utilities. A brief record of his  
20 employment shows the following:

21 From January 1935 to August 1935  
22 Power Plant Clerk;

23 From September 1935 to September 1938  
24 Auditing Department, studying street lighting costs  
25 and revision of billings;

26 From October 1938 to March 1948  
27 General Auditor of electric, water and sewerage  
28 utilities;

29 From 1952 to 1960  
30 General Superintendent directing operations of the  
31 electric, water and sewerage utilities;

32 From 1960 to the present  
As Consultant providing valuable services to  
department heads, employees, customers of City  
Utilities, its policies, practices, union memorandum,  
preparation of detail for ordinances, rates and  
many other matters.

1 By dedicated service for over 45 years with the City  
2 Utilities of Fort Wayne, Indiana he has monumented himself by  
3 his outstanding service to this community.

4 BE IT THEREFORE RESOLVED by the Common Council of the  
5 City of Fort Wayne that it extend to Fred Fuestel its  
6 congratulations and heartfelt thanks to this public servant  
7 whose ability and untiring efforts were dedicated to the  
8 improvement of a great utility in his community and that a  
9 copy of this resolution be delivered to Fred Feustel and be  
10 spread of record in the records of the Common Council of the  
11 City of Fort Wayne, Indiana.
