This Indenture made the 3rd day of September 1825
between James Crawford and Margaret ~~McElveen~~
his wife of the County of Augusta and State of
Virginia of the one part and George Poage of Poca-
hontas County and State aforesaid of the other
part witnesseth that whereas James Crawford
late of St. George County being seized in fee of a tract
of land containing two hundred and ninety six
acres lying within the limits of the present County of
Poage by his last will and Testament devised
the same to his children namely, William, James,
John, Sarah, Elizabeth, and Polly: and whereas the
said George resented his life during his minority, inter-
dicted sum in arrears & without fine, leaving as his legal
representatives, his aforesaid brothers and sisters, and
between the said William after the death of the said
George and after this life after having made his
last will and Testament in which among other things
he devised his interest in said land to his four
surviving brothers and sisters, and whereas the said
John Crawford has resented this life and by his last
will and Testament being thus seized in fee of one
hundred and forty six acres the same to

20 day of November in the year of our Lord one thousand seven hundred and forty three between John Sharp and his wife Margaret and William Sharp both of the County of Franklin
of the other part witnesseth that the two latter have agreed
to have for and in consideration of the sum of four dollars
to have in hand paid unto Benjamin Woodcock and others
William Sharp has had one certain tract of land in the
County of Franklin on the North fork of
Tuckahoe Creek a tract of land containing
one hundred and forty one acres of land surveyed for
John Sharp and Robert 28th 1822 and bounded as
follows: Beginning at a pine and white oak on the
old line N 30° E 66 poles 15 trees white oak N 76° E 60
poles to a maple and white oak North 20 poles between white
oak west 74 poles to two oaks N 15° E 44 poles to a swamp
N 26° E 80 poles from west N 40° E 40 poles to a white oak and
black oak N 20° E 60 poles to three white oaks N 75° E 60
poles to three white oaks S 27° W 220 poles to two white
oaks south 12° W 97 poles thence S 75° E to the Beginning
Together with all its appurtenances to have and to hold
the said one hundred and forty one acres of land with
its appurtenances to the said William Sharp and his heirs
to the sole use and behoof of him and his William Sharp
and his heirs forever and the said John Sharp and his
wife Margaret for themselves and their heirs with
covenant with the said William Sharp and his heirs that
the said John Sharp and Margaret his wife and their
heirs shall have land with all its appurtenances unto the said
John Sharp and his heirs against all persons whatsoever
with full power warrant and command in witness whereof the
1st John Sharp and Margaret his wife both here
unto subscribed their names and affixed their seals the




The boundary lines of Henry Philip Survey of 22000 acres
re-surveyed and divided in to lots by our of Superior Court




1839 Surveyed & Shaded with pale green




