I am very excited that the LAX Northside Plan Update will have its final approval action at the Los Angeles City Council on Tuesday, June 14th at 10 am. I wanted to invite you to join us at City Council that day, and invite you to the press conference

that LAWA will be holding together with the Mayor's office and Councilmember Bonin's office at 1 pm in the LAX Northside area. The location of the press conference will likely be near the Westchester LAFD Fire Station #5 (8900 Emerson Ave), but we will confirm the exact location as we get a little closer to the date.

As you know, we have spent several years working together to build a consensus plan that is designed to meet the community and airport needs and a plan that incorporates latest standards in design and sustainability. Because of your support and collaboration, we have already begun a significant planning effort on a key LAX Northside project, the Argo Drain sub-basin underground infiltration facility, which is designed to accommodate future recreational amenities and to improve the quality of stormwater runoff in the Santa Monica Bay.

I personally cannot thank you all enough for ongoing support, for making the effort to appear at numerous hearings, and for your continued dedication and friendship. I am looking forward to celebrating the major project milestone, and hope you can join us on June 14th!
