By this time, David Ferrie had arrived in Galveston. This was Ruby's final long distance call prior to shooting Oswald.

(Note: Breck Wall subsequently went to work as a headline entertainer for the Thunder-Bird Hotel, managed by Louis McWillie, formerly employed by Meyer Lansky's Tropicana Hotel in Havana. Ferrie, becoming an entrepreneur for the first time in his life, opened a new station in New Orleans).
