On July 27, 1968, at approximately 8:30 p.m., Mr. Mark Lane and myself went to visit Rev. RAYMOND BROSHEARS at his Long Beach address on Orange Avenue. According to an arrangement made with him by telephone, we visited him to discuss his association with DAVID FERRIE, his knowledge of the assassination of President Kennedy which he gained from DAVID FERRIE, and the television appearance he made on a Los Angeles television show called "The Stan Bohrman Show". (See memorandum of July 10, 1968).

We asked REV. BROSHEARS to tell us about his stay in New Orleans. Mr. BROSHEARS said that in 1965 he came to New Orleans from East St. Louis having worked there with the Congress of Racial Equality under a man who was an executive in that organization named MR. RANDOLPH. Mr. RANDOLPH had given him the names of several people in the same organization in Bogaloussa. After going to Bogaloussa, REV. BROSHEARS had been stopped by officers from the Louisiana State Police and interrogated. He said, "I was beat up." The REV. BROSHEARS came to New Orleans.

BROSHEARS said that he came to New Orleans knowing no one here, however, he had come here to escape his problems.

REV. BROSHEARS said that he registered at a hotel which had no name, which was across from the Continental Trailways Bus Station. He said he registered under the name of EARL RAYMOND ALLEN. Shortly after his coming to New Orleans, he met DAVID FERRIE. BROSHEARS said that he met FERRIE at a bar which was known in the French Quarter as a homosexual bar called "Dixie's". He said that he also associated with DAVID FERRIE at another bar known as "LaFitte's in Exile".

FERRIE:

ON THE OTHER HAND, FERRIE SEEMS TO HAVE BURNED A STAGE OF INTIMACY WITH HIM - SUPPORTED WITH THE APPARENT USE OF ALCOHOL + PILLS - SO THAT BROSHEARS SHOULD NOT BE TOTALLY DEPENDENT WITH AS A SOURCE OF INFORMATION AND POSSIBLE LEAD. (FOR EXAMPLE:)

BROSHEARS' REFERENCE TO HALE BOGGS AS THAT CONNECTION IS NOT ONE EXAMPLE WHY HE IS TO BE AVOIDED TO ADD UP TO EVEN BEING A SOURCE OR EVIDENCE

BROSHEARS said that he discussed the assassination of President Kennedy with DAVID FERRIE only after having known him intimately for a while. BROSHEARS stated that FERRIE had discussed with him the following names in relation to the assassination of President Kennedy, and a conspiracy in which FERRIE admitted his own involvement. The names were:

X HALE BOGGS, Representative to Congress from the State of Louisiana;

X KENT COURTNEY, financier in New Orleans; *(Can not check out as being involved in any way)*

*Will know more about who was involved with anti-Castro friends not always with of his political activities of '53.*

X RICHARD C. LAUCHLI, of Collingsville, Ill.;

X CLAY SHAW, who Ferrie said had been Director of the International Trade Mart in New Orleans and was now financially responsible for HALE BOGGS remaining in Congress.

At that time BROSHEARS said, "I didn't know these people, or what the Trade Mart was."

BROSHEARS said that FERRIE stayed over night with him at his hotel room on several occasions. During one of those occasions two men came to their door and forced their entrance to the room. They questioned FERRIE, threatened FERRIE, and, according to BROSHEARS, left abruptly. After these two men left, BROSHEARS asked FERRIE who they were. FERRIE said, "They are just men who I am afraid of." BROSHEARS said that these men had hurriedly identified themselves and he could not see from their identification who they were. BROSHEARS stated that FERRIE later told him that they said they were from the District Attorney's Office (NOTE: This was in 1965.) BROSHEARS said that FERRIE was fantastically nervous, and was given to deep periods of depression. He said that it was only when FERRIE drank to excess, or had taken pills that FERRIE would confide casually with BROSHEARS in some of the involvement that he had had with the assassination. BROSHEARS said that he did not tell him immediately that he was involved with Civil Rights work, but later discussed his background.

FERRIE:

FERRIE told BROSHEARS of "the mess he was in". FERRIE said he was a pilot. He showed Eastern Airlines Wings with his name engraved on the back to BROSHEARS, and said that he had been fired from that organization for charges of homosexuality. FERRIE stated to BROSHEARS that he had been flying private planes to Guatemala, Costa Rica and British Honduras. BROSHEARS said that, "If this was a way to make money, DAVID didn't have any." BROSHEARS stated that he felt that FERRIE had been forced to work for this organization, and had been "hooked into it". He said that FERRIE never liked the work he was doing, but that FERRIE had confided in him that he was working for "a group of people who wanted to take over the United States".

Since BROSHEARS felt that the homosexual underground in which he and FERRIE were involved was "an hysterical scene", he said that he did not take FERRIE seriously. FERRIE said that he was flying guns and ammunition. FERRIE told BROSHEARS

that he had been stopped by British officials at a place called Belize during a "regular run" to a British colony in British Honduras. He told BROSHEARS that his plane had been inspected and that the authorities there had contacted his bosses in New Orleans. FERRIE told BROSHEARS that he was immediately released. He told BROSHEARS that he flew a twin engined plane, but that during the entire time of his work for this organization he was not doing it voluntarily, but was being blackmailed. BROSHEARS had nothing in the way of money, but FERRIE would often give him small amounts - \$20 or so - after he had gotten money by taking the St. Charles streetcar to a location which FERRIE only called "the agency".

FERRIE told BROSHEARS in regard to President Johnson, "that damned Johnson.. If you knew what I knew, you'd kill the bastard." "DAVID said he killed J.F.K", BROSHEARS said. BROSHEARS asked him how he knew this, and DAVID refused to say.

DAVID FERRIE told BROSHEARS he was to fly two men, two of the assassins who killed President Kennedy, in South Houston out of the country. FERRIE said that he was to fly from Houston with the two assassins to Central or South America, and later to Capetown, Republic of South Africa. The reason for going to South Africa, said FERRIE, was that that country had no extradition treaty with the United States. FERRIE told BROSHEARS that the assassins never showed up. They were supposed to have come to the Houston Airport in a small aircraft after the assassination, from Dallas and Fort Worth, Texas. Instead, FERRIE told BROSHEARS, they tried to make it all the way over the Mexican border and their plane crashed and burned on a sandy little islet just off of Corpus Christi, Texas. FERRIE said that one of the assassins named CARLOS had directions to fly to meet him at the Houston Airport, and had further directions to a bar where they were to make a contact in Central or South America.

*FERRIE:*  
FERRIE told BROSHEARS, "It seems like you big money preachers creatures are into everything." When BROSHEARS asked him what he meant by this he said that BILLY JAMES HARGIS and another "big phoney up in New Jersey" (BROSHEARS said this was DR. CARL MCINTIRE) were involved in the plot against President Kennedy.

FERRIE said that, "President Kennedy is the first, they're not going to stop until they kill every nigger in this country." BROSHEARS asked who he meant by "they". DAVID FERRIE said, "HALE BOGGS, and the others. He blackmails everyone. He has a blackmail file, I know." FERRIE told BROSHEARS that some other people had been killed as a result of what they knew about the assassination. He did not evidently tell BROSHEARS who these people were. FERRIE did say that if Jacqueline Kennedy or Robert Kennedy ever spoke out about the assassination they had been warned they would be killed also. FERRIE told BROSHEARS that other people who were in Dallas had been killed.

BROSHEARS doubted what FERRIE had told him. He said that FERRIE ought to go to see a psychiatrist. FERRIE said that he knew what he was talking about. He said that there is an organization called the Central Intelligence Agency and that one of the leaders of that organization, a man named DULLES, is not a fine man. FERRIE told BROSHEARS; "They are going to turn this country into one big barbed wire prison."

BROSHEARS said to FERRIE that, "Everyone knows that LEE HARVEY OSWALD killed President Kennedy." FERRIE replied, "Have you ever read the Warren Report? If you do, you will see that they never looked at the evidence." FERRIE said, "They murdered one of the best lays I've ever had. He didn't have anything to do with killing President Kennedy. He was set up." (LEE HARVEY OSWALD) FERRIE told BROSHEARS that GENERAL WALKER was the "military brains" behind the rightest group. "There are two people in this country in New Orleans, KENT COURTNEY and CLAY SHAW. SHAW keeps HALE BOGGS in office."

While on a television program in Los Angeles, California, the Stan Bohman Show, July 8, 1968, BROSHEARS stated that he had been arrested for threatening the life of President Johnson. He said that he had made the statement, "President Johnson, who was responsible directly or indirectly for the assassination of our beloved President Kennedy, should be put to death." BROSHEARS told us that he had made these statements because of what DAVID FERRIE had told him. After he made these statements in late 1965, he was told by DAVID FERRIE who was told by a man he now knows as CLAY SHAW but then knew as CLAY or BERT. In approximately September of 1965, BROSHEARS was arrested by Secret Service agents and Federal Marshals and taken to the Veterans Administration Hospital in New Orleans. There he was arraigned by Federal Judge Christenberry in the presence of other Secret Service agents for conspiring to assassinate President Johnson. Mark Lane asked BROSHEARS who the other co-conspirators were. BROSHEARS said that he had made statements and discussed President Johnson in a disparaging way with four others who were also arraigned according to what he could find out. One of them, he said, was a young man from National City, although he remembered no names. During his detention in the Veterans Administration Hospital Psychiatric Ward in New Orleans, he was questioned by Secret Service agents, RUFUS YOUNGBLOOD, a MR. SHERMEN or SHERWOOD, and an agent TOM HORN, (now in the Los Angeles Bureau of the Secret Service). One of those agents told BROSHEARS, "For your own good we're going to commit you to a federal mental institution." BROSHEARS was then taken by Secret Service agents to Gulfport Psychiatric Hospital in October or November of 1965, and was not released until April of 1966. During BROSHEAR's stay in the Veterans Administration Hospital in New Orleans, he was under the care of a DR. STONE. In the middle of that stay he was told that DR. STONE had been taken off the case, by Judge CHRISTENBERRY, and been replaced by a DR. ROBINSON. BROSHEARS later found out that STONE had been transferred to the Veterans Administration Hospital in Casa Verde. After he had been transferred to the Gulfport Psychiatric Hospital, a DR. CLARK, who was in charge of REV. BROSHEARS, said to Secret Service agents after reviewing his case, "We're not jailors. We are discharging you." (to BROSHEARS) Agents repeatedly questioned BROSHEARS as to whether or not he was acquainted with DAVID FERRIE in New Orleans, and BROSHEARS denied this acquaintance.

We asked BROSHEARS if he had ever known or heard the name PERRY RUSSO. BROSHEARS told us that DAVID had talked about him many times. He had said to BROSHEARS that RUSSO beat him up. FERRIE told him that RUSSO had stolen or taken \$2300 from CLAY SHAW. BROSHEARS could not exactly remember under what circumstances FERRIE told him RUSSO had gotten this

money, but that it had to do with some sort of financial transaction and involved MR. SHAW.

After being questioned at Gulfport Hospital by Secret Service agents, one of the agents returned from Washington, D. C., and told BROSHEARS, "You'll get a compensation pension. You will have to report to us every time you move from one city to another. If you do not do these things, you will be put in a federal jail mental institution. If you do cooperate, you will receive your compensation pension regularly." At that time the agents gave him \$1700 (BROSHEARS believes it was either \$1300 or \$1700), as "back compensation". BROSHEARS was told by the agents never to return to New Orleans, but to go back to his home.

BROSHEARS was given a ticket by the agents to take a Southern Airlines flight from New Orleans to St. Louis to go to his cousin's farm in St. Louis and remain there. He was told to stay out of New Orleans.

BROSHEARS said that he wanted to talk with DR. STONE in Cincinnati. He said that he purchased a Chevrolet and did visit his cousin in Cotaville. He said that he crossed a bridge at New Harmony and the Indiana State Police at that border stopped him. He was questioned by the police and then taken to a small cafe which BROSHEARS called a "truck stop". At that cafe an agent of the Secret Service was waiting. Mr. BROSHEARS could not remember whether this was RUFUS YOUNGBLOOD or agent SHERWOOD. This was in May of 1966.

The Secret Service agent asked BROSHEARS, at the cafe, where he was going. BROSHEARS told him he was going to see DR. STONE in Cincinnati. The agent told him that he had no need to see anybody and should return immediately to his cousin's farm. The agent did ask him, however, if he was going to see DAVID FERRIE in New Orleans, and BROSHEARS denied that.

BROSHEARS then went to the Secret Service office in St. Louis and said that he was going to leave this part of the country and go to California. He told the agents there that he was going to San Francisco. They said that would be all right, and that he should report to a MR. NEWMAN at the Secret Service Bureau in San Francisco.

Once in San Francisco, BROSHEARS said that he didn't report to anyone, but took an apartment in a suburb. The agents found him one week later at 347 Eddy Street. NEWMAN and another agent called HAMMOND told him that he had violated his instructions and that he was going to be put in a hospital if he ever did that again. They also told him to call the federal building twice a week. BROSHEARS followed their instructions.

In explanation of BROSHEARS' background, he told us the following story.

BROSHEARS said that he had been living in 1964 in Bellville, East St. Louis. HOMER RANDOLF, head of the Congress of Racial Equality there, was REV. BROSHEARS' superior in Civil

Rights work. In Bellville, BROSHEARS said, an all white city, the territorial border had been reconstructed so as to keep the Negro section out of the city. BROSHEARS had announced publicly that he was going to stage a sit-in in a restaurant in East St. Louis. This was printed in the East St. Louis Journal and the sit-in was scheduled for November 11th on Veterans Day. Mayor Nichols of that city had BROSHEARS arrested and taken to him. He told BROSHEARS that their city was a "nice German-Dutch heritage town, and we must stop you from making a mistake". Present at that meeting were the Justice of the Peace and the Chief of Police. BROSHEARS was told not to stage the sit-in.

On November 10th, the morning before the sit-in was scheduled, BROSHEARS was again arrested, taken into custody, and he was threatened by the Chief of Police that he would be put in prison. He said that he had not broken any law, but the police stated that they were aware of laws that he had broken. On November 11th, REV. BROSHEARS staged the sit-in that he had planned. At 7:30 a.m., on November 12th, BROSHEARS was arrested and taken to the Chief of Police. He was charged with the sexual molestation of a young boy. BROSHEARS phoned his superior, MR. RANDOLF; and RANDOLF told him not to say anything or sign anything. RANDOLF said that he would get hold of an attorney who was a friend of his named ROY COHN, and would be back in touch with him. BROSHEARS was charged with sexual molestation of a boy 17 years old named WILLIAM GORGEIOUS. BROSHEARS said that this boy had come to the door of his apartment on November 8th. The boy had asked him to help him with religious and sexual problems which he said he had. REV. BROSHEARS stated that he had talked with the boy, but had never touched him in any way. BROSHEARS said that the charge had been filed, and according to the records was recorded at 10:30 a.m. on the 10th of November which was before his arrest, and before the sit-in which he staged on the 11th. BROSHEARS said that the Chief of Police said, "Boy, we are your friends, and we are going to make it easy on you. Sign this paper and you'll get 2 days in jail and then we'll let you go." A half an hour later they brought him a statement to sign. It was a statement of admission to the charges. BROSHEARS signed that paper without having been re-contacted by MR. RANDOLF or the attorney. BROSHEARS said that he had originally refused to sign the paper until the policemen who were speaking to him brought in a copy of a newspaper which had the headline "Bellville Minister Arrested-Sexual Perversion Charged". BROSHEARS became hysterical and signed all of the papers which the officers requested. Fifteen minutes later Mr. RANDOLF came with MR. COHN. Both said that they knew that he had been forced to sign the paper, but that nothing could be done at that time. BROSHEARS was in MINARD State Penitentiary for the following six months. BROSHEARS said that after he was discharged, he went to New Orleans and worked at a carnival under the name RAYMOND ALLEN. At the carnival he was known as "CORKY". BROSHEARS said that he could not find any other employment as a result of his prior arrest and incarceration. BROSHEARS said that he then went to work for an organization called "Deacons For The Defense of Justice" in Bogaloussa, Louisiana.

When we asked REV. BROSHEARS if he felt that DAVID FERRIE worked for "Deacons for Defense and Justice".

As a result of his appearance on the Los Angeles television program on the 8th of July, 1968, BROSHEARS was visited by Secret Service Agent TOM HORN. BROSHEARS was told that he would lose his pension if he appeared on another such television program. BROSHEARS was threatened by Agent HORN, and was told that he would "end up in Alameda Bay" if he did not keep his mouth shut. BROSHEARS said that he was in constant touch with Agent JOE CONLIN from the Federal Bureau of Investigation Office in Long Beach. He also said that he was in touch with a LT. JOHN COWAN of the Long Beach Police Department and also SGT. CHARLES USERY of that police department. SGT. USERY, according to BROSHEARS, has knowledge about the murder of a reporter which took place in the Long Beach Police Department. The reporter's name was BILL HUNTER from Dallas, Texas.

Two Long Beach Police Department intelligence detectives have also befriended BROSHEARS for the purpose, he believes, of keeping an eye on him. These are GARY COVIN and JOHN OWEN.

When we asked if REV. BROSHEARS knew a DR. THOMAS BECKHAM, BROSHEARS stated that he did indeed know DR. BECKHAM, that he had corresponded with DR. BECKHAM, and produced a photograph of BECKHAM in which he was shown as an entertainer. The personal management office of BECKHAM was listed under the name of FRED LEE CRISMAN.

Other information which BROSHEARS gave us in response to several questions was:

- A) BROSHEARS had been extremely upset because Agent RUFUS YOUNGBLOOD of the Secret Service Office had told him in the last week of March, 1966, that DAVID FERRIE was dead. This was before BROSHEARS left Gulfport Hospital. YOUNGBLOOD had told him that DAVID FERRIE had committed suicide, and that therefore it would not be necessary for BROSHEARS to ever try and find FERRIE again.

It was not until ~~11/23/67/11/23/67/11/23/67/11/23/67~~ just prior to our meeting on Wednesday, July 23, 1968, that BROSHEARS had learned of FERRIE's death in January of 1967. BROSHEARS said that he had obviously been told falsely that FERRIE had died by Agent YOUNGBLOOD.

- B) BROSHEARS said that DAVID FERRIE had friends and family in Cincinnati, Ohio.
- C) We explained that Garrison's investigation had not begun until November of 1966, and that therefore the men who had represented themselves as being from the District Attorney's Office in 1965 had represented themselves falsely. BROSHEARS said, "These weren't Garrison's men in DAVID's hotel room." BROSHEARS asked us if we knew the name ROBERT DUVAL (spelling unsure). He said DAVID flew him to one of the Central American countries, and was sexually intimate with him.

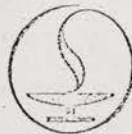


- E) DAVID FERRIE told BROSHEARS that LEE HARVEY OSWALD had been a bi-sexual. BROSHEARS had seen an identification bracelet with the name LEE on it, and also a grey or beige hunter's hat which was in possession of DAVID FERRIE.
- F) FERRIE had told BROSHEARS that Officer TIPPIT was sent to murder LEE HARVEY OSWALD because LEE HARVEY OSWALD had infiltrated a "cell" for the FBI. FERRIE told BROSHEARS that OSWALD had gone to Russia in connection with work for the FBI. FERRIE also told BROSHEARS that the Central Intelligence Agency and the FBI hated each other and worked against each other.
- G) FERRIE told BROSHEARS that three people worked in the Texas School Book Depository, and composed the "cell" which had been infiltrated by LEE HARVEY OSWALD. BROSHEARS said that one of their names was BOB, but that he knew not the last name. FERRIE had told BROSHEARS that JACK RUBY was also involved with these people who worked in the TSBD. It was BOB, according to FERRIE, that was supposed to kill OSWALD in the Book Depository.
- H) FERRIE told BROSHEARS that he had met JACK RUBY in New Orleans.
- I) REV. BROSHEARS gave Mark Lane a letter (see attached) which requests that Mark Lane visit and consult with him in the event that he is ever arrested or taken into custody, or placed in an institution.



- Q. State your name on the tape recorder.
- A. RAYMOND BROSHEARS.
- Q. How did you meet MARTIN?
- A. MARTIN's been in for so long, Nebraska's used to him.
- Q. RAYMOND BROSHEARS, why don't you tell us when you arrived in New Orleans in '65?
- A. It was shortly thereafter I left the Bogalusa demonstrations down there and got stopped by one of the Louisiana State Troopers. I was doing Civil Rights work in Bogalusa. I was with the Congress of Racial Equality at that time. I come down here. I was still in bad shape from having when I was here before and then I got stopped. And I come on down to New Orleans cause I didn't know any where else to go. I was waiting to contact -- waiting for a contact from MR. FARMER from New York City. MR. FARMER was supposed in New Orleans at the time. So I was here and this was in August.
- And this was in August, right at the first of August. And I gravitated into your underground down here because I didn't have money one so to speak. I arrived at the Continental Trailways bus depot over on Tulane at that time. I assume it's still there. And there was a little hotel -- and that's all the sign had out front was "Hotel" and it was just down the street from it. And I figured with a sign like that it had to be a cheap place so I got a place at the cheap hotel. And I got it under the name EARL RAYMOND ALLEN, not RAYMOND BROSHEARS cause I had gotten into a little bit of trouble up North doing Civil Rights work under the name RAYMOND BROSHEARS and I was pretty upset. I didn't know which way to turn. I had lost the church, I lost the family, everything over it. So I thought I'd go back to EARL RAYMOND ALLEN. EARL RAYMOND ALLEN is the name I was born with -- my mother, in one of her mad moments had it changed to one of her many mad husbands.
- Q. What is this name?
- A. EARL RAYMOND ALLEN.
- Q. EARL RAYMOND ALLEN. All right.

A. And RAY ALLEN and AL is the name that I circulated here in New Orleans under in that certain short period of time. And I met a lot of people here, a lot of strange people and I guess one of the strangest people I ever met was what I considered to be a very frightened -- later -- I now consider him to be a very frightened person. At that time I considered him to be a very promiscuous person by the name of DAVID.

Q. DAVID FERRIE?

A. It now turns out to be DAVID FERRIE cause the picture, and the hair, and everything -- and the age -- all correlates out to the same DAVID. But then later on I saw his wings from Eastern Airlines which is engraved on the back which said DAVID FERRIE. This was not right off. He didn't come out and say, "See, my name's DAVID FERRIE."

Q. Where did you meet him?

A. At Dixie's. Then over at Lafittes.

Q. Was he with anyone when you first met him?

A. A couple of young boys. I'd say they were about -- well, I'd say they were too young to be in a bar. Just hustlers, trying to make their way, you know -- and they sure <sup>aren't</sup> going to make it with him. I found that out. He didn't have penny one except at times he would come up with a few pennies but he didn't have much in the way of money. Cause he was -- he just didn't have any money. Now this is what I found to be very strange now. Cause Mr. Lane told me the other day when he came to my home...

Q. REV. BROSHEARS, who is that man there?

A. That's DAVID FERRIE. (Laughter) I'm sorry. It's rather a bad picture. He doesn't look too bad when he's made up, you know. I mean he's passable.

Q. Did you ever get arrested for a charge of conspiring against President Johnson for statements you made?

A. Yes, I did. I was arrested. I was told I was going to be arrested by his friend, BERT. He said I was in trouble cause I had been blabbing my mouth.

Q. By whose friend, DAVE FERRIE's

A. Dave's. Who I had earlier been introduced to as CLARA and also CLAY. The last name was never given. I was told he was one of the wealthiest men in New Orleans and could buy and sell people.

Q. Is this a photograph of the man you knew as BERT?

A. That's a photograph of him. His hair seems to be a little fuller on top then it was on top at that time. He had his hair cut a little closer at that particular time.

Q. And do you recognize the man in this photograph?

Ferris:

apparently  
Shaw:

- A. That's BERT. That's the man who was identified to me as BERT.
- Q. And how was he introduced to you?
- A. The first time he was at Dixie's -- he had been at Lafitte's and then he came over to Dixie's and this is when he made a remark to me I didn't like.
- Q. What was the remark?
- A. He said something about he liked butch people or something of that nature. You all wouldn't understand that kind of language anyhow. Anyhow, he made that kind of remark and I let it be known that I didn't like the man and he kept buying drinks for people and don't like people who have money to go around trying to buy people. And this is obviously what this man did. He tried to buy everything.
- Q. Can you identify the man in this photograph?
- A. That is DAVID FERRIE.
- Q. And this photograph?
- A. I would say that looks like DAVID, but boy that's a lousy shot. That sure looks like him.
- Q. And this photograph?
- A. That is BERT.
- Q. What happened when you were arraigned and where were you arraigned?
- A. Well, anyhow, I was told that I was going to be arrested by the FBI for threatening the life of the President. And I hadn't really threatened the life of the President except to a lot of -- well, this man had heard it and so had DAVID and anyone who was in the bars. And I really didn't threaten his life. And I met some people who claimed that they wanted Johnson dead, too. And you know let's get together and do something. And we never really got together to do anything. Except I had met other people who didn't particularly care for Mr. Johnson in the past. Not here. Out in National City. A boy out in National City who really have a passion to kill Mr. Johnson. I mean that was his driving thing. He was to come out here to New Orleans, cause I called him and he was to come out here to New Orleans.
- Q. What was the statement you had made that led to your arrest?

A. I don't know which one. But they claimed that they had two letters to my grandmother, a letter to my mother in which I made statements to her, and also, -- and this I will never believe in ten thousand years -- that I sent a letter, a card to Mr. Johnson himself. I do not believe that. Now, Gentlemen, I'm sorry, I do not believe that I, even in my maddest moment, could have been crazy enough to send a card directly to the President and signed with my own name because if you're going to kill somebody you don't write them ahead of time and tell them about it. I'm sorry. But I had made some threatening remarks, there's no doubt about that. So on the last night before, DAVID said he was flying out at 12:30 and wanted to know if I wanted to go with him. I wasn't particularly wild about going with him. I thought it would be good but he wasn't going directly on to Cape Town. He was just going straight to Central America. He wasn't going to Cape Town which is where I wanted to go to cause they speak English down there and it's more an American-type country. And he left. And he come back with this huge -- and these things, you know

*Show:* And so we met BERT later on up on Bourbon Street and BERT gave him this huge envelope. It was something like an X-ray envelope. You know how big those are -- those are huge. And it had a smaller envelope attached to the outside and it was a large brown envelope about that size. But anyhow this envelope -- they reiterated that I'd better get out of town, that the FBI was going to arrest me. Well, I never even went back to the hotel.

Q. Who told you that at that time?

A. DAVID told me that BERT said I was going to be arrested. I never even went back to the hotel. DAVID reached in the envelope and took out two twenty dollar bills and he said, "Here, this will tide you over and hide until I get back." And he said, "Don't hide here in New Orleans." He said, "When I get back meet me down at Lafitte's." But he didn't say when or anything. So I figured, god, I was feeling so paranoid. Here I am in a southern city like New Orleans, I got the Civil Rights thing on me and these people down here don't particularly like people who work for Civil Rights. And now this guy says I'm in trouble, DAVE says I'm in trouble and this other guy says the FBI's going to arrest me for threatening the life of the President which there's no doubt that I have. So I didn't know what to do so I'm a disabled veteran so the nearest thing I figured that I would have immunity there, no one could touch me in a VA hospital, a federal hospital. Well, I was almost right. I had a very difficult time getting in. They wasn't going to admit me first. And then I said that I was going to kill myself and the doctor said, "That's nice, go right ahead and do it." I had a terrible time convincing them. So then I finally had to go out and

That got me in. I thought I had it made. I didn't

have it made.

Q. What happened then?

A. There was a real fine doctor up there, a Dr. STONE. A heavy set man, short -- I think he took a little too many mints but he was a fine man, let me tell you. And Dr. STONE told me two days after I had been in there, he said "There's a couple of men here to see you. They identify themselves as from the U.S. Marshal's Office. And I said what for. And he said, "You have written threatening letters to the President and you are wanted on this charge. And it's a very serious charge, threatening the life of the President." And I said, "Dr. Stone, I've said a lot of things but I don't think I've said anymore than anybody else has said." And he said, "Well, if you don't want to talk to them, you don't have to." And he saw to it that I didn't have to talk to them for several days. And then DR. STONE suddenly wasn't there. <sup>He didn't</sup> And this DR. ROBINSON who was his assistant, who was at Tulane University, a psychiatrist at Tulane University on their staff, or a teacher or something there, -- all I remember is he was something at Tulane University -- this DR. ROBINSON took over my case because DR. STONE had suddenly been transferred to Cincinnati, Ohio. Now I had seen DR. STONE the day before and he was talking about helping me get out of this mess and he wasn't going to no Cincinnati or anything and all of a sudden the next morning here comes this ROBINSON walking in. He said, "You're my patient." I go out in the dayroom and these two aides come in, grab me, took me in a room, threw me down, stripped me bare, and had me in cuffs and put pajamas on me and I was in a room like you wouldn't believe...just a mattress on the floor, just a light on the ceiling.

Q. What town was that in?

A. New Orleans, Louisiana, in the U.S. Naval Hospital, right here.

Q. What name were you in the hospital under?

A. EARL RAYMOND ALLEN. But I believe DR. STONE got the other name, RAYMOND BROSHEARS because that's what my sea file was under, BROSHEARS. And that's the first time they came in contact with the other name.

Q. Could I ask you a question? On July 8 you were on the Stan Forman television program in Los Angeles and when you were asked what the statement was that you had made that got you arrested you said that, "I stated that Mr. Johnson, the person who was responsible directly or indirectly for the assassination of our beloved President Kennedy, should be put to death."

A. Yes, I made that statement in front of Judge Christenberry in that so called -- I don't know what it was -- indictment, trial, commitment, whatever it was, I made it there. That is a statement that is officially attributed to me.

Q. Had DAVID FERRIE discussed the assassination of President Kennedy with you?

A. Not right off, but as I got to know him, yes. Of course, you know in the homosexual underworld everybody likes to make themselves out to be something more than what they are. You know, <sup>real important,</sup> especially, the more they're hitting the skids and the deeper down they're going the more important they like to make themselves, I feel. Of course, this doesn't have to be just homosexual underworld, in any facet of life, people on the skids like to make themselves out to be more important and I as I told Mr. Lane, I just talked, I didn't pay any attention to him and I was really riding him over it, you know, but the more I did this, the more he said.

Q. What was the first things that DAVID FERRIE started to tell you about the assassination?

A. He told me that LEE HARVEY OSWALD did not kill President Kennedy. And I said a lot you know about it. And he said, "I'll have you know..." and he started in

and he then proceeded to tell me about he was to fly two of -- he specified two of the assassins. He didn't say there were only two or one, he said "Two of the assassins. He said I was flying two of the killers from South of Houston on down through Central and South America into the Republic of South Africa cause they have no extradition treaty there and they'll be safe. And he proceeds to go on -- I still think it's some kind of a cock and bull story because it's just a little bit too big for me to -- trying to tie HALE BOGGS, a congressman here in Louisiana, trying to tie him with BILLY JAMES HARGUS and GENERAL WALKER and H. LEMAR HUNT and this guy in New Jersey, McINTYRE. He was tying them all together. He said it's part of the great, great white, Anglo-Saxon protestant plot to take over the country to keep their man in and I couldn't buy it. I really couldn't buy it then and I still have a hard -- well, I'm not having as hard a time buying it, I'll be honest with you. I'm not having as hard a time buying it now as I did then.

Q. What did he say specifically about HALE BOGGS and his involvement?

A. Well, he said HALE BOGGS, he mentioned -- now this is the only time he used the name CLAY SHAW -- he mentioned CLAY SHAW keeps HALE BOGGS in Congress. And this was several days after our first meeting. He said CLAY SHAW keeps HALE BOGGS in Congress. I found that interesting. I know some wealthy businessmen who do keep Congressmen in office by keeping the money going. And then I -- HALE BOGGS, I don't know, he -- then Mr. Lane tells me that HALE BOGGS was on the Warren Commission and, I don't know, I had just done what I had been told, I stayed out of everything. When I was told that DAVE FERRIE had killed himself, this was in March of 1966, I just accepted it as such and then went on and then they met me here at the airport, put me on a Delta Airlines for St. Louis and went to my cousin's farm.

Q. Who was it that told you that DAVID FERRIE killed himself in March of 1966 and who was it that put you on the airplane?

*Note: Even if anything Parshers recalls in July is what Ferrie told him, it is apparent that Ferrie is giving him some garbage from time to time -- to say the least. And this paragraph may be good example.*

*Shaw:*



- A. The man that put me on the airplane, I don't know who he was. He just flipped out a badge, and it was a Secret Service badge, you know. You know they've got those little cowboy-like, cowboy-type badges, you know? They just told me the agreement was that I would leave Gulfport, that I would not come back to New Orleans. Well, they had told me over there -- SHERMAN had told me that there was no good for me to go back to New Orleans cause my friend was dead. He had killed himself.
- Q. Who told you?
- A. SHERMAN.
- Q. Who's SHERMAN?
- A. Well, I understand he's Secret Service. He said he's dead. And I was quite physically shook about it. A lot of things were going through my mind and I wanted to see DR. STONE again and I remembered that DR. ROBINSON said he was in Cincinnati. So after I got up to Cincinnati and reported to the Secret Service and everything then I decided to go to Cincinnati. And I started to drive there and I never got there. I was met at the Indiana State line, at the Harmony Bridge by the Indiana Police and I was taken to a cafe up the road and there I was talked to.
- Q. By whom?
- A. By two Secret Service men.
- Q. Do you remember one of their names?
- A. SHERWOOD.
- Q. SHERWOOD?
- A. SHERMAN, SHERMAN.
- Q. Did you ever meet a Secret Service agent by the name of RUFUS YOUNGBLOOD?
- A. I met RUFUS YOUNGBLOOD here in New Orleans. I met RUFUS YOUNGBLOOD -- I have been thinking very seriously and it was not RUFUS YOUNGBLOOD at New Harmony. I get him and this SHERWOOD mixed up. It was not RUFUS YOUNGBLOOD.
- Q. But who was it that told you that DAVID FERRIE was dead?
- A. Well, SHERWOOD came over -- There had been numerous people from Washington because as CLARK said, "we're not jailing him -- if you want him in jail, put him in jail -- this is a hospital, if you want him out, put him out. We don't have any bedspace." So YOUNGBLOOD had been over there, YOUNGBLOOD told me he was dead; SHERWOOD told me he was dead and this other guy, CALCOT of the FBI -- it seems like there's a "cot" at the end of his name -- and he said your friend is dead, your friend DAVID. This was in 1966. So when I was met over at the Indiana State line they asked me where I was going and I said I'm going to Cincinnati. Now I didn't think anymore about this and I'm sure that my

cousin, Virginia, called the St. Louis office and told them where I was going.

Shaw:

- Q. When DAVID FERRIE told you that CLAY SHAW was keeping HALE BOGGS in Congress, did he tell you who CLAY SHAW was or what he did?
- A. He told me he was a wealthy financier and he was one of the wealthiest men in New Orleans and he mentioned a connection he, and then he mentioned a connection between a man named KENT COURTNEY and then he also told me that he was flying -- he had flown one trip with somebody named RICHARD LAUCHLI whom later I learned a little bit about.
- Q. Did you know RICHARD LAUCHLI?
- A. I had met him at the Stove Works at Collinsville, Illinois, after I went back to Coulterville, Illinois. I had never been to Coulterville before, I should say that after my cousin left Illinois. Shortly thereafter when I was told to "Go West, young man" this young man left and I went to San Francisco, and there I remained in comparative safety and silence because it does feel kind of good to have all of that money coming in every month.
- Q. Did DAVE FERRIE ever talk to you about PERRY RAYMOND RUSSO?
- A. Yes. He never did say -- not all the names you're running off there.
- Q. Just PERRY RUSSO?
- A. He mentioned the name RUSSO and he called him numerous names but I strongly suspect there was something there. I would only be projecting.
- Q. Did DAVID FERRIE ever mention RUSSO in connection with CLAY SHAW? For example, in an earlier interview I had with you you told me that RUSSO was somehow involved in either taking money from SHAW...
- A. But that is yet to be determined. That is only what DAVID said.
- Q. What did he say?
- A. He said something about it but the point was not too clear. He had a distinct -- he was very upset with RUSSO but I know he got money from -- I can't remember, three years is a long time for something that to me is insignificant. Insignificant for the fact that I had accepted the Warren Report.
- Q. Who said that?
- A. I had accepted the Warren Report.
- Q. Have you ever read it?

Russo:

A. No, but after what Mr. Lane said the other day -- a good cause. If the Warren Commission doesn't even look at the evidence, well how can it possibly be a reliable report.

Q. What did FERRIE do as an occupation?

A. Well, he claimed, he claimed that he was a private detective -- something which I very seriously doubt. He doesn't look the role of a private detective; he doesn't talk the role of a private detective at all in my book. That's all right. I humored him. You humor a lot of people but I don't think he was a private detective myself. He also told me about his trips and how he made his money. Now he told me that he started working for the government -- now this is the only thing that really has me concerned now -- he told me they started working for the government, but now he later learns that they are not really working for the government. They're working against the government. And that's why he was in the condition he was in. He told me there were films taken of him and a sixteen year old boy engaged in an homosexual act here in New Orleans and he told me that that is punishable in the State of Louisiana by life imprisonment. I don't know your laws here on that particular subject but this is what he told me. This to me in view of his condition, poverty condition, this accounts to me why he didn't have any money cause he was really making these trips almost for free.

Ferrie:

Q. What were these trips? What was he doing?

A. He told me that he made trips down to -- he mentioned to me very specifically, Guatemala and British Honduras and Honduras and Belize is one of the cities he said he likes.

Q. How do you spell Belize?

A. B-E-L-I-Z-E, but this is one of the cities he liked. I believe it's a

Q. It's British, yeah, it's British.

A. He told me that he flew arms and this was the first time that LAUCHLI came into it, but he never mentioned what LAUCHLI, what his role was.

Q. Did he ever say how he got paid for these flights that he made?

A. As I told you many times before, he never mentioned payment. He was always drunk and this is why he mentioned those films. He indicated that he was being blackmailed for these films. This is why it didn't cost somebody to make those flights. Except as I told you he would go, he would take the St. Charles streetcar and come back with money from time to time. And on one occasion we went over to this place, the building I identified which you say is on Camp, I believe, he got money there.

Ferrie

Money:

Q. The building that you identified was at 544 Camp St.

A. You told me that was where he supposedly worked at a detective company.

Q. That was the photograph I showed you.

A. Yes, afterwards, you told me that was where he worked as a detective, but I still don't believe he's a detective, because I understand detectives are licensed by the City here, any city they have to be licensed and I doubt -- was he licensed as a detective here?

Q. I don't know. He did work for a private detective here.

A. But don't you have any license to really be a genuine private detective?

Q. Yes, but you can work for them without a license.

A. He wasn't a private detective, Mr. Alcock.

Q. Did he ever mention the Central Intelligence Agency or any words to that effect?

*The Agency:*

A. The Agency. He mentioned the Agency, that is what he worked for.

Q. When he went on the St. Charles streetcar did he ever speak about that was where he was going?

A. He mentioned that he would get money from someone in the Agency. He never used the words Central Intelligence. And I have since learned, since meeting Steve and Mr. Lane, and I have talked with John, John has told me, and, of course, I have met this man but I didn't know who he was nor what he was with before. Now he's supposed to be a respectable contractor. I really don't know if he is or not but I know he's quite wealthy and has quite a fancy home in Long Beach but this man is --

Q. What's his name?

A. I...I...

Q. You'd rather not say?

A. I would only say that under subpoena; anyhow, this man told me that he used to be with him -- now he admits he used to be and he said he was an electrician, a member of the OSS

and they always refer to it as the Agency. And this is since the talk, because this man became very upset and did not want me to say anything more because he felt it was not in my best interests because Mr. Garrison was a man who had been proved by the government to be mentally ill and he said this man will do anything and he said he will not stop short of murder.

Q. This was that man you'd rather not mention?

A. Then, also, John told me about this MR. BALL, you know.

Q. What did he say about that?

A. Oh, you know, just telling me to lay off, you know -- it would be better for everyone if I just let sleeping dogs lie. Let the man rest in peace. He's dead, everyone else is gone...I didn't know, he later told me who MR. BALL is. He's out there in Long Beach and he's an attorney in Long Beach and he's not a very famous attorney in Long Beach at least not in our

not until Steve told me that.

Q. You're talking about JOSEPH BALL?

A. Yeah, JOSEPH BALL. You said he was on the Warren Commission. I think you said he was on the Commission. Was he?

Q. Yes, he was.

A. As Counsel.

Q. He was an attorney for the Warren Commission.

A. You never hear anything about him in Long Beach. He definitely lives there or John would not have told you that. He's not in the news, cause I've never heard of him. Of course, we don't hear of many of our lawyers in Long Beach...

(END OF FIRST SIDE OF TAPE)

Q. ...that the assassins were supposed to fly out of Dallas? What did he say happened?

A. They were supposed to fly between Ft. Worth and Dallas, he did not specify an airfield. Because a single engine, I have since talking with Mr. Lane, any single engine plane can take off -- it doesn't have to be from an airfield. And he said that CARLOS was a lousy damn pilot.

Q. Who?

A. Carlos. He said he can't fly worth a shit.

Q. Did he say CARLOS was one of the...

A. Yes, CARLOS was one of the assassins. And CARLOS didn't fly worth a shit. And they were supposed to fly him where he'd have a twin engine plane. He'd have a twin engine.

Q. Where was that supposed to be -- South of Houston?

A. South of Houston. He said that they didn't do it. They flew right down to Mexico. And he said they crashed off Corpus Christi.

Q. Did he say what CARLOS' lastname was?

"Carlos":  
(An increasing  
recurrent name  
with Ferris)

A. I can't swear to that, I'm sorry.

Q. What about this crash, was this recorded?

A. Yes, the government certainly knew about it, because the Naval Air Base in Corpus Christi, they cleaned it all up. DAVID said at that time there was some information about it but Steve tells me and Mr. Lane tells me there is no evidence of it.

Q. Did the plane crash close to Corpus Christi?

A. Off of it. On an island, on a sandy island off Corpus Christi.

Q. Was it recorded in the Corpus Christi papers that day?

A. Steve said he checked the Corpus Christi papers and it's not in there.

Q. (STEVE) I said we had somebody try and check the Corpus Christi papers and they couldn't find it. Did he say exactly what day it was that the plane crash took place?

A. Same day.

Q. November 22, 1963.

A. Yes, yes.

Q. Did he say who the other man was in the plane with CARLOS?

A. A Caucasian.

Q. What was CARLOS?

A. He was Spanish. He was from -- he was a Cuban exile.

Q. Did he say he had ever known these two men before?

A. Yes.

Q. Did he say where?

A. Here in New Orleans.

Q. What did he say?

A. Well, he felt that Kennedy was selling out to the Communists  
that Kennedy was selling out to the Communists.

Q. You say he indicated that he knew this CARLOS here in New Orleans; in what connection, how well or where?

A. He didn't say. At that time the whole thing didn't really mean too much to me you've got to remember I was in the homosexual underground and I was too busy trying to have fun and hustle a buck. Still, I wasn't really too interest, cause I could really care less.

*Cuba:*

I mean, at this particular stage of the game.

He was under the influence, when he would talk

He was always extremely frightened when he was sober -- extremely frightened.

Q. Did he ever tell you how he got to Houston or what he did after the plane didn't show up?

A. He told me he drove.

Q. And this what happened after the plane didn't show up?

A. I don't believe I told you that, Steve. I don't recall now how he told me he came back. He drove back.

Q. Did he go down to Houston with anyone?

A. Yeah, three of them.

Q. What was their purpose?

A. He claimed they went to -- and I find this very hard to swallow that anyone would go to Houston in November from New Orleans to iceskate cause I'm sure you must have an iceskating rink here. I think that he made up. An iceskating rink in Houston? It's hot in Houston in November.

Q. Who were the men who went with him?'

A. Well, this one I mentioned to you, TERRY LENDFORK.

Q. TERRY LENDFORK. And who were the others?

A. Inaudible

Q. Now you say when you first got down here leaving Bogalusa you checked into an hotel near the Continental Trailways...

A. Across the street cater-cornered this way, or cater-cornered that way.

Q. It had no sign, I mean no name, just hotel.

A. Hotel, it had to have a name on it. Of course, it would be in the VA records, the VA would have that.

Q. Why would they have it?

A. Because they had to pick up my luggage

Q. You were there the entire time you were here?

A. Yeah, I was there the entire time. Except for when I would visit other places. I stayed there just about the entire time, I would say.

- Q. Did you meet anyone at the location, any names that you can recall?
- A. DAVID came up there.
- Q. After you met him?
- A. After I met him. I didn't meet anyone there. When I first went there? No, no, no. Cause I didn't know where I was going, I had never been to New Orleans before.
- Q. What did you do with yourself when you first...
- A. The first thing I did was head toward -- after I was admitted in the hotel -- was head toward Bourbon Street. Everybody's heard about Bourbon Street. So that's how I accidentally found Dixie's, Lafitte's and everywhere.
- Q. You say you first met DAVID FERRIE in Dixie's. Is that correct?
- A. Yes.
- Q. Were you with anyone at that time?
- A. No, I was still just new. You can't really say you were with anyone, you know, bar places, just talking.
- Q. In other words, no one had actually gone to the place with you.
- A. No, I didn't know anyone in New Orleans.
- Q. How long after you arrived here did you meet FERRIE?
- A. The very next day. You saw the first night I went out and then the next night, the next afternoon...
- Q. You say he was with two young boys.
- A. Yes.
- Q. Do you remember their names?
- A. No, Mr. Alcock, I don't remember their names, because names are something they just don't use too freely...
- Q. Yeah, I can understand that.
- A. ...in this particular world.
- Q. Do you think you'd recognize their picture today if you saw them.
- A. Sure, I remember. I remember one in particular.
- Q. What did he look like?
- A. He was a very handsome young fellow, he had brownish-blond hair and he was about 6'
- Q. About how old would you say?



Thornley:

- A. I don't know. He appeared to be under the age to be in a bar.
- Q. Do you recognize this man in the picture here?
- A. That is the man whom DAVID FERRIE constantly referred to as KERRY THORNLEY.
- Q. And this person here?
- A. That is KERRY THORNLEY.
- Q. Where did you meet him?
- A. At Lafitte's in Exile. And I don't know what -- he always maintained that he was not an homosexual (Tape apparently turned off)
- Q. What is all this mystique in this damn office?
- A. They would just rather not discuss things in front of you that don't pertain to you or me. Now look at this boy here in this photograph. Do you recognize him?
- A. (Inaudible)
- Q. Who is it?
- A. I don't know his name, but I know him.
- Q. Where did you meet him? Where did you meet this boy?
- A. Here in New Orleans. That's one of DAVID's boys.
- Q. Do you recognize that boy right there?
- A. I don't particularly DAVID knew this boy. I've seen him arand.
- Q. DAVID knew this person but you never saw him?
- A. I've seen him. You asked me if I knew him and I said no.
- Q. Do you remember where you saw him?
- A. It had to be in one of the bars.
- Q. And you don't remember this boy's name but do you remember....
- A. I can't say anything on the grounds of being criminally intimidated.
- Q. Do you remember where you saw him?
- A. With DAVID FERRIE, yes..'
- Q. Do you remember what building it was? In a bar or in a house?
- A. No, this was kind of a hamburger place. The first time I saw him. Now this was not one of the two boys. He bears a strong resemblance to one of the two boys but

this was not one of the two boys but this boy I knew but I cannot tell you how well I knew him.

Q. LAYTON MARTENS, does that name ring a bell with you?

A. If his nickname is MARTY, then that's him. If his nickname is not MARTY, that's not him.  
(inaudible)

Q. Do you recognize him?

A. I'm not going to say for sure because if you look at that you can see that looks like so many people, nothing really distinguishable.

Q. Does the name SEELING ring a bell?

A. No.

Q. Now I'm going to show you a photograph of many boys lined up in different rows, do you recognize any of those? (Pause) In the front of the second line. Do you remember where you saw him or what his name was?

(inaudible)

Q. Oh, I see.

A. I can't say that I saw him here. His face is terribly familiar.

Q. Do you know his name?

A. No.

Q. Okay, here's another one.

A. This looks like Dr. THOMAS A. BECKHAM, doesn't it?

*Beckham:*

Q. How do you know DR. BECKHAM?

A. How do I know DR. BECKHAM?

Q. Yeah.

A. I really don't know how I got to know him (Laughter). He contacted me and wanted to know if I wanted to be a part of his organization. You've seen the correspondence.

Q. What was the organization called?

A. The American Academy of Professional Art, at College in Omaha, which I checked the Chief of Police and does not exist, except on paper. Legally it does exist -- I must say this -- legally it does exist. (Inaudible)

Q. Getting back to your first meeting with FERRIE, did you go off with him that night anywhere? That first night.

A. He wanted to, he wanted to.

Q. Did you?

- A. No. Just around to the bars and later on in the evening -- if you mean a hotel or apartment, nothing like that -- later on in the evening I drifted back over and this guy, CLAY, as he called him CLARA, and it made him mad when he would do it. DAVID too much for this guy. He was not that. It appeared to me he had on make-up and I hear all the men down in wear earrings so that didn't so that didn't shock me, so they his shirt and everything and DAVID asked me if I wanted to go with him...
- Q. The first night you met DAVID you also met CLARA or CLAY SHAW.
- A. What is known to you as CLAY SHAW.
- Q. What was he introduced to you as the first night, CLARA?
- A. He wasn't introduced to me. That's what he was called and he resented it greatly, believe me, he resented it. He was introduced to me as a very important person, a very nice person. And then he said something to me about butch or something of that nature and then later on when we were up eating, supposed to be eating, at the bar -- I don't drink, by the way, I just drink Cokes -- he patted me on the rear. And I warned him. I said don't do that again, I don't care who you are. I made quite a
- Who are you? Who in the hell are you? I mean I don't really know him. Frieck? I let him have it, too. I mean, so to speak, verbally. And he said I was only teasing and then did it again. And when he did smack all up. Right along side the head and he apologized, the next time we got together, he apologized. When he passed by he dropped a five dollar bill, you know, like I was a poor pauper that was his way of apologizing to people.
- Q. When DAVID introduced him to you didn't he call him by a name? Did he say, "Here is ..." or "I want you to meet..." or something like that?
- A. As I recall, the first time he used CLARA. He never used the name SHAW, never once, in that particular thing. In talking to me with him is the only time he mentioned the word CLAY SHAW when he mentioned HALE BOGGS. He had that particular hatred for him.
- Q. What about...
- A. HALE BOGGS. He had a hatred for CLAY SHAW, too. Because I kind of suspect the way he discussed those films that SHAW had access to those films or had the films. I can't prove that.
- Q. What about the name BERTRAND?

Shaw:

A. (inaudible)

Q. What about the name BERTRAND?

A. He never used the name BERTRAND, only the name BERT.

Q. Did you ever go to his apartment?

A. No. I went to several places here in New Orleans, apartment, but none that were identified as DAVID FERRIE's apartment or CLAY SHAW's.

Q. You never spent any time in FERRIE's apartment?

A. The only time I spent with FERRIE was when FERRIE stayed with me in my apartment. And this was when he had things he claimed belonged to LEE HARVEY OSWALD and he claimed that he loved LEE and all that kind of bull.

Q. You told me that you had come in contact with some of the possessions of LEE HARVEY OSWALD that belonged...

A. A hat, a hat like a

It's like a hunter's cap, gray. And it had LH on the front. And he claimed it belonged to LEE OSWALD.

which he claimed belonged to LEE HARVEY OSWALD. It had LEE written on it, engraved on it. And he said he had a lot more of these but CLAY has been buying them from me

So I strongly suspect this is one of the ways he got money. It's a weird situation. Blackmail's a weird situation. He said one time, "These are the only thing that's keeping me alive."

Q. These possessions?

A. Yeah.

Q. Did he ever make a comment about LEE HARVEY OSWALD?

A. I mentioned it earlier, he said he did not kill John Kennedy.

Q. Did he ever make a comment about LEE HARVEY OSWALD and his personal relationship with OSWALD?

A. Yes.

Q. Can you something of what that was?

A. Not on tape. (Pause in tape)

DAVID has told me numerous times that KERRY THORNLEY maintains he is not a homosexual. But I say he is and I say to the whole world if he is not a homosexual why was he in homosexual bars, why if he is not. And his resemblance to LEE HARVEY OSWALD is rather frightening. This DAVID pointed out.

Thornley:

Q. DAVID pointed that out to you?

A. Yes. (inaudible)

So, I had told him that there was something in one of the underground papers last week in Los Angeles

and I remember it said "From Kerry Thornley" and I didn't read it but I said to him, "Is KERRY THORNLEY in Los Angeles?" cause I got a little worried and he told me no, he's in Florida.

Q. Tampa.

A. I hope that's far enough away.

Q. Let's see, you met SHAW with FERRIE on one occasion on the first night, now did you have another occasion when you met...

A. Second and a third time.

Q. All right. Now the second time, who was present?

A. DAVID had agreed to meet him in this place. Now I'm almost positive it was on Bourbon Street, I'm not sure. sidewalk tables out there and a bar inside. Well, I sat at a table and he came up in a very nice, long chauffeured car. I think it was Cadillac, I remember that distinctly, it was a Cadillac and he got out

DAVID and he went to the bar and that's when he dropped the five dollar bill and said he was sorry for the other evening. And then they came out and when they came out there was a cab out front and the cab had been called for us

Then the other time was when DAVID met him and got the envelope and told me the FBI was looking for me, that I was in bad trouble. That they had a warrant out for my arrest, were the exact words but I later learned (inaudible).

Q. How did this man CLAY, or CLAY SHAW or BERT come to the restaurant? How did he arrive there?

A. You mean in a car?

Q. How was he dressed and what did he ride in, in anything?

A. He was in a gray suit, a very beautiful gray suit in a chauffeured car.

Q. What kind of car?

A. I said it was a car. I'm not -- I don't know that much about cars, atleast I don't have a car since the government took my driver's license.

Q. What color was it?

A. Black.

Q. What kind of car did FERRIE have?

A. He didn't have a car with me. He didn't have a car with me anytime. Anyplace we went we took a cab or the streetcar. In fact we took a cab from Dixie's down to the St. Charles Streetcar. I didn't even know if he had a car, I never asked him.

Q. Do you think if you drove around you might recall some of these places?

A. I asked Stephen if I'd have time to do this, I wanted to see, I wanted to bring it back. This is something (inaudible)

Q. What's this money you're receiving?

A. Well, it's listed as VA compensation, I found it a bit strange that suddenly I start receiving VA compensation, after being out of the service for almost twelve years.

Q. How did that start?

A. Well, this was in Gulfport (inaudible)

then this English doctor came in and he was

He said, "You tell those bastards that we're not jailing him, and send out a wire to Washington telling them that we're not jailers and if they want him in jail, let them put him in jail. And I'm releasing him." This is what he came and told me. This is when YOUNGBLOOD came down and talked to him and after several weeks I was finally released with the agreement that I would go to my cousin's on this remote farm in Southern Illinois which I did, and everything that went on in New Orleans, they had me, to their satisfaction they had me thoroughly convinced that I loved LYNDON JOHNSON, I was waving flags, I was wrapping myself in the American flag, and I was singing the Yellow Rose of Texas and I had everyone convinced that I loved LBJ and I said "I'm kind of messed up now, how am I going to live." I said to the doctor and he said this has been taken care, we've been assured that you're going to start receiving pension. So all of a sudden I received a huge, something like \$1,500 of back compensation and then I started receiving full compensation of

And this is how I lived.

Q. Did any federal agents ever threaten you saying that you'd lose that?

A. Yes.

Q. What was the circumstance surrounding that?

A. Well, this was not too long ago, actually after a certain television show in Los Angeles. They said if you want to keep receiving your pension, you won't be making any television appearances (inaudible)

"you've been a good boy, stay a good boy. Keep your money, keep everybody happy." (Inaudible) They said, "You're crazy, we've got the papers." I said I've got papers now that show I'm competent and sane.

- Q. Where did you get those papers?
- A. Santa Clara.
- Q. Santa Clara in California.
- A. Yes. With the help of Dr. WORTHINGTON (inaudible)
- Q. DR. WORTHINGTON, is he a psychiatrist?
- A. Yes. (inaudible)

I had not recorded my change of address.

- Q. When DAVID FERRIE was discussing the assassination of President Kennedy with you did he openly admit to you that he was involved or did he try and hide it or was he so upset that he openly...
- A. Let's put it this way. He -- I don't really believe that he felt he was a part in the assassination. He was doing a job that he had to do. He was forced to do. Cause he was terrified of going to prison.
- Q. When you were on the STAN FORMAN show...
- A. From what I hear about your Louisiana prisons, I'd be terrified about going to prison down here, too.
- Q. When you were on the Stan Forman show in Los Angeles on the 8th of July in response to a question from Mr. Forman, he said, "Did DAVID FERRIE admit to you that he was involved with these two assassins, that is CARLOS and the other one?" and you said, "Yes, he admitted that.
- A. He did. He did admit it. I mean you can't admit that you fly the plane and not admit that you're involved. But he never said to me killing the President. He never said that one time.

The first time I met the man identified as CLAY SHAW DAVID had a difficult time convincing him that I was not a communist. He asked who I was and DAVID told him that I was working in Bogalusa, a civil rights worker and all that, and he said oh, one of those communists. (inaudible).

I probably got to know DAVE FERRIE at the New Orleans Airport where I have owned several airplanes. I owned these airplanes from 1946 on. Sometime between 1946 and 1956 I definitely got to know him because in 1952 when we opened the Kenner Finance Company, I remember making direct loans to DAVE at that time. I got to know the man, he was a very interesting man to listen to. I used to just sit down when I had time and just talk to him. We did become friends. It was not just a business relationship. He even came to my house and visited us. DAVE was always tinkering with something and he had no tools and he was always borrowing something. He borrowed to the point of almost being a nuisance. I believe that FERRIE probably considered me one of his personal friends because he would take me into his confidence on financial problems and personal problems he had.

In about 1958-59 he came to me with some kind of hare-brained idea he had. He was going to Central or South America on some kind of treasure hunt or something. He always had wild plans like this outside the United States.

On June 14, 1961, he came into my office and introduced me to SERGIO ARCACHA and he told me that Mr. ARCACHA was a government agent and that the government checks were delayed and that he was needing a loan and FERRIE would be willing to guarantee or endorse this loan for ARCACHA. In the process of taking the application, it showed that ARCACHA was a New Orleans delegate for the Cuban Revolutionary Front and that his previous employment was with the Diplomatic Corps of the Cuban government for ten years. At the time ARCACHA made this loan which was for \$338.82, he gave the following references, namely:

1. A CPT. VON MAYER who lived at 6942 Canal Boulevard, as a personal friend.
2. A RICHARD ST. PE, living at 6971 Louis XIV Street, as a friend.
3. A MRS. NAOMI MARSHALL, 408 Camp Street, as a personal friend.

This is the only loan ARCACHA made with me. At that time I did see a States government Diplomatic I.D. card with his name on it. I verified his employment by calling



Jackson 5-8508. This loan became very troublesome in collection and it became necessary for us to continuously try to contact Mr. ARCACHA to collect it.

ARCACHA came into the office of my company, the Herb Wagner Finance Service, on several occasions with other Cubans, also, with DAVID FERRIE, ARCACHA and Cubans.

One day at my company DAVE called me one afternoon and asked me if he could meet me at my office after working hours as he had something very important to talk to me about. When ARCACHA and FERRIE came in, we sat down and we talked for a while and he told me, "HERB, you can be real valuable to us." FERRIE looked at me and said, "Did you ever hear of 'Operation...'" And he stopped and looked at ARCACHA and ARCACHA shook his head in an affirmative manner and then FERRIE said, "Operation Mosquito?" I made some little funny remark about so many mosquitos in the area and he said, "No, HERB, with your knowledge of motors, you could be helpful to us." Of course, he then went on to explain to me that they were planning a sabotage campaign to Cuba to sabotage machinery and transportation and so forth, in Cuba. I stopped him at that time and said, "Whoa, you've got the wrong man." I went on talking to DAVE as a friend and said I was married and have responsibilities and could not become involved in it. He said that we have to train other people to do this. "Could you give us a hand in that direction?" I told him, "DAVE, I would rather have nothing to do with it. If you have a fund raising campaign or something I can help you with, I will go along in that direction gladly." DAVE then contacted me several days later and asked me, "HERB, did you give it any more thought?" And I told him, "DAVE, I just borrowed a hell of a lot of money to open this business up and I can't fool with this kind of stuff. I have to make every minute count." And he told me, "If money is the only thing keeping you from this, well, hell, we can get money."

A few days later, DAVE called me and said, "HERB, do you want to fly with me to Miami?" I said, "Hell, no, what the hell are you doing in Miami?" He said something and I said, "Do you mean to tell me you're flying to Cuba?" He said, "No, let's say we are taking airplane rides." I told him, "DAVE, you must be some kind of a nut. You know the government's got radar everywhere. How in the heck are you going to Cuba?" And he said, "The government knows what we're doing. As a matter of fact, they're backing us."

He called me on another occasion later on and he came on real friendly this time. He said, "HERB, have you been getting any flying in lately?" I told him I couldn't afford to fly. And he said, "You're a damn fool. With what you know about navigation and flying, you can make money." I told him, "How in the hell can you make money, DAVE. Just tell me that." And he said, "We're taking people in and out of Cuba at nighttime." I didn't want any part of it.

The next thing I can recall, DAVE opened a service station called DAV-AL'S Gulf Service, 2316 Veterans Highway, Metairie. I have a business card with AL BEAUBOUF and DAVE FERRIE's names on it which you have a copy of.

*This was in  
in 1964*

On one occasion I went to the service station and DAVE used to call me "VON WAGNER". And he called out and said, "VON WAGNER, you square-headed German, come back here, I want you to help me." I went back to the station where DAVE was at. He had two rifles and he was attempting to mount scopes on them. I don't know what kind of rifles they were. He asked me if I would assist him in mounting the scopes with them and I told him that this was work for a gunsmith. And he said, "Hell, anybody can do it. Any machinist can do it." And he got kind of peeved at me. There were several other people back there with him but I didn't get a good look at them. I told him, "DAVE, all you're going to do is mess up a good gun" and I went back out to my car. DAVE did not say why he was trying to put scopes on these two rifles and I didn't ask.

Q. Do you remember if AL BEAUBOUF was present at that time?

A. I cannot remember.

On another occasion, I went to the service station and DAVE and a bunch of teenagers were there and they were tearing apart DAVE's plane. I asked him "What are you doing to your airplane" and he said, "I'm going to rebuild it." The airplane stayed there for some time disassembled and then it disappeared.

Q. Mr. WAGNER, previously you mentioned that you read in the Warren Report or in a magazine, that FERRIE's plane was not in flying condition at the time of the President's assassination and further, you related to me that you know for a fact that his plane was in flying condition. Is this correct?

A. I read somewhere, I believe it was a newspaper, that FERRIE's plane was not in flying condition but then I recalled of going to the New Orleans Airport with DAVE FERRIE making a collateral appraisal on the airplane for the purpose of making a loan and I asked DAVE at that time -- the airplane looked raggedy -- I said, "Does this plane have an Air Worthiness Certificate?" He said it did. It did not look like it would even run. He opened the cabin door and jumped in it and before I could say anything he started the engine. He said, "Come on. Take a ride." I got in the plane and we flew over New Orleans and Metairie and so forth. From outside appearances I can see how anyone would think it would not be flyable. I obtained from FERRIE the following information on his airplane to make the loan he requested:

When DAVE became involved in a crime against nature charge in Jefferson Parish, I was a character witness for him. He also had a priest from Loyola, several nuns showed up but they were not brought in, GUY BANISTER showed up and many other people I didn't know. I remember talking to BANISTER personally and I talk to the priest personally.

Q. Were you a member of the CAP?

A. No, DAVE asked me several times to join it and had it been a regular adult CAP, I would have joined it but from my experience around the Airport it was just a glorified Boy Scout Troop, just kids.

Q. Did you know LAYTON MARTENS?

A. Yes, I did. I met him through DAVE FERRIE, where I don't know. MARTENS also appeared at the trial with FERRIE as a character witness.

Q. I showed you a picture of CLAY SHAW. Can you recall if you have ever seen this man or ever heard the name of CLAY BERTRAND?

*Description  
of SHAW!*

A. There was a big fellow who walked with a very slight limp or a lobe -- he was not crippled or anything -- who used to go around DAVE's service station but I cannot say that this man is the same in the picture that you have shown me of CLAY SHAW. I cannot remember anything else about this man.

Q. Did you know LEE HARVEY OSWALD?

A. No.

Q. Do you think that you could recognize any of the Cuban people that you have seen in company with FERRIE or SERGIO ARCACHA SMITH?

A. Through the Cuban type people that you have shown me pictures of, I can't recognize any of them and I think that Cubans all look alike.

Q. It should be noted that Mr. WAGNER was shown all the pictures in our mug file on subjects connected with this investigation. The only ones he could identify were GUY BANISTER, LAYTON MARTENS, AL BEAUBOUF, DAVE FERRIE and SERGIO ARCACHA SMITH.

Let me tell you this, five times since the assassination my house has been ransacked and nothing taken. Four different times my office has been ransacked and nothing taken. One time my camp on Blind River was ransacked and nothing taken. These can all be verified by police reports.

Something else I remember is that when FERRIE had the service station, he asked me if I would like to go across the Lake with him for a weekend to tell people or show people how to damage engines.

Well, to make a long story short, I was in the same outfit as Oswald was in the "Fair Play for Cuba Committee" only apparently he wasn't in it so deeply and in a different part of the country and, at the same time; now bear with me now because this is a very difficult explanation to a certain extent.

My wife gives me a bit of a rough time when I discuss this situation. I think I'll bust her in the eye to be truthful about it. Anyway the FBI contacted me when I came back and I blew the whistle to them for a year while I was still an officer in that outfit in Chicago "Fair Play for Cuba Committee" I appeared in a hearing with the rest of them. Now, I was never a communist, right winger or left winger or anything you see. I was merely interested in the revolution which I hated a little bit. I could fly a little or push an airplane around a little.

Now, Can I make a more important point, after my time was up there, which was a year, when a hearing was to be held, I was told by the FBI that they wanted more information from me and that was it, they didn't explain or anything, and it was sort of a let down. I was going to whistle on my former friends. I thought I was convinced by them that I was doing a proper job and they kicked me down so, I blew out of there and came to California and that was in 1961, the day they were holding the hearing. They didn't want me around apparently, so here in 1962, I joined up with a bunch of anti-Castro people, Cubans, Americans and others. And then I found my way into circles of the political right, you see, who were very effective in trying to do away with Castro. At least they were talking about it. That's all they did was talk about it. Believe me, I bought the right wing line of thing and I am not against them right now, as a matter of fact, except that I found out a lot of things that horrified me; I peddled their line for them, because I thought in turn that they were going to help us get rid of Castro. They were anti-communist, anti-Castro and all that stuff and I hated Castro, because what the communist were doing embarrassed me, made a fool out of me and wasted all my efforts, so I was going to get even. So this right wing thing was the way to do it and I swallowed it. I thought it was a great idea; the Americanism, patriotism and all that stuff. As time went on and as I look back I didn't know it at that time, it was always the anti-unity bit; (he's a dirty communist, and this and that) and I figured it was just a bunch of hog wash and I'll go along with the people just to get action against Castro. And the individuals were donating heavily, you see.

Well, the Birch Society was talking against Castro. In other words, "Cuba free in 1963" and everything. The individuals were actually doing something about it by donating money to these different organizations preferably to Hall, and Howard got it and the other people got it in New Orleans, Dallas, Florida and so forth, the money finally got to them and the medicine that came from the doctors.

Q. When you say Hall, you mean Lorenz D. Hall?

It is a nickname by the way, his name is Lorenzo. And Lawrence Howard is Larry Howard. I am sure Weisberg knows this, the rest know this too that Larry Howard is a Mexican American. Lorenzo Hall is a Cuban American. The number three man was a guy by the name of Guy Gabaldin, a Mexican American, the one time big hero they made a movie about called "Hell to Eternity", a former marine, if you recall it.

Q. I do vaguely.

They play it every year on Channel 9.

Well, anyway, the point is, these people, I find later were in it long before Weisberg and all the rest of those people came along writing books and it bore on my conscience. I informed the proper authorities about my involvements so I wouldn't become pinned down

when they finally arrested them for associating with assassigators of President Kennedy.

Now, I immediately thought, and I told old lady Oswald so, "My gosh woman, your son is doing the same job as I was." That was my impression. You don't get wrong impressions when you are in a mess like that. And later on the evidence came out that he was this and that. So I said well, apparently those people were the ones that did it and then I thought they didn't want Kennedy dead, but the right wing was always trying to kill him. Gabaldin said he was going to kill him in 1962, when Kennedy visited Mexico City. He had an office in Mexico City, by the way, running an anti-communist fron called "Drive against Communist Aggression".

Q. This was Gabaldin?

Gabaldin, Howard, Hall, me and all the rest. He was financed by some big business men here of whom I have the list of names and whom I became very friendly with. Now, I don't know if you are getting this proper or not, but you can ask me questions. He had an office there, he had some friends in Mexican Federal Police. The FBI of Mexico, who he tried to get to help with this Kennedy deal down there. To shoot Kennedy in Mexico City when he was on parade there. And I thought, well, the guy was crazy, he is not talking sense and he didn't really mean that he was going to kill Kennedy.

These people, Oswald and whoever they blame for it and even if he was involved or not which I doubt that he was in a way, at least I think he was finking on him just like I was on those people up there. They hated Kennedy, you get it, no "Fair Play for Cuba Committee" say they hated him, but I heard the right wing say they hated him. "Them dirty B----- should be dead. G---D---him and all that sort of thing". When I was on the other side, I believed what they believed in. I didn't believe what the left wing believed. I finally got to believe what they believed. I couldn't follow it, it didn't make sense. But I understood that they called him a communist. Actually I was against communism, but I wasn't long with them, just to do away with Castro and to aid the people that were going against Castro. Okay, now they had this office in Mexico City, this Federal police officer, Captain Juan A. Aranda practically had him assassinated, Gabaldin assassinated for trying to present the problem of killing Kennedy there. He ran him out of Mexico City.

Q. He knew what he was up to, in other words?

Sure, he told the, they had been friends for a long time, this anti-communist stuff. Then Gabaldin tried to sell ---remembering Gabaldin, Howard and Hall was one group with a bunch of other people---

Q. Of course, I remember.

They all associated. I knew this and I thought it was great. Anyways, he couldn't swallow the whole trap that Kennedy was a communist. Being Mexican and he wouldn't believe it. He just couldn't see it, so they rounded them all up and threw them out of Mexico City. That was it, they took his furniture that he had in his office and seized him. And no one knows about those things. If Oswald went to Mexico City, he went there (now here is another shot)--Gabaldin and I went one day to John Rousselot of the Birch Society and Sam Moreno in their old office down the street from there, the present one) to get \$10,000. You might think I am some kind of a damn fool, but I am not. I want to see these dirty double crossing finks get what they got coming, because they continue to be a threat to me, what we believe is true, and obviously it is as true as the daylight now showing. I dont' care to prove it and all that garbage where you've got to prove stuff, that doesn't mean anything to me.

Q. But you want the information to get out?

That's right. I've written all of this down and I am looking at my briefcase that contains every name and address and everything I ever did.

Q. Do you remember that portion that Mr. Weisberg spoke and he talks about the visit to Sodib Auleo's apartment?

Right in my organization, sure. Certainly I remember that. When I saw that in October 1964, I said, My God, they have really did it.

They have really reached out, when Howard and Hall's name appeared.

Q. What about William Seymour?

Billy Seymour. It looked like Oswald---And I would say that---how come no one?---How come no one has ever gotten the whereabouts of Cabaldin? You know the FBI---Now let me tell you first one thing before the \$10,000 bit is finished here.

Senator Hoover---Now, you know what I know about the Bureau is this, and you can't blame him, No, I mean you can blame hi, but, for this point---National Security was always drummed into our minds --And any time I open my mouth, they talk about National Security---please don't say anything to me. Now, I agree with National Security and it is immoral sometime, but, for National Security reasons alone he has done what he has done.

Q. He put the lid on this thing, in other words?

He put the lid on, he aimed to keep it on there at all costs. He has to, because, these people, their representatives, of the people I am discussing now, are so powerful in the United States, that they can knock the President off, if they want, if he doesn't tow the line. The right wing said this about the communists. But it isn't so, it is the right wing that is really that way.

Mr. Hunt and a lot of the big shots that I agreed with, they can do these things and they will. If things don't go right. Now, I am surprised, the right used to cry, we don't have any money, we don't have any power, we don't have this, why, they organized the Birch Society and got it financed. Now, don't get me wrong, I am not an enemy of theirs. I read their book right now, and their material and I agree with a great deal of it, but nevertheless, it doesn't make this fellow any less guilty of associating with Cabaldin and that bunch of creeps. The ten grand Cabaldin said he didn't get when I waited outside the office, he went inside and talked to Rouselot. He said he didn't get it, but they talked for four hours. The ten grand was supposed to go to Mexico City operation, whatever that means, I know when I was invited down there, Cabaldin and I were both flying airplanes, he invited me to co-pilot for him. I never went down, I was afraid to go to Mexico because of the mess I had been in with Castro and he got more effective agents.

Q. In Mexico?

Yes, the ten grand apparently he didn't get. But I think he did get it. And John Rouselot was supposed to kick back whatever benefits to the Birch Society. That was Cabaldin's work. It didn't ring a bell with me then. Later on, a personal friend of mine was working in a little Savings and Loan place and it turns out that this very poor fellow, Mr. Rouselot, whom I know quite well, and as I have said many times, he was in cahoots. To many people, I have said this, but I never went into an explanation of the whole thing. He made a loan of \$19 or 24,000 on the first of 1963. So you can't say he didn't have the ten grand to do it with. I've got a copy of the loan. When I saw that, it even added up more so. I am not one given to fear, but I am just telling you that is the way things are. And when I see all these guys like Mr. Weisberg and Mark Lane. I have talked to him on the phone, he kind of figured out I was some kind of crackpot. But they are aiming at a thing that I have known for years. And if they really are wanting to do something, let them do this. Let them say these things. Let me get up and say these things and I'll say them. We'll bring this thing to a head.

I'll tell you why exactly Mr. Hoover is covering up from my point of view is having been an undercover fink for them for a year is for National Security reasons. I agree with him, but he is still covering up. And that's it. And many another thing has happened in the interim. They're all written down here.

Q. I don't know if you recall, I just wanted to ask if there was a Leopoldo.

That could have been his underground name of Lorenzo.

Q. That came to Sodio Audeo's apartment too?

I think it was Lorenzo. Leopoldo was working with an underground name. Howard wanted me to run an office here in 1963, before Kennedy was assassinated, to inform the press, make press releases and collect money, which I didn't do because I was doing other things along right wing lines; to run an office here, to get press releases under way, just as they were about to happen against Castro.

Howard is a warrior. Hall was political person that made speeches at Birch Society meetings open meetings and closed meetings and was very well accepted by them. He made a lot of money. I found out, I said to Gabaldin one day, "what is he doing with all this dough? Is he really putting it into the anti-Castro operations. He said "every penny of it goes in there, I guarantee you", and I took his word for it at that time, because he was a sort of the leader of things.

And another thing, Gabaldin, when he came back from Mexico, he ran this drive against communist aggression which was financed from here. I have all the literature on it and remember all the details. He made speeches all around Arizona, Canada, Detroit. He was all around and therefore, helped build up the network we had. Everything is ABC

Q. Was there such a network in Dallas too?

Well sure it is in Dallas. It was part of our---I am associated with juror members here now, they're inactive by the way. If there is something going on at least they are keeping it quiet. They probably suspect me of being a fink, I suppose. But I really think, because we were such good friends, awhile back, that there is really nothing popping just now. They work and naturally take advantage of the situation. Right now it is not profitable or possible.

Q. Where is Gabaldin now?

Oh, he's hiding out in Mexico. See, all those guys took trips quietly. You know when the FBI can't find the, they are well hidden. They couldn't find Howard or Hall for a long time.

I saw Gabaldin about six months ago, over in El Monte, a Mexican restaurant here, he and one of his former backers, who was a big wheel in Freedom Forum, and his name was Ray Fleischman. Now for Ray in whose opinion, doctors and so forth, we \$10,000 worth of medicine for anti-Castro operation in the Mexico City deal.

Q. Was there any link between group and Ruby with his activities in Cuba?

I don't even like to talk about that guy because, I can't stand anyone, I feel sorry for him and the way he died and so forth, but I knew he and I knew he would just like Lane and Mr. Weisberg knew. He was a dirty rat that was in the scheme somewhere. I don't even like to talk about a back shooter in other words. I got no use for him. He's cheated everyone and helped make the big lie.

Obviously, if that woman said he was involved, he probably was involved. I'd discuss it with her if I were researching the situation.

Q. Which woman are you referring to?

I think Mr. Lane or Mr. Weisberg wrote about some woman who put the finger on Ruby as being the payoff man.

You see, we were all in Cuba at different times.

Q. You were there too?

Well, sure, just for a short time, after the war.

This is some of the government there, some of the big wheels. Any of them that went there were either for or against. They had some deal going with the government, see. They were involved in other words, they didn't just go there to look around, because the peasant armies are marching and people are building and things are really going on down there. So you just don't go there to look around, it is not just a good tourist spot. It's a revolutionary activity, so Ruby was there, and that convinces me he was involved.

Q. Did you know anyone there by the name of Praskins or Pratkins, or anyone by the name of McWilly?

I knew those names. They're in the same report that I am in. Oh, no, no, no. I just heard the names. I don't know them.

Q. They don't ring a bell.

They do ring a bell, but not with my activities; I don't know them at all. I just read about them and I don't want to bring them in with the reality of what I know.

Q. Certainly. Well, it has been very interesting, in any case, and I don't know when Harold will be out here again, but I know that he would enjoy meeting you when he does come and I am sure that can be arranged. In any case, remember that I called and that wasn't your home phone was it. Am I talking to you from there?

That is my business and home both. It's a little printing business.

Q. Well, I'll be in touch with you in any case. I am very grateful for your call and that is all I can say.

Well, these guys are bating their brains out. I don't know what their angles are. They may be very honest upstanding non-political non-religious people that are really trying to do their job, and I'd like to think that was the case. It doesn't matter what their real motives are, the point is, they are fishing around and finding out a whole lot of things and I don't want to be embroiled in the middle of it when they fish my name out of the hat. If you know what I mean.

I'd rather blow the whistle now and get it over with, If someone used it, then I am in the clear.

Q. You speak about people knowing how to fly airplanes, you know it was speculated that a plane did take off or was scheduled to take off at Redbury Field at Dallas the afternoon of the assassination.

Oh, I never heard that.

Q. Yes, that is in one of the articles by one of the authors of the case. Somebody felt that a plane really did take off for Mexico or one of the South American countries.

I know Gabaldi flew a lot of miles back and forth. Look, here is a very simple solution. Gabaldi naturally wouldn't be involved directly, he might even be sitting there in an airplane, I don't know, I don't care about that. But where was Billy Seymour that day, to whom I think, you know, run upstairs and put uncle on the spot, I really think that. He was just a dirty little rat like some of these people who are trying to make a name for themselves. These big movies heros.

Q. Did these people have experts, firearms and weapons?

Well, yes. I learned stuff myself and they had people who wrote manuals by hand and passed them around to the Greeks that were training on Nonamekey. That's name of the key. That's "no name". There was also a place near New Orleans. They had experts there. ~~There was a local guy training them there, a Canadian, and Howard and several others. What they wanted from us was medicine. If you've got a wound, they want to throw a powder on it. What kind of powder it is I forget now. And aspirin and stuff like that in case they were wounded you see.~~



So they knew all the fundamentals of killing, wounding. They knew all the fundamentals in a raid. I would say Howard was an expert because he sure taught an awful lot of men in the army --Castro.

I don't give a hoot about any of those people anymore. I think they've used me up. I don't want to be around when the ax falls and at the same time I want to see it fall.

Q. You want to get your information out while you have the chance?

Right. ~~And these birds which I did definitely imagine was the case, were involved, whether Oswald was or not doesn't matter. I still think he was doing the same job I was doing. Before, I even read a word of it, I knew it.~~

Q. That Oswald was down here?

<sup>brought</sup>  
I'm the one/his old lady on the "Joe Pine Show". Did you see that?

Q. No, I didn't, I heard that she was here though.

~~That was in 1965, I appeared down there and I told briefly what I was involved in and I said "you know I got the impression your son was doing the same thing I was"; they shut me up and I thought the Federal Bureau wouldn't ever speak to me again, because they told me to shut my trap, see.~~

Q. Tell me can I reach you at this number? When is the best time to call? Or do you want to leave it as just where you can reach me?

Well, it would be sensible just to have it that way, wouldn't it?

Q. Allright, whatever you like, but this is a good time to call me, early in the morning and I will transfer some of this to Harold, if you like, at least I will give him a report on the facts as they are.

Q. What do you think of General Walker? I mean you say you know Walker, Do you think it is true that he might be involved? First of all, you know that Oswald was to have taken the shot at General Walker?

A. I don't believe it. I think Howard took a shot.

Q. Oh, you think Howard took a shot?

Certainly, he was in Dallas with all those other crums. I don't believe Oswald did it. I don't care, you see. I don't want to try to prove anything. I am just trying to tell you who did what, and why.

Q. Well Oswald supposedly had someone with him? There were perhaps two people involved in it.

Like Billy Seymour and Howard who was always hauling his big Mexican carcass around trying to pull some kind of a caper. Oswald was a fink, just like I was. A fink for the Feds. Let's face it. We did things that were completely opposed. We committed treason for the Federal Bureau of Investigation. You know what I mean. The things we blame the committee for doing, we did, we led them, we organized them and we would do things that would put us in such a light, such a position and we would even go take a shot at someone, if we had to, if that was part of getting us to infiltrate some organization. There it is, it is horrible, but true. And then it was very likely that Oswald did it intending to infiltrate never intending to hit, you never know, it is something that bears investigation, if possible. The very cover up of the situation, obliterations here and there of things, indicates some more things involved which I am glad to see people investigate it.

Q. Do you think it is conceivable when Oswald went to Mexico City that he was endeavoring to see Gabaldin or was Gabaldin there at that time?

Exactly what I am thinking. Look at Billy Seymour--And another thing Gabaldin told me that hit me pretty hard and I hated his guts for it, not hate him, I wouldn't burn his house down, but I hated him because he said later on before Kennedy died, "I know a guy that looks just like you." Now here's me. A picture of me. I'm going around wearing a Texas hat, I've got a rifle and I go out and shoot all the time and Gabaldin knows this. I'm a chewing tobacco, Texas hat wearing gunman, you get it. He's got this picture of me like I am some kind of a big fat fool. He's telling me, I know a guy looks exactly like you and I said "poor b-----and so forth. But he told me this several times and that gave me the impression he was trying to tell me something. Then later on I realized By God it could have been another one of these Billy Seymour deals trying to get me with my own reputation as an NRA member and a shooter and get me involved in all this deal. So this isn't from what somebody else investigated, this is what I realized later on, and it worried me plenty.

Anyway it is a long miserable situation and with both people it was hate drove them ever forward and I suppose with a little money too. But more and more actual hate than money.

Q. I think that is obvious.

I think I had better hit the trail as I am holding you up there.

Q. I appreciate it in any case and we will be in touch then.

A. Good show.

Q. Okay, thank you so much. Bye Bye now.

On July 27, 1968, at approximately 8:30 p.m., Mr. Mark Lane and myself went to visit Rev. RAYMOND BROSHEARS at his Long Beach address on Orange Avenue. According to an arrangement made with him by telephone, we visited him to discuss his association with DAVID FERRIE, his knowledge of the assassination of President Kennedy which he gained from DAVID FERRIE, and the television appearance he made on a Los Angeles television show called "The Stan Bohrman Show". (See memorandum of July 10, 1968).

We asked REV. BROSHEARS to tell us about his stay in New Orleans. Mr. BROSHEARS said that in 1965 he came to New Orleans from East St. Louis having worked there with the Congress of Racial Equality under a man who was an executive in that organization named MR. RANDOLPH. Mr. RANDOLPH had given him the names of several people in the same organization in Bogalousa. After going to Bogalousa, REV. BROSHEARS had been stopped by officers from the Louisiana State Police and interrogated. He said, "I was beat up." The REV. BROSHEARS came to New Orleans.

BROSHEARS said that he came to New Orleans knowing no one here, however, he had come here to escape his problems.

REV. BROSHEARS said that he registered at a hotel which had no name, which was across from the Continental Trailways Bus Station. He said he registered under the name of EARL RAYMOND ALLEN. Shortly after his coming to New Orleans, he met DAVID FERRIE. BROSHEARS said that he met FERRIE at a bar which was known in the French Quarter as a homosexual bar called "Dixie's". He said that he also associated with DAVID FERRIE at another bar known as "LaFitte's in Exile".

FERRIE:

BROSHEARS' REFERENCE  
TO HALE BOGGS IN THE  
CONNECTION IS BUT ONE  
EXAMPLE THAT HE IS TOO  
HASTY TO ADD UP TO EVER  
BEING A SOURCE OF EVIDENCE

ON THE OTHER HAND, FERRIE SEEMED TO HAVE REACHED A  
STAGE OF INTIMACY WITH HIM - SUPPORTED WITH THE  
APPARENT USE OF ALCOHOL & PILLS - SO THAT BROSHEARS  
SHOULD NOT BE TOTALLY DISPENSED WITH AS A SOURCE  
OF INFORMATION AND POSSIBLE LEAD. (FOR EXAMPLE)

BROSHEARS said that he discussed the assassination  
of President Kennedy with DAVID FERRIE only after having known  
him intimately for a while. BROSHEARS stated that FERRIE had  
discussed with him the following names in relation to the  
assassination of President Kennedy, and a conspiracy in which  
FERRIE admitted his own involvement. The names were:

X HALE BOGGS, Representative to Congress from the  
State of Louisiana;

X KENT COURTNEY, financier in New Orleans; *(Does not check out as being involved in any way)*

*Well known Marxist  
Was arrested with  
anti-Castro friends  
at dinner north of  
Lake Pontchartrain in  
late Summer of '63.*

X RICHARD C. LAUHLI, of Collingsville, Ill.;

CLAY SHAW, who Ferrie said had been Director  
of the International Trade Mart in New Orleans  
and was now financially responsible for HALE  
BOGGS remaining in Congress.

At that time BROSHEARS said, "I didn't know these people, or  
what the Trade Mart was."

BROSHEARS said that FERRIE stayed over night with him  
at his hotel room on several occasions. During one of those  
occasions two men came to their door and forced their entrance  
to the room. They questioned FERRIE, threatened FERRIE, and,  
according to BROSHEARS, left abruptly. After these two men  
left, BROSHEARS asked FERRIE who they were. FERRIE said, "They  
are just men who I am afraid of." BROSHEARS said that these  
men had hurriedly identified themselves and he could not see  
from their identification who they were. BROSHEARS stated that  
FERRIE later told him that they said they were from the District  
Attorney's Office (NOTE: This was in 1965.) BROSHEARS said  
that FERRIE was fantastically nervous, and was given to deep  
periods of depression. He said that it was only when FERRIE  
drank to excess, or had taken pills that FERRIE would confide  
casually with BROSHEARS in some of the involvement that he had  
had with the assassination. BROSHEARS said that he did not tell  
him immediately that he was involved with Civil Rights work, but  
later discussed his background.

FERRIE:

FERRIE told BROSHEARS of "the mess he was in". FERRIE  
said he was a pilot. He showed Eastern Airlines Wings with his  
name engraved on the back to BROSHEARS, and said that he had  
been fired from that organization for charges of homosexuality.  
FERRIE stated to BROSHEARS that he had been flying private  
planes to Guatemala, Costa Rica and British Honduras. BROSHEARS  
said that, "If this was a way to make money, DAVID didn't have  
any." BROSHEARS stated that he felt that FERRIE had been forced  
to work for this organization, and had been "hooked into it".  
He said that FERRIE never liked the work he was doing, but that  
FERRIE had confided in him that he was working for "a group of  
people who wanted to take over the United States".

Since BROSHEARS felt that the homosexual underground  
in which he and FERRIE were involved was "an hysterical scene",  
he said that he did not take FERRIE seriously. FERRIE said  
that he was flying guns and ammunition. FERRIE told BROSHEARS

that he had been stopped by British officials at a place called Belize during a "regular run" to a British colony in British Honduras. He told BROSHEARS that his plane had been inspected and that the authorities there had contacted his bosses in New Orleans. FERRIE told BROSHEARS that he was immediately released. He told BROSHEARS that he flew a twin engined plane, but that during the entire time of his work for this organization he was not doing it voluntarily, but was being blackmailed. BROSHEARS had nothing in the way of money, but FERRIE would often give him small amounts - \$20 or so - after he had gotten money by taking the St. Charles streetcar to a location which FERRIE only called "the agency".

FERRIE told BROSHEARS in regard to President Johnson, "that damned Johnson.. If you knew what I knew, you'd kill the bastard." "DAVID said he killed J.F.K", BROSHEARS said. BROSHEARS asked him how he knew this, and DAVID refused to say.

DAVID FERRIE told BROSHEARS he was to fly two men, two of the assassins who killed President Kennedy, in South Houston out of the country. FERRIE said that he was to fly from Houston with the two assassins to Central or South America, and later to Capetown, Republic of South Africa. The reason for going to South Africa, said FERRIE, was that that country had no extradition treaty with the United States. FERRIE told BROSHEARS that the assassins never showed up. They were supposed to have come to the Houston Airport in a small aircraft after the assassination, from Dallas and Fort Worth, Texas. Instead, FERRIE told BROSHEARS, they tried to make it all the way over the Mexican border and their plane crashed and burned on a sandy little islet just off of Corpus Christi, Texas. FERRIE said that one of the assassins named CARLOS had directions to fly to meet him at the Houston Airport, and had further directions to a bar where they were to make a contact in Central or South America.

FERRIE:   
preachers, FERRIE told BROSHEARS, "It seems like you big money creatures are into everything." When BROSHEARS asked him what he meant by this he said that BILLY JAMES HARGIS and another "big phoney up in New Jersey" (BROSHEARS said this was DR. CARL MCINTIRE) were involved in the plot against President Kennedy.

FERRIE said that, "President Kennedy is the first, they're not going to stop until they kill every nigger in this country." BROSHEARS asked who he meant by "they". DAVID FERRIE said, "HALE BOGGS, and the others. He blackmails everyone. He has a blackmail file, I know." FERRIE told BROSHEARS that some other people had been killed as a result of what they knew about the assassination. He did not evidently tell BROSHEARS who these people were. FERRIE did say that if Jacqueline Kennedy or Robert Kennedy ever spoke out about the assassination they had been warned they would be killed also. FERRIE told BROSHEARS that other people who were in Dallas had been killed.

BROSHEARS doubted what FERRIE had told him. He said that FERRIE ought to go to see a psychiatrist. FERRIE said that he knew what he was talking about. He said that there is an organization called the Central Intelligence Agency and that one of the leaders of that organization, a man named DULLES, is not a fine man. FERRIE told BROSHEARS; "They are going to turn this country into one big barbed wire prison."

BROSHEARS said to FERRIE that, "Everyone knows that LEE HARVEY OSWALD killed President Kennedy." FERRIE replied, "Have you ever read the Warren Report? If you do, you will see that they never looked at the evidence." FERRIE said, "They murdered one of the best lays I've ever had. He didn't have anything to do with killing President Kennedy. He was set up." (LEE HARVEY OSWALD) FERRIE told BROSHEARS that GENERAL WALKER was the "military brains" behind the rightest group. "There are two people in this country in New Orleans, KENT COURTNEY and CLAY SHAW. SHAW keeps HALE BOGGS in office."

While on a television program in Los Angeles, California, the Stan Bohrman Show, July 8, 1968, BROSHEARS stated that he had been arrested for threatening the life of President Johnson. He said that he had made the statement, "President Johnson, who was responsible directly or indirectly for the assassination of our beloved President Kennedy, should be put to death." BROSHEARS told us that he had made these statements because of what DAVID FERRIE had told him. After he made these statements in late 1965, he was told by DAVID FERRIE who was told by a man he now knows as CLAY SHAW but then knew as CLAY or BERT. In approximately September of 1965, BROSHEARS was arrested by Secret Service agents and Federal Marshals and taken to the Veterans Administration Hospital in New Orleans. There he was arraigned by Federal Judge Christenberry in the presence of other Secret Service agents for conspiring to assassinate President Johnson. Mark Lane asked BROSHEARS who the other co-conspirators were. BROSHEARS said that he had made statements and discussed President Johnson in a disparaging way with four others who were also arraigned according to what he could find out. One of them, he said, was a young man from National City, although he rememberd no names. During his detention in the Veterans Administration Hospital Psychiatric Ward in New Orleans, he was questioned by Secret Service agents, RUFUS YOUNGBLOOD, a MR. SHERMEN or SHERWOOD, and an agent TOM HORN, (now in the Los Angeles Bureau of the Secret Service). One of those agents told BROSHEARS, "For your own good we're going to commit you to a federal mental institution." BROSHEARS was then taken by Secret Service agents to Gulfport Psychiatric Hospital in October or November of 1965, and was not released until April of 1966. During BROSHEAR's stay in the Veterans Administration Hospital in New Orleans, he was under the care of a DR. STONE. In the middle of that stay he was told that DR. STONE had been taken off the case, by Judge CHRISTENBERRY, and been replaced by a DR. ROBINSON. BROSHEARS later found out that STONE had been transferred to the Veterans Administration Hospital in Casa Verde. After he had been transferred to the Gulfport Psychiatric Hospital, a DR. CLARK, who was in charge of REV. BROSHEARS, said to Secret Service agents after reviewing his case, "We're not jailors. We are discharging you." (to BROSHEARS) Agents repeatedly questioned BROSHEARS as to whether or not he was acquainted with DAVID FERRIE in New Orleans, and BROSHEARS denied this acquaintance.

We asked BROSHEARS if he had ever known or heard the name PERRY RUSSO. BROSHEARS told us that DAVID had talked about him many times. He had said to BROSHEARS that RUSSO beat him up. FERRIE told him that RUSSO had stolen or taken \$2300 from CLAY SHAW. BROSHEARS could not exactly remember under what circumstances FERRIE told him RUSSO had gotten this

money, but that it had to do with some sort of financial transaction and involved MR. SHAW.

After being questioned at Gulfport Hospital by Secret Service agents, one of the agents returned from Washington, D. C., and told BROSHEARS, "You'll get a compensation pension. You will have to report to us every time you move from one city to another. If you do not do these things, you will be put in a federal jail mental institution. If you do cooperate, you will receive your compensation pension regularly." At that time the agents gave him \$1700 (BROSHEARS believes it was either \$1300 or \$1700), as "back compensation". BROSHEARS was told by the agents never to return to New Orleans, but to go back to his home.

BROSHEARS was given a ticket by the agents to take a Southern Airlines flight from New Orleans to St. Louis to go to his cousin's farm in St. Louis and remain there. He was told to stay out of New Orleans.

BROSHEARS said that he wanted to talk with DR. STONE in Cincinnati. He said that he purchased a Chevrolet and did visit his cousin in Cotaville. He said that he crossed a bridge at New Harmony and the Indiana State Police at that border stopped him. He was questioned by the police and then taken to a small cafe which BROSHEARS called a "truck stop". At that cafe an agent of the Secret Service was waiting. Mr. BROSHEARS could not remember whether this was RUFUS YOUNGBLOOD or agent SHERWOOD. This was in May of 1966.

The Secret Service agent asked BROSHEARS, at the cafe, where he was going. BROSHEARS told him he was going to see DR. STONE in Cincinnati. The agent told him that he had no need to see anybody and should return immediately to his cousin's farm. The agent did ask him, however, if he was going to see DAVID FERRIE in New Orleans, and BROSHEARS denied that.

BROSHEARS then went to the Secret Service office in St. Louis and said that he was going to leave this part of the country and go to California. He told the agents there that he was going to San Francisco. They said that would be all right, and that he should report to a MR. NEWMAN at the Secret Service Bureau in San Francisco.

Once in San Francisco, BROSHEARS said that he didn't report to anyone, but took an apartment in a suburb. The agents found him one week later at 347 Eddy Street. NEWMAN and another agent called HAMMOND told him that he had violated his instructions and that he was going to be put in a hospital if he ever did that again. They also told him to call the federal building twice a week. BROSHEARS followed their instructions.

In explanation of BROSHEARS' background, he told us the following story.

BROSHEARS said that he had been living in 1964 in Bellville, East St. Louis. HOMER RANDOLF, head of the Congress of Racial Equality there, was REV. BROSHEARS' superior in Civil

Rights work. In Bellville, BROSHEARS said, an all white city, the territorial border had been reconstructed so as to keep the Negro section out of the city. BROSHEARS had announced publicly that he was going to stage a sit-in in a restaurant in East St. Louis. This was printed in the East St. Louis Journal and the sit-in was scheduled for November 11th on Veterans Day. Mayor Nichols of that city had BROSHEARS arrested and taken to him. He told BROSHEARS that their city was a "nice German-Dutch heritage town, and we must stop you from making a mistake". Present at that meeting were the Justice of the Peace and the Chief of Police. BROSHEARS was told not to stage the sit-in.

On November 10th, the morning before the sit-in was scheduled, BROSHEARS was again arrested, taken into custody, and he was threatened by the Chief of Police that he would be put in prison. He said that he had not broken any law, but the police stated that they were aware of laws that he had broken. On November 11th, REV. BROSHEARS staged the sit-in that he had planned. At 7:30 a.m., on November 12th, BROSHEARS was arrested and taken to the Chief of Police. He was charged with the sexual molestation of a young boy. BROSHEARS phoned his superior, MR. RANDOLF, and RANDOLF told him not to say anything or sign anything. RANDOLF said that he would get hold of an attorney who was a friend of his named ROY COHN, and would be back in touch with him. BROSHEARS was charged with sexual molestation of a boy 17 years old named WILLIAM GORGEIOUS. BROSHEARS said that this boy had come to the door of his apartment on November 8th. The boy had asked him to help him with religious and sexual problems which he said he had. REV. BROSHEARS stated that he had talked with the boy, but had never touched him in any way. BROSHEARS said that the charge had been filed, and according to the records was recorded at 10:30 a.m. on the 10th of November which was before his arrest, and before the sit-in which he staged on the 11th. BROSHEARS said that the Chief of Police said, "Boy, we are your friends, and we are going to make it easy on you. Sign this paper and you'll get 2 days in jail and then we'll let you go." A half an hour later they brought him a statement to sign. It was a statement of admission to the charges. BROSHEARS signed that paper without having been re-contacted by MR. RANDOLF or the attorney. BROSHEARS said that he had originally refused to sign the paper until the policemen who were speaking to him brought in a copy of a newspaper which had the headline "Bellville Minister Arrested-Sexual Perversion Charged". BROSHEARS became hysterical and signed all of the papers which the officers requested. Fifteen minutes later Mr. RANDOLF came with MR. COHN. Both said that they knew that he had been forced to sign the paper, but that nothing could be done at that time. BROSHEARS was in MINARD State Penitentiary for the following six months. BROSHEARS said that after he was discharged, he went to New Orleans and worked at a carnival under the name RAYMOND ALLEN. At the carnival he was known as "CORKY". BROSHEARS said that he could not find any other employment as a result of his prior arrest and incarceration. BROSHEARS said that he then went to work for an organization called "Deacons For The Defense of Justice" in Bogalouza, Louisiana.

When we asked REV. BROSHEARS if he felt that DAVID FERRIE worked for "Deacons for Defense and Justice".

As a result of his appearance on the Los Angeles television program on the 8th of July, 1968, BROSHEARS was visited by Secret Service Agent TOM HORN. BROSHEARS was told that he would lose his pension if he appeared on another such television program. BROSHEARS was threatened by Agent HORN, and was told that he would "end up in Alameda Bay" if he did not keep his mouth shut. BROSHEARS said that he was in constant touch with Agent JOE CONLIN from the Federal Bureau of Investigation Office in Long Beach. He also said that he was in touch with a LT. JOHN COWAN of the Long Beach Police Department and also SGT. CHARLES USERY of that police department. SGT. USERY, according to BROSHEARS, has knowledge about the murder of a reporter which took place in the Long Beach Police Department. → The reporter's name was BILL HUNTER from Dallas, Texas.

Two Long Beach Police Department intelligence detectives have also befriended BROSHEARS for the purpose, he believes, of keeping an eye on him. These are GARY COVIN and JOHN OWEN.

When we asked if REV. BROSHEARS knew a DR. THOMAS BECKHAM, BROSHEARS stated that he did indeed know DR. BECKHAM, that he had corresponded with DR. BECKHAM, and produced a photograph of BECKHAM in which he was shown as an entertainer. The personal management office of BECKHAM was listed under the name of FRED LEE CRISMAN.

Other information which BROSHEARS gave us in response to several questions was:

- A) BROSHEARS had been extremely upset because Agent RUFUS YOUNGBLOOD of the Secret Service Office had told him in the last week of March, 1966, that DAVID FERRIE was dead. This was before BROSHEARS left Gulfport Hospital. YOUNGBLOOD had told him that DAVID FERRIE had committed suicide, and that therefore it would not be necessary for BROSHEARS to ever try and find FERRIE again.

It was not until ~~MY/LATE/AAA/1/11/1968/BROSHEARS~~ just prior to our meeting on Wednesday, July 23, 1968, that BROSHEARS had learned of FERRIE's death in January of 1967. BROSHEARS said that he had obviously been told falsely that FERRIE had died by Agent YOUNGBLOOD.

- B) BROSHEARS said that DAVID FERRIE had friends and family in Cincinnati, Ohio.
- C) We explained that Garrison's investigation had not begun until November of 1966, and that therefore the men who had represented themselves as being from the District Attorney's Office in 1965 had represented themselves falsely. BROSHEARS said, "These weren't Garrison's men in DAVID's hotel room." BROSHEARS asked us if we knew the name ROBERT DUVALL (spelling unsure). He said DAVID flew him to one of the Central American countries, and was sexually intimate with him.



- E) DAVID FERRIE told BROSHEARS that LEE HARVEY OSWALD had been a bi-sexual. BROSHEARS had seen an identification bracelet with the name LEE on it, and also a grey or beige hunter's hat which was in possession of DAVID FERRIE.
- F) FERRIE had told BROSHEARS that Officer TIPPIT was sent to murder LEE HARVEY OSWALD because LEE HARVEY OSWALD had infiltrated a "cell" for the FBI. FERRIE told BROSHEARS that OSWALD had gone to Russia in connection with work for the FBI. FERRIE also told BROSHEARS that the Central Intelligence Agency and the FBI hated each other and worked against each other.
- G) FERRIE told BROSHEARS that three people worked in the Texas School Book Depository, and composed the "cell" which had been infiltrated by LEE HARVEY OSWALD. BROSHEARS said that one of their names was BOB, but that he knew not the last name. FERRIE had told BROSHEARS that JACK RUBY was also involved with these people who worked in the TSBD. It was BOB, according to FERRIE, that was supposed to kill OSWALD in the Book Depository.
- H) FERRIE told BROSHEARS that he had met JACK RUBY in New Orleans.
- I) REV. BROSHEARS gave Mark Lane a letter (see attached) which requests that Mark Lane visit and consult with him in the event that he is ever arrested or taken into custody, or placed in an institution.



On August 2, 1968, I conducted a re-interview with REV. RAYMOND BROSHEARS. He told me that he had been informed by a reporter named MURRY, who works with the Long Beach Police Department, that intelligence officers had given information to the local newspaper, The Long Beach Press Telegram, and that a forthcoming unfavorable article would be written about him. MURRY told BROSHEARS this article would appear probably Sunday, August 11th. I told BROSHEARS that I would write an article for the Los Angeles Free Press which would appear on Thursday, August 8th, which would explain the possibility of an article in the Long Beach Press Telegram, and therefore cancel any disparaging effect which the article might have on his reputation. (See attached article)

I showed a photograph of the man possibly known as RALPH SHLATTER or "SKINNY RALPH" to REV. BROSHEARS. He said that he was not sure, but he felt that he might have met this man in New Orleans in one of the "gay bars". BROSHEARS said that he felt that if this was the man, he was going by the name of "RED" and was operating as a "hustler" in the gay or homosexual underground.

SHAW:

I showed BROSHEARS the photograph of CLAY SHAW. He recognized him immediately stating that he had known this man in New Orleans, and had met him in the company of DAVID FERRIE in late August or early September of 1965. BROSHEARS said that he was with DAVID FERRIE when he met CLAY SHAW. He said that FERRIE introduce SHAW as either "CLARA" or on another occasion, "BURT", or "CLAY".

BROSHEARS said that the first time he met this man (CLAY SHAW) was in a bar called "Dixie's". At that time he said the man was dressed in sport clothes, but later changed into a coat and tie and the three of them went in a cab from Dixie's to a restaurant which he said he would be able to locate in New Orleans, but that he could not remember the name of the restaurant at this time. BROSHEARS said that the first meeting at Dixie's had taken place because FERRIE had told him he had to go there to get some money.

After FERRIE introduced BROSHEARS to "CLARA" or "BURT", he told him that BROSHEARS had been in Civil Rights work up North. SHAW said at that time, "Oh, a Commie." BROSHEARS and FERRIE both denied that. FERRIE said that he would like to go to a restaurant with the man who BROSHEARS has now identified as SHAW, and invited BROSHEARS to come with them.

During the ride in the taxi cab, SHAW told BROSHEARS that he liked "little boys", and BROSHEARS told him, "Go find one." At this time, BROSHEARS said SHAW patted him on the rear. BROSHEARS sternly rebuked this action, and told SHAW not to repeat it. Later, at the restaurant, SHAW did repeat the gesture and was slapped by BROSHEARS. This took place at the dinner table.

The second meeting between BROSHEARS and SHAW took place at a small sidewalk cafe, the tables outside on the sidewalk, somewhere on Bourbon Street. BROSHEARS said he would be able to locate this restaurant in person as he would the other one. DAVID told him, "I have got to meet your 'blank bandit.'" DAVID FERRIE had just returned from taking the St. Charles streetcar to get some money. They both went to the restaurant where SHAW drove up in a chauffeured black car. BROSHEARS could not remember whether the car was a Cadillac or a Lincoln Continental. FERRIE said to BROSHEARS, "You remember CLAY." SHAW then apologized for his actions on the previous meeting. He said to BROSHEARS, "I had a couple of drinks, and I'm sorry."

SHAW:

The third meeting between BROSHEARS and SHAW took place when BROSHEARS went to wait on a street corner with DAVID FERRIE somewhere on a street known as Dauphine (BROSHEARS was not sure about this name, but that it began with the letter "D"). At that time, SHAW drove up and handed DAVID FERRIE a large envelope. SHAW informed FERRIE that BROSHEARS was in trouble because of what he had been saying about President Johnson. He told FERRIE of the danger of BROSHEARS being arrested by the FBI. FERRIE said to BROSHEARS, "A lot of people have threatened the life of President Johnson, but you are in trouble with the government. You threatened the life of the President. Why don't you come with me? I'm flying South and we can stay there together." BROSHEARS said that he could not go with him, and FERRIE took some money out of the bulky envelope and gave it to him. SHAW had already driven off.

FERRIE and BROSHEARS went to "LaFitte's In Exile" until 11:00 p.m. when DAVID FERRIE left. The next day two men came to the owner of the hotel where BROSHEARS was staying. BROSHEARS was later told by the owner that, "Two men were here looking for you."

BROSHEARS state that SHAW had referred to himself as a "butch queen".

I further questioned BROSHEARS on some of the information which had been related to him by DAVID FERRIE concerning the actual shooting of President Kennedy on November 22, 1963. BROSHEARS said that OSWALD had not shot the President, but that

according to DAVID FERRIE, it had been two assassins who were behind the fence. One of the assassins, according to DAVID FERRIE, was named CARLOS. FERRIE also told BROSHEARS about a boy named "BILL" who worked in the Book Depository. BROSHEARS felt that this might have been one of the assassins who fired at the President from the rear.

FERRIE had told BROSHEARS that H. L. HUNT of Dallas, Texas, had entertained HALE BOGGS after the Warren Commission Hearings. FERRIE had pointed out a connection between H. L. HUNT and HALE BOGGS previously. FERRIE had had a deep hatred for HALE BOGGS, and had linked HALE BOGGS with CLAY SHAW. FERRIE had told BROSHEARS that SHAW had some ownership in Dallas and had met HUNT through his financial dealings, possibly with Hunt Foods, or possibly through the Trade Mart in Dallas.

BROSHEARS said that DAVID FERRIE had a "beautiful machete", a Barrett Italian pistol, in addition to the possessions of LEE HARVEY OSWALD.

BROSHEARS stated that he did not know GORDON NOVEL, and could not remember that name, but requested that he see a picture of the man.

Once again asking BROSHEAR about "RALPH" (the walking man photo), BROSHEARS said that he might have been the man who chauffeured CLAY SHAW's car in 1965. He said that a man had hustled him and taken \$10 from him at his hotel. BROSHEARS said that he would have met this man, if this were indeed the person, at either one of the two bars previously mentioned.

BROSHEARS said that he met a man named "KERRY" and from a picture he identified KERRY THORNLEY at the bar called Dixie's. FERRIE had commented on the similarity of appearance between THORNLEY and LEE HARVEY OSWALD, but had told BROSHEARS that the similarity stopped with the appearance.

BROSHEARS stated that he did know FRED LEE CHRISMAN of Oregon because he was the representative of the "Universal Life Church" in that Northwest area. (SEE SUBSEQUENT MEMO ON CHRISMAN AND THIS CHURCH)

Ex-roomate reveals

FERRIE CONCESSSED HIS INVOLVEMENT  
IN JOHN KENNEDY ASSASSINATION PLOT

1 August 5, 1968 Los Angeles,

4 The first public disclosure of a confession by  
5 any of the participants in the conspiracy which led to the  
6 Dallas assassination of President Kennedy was revealed in  
7 surprising fashion recently on the Stan Bohrman, Tempo I,  
8 television show in Los Angeles. An ex-roomate of the late  
9 David Ferrie appeared on the program as a last minute guest.  
10 The roomate, Reverend Raymond Broshears of Long Beach, was  
11 asked to replace a guest who had been scheduled to discuss  
12 psychic phenomena and predictions of the future.

13 After introductory comments were made, the program,  
14 which is in the format of receiving questions from outside  
15 telephone callers, became one of significant historical im-  
16 portance. In response to one of the callers questions the  
17 Reverend told of his association with the late David Ferrie  
18 of New Orleans.

19 Ferrie was named by District Attorney Jim Garrison  
20 of New Orleans as one of the participants in the conspiracy  
21 which ended in the murder of President Kennedy. Garrison said  
22 of Ferrie, "He was one of history's most important individuals."

23 The caller questioned Reverend Broshears and much  
24 to the shock of host Stan Bohrman, Broshears answered the  
25 questions frankly. When asked if Ferrie told him of the assass-  
26 ination conspiracy the his former roomate replied, "David ad-  
27 mitted being involved with the assassins. There's no question  
28 about that."

29 Reverend Broshears, who has tried to escape harrass-  
30 ment by "individuals from mysterious sources" ever since his  
31 short association with Ferrie in 1965, told of the role which  
32 Ferrie had played in the plot. "He was in Houston at the time

1 Mr. Garrison has him in Houston, with an airplane waiting,"  
2 reported Broshears. The Reverend said that Ferrie had intended  
3 to fly the assassins on the second leg of a getaway trip which  
4 was to carry them, on at least two of the gunmen, first to  
5 South America and then to South Africa. The location in Africa  
6 was chosen as a final destination because that country has no  
7 extradition agreement with the United States. Ferrie was wait-  
8 ing, in the Houston airport, that Friday afternoon, when the  
9 two assassins, having just murdered President Kennedy, fled  
10 in a light aircraft from a landing strip just outside of Dallas.  
11 Instead of going straight to Houston as was arranged, the  
12 assassins tried to make their escape all the way to Mexico  
13 without stopping. According to Reverend Broshears the assassins  
14 died in a plane crash that afternoon off the coast of Corpus  
15 Christi, Texas.

16 Broshears said that Ferrie had been a nervous wreck  
17 in the days of their acquaintanship. This was over a year  
18 before the public disclosure of the investigation of Jim  
19 Garrison and, according to a recent article in Ramparts Maga-  
20 zine by William W. Turner, Garrison hadn't even begun his  
21 probe, <sup>SECRET</sup> secretly, until the later half of 1966. Broshears told  
22 of Ferrie's fears that someone was going to kill him. "No  
23 matter what happens I will never commit suicide," Ferrie  
24 had told the Reverend. "He was emphatic about this" Broshears  
25 reiterated.

26 Broshears said that he knew David Ferrie had been  
27 murdered and thus confirmed another portion of Garrison's  
28 analysis of the evidence since his probe began.

29 More questions in the assassination matter are added  
30 by the case of David Ferrie. Aside from his mysterious death,  
31 the strange activities of Ferrie on November 22, 1963 had  
32 led Garrison to arrest him for questioning when Ferrie returned

Broshears

1 from his trip to Houston. After the District Attorney's office  
2 questioned Perrie they referred him to the Federal Bureau of  
3 Investigation for further questioning and examination by the  
4 Warren Commission. As in most instances the Warren Commission  
5 never questioned Perrie, who, it is evident, might have shed  
6 considerable light on the true events of the assassination.

7 Compounding the federal negligence is the fact that  
8 the F.B.I. did question Perrie and the forty page transcrip-  
9 tion of that interview has been committed to the National  
10 Archives for the duration of 75 years from the issuance of  
11 the Warren Report.

12 Reverend Broshears was asked <sup>by the caller</sup> if he was ever arrested  
13 for threatening the life of President Lyndon Johnson. Most  
14 reluctantly he replied that he had. <sup>But</sup> But he qualified the  
15 implication saying that it was for the love of his country  
16 that such an incident transpired. He did not actually threaten  
17 President Johnson, and he explained that he does not believe  
18 in killing. "What then," Bohrman puzzled, "did you say?"

19 At the risk of being re-arrested for repeating a state-  
20 ment that had caused Secret Service agents to take the Reverend  
21 into custody two years ago, Broshears stated, "I said that Mr.  
22 Johnson, the person who was responsible, directly or indirectly  
23 for the assassination of President Kennedy, should be put to  
24 death!"

25 With the energy of ten men, and the breath of a parakee  
26 Bohrman activated his lips to form the words, "We'll be right  
27 back after this word from Arid Extra Dry."

28 But the shock which characterizes most of the assassin-  
29 ation revelations did not stop there. Broshears admissions,  
30 however courageous or honest, have meant nothing but total  
31 torture and harrassment for him ever since the television pro-  
32 gram.



1            Since the time of his arrest by Federal Agents in  
2 New Orleans for the incident of his alleged threat on Pres-  
3 ident Johnson (after which he was questioned and released  
4 without conviction or sentence) he has had to be in constant  
5 touch with Federal offices of the Secret Service and F.B.I.  
6 by order of the Federal Government. Agents from those organ-  
7 izations have warned him to "keep his mouth shut" or risk being  
8 committed to a mental institution.

9            After the television program, Broshears was served by  
10 his landlady, Mrs. Norma L. Smith, with a seven-day- limit  
11 eviction notice. Phonecalls from anonymous sources told him,  
12 "How many presidents did you kill today, Reverend?" And two  
13 reporters from the Sunday supplement of the Long Beach Press  
14 Telegram Newspaper, have planned an article for this Sunday's  
15 edition which will reveal that Reverend Broshears is a homo-  
16 sexual. A friend of the Reverend's on the Long Beach Police  
17 Force confided that the article would not be favorable to him  
18 at all. Broshears realizes that the price of breaking his  
19 silence on the case could certainly bring damaging comments  
20 about him and possibly endanger his life. Ironically Broshears  
21 never tried to hide the fact that he is a homosexual. He answer-  
22 ed, "I am a homosexual but I have never denied it." Homosexual-  
23 ity is often used as a source of smear material but that is  
24 usually in the case of a person who would be damaged by that  
25 public revelation. Broshears only fault or sin seems to be his  
26 persistent honesty.

27            Apparently, freedom of speech is something which Bro-  
28 shears has always taken as a cause to defend. When an attack  
29 was waged by a Reverend John C. Bonner, of the Long Beach-  
30 Lakewood Area, to try and halt the sale of the Los Angeles  
31 Free Press, in March of 1968, Broshears replied to the aggressor  
32 in a modest but outspoken newspaper published by Reverend

1 Broshears, called "The Light of Understanding," Broshears  
2 replied to Reverend Bonner's limited acceptance of journalistic  
3 freedom. "In the Bible it states that if you raise your  
4 children rightly, you need not fear," he wrote. Where the  
5 Reverend Bonner had requested that the representatives of  
6 some 47 area churches "stand up and be counted," Broshears  
7 answered, "Stand up and be counted as what? A person who  
8 opposes freedom of the press?" The result of this small  
9 but noble defense Reverend Broshears was expelled from the  
10 ministerial alliance of his district.

11 Another Los Angeles broadcaster, Eliot Mintz of KPFK,  
12 invited Reverend Broshears on his show. Responding to his  
13 tremendous audience interest in the events surrounding the  
14 murder of President Kennedy, Mintz questioned Broshears on  
15 his association with Ferrie. After callers quizzed the Reverend  
16 there was not enough time allowed to the Reverend to discuss  
17 his Night Ministry school which is his occupation in Long  
18 Beach. Although the program closed without the discussion of  
19 some of the Reverend's work in the Community Relations field  
20 (finding help for "skid row" bums, improving conditions in the  
21 ghettos) the oversight of time promised the Reverend <sup>shall</sup> ~~and~~ be  
22 corrected by the show's host. Mintz told me, "If Mr. Broshears  
23 would like to come on our show to discuss his work, and his  
24 Night Ministry school and not to discuss his association with  
25 David Ferrie, he has a standing invitation from me to do that."

26 It is impossible to estimate the truth or falsehood  
27 of the Reverend's statements about the assassination. It is  
28 certain that in his association with Ferrie he had the unique  
29 opportunity to learn what Ferrie might have told the New Orleans  
30 Grand Jury had he lived. In the case of the assassination of  
31 President Kennedy it seems apparent that those with important  
32 knowledge, who speak out, risk death. <sup>In the current issue of...</sup> Reverend Broshears, explains  
this puzzle, in a different way. He says, "the price of silence  
is death."

J. Now, the Universal Life Church was formed in 1960 as an association. Who formed the church?

B. The church at that time was formed by a DR. KIRBY J. HENSLEY, formerly from the State of North Carolina. He is an illiterate in this respect, he cannot read, nor can he write.

J. The Universal Life Church was incorporated on the 2nd of May, 1962. Can you say where?

B. It was incorporated in Modesto. It was incorporated as The Church of God under the Universal Life Church of Modesto, Incorporated. DR. HENSLEY drew up the papers, took them up to - or his wife drew them up due to his illiteracy. He fooled you quite well, but he does know his Bible by heart. That's through learning it from his parents. . . . But he took these papers, typed up very crudely on ordinary stationery, went to Sacramento and bullied his way, and pleaded and cajoled his way through Sacramento, and this is entirely unheard of because I've talked with many corporate lawyers in the State of California, and they cannot understand how he was granted a corporate charter; how he was granted articles of incorporation when you have to do it on a legal form. But yet he did it and I have a photostatic copy of his articles of incorporation which are done up that way. And to me it is quite appalling because there are strikeovers marked out and I know the Corporate Board of the State of California did not allow this because they have turned down many of my applications for corporation on legal paper because it was not spaced property. And yet DR. HENSLEY put in something that was absolutely atrocious. This I've always thought a bit weird.

J. Now, you said it spread to 8,000 members; 3,800 outside of the United States.

B. I did not say members.

J. Ministers?

B. No. You said members. I said ministers.

J. Okay.

B. I said ministers last night. There are now 8,000 ministers, affiliate membership numbers somewhere near 100,000 now.

J. Where are the branches of the church outside of the U. S.? You mentioned there were 14 foreign countries.

B. In Europe there is England, Sweden, Italy in particular. I have a list of all of the ones in Italy, and then Uganda in the Continent of Africa, and several of the new emerging African nations the people have been named Bishops and like this for their ego purposes, and they're growing quite large. In fact the head of - the Bishop of the Uganda Church is the Defense Minister there of Uganda, I think that is very interesting.

J. What's his name?

B. I can't pronounce any of those black names. You forget it. I've got it at home.

J. Will you send it back? Send us. . .

B. I'll send it to Mr. Alcock, yes.

J. Now do you know, for example, you just stated that the Defense Minister of Uganda is the head of the Universal Life Church there.

B. 10,000 members in his church in Uganda. He won't have it for long. It's more of a political party than anything religious.

J. Can you say another country where possibly a Defense Minister or another member of the government is known to you would be involved?

B. I think you're projecting a bit because I don't know these people's positions. I know the Mayor of a town in the Country of Guatemala is the head of the Universal Life Church in his city, but he is not the head of the church in Guatemala. DR. HENSLEY is the head of the church in Guatemala.

J. DR. HENSLEY of Modesto?

B. Yes. He is the head of the church in Guatemala.

J. Does he go to Guatemala to take part in it?

B. No, he's never been there. He just - all through correspondence. There are several ministers in Guatemala, Honduras - British Honduras, Costa Rica, Nicaragua; one of the Samosa brothers, I don't know whichever one that is still alive, he wrote for our papers. He has been granted ministers and bishops papers with the Universal Life Church. Now, how he heard of it I do not know, and I understand that Samosa

is a very good conservative Roman Catholic, and it has puzzled me why he wanted bishop's papers to the Universal Life Church. But this is not for me to wonder, as DR. HENSLEY says, it's none of my business. I have gone through DR. HENSLEY's files quite extensively. DR. CARL McINTIRE has papers with the Universal Life Church.

J. What kind of papers?

B. Ordination papers. Bishop's papers. As does HERBERT W. ARMSTRONG of Pasadena, who publishes the Plain Truth Magazine and the International Broadcasts is most extensive to all the English speaking nations in the world, called "The World Tomorrow" under TED ARMSTRONG. And of course they of the "I cannot fathom why the Samosa brothers would want ordination papers. There is only one left that I know of, of the Samosa brothers. I don't know too much about them. But this is typical of DR. HENSLEY's operations. He says, "I will give ordination papers to anybody who writes me. All they have to do is write me in care of the Universal Life Church, 1766 Poland Road, Modesto, California 95351, and I will send them ordination." And he said he does not care who they are, or what they are, or what they're going to preach. They can preach hate - anything they want to preach because they only have to answer to the God within. This is DR. HENSLEY's basis for giving out all of these ordinations that he gives out. HENSLEY has operations in 14 different countries, and I do not know the extent. The Italian one seems to be fairly great. The one in Sweden alarms me. As a person, it's my own personal observation. But he does have operations in Sweden. Several ministers over there. I do know two recent deserters from the United States Armed Forces - what branch I do not know - have written for ordination, and they have been granted by KIRBY HENSLEY. Of course, KIRBY HENSLEY is known for his helping of draft dodgers by granting them ordinations. But of course not all the Draft Boards are granting for the Divinity Classification because they have done this. I feel very strongly that I'm - excuse me - keep my feelings out of it. Numerous intelligence men in the Long Beach Police Force have ordination papers with Universal Life Church, as L.A.P.D.S.O. - Sheriff's Office - intelligence. Also FBI, Long Beach, and I know the FBI office in numerous places have ordination papers with the Universal Life Church. Now, these papers - they can get them under any name they want. They can use an alias because they don't have to furnish any proof that it is their name, so many people are using these for many devious purposes. Of this, I am sure. Now these papers, I want to reiterate, are perfectly legal and valid papers; and people are using these to impersonate ministers, and some are really using them for legitimate purposes. People who do not have the college education are using them. One of the things I wanted to point out with the San Francisco office of the FBI is Agent known to me as MANNING has a Universal Life Ordination. This is one FBI man outside of JOE CONLON at the Long

Beach office who has bishop's papers. There are a MR. NEWMAN of the United States Secret Service has ordination papers, but under another name. He told me that he wrote for them - that he wrote for them under another name. Also, all of the FBI men in the San Jose Office have ordination papers, but under other names. This I feel that I am responsible for. It's my fault to a very great degree, and I'm not going to apologize for it. But the country Canada is one that I really overlooked to men as an important part of the Universal Life Church. Now this is tied in with TOM BECKHAM and some "kook" in Ontario. I've got the name and address of the man who BECKHAM recently visited in Ontario in connection with his particular church, the Holy Orthodox Christian Churches which he made me a bishop of. Holy! Holy! Holy! Ha, ha. But, BECKHAM's organization is not a valid organization in the State of California so any papers that he sends me subsequently mean nothing as far as my own activities in the State of California. BECKHAM and HENSLEY have never met as of three months ago. Now BECKHAM is out on the West Coast at this moment selling ordinations and various peoples are trying to trace him down and locate BECKHAM. BECKHAM brags it seems now of his association with DAVID FERRIE, but yet he cannot spell FERRIE's name right. This appalls me. He spells FERRIE's name F E R R Y, and he said that he is not a homosexuality - humm - person - he can't even use proper English, but, I'm not so great myself. But anyhow BECKHAM had a great tie with FERRIE. This is how BECKHAM got into the Ministry was through FERRIE here in the City of New Orleans. As I related to Mr. Garrison last night, FERRIE got into the Ministry of the Old Catholic Church through this "kook" JAMES up in Canada somewhere. That's what FERRIE claims. But I have conflicting reports on that from MICHAEL ITKIN who it seems that Mr. Garrison knows. MICHAEL ITKIN is a cardinal, or bishop, or pope, anything you want to name. He's it. And he had currently been stirring up trouble in the San Francisco-Hate Ashbury, and in the Berkely area Telegraph. ITKIN has his own corporate body called the HOLY EVANGELICAL CATHOLIC COMMUNION BROTHERHOOD OF LOVE, and they - ITKIN was exposed for myself in the City of San Francisco but it did no good because now it seems that ITKIN is getting from mysterious sources and is able to print these documents and papers and is growing quite fast and quite large. HENSLEY got into the so-called 'draft dodging' or helping the anti-drafters through myself quite innocently - maybe. Or maybe I got into it quite innocently. I can't figure out just what. But some young men wanted to be student ministers in my church in San Francisco, which was called the Universal Church of Light which was located at 465 Garic, Studio B. It's a music studio. MADAM ROSALIE ZARGA (Zaga?) is the Manaer. Reverand ANGELINA MILLER and REVERAND GERTA MAYS who are both listed. REV. GERTA MAYS is listed in the directories. REV. ANGELINA MILLER is not, but she is listed in our magazine. Her private telephone number is listed in

The Light of Understanding. These people were all on my staff of the church in San Francisco. Young men - hippies - started coming to me asking to be student ministers. I later learned, for their only purpose, for being ministers was to escape the draft. When I so learned, I spoke to them rather harshly, and it ended their association with me but by this time they had already gone to Modesto, KIRBY HENSLEY gave them ordination papers, and this was the beginning of KIRBY HENSLEY's anti-draft work which has been publicized in the New York Times extensively which led to a CBS telecast by MR. TERRY DRINKWATER. And this was on CBS evening news Walter Cronkite; CBS late night news local Los Angeles; and CBS morning news with Douglas the next morning. Anyhow, HENSLEY - this is how he got into, or maybe the anti-draft movement. HENSLEY is not - of course he does not profess to be anti-draft. But I do think it is strange, because after this I personally contacted the Attorney General of the State of California, MR. TOM LYNCH, and MR. FRANK JORDAN the Secretary of State who has control over such matters as the corporate bodies existing in their State. MR. LYNCH and MR. JORDAN both told me that DR. KIRBY HENSLEY they can find nothing wrong with his operations even though I had pointed out the CBS telecast, the New York Times disclosures, and the disclosures over the wire services - Associated Press and United Press International. And yet these men, State elected officials, appointed officials - MR. JORDAN - most of his people. MR. JORDAN is elected. Excuse me. He's elected every year. He has been in so long I thought he was appointed. He's been in about 30 years. But anyhow, these gentlemen told me that they can find nothing wrong with KIRBY HENSLEY's operations and they said - wanted to question me why I was coming to them to ask them to close him down when I used to be a part of DR. HENSLEY's operation, and I told them that DR. HENSLEY used to be an honorable, honest man, but now he has gone into what I feel - things that are detrimental to the security of the country of the United States. I have seen other people prosecuted and sent to prison for doing the things far minor against the draft than what KIRBY HENSLEY has said on coast-to-coast TV, and is currently doing. He now has 8,000 ministers. Of these 8,000 I would have to say very, very truthfully, because I know this to be a fact, that over 3,00 of them are draft-dodgers. And I want to say, of the 3,000 draft-dodgers, that approximately 1,800 have received 4-D Divinity classifications from their Draft Boards. And I want to point out to you that when they receive a 4-D classification, they cannot be drafted, nor can their classification be changed, my understanding of the Selective Service laws in the State of California. DR. KIRBY HENSLEY's organization is incorporated in 27 other states. This is something I neglected to mention earlier. 27 other states. The last being the State of Nevada. The latest

I should say. He plans to have it incorporated in every single State of the Union. Where he is getting the money for this is really beyond me. Where KIRBY HENSLEY is getting the money all along is beyond me, because he has never - I want to repeat - he has never advertised in any publication, major or minor, with the exception of our magazine, The Light of Understanding, and KIRBY HENSLEY's advertisement in there just says merely "Universal Life Church", Modesto, California, and gives the address, but it does not say "Get an Ordination", or "Buy and Ordination", or anything. But I want to point out that DR. HENSLEY does not sell his ordinations. He gives them to you free. Scott free. He does not sell them. So, I want to emphasize this over and over, and I would appreciate Mr. Ivon and everyone in this - I would appreciate everyone in this particular office writing to DR. HENSLEY under assumed names with post office boxes preferably, maybe General Delivery or just anyone else's address, and write for ministerial papers just to see how this does work, and sure enough an ordination paper will arrive for them. I do not know his procedure on handing out the bishop's papers now. Usually - I can't really say how he hands out the bishop's papers. I was pointing out earlier about the bishop of Uganda, HENSLEY is on the board of TOM BECKHAM's American Academy of Professional Arts, as is FRED LEE CHRISMAN of Tacoma, Washington, and vice versa in all the other organizations. MICHAEL ITKIN, who heads up the Evangelical Catholic Communion, which I talked about earlier for a moment, have extensive information on ITKIN's bullshit which I will send to the New Orleans office on this particular portion because I did not know that ITKIN had been in New Orleans, and had been the great source of trouble that he had been in this City. MORELAND BALLARD of Baltimore is the man who is supposedly - I want to point this out - supposedly ordained DAVID FERRIE. Now, I have no way of checking - I do have ways of checking this out, but I would have to have permission from Mr. Garrison or one of his Mr. Alcock, the two men who are involved in the litigation of this particular investigation because I would not want to embarrass them by going to San Francisco and talking with the various people up there in the Evangelical Communion and ask them about this because ITKIN has never - I want to point out - ITKIN has never met FERRIE. ITKIN has met TOM BECKHAM, and of course ITKIN has met BALLARD. I have spoken with BALLARD long distance on the telephone from San Jose when I was helping the FBI with the investigation of the Students for Democratic Society in San Jose, but let me add that the investigation in San Jose was not of my doing. That was the suggestion of certain people in the federal government that I assisted because I had many young people who were attending San Jose State College who were involved in SDS, and I did my dirty deed. I'm not going to try and justify it, and I'm not

going to say I'm ashamed of it because at the time I did it - that's it. But anyhow, I'm starving to death right now. When I talked to BALLARD IN Baltimore, BALLARD said that he knew nothing of ITKIN except that ITKIN came through Baltimore; ITKIN was a hypocritical egotistical little bastard who wanted to connect up with the Old Catholic Church of which BALLARD claimed he was the Metropolitan Bishop. I have seen papers to this effect that say that BALLARD is the Metropolitan Bishop of it. But BALLARD said that he was - I did not ask BALLARD anything about New Orleans or anything of this nature. But as far as ITKIN in New Orleans, I know nothing - I knew nothing until last night that ITKIN had ever been to this particular area. I know ITKIN has a fantastic hatred. ITKIN is a homosexual - a rather flagrant homosexual, wanton. But ITKIN has never mentioned even being to this City. ITKIN is much younger than myself. I am 33. ITKIN, I would say, is closer to 27, maybe 28. He could be older, but I doubt very seriously. I'm sure Mr. Garrison knows. The Twentieth Century Reformation Church is McINTIRE's organization. They're associated with the BILLY JAMES HARGIS anti-Communist crusade, this Christian crusade that is throughout the South - the Bible Belt in which he rakes in the shekels from the "little lambs". And McINTIRE is also associated with FRED SCHWARTZ in the City of Long Beach where I reside, and his anti-Communist Christian Crusade. FRED SCHWARTZ is about as anti-Communist as Fidel Castro. I have been asked questions by Mr. Jaffe concerning EDGAR EUGENE BRADLEY.

EDGAR EUGENE BRADLEY as all well know, had purchased a bus ticket and said that he was en route and arrived, and knew nothing of the assassination of President Kennedy until he arrived in El Paso. As anyone knows, that particular route of the bus, BRADLEY - and any bus of the Greyhound or Trailways, you may get off any any designated stop, any place you want, and re-join another bus coming through later on, and no one knows the difference. And this is what allegedly happened with BRADLEY in the City of Dallas. I, myself, have done this on bus trips, and so I know it can be done. So BRADLEY's story there does not hold water because there is no one on the bus, if anyone who has travelled cross-country as BRADLEY claims he was doing, if you travel cross-country with people and you do not get off a bus, people remember you regardless. I mean you strike up acquaintanceship, and I don't care if you are the most introverted person, this is the part of BRADLEY's story which proves conclusively to me that this man - of course this is my own personal opinion - this man is lying in this particular case. Of course, DAVID FERRIE had mentioned him casually, but I do want to point out this part about BRADLEY that there are pictures that I have looked at here that are quite shocking to me. I see a man which I knew as RED STOWE with EDGAR EUGENE BRADLEY. I thought

at first the pictures were of Parish Prison, but they are not of Parish Prison they are Dealey Plaza, and this is RED STOWE a "punk", "hustler", "alcoholic", a roll-them-over beat-em-up, anything he can do. He is in the pictures with the man alleged to be BRADLEY. Now this man in the picture BRADLEY says is not himself. The Dallas Police Force says it is not BRADLEY. But, the striking similarity - the similarity is too great for it not to be BRADLEY. It has to be. I cannot be anyone else but BRADLEY, because this is how BRADLEY looks when he is carousing. People who - in Los Angeles at the moment who have seen BRADLEY, and I have seen BRADLEY, it looked like BRADLEY because I have seen BRADLEY recently in a carousing mood in - out on the Strip, and this was BRADLEY in the - Hollywood by Farmer's Market. I had seen him out near - he had on a sport shirt, tousled - his hair was tousled, much like the picture that I now see that is Dealey Plaza. It looked like him. It looked nothing like the pictures that are in the courtroom there. Of course at the time I did not know that was EDGAR EUGENE BRADLEY except the face was horribly familiar. And of course he's been on - his pictures have been on TV and in the newspapers quite a bit in California, and - but I did not associate that particular man at that time with the pictures that I'd seen on television, because all the pictures there had been of a man very neatly dressed, hair combed right down to a speck. But this, the pictures here of the man at Dealey Plaza are EDGAR EUGENE BRADLEY that I have seen in some of his carousing moments.

FERRIE was mentioning the Voice of Americanism by the anti-Communist Christian Crusade, BILLY JAMES HARGIS' crusade, and also McINTIRE. The Voice of Americanism, I want to point out, comes from Pasadena, California, and plays a very important role. BRADLEY was allegedly going from McINTIRE's to the Voice of Americanism, which is headed up by - Jaffe remembers the story. It is in The Free Press, the name of this man who BRADLEY has a great deal of association with. The Voice of Americanism from Pasadena, California, a religious broadcast? The story was supposedly showing atrocities by the Vietcong, when in reality I, myself, recognize the picture right off, and had screamed to the radio station, KGR in Long Beach, that that picture was taken as a still from the movie "The Sand Pebbles", and this is the picture used by the gentleman, CLYDE McBURNIE is his name. Now it is coming to me. CLYDE McBURNIE is his name, and he and EDGAR EUGENE BRADLEY, McINTIRE and HARGIS and SCHWARTZ, they're all in the same particular bag. They all know one another. Whether they admit it or not this is absolute fact because I'm the Pasadena police if they were in a cooperative mood could tell you if they put out surveillance, they would see the cars of SCHWARTZ in Pasadena at McBURNIE's house. And this also goes to GARNER TED ARMSTRONG at the "Plain Truth" Magazine, the World Tomorrow broadcast coming from Pasadena. I think it's quite interesting

that a great deal of the radical right-wing activities religious-wise come out of Pasadena and Long Beach.

In connection, when FERRIE had said CARLOS was to fly to Houston, this is where BRADLEY's name came up. BRADLEY was not one of the two people, but I said, "How many were there?", and he said there was more than two. I said, "Who is the other one?", and he said the other one involved a guy by the name - some kind of nut by the name of BRADLEY. He says one of these religious fanatics. Now he did not use the name EDGAR EUGENE BRADLEY. He said "BRADLEY". When he used the word "BRADLEY", I mentioned - I asked him what he was referring to, and he said BRADLEY was a minister. And this is how I learned that DAVID FERRIE was a "priest". A Catholic Priest. BRADLEY was a minister with McINTIRE's organization. He has papers with numerous of these radical right ministerial groups. BRADLEY is an ordained minister. He does not profess to be to anyone. He's is just EUGENE BRADLEY who works for McINTIRE and his group in New Jersey. I want to point out one thing which I have not pointed out to anyone before, McINTIRE is associated very loosely, but is associated with a person who knows BRADLEY in New Brunswick, New Jersey, and this man's name is TIMOTHY BECKLEY. TIMOTHY BECKLEY is a UFO-ologist - flying saucers to you all. But BECKLEY knows something of BRADLEY because in a Newsletter sent out not too long ago by BECKLEY's UFO group there in New Brunswick, I have the full title of BECKLEY's - it's on Courtland Place - have the full address and all in Long Beach, and here, now, it seemed insignificant at that time, but he inserted a little article sticking up for EDGAR EUGENE BRADLEY and saying that he had nothing to do with the assassination of President Kennedy. I thought it was quite curious - it was quite curious to me that he even inserted this in the UFO magazine, there was no need for. That's my personal opinion. But this makes me wonder about BECKLEY and his association with McINTIRE. They're both in the State of New Jersey and just a short distance from one another. BECKLEY, by the way, has minister's papers with the Universal Life Church. The Universal Life Church is an incorporated body in the State of Texas. There are numerous Universal Life ministers, and I could not even begin to go into right now all the names of that I know of, If I can get on KIRBY HENSLEY's good side again, and could go through the records in Modesto again it would be of great help. But right now I'm on KIRBY's bad side. Yes, there are ministers in Dallas. There are ministers in Dallas and Fort Worth and Arlington. The Sky Ministry is in Arlington. That is the Universal Life Church minister who conducts what he calls a Sky Ministry. He drops leaflets. According to him, he drops leaflets. Religious leaflets. And he is a Sky Pilot minister in Arlington. He has a Fort Worth post office box. Angel Wing, Texas is another portion of the Universal

Life Church down there which he claims that he raises money for an Angel Wing orphanage in Angel Wing, Texas. There is no such address as "Angel Wing" - a town as Angel Wing that I have been able to discover. I do have an address for the Angel Wing Ranch. I have been asked if I had the name of The Church of the Abundant Light. This is a very familiar name to me in connection with MICHAEL ITKIN. This is one of the churches in his ecumenical movement. I have been asked concerning whether I tried to leak out some information under the guise of a seance in the - ah - there was no seance, but I wrote it in the Light of Understanding and this was one way, I felt, of trying to leak certain things out to the public. But I will say this, the response from the spiritualist people in the country has been one million per cent overwhelming and they all accept what has been given there in that article as gospel truth. Which it is - gospel truth - as the way I have learned it from ah. . .

FERRIE referred to RUBY, he never used the word "RUBY" once - he referred to JACK as "a fat clown from Dallas; and he's a faggot, and he likes to eat pussy", which is not unusual in the homosexual underworld. A lot of them like to get it in the rear, while eating the pussy. Shocking Mr. Garrison? Lovely. Yes, this is one thing I believe very strongly - well this is something he was very emphatic upon. In fact, this is one of his more serious moments when he was high. Now, as I said before, I cannot swear up and down that it was liquor because I don't think one or two beers puts anybody stoned. But he did take a great amount of pills because he was a fantastically nervous person. But as I stated many times before, he was an intelligent person and a brain attract more than a physical body. But anyhow his - he mentioned TIPPIT - OFFICER TIPPIT. Now, he mentioned TIPPIT and OSWALD and RUBY as being in the same "cell". Now, I'm sure this was not a jail, and the only things that's been used as cells in America, the term "cells" has been applied to Communist groups. Now RUBY, according - "FAT JACK the clown", had been referred to by RUBY - by, excuse me, I've got Ruby on the brain - by FERRIE as not having any love for Kennedy, so this is why this later display of killing OSWALD was so phoney to FERRIE himself. And he said that TIPPIT did not - that TIPPIT was a part of the cell as OSWALD. OSWALD did not shoot President Kennedy; that OSWALD ran out and as he did BOB threatened to shoot him. Now BOB works at the Book Depository as did - all told, there were three of them who worked at the Book Depository and who were in the same cell, and I believe OSWALD was infiltrating this cell for the Federal Bureau of Investigation as this was what was intimated more than once by DAVE, that OSWALD was working for the FBI. In fact, I don't think he kept stressing that point a little too much to where I have more or less sluffed it off. But, now that I am getting a better picture of it, I can see where this is a great - of great importance

FERRIE:

because Mr. Hoover has a phobia and a passion about the Communists and so this would fit in with his plans the more that you dwell on the subject. But he did say that he was in a "cell" with them, and he said that - now I learned about the all points bulletin recently from Mr. Lane and Steve Jaffee being sent out, and it was sent uh - TIPPIT uh could not have possibly realistically received the bulletin yet met OSWALD at this theater. How did OFFICER TIPPIT know that OSWALD was going to the theater. This is the one thing that FERRIE pointed out. Well, this was what I was pointing out. OSWALD had been in the theater, though. This is what I was pointing out. OSWALD had been into the motion picture theater. This is what FERRIE said. He had been in the motion picture theater to hide, and he became paranoid in the dark, and as, I guess, anyone would in this particular situation. The people are telling me now - I don't know about what Garrison has here, and I do not know what the Warren Commission Report says, but, DAVID said that there was one person - TIPPIT - in the squad car. But now, since the visit of Mark Lane, I related this to LT. COWAN - Lt. JOHN COWAN and LT. COWAN says that's wrong, that FRED COLE told him that there were two men in the car; that Dallas at that time did not have two men in cars, and there were not two men in that car, there was only one man OFFICER TIPPIT, and it is standard procedure in the City of Dallas Police Department, according to LT. COWAN, that no one single officer on an all points bulletin like that approaches what is considered to be an armed and dangerous person alone. So this shoots the TIPPIT story all to hell as far as police science, and as far as LT. COWAN is concerned. He said that this is the only thing that makes him wonder.

JAFFE: Who shot TIPPIT?

Steve Jaffee has asked me who shot TIPPIT. FERRIE said OSWALD shot and killed TIPPIT, and if I was in OSWALD's shoes, I would have shot and killed TIPPIT. The other patrol car arrived just shortly after the killing of TIPPIT from fear, because he knew TIPPIT was going to kill him. He knew TIPPIT.

J. Did FERRIE know TIPPIT?

He just asked if FERRIE knew TIPPIT. I can't say. FERRIE said he knew a Dallas policeman. That may not have been TIPPIT. They've got umteen thousand men on that force. FERRIE talked about GEN. WALKER to - he was pointing out how powerful MR. SHAW was and H. LAMAR HUNT. He kept trying to tie them together, but of course Mr. Garrison last night pooh-poohed that. He said that DAVID had more intelligence than that. Or course, Mr. Garrison knew DAVID better than I, I guess. So, Mr. Garrison's right I guess, but I - but this is what he stated. That ah - he said to show you the power, he says the FBI tried to put WALKER away in the criminally insane hospital - federal hospital, Springfield, Missouri, and they were completely unsuccessful because

LAMAR HUNT got him out. It was all HUNT's money and it's still HUNT's money that is pushing WALKER around the country. He said WALKER had a fantastic hatred for JOHN F. KENNEDY. I don't think this fact is unknown to anyone. I think it's a well-known fact that he felt that Mr. Kennedy was a Communist, or a "Pinky". He stated so in various speeches. FERRIE claimed that SHAW was in touch with all the radical right groups; that SHAW wanted to preserve the Anglo-Saxon Protestant White area and race, and that included his doing away with all black people. I had to mention that because DAVID didn't.

J. Had DAVID mentioned planning with OSWALD concerning the assassination?

B. DAVID never said anything about planning with OSWALD concerning the assassination. He only had this sexual thing with OSWALD as far as I know. Of course, I am sure there was far more to it than that from what I am now viewing. But the only one that he had discussed that he was contracted through blackmail that the 16 year old boy - the sexual thing which SHAW allegedly has the pictures, or the film - DAVID did reiterate that it was a film, and that he had been shown pictures, and been given pictures. But this is how he was contracted to fly to - on down to Honduras and to Panama and then on over into Cape Town. DAVID did not receive his orders from SHAW to go to the airport. DAVID received his orders from going out on the St. Charles streetcar and I'm sure that you people here in New Orleans know what is out - if the agency has a man out on St. Charles Street in a fine home out there, because they had always described it as "a fine home", "gracious home". DAVID also said that he picked up a lot of his things at his detective agency at which he was a private investigator, which I do not believe still to this day despite what Mr. Garrison has said. I appreciate Mr. Garrison, but anyone who has met DAVID FERRIE cannot even begin to believe him as a private detective. BANISTER is the name that he mentioned most prominently over there and and a person named NOVEL. NOVEL, yes. NOVEL can fly, he's not an angel, but he can fly. Something to the effect about flying. But, I thought the name was more MOREL but it is NOVEL. He never said BANISTER told him where to go. He just went to what I now know as 544 Camp. 544 Camp, and this is where he received some of his brown envelopes similar to the brown envelope I saw that BERT, as he called him, handed him that evening in the long blue or bluish-black, could be black, at night under New Orleans street lights it could have been blue. It could have been black, Cadillac. He asked me if we talked about CHRISMAN, I said we have talked about CHRISMAN. I mentioned CHRISMAN's association with the various churches, but I did not go into it in detail, no.

FERRIE & MONEY:

CHRISMAN:

F. LEE CHRISMAN has been with the Universal Life Church since about 1964, I understand from DR. HENSLEY. CHRISMAN contacted KIRBY HENSLEY. BECKHAM contacted KIRBY HENSLEY. Numerous of these people involve here

had contacted KIRBY HENSLEY. KIRBY HENSLEY contacted no one. As I said, he did no advertising until The Light of Understanding, and that is only recently. BISHOP F. LEE CHRISMAN of Tacoma, Washington, he has a post office box. The exact address for CHRISMAN, if Mr. Garrison does not have it, I will be more than happy to send to Mr. Garrison.

CHRISMAN:

CHRISMAN, anyhow, seems to be quite a will-o-the-wisp. CHRISMAN contact all of the, shall we say, little religious organizations anywhere, including my own. He is located in Tacoma, Washington. F. LEE CHRISMAN is a homosexual, first, last and always. In this respect he likes to have fun. He has one - he has a permanent lover. He has a permanent lover in Tacoma. The name of the man I do not know. The man has been to Modesto, and Sister HENSLEY did not like him. Of course, SISTER HENSLEY does not like homosexuals period. She doesn't know I am, until - I'm sure she does now with that Free Press article. CHRISMAN does - he does not - now branches of the Universal Life Churches was - Jaffee asked me about "branches - there is no such thing as a "branch". Each church is independent and completely, - they are completely autonomous, so there is no branch, so that he must contact each individual church. He cannot do it through Modesto because Modesto will not - supposedly will not help anyone. They have helped me on occasion, I will say this. But CHRISMAN seems to be come involved in most all other things. He is also a member of DR. FRED SCHWARTZ's anti-Communist Christian Crusade, I would like to point out because I happen to have seen his name on the mailing list down by FRED SCHWARTZ's place at 137 E. First Street in Long Beach. I went in there one day and I don't think I'm welcome there any more. I was asked how do I think CHRISMAN receives his money. Well, I'm sure he doesn't make it as being a prostitute sexually because he's not that - he's not desirable in any way shape or form to my way of thinking, and he has to pay for what he gets. And so CHRISMAN - his source of money is indeed mysterious, except that he is hooked up with such groups as The Circle of Loving Companion and the other religious organizations that I have mentioned. While he has his own thing to save the American Indians, and I learned last night from Mr. Garrison he's getting a Poverty Program grant, trying to for the Gypsies.

I have not mentioned The Circle of Loving Companions because I was meditating more after I left last night - the meeting with Mr. Garrison - on The Circle of Loving Companions, and the address is on Washington Boulevard. I said 2205½, but the more I think about it, it is 2255½ Washington Blvd., but the exact address is not important at this moment. I will have that address to Mr. Garrison, and there are several bull dykes there and several male homosexuals also. And this group

CHRISMAN:

CHRISMAN is also associated with, and they seek to raise money. In fact, I had mentioned a bit that CHRISMAN was - now I want to point - CHRISMAN was involved with DICK GREGORY. I have - I have really failed to mention this. It is in this issue of the Light of Understanding. I did not put CHRISMAN's name, nor did I put GREGORY's name in it concerning the Pallioupe and the Nesquall Indians of the State of Washington where Governor Evans is with the commercial fishing industries taking away their fishing rights. And these tribes live on the river. They've always lived off of the fishing that they have received, and now this has been taken away from them. DICK GREGORY went up there recently, and was there with CHRISMAN demonstrating, trying to help these people. A girl by the name of CLOUD is involved in this to an extent, and she is a friend of F. LEE CHRISMAN. She is also a minister with the Universal Life Church. DICK GREGORY was up there. DICK GREGORY was subsequently sentenced to jail, served considerable amount of days in which he fasted, supposedly, in a county jail in the State of Washington. But this is a recent thing where CHRISMAN was involved in something with another type of a group which is DICK GREGORY. I'm sure GREGORY didn't know CHRISMAN from anything. GREGORY is tied up with the Peace and Freedom Party. CHRISMAN has no tie-up with the Peace and Freedom Party. I have checked this out very closely because I, at one time, tried to seize control of the Peace and Freedom Party in Southern California. I admit this quite freely. Because I felt that it would be a good vehicle because I have been just a little bit more than disturbed at Mr. Johnson. But, the Peace and Freedom Party has taken a radical course which I cannot participate in.

Steve Jaffee just asked me about DAVID FERRIE and The Universal Life Church. There was no mention from DAVID FERRIE of the Universal Life Church. No mention whatsoever. I have not checked the records recently, but I have been told that there was a young man involved in the Kennedy assassination. Now, the word "young" was used, and so this may put aside DAVID FERRIE; but a young man involved in the Kennedy assassination in New Orleans has papers with the Universal Life Church. This could be also my dear little friend MR. MARTENS. This was told to me by MR. HENSLEY's little 14 year old daughter who you can get most anything out of if you know how to get around her, yes. She's just an innocent little girl. She doesn't really know anything. The whole HENSLEY family is quite naive with the exception of SISTER HENSLEY, and this is why such an organization - Mr. Garrison put this into my mind last night - I can see how such an organization can be taken over and used. Now, I want to point out a very interesting person DOUGLAS - whose name is DOUGLAS. LLOYD DOUGLAS. He has a church and lives at 1731 North Lake Street in the City of Pasadena. Here we go



"Pasadena" again. DOUGLAS is the Vice-President of the Universal Life Church. He has sent HENSLEY considerable - well into the hundreds - of dollars, within the past, well this was prior to my coming down here, within six months he'd sent him several hundred dollars of thanking him for his wonderful things and praising him, and then DR. HENSLEY - an opening came for the Vice Presidency and ah which was vacated by MR. MAYALL - REV. MAYALL of Bakersfield who is the Chairman - who is now the head of GEORGE WALLACE'S American Independent Party in the State of California, I'd like to point out. He was the Vice President of the Universal Life Church. I have seen pictures of him in space suits. Don't ask me why. He's in space suits. But anyhow, - I was asked if EDGAR EUGENE BRADLEY is tied in with GOVERNOR GEORGE WALLACE'S group. I cannot say because I do not know. Except that I do know that BILLY JAMES HARGIS is backing the candidacy of GOVERNOR WALLACE as CAR - Cardinal McIntire. We got a cardinal in Los Angeles called McIntire and I keep on calling him Cardinal McIntire. DR. MCINTIRE in New Jersey. DR. MCINTIRE has come out very strongly in favor of GEORGE C. WALLACE. A recent broadcast I heard this on. KGER in Long Beach. Religious radio station. I wanted to point that out that there was considerable funds by a dance put on in the City of Seattle. Some of the "rock bands" - is that what they call them? - some of the "rock bands" up there for DICK GREGORY and all of them, there was funds raised for that and it was sponsored by a religious group. I have not been able to find what religious group, but I am sure if it was sponsored by any religious group in the State of Washington, it was F. LEE CHRISMAN because he was involved in the demonstrations for the Pallioupe and Nesquali Indians, and this all happened just a month and a half ago.

Mr. Jaffee has asked me about the ten millionth time how DAVID FERRIE felt about his part in the assassination of President Kennedy. DAVID FERRIE, from what he would tell me maybe out of conscience or what, or out of fear, but all he would say to me is that he was paid and he had to do what he was doing, and then he went back to that film with the 16 year old boy. If this film or the 16 year old boy could be found, I think this would be the key to breaking the whole thing. In fact, I would like to find out who the 16 year old boy is. I have been asked earlier by Mr. Jaffee if Mr. BANISTER gave him his orders, or OSWALD. Or you did not ask me if BANISTER -- about the meeting..

FERRIE:

He never specified exactly any meetings or anything of that nature. Most everything took place at the - where he discussed the assassination - his part. Now he did not feel that he was assassinating the President. I want to emphasize this, because he really didn't

feel that he was assassinating the President. And I don't know what Mr. Garrison has him indicted for. I have not seen the indictment, I would love to see it, but, well I have been told that he was indicted for conspiracy to assassinate the President of the United States. But FERRIE did not feel that he was conspiring to assassinate the President of the United States, but they took place at the mysterious dwelling wherever it is out on St. Charles Street, and I have since asked a bellhop where I'm staying here in the City of Orleans, and they told me that all the homes out on St. Charles are very, very palatial type places and they are very old, and they are very lovely, and they are owned by fine people. The lawyer that was supposed to defend me - KOHN - I had mentioned to him about KOHN who was to come to defend me in my particular episode up in Bellville, Illinois when I was in a Civil Rights demonstration up there. Now KOHN is not the same KOHN that Mr. Jaffee just mentioned. He said ROY KOHN. This is a ROY KOHN but I'm sure it is not the same KOHN because I have met this KOHN and he is what they call the stereotype Jewish person, and totally unlike the person if Mr. Jaffee is referring to the people in the Army-McCarthy hearings. This is not the person, no. This is not the person because - but this person is related to that person. That I do know because he discussed this particular facet. I do not know why anyone was so interested in getting me off of that. They probably could have gotten me off of it, but I feel that I did the better thing, just serve my particular little sentence and got out. Well, Steve wanted me to mention some of the things - little things, or maybe big things, it's debatable. Let Mr. Garrison decide that. I've told Mr. Jaffee, Stephen out at my place in Long Beach, that DAVID had one great fault and that was his love for young boys. Mr. Garrison said last night he did not feel that it was necessarily sexual. Well, a person with his brain, I do not feel that it would necessarily be sexual, and it would be more or less a thing because DAVID had great empathy for people, and he did want to help people like he wanted to help me. I was in a particularly bad situation when I arrived in this City and he did his very best to help me. He gave me money there at the end when he was preparing to fly down to Guatemala on that trip which he had asked me to go with him so I could escape the FBI, which he said BERT said was looking for me. Of course, I do not - there is no record. No one has any way of knowing that the FBI was really looking for me or not I don't believe. I would like to know. The FBI claimed they were not. Yes. Yes. Right there at the car. I was standing on the corner. He asked if I saw BERT tell DAVE that the FBI was looking for me. I'd better get out of town. Now Bert wanted me to get out of town. I was just another noisome little faggot that he didn't want around probably. That was

more of it than anything else, and he was afraid that DAVID might have said something to me. Now, I do recall very, very plainly in the second meeting where I saw SHAW with DAVID where he stated, "Have you told him anything?" David said, "No. I'm keeping my word. I don't say nothing to him. I don't tell my "tricks" anything." I was not DAVID's "trick". He asked me about LAYTON MARTENS.

LAYTON MARTENS, I saw him the first time with DAVID FERRIE and CLAY SHAW was sitting there at the same time. This was at Dixie's, which is no longer in existence. I later saw LAYTON MARTENS several times around the Quarter, and I had - later on I propositioned LAYTON MARTENS. I will end it right there because I don't want to commit myself.

Steve has asked me what gave me the impression MARTINIS, as they're calling him, I know him as MARTY and MART, what gave me the impression that he was occupied with CLAY SHAW, rather than DAVID FERRIE. But I want to point out that Dixie's at that time was an older crowd than what I found the other evening up at LaFitte's in Exile. The LaFitte's in Exile crowd was the same type at that time, now it's nothing but a bunch of young kids. And the people were considerably more reserved, but LAYTON MARTENS appeared to know Mr. SHAW quite well as they talked, and then MARTENS would go around talking to others, and MARTENS to my way of thinking, at that time did not look like he could be over 18, maybe 19 at the very, very most. Just a little boy. He had that little boy look. I still, to this day, I do not even know his age. I have never been informed of his age, but he was extremely well-built, put it that way. And I feel - I mean he talked to DAVID and then he talked to SHAW, and then when we later left, DAVID and myself and SHAW and the young man that DAVID had purchased which I have identified today in the photos, I identified him today in the photos of BLACKMOOR, known to me at that time as BLACKIE. This is the young man whom DAVID referred to that he had - that was his gift. That was who he had bought, and I assumed that he had purchased him for the night. No, the gift DAVID had bought was BLACKMOOR. (A little bit of French in here that I can't spell, but translated: Do you understand? Prostitution?) This Jaffee is quite naive or something, but he knows nothing about the underground or else he would know that when you buy yourself someone, that means that you have purchased that person's services for the evening. For the night, or for a period of time, and so this meant that he and BLACKMOOR were going to have a sexual thing. That's what the gift in that particular case meant. I mean, when you're holding onto something, and said here is the gift I bought, that is the gift Baby. Excuse me Mr. Garrison. I didn't mean to use endearing terms. Apologize to your wife too.

BECKHAM:

I want to point out one thing that Stephen just brought up. FERRIE and BECKHAM. Now, I cannot give the exact date of FERRIE and BECKHAM. Now Mr. Sciambra stated that BECKHAM's a f-----g liar? Well whatever it is. But that's fine and well, and I know BECKHAM to be a liar. That's for damn sure, but I don't know what he was referring to. But BECKHAM is a homosexual, and BECKHAM - I wanted to finish this part here on BECKHAM. BECKHAM, when it came out in the paper that he had been subposnaed by Mr. Garrison, to me as far as I knew THOMAS BECKHAM was a good person. BECKHAM claimed to be the son-in-law of Senator ALLEN ELLENDER of Louisiana, but this is the same TOM whom DAVE had mentioned. I'm positive now, because this was the TOM whom he had ordained as a priest in the Old Catholic Church. And now BECKHAM ordains people for \$30 of course. A donation? It's illegal to sell them, but it's a donation, a love offering. And this is the same BECKHAM, and this had to be. I would say this had to be no later than '64 because BECKHAM was not here when I was here in '65, and I asked BECKHAM on the telephone if he had been in New Orleans after I had been to New Orleans and he said only to talk to Mr. Garrison. And this is because I was planning on writing an expose article on BECKHAM as being a phoney minister, a phoney everything by selling phoney doctorates. The doctorates are legal, unfortunately, as the ordinations, but I mean as far as anything backing him up, anyone can buy them. And I was going to write this in order to expose him to stop him from running for Congress from Omaha, the district there around Omaha where Mr. Martin a very respected Republican member of the Congress has been in office for many years. And, of course, I later found out from the Chief of Police of Omaha that BECKHAM's a pile of shit as far as political or anything else in Omaha. BECKHAM had been under observation for taking little girls back over to Council Bluffs, Iowa, and boys. But the boys BECKHAM was not having any sexual thing because BECKHAM is a man, according to BECKHAM. BECKHAM takes the aggressor's role and he - as I have learned, BECKHAM only does it for money. He's a man. HUM.

RED STOWE? I have been asked about RED STOWE. RED STOWE is known to me. Mr. Ivon gave me several books to look through this morning of photos. The one book, I don't know if it was on purpose or accidental, he gave it to me and start here. I don't know if he exactly said start here, but it later developed that that was the back of the book and the index with the names to the pictures, any how, had put the book in that particular position. (I had to stop for a moment) And when I turned to the picture I thought it was a picture of RED STOWE with EDGAR EUGENE BRADLEY in prison. Possibly Parish Prison here. And then I turned over the next page and then I saw a sign, and they were outside in another picture, and I saw the sign

"Highway 80", and then I knew that it was not - they were not in Parish Prison. And so then I finally found - there was an index and that I had started at the back of the book and I saw that it was not, according to them, EDGAR EUGENE BRADLEY nor was it RED STOWE. But I disagree with whoever has made the identifications on that because it definitely is RED. I mean, who knows better than the person that has known him intimately? And that is RED. I don't know where he is now. I met him here in New Orleans and God only knows where he is now. But of course RED - the type of person he is, he would sell his mother in order to a slave owner in order to make money, so, I mean, anything that he is possibly involved in would not surprise me. The other man is definitely EDGAR EUGENE BRADLEY because I've seen BRADLEY in that particular condition. Dallas P.D., I understand from Jaffee, says it is not EDGAR EUGENE BRADLEY, but Jaffee has not told me who it is then and this does bother me that they refuse to - when I ask them who the picture is when I identify it - to my knowledge, the way I know the people they refuse to give me any answers. This is the whole thing concerning Jaffee which is beginning to bug me. I feel that after I make an identification then they should tell me something at least. But I am still positive that picture is EDGAR EUGENE BRADLEY I know it is RED STOWE. RED STOWE was here - I first met him here in the City of New Orleans. Today I want to point out, I finally went to what is known - is now known as the Dixie Hotel. It could possibly have been known as the Dixie Hotel in 1965 on Tulane. It's katywampus down the street and directly across from Charity Hospital. Now Mr. Ivon seems to think it was rather amazing that I could not remember the Charity Hospital was across the street. Well, Charity Hospital may be very big in Mr. Ivon's mind and the citizens of New Orleans, but I am not a resident of New Orleans. It's just another building to me and so at that particular I wasn't interested in landmarks, hospitals or anything else, All I was interested in was hiding and having fun. And the lady who owned it I refer to as a "fat lady". She was not exceptionally fat, but she was much larger than the bitch who now runs it. Pardon me. Is that slander? No, bitch is a dog. She could be doggie. But anyhow, the woman who now runs it is her daughter who said she was there all that time in '65. I spoke to her this morning; had a very difficult time getting to talk to her. She wanted to know this, that and the other, and in a word, she had her hand out for the almighty dollar and I did this the other evening to the other people at the Center Hotel and the restaurants and the bars and everything directly across from Continental. The one lady said that I did look familiar, but she said that was three years ago and there had been so many people come and go into her particular hotel. This woman says, "Well, I don't remember you. But I know all of Mama's guests." Well, she's a liar because

she is an obvious prostitute. Of course, I may be slandering myself - or slandering her, open to suit but I don't give a damn. I'm letting the cards fall where they may because we can probably get the witnesses to prove that she is a whore or prostitute. But the woman is elderly herself. Her mother, of course, was much older. She said her mother killed by a German Shephard. This confirms a story that I had heard later concerning the death of her mother. Her mother was extremely distrustful person. She had a small black dog as I remember when I lived there. The rooms are exactly as I described them to others. It's still a gray building. It was a gray building then. There is that horrible, atrocious yellow picture of Huey Long hanging on the wall. You go down the hallway and I had not entered into the hotel and I said to her, I says, "Is the bath at the end of the hall on the right?" She confirmed this, and I asked her about the rooms, "Are they small?" and she said, "Yes, they are small", and then I pretty well described the hotel before I went on into it. There is kind of an alcove ante-way to go into it. The woman is nasty. I do remember her as being the daughter of the owner of the hotel. I mean, one couldn't forget a bitch like that. And at that time she was whoring around, if I - I don't remember her that well, but I do remember that she was whoring around. She looks much different now than she looked then. She was much more painted and she is now - today she looked like a plain, grey-haired - more salt and pepper hair. And she is elderly. She is in her 50's I would say now, and she is still plying the trade to the best of her ability probably. A man for a room for the night. Of course I'm doing this speculation, but that is the hotel - the Center Hotel - I remember it quite well because at that time there were a great deal of homosexuals and hustlers, and it was a good place to find what you wanted. I want to point out before this tape runs out, and while Mr. Jaffee and Mr. Alcock are not in here - I don't mind saying it to Mr. Alcock - but I do want to say this, that the - I am a great deal disappointed that the Dixie's is now gone because I was led to believe that Dixie's was still here. There is a Dixie's here but it is not the Dixie's that was here in 1965. Where Dixie's was at in 1965 is now taken over by some place called the Dream House or the Dream Room or something or other. Maybe it's not even that, but it's just down the street. LaFitte's in Exile is still here. It is much dirtier and they've done nothing to it. It was very, very crowded the other night when I was there. I was looking for LAYTON MARTENS, That was the reason I went out. I did not let Jaffee or any of the people of the District Attorney's Office know because I wanted to find MARTENS. I wanted him to see me. I wanted him to see if he remembered me. He is like a machine sexually, and he probably would not remember me. But when you are a person of my nature you certainly remember somebody as cold as that, and he operates like a machine and it's on a money basis.

Now, I would be interested in meeting him again. Of course, I do not have the money to really meet him for another encounter, but I think it would be interesting in the interest of justice if I could get next to him and maybe learn a lot more, because LAYTON MARTENS, I understand, is being defended by some of the wealthiest, or some of the biggest attorneys in the City of New Orleans. Yet LAYTON MARTENS still does not have a pot to piss in and to me this only - well it's only - to me I don't give a damn, but it should show Mr. Garrison and the others that CLAY SHAW - the connection with CLAY SHAW. But, that CLAY SHAW is paying MARTENS' lawyers bills. But time will tell. And now, I'm sure it will tell on the side of Mr. Garrison, and I'm beginning to take more and more stock in the Garrison case. I'm just - I'm absolutely positive that he has... (end of tape.)

J. Now, the Universal Life Church was formed in 1960 as an association. Who formed the church?

B. The church at that time was formed by a DR. KIRBY J. HENSLEY, formerly from the State of North Carolina. He is an illiterate, in this respect, he cannot read, nor can he write.

J. The Universal Life Church was incorporated on the 2nd of May, 1962. Can you say where?

B. It was incorporated in Modesto. It was incorporated as The Church of God under the Universal Life Church of Modesto, Incorporated. DR. HENSLEY drew up the papers, took them up to - or his wife drew them up due to his illiteracy. He fooled you quite well, but he does know his Bible by heart. That's through learning it from his parents. . . . But he took these papers, typed up very crudely on ordinary stationary, went to Sacramento and bullied his way, and pleaded and cajoled his way through Sacramento, and this is entirely unheard of because I've talked with many corporate lawyers in the State of California, and they cannot understand how he was granted a corporate charter; how he was granted articles of incorporation when you have to do it on a legal form. But yet he did it and I have a photostatic copy of his articles of incorporation which are done up that way. And to me it is quite appalling because there are strikeovers marked out and I know the Corporate Board of the State of California did not allow this because they have turned down many of my applications for corporation on legal paper because it was not spaced property. And yet DR. HENSLEY put in something that was absolutely atrocious. This I've always thought a bit weird.

J. Now, you said it spread to 8,000 members; 3,800 outside of the United States.

B. I did not say members.

J. Ministers?

B. No. You said members. I said ministers.



- J. Okay.
- B. I said ministers last night. There are now 8,000 ministers, affiliate membership numbers somewhere near 100,000 now.
- J. Where are the branches of the church outside of the U. S.? You mentioned there were 14 foreign countries.
- B. In Europe there is England, Sweden, Italy in particular. I have a list of all of the ones in Italy, and then Uganda in the Continent of Africa, and several of the new emerging African nations the people have been named Bishops and like this for their ego purposes, and they're growing quite large. In fact the head of - the Bishop of the Uganda Church is the Defense Minister there of Uganda, I think that is very interesting.
- J. What's his name?
- B. I can't pronounce any of those black names. You forget it. I've got it at home.
- J. Will you send it back? Send us. . .
- B. I'll send it to Mr. Alcock, yes.
- J. Now do you know, for example, you just stated that the Defense Minister of Uganda is the head of the Universal Life Church there.
- B. 10,000 members in his church in Uganda. He won't have it for long. It's more of a political party than anything religious.
- J. Can you say another country where possibly a Defense Minister or another member of the government is known to you would be involved?
- B. I think you're projecting a bit because I don't know these people's positions. I know the Mayor of a town in the Country of Guatemala is the head of the Universal Life Church in his city, but he is not the head of the church in Guatemala. DR. HENSLEY is the head of the church in Guatemala.
- J. DR. HENSLEY of Modesto?
- B. Yes. He is the head of the church in Guatemala.
- J. Does he go to Guatemala to take part in it?
- B. No, he's never been there. He just - all through correspondence. There are several ministers in Guatemala, Honduras - British Honduras, Costa Rica, Nicaragua; one of the Samosa brothers, I don't know whichever one that is still alive, he wrote for our papers. He has been granted ministers and bishops papers with the Universal Life Church. Now, how he heard of it I do not know, and I understand that Samosa

is a very good conservative Roman Catholic, and it has puzzled me why he wanted bishop's papers to the Universal Life Church. But this is not for me to wonder, as DR. HENSLEY says, it's none of my business. I have gone through DR. HENSLEY's files quite extensively. DR. CARL MCINTIRE has papers with the Universal Life Church.

J. What kind of papers?

B. Ordination papers. Bishop's papers. As does HERBERT W. ARMSTRONG of Pasadena, who publishes the Plain Truth Magazine and the International Broadcasts is most extensive to all the English speaking nations in the world, called "The World Tomorrow" under TED ARMSTRONG. And of course they of the "I cannot fathom why the Samosa brothers would want ordination papers. There is only one left that I know of, of the Samosa brothers. I don't know too much about them. But this is typical of DR. HENSLEY's operations. He says, "I will give ordination papers to anybody who writes me. All they have to do is write me in care of the Universal Life Church, 1766 Poland Road, Modesto, California 95351, and I will send them ordination." And he said he does not care who they are, or what they are, or what they're going to preach. They can preach hate - anything they want to preach because they only have to answer to the God within. This is DR. HENSLEY's basis for giving out all of these ordinations that he gives out. HENSLEY has operations in 14 different countries, and I do not know the extent. The Italian one seems to be fairly great. The one in Sweden alarms me. As a person, it's my own personal observation. But he does have operations in Sweden. Several ministers over there. I do know two recent deserters from the United States Armed Forces - what branch I do not know - have written for ordination, and they have been granted by KIRBY HENSLEY. Of course, KIRBY HENSLEY is known for his helping of draft dodgers by granting them ordinations. But of course not all the Draft Boards are granting for the Divinity Classification because they have done this. I feel very strongly that I'm - excuse me - keep my feelings out of it. Numerous intelligence men in the Long Beach Police Force have ordination papers with Universal Life Church, as L.A.P.D.S.O. - Sheriff's Office - intelligence. Also FBI, Long Beach, and I know the FBI office in numerous places have ordination papers with the Universal Life Church. Now, these papers - they can get them under any name they want. They can use an alias because they don't have to furnish any proof that it is their name, so many people are using these for many devious purposes. Of this, I am sure. Now these papers, I want to reiterate, are perfectly legal and valid papers; and people are using these to impersonate ministers, and some are really using them for legitimate purposes. People who do not have the college education are using them. One of the things I wanted to point out with the San Francisco office of the FBI is Agent known to me as MANNING has a Universal Life Ordination. This is one FBI man outside of JOE CONLON at the Long

Beach office who has bishop's papers. There are a MR. NEWMAN of the United States Secret Service has ordination papers, but under another name. He told me that he wrote for them - that he wrote for them under another name. Also, all of the FBI men in the San Jose Office have ordination papers, but under other names. This I feel that I am responsible for. It's my fault to a very great degree, and I'm not going to apologize for it. But the country Canada is one that I really overlooked to men as an important part of the Universal Life Church. Now this is tied in with TOM BECKHAM and some "kook" in Ontario. I've got the name and address of the man who BECKHAM recently visited in Ontario in connection with his particular church, the Holy Orthodox Christian Churches which he made me a bishop of. Holy! Holy! Holy! Ha, ha. But, BECKHAM's organization is not a valid organization in the State of California so any papers that he sends me subsequently mean nothing as far as my own activities in the State of California. BECKHAM and HENSLEY have never met as of three months ago. Now BECKHAM is out on the West Coast at this moment selling ordinations and various peoples are trying to trace him down and locate BECKHAM. BECKHAM brags it seems now of his association with DAVID FERRIE, but yet he cannot spell FERRIE's name right. This appalls me. He spells FERRIE's name F E R R Y, and he said that he is not a homosexuality - humm - person - he can't even use proper English, but , I'm not so great myself. But anyhow BECKHAM had a great tie with FERRIE. This is how BECKHAM got into the Ministry was through FERRIE here in the City of New Orleans. As I related to Mr. Garrison last night, FERRIE got into the Ministry of the Old Catholic Church through this "kook" JAMES up in Canada somewhere. That's what FERRIE claims. But I have conflicting reports on that from MICHAEL ITKIN who it seems that Mr. Garrison knows. MICHAEL ITKIN is a cardinal, or bishop, or pope, anything you want to name. He's it. And he had currently been stirring up trouble in the San Francisco-Hate Ashbury, and in the Berkely area Telegraph. ITKIN has his own corporate body called the HOLY EVANGELICAL CATHOLIC COMMUNION BROTHERHOOD OF LOVE, and they - ITKIN was exposed for myself in the City of San Francisco but it did no good because now it seems that ITKIN is getting from mysterious sources and is able to print these documents and papers and is growing quite fast and quite large. HENSLEY got into the so-called 'draft dodging' or helping the anti-drafters through myself quite innocently - maybe. Or maybe I got into it quite innocently. I can't figure out just what. But some young men wanted to be student ministers in my church in San Francisco, which was called the Universal Church of Light which was located at 465 Garic, Studio B. It's a music studio. MADAM ROSALIE ZARCA (Zaga?) is the Manaer. Reverand ANGELINA MILLER and REVERAND GERTA MAYS who are both listed. REV. GERTA MAYS is listed in the directories. REV. ANGELINA MILLER is not, but she is listed in our magazine. Her private telephone number is listed in

The Light of Understanding. These people were all on my staff of the church in San Francisco. Young men - hippies - started coming to me asking to be student ministers. I later learned, for their only purpose, for being ministers was to escape the draft. When I so learned, I spoke to them rather harshly, and it ended their association with me but by this time they had already gone to Modesto, KIRBY HENSLEY gave them ordination papers, and this was the beginning of KIRBY HENSLEY's anti-draft work which has been publicized in the New York Times extensively which led to a CBS telecast by MR. TERRY DRINKWATER. And this was on CBS evening news Walter Cronkite; CBS late night news local Los Angeles; and CBS morning news with Douglas the next morning. Anyhow, HENSLEY - this is how he got into, or maybe the anti-draft movement. HENSLEY is not - of course he does not profess to be anti-draft. But I do think it is strange, because after this I personally contacted the Attorney General of the State of California, MR. TOM LYNCH, and MR. FRANK JORDAN the Secretary of State who has control over such matters as the corporate bodies existing in their State. MR. LYNCH and MR. JORDAN both told me that DR. KIRBY HENSLEY they can find nothing wrong with his operations even though I had pointed out the CBS telecast, the New York Times disclosures, and the disclosures over the wire services - Associated Press and United Press International. And yet these men, State elected officials, appointed officials - MR. JORDAN - most of his people. MR. JORDAN is elected. Excuse me. He's elected every year. He has been in so long I thought he was appointed. He's been in about 30 years. But anyhow, these gentlemen told me that they can find nothing wrong with KIRBY HENSLEY's operations and they said - wanted to question me why I was coming to them to ask them to close him down when I used to be a part of DR. HENSLEY's operation, and I told them that DR. HENSLEY used to be an honorable, honest man, but now he has gone into what I feel - things that are detrimental to the security of the country of the United States. I have seen other people prosecuted and sent to prison for doing the things far minor against the draft than what KIRBY HENSLEY has said on coast-to-coast TV, and is currently doing. He now has 8,000 ministers. Of these 8,000 I would have to say very, very truthfully, because I know this to be a fact, that over 3,00 of them are draft-dodgers. And I want to say, of the 3,000 draft-dodgers, that approximately 1,800 have received 4-D Divinity classifications from their Draft Boards. And I want to point out to you that when they receive a 4-D classification, they cannot be drafted, nor can their classification be changed, my understanding of the Selective Service laws in the State of California. DR. KIRBY HENSLEY's organization is incorporated in 27 other states. This is something I neglected to mention earlier. 27 other states. The last being the State of Nevada. The latest

I should say. He plans to have it incorporated in every single State of the Union. Where he is getting the money for this is really beyond me. Where KIRBY HENSLEY is getting the money all along is beyond me, because he has never - I want to repeat - he has never advertised in any publication, major or minor, with the exception of our magazine, The Light of Understanding, and KIRBY HENSLEY's advertisement in there just says merely "Universal Life Church", Modesto, California, and gives the address, but it does not say "Get an Ordination", or "Buy and Ordination", or anything. But I want to point out that DR. HENSLEY does not sell his ordinations. He gives them to you free. Scott free. He does not sell them. So, I want to emphasize this over and over, and I would appreciate Mr. Ivon and everyone in this - I would appreciate everyone in this particular office writing to DR. HENSLEY under assumed names with post office boxes preferably, maybe General Delivery or just anyone else's address, and write for ministerial papers just to see how this does work, and sure enough an ordination paper will arrive for them. I do not know his procedure on handing out the bishop's papers now. Usually - I can't really say how he hands out the bishop's papers. I was pointing out earlier about the bishop of Uganda, HENSLEY is on the board of TOM BECKHAM's American Academy of Professional Arts, as is FRED LEE CHRISMAN of Tacoma, Washington, and vice versa in all the other organizations. MICHAEL ITKIN, who heads up the Evangelical Catholic Communion, which I talked about earlier for a moment, have extensive information on ITKIN's bullshit which I will send to the New Orleans office on this particular portion because I did not know that ITKIN had been in New Orleans, and had been the great source of trouble that he had been in this City. MORELAND BALLARD of Baltimore is the man who is supposedly - I want to point this out - supposedly ordained DAVID FERRIE. Now, I have no way of checking - I do have ways of checking this out, but I would have to have permission from Mr. Garrison or one of his Mr. Alcock, the two men who are involved in the litigation of this particular investigation because I would not want to embarrass them by going to San Francisco and talking with the various people up there in the Evangelical Communion and ask them about this because ITKIN has never - I want to point out - ITKIN has never met FERRIE. ITKIN has met TOM BECKHAM, and of course ITKIN has met BALLARD. I have spoken with BALLARD long distance on the telephone from San Jose when I was helping the FBI with the investigation of the Students for Democratic Society in San Jose, but let me add that the investigation in San Jose was not of my doing. That was the suggestion of certain people in the federal government that I assisted because I had many young people who were attending San Jose State College who were involved in SDS, and I did my dirty deed. I'm not going to try and justify it, and I'm not

going to say I'm ashamed of it because at the time I did it - that's it. But anyhow, I'm starving to death right now. When I talked to BALLARD IN Baltimore, BALLARD said that he knew nothing of ITKIN except that ITKIN came through Baltimore; ITKIN was a hypocritical egotistical little bastard who wanted to connect up with the Old Catholic Church of which BALLARD claimed he was the Metropolitan Bishop. I have seen papers to this effect that say that BALLARD is the Metropolitan Bishop of it. But BALLARD said that he was - I did not ask BALLARD anything about New Orleans or anything of this nature. But as far as ITKIN in New Orleans, I know nothing - I knew nothing until last night that ITKIN had ever been to this particular area. I know ITKIN has a fantastic hatred. ITKIN is a homosexual - a rather flagrant homosexual, wanton. But ITKIN has never mentioned even being to this City. ITKIN is much younger than myself. I am 33. ITKIN, I would say, is closer to 27, maybe 28. He could be older, but I doubt very seriously. I'm sure Mr. Garrison knows. the Twentieth Century Reformation Church is McINTIRE's organization. They're associated with the BILLY JAMES HARGIS anti-Communist crusade, this Christian crusade that is throughout the South - the Bible Belt in which he rakes in the shekels from the "little lambs", And McINTIRE is also associated with FRED SCHWARTZ in the City of Long Beach where I reside, and his anti-Communist Christian Crusade. FRED SCHWARTZ is about as anti-Communist as Fidel Castro. I have been asked questions by Mr. Jaffe concerning EDGAR EUGENE BRADLEY.

EDGAR EUGENE BRADLEY as all well know, had purchased a bus ticket and said that he was en route and arrived, and knew nothing of the assassination of President Kennedy until he arrived in El Paso. As anyone knows, that particular route of the bus, BRADLEY - and any bus of the Greyhound or Trailways, you may get off any any designated stop, any place you want, and re-join another bus coming through later on, and no one knows the difference. And this is what allegedly happened with BRADLEY in the City of Dallas. I, myself, have done this on bus trips, and so I know it can be done. So BRADLEY's story there does not hold water because there is no one on the bus, if anyone who has travelled cross-country as BRADLEY claims he was doing, if you travel cross-country with people and you do not get off a bus, people remember you regardless. I mean you strike up acquaintanceship, and I don't care if you are the most introverted person, this is the part of BRADLEY's story which proves conclusively to me that this man - of course this is my own personal opinion - this man is lying in this particular case. Of course, DAVID FERRIE had mentioned him casually, but I do want to point out this part about BRADLEY that there are pictures that I have looked at here that are quite shocking to me. I see a man which I knew as RED STOWE with EDGAR EUGENE BRADLEY. I thought

at first the pictures were of Parish Prison, but they are not of Parish Prison they are Dealey Plaza, and this is RED STOWE a "punk", "hustler", "alcoholic", a roll-them-over beat-em-up, anything he can do. He is in the pictures with the man alleged to be BRADLEY. Now this man in the picture BRADLEY says is not himself. The Dallas Police Force says it is not BRADLEY. But, the striking similarity - the similarity is too great for it not to be BRADLEY. It has to be. I cannot be anyone else but BRADLEY, because this is how BRADLEY looks when he is carousing. People who - in Los Angeles at the moment who have seen BRADLEY, and I have seen BRADLEY, it looked like BRADLEY because I have seen BRADLEY recently in a carousing mood in - out on the Strip, and this was BRADLEY in the - Hollywood by Farmer's Market. I had seen him out near - he had on a sport shirt, tousled - his hair was tousled, much like the picture that I now see that is Dealey Plaza. It looked like him. It looked nothing like the pictures that are in the courtroom there. Of course at the time I did not know that was EDGAR EUGENE BRADLEY except the face was horribly familiar. And of course he's been on - his pictures have been on TV and in the newspapers quite a bit in California, and - but I did not associate that particular man at that time with the pictures that I'd seen on television, because all the pictures there had been of a man very neatly dressed, hair combed right down to a speck. But this, the pictures here of the man at Dealey Plaza are EDGAR EUGENE BRADLEY that I have seen in some of his carousing moments.

FERRIE was mentioning the Voice of Americanism by the anti-Communist Christian Crusade, BILLY JAMES HARGIS' crusade, and also McINTIRE. The Voice of Americanism, I want to point out, comes from Pasadena, California, and plays a very important role. BRADLEY was allegedly going from McINTIRE's to the Voice of Americanism, which is headed up by - Jaffe remembers the story, It is in The Free Press, the name of this man who BRADLEY has a great deal of association with. The Voice of Americanism from Pasadena, California, a religious broadcast? The story was supposedly showing atrocities by the Vietcong, when in reality I, myself, recognize the picture right off, and had screamed to the radio station, KGR in Long Beach, that that picture was taken as a still from the movie "The Sand Pebbles", and this is the picture used by the gentleman, CLYDE McBURNIE is his name. Now it is coming to me. CLYDE McBURNIE is his name, and he and EDGAR EUGENE BRADLEY, McINTIRE and HARGIS and SCHWARTZ, they're all in the same particular bag. They all know one another. Whether they admit it or not this is absolute fact because I'm the Pasadena police if they were in a cooperative mood could tell you if they put out surveillance, they would see the cars of SCHWARTZ in Pasadena at McBURNIE's house. And this also goes to GARNER TED ARMSTRONG at the "Plain Truth" Magazine, the World Tomorrow broadcast coming from Pasadena. I think it's quite interesting

that a great deal of the radical right-wing activities religious-wise come out of Pasadena and Long Beach.

In connection, when FERRIE had said CARLOS was to fly to Houston, this is where BRADLEY's name came up. BRADLEY was not one of the two people, but I said, "How many were there?", and he said there was more than two. I said, "Who is the other one?", and he said the other one involved a guy by the name - some kind of nut by the name of BRADLEY. He says one of these religious fanatics. Now he did not use the name EDGAR EUGENE BRADLEY. He said "BRADLEY". When he used the word "BRADLEY", I mentioned - I asked him what he was referring to, and he said BRADLEY was a minister. And this is how I learned that DAVID FERRIE was a "priest". A Catholic Priest. BRADLEY was a minister with McINTIRE's organization. He has papers with numerous of these radical right ministerial groups. BRADLEY is an ordained minister. He does not profess to be to anyone. He's is just EUGENE BRADLEY who works for McINTIRE and his group in New Jersey. I want to point out one thing which I have not pointed out to anyone before, McINTIRE is associated very loosely, but is associated with a person who knows BRADLEY in New Brunswick, New Jersey, and this man's name is TIMOTHY BECKLEY. TIMOTHY BECKLEY is a UFO-ologist - flying saucers to you all. But BECKLEY knows something of BRADLEY because in a Newsletter sent out not too long ago by BECKLEY's UFO group there in New Brunswick, I have the full title of BECKLEY's - it's on Courtland Place - have the full address and all in Long Beach, and here, now, it seemed insignificant at that time, but he inserted a little article sticking up for EDGAR EUGENE BRADLEY and saying that he had nothing to do with the assassination of President Kennedy. I thought it was quite curious - it was quite curious to me that he even inserted this in the UFO magazine, there was no need for. That's my personal opinion. But this makes me wonder about BECKLEY and his association with McINTIRE. They're both in the State of New Jersey and just a short distance from one another. BECKLEY, by the way, has minister's papers with the Universal Life Church. The Universal Life Church is an incorporated body in the State of Texas. There are numerous Universal Life ministers, and I could not even begin to go into right now all the names of that I know of, If I can get on KIRBY HENSLEY's good side again, and could go through the records in Modesto again it would be of great help. But right now I'm on KIRBY's bad side. Yes, there are ministers in Dallas. There are ministers in Dallas and Fort Worth and Arlington. The Sky Ministry is in Arlington. That is the Universal Life Church minister who conducts what he calls a Sky Ministry; He drops leaflets. According to him, he drops leaflets. Religious leaflets. And he is a Sky Pilot minister in Arlington. He has a Fort Worth post office box. Angel Wing, Texas is another portion of the Universal



Life Church down there which he claims that he raises money for an Angel Wing orphanage in Angel Wing, Texas. There is no such address as "Angel Wing" - a town as Angel Wing that I have been able to discover. I do have an address for the Angel Wing Ranch. I have been asked if I had the name of The Church of the Abundant Light. This is a very familiar name to me in connection with MICHAEL ITKIN. This is one of the churches in his ecumenical movement. I have been asked concerning whether I tried to leak out some information under the guise of a seance in the - ah - there was no seance, but I wrote it in the Light of Understanding and this was one way, I felt, of trying to leak certain things out to the public. But I will say this, the response from the spiritualist people in the country has been one million per cent overwhelming and they all accept what has been given there in that article as gospel truth. Which it is - gospel truth - as the way I have learned it from ah. . .

FERRIE referred to RUBY, he never used the word "RUBY" once - he referred to JACK as "a fat clown from Dallas; and he's a faggot, and he likes to eat pussy", which is not unusual in the homosexual underworld. A lot of them like to get it in the rear, while eating the pussy. Shocking Mr. Garrison? Lovely. Yes, this is one thing I believe very strongly - well this is something he was very emphatic upon. In fact, this is one of his more serious moments when he was high. Now, as I said before, I cannot swear up and down that it was liquor because I don't think one or two beers puts anybody stoned. But he did take a great amount of pills because he was a fantastically nervous person. But as I stated many times before, he was an intelligent person and a brain attract more than a physical body. But anyhow his - he mentioned TIPPIT - OFFICER TIPPIT. Now, he mentioned TIPPIT and OSWALD and RUBY as being in the same "cell". Now, I'm sure this was not a jail, and the only things that's been used as cells in America, the term "cells" has been applied to Communist groups. Now RUBY, according - "FAT JACK the clown", had been referred to by RUBY - by, excuse me, I've got Ruby on the brain - by FERRIE as not having any love for Kennedy, so this is why this later display of killing OSWALD was so phoney to FERRIE himself. And he said that TIPPIT did not - that TIPPIT was a part of the cell as OSWALD. OSWALD did not shoot President Kennedy; that OSWALD ran out and as he did BOB threatened to shoot him. Now BOB works at the Book Depository as did - all told, there were three of them who worked at the Book Depository and who were in the same cell, and I believe OSWALD was infiltrating this cell for the Federal Bureau of Investigation as this was what was intimated more than once by DAVE, that OSWALD was working for the FBI. In fact, I don't think he kept stressing that point a little too much to where I have more or less sluffed it off. But, now that I am getting a better picture of it, I can see where this is a great - of great importance

because Mr. Hoover has a phobia and a passion about the Communists and so this would fit in with his plans the more that you dwell on the subject. But he did say that he was in a "cell" with them, and he said that - now I learned about the all points bulletin recently from Mr. Lane and Steve Jaffee being sent out, and it was sent uh - TIPPIT uh could not have possibly realistically received the bulletin yet met OSWALD at this theater. How did OFFICER TIPPIT know that OSWALD was going to the theater. This is the one thing that FERRIE pointed out. Well, this was what I was pointing out. OSWALD had been in the theater, though. This is what I was pointing out. OSWALD had been into the motion picture theater. This is what FERRIE said. He had been in the motion picture theater to hide, and he became paranoid in the dark, and as, I guess, anyone would in this particular situation. The people are telling me now - I don't know about what Garrison has here, and I do not know what the Warren Commission Report says, but, DAVID said that there was one person - TIPPIT - in the squad car. But now, since the visit of Mark Lane, I related this to LT. COWAN - Lt. JOHN COWAN and LT. COWAN says that's wrong, that FRED COLE told him that there were two men in the car; that Dallas at that time did not have two men in cars, and there were not two men in that car, there was only one man OFFICER TIPPIT, and it is standard procedure in the City of Dallas Police Department, according to LT. COWAN, that no one single officer on an all points bulletin like that approaches what is considered to be an armed and dangerous person alone. So this shoots the TIPPIT story all to hell as far as police science, and as far as LT. COWAN is concerned. He said that this is the only thing that makes him wonder.

JAFFE: Who shot TIPPIT?

Steve Jaffee has asked me who shot TIPPIT. FERRIE said OSWALD shot and killed TIPPIT, and if I was in OSWALD's shoes, I would have shot and killed TIPPIT. The other patrol car arrived just shortly after the killing of TIPPIT from fear, because he knew TIPPIT was going to kill him. He knew TIPPIT.

J. Did FERRIE know TIPPIT?

He just asked if FERRIE knew TIPPIT. I can't say. FERRIE said he knew a Dallas policeman. That may not have been TIPPIT. They've got umteen thousand men on that force. FERRIE talked about GEN. WALKER to - he was pointing out how powerful MR. SHAW was and H. LAMAR HUNT. He kept trying to tie them together, but of course Mr. Garrison last night pooh-poohed that. He said that DAVID had more intelligence than that. Or course, Mr. Garrison knew DAVID better than I, I guess. So, Mr. Garrison's right I guess, but I - but this is what he stated. That ah - he said to show you the power, he says the FBI tried to put WALKER away in the criminally insane hospital - federal hospital, Springfield, Missouri, and they were completely unsuccessful because

LAMAR HUNT got him out. It was all HUNT's money and it's still HUNT's money that is pushing WALKER around the country. He said WALKER had a fantastic hatred for JOHN F. KENNEDY. I don't think this fact is unknown to anyone. I think it's a well-known fact that he felt that Mr. Kennedy was a Communist, or a "Pinky". He stated so in various speeches. FERRIE claimed that SHAW was in touch with all the radical right groups; that SHAW wanted to preserve the Anglo-Saxon Protestant White area and race, and that included his doing away with all black people. I had to mention that because DAVID didn't.

J. Had DAVID mentioned planning with OSWALD concerning the assassination?

B. DAVID never said anything about planning with OSWALD concerning the assassination. He only had this sexual thing with OSWALD as far as I know. Of course, I am sure there was far more to it than that from what I am now viewing. But the only one that he had discussed that he was contracted through blackmail that the 16 year old boy - the sexual thing which SHAW allegedly has the pictures, or the film - DAVID did reiterate that it was a film, and that he had been shown pictures, and been given pictures. But this is how he was contracted to fly to - on down to Honduras and to Panama and then on over into Cape Town. DAVID did not receive his orders from SHAW to go to the airport. DAVID received his orders from going out on the St. Charles streetcar and I'm sure that you people here in New Orleans know what is out - if the agency has a man out on St. Charles Street in a fine home out there, because they had always described it as "a fine home", "gracious home". DAVID also said that he picked up a lot of his things at his detective agency at which he was a private investigator, which I do not believe still to this day despite what Mr. Garrison has said. I appreciate Mr. Garrison, but anyone who has met DAVID FERRIE cannot even begin to believe him as a private detective. BANISTER is the name that he mentioned most prominently over there and and a person named NOVEL. NOVEL, yes. NOVEL can fly, he's not an angel, but he can fly. Something to the effect about flying. But, I thought the name was more MOREL but it is NOVEL. He never said BANISTER told him where to go. He just went to what I now know as 544 Camp. 544 Camp, and this is where he received some of his brown envelopes similar to the brown envelope I saw that BERT, as he called him, handed him that evening in the long blue or bluish-black, could be black, at night under New Orleans street lights it could have been blue. It could have been black, Cadillac. He asked me if we talked about CHRISMAN, I said we have talked about CHRISMAN. I mentioned CHRISMAN's association with the various churches, but I did not go into it in detail, no.

FERRIE & MONEY:

CHRISMAN:

F. LEE CHRISMAN has been with the Universal Life Church since about 1964, I understand from DR. HENSLEY. CHRISMAN contacted KIRBY HENSLEY. BECKHAM contacted KIRBY HENSLEY. Numerous of these people involve here

had contacted KIRBY HENSLEY. KIRBY HENSLEY contacted no one. As I said, he did no advertising until The Light of Understanding, and that is only recently. BISHOP F. LEE CHRISMAN of Tacoma, Washington, he has a post office box. The exact address for CHRISMAN, if Mr. Garrison does not have it, I will be more than happy to send to Mr. Garrison.

CHRISMAN'S

CHRISMAN, anyhow, seems to be quite a will-o-the-wisp. CHRISMAN contact all of the, shall we say, little religious organizations anywhere, including my own. He is located in Tacoma, Washington. F. LEE CHRISMAN is a homosexual, first, last and always. In this respect he likes to have fun. He has one - he has a permanent lover. He has a permanent lover in Tacoma. The name of the man I do not know. The man has been to Modesto, and Sister HENSLEY did not like him. Of course, SISTER HENSLEY does not like homosexuals period. She doesn't know I am, until - I'm sure she does now with that Free Press article. CHRISMAN does - he does not - now branches of the Universal Life Churches was - Jaffee asked me about "branches - there is no such thing as a "branch". Each church is independent and completely, - they are completely autonomous, so there is no branch, so that he must contact each individual church. He cannot do it through Modesto because Modesto will not - supposedly will not help anyone. They have helped me on occasion, I will say this. But CHRISMAN seems to become involved in most all other things. He is also a member of DR. FRED SCHWARTZ's anti-Communist Christian Crusade, I would like to point out because I happen to have seen his name on the mailing list down by FRED SCHWARTZ's place at 137 E. First Street in Long Beach. I went in there one day and I don't think I'm welcome there any more. I was asked how do I think CHRISMAN receives his money. Well, I'm sure he doesn't make it as being a prostitute sexually because he's not that - he's not desirable in any way shape or form to my way of thinking, and he has to pay for what he gets. And so CHRISMAN - his source of money is indeed mysterious, except that he is hooked up with such groups as The Circle of Loving Companion and the other religious organizations that I have mentioned. While he has his own thing to save the American Indians, and I learned last night from Mr. Garrison he's getting a Poverty Program grant, trying to for the Gypsies.

I have not mentioned The Circle of Loving Companions because I was meditating more after I left last night - the meeting with Mr. Garrison - on The Circle of Loving Companions, and the address is on Washington Boulevard. I said 2205½, but the more I think about it, it is 2255½ Washington Blvd., but the exact address is not important at this moment. I will have that address to Mr. Garrison, and there are several bull dykes there and several male homosexuals also. And this group

CHRISMAN:

CHRISMAN is also associated with, and they seek to raise money. In fact, I had mentioned a bit that CHRISMAN was - now I want to point - CHRISMAN was involved with DICK GREGORY. I have - I have really failed to mention this. It is in this issue of the Light of Understanding. I did not put CHRISMAN's name, nor did I put GREGORY's name in it concerning the Pallioupe and the Nesquali Indians of the State of Washington where Governor Evans is with the commercial fishing industries taking away their fishing rights. And these tribes live on the river. They've always lived off of the fishing that they have received, and now this has been taken away from them. DICK GREGORY went up there recently, and was there with CHRISMAN demonstrating, trying to help these people. A girl by the name of CLOUD is involved in this to an extent, and she is a friend of F. LEE CHRISMAN. She is also a minister with the Universal Life Church. DICK GREGORY was up there. DICK GREGORY was subsequently sentenced to jail, served considerable amount of days in which he fasted, supposedly, in a county jail in the State of Washington. But this is a recent thing where CHRISMAN was involved in something with another type of a group which is DICK GREGORY. I'm sure GREGORY didn't know CHRISMAN from anything. GREGORY is tied up with the Peace and Freedom Party. CHRISMAN has no tie-up with the Peace and Freedom Party. I have checked this out very closely because I, at one time, tried to seize control of the Peace and Freedom Party in Southern California. I admit this quite freely. Because I felt that it would be a good vehicle because I have been just a little bit more than disturbed at Mr. Johnson. But, the Peace and Freedom Party has taken a radical course which I cannot participate in.

Steve Jaffee just asked me about DAVID FERRIE and The Universal Life Church. There was no mention from DAVID FERRIE of the Universal Life Church. No mention whatsoever. Now, I want to point out a very interesting person DOUGLAS - whose name is DOUGLAS. LLOYD DOUGLAS. He has a church and lives at 1731 North Lake Street in the City of Pasadena. Here we go

"Pasadena" again. DOUGLAS is the Vice-President of the Universal Life Church. He has sent HENSLEY considerable - well into the hundreds - of dollars, within the past, well this was prior to my coming down here, within six months he'd sent him several hundred dollars of thanking him for his wonderful things and praising him, and then DR. HENSLEY - an opening came for the Vice Presidency and ah which was vacated by MR. MAYALL - REV. MAYALL of Bakersfield who is the Chairman - who is now the head of GEORGE WALLACE'S American Independent Party in the State of California, I'd like to point out. He was the Vice President of the Universal Life Church. I have seen pictures of him in space suits. Don't ask me why. He's in space suits. But anyhow, - I was asked if EDGAR EUGENE BRADLEY is tied in with GOVERNOR GEORGE WALLACE'S group. I cannot say because I do not know. Except that I do know that BILLY JAMES HARGIS is backing the candidacy of GOVERNOR WALLACE as CAR - Cardinal McIntire. We got a cardinal in Los Angeles called McIntire and I keep on calling him Cardinal McIntire. DR. McINTIRE in New Jersey. DR. McINTIRE has come out very strongly in favor of GEORGE C. WALLACE. A recent broadcast I heard this on. KGER in Long Beach. Religious radio station. I wanted to point that out that there was considerable funds by a dance put on in the City of Seattle. Some of the "rock bands" - is that what they call them? - some of the "rock bands" up there for DICK GREGORY and all of them, there was funds raised for that and it was sponsored by a religious group. I have not been able to find what religious group, but I am sure if it was sponsored by any religious group in the State of Washington, it was F. LEE CHRISMAN because he was involved in the demonstrations for the Pallioupe and Nesquali Indians, and this all happened just a month and a half ago.

Mr. Jaffee has asked me about the ten millionth time how DAVID FERRIE felt about his part in the assassination of President Kennedy. DAVID FERRIE, from what he would tell me maybe out of conscience or what, or out of fear, but all he would say to me is that he was paid and he had to do what he was doing, and then he went back to that film with the 16 year old boy. If this film or the 16 year old boy could be found, I think this would be the key to breaking the whole thing. In fact, I would like to find out who the 16 year old boy is. I have been asked earlier by Mr. Jaffee if Mr. BANISTER gave him his orders, or OSWALD. Or you did not ask me if BANISTER -- about the meeting..

He never specified exactly any meetings or anything of that nature. Most everything took place at the - where he discussed the assassination - his part. Now he did not feel that he was assassinating the President. I want to emphasize this, because he really didn't

feel that he was assassinating the President. And I don't know what Mr. Garrison has him indicted for. I have not seen the indictment, I would love to see it, but, well I have been told that he was indicted for conspiracy to assassinate the President of the United States. But FERRIE did not feel that he was conspiring to assassinate the President of the United States, but they took place at the mysterious dwelling wherever it is out on St. Charles Street, and I have since asked a bellhop where I'm staying here in the City of Orleans, and they told me that all the homes out on St. Charles are very, very palatial type places and they are very old, and they are very lovely, and they are owned by fine people. The lawyer that was supposed to defend me - KOHN - I had mentioned to him about KOHN who was to come to defend me in my particular episode up in Bellville, Illinois when I was in a Civil Rights demonstration up there. Now KOHN is not the same KOHN that Mr. Jaffee just mentioned. He said ROY KOHN. This is a ROY KOHN but I'm sure it is not the same KOHN because I have met this KOHN and he is what they call the stereotype Jewish person, and totally unlike the person if Mr. Jaffee is referring to the people in the Army-McCarthy hearings. This is not the person, no. This is not the person because - but this person is related to that person. That I do know because he discussed this particular facet. I do not know why anyone was so interested in getting me off of that. They probably could have gotten me off of it, but I feel that I did the better thing, just serve my particular little sentence and got out. Well, Steve wanted me to mention some of the things - little things, or maybe big things, it's debatable. Let Mr. Garrison decide that. I've told Mr. Jaffee, Stephen out at my place in Long Beach, that DAVID had one great fault and that was his love for young boys. Mr. Garrison said last night he did not feel that it was necessarily sexual. Well, a person with his brain, I do not feel that it would necessarily be sexual, and it would be more or less a thing because DAVID had great empathy for people, and he did want to help people like he wanted to help me. I was in a particularly bad situation when I arrived in this City and he did his very best to help me. He gave me money there at the end when he was preparing to fly down to Guatemala on that trip which he had asked me to go with him so I could escape the FBI, which he said BERT said was looking for me. Of course, I do not - there is no record. No one has any way of knowing that the FBI was really looking for me or not I don't believe. I would like to know. The FBI claimed they were not. Yes. Yes. Right there at the car. I was standing on the corner. He asked if I saw BERT tell DAVE that the FBI was looking for me. I'd better get out of town. Now Bert wanted me to get out of town. I was just another noisome little faggot that he didn't want around probably. That was

more of it than anything else, and he was afraid that DAVID might have said something to me. Now, I do recall very, very plainly in the second meeting where I saw SHAW with DAVID where he stated, "Have you told him anything?" David said, "No. I'm keeping my word. I don't say nothing to him. I don't tell my "tricks" anything." I was not DAVID's "trick". He asked me about LAYTON MARTENS.

LAYTON MARTENS, I saw him the first time with DAVID FERRIE and CLAY SHAW was sitting there at the same time. This was at Dixie's, which is no longer in existence. I later saw LAYTON MARTENS several times around the Quarter, and I had - later on I propositioned LAYTON MARTENS. I will end it right there because I don't want to commit myself.

Steve has asked me what gave me the impression MARTINIS, as they're calling him, I know him as MARTY and MART, what gave me the impression that he was occupied with CLAY SHAW, rather than DAVID FERRIE. But I want to point out that Dixie's at that time was an older crowd than what I found the other evening up at LaFitte's in Exile. The LaFitte's in Exile crowd was the same type at that time, now it's nothing but a bunch of young kids. And the people were considerably more reserved, but LAYTON MARTENS appeared to know Mr. SHAW quite well as they talked, and then MARTENS would go around talking to others, and MARTENS to my way of thinking, at that time did not look like he could be over 18, maybe 19 at the very, very most. Just a little boy. He had that little boy look. I still, to this day, I do not even know his age. I have never been informed of his age, but he was extremely well-built, put it that way. And I feel - I mean he talked to DAVID and then he talked to SHAW, and then when we later left, DAVID and myself and SHAW and the young man that DAVID had purchased which I have identified today in the photos, I identified him today in the photos of BLACKMOOR, known to me at that time as BLACKIE. This is the young man whom DAVID referred to that he had - that was his gift. That was who he had bought, and I assumed that he had purchased him for the night. No, the gift DAVID had bought was BLACKMOOR. (A little bit of French in here that I can't spell, but translated: Do you understand? Prostitution?) This Jaffee is quite naive or something, but he knows nothing about the underground or else he would know that when you buy yourself someone, that means that you have purchased that person's services for the evening. For the night, or for a period of time, and so this meant that he and BLACKMOOR were going to have a sexual thing. That's what the gift in that particular case meant. I mean, when you're holding onto something, and said here is the gift I bought, that is the gift Baby. Excuse me Mr. Garrison. I didn't mean to use endearing terms. Apologize to your wife too.



BECKHAM:

I want to point out one thing that Stephen just brought up. FERRIE and BECKHAM. Now, I cannot give the exact date of FERRIE and BECKHAM. Now Mr. Sciambra stated that BECKHAM's a f-----g liar? Well whatever it is. But that's fine and well, and I know BECKHAM to be a liar. That's for damn sure, but I don't know what he was referring to. But BECKHAM is a homosexual, and BECKHAM - I wanted to finish this part here on BECKHAM. BECKHAM, when it came out in the paper that he had been subposnaed by Mr. Garrison, to me as far as I knew THOMAS BECKHAM was a good person. BECKHAM claimed to be the son-in-law of Senator ALLEN ELLENDER of Louisiana, but this is the same TOM whom DAVE had mentioned. I'm positive now, because this was the TOM whom he had ordained as a priest in the Old Catholic Church. And now BECKHAM ordains people for \$30 of course. A donation? It's illegal to sell them, but it's a donation, a love offering. And this is the same BECKHAM, and this had to be. I would say this had to be no later than '64 because BECKHAM was not here when I was here in '65, and I asked BECKHAM on the telephone if he had been in New Orleans after I had been to New Orleans and he said only to talk to Mr. Garrison. And this is because I was planning on writing an expose article on BECKHAM as being a phoney minister, a phoney everything by selling phoney doctorates. The doctorates are legal, unfortunately, as the ordinations, but I mean as far as anything backing him up, anyone can buy them. And I was going to write this in order to expose him to stop him from running for Congress from Omaha, the district there around Omaha where Mr. Martin a very respected Republican member of the Congress has been in office for many years. And, of course, I later found out from the Chief of Police of Omaha that BECKHAM's a pile of shit as far as political or anything else in Omaha. BECKHAM had been under observation for taking little girls back over to Council Bluffs, Iowa, and boys. But the boys BECKHAM was not having any sexual thing because BECKHAM is a man, according to BECKHAM. BECKHAM takes the aggressor's role and he - as I have learned, BECKHAM only does it for money. He's a man. HUM.

RED STOWE? I have been asked about RED STOWE. RED STOWE is known to me. Mr. Ivon gave me several books to look through this morning of photos. The one book, I don't know if it was on purpose or accidental, he gave it to me and start here. I don't know if he exactly said start here, but it later developed that that was the back of the book and the index with the names to the pictures, any how, had put the book in that particular position. (I had to stop for a moment) And when I turned to the picture I thought it was a picture of RED STOWE with EDGAR EUGENE BRADLEY in prison. Possibly Parish Prison here. And then I turned over the next page and then I saw a sign, and they were outside in another picture, and I saw the sign

"Highway 80", and then I knew that it was not - they were not in Parish Prison. And so then I finally found - there was an index and that I had started at the back of the book and I saw that it was not, according to them, EDGAR EUGENE BRADLEY nor was it RED STOWE. But I disagree with whoever has made the identifications on that because it definitely is RED. I mean, who knows better than the person that has known him intimately? And that is RED. I don't know where he is now. I met him here in New Orleans and God only knows where he is now. But of course RED - the type of person he is, he would sell his mother in order to a slave owner in order to make money, so, I mean, anything that he is possibly involved in would not surprise me. The other man is definitely EDGAR EUGENE BRADLEY because I've seen BRADLEY in that particular condition. Dallas P.D., I understand from Jaffee, says it is not EDGAR EUGENE BRADLEY, but Jaffee has not told me who it is then and this does bother me that they refuse to - when I ask them who the picture is when I identify it - to my knowledge, the way I know the people they refuse to give me any answers. This is the whole thing concerning Jaffee which is beginning to bug me. I feel that after I make an identification then they should tell me something at least. But I am still positive that picture is EDGAR EUGENE BRADLEY I know it is RED STOWE. RED STOWE was here - I first met him here in the City of New Orleans. Today I want to point out, I finally went to what is known - is now known as the Dixie Hotel. It could possibly have been known as the Dixie Hotel in 1965 on Tulane. It's katywampus down the street and directly across from Charity Hospital. Now Mr. Ivon seems to think it was rather amazing that I could not remember the Charity Hospital was across the street. Well, Charity Hospital may be very big in Mr. Ivon's mind and the citizens of New Orleans, but I am not a resident of New Orleans. It's just another building to me and so at that particular I wasn't interested in landmarks, hospitals or anything else, All I was interested in was hiding and having fun. And the lady who owned it I refer to as a "fat lady". She was not exceptionally fat, but she was much larger than the bitch who now runs it. Pardon me. Is that slander? No, bitch is a dog. She could be doggie. But anyhow, the woman who now runs it is her daughter who said she was there all that time in '65. I spoke to her this morning; had a very difficult time getting to talk to her. She wanted to know this, that and the other, and in a word, she had her hand out for the almighty dollar and I did this the other evening to the other people at the Center Hotel and the restaurants and the bars and everything directly across from Continental. The one lady said that I did look familiar, but she said that was three years ago and there had been so many people come and go into her particular hotel. This woman says, "Well, I don't remember you. But I know all of Mama's guests." Well, she's a liar because

she is an obvious prostitute. Of course, I may be slandering myself - or slandering her, open to suit but I don't give a damn. I'm letting the cards fall where they may because we can probably get the witnesses to prove that she is a whore or prostitute. But the woman is elderly herself. Her mother, of course, was much older. She said her mother killed by a German Shephard. This confirms a story that I had heard later concerning the death of her mother. Her mother was extremely distrustful person. She had a small black dog as I remember when I lived there. The rooms are exactly as I described them to others. It's still a gray building. It was a gray building then. There is that horrible, atrocious yellow picture of Huey Long hanging on the wall. You go down the hallway and I had not entered into the hotel and I said to her, I says, "Is the bath at the end of the hall on the right?" She confirmed this, and I asked her about the rooms, "Are they small?" and she said, "Yes, they are small", and then I pretty well described the hotel before I went on into it. There is kind of an alcove ante-way to go into it. The woman is nasty. I do remember her as being the daughter of the owner of the hotel. I mean, one couldn't forget a bitch like that. And at that time she was whoring around, if I - I don't remember her that well, but I do remember that she was whoring around. She looks much different now than she looked then. She was much more painted and she is now - today she looked like a plain, grey-haired - more salt and pepper hair. And she is elderly. She is in her 50's I would say now, and she is still plying the trade to the best of her ability probably. A man for a room for the night. Of course I'm doing this speculation, but that is the hotel - the Center Hotel - I remember it quite well because at that time there were a great deal of homosexuals and hustlers, and it was a good place to find what you wanted. I want to point out before this tape runs out, and while Mr. Jaffee and Mr. Alcock are not in here - I don't mind saying it to Mr. Alcock - but I do want to say this, that the - I am a great deal disappointed that the Dixie's is now gone because I was led to believe that Dixie's was still here. There is a Dixie's here but it is not the Dixie's that was here in 1965. Where Dixie's was at in 1965 is now taken over by some place called the Dream House or the Dream Room or something or other. Maybe it's not even that, but it's just down the street. LaFitte's in Exile is still here. It is much dirtier and they've done nothing to it. It was very, very crowded the other night when I was there. I was looking for LAYTON MARTENS, That was the reason I went out. I did not let Jaffee or any of the people of the District Attorney's Office know because I wanted to find MARTENS. I wanted him to see me. I wanted him to see if he remembered me. He is like a machine sexually, and he probably would not remember me. But when you are a person of my nature you certainly remember somebody as cold as that, and he operates like a machine and it's on a money basis.

Now, I would be interested in meeting him again. Of course, I do not have the money to really meet him for another encounter, but I think it would be interesting in the interest of justice if I could get next to him and maybe learn a lot more, because LAYTON MARTENS, I understand, is being defended by some of the wealthiest, or some of the biggest attorneys in the City of New Orleans. Yet LAYTON MARTENS still does not have a pot to piss in and to me this only - well it's only - to me I don't give a damn, but it should show Mr. Garrison and the others that CLAY SHAW - the connection with CLAY SHAW. But, that CLAY SHAW is paying MARTENS' lawyers bills. But time will tell. And now, I'm sure it will tell on the side of Mr. Garrison, and I'm beginning to take more and more stock in the Garrison case. I'm just - I'm absolutely positive that he has... (end of tape.)
