

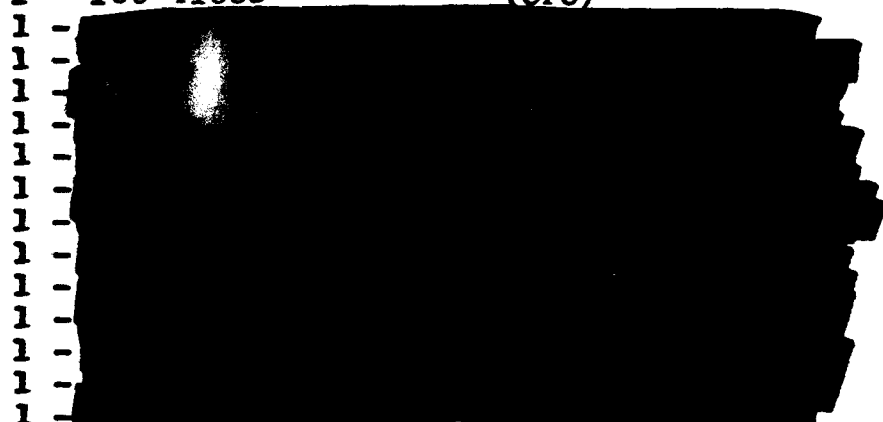

Report on COUNCIL MEETING - May 12, 1976

ATTENDANCE: 90 persons, representing 53 organizations (some unofficial)

## TASK FORCE AND SPECIAL REPORTS:

JUDGE ROBSON'S GAG ORDER: (report by Linda Quint, Chicago 15 defendant)

(1) On Feb. 24, the task force coordinated the filing of an amicus brief for 12 organizations in the U.S. Circuit Court of Appeals seeking a writ of mandamus against Robson's order. On May 1, the Circuit Court handed down a decision vacating the gag order in its entirety, stating "we believe... fundamental to our system is the right of all citizens even if they be criminal defendants to exercise their first amendment rights."

(2) With this victory, the task force had fulfilled its mandate. It was proposed that the task force be continued on the basis of a new mandate to protect the rights of defendants in trials with political connotations. A repressive atmosphere is strongly felt in the current Chicago 15 trial now in progress.

MOVED, SECONDED & CARRIED (MSC): To continue the task force on this basis.

(Note: Attendance urged at Chicago 15 trial - Federal Bldg., 219 S. Dearborn St., 25th floor - Courtroom of Judge Edwin Robson - week days 10 -12 & 2 - 5.)

BAIL TASK FORCE: (report by Hiroshi Kanno, t.f. sec'y -JACL)

(1) A letter to cooperating groups, with form for bail payments to Bail Bond Fund, Coalition for United Community Action, and a statement of the bail fund guidelines was provided for each delegate. (additional copies available from Alliance office.) Commitments totalling \$150 per month were made prior to Council meeting.

(2) The task force meetings, with large attendance of black and latin youth & community groups among others, have outlined plans for a major public campaign to reform bail practices, particularly in regard to release on recognizance. Plans for legal representation in bail courts are under discussion with lawyers' groups.

URGENT ACTION: Raising of bail funds is a first priority--a test of the commitment of the Alliance.

## HANRAHAN'S DISMISSAL OF CHARGES vs. BLACK PANTHERS:

Reports by Warren Wolfson, defense counsel, and Chaka Walls, Minister of Information, Black Panther Party.

On May 8, in a surprise move, State's Attorney Hanrahan dismissed all charges against 7 Black Panther Party survivors of the police raid in which Fred Hampton and Mark Clark were shot to death. The survivors had been charged with attempted murder of police and other crimes. Hanrahan admitted to the court that his evidence did not satisfy "judicial standards of proof."

A policy statement was presented to the Council, summarized as follows: Hanrahan's admission means that there is no legal evidence that the police were fired upon; sworn testimony of police witnesses was false; Fred Hampton and Mark Clark were evidently murdered by police operating under Hanrahan's direction. To have justice, we call upon Chief Judge John S. Boyle to appoint immediately a special prosecutor charged with the responsibility of bringing to justice all involved in the killing of Hampton and Clark.

ACTION TAKEN: (1) To adopt the statement (with minor revision)

(2) To set up a task force to implement action.

**SUSPENSION OF RENAULT ROBINSON BY POLICE DEPARTMENT:**

Report by Archie Hargraves, Black Strategy Center

CONFIDENTIAL

(1) The suspension of Renault Robinson, President of the Afro-American Patrolmen's League, is the latest of a series of disciplinary actions taken against him since he assumed leadership of this group. A large and representative group of black organizations considers his suspension to be official harassment intended to destroy the black police organization, which has had close relations with black community groups. His reinstatement is demanded with an end to harassment of AAPL leaders.

(2) A protest demonstration has been called Friday, May 15, 12:00 noon, outside of the Central Police Station, 11th & State Strs.

MSC: To join in sponsorship of this protest action and support above demands.

**LEGISLATION:** report by Coffee Humbert, Auschwitz, U.S.A. Committee

(1) General Electric Co. has endorsed Detention (Concentration) Camp Law and H.R. 14864 (to screen employees suspected of "disloyalty" in private industry defense-connected jobs.) A committee, primarily of young women and students is undertaking to respond by:

- (a) issuance in large volume of a leaflet exposing GE's position and urging repeal of the Detention Camp Law (Title II, ISA) and defeat of HR 14864;
- (b) demonstrative actions -- time and place to be announced -- in front of GE office;
- (c) "guerilla" theater skit, prepared by Northwestern student dramatics group, for presentation to meetings and gatherings; etc.

**ACTION REQUESTED:**

- (a) Orders of leaflets for mass distribution (cost approx. \$6 per 1000);
- (b) Scheduling of educational skit at your meetings.

Note: The bill to repeal the Detention Camp Law (Title II, Internal Security Act) is still being held up by the House Internal Security Committee which apparently seeks to delay action until Congress adjourns. HR 14864 is still before the Senate Judiciary Committee. Letters to both Congressmen and Senators are in order; we can still use petitions urging defeat of HR 14864 to Senators Smith and Percy.

**CAIRO UNITED FRONT:** report by Leon Page, CUF Chicago Committee

The most critical need is for a truck to transport supplies, groceries, etc. needed to maintain the boycott of merchants who have instigated repressive measures against the black community and resisted all corrective steps.

**ACTION NEEDED:** Can any organization or group of organizations undertake purchase or long-term lease of a truck?

**INFORMATIONAL REPORTS:**

(1) Student Strikes -- Cambodian Invasion & Kent Massacre

A representative of the student strike committee described the local and national student protest actions and pledged future student support for the Alliance to End Repression.

(2) NBC "Documentary on Youth Gangs": Rev. A.I. Dunlap, Coalition

He charged that the NBC (Channel 5) documentary, in the estimate of many black organizations, was deliberately distorted and divisive, placing black and latin youth groups in the most unfavorable light. The Coalition for United Community Action is seeking support for its demand for equal time to present rebuttal evidence.

**ORGANIZATIONAL REPORT:** by John Hill, Executive Coordinator

Participation in varying ways by many previously unconnected organizations and agencies is increasing. Task force meetings have been well attended and most decisions implemented. New affiliations continue -- somewhat slowly. (Attention is directed to affiliation forms distributed to council delegates.) Operating funds for the Alliance office are running low; funds on hand are sufficient only for the end of May. Additional volunteers are needed in many areas -- primarily for task forces.

## REPORT ON COUNCIL MEETING - JUNE 9, 1970

ATTENDANCE: 80 representatives from 44 organizations.

### REPORTS AND ACTIONS TAKEN

**COMMITTEE ON NATIONAL PRIORITIES:** "Repression - 1970", a 4-page brochure, was prepared for the Alliance. Additional copies may be ordered from Alliance.

**TASK FORCE ON CHICAGO 15 TRIAL:** report by David Buss

**Trial Summary:** Fifteen persons were indicted a year ago for burning the files of a South-side Draft Board. The trial began on May 5 and ended on June 5, with a finding of guilty on all four counts for 10 defendants. Four failed to appear for trial. One was judged "incompetent". Three defendants disappeared on the last day. The seven remaining were sentenced to 5 years in jail and 5 years on probation. The three who jumped bail were given 10 years in prison. Judge Robson has denied bail pending appeal.

**ACTION:** The task force was instructed to consult with defense counsel for discussion of possible constitutional grounds on which to base amicus briefs in support of appeal.

**MEDICAL ESTABLISHMENT AND REPRESSION - Special Report by Dr. Quentin Young, Medical Committee for Human Rights**

The American Medical Association will hold its national convention here starting June 20 at the Palmer House and the International Amphitheater. The AMA symbolizes what is wrong with the medical establishment: it supports and tolerates racism, oppresses and exploits its women medical workers, and subordinates health care to profits and war. The MCHR is coordinating two actions, the Chicago Peace Council a third.

### **ACTIONS:**

1. Saturday, June 20 - 9 am to 11 pm - Peoples' Health Care Convention - University of Ill. Circle Campus, Science & Engineering Bldg., room 250
2. Sunday, June 21 - Noon Rally at General Logan Statue - Grant Park  
2 p.m. - March to Palmer House
3. Wednesday, June 24 - 2 pm at International Amphitheater (43rd & Halsted) to protest AMA seminar on medical cooperation with military machine

**TASK FORCE ON BAIL - report by Hiroshi Kanno, Starr Tomcsak, Joan Hoffman and Tom Poindexter**

1. A mimeographed booklet has been prepared with a draft of the pilot project for the release on recognizance program. If successfully implemented, the project would be a major step in reforming the whole bail procedure. The draft project is receiving support from many influential agencies and organizations. Prospects look good for obtaining the necessary funding.

**ACTION:** Study and endorsement of the Pilot Project by your organization. Copies of the booklet are available at the Alliance office.

2. Some progress has been made since last Council meeting in raising sustaining contributions for the bail fund administered by the Coalition for United Community Action. The needs, however, far outrun the funds available. Additional sustainers (\$25 or more per month) are urgently needed.

**RENAULT ROBINSON CASE:** Officer Frank Lee discussed the new charges placed against Renault Robinson, president of the Afro-American Patrolmen's League and the continuing discrimination against League members. The League is fighting for survival.

**ACTION:** Support benefit performance for League - Civic Opera House - Monday, June 22, at 8 pm. Program includes Dick Gregory and Renault Robinson - Tickets - \$5 & \$10.

**TASK FORCE - SPECIAL PROSECUTOR & GRAND JURY: report by Dick Menges**

The May Council meeting passed a resolution calling for the appointment of a special prosecutor to prosecute law violations committed by police and the State's Attorney in connection with the Dec. 4th Panther raid. On May 15, the Federal Grand Jury report made public further evidence of law violations --including probable manslaughter and perjury.

The Task Force made repeated attempts to get an appointment with Judge John Boyle. Then, Judge Joseph A. Power, chief of the criminal division of the Circuit Court assumed responsibility to rule on a legal petition for a prosecutor and grand jury filed by the ACLU Chicago Council of Lawyers and the Businessmen for the Public Interest. Our delegation met with Judge Power on 5/28. Strong expressions of public concern will be needed to win a favorable ruling.

In addition to the groups working with the Alliance, other groups are supporting the ACLU petition -- including the Chicago Bar Association. On 6/11, Hanrahan's office announced that it had dropped its opposition to the appointment of the prosecutor and grand jury.

Another legal action is seeking the release by federal court order of the minutes of the Federal Grand Jury, as these contain additional evidence to submit to Judge Power. The Dept. of Justice representative, Jerris Leonard, opposes the release, but Hanrahan has reversed his position and withdrawn his objections.

**ACTIONS:**

1. A wire, signed by delegates at Council, was sent to Jerris Leonard.
2. We are collecting endorsements from cooperating organizations to file with Judge Power in support of the ACLU petition - deadline 6/17.
3. Attendance urged at Court hearings: June 17, 2 pm, room 400 (Judge Power), Criminal Courts Bldg., 26th & California. June 18, 10 am, Judge Robson's court, Federal Building, 219 S. Dearborn.

Jay Miller reported on the ACLU's proposal for reform of the Internal Investigation Division (IID) of the police department, through the addition of independent civilian investigators of cases involving civilian complaints of police misconduct.

**ACTION:** The mandate of the Task Force was enlarged to include IID reform and abolition of the Coroner's office through Con-Con - State Legislative action.

**TASK FORCE ON LEGISLATION:**

1. 20,000 leaflets were printed on the GE-Electronics Council statement supporting the Emergency Detention Camp Act (Title II, I.S.A.) and H.R. 14864. Some 15,000 have been distributed. The Northwestern U. students' dramatic skit has fallen through.
2. Status of Title II, I.S.A. repeal bill and H.R. 14864 is unchanged.
3. Meetings of the Legislative Task Force will be regularized, with notifications to be made to all T.F. volunteers.

**SPECIAL REPORT ON REPRESSION AT BOWEN HIGH - Claude Balanoff, student**

Bowen High School students have been disciplined for exercising First Amendment freedoms of press and petition. Members of Black Student Union have been victims.

**G.I. RIGHTS:** Sholem Lebovitz, Exec. Sec'y of the G.I. Defense Organization is available to speak to organizations on the repressions of the right to dissent in the armed forces. Speaking dates may be made through the Alliance office.

BLACK PANTHER PARTY (BPP)

A characterization of the Black Panther Party (BPP) is attached as an appendix hereto.

[A confidential source, who has furnished reliable information in the past, advised on May 1, 1971,] a rally, sponsored by the Illinois BPP, along with several white peace groups, was held at East 53rd Street and South Martin Luther King Drive, Chicago, wherein various speakers called for the cooperation and support for various civil rights and peace-type movements. (S)(u)

185 to 200 persons were in attendance with about 75 percent being white. (u)

[Source stated] that Yvonne King, Communications Secretary, Illinois BPP, lead off the speakers with remarks concerning the oppression of black people and called for the need to free all political prisoners.

[Source stated] that Mickey Lerner of the Chicago Angela Davis Defense Committee eulogized Angela Davis, publically identified as a black Communist Party member currently in California on charges of conspiracy to commit murder. The Defense Committee was formed following her apprehension to raise funds on her behalf.

[Source stated] that several unidentified speakers identifying themselves as members of the Gay Liberation Movement addressed the crowd calling for equal rights to be granted all "gay" people. Following these speakers, an unidentified Negro female identifying herself as a spokesman for the United Front of Cairo, Illinois, spoke concerning action taken by the State of Illinois in having moved two armored cars into Cairo. She called for the need of food and clothing to be furnished the people in Cairo (u)

since both sides have lost. The United Front, [according to the source,] is made up of black citizens of Cairo, Illinois, who have been boycotting businesses owned and operated by the white establishment and which has resulted in violence in the past. (S) (u)

The following speaker was identified as Mike James of "Rising Up Angry," an extremist underground newspaper, who stated that his organization was ready to help the blacks and any other worthy organization trying to rise above the oppression of the establishment.

Jackie Robinson, a white male, of the Movement of a Democratic Military, followed speaking about the forthcoming planned disruption to take place on May 15, 1971, at the Great Lakes Naval Training Center, Great Lakes, Illinois.

The last speaker was unidentified (Negro Male), representing the Black P. Stone Nation, a Negro youth gang operating on Chicago's South side, who called for the freeing of all Blackstone Rangers recently indicted by a Federal Grand Jury in Chicago on charges stemming from misappropriation and fraud of the Office of Economic Opportunity funds.

The rally, which commenced at 2:30 p.m., was concluded by 4:30 p.m., with no incidents reported or arrests made.

Attached to the appendix pages of this memorandum is a flier captioned, "May Day Rally, Washington Park," advertising the above-described rally.

A copy of this memorandum is being furnished to the United States Secret Service, Chicago.

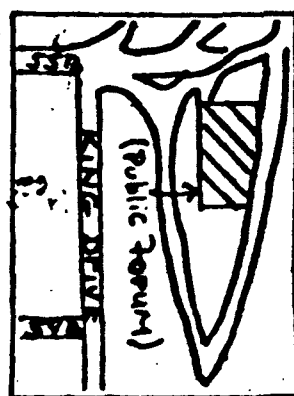

**BLACK PANTHER PARTY (BPP),**  
Also known as  
Black Panther Party for Self Defense

According to the official newspaper of the BPP, the BPP was started during December, 1966, in Oakland, California, to organize black people so they can take control of the life, politics, and the destiny of the black community. It was organized by BOBBY G. SEALE, BPP Chairman, and HUEY P. NEWTON, Minister of Defense, BPP.

The official newspaper, called "The Black Panther," regularly states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to as "pigs" who should be killed.

The newspaper, in its issue of September 7, 1968, had an article by the then Minister of Education, GEORGE MURRAY. This article ended with the following:

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is revolutionary culture. Change. Freedom everywhere. Dynamite! Black power. Use the gun. Kill the pigs everywhere."

The BPP newspaper, issue of October 5, 1968, had an article introduced with the following statement: "We will not dissent from American government. We will overthrow it."

DAVID HILLIARD, Chief of Staff, BPP, in a speech at the San Francisco Polo Field on November 15, 1969, said "We will kill RICHARD NIXON."

DAVID HILLIARD, in the "New York Times," issue of December 13, 1969, was quoted as follows: "We advocate the very direct overthrow of the government by way of force and violence."

In the issue of April 25, 1970, the BPP newspaper had an article by Minister of Culture EMORY DOUGLAS as follows:

"The only way to make this racist U.S. Government administer justice to the people it is oppressing, is...by taking up arms against this government, killing the officials, until the reactionary forces...are dead, and those that are left turn their weapons on their superiors, thereby passing revolutionary judgment against the number one enemy of all mankind, the racist U.S. Government."

The BPP Headquarters is located at 1046 Peralta Street, Oakland, California. Branches of the BPP, and Committees to Combat Fascism, under control of the BPP, have been established in various locations in the USA.

# 4 arrested on campus in protest over Foran

Last year, Tom Foran, then US Attorney and prosecutor of the Conspiracy eight, would have sooner shaken hands with the devil than visit Hyde Park.

But that was two years ago.

Even so, the appearance of a Foran for Governor fundraiser at the Quadrangle Club was a surprise to those walking in the vicinity of 57th and University last Tuesday night.

What Foran is best remembered for at this point is the remark that he made to the Evanston Rotary Club after the conspiracy trial was over. He said that he suspected the masculinity of all the defendants with the exception of Bobby Seale.

"We are losing our kids to a freaking fag revolution," is the declaration that will earn Thomas Foran a place in history.

Not surprisingly, Gay Liberation Front did not appreciate the tone of Foran's comment. And unbeknownst to the Foran supporters Tuesday night was that just across the street, in Reynolds Club, Gay Lib was sponsoring a speech by Allen Young, a former member of SDS and past editor of Liberation News Service.

Learning of the Foran affair, a group from the Gay Lib meeting made its way to the entrance of the Quad Club. "We found out that the rally was open and went inside," said Murray Edelman, one of the Gay Lib group.

Once inside, about six Gay Lib members made their way upstairs where speeches were being made in the main ballroom. "It was obvious that there were a lot of people who looked like heavies. The rally was almost over and Mrs. Foran's daughter got up to make some sugarsweet speech about how wonderful her father was. So we shouted 'Foran is a fag-beater,'" Edelman explained to the Maroon.

"Immediately people were all around telling us that if we said one more thing we'd be out," Edelman continued. "We decided to go, but on the way shouted 'Gay Power.'"

At that point, Edelman, who is a graduate student in human development, Brad Edwards '73, Kevin Thomas Burke '74, and another graduate student who wishes to remain unidentified were escorted outside by several Chicago policemen.

Hustled into unmarked cars across the street, the four were taken to 57th and Cottage Grove where they were transferred to a paddy wagon and taken to the district station at 29th and Prairie Avenue. Before that, according to Edelman, Burke was taken into an alley next to the Quad Club where police allegedly intended to beat him. They decided against it, Edelman said, reportedly because a woman told the police that she was watching.

The four were subsequently charged with resisting arrest and disorderly conduct. Bond was set at \$100 total for all four.

January 5 was set as the preliminary court date.

But the question of the evening was why Foran would choose the Quad Club for a city-wide reception.

The Maroon contacted Foran's campaign committee, but a spokesman there refused to comment.

According to Nicholas Fulup, manager of the Quad Club, any member of the club can reserve the facilities. Apparently, the building had been reserved about a week in advance by several friends of Foran. Although the Quad Club's membership is customarily composed of University faculty and administration personnel, Fulup said that the Club's by-laws permit 30 percent of the membership to come from outside the University.

For Foran, the evening was an exercise in disappointment. Hoping for his campaign to be bolstered by the appearance of Mayor Daley, Foran kept his guests waiting until 11:30 before announcing that the lateness of the hour prohibited the mayor from stopping on his way home from another dinner that was being held downtown.

Nonetheless, Senator Adlai Stevenson III paid a surprise visit and said that he thought that Tom Foran would make a great governor for the state of Illinois. "Of course, I also think that he'd make a great Senator from Illinois," Stevenson added.

Perhaps the greatest disappointment, however, was felt by the 45 members of the Leo High School band. Standing on the grass in front of the Quad Club, in near freezing weather, the band waited for hizzoner for nearly three hours only to catch a fleeting glimpse of Representative Roman Pucinski.
