

Re San Francisco teletype to the Bureau dated 10/3/77; and Bureau teletype to San Francisco dated 10/4/77.

On 1/10/78, Department, advised that his investigation in this matter had failed to positively identify the persons responsible for captioned bombing. He stated, however, that his investigation indicated that it was not of a terrorist nature and that his investigation of the bombing, although not conclusive, tended to indicate that it was perpetrated as a result of labor unrest at the Coors Distributorship in San Francisco where the victim is in a management position.

In view of the foregoing, this case is being placed in a closed status and no further investigation is being conducted.
