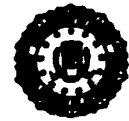

Re San Francisco teletype to the Bureau dated 10/3/77; and Bureau teletype to San Francisco dated 10/4/77.

On 1/10/78, [REDACTED] Atherton Police Department, advised that his investigation in this matter had failed to positively identify the persons responsible for captioned bombing. He stated, however, that his investigation indicated that it was not of a terrorist nature and that his investigation of the bombing, although not conclusive, tended to indicate that it was perpetrated as a result of labor unrest at the Coors Distributorship in San Francisco where the victim is in a management position.

In view of the foregoing, this case is being placed in a closed status and no further investigation is being conducted.
